REPORT OF THE TOWN MANAGER

THERE WERE A NUMBER OF PROPERTIES THAT HAD TO BE REVIEWED BY AVITAR WHICH WERE DUE IN PART TO BOTH THE ASSESSING FIRM AND PROPERTY OWNERS. BY THE TIME ALL FINAL ASSESSMENTS WERE REACHED AND A TAX RATE COULD BE MADE BY THE STATE IT MADE THE MIDDLE OF JANUARY OF THIS YEAR BEFORE THE 1990 TAXES WERE DUE. WITH PREPARATION OF THE YEAR END FIGURES, TAXES DUE AND TOWN MEETING MATERIALS IT WAS A VERY BUSY BEGINING FOR 1991.

NATURE BROUGHT FORTH MY NEXT PROBLEM WHICH WAS MUD CAUSED BY SEVERAL THAWS DURING THE WINTER SEASON. BY SAVING MONEY ON PREVIOUS PROJECTS I WAS ABLE TO ENCUMBER FUNDS WHICH ALLOWED ME TO DIRECT THE ROAD AGENT TO USE A FABRIC ON HARVEY SWELL ROAD, HUGHES ROAD AND REED ROAD. WE ARE REQUESTING FUNDS IN THIS YEARS BUDGET TO DO FURTHER WORK ON OTHER ROADS WHICH WILL HOPEFULLY PREVENT THESE CONDITIONS FROM HAPPENING AGAIN. BASICALLY EVERY BACK ROAD SHOULD BE GRAVELED, BUT THIS WOULD MEAN A LARGER AMOUNT OF FUNDS TO BE RAISED, AND TAXPAYERS DURING THESE HARD ECONOMIC TIMES DO NOT WANT THIS. THE SELECTMEN AND I TRY TO HOLD THE LINE ON BUDGET ITEMS. WHAT WE WOULD LIKE TO SEE DONE FOR THE TOWN AND WHAT IS ECONOMICALY POSSIBLE ARE TWO DIFFERENT THINGS.

THE BEAVER BROOK PROJECT WAS COMPLETED IN THE EARLY SUMMER AND THEN IT WAS ON TO THE SOUTH MAIN STREET PROJECT. AT THIS TIME I WANT TO EXPRESS MY APPRECIATION TO THE RESIDENTS OF THAT STREET FOR BEING SO PATIENT THROUGH DUT THIS PERIOD OF INCONVENIENCE. THERE HAS BEEN A GREAT DEAL OF INFILTRATION REMOVED FROM OUR SEWERAGE LAGOONS WHICH WAS ONE REASON FOR THE STATE MORATORIUM BEING PLACED ON THE SYSTEM AND HOPEFULLY BY CORRECTING THE PROBLEMS WITH SOUTH MAIN STREET IT WILL RESULT IN A LIFTING OF THE MORATORIUM ON AT LEAST THE RESIDENTIAL HOOKUPS. THIS WORK WAS DONE BY THE TOWN EMPLOYEES WHICH ALLOWED ME TO TURN BACK \$19,511.00 TO BE PLACED IN THE SURPLUS FUND AND WHEN THE TAX RATES ARE SET BY THE STATE THIS WILL MAKE A REDUCTION IN THE TAX RATE.

TESTS FOR OUR SEWERAGE LAGOONS HAD BEEN DONE IN THE BERLIN FACILITY ONCE A MONTH. THIS YEAR EPA REQUIRES ONCE A WEEK TESTING. SO LOOKING AT IT AS TO WHICH WAY WOULD BE THE BEST FINANCIALLY IT APPEARED MORE REASONABLE TO HAVE OUR OWN LABORATORY WHICH WE HAVE DONE.

ECONOMIC CONDITIONS THIS PAST YEAR HAVE CAUSED A GREAT INCREASE ON OUR WELFARE ASSISTANCE ACCOUNT. THIS FALL WE IMPLEMENTED A WORK FARE PROGRAM WHICH ALLOWS FOR THOSE RECEIVING ASSISTANCE TO WORK TO REIMBURSE THE TOWN. TO DATE IT HAS WORKED TO BENEFIT BOTH THE TOWN AND THOSE RECEIVING ASSISTANCE. THE SSI INTERIM ASSISTANCE PROGRAM WILL BE IMPLEMENTED EARLY IN 1992 TO HELP THE TOWN RECOUP FUNDS PAID OUT TO INDIVIDUALS WHO QUALIFY FOR SSI BUT HAVE NOT YET RECEIVED THEIR CHECKS.

IN ORDER TO LENGTHEN THE LIFE OF OUR LANDFILL WE HAVE ENTERED INTO AN AGREEMENT WITH COOS COUNTY TO USE THEIR RECYCLING CENTER. THERE IS A CONTAINER PLACED AT THE MUNICIPAL PARKING LOT THAT IS PROVING VERY SUCCESSFUL. THIS YEAR I WAS ABLE TO REIMBURSE THE COUNTY FOR OUR COMPLETE COST SHARE AND HAVE THUS SAVED INTEREST COSTS. AS IT WAS ON A SCHEDULE TO PAY IN ONE YEAR OR OVER A PERIOD OF YEARS. A GRANT OF \$ 10,000.00 RECEIVED FROM THE STATE OF NEW HAMPSHIRE WAS ALSO AWARDED COLEBROOK AND TURNED OVER TO THE COUNTY FOR THIS PROJECT.

DURING THE PAST YEAR AND PREVIOUS YEARS I HAVE BEEN ABLE TO TRANSFER FUNDS FROM BOTH WATER AND SEWER INTO SAVINGS ACCOUNTS. THIS WILL HELP HOPEFULLY IN LOCATING A SECOND WATER SUPPLY WHICH WE MUST SOON ADDRESS. DUR PUMPING STATION AND EJECTOR PITS ARE OVER TWENTY YEARS DLD, PARTS ARE NO LONGER AVAILABLE AND SHOULD THEY GO DOWN WE ARE FACING MAJOR COSTS.

IN CLOSING MAY I EXPRESS MY APPRECIATION TO THE BOARD OF SELECTMEN FOR THEIR CONTINUED LEADERSHIP, TOWN OFFICERS, DEPARTMENT HEADS AND EMPLOYEES FOR THEIR DEDICATED SERVICES AND THE CITIZENS FOR THEIR COOPERATION.

TRANSMITTAL AND COMMENTARY LETTER

Board of Selectmen
Town of Colebrook
Colebrook, New Hampshire 03576

Members of the Board:

We have audited the financial statements of the various funds and account groups of the Town of Colebrook for the year ended December 31, 1990 and have issued our report thereon, dated May 16, 1991. As part of our audit. we reviewed and tested the Town's system of internal accounting control to the extent we considered necessary to evaluate the system as required by generally accepted auditing standards. Under these standards, the purpose of such evaluation is to establish a basis for reliance thereon in determining the nature, timing and extent of other such auditing procedures that necessary for expressing an opinion on the financial statements. Such study and evaluation disclosed the following conditions that should be corrected in order to improve the Town's internal control system. Our following remarks are being made in the hope that they will improve existing procedures and are in no way a criticism of Town personnel.

1. Necessity for clear-cut Invoice Cancellation

During our examination, we noted that a number of invoices submitted for payment were not stamped 'paid', or otherwise effectively cancelled, at the time of payment.

Recommendation

Employees should be advised that all documents must be effectively cancelled to prevent their possible resubmission.

Library Treasurer signs all checks and also Maintains all Financial Records.

The present library treasurer, who signs all checks also is the bookkeeper.

This is poor internal control as there is no segregation of duties between the payment and recording function.

Recommendation

The Library Trustee's should institute a program of dual signatures on all library checks.

3. Eliminate Water Department Customer Deposits

The Town presently maintains detailed customer deposit cards for the water department.

Recommendation

The Town should seek guidance from the Department of Revenue as to whether these deposits could be written off and reflected as water department revenue with majority Town vote.

4. Need Formalized_Policy_Regarding_Vacation and Sick Pay

The Board of Selectmen should prepare and adopt a formal policy on the accrual and payment of accrued vacation and sick pay. The adoption of this policy could be extremely helpful in the future in avoiding possible litigation on contingent liabilities.

We extend our thanks to the officials and employees of the Town of Colebrook for their assistance during the course of our audit.

It is our opinion that the Selectmen, Town Manager and staff are doing an excellent job administering the Town of Colebrook.

- Article 4 Motion made by Wendell Woodard and seconded by John Kenny to see if the Town will vote to approve use of the sidewalk on the Westerly side of Main Street, from the intersection with the present snowmobile trail at Lemieux's Garage Southerly to the Lewis and Woodard Gulf Garage property, as a designated snowmobile trail, subject to a speed limit of 10 mph and subject to all other applicable State and Town regulations. Said trail to be open for use only between the hours of 8 a.m. and 10 p.m. (By Petition) Ballot vote 34 yes and 182 pg.
- Article 5 Motion made by Wendell Woodard and seconded by John Kenny to see if the Town will vote to approve use of Colby Street, from the intersection with the present snowmobile trail at the railroad tracks to Main Street, as a designated snowmobile trail, subject to a speed limit of 10 mph and subject to all other applicable State and Town regulations. Said trail to be open for use only between the hours of 8 a.m. and 10 p.m. (By Petition) Ballot vote 44 yes and 174 no.
- Article 6 Motion made by Wendell Woodard and second by Cameron Howard to see if the Town will vote to authorize all property owners in the Colebrook Village Fire Precinct access to the nearest snowmobile trail by way of closest Town roads and/or sidewalks and to authorize the Selectmen to designate the allowed routes of travel. Article 43 To transact any other business that may legally come before this meeting.

GENTLEMEN:

THIS YEAR WAS ANOTHER BUSY YEAR FOR THE DEPARTMENT, MANY HOURS WERE SPENT ON NUMEROUS CRIMINAL INVESTIGATIONS AND KEEPING UP WITH THE EVERYDAY COMPLAINTS AND REPORTS. THE MANPOWER WAS DOWN TO TWO-FULL-TIME, AFTER MICHAEL SIELICKI RESIGNED AND MOVED TO CALIFORNIA. WE HIRED MYRON CROSSLEY FULL-TIME AND STEVE BRETON PARTTIME. IT TOOK TIME WORKING WITH BOTH MYRON AND STEVE, TEACHING THEM WORKABLE SITUATIONS, LAWS AND APPLICATIONS IN THE FIELD OF POLICE WORK. MYRON IS NOW ATTENDING THE POLICE ACADEMY IN CONCORD, NEW HAMPSHIRE. HE WILL GRADUATE THIS SPRING.

AGAIN THIS YEAR JUVENILE PROBLEMS STILL KEEP US BUSY, ALCOHOL IS STILL A LARGE PROBLEM WITH YOUNG PEOPLE UNDER THE AGE OF TWENTY-ONE, I BELIEVE THE PROBLEMS WE EXPERIENCE WITH OUR YOUNG PEOPLE WOULD BE GREATER, WITHOUT THE HELP OF DAVE DEWERS, DAVE IS OUR NORTH COUNTRY YOUTH COUNSELOR, HE DOES WORTH WHILE PROJECTS WITH A LOT OF OUR YOUNG PEOPLE.

OUR MOTOR VEHICLE ACCIDENTS INVESTIGATED WERE THE LOWEST I HAVE SEEN IN MANY YEARS. THIS COULD BE DO TO THE FACT, DRIVERS ARE BEING MORE CAREFUL OPERATING AND MORE COURTEOUS TO EACH OTHER.

I WOULD LIKE TO THANK THE MANY PEOPLE AND DEPARTMENTS FOR THEIR CONTINUING ASSISTANCE AND SUPPORT OF THE POLICE DEPARTMENT, INCLUDED ARE THE MEN/WOMEN OF THE FIRE DEPARTMENT, AMBULANCE CORPS, DISPATCHERS, THE CITIZENS OF THE TOWN, THE SELECTMEN AND THE TOWN MANAGER FOR THEIR CONTINUING GUIDANCE.

THE LAST TWO YEARS HAS SEEN A TREMENDOUS GROWTH IN THE COLEBROOK PUBLIC LIBRARY. THE COMMUNITY SHOULD BE VERY PROUD OF THE BEAUTIFUL NEW ADULT SECTION AND THE NEWLY RENOVATED CHILDREN'S ROOM. IT HAS BEEN A COMMUNITY EFFORT THAT HAS MADE THIS GROWTH POSSIBLE.

A WONDERFUL GIFT OF MANY BEAUTIFUL BOOK CASES WAS GIVEN TO THE LIBRARY FOR THE CHILDREN'S ROOM AND THE NEW ADULT SECTION BY THE ETHAN ALLEN CORPORATION OF BEECHER FALLS. THESE BOOK CASES GREATLY ENHANCES THE BEAUTY OF BOTH ROOMS. THE CHAMPION CORPORATION DONATED THE LOGS TOWARDS THE BOOK CASES, AND RAYMOND WHITE CUT AND TRANSPORTED THE LOGS TO BEECHER FALLS. WE ARE VERY GRATEFUL TO THOSE PEOPLE WHO MADE THIS GIFT OF BOOK CASES POSSIBLE. BARBARA AND DENNIS LAPERLE DONATED AN ETHAN ALLEN DESK FOR THE CHILDREN'S LIBRARIAN. SEVERAL DONATIONS WERE MADE TO THE CHILDREN'S ROOM FUND.

WE RECEIVED A GRANT FROM THE NORTHERN NEW HAMPSHIRE FOUNDATION TO HELP CHILDREN AND FAMILIES AND TO HELP ENCOURAGE PARENTS TO START READING TO THEIR CHILDREN AT A VERY YOUNG AGE. EVERY PARENT WHO HAS A CHILD BORN AT THE LOCAL HOSPITAL RECEIVES A BOARD BOOK, A T-SHIRT WITH "READ TO ME" ON IT, AND A BROCHURE LISTING SOME OF THE PARENTING AND BOARD BOOKS AVAILABLE AT THE LIBRARY, AND WHEN THE CHILD IS ONE YEAR OLD, IT WILL RECEIVE ANOTHER FREE BOOK. WE WANT TO INSTILL THE LOVE OF BOOKS AND READING AT A VERY YOUNG AGE AND MAKE MORE CHILDREN LIFE-LONG READES. WE ALSO BOUGHT FURNITURE AND BOOKS FOR THE CHILDREN'S ROOM WITH THE MONEY RECEIVED.

TO IMPROVE OUR SERVICES, MANY NEW BOOKS HAVE BEEN ADDED TO OUR COLLECTION. OUR INTERLIBRARY LOAN SERVICE HAS GREATLY INCREASED. BECAUSE OF BUDGET CUTS IN THE STATE LIBRARY, THE N. H. STATE LIBRARY MEDIA MOBILE IS NO LONGER COMING TO THIS AREA. WAYS ARE BEING EXPLORED TO HELP SERVE THOSE PEOPLE WHO ARE NO LONGER BEING SERVED.

SEVERAL KINDS OF PROGRAMS WERE OFFERED TO THE CHILDREN IN THIS AREA THAT INCLUDED: PRESCHOOL STORY AND ACTIVITY PROGRAMS WITH ROSALIE SWEATT AND VOLUNTEERS: CHILDREN'S SUMMER READING AND SCIENCE PROGRAMS WITH ROSALIE, LOU DESOUSA, DR. GIFFORD, MR. AND MRS. RICHARD BOND, JUDY JACQUES, MEG SHELTRY, AND SUE BAILEY: STORY-TELLING BY PURLY GATES: A SPACE PROGRAM BY MR. BROWDER FROM STATION WJYY; A SCIENCE FICTION PROGRAM BY JAMES KELLY; THE HIGH SCHOOL ART CLASS HAD THEIR ANNUAL ART EXHIBIT; AND THE "LITTLE RED WAGON" WAS HERE WITH THEIR PUPPET AND THEATRE PROGRAM. FOR ADULTS THERE WERE THE FOLLOWING PROGRAMS: "CONNECTIONS". A LITERACY BASED PROGRAM: A LEADERSHIP SEMINAR BY LINDA STONNER; PROGRAMS FUNDED BY THE NEW HAMPSHIRE HUMANITIES COUNCIL-- "ENCOUNTER IN NORUMBEGIA" WITH A MAP EXHIBIT, "TOWNS OF THE WHITE MOUNTAINS" WITH AN ART EXHIBIT OF THE WHITE MOUNTAINS, AND "A NATURAL WILDERNESS*, WHICH WAS A 4-PART READING-DISCUSSION SERIES; BUILDING SELF-ESTEEM IN CHILDREN BY VALARIE HERRES: AN ART EXHIBIT BY LOCAL ARTISTS: AND POWER SCHEDULING WITH DAVID DESOUSA. THERE HAS BEEN AN EXTENSION MEETING, GARDEN CLUB MEETINGS, AND THE COLEBROOK AREA HISTORICAL SOCIETY IS HOLDING IT'S REGULAR MEETINGS AT THE LIBRARY ON THE SECOND THURSDAY OF EACH MONTH.

THE LIBRARY HAS APPLIED FOR A \$25,000 LITERACY GRANT. THIS WOULD HELP US COORDINATE ALL SERVICES IN THE AREA AND OFFER PROGRAMS FOR THOSE WHO NEED HELP IN READING AND MATH AND FOR OTHERS WHO WISH TO GET THEIR GED'S. SPACE IS BEING PROVIDED FOR THE ADULT TUTORIAL PROGRAM IN THE BASEMENT OF THE ORIGINAL LIBRARY.

JULIE COLBY, ASSISTANT LIBRARIAN, IS CONTINUING TO TAKE LIBRARY TECHNIQUE COURSED THROUGH THE N. H. STATE LIBRARY AND THE SCHOOL FOR LIFE-LONG LEARNING. THESE COURSES ARE REQUIRED BY THE N. H. STATE LIBRARY IF YOU DO NOT HAVE A MASTERS DEGREE IN LIBRARY SCIENCE.

THE STAFF AND TRUSTEES HAVE WORKED VERY HAD THIS PAST YEAR TO IMPROVE LIBRARY SERVICES FOR PEOPLE IN THIS AREA. WE WILL CONTINUE TO TRY TO PROVIDE THE BEST POSSIBLE LIBRARY AND INFORMATION SERVICES AND PROGRAMS FOR THIS COMMUNITY. WE ARE A PLEASURABLE COMMUNITY RESOURCE AND WE HOPE THAT ENLEVEN HORE PEOPLE WILL USE THE LIBRARY AND MAKE IT A FAMILY PLACE TOO. WE WANT TO SERVE EVERYONE WHATEVER THEIR TASTE, INQUIRY, OR EDUCATIONAL, INFORMATIONAL AND CULTURAL NEED AND TO PROVIDE ASSISTANCE IN UTILIZING MATERIALS IN ALL FORMATS. IN'S EVERYONE'S LIBRARY TO USE.

THE TRUSTEES AND STAFF WOULD LIKE TO THANK EVERYONE WHO HAVE DONATED THEIR TIME AND MONEY AND THE VOLUNTEERS WHO HAVE HELPED IN MANY WAYS. MANY PEOPLE HAVE HELPED TO MAKE OUR LIBRARY GROW.

AGAIN I WOULD LIKE TO THANK THE TRUSTEES, STAFF, AND THE FRIENDS OF THE LIBRARY WHO HAVE SUPPORTED ME IN THE PAST YEAR.
