Town Warrant

To the Inhabitants of the Town of Exeter, in the County of Rockingham, in said State, qualified to vote in Town Affairs: [L.S.]

You are hereby notified to meet at the Town Hall, in said Exeter, on Tuesday, the eleventh day of March next, at eight o'clock in the forenoon, to choose all necessary Town Officers for the ensuing year, by official ballot, and to take other action required to be inserted on said official ballot; the polls to open at eight o'clock in the forenoon and to close not earlier than eight o'clock in the evening, and thereafter to reconvene at the Exeter High School gymnasium on Monday, March 17, 1980, at seven o'clock in the afternoon for the purpose of acting upon all other matters to come before the meeting.

ARTICLE 1

To choose by ballot and plurality vote two (2) Selectmen for the term of three (3) years.

ARTICLE 2

To choose by ballot and plurality vote one (1) Treasurer for one year, the remainder of the 1978-1981 term.

ARTICLE 3

To choose by ballot and plurality vote one (1) Moderator for the term of two (2) years.

ARTICLE 4

To choose by ballot and plurality vote one (1) Supervisor of the Checklist for the term of six (6) years.

ARTICLE 5

To choose by ballot and plurality vote one (1) member of the Library Committee for the term of two (2) years and three (3) members of the Library Committee for the term of three (3) years.

ARTICLE 6

To choose by ballot and plurality vote one (1) Trustee of Trust Funds for the term of three (3) years.

ARTICLE 7

To choose by ballot and plurality vote one (1)

Trustee of the Robinson Fund for the term of seven (7) years.

ARTICLE 8

To choose by ballot and plurality vote one (1) Trustee of the Swasey Parkway for the term of three (3) years.

ARTICLE 9 — Zoning Amendment #1

To see if the Town will vote to amend the Town of Exeter Zoning Ordinance, as proposed by the Planning Board as follows:

Amend Article 4.50 Performance Standards — (p. 10) by striking paragraph #5 entitled "Toxic or Noxious Matter," and inserting the following:

5. Hazardous Waste. Hazardous waste shall be those substances as defined by the Environmental Protection Agency in its proposed Regulations under Section 3001, 3002 of the Solid Waste Disposal Act of 1976 and as said proposed Regulations (including definitions) are more fully set forth in the Federal Register, Monday, Dec. 18, 1978, Part IV, and as said proposed Regulations (including definitions) may from time to time be amended and finally adopted. Hazardous Waste shall also be further defined as provided for in "An Act Establishing a Hazardous Waste Management Program," N.H. RSA 347:1, effective July 1, 1979, hereinafter referred to as the "Act," and as same may be amended or enlarged upon by the Rules and Regulations of the Bureau of Solid Waste Management, as is more specifically provided for in the Act.

The disposal, treatment, bulking or handling (hereinafter collectively called treatment) of hazardous waste within the corporate limits of the Town of Exeter shall be permitted only when such waste is generated within the Town of Exeter and such treatment shall be prohibited except by an operation or facility owned or operated and controlled by the Town of Exeter, its agents or its designees, in which event such treatment shall not be conducted by the Town or delegated to any third party until two prerequisites have been satisfied, namely:

1. The Town shall have adopted by vote at an annual town meeting or a special town meeting called for such purpose, a comprehensive plan for the treatment of hazardous waste, such plan to be consistent with and in con-

formity with all State and Federal statutes and regulations governing the same.

2. Approval of the operation or facility proposed shall be in each instance by vote of the Town at an annual town meeting or special town meeting called for such purpose by the Town.

The temporary storage of hazardous waste other than for treatment is permitted only when it is used, manufactured or generated as a waste as part of an industrial, manufacturing or laboratory process that takes place within the Town of Exeter, and in such event the same shall be inventoried and stored inside a building with an impermeable floor and otherwise handled in strict conformance with all applicable Federal and State regulations governing the same. The records pertaining to such inventory and storage shall be open to the Board of Selectmen and/or the Exeter Fire Department upon reasonable request.

ARTICLE 10 — *Zoning Amendment #2*

To see if the Town will vote to amend the Town of Exeter Zoning Ordinance, as proposed by the Planning Board as follows:

Amend Article 4 “District Regulations” by inserting a new section, referenced:

4.41 **Junkyards**

New junkyards may be permitted only within an I- or I-3 District, subject to the granting of a special exception found to comply with the requirements herein set forth.

Without the granting of a special exception, no junkyard existing as a non-conforming use shall be allowed to:

- a. expand in area;
- b. install salvage-processing equipment or facilities that would create noise or vibration detectable beyond the property lines;
- c. extend the hours of operation;
- d. increase the height of materials stored.

The Board of Adjustment, in considering an application for a special exception, shall find that the proposal complies with the following criteria:

1. The terms of Article 6.60 herein are complied with;
2. To the greatest extent practical, the objectives and purposes of RSA 267-A shall be promoted;

3. All materials and equipment shall be stored within the enclosed area, unless an accessory use is specifically authorized;
4. A landscaped buffer (per Article 5.76-b of the Subdivision Regulations) exterior to a minimum eight foot (8') high fence shall be provided to effectively screen from view, year-round, all materials and equipment from adjacent rights of way and property lines.

ARTICLE 11 — *Zoning Amendment #3*

To see if the Town will vote to amend the Town of Exeter Zoning Ordinance, as proposed by the Planning Board as follows:

A. Amend the Zoning Ordinance by including a new section “6.42” as follows:

6.42 **Epping Rd. Strip Management Ordinance, I-3 and C-3 Districts**

1. **Purpose** To lessen congestion upon arterial streets and provide for the safe and orderly flow of traffic within a developing commercial area. These regulations intend to prescribe design standards for traffic access, curbcuts, landscaping, lighting, signing and internal traffic circulation within the C-3 and I-3 Districts.
 - a. Insofar as possible, access points shall be located directly opposite each other across Epping Rd.
 - b. Each parcel shall have but one point of access to Epping Rd. unless it has more than 1,200 feet of frontage, in which case, one point of access is permitted for each 600 feet of frontage.
 - c. Abutters shall consolidate access points at common property lines or, as may be agreed, elsewhere so as to reduce the number of such points.
2. **Minimum Front Yard, Use Thereof** The first 25 feet of front yard shall be kept clear of obstructions to sight and shall not be used for display of goods or signs. The next 25 feet of front yard shall be planted and landscaped and no signs shall be permitted within this area. The next 25 feet shall be utilized or reserved for a frontage road.
3. **Setback Requirements from Right of Way**
 - a. The minimum building setback shall be

85 feet from the Epping Rd. right of way.

- b. The minimum access road setback shall be 50 feet and the parking area setback shall be 75 feet.
- c. No business sign shall be within 50 feet of the Epping Rd. right of way line except a directory sign, approved by the Planning Board, which shall be set back 25 feet from Epping Rd. and limited in area to 10 square feet per business, which sign shall not be internally illuminated.

B. Amend Article 4.20 by including in "Schedule 1 Zoning Schedule of Use Controls" a new paragraph as follows:

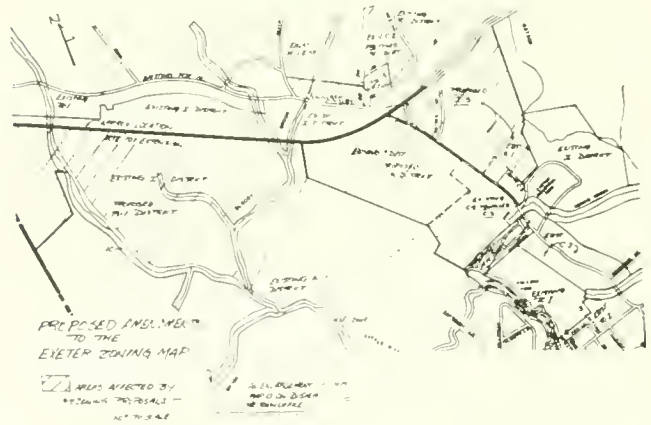

D. Amend the Zoning Map by including new districts, labeled C-3 Epping Rd. Highway Commercial and I-3 Epping Rd. Highway Industrial, to replace the I and C-2 Districts, to delete a portion of the C-2 District by extending the MH Mobilehome District to include the area known as Oakhaven Mobile Home Park, and to rezone land southerly of the Rte. 101 Extension from Industrial to R-1 Residential, all as shown hereon:



ARTICLE 12 - Zoning Amendment #4

To see if the Town will vote to adopt a Fire Prevention Code prescribing regulations governing conditions hazardous to life and property from fire or explosion, and establishing a bureau of fire prevention and providing officers therefor and defining their powers and duties, as follows:

Section 1. Adoption of Fire Prevention Code.

There is hereby adopted by the Town of Exeter, New Hampshire, for the purpose of prescribing regulations governing conditions hazardous to life and property from fire or explosion, that certain Code known as the Fire Prevention Code recommended by the American Insurance Association, being particularly the 1976 edition thereof and the whole thereof, and as same may be amended at town meeting, of which Code not less than three (3) copies have been and now are filed in the office of the Clerk of the Town of Exeter, New Hampshire, and the same are hereby adopted and incorporated as fully as if set out at length herein, and from the date on which this ordinance shall take effect, the provisions thereof shall be controlling within the limits of the Town of Exeter.

Section 2. Establishment and Duties of Bureau of Fire Prevention.

- a. The Fire Prevention Code shall be enforced by the Bureau of Fire Prevention in the Fire Department of the Town of Exeter, New Hampshire, which is hereby established and which shall be operated under the supervision of the Chief of the Fire Department.
- b. The Chief of the Fire Department is permitted to detail such members of the fire department as inspectors as shall from time to time be necessary. The Chief of the Fire Department shall recommend to the Town Manager the employment of technical inspectors, who, when such authorization is made, shall be selected through an examination to determine their fitness for the position. The examination shall be open to members and non-members of the fire department, and appointments made after examination shall be for an indefinite term with removal only for cause.
- c. A report of the Bureau of Fire Prevention shall be made annually and transmitted to the chief executive officer of the municipality; it shall contain all proceedings under this Code, with such statistics as the Chief of the Fire Department decides to include therein; the Chief of the Fire Department shall also recommend any amendments to the Code which, in his judgment, shall be desirable.
- d. The Chief of the Fire Department may request and shall receive so far as may be necessary, in the discharge of his duties, the assistance and cooperation of other officials of the community.

Section 3. Definitions.

- a. Wherever the word "Municipality" is used in the Fire Prevention Code, it shall be held to mean the Town of Exeter, New Hampshire.
- b. Wherever the term "Corporation Counsel" is used in the Fire Prevention Code, it shall be held to mean the attorney(s) for the Town of Exeter, New Hampshire.

Section 4. Establishment of Limits of Districts in which Storage of Explosives and Blasting Agents is to be Prohibited.

The limits referred to in Section 12.5b of the Fire Prevention Code, in which storage of explosives and blasting agents is prohibited, are hereby established as follows:

The areas within the urban compact zone as defined by the New Hampshire Department of Public Works and Highways.

Section 5. Establishment of Limits of Districts in which Manufacture and Storage of Fireworks is to be Prohibited.

The limits referred to in Section 13.3a of the Fire Prevention Code, in which manufacture and storage of fireworks is prohibited, are hereby established as follows:

All except the Industrial Districts as shown on the Exeter Zoning Map, and as amended.

Section 6. Establishment of Limits of Districts in which Storage of Flammable Liquids in Outside Aboveground Tanks is to be Prohibited.

- a. The limits referred to in Section 16.22a of the Fire Prevention Code in which storage of flammable liquids in outside aboveground tanks is prohibited, are hereby established as follows:

All residential districts and commercial districts.

- b. The limits referred to in Section 16.61 of the Fire Prevention Code, in which new bulk plants for flammable or combustible liquids are prohibited, are hereby established as follows:

All residential districts and commercial districts.

Section 7. Establishment of Limits in which Bulk Storage of Liquefied Petroleum Gases is to be Restricted.

The limits referred to in Section 21.6a of the Fire Prevention Code, in which bulk storage of liquefied petroleum gas is restricted, are hereby established as follows:

All residential districts and commercial districts.

Section 8. Establishment of Motor Vehicle Routes for Vehicles Transporting Explosives and Blasting Agents.

The routes referred to in Section 12.70 of the Fire Prevention Code for vehicles transporting explosives and blasting agents are not applicable at this time.

Section 9. Establishment of Motor Vehicle Routes for Vehicles Transporting Hazardous Chemicals or Other Dangerous Articles.

The routes referred to in Section 20.14 of the Fire Prevention Code for vehicles transporting hazardous chemicals and other dangerous articles are not applicable at this time.

Section 10. Establishment of Fire Lanes on Private Property, Devoted to Public Use.

The fire lanes referred to in Section 29.16 of the Fire Prevention Code are not applicable at this time.

Section 11. Amendments Made in the Fire Prevention Code.

Not applicable at this time.

Section 12. Modifications.

The Chief of the Bureau of Fire Prevention shall have power to modify any of the provisions of the Fire Prevention Code upon application in writing by the owner or lessee, or his duly authorized agent, when there are practical difficulties in the way of carrying out the strict letter of the Code, provided that the intent of the Code shall be observed, public safety secured, and substantial justice done. The particulars of such modification when granted or allowed and the decision of the Chief of the Bureau of Fire Prevention thereon shall be entered upon the records of the department and a signed copy shall be furnished the applicant.

Section 13. Appeals.

Whenever the Chief of the Bureau of Fire Prevention shall disapprove an application or refuse to grant a permit applied for, or when it is claimed that the provisions of the Code do not apply or that the true intent and meaning of the Code have been misconstrued or wrongly interpreted, the applicant is permitted to appeal from the decision of the Chief of the Bureau of Fire Prevention to the Zoning Board of Adjustment within 30 days from the date of the decision appealed.

Section 14. New Materials, Processes or Occupancies which Require Permits.

The Board of Selectmen, the Chief of the Fire Department and the Chief of the Bureau of Fire Prevention shall act as a committee to determine and specify, after giving affected persons an opportunity to be heard, any new materials, processes or occupancies, which shall require permits, in addition to those now enumerated in said Code.

The Chief of the Bureau of Fire Prevention shall post such list in a conspicuous place in his office, and distribute copies thereof to interested persons.

Not applicable at this time.

Section 15. Penalties.

- a. Any person who shall violate any of the provisions of the Code hereby adopted or fail to comply therewith, or who shall violate or fail to comply with any order made thereunder, or who shall build in violation of any detailed statement of specifications or plans submitted and approved thereunder, or any certificate or permit issued thereunder, and from which no appeal has been taken, or who shall fail to comply with such an order as affirmed or modified by the Chief of the Fire Department or by a court of competent jurisdiction, within the time fixed herein, shall severally for each and every such violation and noncompliance, respectively, be guilty of a misdemeanor, punishable by a fine of not less than \$10, nor more than \$100, or by imprisonment for not less than one day nor more than 30 days or by both such fine and imprisonment. The imposition of one penalty for any violation shall not excuse the violation or permit it to continue; and all such persons shall be required to correct or remedy such violations or defects within a reasonable time; and when not otherwise specified, each one day that prohibited conditions are maintained shall constitute a separate offense.
- b. The application of the above penalty shall not be held to prevent the enforced removal of prohibited conditions.

Section 16. Repeal of Conflicting Ordinances.

All former ordinances or parts thereof conflicting or inconsistent with the provisions of this ordinance or of the Code hereby adopted are hereby repealed.

Amendments to the Fire Prevention Code

Amend the following sections to read as follows:

A permit for this section is not required: Sections 2.2; 3.2; 4.2; 5.2; 6.2; 7.2; 8.2; 9.2; 10.2; 15.12; 17.2; 18.3; 19.2; 25.3; 26.3; 29.1; 30.3; 30.7; 30.15; 30.18.

Amend Section 16.76-d, to read as follows:

Special Regulations for Attended Self-Service Gasoline Dispensing Stations

- a. Every person, firm or corporation who intends to construct, reconstruct, or alter any service station to provide attended self-service gasoline dispensing shall furnish the Bureau of Fire Prevention with plans of such proposed

- station that shall include the location of the pump island in respect to the control console and location of fire extinguishing control.
- b. Every gasoline service station shall be under the direct control of the owner, operator or duly authorized employee who shall be on duty at all times while gasoline is being sold or dispensed.
 - c. Each installation shall be equipped with a fixed fire extinguishing system installed in accordance with the appropriate NFPA Code. Said system shall provide protection for all pumps in the dispensing area. Each extinguisher head shall be installed in such a manner that an accumulation of ice or snow will not adversely affect the proper functioning of the system.
 - d. No more than eight (8) dispensing nozzles shall be under the control of one operator.
 - e. The controlling mechanism console and its related equipment are to be of an approved type.
 - f. Gasoline shall be dispensed only by a competent licensed motor vehicle operator or by a qualified station attendant.
 - g. Instructions for the operation of dispensers shall be conspicuously posted, and in addition, signs bearing the words "Extinguish All Smoking Materials; Shut Off Engine" in block letters at least two (2) inches in height shall be conspicuously posted at both ends of the pump island visible to approaching vehicles.
 - h. The controlling console providing power to the pump motor shall be constantly attended by the owner, operator or duly authorized employee while gasoline is being dispensed and shall be properly protected against physical damage from motor vehicles.
 - i. There shall be constant contact between the control console operator and the pump island by means of intercommunication system which shall be maintained in proper operating condition at all times.
 - j. The control console operator must observe the filling operation of each vehicle. Mirrors are not acceptable as providing adequate visual control.
 - k. The control console shall include a disconnect switch which will instantly cut off all pumping power.

- l. No other method of self-service gasoline dispensing will be permitted.

ARTICLE 13 — *Zoning Amendment #5*

To see if the Town will vote to amend the Town of Exeter Life Safety Code as proposed by the Planning Board as follows:

Amend the "Life Safety Code NFPA #101" as adopted at the Sept. 16, 1975, Special Town Meeting, to include:

- a. "the 1976 edition"
- b. "to rescind the Sept. 16, 1975, amendment, thereby making the provisions of the Life Safety Code applicable to a "Two-Family Dwelling" by adopting the provisions of Section 11-6, as applicable, as recommended by the Fire Chief.
- c. A new section to be numbered 1-6 and titled "Penalties" to read as follows:

1.6 Penalties.

- a. Any person who shall violate any of the provisions of the Code hereby adopted or fail to comply therewith, or who shall violate or fail to comply with any order made thereunder, or who shall build in violation of any detailed statement of specifications or plans submitted and approved thereunder, or any certificate or permit issued thereunder, and from which no appeal has been taken, or who shall fail to comply with such an order as affirmed or modified by the Chief of the Fire Department or by a court of competent jurisdiction, within the time fixed herein, shall severally for each and every such violation and noncompliance, respectively, be guilty of a misdemeanor, punishable by a fine of not less than \$10, nor more than \$100, or by imprisonment for not less than one day nor more than 30 days or by both such fine and imprisonment. The imposition of one penalty for any violation shall not excuse the violation or permit it to continue; and all such persons shall be required to correct or remedy such violations or defects within a reasonable time; and when not otherwise specified, each one day that prohibited conditions are maintained shall constitute a separate offense.
- b. The application of the above penalty shall not be held to prevent the enforced removal of prohibited conditions.

ARTICLE 14 — *Zoning Amendment #6*

To see if the Town will vote to amend the Town of Exeter Building Code as proposed by the Planning Board as follows:

Amend Section 3 of the Exeter Building Code to add a new section, number 3.13 entitled **Certificate of Occupancy**.

Purpose

To insure that buildings and structures comply with the standards and codes of the Town of Exeter and to promote the health, safety, and welfare of occupants in such buildings, this ordinance intends to regulate occupancy and change of occupancy or use for buildings, structures or parts thereof by requiring the issuance of a Certificate of Occupancy prior to habitation, use or occupancy as set forth herein.

A. Certificate of Occupancy

1. Every building that is constructed, remodeled, repaired, or renovated to the extent that a building permit is required (per Sec. 3.1), and that is designed for human habitation or use, must have a certificate of occupancy signed by the Building Inspector. The certificate shall be issued only after the Building Inspector makes a finding that the dwelling unit has been constructed or structurally altered so as to be habitable and in compliance with the provisions of this ordinance and all other health, safety and building codes effective in Exeter.
2. No change shall be made in the use of an existing building, part thereof, or dwelling unit, nor shall any such use of a building commence until a certificate of occupancy has been issued by the Building Inspector. No change of use shall be permitted unless it is in conformity with the provisions of the codes and rules of the Town of Exeter.

B. Administration

1. It shall be the responsibility of the owner or his authorized agent to make application to the Building Inspector. Applications for a certificate of occupancy shall be on forms provided for the issuance of a building permit. A change of use shall require application for a certificate of occupancy, whether or not construction or alterations are necessary to accommodate the intended use.
2. The Building Inspector will distribute one

copy each to: (a) the Planning Board; (b) the Fire Department; (c) the Health Department; (d) the Housing Code Board; and shall indicate thereon his recommendation for an inspection.

3. Any or all of the above may make an inspection of the premises. Arrangements may be made among the departments to designate one or more persons to act on behalf of any department or all such departments when appropriate. Results of the inspections shall be promptly reported in writing to the Building Inspector and made available to the applicant.
4. Prior to issuing a certificate of occupancy, the Building Inspector shall determine that deficiencies reported after inspection have been corrected in accordance with the requirements of the codes, ordinances and regulations effective in the Town of Exeter and as required by the State of New Hampshire, including but not limited to: the National Building Code and its referenced Electrical and Plumbing Codes, the Exeter Zoning Ordinance, Regulations for Non-residential Development of the Subdivision Regulations, the Life Safety Code, the Fire Prevention Code and, if a rental unit, the Exeter and New Hampshire Housing Codes, and as these codes may be amended.
5. Departments shall have three (3) working days following date of application to perform necessary inspections and report to the Building Inspector. Within the fifth working day following the application, the Building Inspector shall issue to the applicant a list of requirements necessary to bring the structure up to code. Upon request of the applicant, a final inspection shall be made by the Building Inspector or his representative to verify conformance with all requirements. Following this inspection, the Building Inspector shall:
 - a. find the building in compliance with applicable ordinances, codes and regulations and issue a certificate of occupancy; or
 - b. find the building to be in substantial compliance with the applicable ordinances, codes and regulations and issue a 30-to-90 day temporary occupancy, listing the cor-

- rective measures necessary; or
- c. deny a certificate of occupancy and order correction of deficiency(s) prior to the occupancy thereof.

6. Appeals

Appeal may be taken to the Board of Adjustment.

7. Fees

A fee of \$5.00 shall be paid to the Building Inspector.

8. Issuance — for Rental Units

The owner or his authorized agent shall post on the premises in a conspicuous location any 'temporary' certificate of occupancy.

9. Effective Date

This ordinance shall take effect thirty (30) days after its passage.

ARTICLE 15 — Zoning Amendment #7

To see if the Town will vote to amend the Town of Exeter Building Code as proposed by the Planning Board as follows:

Amend Section 3.10 of the Building Code Administrative section of the Town of Exeter, by changing the fee from \$2.00 per thousand to \$4.00 per thousand and to include mobilehomes and replacement of mobilehomes at this rate, also requiring a flat fee of \$1.00, for the replacement of boiler, oil burners or furnaces, so that it reads:

3.10 Fees. For each permit issued by the Building Inspector, a fee of \$4.00 per thousand of estimated value shall be charged for such a permit, including new mobilehomes and replacement mobilehomes. A fee of \$1.00 for boilers, oil burners or furnaces shall be required.

ARTICLE 16 — Zoning Amendment #8

To see if the Town will vote to amend the Town of Exeter Zoning Ordinance as proposed by petition of Harold Carbonneau, and others, as follows:

To see if the voters shall vote to amend the zoning ordinance to change the zoning use classification of the property located at 2 Lincoln St. from R-2 to C-1.

The Planning Board disapproves this petition.

ARTICLE 17 — Zoning Amendment #9

To see if the Town will vote to amend the Town of Exeter Zoning Ordinance and the Zoning Map, as proposed by petition of Andrea C. Poliquin and others, as follows:

To amend the Exeter Zoning Ordinance and the

Zoning Map incorporated therein so as to include within the Industrial District the premises which are bounded southerly by the Hampton Rd., westerly by land of Prosper-Shevenell & Son, Inc., northerly by the Manchester-Hampton Express Bypass and easterly by land of David and Helen Maginnes and Beatrice A. Rollins and also to include within the Industrial District those premises situated on the southerly side of Hampton Rd. presently standing in the name of William O. Dawson (doing business as Chemtan Company), James W. Colcord, Ezra P. Colcord and Arlene L. Colcord and Robert S. and Patricia Colcord.

The Planning Board disapproves this petition.

ARTICLE 18 — Zoning Amendment #10

To see if the Town will vote to amend the Town of Exeter Zoning Ordinance and Zoning Map as proposed by petition of Andrea C. Poliquin and others, as follows:

To amend the Exeter Zoning Ordinance and the Zoning Map incorporated therein so as to include within the C-2 Commercial District the premises which are bounded southerly by the Hampton Rd., westerly by land of Prosper-Shevenell & Son, Inc., northerly by the Manchester-Hampton Express Bypass and easterly by land of David and Helen Maginnes and Beatrice A. Rollins and also to include within the C-2 Commercial District those premises situated on the southerly side of Hampton Rd. presently standing in the name of William O. Dawson (doing business as Chemtan Company), James W. Colcord, Ezra P. Colcord and Arlene L. Colcord and Robert S. and Patricia Colcord.

The Planning Board disapproves this petition.

ARTICLE 19 — Zoning Amendment #11

To see if the Town will vote to amend the Town of Exeter Building Code as proposed by the Planning Board as follows:

Amend Sections 3.1 and 3.11 as follows:

A. Amend Section 3.1 to make the basic exemption for a building permit \$1,500, so that it reads: ". . . to the extent of fifteen hundred dollars (\$1,500) or more in value. . ."

Amend Section 3.11 Repairs by inserting the following:

3.11 Repairs. Repairs may be made without filing an application or obtaining a permit. Shingling a roof will come under Section 3.11 Repairs, and will require no permit.

ARTICLE 20

On petition of Joseph A. Gorski and others, to see if the Town will vote to adopt the following Article: "Shall we adopt the provisions of RSA 654:34-a permitting changes in party affiliation to be made with the Town Clerk?"

ARTICLE 21

Shall we adopt the provisions of RSA 466:30-a which makes it unlawful for an owner of any dog licensed or unlicensed to allow said dog to run at large, except when accompanied by the owner or custodian, and when used for hunting, herding, supervised competition and exhibition or training for such?

ARTICLE 22

To choose all other necessary Town Officers, Auditors, or Committees for the ensuing year.

ARTICLE 23

To see what sums of money the Town will raise and appropriate for the maintenance of the poor, for repairing and building bridges, for repairing and building sidewalks, for building drains and sewers, for oiling streets, for payment of the Town debts, for lighting streets, for defraying expenses of decorating the graves of soldiers, for payment of firemen for the ensuing year, and for other charges arising within the Town.

ARTICLE 24

On petition of Jane T. Veale and others, to see if the Town will vote to raise and appropriate the sum of Thirty-eight Thousand Fifty-two (\$38,052.00) Dollars to be used for schematic design and design development for the renovation and reconstruction of the Exeter Public Library.

ARTICLE 25

To see if the Town will vote to raise and appropriate the sum of Ninety Thousand (\$90,000.00) Dollars for the purpose of construction of an addition to the Exeter Recreation Building and to authorize the selectmen to expend such sums for this purpose as they in their judgment deem advisable.

ARTICLE 26

To see if the Town will vote to authorize the Treasurer, with approval of the Selectmen, and pursuant to New Hampshire Revised Statutes Annotated, Section 33:7 and Section 33:7-a to incur

debt for temporary loans in anticipation of 1980 taxes, and in anticipation of any bond issue which may be voted by the Town, and to issue therefor notes of the Town payable within one (1) year after their date, and to pay or renew the same by issue of new notes payable within one (1) year after the date of the original obligation.

ARTICLE 27

To see if the Town will vote to authorize the board of selectmen to apply for, accept and expend money from the state, federal or another governmental unit or a private source which becomes available during the year in accordance with the procedures set forth in New Hampshire Revised Statutes Annotated Chapter 31, Section 95-b, such sums to be used only for legal purposes for which a town may appropriate money, and requires the selectmen to hold a prior public hearing on the action to be taken, and not require the expenditure of town funds.

ARTICLE 28

To see if the Town will vote to authorize the selectmen to expend funds held in the Capital Reserve Fund plus interest as needed for the improvement, construction, reconstruction, including drainage and appurtenances of town streets and roads and to authorize the selectmen to expend such funds as in their judgment they deem advisable.

ARTICLE 29

To see if the Town will vote to authorize the selectmen to expend not more than Fifty Thousand (\$50,000.00) Dollars from the funds held in the Capital Reserve Fund for the improvement and reconstruction of town streets and roads for the purpose of construction of a storm drainage project to the river from Highland St., Prospect St., Auburn St., Portsmouth Ave., and Hall Pl.

ARTICLE 30

To see if the Town will vote to establish a Capital Reserve Fund in the sum of Fifteen Hundred (\$1,500.00) Dollars from the proceeds of the funds paid to the Town by Bell & Flynn for the purpose of extending and repairing the fire alarm system at Academy Estates and to authorize the selectmen to expend such funds as in their judgment they deem advisable.

ARTICLE 31

To see if the Town will vote to receive, accept, and appropriate the sum of Two Hundred Ten Thousand (\$210,000.00) Dollars from the monies to be received in 1980 from Federal Revenue Sharing Trust Funds plus interest accrued from Revenue Sharing Trust Funds received in prior years, for payment of principal and interest which become due in 1980 with respect to the outstanding bonds of the Public Safety Complex, with any surplus of funds to be used and held in reserve for future payments of principal and interest on the outstanding bonds of the Complex.

ARTICLE 32

To see if the Town will vote to fix the annual salary of the Tax Collector at Twelve Thousand Eight Hundred Three (\$12,803.00) Dollars, and to raise and appropriate an additional sum of Nine Hundred Twenty-six (\$926.00) Dollars above the sum budgeted therefor.

ARTICLE 33

To see if the Town will vote to set the annual rate of compensation of the Town Clerk at Sixteen Thousand Six Hundred Forty-one and fifty hundredths (\$16,641.50) Dollars, and to raise and appropriate the sum of One Thousand One Hundred Twenty-six (\$1,126.00) Dollars above the sum budgeted therefor.

ARTICLE 34

On petition of Ann H. Warren and others, to see if the Town will vote to fix the annual salary of the Selectmen at Two Thousand (\$2,000.00) Dollars per year and to raise and appropriate an additional Twenty-five Hundred (\$2,500.00) Dollars above the sum budgeted therefor.

ARTICLE 35

To see if the Town will vote to raise and appropriate the sum of Thirteen Thousand Seventy-eight and thirty-three hundredths (\$13,078.33) Dollars for the purpose of mosquito control for the ensuing year.

ARTICLE 36

To see if the Town will vote to raise and appropriate the sum of Twelve Thousand Three Hundred Sixty-six (\$12,366.00) Dollars as partial reimbursement to the Exeter Area Visiting Nurse Association, Inc., for providing continued home

health care services to residents of the Town of Exeter.

ARTICLE 37

To see if the Town will vote to raise and appropriate the sum of Six Thousand Four Hundred Fifty-one and eighty hundredths (\$6,451.80) Dollars as its contribution to the Southeastern New Hampshire Regional Planning Commission.

ARTICLE 38

To see if the Town will vote to adopt a Housing Code for the Town of Exeter as follows:

Housing Code — Town of Exeter

Purpose:

WHEREAS there is no comprehensive ordinance or code regulating minimum standards for occupancy, facilities and maintenance in dwelling units of the Town of Exeter, and

WHEREAS the Town Meeting of the Town of Exeter finds that there exist within the municipality dwellings unfit for human habitation due to dilapidation, dangerous defects likely to result in fire, accidents or other calamities, and other defects dangerous or unhealthful to its citizens, and that the Town is in need of a code to cause repair, closing, demolition or removal of such dwellings and to prevent substandard conditions from developing or continuing:

NOW, THEREFORE, the Town of Exeter Ordains:

ARTICLE I ADMINISTRATION

A. A public agency to be known as the Housing Code Board is hereby created, pursuant to RSA 48A composed of the Health Officer, the Fire Chief and the Planning Director.

B. The position of Housing Code Enforcement Officer is hereby created, appointment to be made by the Exeter Board of Selectmen.

C. The Housing Code Enforcement Officer, upon receiving notice of a suspected violation of this code, is hereby authorized to take such steps as appropriate under RSA 48A, 1-13, to enforce the provisions of this code.

D. In order that he may perform his statutory duty of safeguarding the health and safety of the occupants of the dwelling and general public, the Housing Code Enforcement Officer or his authorized representative is hereby empowered and directed to make inspections to determine the

conditions of dwellings and premises located within the Town, and, to that end, to enter, examine and survey at reasonable times all such dwellings and premises within the Town.

The officer shall notify the owner so as to arrange an inspection of the premises in the company of the owner.

The Housing Code Enforcement Office may obtain an order from a court of competent jurisdiction in the event entry is denied or restricted.

E. Whenever a petition is filed with the Housing Code Board by at least 10 residents of the municipality charging that any dwelling is unfit for human habitation or whenever it appears to the Housing Code Board by inspection that any dwelling is unfit for human habitation, it shall, if preliminary investigation discloses a basis for such charges, issue and cause to be served upon the owner, every mortgagee of record and all parties in interest in such dwelling (including persons in possession) a complaint stating the charges in that respect. If the person to be served resides outside the state, service may be made upon him by registered mail, and if there are any unascertained persons having an interest in said dwelling, notice may be given them by publication in a newspaper having general circulation in the municipality, such publication to be at least 10 days before the date set for the hearing. Such complaint shall contain a notice that a hearing will be held before the Housing Code Board at a place therein fixed not less than 10 days nor more than 30 days after the serving of said complaint; that the owner, mortgagee and parties in interest shall be given the right to file an answer to the complaint and to appear in person, or otherwise, and give testimony at the place and time fixed in the complaint; and that the rules of evidence prevailing in courts of law or equity shall not be controlling in hearings before such Housing Code Board.

F. If, after such notice and hearing, the Housing Code Board determines according to the standards of the code that the dwelling under consideration is unfit for human habitation, it shall state in writing its findings of fact in support of such determination and shall issue and cause to be served upon the owner thereof an order which, if the repair, alteration or improvement of the said dwelling can be made at a reasonable cost in relation to the value of the dwelling and the ability of the owner to

assume such cost, requires the owner within the time specified in the order, to repair, alter, or improve such dwelling to render it fit for human habitation or to vacate and close the dwelling as a human habitation; or if the repair, alteration or improvement of the said dwelling cannot be made at a reasonable cost in relation to the value of the dwelling and the ability of the owner to assume such cost, requires the owner, within the time specified in the order to remove or demolish such dwelling.

G. If an owner is aggrieved by an order of the Housing Code Board made pursuant to Section F hereof, he may appeal to the Board of Selectmen. Said Board of Selectmen shall hold a public hearing upon said appeal, due notice of said hearing having first been given to the Housing Code Board and to the owner. The Board of Selectmen may affirm or revoke the order of the Housing Code Board, or they may modify the same in accordance with their findings. If they shall affirm or modify such order, the Housing Code Board shall proceed to enforce said order as affirmed or so modified. If the Board of Selectmen shall revoke said order, the proceedings shall be terminated.

H. Nothing under this ordinance shall be construed to restrict rights of landlords as defined under N.H. RSA 540-A.

ARTICLE II MINIMUM STANDARDS ESTABLISHED

A. The following sub-standard conditions, as specified by RSA 48-A:14 (and as amended) for rental units, shall not occur in any dwelling unit within the Town of Exeter:

1. The premises are infested by insects and rodents, for which infestation the landlord is not conducting a periodic inspection and eradication program;
2. There is defective internal plumbing or a back-up of sewage caused by a faulty septic or sewage system;
3. There are exposed wires, improper connectors, defective switches or outlets or other conditions which create a danger of electrical shock or fire;
4. The roof or walls leak consistently;
5. The plaster is falling or has fallen from the walls or ceilings;
6. The floors, walls or ceilings contain substantial holes that seriously reduce their function

- or render them dangerous to the inhabitants,
7. The porches, stairs or railings are not structurally sound;
 8. There is an accumulation of garbage or rubbish in common areas resulting from the failure of the landlord to remove or provide a sufficient number of receptacles for storage prior to removal unless the tenant has agreed to be responsible for removal under the rental agreement and the landlord has removed all garbage at the beginning of the tenancy;
 9. There is an inadequate supply of water, or whatever equipment that is available to heat water is not properly operating;
 10. There are leaks in any gas lines or leaks or defective pilot lights in any appliances furnished by the landlord; or
 11. There are heating facilities that are improperly installed, unsafely maintained and in poor working condition, and are incapable of safely and adequately heating all habitable rooms, bathrooms and toilet rooms located therein, to a temperature of at least an average of 65 degrees F.; or, when the landlord supplies heat in consideration for the rent, the premises are not actually maintained at a minimum average room temperature of 65 degrees F. in all habitable rooms.*

GENERAL PROVISIONS

1. Sanitary Facilities

Each dwelling unit shall have available a room or rooms which afford privacy and are equipped with a toilet, lavatory basin and bath or shower unit, supplied with hot and cold running water. All such facilities shall be in proper operating condition and connected to water and sewage systems approved by the Health Inspector. Such facilities above described shall not be shared by more than six (6) persons living therein, except in a single-family dwelling unit.

2. Food Preparation and Refuse Disposal

When a dwelling or lodging unit contains kitchen and cooking facilities, there shall be suitable space and equipment to store, prepare and serve foods in a sanitary manner. The unit shall contain a kitchen sink with hot and cold running water, cooking stove or range, and refrigerator; and facilities for sanitary disposal of food waste and refuse shall be provided by the owner or tenant.

3. Space and Security

The dwelling unit shall afford the occupants adequate space and security. There shall be a living room, kitchen area and available bathroom facilities; and the dwelling unit shall contain at least one sleeping or living/sleeping room of appropriate size for each two persons. Exterior doors and windows accessible from outside the unit shall be lockable.

4. Illumination and Electricity

Each room shall have adequate natural or artificial illumination. Adequate electrical service and outlets shall be provided to permit use of essential electrical appliances while assuring safety from fire.

Living and sleeping rooms shall include at least one window. A ceiling or wall light fixture shall be present and working in the bathroom and kitchen area. At least two electric outlets, one of which may be an overhead light, shall be present and operable in the living area, kitchen area and each bedroom area.

5. Structure and Materials

The dwelling shall be structurally sound so as not to pose any threat to the health and safety of the occupants and so as to protect the occupants from the environment. Ceilings, walls and floors shall not have any serious defects, such as severe bulging or leaning, large holes, loose surface materials, severe buckling or noticeable movement under walking stress, missing parts or other serious damage. The roof structure shall be firm and the roof shall be weathertight. The exterior wall structure and exterior wall surface shall not have any serious defects, such as serious leaning, buckling, sagging, cracks or holes, loose siding or other serious damage. The condition and equipment of interior and exterior stairways, halls, porches, walkways, etc. shall be such as not to present a danger of tripping or falling. Elevators shall be maintained in a safe and operating condition.

6. Interior Air Quality

The dwelling shall be free from dangerous levels of air pollution from carbon monoxide, sewer gas, fuel gas, dust and other harmful air pollutants. Air circulation shall be adequate throughout the unit. Bathroom areas shall have at least one openable window or other adequate exhaust ventilation.

7. Water Supply

The dwelling shall be served by an approved

public or private sanitary water supply, free of contamination.

8. Lead-Based Paint

If a dwelling unit presents a hazard from lead-based paint, measures to remove said hazard shall be taken.

9. Access and Egress

Every dwelling shall have a safe, unobstructed means of egress to a safe and open space at ground level. Access and egress to dwelling units and passage thereto shall not lead through any other dwelling unit or through a space that might reasonably be locked by anyone who is not a member of the household.

ARTICLE IV PENALTY

Any person violating any of the provisions of this ordinance, or failing, or neglecting, or refusing to obey any lawful order of direction of a person authorized to investigate and enforce the provisions of this ordinance shall be guilty of a misdemeanor and shall be subject to a fine of not less than \$10 nor more than \$20, and each day's violation shall be a separate offense.

ARTICLE V EFFECTIVE DATE

This ordinance shall take effect thirty (30) days after its passage.

ARTICLE 39

To see if the Town will vote to authorize the Selectmen to sell premises located on the westerly side of Brentwood Rd., so-called, (which appears on the Town of Exeter Assessment Map 07-02 as parcel 005.002) and containing .84 acres of land, more or less, and being the premises formerly owned by Arthur W. Dudley, Heir, and a portion of the premises acquired by the Town by Tax Collector's deed dated July 21, 1978, said sale to be effected pursuant to New Hampshire Revised Statutes Annotated, Chapter 80, Section 42, I and III.

ARTICLE 40

To see if the Town will vote to authorize the selectmen to enter into an agreement with the State of New Hampshire to grant the State of New Hampshire the right to enforce for a period of twenty (20) years certain restrictive covenants with respect to use, maintenance and preservation of the Town Hall in which the Town agrees it will make no alterations, nor construct any additions, nor change the present use of the building; nor subdivide the premises,

without prior consent of the State and further agree to repair, maintain and restore and rehabilitate the premises in the event of damage or destruction.

ARTICLE 41

To see if the Town will vote to indemnify and save harmless from loss or damage, all Town employees, officers and officials from personal financial loss and expense including reasonable legal fees and costs, if any, arising out of any claim, demand, suit or judgment by reason of any act or omission constituting the violation of the civil rights of any officer or employee, or any other person under any federal law if such act was not committed with malice, and if the indemnified person at the time of such act or omission was acting within the scope of his employment or office, or by reason of negligence or other act resulting in accidental injury to a person or accidental damage to or destruction of property if the indemnified person at the time of the accident resulting in the injury, damage or destruction was acting in the scope of his employment or office, and authorize the selectmen to purchase such insurance as may be available for such purpose as in their judgment they deem advisable.

ARTICLE 42

To see if the Town will vote to discontinue as an open highway Jolly Rand Rd., so-called, and subject such road to gates and bars.

ARTICLE 43

On petition of M. Sheila Duff and others, to see if the Town will vote to designate Jolly Rand Rd., so-called, from Brentwood Rd. to Kingston Rd. at the junction of Pickpocket Rd. as scenic under the provisions of RSA 253:17, 18 for the purposes of protecting and enhancing the scenic beauty of Exeter.

ARTICLE 44

On petition of M. Sheila Duff and others, to see if the Town will vote to designate John West Rd., otherwise known as East Kingston Rd., from the Kingston Rd. to the Exeter Town line as scenic under the provisions of RSA 253:17, 18, for the purposes of protecting and enhancing the scenic beauty of Exeter.

ARTICLE 45

On petition of Burton MacArthur and others, to

see if the Town will vote to authorize the Selectmen to cause Stoneywater Rd. to be plowed, salted and sanded, so that access for emergency vehicles will be available and to provide access to fire hydrants and water mains for the protection of the residents of said road.

ARTICLE 46

On petition of Frank J. Kozacka and others, to see if the Town will vote to raise and appropriate the sum of Twenty-five Thousand (\$25,000.00) Dollars for the use of the Conservation Commission to enable it to purchase land, easements, or water rights which it deems to be in the public interest, and in order to preserve open space and natural resources of the Town and to provide sites for open space and recreation.

ARTICLE 47

On petition of Frank J. Kozacka and others, to see if the Town will vote to authorize the Conservation Commission to apply for, secure and accept such state funds or federal funds as may be available from the State of New Hampshire Heritage Conservation Recreation Services, or any other sources and to spend therefrom up to the sum of Ten Thousand (\$10,000.00) Dollars for the purpose of acquiring land, easements, or water rights, in order to preserve open space and natural resources in the Town.

ARTICLE 48

To see if the Town will vote to authorize the selectmen to convey to E. Leslie and Dorothy K. Hall an easement which is a passageway seven feet wide owned by the Town and running from High St. across the easterly side of premises of E. Leslie and Dorothy K. Hall situate on the south side of High St. which is reserved "for the benefit of the inhabitants of the Town for the purpose of conveying water from fresh river" now known as Exeter River for the sum of One Hundred (\$100.00) Dollars to be paid to the Town of Exeter Conservation Fund.

ARTICLE 49

To see if the Town will vote to authorize the selectmen to purchase from Sarah J. and Ralph L. Jewell heirs for the sum of Five Thousand Seven Hundred (\$5,700.00) Dollars the premises on Cross Rd. which is a gravel pit from which the Town has a right to take gravel.

ARTICLE 50

To see if the Town will vote to authorize the selectmen to purchase land and/or land and buildings which may be available for the purpose of rehabilitation, reconstruction or development of four units, more or less, of low and moderate income housing providing federal funds for this purpose are available, and to authorize the selectmen to transfer to the Exeter Housing Authority such housing upon completion of reconstruction, rehabilitation or development on terms as are in the best interest of the town, and to execute such instruments and deeds as may be necessary to carry out the purpose of this vote.

ARTICLE 51

To see if the Town will vote to authorize the fire chief to send fire apparatus out of town and receive fire apparatus from other towns on a donated basis and to authorize the fire chief to execute a mutual aid agreement with the fire departments of other municipalities pursuant to New Hampshire Revised Statutes Annotated, Chapter 154, Sections 24 through 30-h.

ARTICLE 52

On petition of Joseph F. Kenick, Jr., and others, to see if the Town will vote to raise and appropriate the sum of Nineteen Thousand Three Hundred and Fourteen (\$19,314.00) Dollars for the Town's participation in the expenses of the Exeter Area Youth Group Home.

ARTICLE 53

On petition of Kenneth V. Vance and others, to see if the Town will vote to raise and appropriate the sum of Two Hundred Fifty (\$250.00) Dollars for contribution to the Portsmouth-Kittery Armed Services Committee, Inc., a non-profit organization.

ARTICLE 54

On petition of Ethel Doe and others to see if the Town will vote to raise and appropriate the sum of Four Thousand One Hundred Twelve and Fifty Hundredths (\$4,112.50) Dollars to assist Rockingham Child and Family Services, a private, non-profit Social Service Agency.

ARTICLE 55

On petition of Barbara Oliver and others, to see if the Town will vote to raise and appropriate the sum of Three Thousand Five Hundred (\$3,500.00)

Dollars to Rockingham County Community Action Program, Inc.

Selectmen

During the final year of the decade the policies of the town established by Town Meeting continued as in the past to be carried out by the network of people, elected, appointed, and volunteer, who in the aggregate have contributed hundreds of hours, in almost all cases without cost to the taxpayer. Reports of the formal boards, commissions, and committees are included under their respective headings. The Board of Selectmen keeps informed of activities and problems by participation in meetings and discussions. Citizen involvement in this aspect of town affairs gives all of us valuable benefits; identification of present and foreseeable problems, an opportunity for controversy and where possible a definition of issues arising from different points of view, and consideration of courses of action that may be presented to the selectmen or Town Meeting.

For its part in this political process, the Board of Selectmen has invited and has welcomed the appearance of citizens at its regular meetings, without formality or prior arrangements. This board is well aware that it is the only level of government to which citizens have immediate access, where they can be heard at once on complaints, grievances, and comments favorable or otherwise. The board cannot guarantee immediate action, however, for New Hampshire law limits the areas of administrative decision in many matters. Some matters are considered by selectmen in executive session rather than in the regular open meetings, notably requests for tax abatements. The decisions of the board become public at a later date. Abatements are often

difficult questions; the board must arrive at decisions equitable to individuals, businesses, and others who seek relief, as well to the great majority of taxpayers who are affected by each abatement.

Selectmen accepted with regret the resignation of the Town Treasurer Mr. Homer Snell, and appointed Mr. Donald Brabant to serve for the unexpired portion of Mr. Snell's term.

The selectmen can report that the town continues to be served well by its employees. The level of efficiency and initiative is good, and we believe that in general performance of duties is equally so. This reflects good supervision by the town manager and the several department heads. Selectmen routinely see all performance evaluations and may, and do, ask questions of the rating officer. The town manager is a major element in this process; he has been frank and forthright in his dealings with both employees and the board in the sometimes sensitive decisions involving people.

This is not to say that everything is perfect, nor that it is possible to resolve everything to the satisfaction of everyone. Two policy decisions during the year clearly did not satisfy everyone, that on limiting participation on the Exeter Swim Team to Exeter residents, and the split decision declaring that the board believed that town's interests would best be served by the police chief's not serving as a call fireman. The view of the majority was that the primary responsibility of the chief was of paramount importance to the town, and that that responsibility should not be compromised by any other service. This vote was not a

judgment on his ability or on the need for call firemen. Both are unquestioned.

Another factor was introduced into town employee affairs by the vote of the police to join the AFL-CIO affiliated American Association of State, County, and Municipal Employees. The results of this action, taken in November, were not known by the end of the year, since the only action the town had taken by that date was to address a letter to the state body charged with certification of government employee organizations.

The board has informally discussed, without any conclusion, the desirability of adding an engineer to the salaried staff. The nature and cost of engineering work now being let by contract appear to some to warrant such a decision; another factor is the services which could be made available to several town departments by a qualified civil engineer.

The board adopted several ordinances during the year. That redefining parking in the vicinity of the high schools followed study and consideration by a joint effort of the School Board and Selectmen. Through the actions of the former, the dangerous and aggravating situation on Linden St. has been greatly alleviated, and the new parking regulations have helped also. The police department has codified parking and speed limit ordinances into a single regulation, superseding, by the vote of the selectmen, all previous, separate ordinances.

Selectmen adopted the first comprehensive town ordinance regulating taxicab operations, effective Jan. 1, 1980. Also, pursuant

to the vote at the town meeting of March, 1979, selectmen negotiated and concluded a franchise for cable television in the town, which is expected to be in operation in the coming year.

Work on the town dump continued, and its scope and nature expanded considerably in proportion to concern, by no means confined to Exeter, over hazardous and toxic wastes. The town contracted for the services of Gidlab, Fairhaven, Mass., for study of the present site, improvement of operations, survey of local waste production and disposal, and recommendations for short and long term solutions. The assembling of data was accomplished with the full cooperation of local businesses and institutions, to all of which the board expresses the town's thanks. Work at the dump was effectively carried out by the highway department. Some of the proposals for local handling of hazardous waste, to be acted upon by town meeting, have aroused some controversy. In the absence of any promising regional approach to a constantly growing problem, the board believes that local action is imperative, and that any ordinance must provide for enforceable restrictions on use of town facilities.

At the end of the year, negotiations were nearly complete for the renovation of the Town Hall. The board decided to go ahead with work on the front porch using only available town funds rather than on the larger scope of work proposed by the architect. A reason for the decision was opinion of town counsel that only town meeting could authorize the board to sign the covenants required by the Federal government before advancing federal

funds. The board will present an appropriate warrant article to town meeting in order to continue this project.

The police and fire departments report separately on their respective activities, which during 1979 started to operate from a joint facility, formally opened in March. There have been some mechanical problems . . . fire bay doors not visible from central dispatch, distribution of heat . . . but none, so far as the Board of Selectmen is aware, arising from a lack of cooperation between the departments. They are to be commended for their adaptation to unfamiliar working conditions.

Selectmen have been involved in the projects of the Exeter Housing Authority, especially in disposition of municipal property on the site of the former town sheds, which will be the site of the housing for the elderly actively pursued by the housing authority. The board has also had occasion to discuss with the authority questions of policy on nature and location of housing for low income families, in respect of which town services, especially water and sewer, are important.

The Board of Selectmen has been constantly concerned about the steady increase in the cost of all government services. Not having any privileged information on the future, except to be pretty certain that the demand for town services will grow with populations, a factor beyond the town's control, the board is in a dilemma. Where can services be decreased to avoid a tax increase? This is a topic on which the voice of the citizen is silent, and yet it is the single most important issue facing us. The succeeding board will want to

hear . . . not appealing generalities, in percentage terms, but concrete proposals.

Town Manager

The Town ended the year with a \$56,000.00 surplus. No snow in November and December and fewer tax abatement cases than anticipated made this possible.

The Pollution Abatement program has been postponed until 1984 due to lack of Federal Funds.

The Industrial Commission has leased the last 50 acres of the Industrial Park to a group of Manchester business and professional men. This will allow private developers to develop the Park; will provide funds to pay the remaining financial obligations; and any financial balance will be paid to the Town. All subdivisions in the Park will have to be approved by the Planning Board.

There may be a need for a water rate increase either later in 1980 or early in 1981. The last increase was in 1978.

I feel there is a need for a better Library building, and an expansion of the Recreation Center to service the ever increasing number of senior citizens. If Federal Revenue Sharing is extended, the Library and Recreation Center work can be done without an increase in the annual debt service payments.

The Budget Commission has set up a subcommittee to look into the Town Administrative practices to see if there may be ways to improve the operations.

The Selectmen have recommended that there be a revaluation in 1981.

This should be done as property values are changing very rapidly. As painful as it is, a revaluation is a lot worse if it goes too long between updates.

The Selectmen have requested energy audits of all buildings to see if there are ways to cut down energy use.

I would like to thank the Selectmen, Department Heads, Town employees, Boards and Commissions, and Citizens of Exeter for the kindness extended to me during the year.

I have examined the financial statements of the various funds and groups of accounts of the Town of Exeter for the year ended December 31, 1979 in the foregoing table of contents. My examination was made in accordance with generally accepted auditing standards, and accordingly included such tests of the accounting records and such other auditing procedures as I considered necessary in the circumstances.

The Town of Exeter has not maintained a record of its general fixed assets, and accordingly a statement of general fixed assets, required by generally accepted accounting principles, is not included in the financial report.

In addition, the Town has not capitalized the cost of all property and equipment purchased by the water and sewer department. No depreciation is recorded on those assets not properly capitalized. Generally accepted accounting principles require that property and equipment of enterprise funds be capitalized and depreciated over the useful lives of the assets.


Since I was unable to determine the cost value of property and equipment and depreciation charges for all capital assets in both the water and sewer department, as noted in the above paragraph. The scope of my work was not sufficient to enable myself to express an opinion on the water and sewer department financial statements.

In my opinion, the financial statements listed in the aforementioned table of contents, other than the financial statements of the water and sewer department, present fairly the financial position of the various funds and groups of accounts of the Town of Exeter at December 31, 1979 and the results of operations of such funds for the year then ended in conformity with generally accepted accounting principles applied on a basis consistent with that of the preceding year.

Notes to Financial Statements

Note #1 Summary of Significant Accounting Policies:

The following is a summary of significant accounting policies employed in the preparation of these financial statements.

Fund Accounting:

The diverse nature of governmental operations and the necessity of determining compliance with legal provisions requires modification of accounting systems commonly used by commercial enterprises. Rather than establishing a single unified set of accounts to record and summarize all financial transactions, the accounts of the Town are organized on the basis of funds and account groups, each of which is considered a separate entity with self-balancing accounts that comprise its assets, liabilities, reserves, fund balance, revenues and expenditures, including interfund obligations and transfers.

Operations supplying the basic services of a general governmental nature which are controlled by legal budgets are accounted for in the general fund and special revenue fund.

In addition to the general category of operations listed above, a further distinction from accounting in commercial enterprises exists with respect to capital expenditures. Capital expenditures are required to be capitalized at historical cost in a general fixed asset group of accounts primarily for control purposes. The Town has not maintained a record of its general fixed assets, and accordingly a statement of general fixed assets, required by generally accepted accounting principles, is not included in the financial report.

Fiduciary activities of the Town are accounted for in trust funds.

General obligation bonds supported by general revenues are obligations of the Town as a whole and not its individual constituent funds. Accordingly, such unmatured obligations which are backed by the full faith and credit of the Town are accounted for in the general long-term debt group of accounts.

Budgetary Accounting and Encumbrances:

General governmental revenues and expenditures accounted for in budgetary funds are controlled by a formal integrated budgetary accounting system in accordance with various legal requirements which govern the Town's operations.

Basis of Accounting:

The accounts of the general fund, special revenue funds and debt service fund are maintained and reported on a modified accrual basis. All other funds included in the financial statements are maintained and reported on the accrual basis.

TOWN OF EXETER

Notes to Financial Statements

Under the modified accrual basis of accounting, revenues are recorded when received in cash, except in cases where they are both measurable and available, and therefore are resources which may be appropriated. Expenditures, except for interest on general long-term debt which is recorded when it becomes due, are recorded when certain goods or services are received and actual liabilities are incurred.

Enterprise Fund:

Water and Sewer Departments:

The water and sewer departments follow the practice of charging the purchase of the majority of property and equipment against operating expenses in the year purchased which is not in accordance with generally accepted accounting principles. In addition, no depreciation expense has been recorded on these assets; before January 1, 1979.

Note #2 Fund Balance - General Fund:

In analyzing the change in fund balance from 1978 to 1979, it disclosed that revenue exceeded expenditures by \$146,318.52 and the revenue for encumbrances charged against fund balance amounted to \$89,907.57. The fund balance at 1979 shows a balance of \$151,759.48. I recommend that the fund balance be accumulated and used for unpaid bills and contingency reserve against unpaid property taxes.

Public Works

I respectfully submit the annual report for the Town of Exeter's Highway Department.

During the year 1979, there was a total of 13 storms with a total accumulation of approximately 41½ inches of snow and three freezing rain storms.

Summer maintenance consisted of spring clean up, coldpatching potholes, storm drain repairs and trimming and grooming of roadsides.

Along with our regular summer maintenance, the Town employee's did the landscaping at the New Fire and Police Complex and built the extension of the Town Parking Lot off Bow St.

With our overlay account and the State TRA B funds, we were able to do Epping Rd., Hampton Rd. and the bad section of Water and High Sts. LaPerle Ave., Michael Ave. and a short section of Bow St. was done under our street oiling program. This year with our TRA "A" Funds, we reconstructed Ashbrook Rd. and Briar Rd. Also this year, we were able to improve 12,802 square feet of sidewalks. The asphalt paving was done by Bell & Flynn, Inc., with the exception of raising the catch basins and manholes, and repairs which was done by Town Employees.

Police

On behalf of all the members of the Exeter Police Department, I am pleased to report to you the various activities functions of the Department during the year 1979.

The most noted activity was the move from the old police station on Water St. to the new Public Safety Complex on the corner of Bow and Court Sts. The new facility is very functional and a welcomed change from the cramped quarters in the Town Hall. We totally enjoy the added space, warm surroundings and the new equipment made available by the new complex funding.

During the year we undertook many new projects to improve our delivery of service to the community. As a part of that program we initiated a new incident-based reporting system designed to integrate with the State and Federal Uniform Crime Reports. As a result our Annual Report takes on a new look, one which will show total activity as well as court action taken.

The Juvenile Unit has devoted numerous hours to youth problems in the community, schools and individual homes. The "Officer Friendly" program has been introduced into the elementary and day schools bringing the youngsters in contact with police officers, their duties and their equipment. As part of our effort to increase service, we have added an additional patrolman to patrol the Town and CETA and other grants have provided us with additional civilian employees. Our crime prevention program is in full operation and we hope each resident and business in the community will take advantage of the various offers of service available from this program.

Fire

On Jan. 2, 1979, Chief Arthur R. Emerson was appointed. Throughout the year, working with the department officers, reorganization of the department was on-going to obtain better efficiency in all department operations.

The main change occurred on Friday, March 2, when the Fire Department moved into the new Public Safety Complex at 20 Court St. This was a very long awaited day for all the men. This new facility has worked out very efficiently and has been visited and admired by many people, both in and out of the fire service.

In the addition area, two new pieces of apparatus were added to the department. A new fully equipped 1,500-gallon-per-minute Mack Fire Engine was purchased after being approved at a special Town meeting. Also added was a new fully equipped Modulance Rescue-Ambulance. This

unit was a welcome replacement for the 1969 Cadillac ambulance.

As far as the fire report is concerned this year, Exeter was very lucky. We know with the addition of many new wood stoves in the homes in this community that we will sustain more fires than ever before. We only hope that through public education and awareness programs that these needless fires can be reduced and possibly eliminated. Your help in this matter will be greatly appreciated.

In conclusion, I would like to extend my thanks to all of those who have extended their help this year. The Police, Highway and other departments including the fine citizens of Exeter have made our job much easier this past year. We look forward to improving our services this year in an effort to serve you better. Thank you all for your help.

**Visiting Nurse
Association**

The Exeter Area Visiting Nurse Association, Inc., is a community health service that provides health care to individuals and families in their home, in the office, or in clinics. The care may be to prevent disease, promote, maintain, or restore health or it may be to minimize the effects of illness or disability.

The Association is a non-profit agency governed by a Board of Directors. This Board is made up of people who are appointed by the selectmen in your town.

Funding for the Association comes from Medicare, Medicaid, patient fees, local taxes, and donations. Town appropriations

make the service available to the town.

Home Care. Professional nurses give care to the sick and disabled under medical direction, teach and supervise care by the family and others. They are responsible for the management of patient care, coordinating the services of other disciplines, within and out of the Agency. Care is family centered and consideration is given to the total needs of the patient and family for health promotion and disease prevention and rehabilitation as well as care and support during the dying process.

Maternal and Child Health. Free visits are made to new or expectant mothers to provide information and instruction in the care of themselves and their babies. Well Child Clinics are held twice a month and provide the following services: Physical exams by a local physician, immunizations, hearing and vision screening, lead and urine testing, special counseling, family planning and referral when appropriate. The Clinics are for infants and preschool children.

Adult Health Screening. Clinics are held twice a month to check blood pressure, provide diet and medication counseling, and general health instruction. Referrals are made when appropriate. Plans for 1980 include increasing the number of these clinics.

Flu Clinics. Clinics are held each fall to immunize hi-risk (65 and over or chronic disease) persons against influenza. The number of these clinics was increased this year from 2 to 12.

**There Is No Charge
For Any Clinic Services**

The Association has many valuable volunteers who work at the clinics in addition to staff.

Mental Health. Visits to persons

who have mental and/or emotional problems. Coordination between patient, family, psychiatrist and community.

Communicable Disease. Visits to persons who have or are contacts of persons with tuberculosis for testing and/or medication and general health supervision. Other communicable diseases-testing and/or care as appropriate.

Continuing Care. An Agency nurse is in the local hospital part of each day to assist in planning, coordinating and arranging for care at home so that a person can move from hospital to home without any interruption in care.

8,773 units of service were provided to residents of the service area between Jan. 1, 1979, and Oct. 31, 1979.

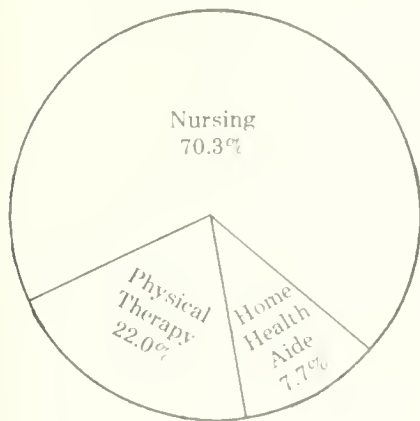

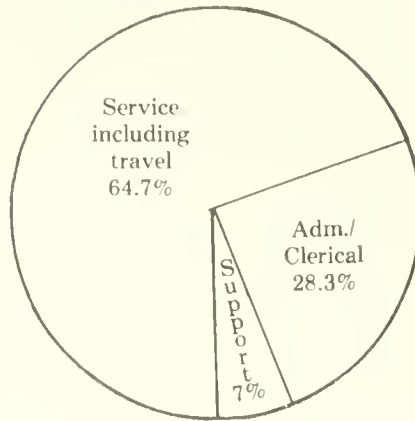

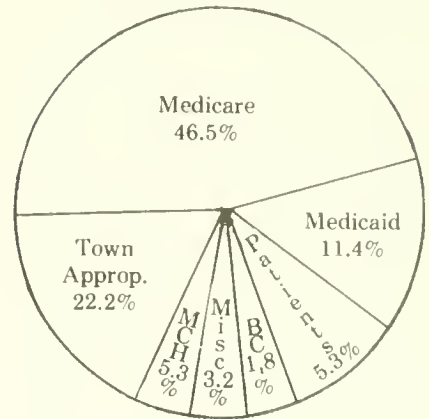
Total Service Time

EXETER AREA VISITING NURSE ASSOCIATION, INC. SERVICE REPORT

Recreation and Parks

Through a good working relationship with the Phillips Exeter Academy, the Exeter School System, and continued support by you the public, we have been able to provide many activities that would otherwise have been impossible to accomplish. We use the Academy's hockey rinks for the youth hockey program, the Jim Houston Hockey Tournament, public skating, figure skating, the pools for adult swim lessons, aqua swim programs, swim team, other facilities for adult night activities, the ball fields and the track. We thank them for their fine community support. The schools are used for adult and elementary and high school student basketball, fitness programs, vacation activities, Junior Winter

Carnival events, volleyball for adults, gymnastics, dancing classes, as well as Lincoln Street School for a summer playground.

Recreation in Exeter has grown in the past eight years. This is due to the great support you have given us during this time. As I have said many times a great deal of our programs and activities either support themselves totally or in part. All of our adult activities, with the exception of our senior citizens' programs, support themselves through sponsors and fees. Our adult softball, basketball, fitness, and yoga programs if paid for by the taxpayer would cost the town more than \$25,000.00 per year to operate, whereas now they support themselves. Many of our youth programs are funded in part through a registration fee, but no child is ever left out of a program for a lack of funds as the Jim Houston Hockey

Tournament held each January raises money for that purpose.

It is our goal to provide you the taxpayer with the best program and department that we can through the tax dollar and fees and charges. We are fortunate to have a nice park where you can bring your family to see a baseball, softball, soccer game, go for a swim, play tennis and soon enjoy an exercise trail that we hope will open in May of 1980. Our Recreation Center is the home of Exeter senior citizens' activities and trips as well as the home of the Recreation and Parks office. The Center is used by various groups throughout the year for meetings, testing, and classes.

The major highlight of the year was the donation of a 1974 school bus to our department by the Exeter Lions Club to be used mainly for the seniors but may be used for youth trips as long as they do not conflict. It has enabled us to take our seniors on trips at a reduced cost as we pay for the driver and gas, a good savings to our department.

For the first time we ran a summer day camp for six weeks. The response was good for the first year of activity. We hope to offer this program again this summer, with a few minor changes.

The swimming pool was busy for the first month and a half, then the cold weather of August came and the attendance dropped as it did at the tennis courts. We have plans to seal the surfaces of the tennis courts in the spring of 1980 for the first time since they were built in 1974. We should be able to save the town more than \$3,000.00 by having the Highway and Recreation Department personnel do the work once the materials are purchased.

I would like to thank the Exeter merchants for their fine support

during the past year for events that include Halloween window painting and prizes for special events. I think the merchants in Exeter are some of the best when it comes to helping our department, they are always ready to help.

The summer concert program saw large turnouts of people of all ages. We had two extra concerts this year thanks to the Exeter Jaycees and the Exeter Police Association as they each co-sponsored a concert. The sounds of Clayton Poole and his Big Band music was a big hit again this year. We have plans for as many concerts next year. If you know of a group who might like to co-sponsor a concert, have them contact me at the office.

One of the most popular programs

this year was rollerskating with both young people and adults enjoying our monthly trips. Baseball for students age 7-12 was up again this year with close to 300 students participating as was youth basketball up to more than 100 students this year. The program that showed the most drastic increase was youth soccer. As this sport continues to grow we should have about the same numbers of students as we do in baseball for next fall's soccer season. Our summer youth soccer program had a chance to play a game prior to the New England Teamen's game in July in Boston.

I would like again to thank you for your support.

Conservation Commission

The end of the decade appears to be an appropriate time to assess the

accomplishments of the Conservation Commission and to suggest direction for the future. Due in large measure to the generosity of public spirited citizens, perhaps the land conservation portion of our program is most worthy of note. Starting with a donation of 13 acres by the Exeter Industrial Development Commission, the land holdings now exceed 300 acres. The largest parcel is Henderson-Swasey Park which now embraces 188 acres (150 acres of which were the original gift of Mr. and Mrs. Henderson in 1971 and the remainder made up of abutting properties which have been added since that time).

The contribution of a large tract of prime wetlands on Drinkwater Rd. by the Herman Smith family in 1975 gave us an important property on the other side of town. The Commission purchased the abutting Page land, in order to give Exeter citizens access to 50 acres of passive recreation area.

The Nursery, established in 1967 near the sewer lagoons, has furnished 550 trees which are now adding scenic beauty to the Exeter countryside. In 1974, the Nursery was dedicated to the memory of Wilfred J. Moreau, who spent many hours nurturing the first plantings.

Another important undertaking was our wetlands survey of 1977 which yielded vital information necessary for formulation of our Wetlands Ordinance.

The educational phase of our program has not been neglected. Each year teachers and students have been sponsored at a two-week conservation camp program. This investment is returned to us many fold by increasing ecological awareness of our youth. Henderson-Swasey Park is also available as an ecological laboratory for students. Conservation movies have been made

available periodically for elementary school pupils. Commission members have periodically attended conferences, conventions and seminars to increase their knowledge of environmental problems.

During the year 1979, some of our ambitious plans never reached fruition. A number of projects which were to have been undertaken by the Adult Conservation Corps were never started due to unavailability of manpower. Among these were the following:

Widening trails in Henderson-Swasey Park.

Renewal of signs in the park.

Upgrading the park entrance.

Clearing brush in the Smith-Page right-of-way.

Rebuilding the Wilfred J. Moreau Nursery.

These projects must await another year. It is hoped that some of them can be done in the near future.

At the suggestion of Roger Sloan, the Commission sponsored a daffodil bulb planting program at the Lincoln Street Elementary School as our contribution to the "Year of the Child." Each third grader planted bulbs at the school and was also permitted to plant two at home. The pupils enjoyed this so much that we plan to do this again next year.

Tree planting was conducted as usual under the able supervision of Bob Strout and the watchful eyes of Joanna Johnson and Betsey MacDonald. Nine black gum trees were set out in the periphery of the County Building. Six maples were added to the cemetery boundary and 20 oaks were scattered about the town.

The Commission has cooperated with the Open Space Committee in land acquisition planning and in formation of a "Land Trust." The latter should facilitate land purchase,

which at times seems to be an endless process.

The contributions of the Exeter Planning Board to the Open Space program are much appreciated. Developers are required by policy to devote 10 percent of their acreage to open space, either by their own maintenance or by deeding land to the town. The latest such acquisition, which includes 10 acres located on Old Town Farm Rd., has been donated by Joseph Kenick.

Interest has been stimulated in the preservation of scenic roads in Exeter by Sheila Duff, one of the newer members of the Commission. Jolly Rand Rd., which was once part of a stage coach route from Rochester, seems to be worthy of retention as a scenic way for both its beauty and historical interest.

In the future, commission members must be ever more vigilant in attempting to preserve and protect our fragile environment. We appreciate the help given us by Exeter citizens and ask that such aid be continued, indeed even increased, during the current decade.

Planning Board

The Exeter Planning Board, during 1979, found itself with a busy schedule, meeting every week, either conducting public hearings or in work sessions, at which site plans and

subdivision proposals were reviewed. Although building activity, during 1979, has slowed considerably, the board found itself holding 46 meetings, 29 being public hearings and 17 being work sessions, with approximately a dozen site inspections; 37 site plans were processed and 61 lots were created through subdivision.

This was the first year of implementing the Open Space Development Ordinance and the Wetland Conservation District Ordinance and the board has been successful in administering these ordinances in reviewing new proposals. Currently, a 45-unit project is being proposed for Kingston Rd. under the Open Space Development Ordinance and it is hoped that the design standards will produce an environmentally sensitive project, as well as promoting greater housing opportunities and choices.

A sewer extension plan for Kingston Rd. has been approved and it is anticipated that this area will see many new homes in the next few years. The board has carefully reviewed the potential for development in this area and intends to minimize social and environmental impacts while promoting the public's convenience by providing adequate open space, recreation opportunities, pedestrian/bicycle access to the downtown and improved traffic circulation.

The Sounding Board continues to contribute valuable time and effort in promoting the Master Plan and endeavoring to recommend to the Planning Board progressive ideas on planning issues. The Sounding Board is now co-chaired by Moana Minnon and William Armstrong.

The board accepted the resignation of Francis Zimmerman, who now continues to provide

valuable service as an alternate; Frank Kozacka has been appointed as a regular member.

The board looks forward to the challenge and changes the 80's will bring, with renewed dedication to chart the best course for Exeter, its present and future citizens.

Housing Authority

The Exeter Housing Authority is continuing to provide assistance in paying the rent for up to 145 Exeter families through the Section 8 Existing Housing Program funded by the Department of Housing and Urban Development. Total housing assistance payments for the EHA's Fiscal Year 1979 were \$212,729.00. Despite difficulties encountered in the adjustment of the federal limitations on the maximum rents allowed to be paid for dwellings occupied by assisted families, the EHA managed to continue to assist all but two families who had previously been helped. The EHA appreciates the patience and

cooperation of Exeter's private landlords during some difficult times this past year.

The EHA applied for additional Section 8 Existing Funding in 1979 but, although its application was approvable, was not funded due to the limited federal allocation for northern New England.

J. Douglas Guy III was appointed Executive Director in April, 1979, following the resignation of Sandra Knowles. Doug Guy is assisted by Roberta Butt and a CETA funded employee, Judith Mills. Charles Hayes was reelected Chairman in April and Flavia Page was elected Vice Chairman. Robert Curran was reappointed to an additional three-year term by the Selectmen as of March 21, 1979.

Progress was made in the development of the 85 apartments for the elderly on Water St. Complications regarding the extra costs due to the soil conditions on the site were resolved when the Board of Selectmen agreed to transfer the Town Shed property to the EHA at no cost. An option to purchase adjacent land was negotiated which increased the size of the site.

The EHA's present goals are to commence construction no later than the fall of 1980 with completion and occupancy late in 1981. Estimated total cost, federally funded, is \$4.2 million.

The EHA is continuing to investigate possible locations for 15 apartments for low income families. Two proposals under consideration failed to materialize due to cost factors.

Among this year's alterations the transformation of the Women's Shop into the restaurant named 127 Water St. is noteworthy.

This year's changes in membership of the Commission have occurred as follows:

Evelyn Zarnowski replaced Richard Niebling as Selectmen's representative.

In July Mrs. John E. LeBaron, secretary of the Commission, completed her second three-year term and the Board of Selectmen named James E. Samiljan to replace her. In June Joan Pratt was named to replace Barbara Harris, who moved away from Exeter.

Health Department

Another year has passed and I am now reporting my sixth year as your Health Inspector. Each year we encounter about the same problems.

One of Exeter's present problems is the "Occupancy" situations. We should enter this with caution without involving a great expense to the taxpayers. I feel this can be taken care of with the cooperation of the Fire Chief, Building Inspector, and Health Inspector. To initiate this plan in Exeter we should be involved with very little cost to start.

Every year I have inspected the school buses. This year I am happy to report they have surpassed prior years in cleanliness and overall health conditions. I have expressed my appreciation to the Timberlane Company and to Berry Transportation Co. in a written form. I commended them for the very good health conditions of their buses which transport our Exeter pupils to school. For example, I found only two out of 28 buses that I could question. A copy of the letter was sent to the School Board Superintendent, and to the Chairman of the Board of Selectmen.

Being pleased to announce the superior condition of our buses, I feel it should be inserted in the Town Report.

Again, I want to compliment our Health Program in our schools, and also the Food Cafeteria Departments. Contrary to a recent complaint that was brought to the attention of the Exeter citizens in a meeting, and then in our local paper, of a health condition in our school, I feel all health problems should first be handled through your Health Officer

Welfare

Fortunately, 1979 brought to us an uncommonly mild winter. Many Exeter residents were extremely thankful for the great savings on heat. However, from another angle, 1979 was a year beyond any expectations in the area of juvenile support.

The 1979 Juvenile Delinquent account was set at \$3,500.00. Our 1979 expenditures for juvenile support alone were \$37,209.54 for the period from Jan. 1, 1979, to Jan. 1, 1980. We are all well aware that aid, care, and guidance are necessary components for the juveniles of our town. Due to New Hampshire Law 169:11, each town is responsible for the costs of any juvenile offender incurred as a result of a Court Order. Under Law 165:19-27, the town has a right to be reimbursed by the parents of the individual if they are capable of payment. The town has set up hearings with parents in order to reach negotiations. We have been quite successful on the whole, but there have been several cases involving uncooperative parents. Some parents have been summoned to court, where, in turn, they have been required by law to make payments. Situations similar to these bring about problems for all involved. Our town officials must exert their full energies in these incidents since investigations, time-consuming decisions and human compassion

must be exercised in each individual case. We feel that we are heading in the right direction for our taxpayers as well as for each Exeter family involved. Since this family restitution program is in effect, in my opinion, in the coming year the juvenile delinquency account will show a decline in the budget.

The Town of Exeter has always shown great concern for our needy people and done everything possible for our elderly also.

I wish to thank all the town officials and citizens for helping me in my investigations.

Council on Aging

It is our goal to provide senior citizens age 62 and over with a community service that is for seniors only. We have been working towards a goal of helping our seniors with discount taxi rides, meals, blood pressure clinics, outings, plus other services.

In December a new taxi contract between the Exeter Council on Aging and D's Taxi and J & L Taxi was signed for the next 12-month period, Jan. 1 through Dec. 31, 1980. We have tried to hold the line on cost for the subsidized taxi program, but was forced to have an increase this year due to the cost of gas. We still provide 15,000 rides per year. In 1979, we still had a few tickets left that were not sold. This has never happened before in the first five years, we cannot explain why. We still realize that the number of tickets that you may purchase each month

will not take care of all your needs, but is designed to help with many of your weekly and monthly trips. During the winter months we try to provide up to 12 tickets per month, but drop that figure in the warmer months so we will not run out in November and December. Tickets are sold only at the Exeter Recreation Center, Monday through Friday, between the hours of 10-12 by volunteer seniors.

A monthly blood pressure clinic is held at St. Michael Church free of charge for Exeter seniors.

Through the Rockingham County Nutrition program meals are provided for between 30 and 40 seniors each day, Monday through Friday, at the Recreation Center. We would like to expand this but due to limited space we are unable at this time to accommodate more than 40 each day.

The big event of the year was the donation to the Exeter Recreation and Parks Department of a 1974 school bus to be used for senior activities and for student programs if they do not conflict. The bus will enable our seniors to go on more trips at a reduced rate through the Recreation Department's programs. Some of the trips the seniors went on using the new bus were to Leisure Services for Seniors Oktoberfest at Mt. Sunapee State Park, the Kennedy Library in Boston, Edaville Railroad, Strawberry Banke in Portsmouth.

We are still continuing to update our ID cards with many new seniors requesting this service as they turn 62 or if they have just moved into town.

We still have the Vial of Life program for seniors when they come to the center to get their new ID cards.

We have outgrown our facilities

here at the Recreation Center and have tried to get by all these years without more space. Well, this year we will make a request for an addition to the Recreation Center that would give the seniors more space for meals, meetings, parties, movie and recreational activities. We know that the tax problem is facing us all and we have not asked for that much over the years. The Council has been operating but feel we need the room and hope you will support our request.

As I wear two hats, Chairman of the Exeter Council on Aging and Director of Recreation and Parks, I know that with more than 1,700 seniors age 62 and over that we could use the additional space as it could be used for town meetings, with a possibility that we might rent the hall out to groups throughout the year to help with the upkeep. If we do have this addition built, the Exeter Senior Citizens will have priority in its use.

One other major program the seniors here at the center have been part of the past three years is our annual toys for tots program. The seniors give many hours to this program and should be given a big thank you from you all.

Citizens Advisory Committee

The Citizens Advisory Committee (CAC) is a volunteer group of citizens who serve as an advisory body to the Board of Selectmen on matters relating to the Department of Housing & Urban Development's Small Cities Grant Program. The committee has been instrumental in recommending projects to the selectmen which are eligible for funding and has served in an ongoing advisory capacity to implement the program's objectives.

In 1979, the town completed

remaining projects under a 1976 Community Development grant including: (a) construction of storage facilities (\$33,000) for the Water & Sewer Department on Portsmouth Ave., to replace facilities to be demolished on Water St., site of the proposed 85-unit elderly housing complex; (b) completion of a \$40,000 storm drainage separation project on Myrtle and Sanborn Sts. to eliminate a health and drainage problem; (c) construction of a sidewalk along South St. to Franklin St.; (d) creation of a pedestrian access from Swasey Parkway to the elderly housing site — this will be completed in the spring with landscaping, lighting and benches. (See 1978 report for other activities completed under this 1976 grant.)

The town is extremely fortunate in having its 1980 Small Cities Grant for \$364,000 approved by HUD. The programs which will begin in August of 1980, include:

1. Rehabilitation grants for low-moderate income homeowners and landlords with low-moderate income tenants, to be administered by a Grant Review Committee (GRC). Grants in 'target neighborhoods' will finance a portion of the rehab costs as determined by the GRC, based on income, severity of repairs and other factors. Goal: 14 homeowner units; 31 rental units. Budget: \$169,000.
2. Code Enforcement Program. An officer would be hired to administer a "Housing Code" in selected target areas. This enforcement would be coordinated with the grant program and GRC to make necessary repairs eligible for a grant. Budget: \$10,000.
3. Acquisition and rehabilitation of a dilapidated residential structure for transfer to the Exeter Housing Authority for low-income family

housing assistance. Budget: \$185,000.

These programs are designed to meet HUD's objectives of improving a community's housing conditions, especially for low and moderate income persons. The CAC feels the \$169,000, earmarked for rehabilitation grants combined with an owner's contribution, will greatly improve housing conditions for approximately 45 low and moderate income families and enable elderly homeowners to afford necessary repairs.

The CAC welcomes inquiries from anyone interested in these programs and information can be obtained at the Planning Department. The cooperation of town officials in supervising these programs is deeply appreciated.

applying for an exemption for the first time, you need to come into the office and file a permanent card when you file your inventory. The inventories will be mailed first class this year, hoping some problems will be alleviated. Exemptions set a record in 1979, adding 80 cents to our tax rate and \$136,553 in lost tax revenue. This is a conservative figure, since we do not carry full value assessments on Current Use parcels, it is estimated the total loss is closer to \$150,000 in tax revenues.

We will change the menu to hamburgers and hot dogs, potato salad, brownies, soft drinks, coffee and ice cream. Everything will be sold that night, no advanced purchase of tickets will be required. We will have entertainment, fireworks, a pie eating contest, dunking booth, plus a few other surprises that we will announce later if the budget is approved. Mosquito Control Commission

Nineteen seventy-nine was the third year of actual control in Exeter's four-year-old Mosquito Control program. It was an important year because surveying methods were improved, giving us a better understanding of the sources

of breeding which led to Exeter's Mosquito problem.

This past year marked the beginning of Spring larviciding in Exeter. Several major spring breeding sites were located, mapped and treated. The additional mapping and treatment of early breeding sites will be continued in 1980 with more manpower and better methods. Research carried out last summer indicated that some early spring mosquitoes live well into the summer months and may represent as much as sixty percent (60%) of Exeter's mosquito problem. Thus, more spring control work means a lot less mosquitoes lingering into the summer months and into your back yards.

The salt marsh along the Squamscott River is also an important mosquito breeding site. This area is surveyed and treated immediately following the high tides caused by the full moon and new moon of the summer months.

Fresh water work was also carried out throughout the summer but was hampered by the unusually heavy rainfall of May and August which produced numerous mosquito breeding sites.

Adulticiding was done as a back-up control method after larviciding. Adulticiding was done once a week throughout last spring and early summer. In late summer it was done whenever truck engine troubles did not interfere.

The Commission wishes to thank Thomas (Jude) Boucher, supervisor of the Mosquito Control program. Jude has proven to be quite an asset to this program . . . very knowledgeable in his field. Jude has also kept excellent records. The Commission

also wishes to thank all persons showing interest in this program.
