## **TOWN WARRANT**

---

To the Inhabitants of the Town of Gilford in the County of Belknap in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Town Hall in said Gilford on Tuesday, the 8th day of March, 1960, at 8:30 of the clock in the forenoon (Polls to be open from 8:30 to 6 P. M. at least) to act upon the following subjects:

Article 1. To choose all necessary Town Officers for the year ensuing.

Article 2. To raise and appropriate such sums of money as may be necessary to defray town charges for the ensuing year, including charges for Officers' Salaries, Officers' Expenses, Election and Registration, Repair and Maintenance of Town Buildings, Street Lighting, Town Dump, Water Works, Dog Damage, Legal Expense, Social Security and Retirement Payments, Insurance, Health Officer Expense, Interest on temporary loans and Tax Map.

Article 3. To see what sum of money the Town will vote to raise and appropriate for the purposes of the Police Department.

Article 4. To see what sum of money the Town will vote to raise and appropriate for the purchase of a Police Cruiser (present cruiser to be traded in).

Article 5. To see what sum of money the Town will vote to raise and appropriate for the Maintenance of the Fire Department.

Article 6. To see if the Town will vote to raise and appropriate a sum not to exceed \$8,325.00 for the purpose of paying all of the outstanding indebtedness with respect to the construction of the Glendale Fire Station and to provide funds for exterior painting of said building and construction of an exterior stairway, and upon payment of such sums to authorize the Selectmen to accept a deed of the land and buildings from John Goodhue as prepared and executed on Dec. 18, 1956 and held in escrow with Nighswander, Lord & Bownes, upon the terms and conditions as set forth in said deed.

Inserted in the Warrant by petition.

(Recommended by the Budget Committee)

Article 7. To see what sum of money the Town will vote to raise and appropriate for White Pine Blister Rust control.

Article 8. To raise and appropriate such sums of money as may be necessary for maintenance and repairs of Highways and Bridges, including expenditures for Asphalt, Calcium and Sodium Chlorides and the purchase of a 1956 Dodge one ton truck.

Article 9. To raise and appropriate such sums of money as may be necessary for Town Road Aid for maintenance, construction or reconstruction of Class V Highways.

Article 10. To see what sum of money the Town will vote to raise and appropriate for the support of the Public Library.

Article 11. To see what sum of money the Town will vote to raise and appropriate for the aid of the Town Poor and for Old Age Assistance.

Article 12. To see what sum of money the Town will vote to raise and appropriate for the decoration of graves of soldiers and sailors.

Article 13. To see if the Town will vote to observe Old Home Day and to make appropriation for the same.

Article 14. To see what sum of money the Town will vote to raise and appropriate for the maintenance of Gilford Beach.

Article 15. To see what sum of money the Town will vote to raise and appropriate for the Lakes Region Association for the purpose of publicizing and promoting the natural advantages and resources of the Town, in co-operation with other towns in the Lakes Region.

Article 16. To see what sum of money the Town will vote to raise and appropriate for Civil Defense.

Article 17. To see if the Town will vote to authorize the Selectmen to transfer to a Village Water District, in the event such a District is organized in Gilford, all properties, both real and personal, and heretofore owned and used by the Town to furnish water to users in the portion of Town known as the Village, such transfer to be for a nominal consideration, and to raise and appropriate the sum of \$5,000.00 to pay for engineering services in the event such District is formed, if incurred in connection with the improvement of such water system.

(Recommended by the Budget Committee)

Article 18. To see what action the Town will take to reopen a section of road formerly known as Blaisdell Avenue to and across Black Brook including the bridge, a distance of 211 feet from Blaisdell Avenue. Said road to be known as Brooks Street.

Article 19. To see what action the Town will take on closing that section of the Liberty Hill Road from Route 11A to the residence of Alexander Rudzinski.

Article 20. To see if the Town will vote to authorize the Selectmen to hire money on the credit of the Town in anticipation of taxes.

Article 21. To see if the Town will vote to authorize the Selectmen to sell to Milo Bacon a certain piece or parcel of land. Said land being part of that deeded to the Town by United Baptist Convention of New Hampshire.

Article 22. To see if the Town will vote to authorize the Selectmen to sell to Charles Gove land transferred to the Town of Gilford by deed of Ethel B. Morin, and to determine the terms of such sale.

Article 23. To see if the Town will vote to authorize the Selectmen to sell and transfer tax liens upon all real estate acquired by the town at any tax sale, and title to all real estate taken by the town in default of redemption from any tax sale, to such persons and upon such conditions as they shall see fit.

Article 24. To see if the Town will vote to authorize the Selectmen to request the State Tax Commission to do a complete reappraisal of property in the Town of Gilford.

(Recommended by the Budget Committee)

Article 25. To see what sum of money the Town will vote to raise and appropriate for the purposes of the Laconia Hospital.

Article 26. To see if the Town will vote to instruct the Trustees of the Trust Funds to put all trust funds into a common fund and to be invested in accordance with State of New Hampshire Statutes.

By Petition.

Article 27. To see if the Town will vote to raise and appropriate the sum of \$225.00 to cover costs of purchasing land from the Laconia State School.

Article 28. To see if the Town will vote to raise and appropriate the sum of \$10,000.00 to pay the note on the Fire Truck.

Article 29. To see if the Town will vote to raise and appropriate the sum of \$12,600.00 to pay the interest (\$2,600.00) and bond payment (\$10,000.00) on the Town Building Bonds.

Article 30. To see if the Town will vote to raise and appropriate the sum of \$1,000.00 for furnishings for the new Fire Station.

Article 31. To see what action the Town will take on the proposed Airport Zoning Ordinance.

Article 32. To transact any other business which may legally come before said meeting.

In accordance with a resolution adopted at the 1957 Town Meeting a motion will be presented to adjourn to the Gilford Grade School in said Gilford on Wednesday, the 9th day of March, 1960 at eight o'clock in the evening to take up articles 2 through 32.

### **PREVENTION IS EVERYBODY'S BUSINESS**

The year 1959 was fortunate from a forest fire standpoint. New Hampshire had the best record in the nation. Fewer acres were burned, suppression costs were substantially reduced and damage to woodlands held to a minimum. The record resulted from a combination of favorable weather conditions, an alert warden service and a cooperating public.

Yet, despite all this, there still persists a disturbing note

58%, or 6 out of every 10 fires in 1959 were caused by careless smokers and debris burners.

10%, or 1 out of every 9 fires was caused by children.

Careless, indifferent, thoughtless and independent minded individuals and failure of parents to properly supervise children and keep matches out of their reach, annually cause these unnecessary fires which cost large sums to extinguish and cause extensive damage. The elimination of these three causes of fires would radically change this picture. The rules are simple —

1. Before burning, secure a permit from your local forest fire warden — the law requires it.
2. Be sure to properly supervise your burning.
3. Make certain your fire is DEAD OUT before leaving it.

4. Don't throw lighted matches, cigars and cigarettes from moving vehicles — use your ash tray.
5. Don't burn at home — Use your town dump and save yourself much possible difficulty, both personal and financial.

Mrs. Dorothy Simonds, Librarian, attended the Neighborhood Association meeting sponsored by the State Library Association at Alton in October. She was hostess at a similar meeting held last spring in the Gilford Public Library.

Mr. William S. Lord, in May, was elected a trustee of the New Hampshire Library Trustees' Association at Concord. He was also made co-chairman on the Committee to Report on Laws relating to Libraries.

During the November Book Week, Mrs. Hazel Weed read stories to a pre-school, kindergarten and first-grade group of children. Mrs. Kathleen Taylor held a story hour for the second and third graders. Two classes of third graders from the Gilford Grade School visited the library with their teachers, Mrs. Gustafson and Mrs. Phelps, to learn about the library and its method of operation. Later on that week, Mrs. Simonds spoke on books and the library to the fifth and sixth grades at the Gilford Grade School.

**Report of Librarian of Gilford Public Library  
for 1959**

During 1959 significant progress has been made in the project of cataloging the entire collection of books in the Gilford Public Library.

Printed catalog cards have been purchased from the H. W. Wilson Co. for all those books for which they are available. These cards come in sets for each book, which includes a shelf-list card, author card, title card, and usually one or more subject entries. All the non-fiction catalog card sets have subject entries, and also many of the fiction sets have them when pertinent. About three-fourths of these sets have been filed and are ready for use in the new card catalog case. When this filing has been finished, there will still be a considerable backlog of books for which similar sets will have to be type-written. Cards for new books as purchased usually are available, but many of the older sets have been discontinued by H. W. Wilson Co.

Many readers have used the excellent service provided by the N. H. State Library for borrowing books by mail on every conceivable subject, including science, philosophy, religion, history, etc. Also the State Bookmobile's frequent visits that leave approximately two hundred books at a time for readers of all ages have been much appreciated.

The librarian would like to urge every resident of Gilford to visit the Gilford Public Library during 1960 and to make use of its services.

## GILFORD FIRE DEPARTMENT

1959

---

During the past year, your Fire Department responded to 36 alarms. Of these, 20 occurred in structures, 10 were grass, brush or forest fires. We responded to search for a lost child. We were called for Mutual Aid assistance on five occasions and received assistance from Mutual Aid for three fires.

Our new F. W. D. pumper-tanker combination truck arrived in September. It successfully passed the test of the Board of Underwriters and has been fully approved by their office. We are more than pleased with our new equipment and take this opportunity to extend our thanks.

Grateful appreciation is also extended to all those who assisted during and after the Weeks Farm fire. Special acknowledgment is made to our Ladies Auxiliaries, the Salvation Army and the Lake Shore Manor, who fed us such quantities of "coffee and." It is also noted that without the splendid cooperation of our own Police Department it is doubtful that the 46 truckloads of water used at the fire could have been delivered with such ease. Also, we feel that the response of the Mutual Aid apparatus would have been delayed without the able assistance of these men.

As this report is written, a work party is in progress at the Glendale Fire Station and the latest report is that the interior finish of the building will be completed by the time this report is in print.

Once again, we feel it is our duty to remind you of the severe lack of water for fire fighting purposes in large areas of the town. This matter is worthy of your long range consideration and eventually an adequate hydrant system should be provided to protect the built up areas of the community.

Your Fire Department is now one of the best equipped in the area for its size. We hope to be as efficient as we are well equipped. You can help us in this regard by, First Know our telephone number, Second, do not hesitate to call, since delayed alarms are the cause of many major losses, Third, give clear concise instructions as to the location, and if possible the type of fire, Last, keep your premises clean and free from combustible waste material, check your heating equipment at the start of EVERY heating season.

## **REPORT OF THE POLICE DEPARTMENT**

**January 1 through December 31, 1959**

---

I hereby submit my report for the year ending December 31, 1959.

I am happy to note that there was but one major crime reported to this department during the year, that being the burglary and attempted safe job at the Goodhue Boat Yard. Due to the "round the clock" work of the Gilford Officers plus the splendid cooperation of the Laconia, Meredith, Alton, Belmont and Weare Police Departments; the Belknap County Sheriff's Department and the State Police, along with the help of many residents, the culprits were apprehended and brought to justice.

There were fifty-four arrests made of which thirty-five were motor vehicle violations. The remaining nineteen were comprised of assault, drunk, larceny, disorderly conduct, unlawful possession of liquor, disturbing the peace and attempted rape.

The police cruiser responded to nineteen fires during the year plus checking several possible fires for the Forest Fire Warden and the watchman on Mt. Belknap. Two people were transported from two of these fires to the Laconia Hospital for treatment of burns and a hand injury.

At the present time your police department is comprised of one Sergeant, twelve active police officers, subject to call at any time plus two restricted special police officers, in addition to your Chief.

A few of the many improvements made during the past year are:

1. The addition of an office in the Town Hall.
2. The purchase of two .38 special revolvers through Civil Defense surplus commodities.

3. The purchase of two pairs of handcuffs and cases.
4. The addition of a typewriter and stand.
5. The addition of fingerprinting equipment.
6. The addition of a monitor radio receiver.

As in the past two years, we have continued to check doors and windows nightly at business establishments throughout the town and make periodic inspections of summer homes and cottages during the winter months.

The police cruiser was driven 28,965 miles during the year and in addition to this my own personal car, which is equipped with emergency lights and siren and State Police radio was operated an additional 3,500 miles.

Cooperation between all other town departments and all other law enforcement agencies, included the F.B.I., with this department has been excellent.

## REPORT OF SUPERINTENDENT OF SCHOOLS

---

To the Members of the School Board,  
Parents and Voters:

### School Proposed Budget

The budget proposed to the Municipal Budget Committee will carry an increase of forty-five hundred dollars for teachers' salaries to furnish twelve grade teachers for Grades 1-6 inclusive and a part-time teacher for kindergarten.

The transportation budget was \$17,802.00 for the 1959-1960 school year. Increased Gilford pupil enrollment will require an automatic increase in the 1960-1961 budget.

The tuition cost will decrease sixteen hundred seventy-five dollars, since the high school tuition rate has been reduced from four hundred four to three hundred fifty-seven dollars while the junior high school rate has increased by the slight margin of three hundred forty-one against three hundred thirty-nine for this year.

### Tuition Rates and Costs

The following table shows the tuition rates and totals paid since the pupils of Grades 7 and 8 were assigned to Laconia in September 1947 because of lack of classrooms in Gilford:
