The Polls will be open from 1:00 P.M. to 7:00 P.M.

To the inhabitants of the Town of Goshen in the County of Sullivan in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at Goshen Town Hall in said Goshen on Tuesday, the Second day of March, next at one of the clock in the Afternoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.
2. To receive the reports of the Town Officers and take action thereon.
3. To raise and appropriate the sum of \$4375.00 for Town Officers' salaries.
4. To raise and appropriate the sum of \$2800.00 for Town Officers' expenses.
5. To raise and appropriate the sum of \$585.00 for Election and Registration Expenses.
6. To raise and appropriate the sum of \$2200.00 for maintenance and repair of the Town Hall and other Town Buildings.
7. To raise and appropriate the sum of \$1200.00 to defray the Town's share of Social Security Insurance.
8. To raise and appropriate the sum of \$2100.00 for the Police Department.
9. To raise and appropriate the sum of \$2600.00 for the Fire Department.
10. To raise and appropriate the sum of \$1865.00 for Insurance.
11. To raise and appropriate the sum of \$50.00 for Planning and Zoning.
12. To raise and appropriate the sum of \$400.00 for Damages and Legal Expenses.
13. To raise and appropriate the sum of \$100.00 for Civil Defense.
14. To raise and appropriate the sum of \$1036.00 for the Health Department for support of the Newport Ambulance Service.

15. To raise and appropriate the sum of \$15.00 for Vital Statistics.
16. To raise and appropriate the sum of \$2200.00 for the Town Dump.
17. To raise and appropriate the sum of \$6000.00 for Winter Maintenance.
18. To raise and appropriate the sum of \$5000.00 for General Expenses of the Highway Department.
19. To raise and appropriate the sum of \$9000.00 for Summer Maintenance of Roads.
20. To raise and appropriate the sum of \$325.00 for T. R. A. (town's share).
21. To raise and appropriate the sum of \$75.00 for Street Lighting.
22. To raise and appropriate the sum of \$2000.00 for the Library.
23. To raise and appropriate the sum of \$600.00 for Public Welfare; Town Poor, \$300.00; Aid to Disabled, \$300.00
24. To raise and appropriate the sum of \$25.00 for Patriotic Purposes.
25. To raise and appropriate the sum of \$500.00 for Cemeteries.
26. To raise and appropriate the sum of \$3500.00 for Audit by State of New Hampshire.—Not recommended by Budget Committee.
27. To raise and appropriate the sum of \$200.00 for interest on temporary loans.
28. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.
29. To see if the Town will raise and appropriate the sum of \$2000.00 to be placed in the Highway Capital Reserve Fund.
30. To see if the Town will vote to authorize the withdrawal of the \$7000.00 received from the sale of Lot No. 12 in Great Lot No. 4 and apply these funds toward purchase of land or construction of Building for Highway Department.
31. To see if the Town will appropriate the sum of \$2500.00 for the Tax Map; to authorize the withdrawal of this money from the Revenue Sharing Fund and to deposit it in the Tax Map Trust Fund if allocations are adequate to permit same.

32. To see if the Town will authorize the withdrawal of the total amount of money from Soils Map Trust Fund to make payments for Soils Maps and to deposit balance in Tax Map Fund.
33. To see if the Town wishes to incorporate the duties of the Sexton of Cemeteries into functions performed by the Road Agent.
34. To see if the Town will vote to change from present non-partisan method of election of officers to the Australian Ballot System which was used in the years prior to 1972.
35. To take up any other business that may legally come before this meeting.

AUDITOR'S REPORT

Pursuant to and in accord with the provisions and instructions of the New Hampshire Department of Revenue Administration, Municipal Services Division, I have examined the records, ledgers and accounts of the Tax Collector, Town Clerk, Board of Selectmen, Trustee's of the Trust Fund and the Revenue Sharing Fund, all of the Town of Goshen. With the exception of the Trust Fund Accounts, I found them to be balanced, accurate and in compliance with good and acceptable accounting practices.

The Trust Fund accounts could not produce proper vouchers for expenditures of income, however, all expenditures were properly accounted for. Action that is being taken by the present Trustees, will eliminate this problem in the future.

I have certified the foregoing fact to the proper authorities of the State of New Hampshire and do so here.

REPORT OF THE FIRE DEPARTMENT

In 1975 the Fire Department answered 9 calls with 83 men responding. Reported loss from fire was \$1,890.

As in past years our equipment has been maintained, training and drill meetings have been attended, and some equipment replaced and added as our budget has allowed. In 1976 we hope to be able to replace the cab and chassis on our tank truck. There is now \$3,567.31 in our equipment fund for this purpose.

Again in 1975 the Fire Department sponsored a Fire Prevention Contest with the students at Goshen-Lempster School participating in coloring, posters, and essays. Cash prizes were awarded.

The Firemen's Auction and other fund raising activities earned \$1,300. in 1975 for our equipment fund.

We are continuing our Home Fire Extinguisher Program and if anyone desires information on home fire extinguishers or home fire alarm systems we are qualified to advise you of quality products available. This year the Department hopes to present a Home Fire Extinguisher Training Program to interested citizens of Goshen.

Your Fire Department is also qualified to advise you about chimneys and wood stove installations (oil and gas too). PLEASE, if in doubt, seek advise BEFORE you install your stove or heating unit.

Please accept my sincere thanks to the firemen for their many hours of help and cooperation and to the citizens and taxpayers of Goshen for their interest and participation in Fire Department activities.

REPORT TO TOWNS

Upon the recommendation of town selectmen and city councils, the Division of Forests and Lands appoints a forest fire warden and several deputy forest fire wardens in each town and city every three years. The town or city warden is responsible for maintaining a force of men and adequate equipment to suppress any wildfire that occurs in his town or city during his term of appointment. The fire warden must authorize all open burning when the ground is not covered with snow. No open fires can be authorized between 9 a.m. and 5 p.m., unless it is raining, without the additional permission of the state district fire chief.

Any person wishing to kindle an open fire when the ground is not covered with snow must first obtain the written permission of the forest fire warden. Camp and cooking fires also require the warden's permission.

The Division of Forests and Lands, through its Forest Fire Service, assists all cities and towns in meeting these requirements by training the warden and deputy forces in wildfire suppression tactics, making hand tool suppression equipment available at fifty percent of cost, supplying pieces of Federal excess property for use as fire attack vehicles and sharing up to fifty percent of the cost of wildfire suppression costs.

Wildfire prevention is also a joint state, city or town program. Smokey Bear is available from the Forest Fire Service for local fire prevention programs. Posters and Junior Ranger kits are available for distribution by local fire departments upon request to the Forest Fire Service. Each forest fire warden is expected to carry on a continuous wildfire prevention program within his town or city.

The ceiling insulation was installed during April. The cost being \$35.00 more than the \$150.00 allotted by the town, the Friends of the Library reimbursed us. The Friends of the Library also took care of the cost of the storm windows and doors. We are very grateful to them for their gifts throughout the year. The Book Fair in July sponsored by them was again successful. Books were donated to the library and to the fair by many townspeople and also by Mr. and Mrs. Paul Majoros of Newport.

REPORT OF THE GOSHEN HISTORICAL SOCIETY NHAR BICENTENNIAL COMMITTEE

A great deal has been accomplished by our Goshen Bicentennial Committee since its formation early in 1975. A grant was awarded us by the New Hampshire American Revolution Commission in Concord, to be matched by local funds and used for the accepted Bicentennial project of replacing the weatherbeaten wooden soldiers' memorial plaque with a lasting one of bronze. The \$500 voted by the town for Bicentennial projects was used, supplemented by \$500 from the Goshen Historical Society which completed the necessary local matching fund. The plaque has been completed and will be attached to the monument and dedicated at some time in the Bicentennial year. The Goshen History Supplement material has been completed and will be published as soon as a printer can be found who will print it at a reasonable cost. A committee is working on the project of a suitable marker for the area of the early pioneer cemetery on the Province Road. These last two projects are expected to be completed in 1976. The project of a clearly marked trail to the Pierce Lead Mine was completed and used for the annual hike on Old Home Day, 1975.

The official Bicentennial flag was presented to Goshen at a ceremony in June, 1975, for which occasion the townspeople had newly decorated the town hall, having met the previous week in a tremendous work bee to accomplish it. Our town received the thirtieth Bicentennial flag in the state.

At the Old Home Day in October, 1975 a Bicentennial queen and princess were chosen and will reign over Bicentennial events which are being planned.

I sincerely thank all those who have worked with me to make all these foregoing events and projects successful and possible. I look forward to their continued interest and cooperation.

REPORT OF THE SUPERINTENDENT OF SCHOOLS

To the Citizens of the Goshen-Lempster Cooperative School District:

ENROLLMENT . . .

The present number of students totals 133 in Grades 1-8.

Fifty-three students are attending high school: one at Keene, two at Claremont, and fifty at Newport.

Mention should be made of the increase in enrollment since September 1975. The September figure of 121 has now risen to 133 - an increase of 12 students - or 10%.

STAFF . . .

There are no changes this year in regular staff positions. An expansion of services was provided by employing an Art instructor for one day per week.

Increased federal funding under E.S.E.A. Title I has made it possible to employ a specialist in Learning Disabilities on a two-day per week basis and a full-time Aide to assist in working daily with the students identified for this help.

These added instructional services should aid immensely in up-grading the training in the early years of schooling and make for a better adjustment to secondary school for some students.

With 154 school districts in New Hampshire operating elementary schools, 126 had a higher per-pupil cost and 27 had a lower per-pupil cost in 1974-75.

FINANCES . . .

Some mention of comparative school costs may be of interest.

Based on the 1974-75 school year:

State Elementary Average	— \$950 per pupil
Goshen-Lempster Elementary Average	— \$707 per pupil

BUDGET . . .

An attempt has been made by the School Board to keep the expenditures within reasonable limits in spite of continued rising prices and especially in light of the substantial increase in enrollment. This has caused the re-arrangement of bus schedules and the addition of a third route.

The greatest increase (\$14,500) comes in high school tuition charges. An increase over last year of ten students in Grade 8 (14 to 24) makes it necessary to provide the funds for this large group to enter Grade 9 next fall. This is coupled with an increase in tuition charges at each of the receiving high schools. Rates per students for 1976-77 are as follows:

CONCLUSION . . .

Auxiliary services are being provided in a very satisfactory manner — transportation and custodial services by Mr. and Mrs. Charles Newton. The Lunch Program is now managed by Mrs. Janie Miller and is operating within the limits of a tight food budget.

The school program includes many worthwhile projects and activities which are detailed in the Principal's Report. I am pleased to commend the staff for both the interest and time devoted to many "extras" that go to enrich the school experience of the students.

REPORT OF TEACHING PRINCIPAL

In a continuing effort to provide for individual differences among students, the pattern of organization in curriculum offerings was expanded to accommodate a more flexible grouping situation dealing with reading abilities of students. Each faculty member engaged in a broader teaching load involving a level capability program. This involved the placing of students (grades 4-8) in various subject matter categories according to their reading comprehension levels. Significant success was noted in this first-year trial organization. Teachers were assigned as follows:

- Nancy Richard - 1st and 2nd grade
- Jan Bradeen - 2nd and 3rd grade, and including a 4th grade group in Social Studies
- Ann Schroeder - 4th grade in Language Arts, Math, Science, Reading; 5th grade in all subjects, and 6th grade in English.
- John Bonfiglio - 6th, 7th, and 8th grade science and math, but working in groups spanning a wide level capabilities of students
- David Cronin - 6th, 7th, and 8th grade Social Studies and English, also working in groups spanning a wide level capabilities of students.

Within each subject level were a number of students either from a lower or higher grade, based on individual difference of learning ability.

The availability of additional funds through TITLE I, ESEA made possible the employment of a special Learning Disabilities Teacher, Mrs. Therese Kramer through a cooperative arrangement with Newport. Under Mrs. Kramer's direction, a full-time Aide, Mr. Ronald Purmort, was added to assist Mrs. Kramer in activities dealing with math, reading, and other learning disabilities.

Betty Lohman returned to her duties as Library Aide, but this year's full-time employment included duties as receptionist, and Aide to the Principal - and to other staff members as directed by Mr. Cronin.

With the addition of an Art Teacher, Jan Struble and a music teacher, Alan Peterson, we came close to realizing the N. H. Minimum Standards for Elementary Schools. Each comes to the school once a week to work at all grade levels.

Mrs. Jane Miller replaced Mrs. Hooper as cook for the hot lunch program and continues to provide delicious and nutritious meals.

In addition to serving lunches, our Cafetorium is used for peer tutors, music and art activities, sewing, supervised student meetings for projects, and recess periods when indoor activities are in order. During these inclement days, ping-pong equipment is provided.

In class and during activity periods, students were involved in Fire Prevention Week, Honor Society Programs for the Newport Nursing Home, and participation in such programs as the Lempster Bicentennial at which a 7th and 8th grade play was presented.

Among the field trips scheduled included (1) the Newport Library (expanding our Library Science offering), (2) visits to book displays in the area by Mrs. Lohman and her library students, (3) the traditional Eighth Grade Class Trip - last year an educational tour of New York City, and (4) a trip to Squam Lake Science Exhibition by Mr. Bonfiglio's class.

I would like to express my thanks and appreciation to the faculty and auxiliary teaching staff and aides for their work in helping to create a good student-learning climate. Sincere gratitude goes out to parents, guardians, and friends of the Goshen-Lempster community, as well as to the school board and administration for their support in providing good education for all our children.

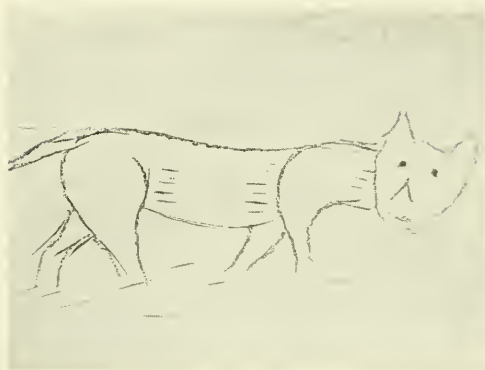
