## TOWN WARRANT

To the Inhabitants of the Town of Henniker in the County of Merrimack in said State, qualified to vote in Town Affairs:

(L. S.)

You are hereby notified to meet at Cogswell High School Auditorium in said Henniker on Tuesday, the fourteenth day of March, next at one of the clock in the afternoon, to act upon the following subjects:

Town meeting will be recessed for School meeting.

Polls open at 1:00 p. m. and close at 8:00 p. m.

The articles in the Warrant will be taken up at 8:00 p. m.

1. To choose all necessary Town Officers for the ensuing year.
2. To hear and act upon the reports of Town Officers, Library Trustees, Trustees of Trust Funds, and other Committees.
3. To raise and appropriate such sums of money as may be necessary to defray Town charges for the ensuing year.

4. To see what sum of money the Town will vote to raise and appropriate for the repair of highways and bridges, repair or purchase of machinery.

5. To see what action the Town will take in regard to the Public Health, and raise money for the same.

6. To see what sum of money the Town will vote to raise and appropriate to defray the expense of observing Memorial Day.

7. To see what sum of money the Town will vote to raise and appropriate for the support of the Tucker Free Library.

8. To see what sum of money the Town will vote to raise and appropriate for the maintenance of the Fire Department.

9. To see what sum of money the Town will vote to raise and appropriate for maintaining hydrant service for the ensuing year.

10. To see what sum of money the Town will vote to raise and appropriate for street lighting for the ensuing year.

11. To see if the Town will authorize the Selectmen to borrow money in anticipation of taxes.

12. To see if the Town will vote to accept the provisions of R. S. A. 41:32A for the election of Town Auditors.

13. To see what sum of money the Town will vote to raise and appropriate for State Aid Construction of Class V Roads.

14. To see what sum of money the Town will vote to raise and appropriate for the support of the Merrimack Valley Region Association.

15. To see what action the Town will take relative to maintaining a Town Dump, raise money for same or take other action relative thereto.

16. To see what sum of money the Town will vote to raise and appropriate for Old Age Assistance.

17. To see if the Town will vote to raise and appropriate the sum of \$693.00 for the support of Concord Hospital.

18. To see what sum of money the Town will vote to raise and appropriate for legal services.

19. To see if the Town will raise and appropriate the sum of \$100.00 for use of the Planning Board.

20. To see if the Town will raise and appropriate \$25.00 to be expended in cooperation with the New Hampshire Forestry and Recreation Commission for the opening and maintaining of trails and old roads for Forest Fire protection. The New Hampshire Forestry and Recreation Commission to provide a matching sum not in excess of \$25.00 for this purpose.

21. To see if the Town will vote to change the name of Commercial Street to Ramsdell Road. If Commercial Street becomes a dead end road, below the house Miss Ramsdell lived in, then the area at the Common and the remaining part of Commercial Street shall be designated as Ramsdell Circle.

22. To consider, act upon and approve a proposed agreement between the Town of Henniker and the United States for the relocation, rearrangement, or alteration of public highways situated within the Hopkinton-Everett Dam and Reservoir Project, and to authorize and empower the Selectmen, for and in behalf of the Town, to enter into such agreement and to take such action and to do any and all such things as may be incidental or necessary to the performance thereof.

23. To see what sum of money the Town will vote to raise and appropriate for Civil Defense.

24. To transact any other business that may legally come before said meeting.

RECORD OF AFFIRMATIVE VOTES AT  
ANNUAL MEETING 1960

Article 2. VOTED, that the Reports of Town Officers, Library Trustees, Trustees of Trust Funds, and other Committees, be accepted as printed in the Town Report.

Article 3. VOTED, that the Town raise and appropriate the sum of Fourteen Thousand Two Hundred Ten Dollars, (\$14,210.00), to defray Town Charges for the ensuing year, divided as follows:

For Town Officers Salaries	\$5,000.00
For Town Officers Expenses	2,100.00
For Elections & Registrations	500.00

Article 3. and, that Town Officers be paid at the following rates:

Tax Collector	1% of taxes collected

Article 4. VOTED, that the Town raise and appropriate the sum of Twenty Four Thousand Dollars, (\$24,000.00), for the repair of highways and bridges and the repair and purchase of machinery.

Article 5. VOTED, that the Town raise and appropriate the sum of Three Thousand Dollars, (3,000.00), for salary and Six Hundred Dollars,, (\$600.00), for use of car, a total of Three Thousand Six Hundred Dollars, (\$3,600.00), for the District Nurse for the ensuing year.

Article 6. VOTED, that the Town raise and appropriate the sum of Two Hundred Dollars, (200.00), to defray the expense of observing Memorial Day.

Article 7. VOTED, that the Town raise and appropriate the sum of One Thousand Dollars, (\$1,000.00), for the support of Tucker Free Library for the ensuing year.

Article 8. VOTED, that the Town raise and appropriate the sum of Two Thousand Three Hundred Dollars (\$2,300.00), for maintaining the Fire Department for the ensuing year. NOTE: This action reconsidered under Article 33.

Article 9. VOTED, that the Town raise and appropriate the sum of Fifteen Hundred Dollars, (\$1,500.00), for maintaining hydrant service for the ensuing year.

Article 10. VOTED, that the Town raise and appropriate the sum of Two Thousand Seven Hundred Dollars (\$2,700.00), for street lighting for the ensuing year.

Article 11. VOTED, that the Selectmen are authorized to borrow money in anticipation of taxes.

Article 12. VOTED, that the Town raise and appropriate the sum of Four Hundred Dollars, (\$400.00), to prevent the spread of white pine blister.

Article 13. VOTED, that the Town raise and appropriate the sum of One Thousand One Hundred Fifty Seven Dollars Ten Cents, (\$1,157.10), for State Aid Construction of Class 5 roads for the ensuing year.

Article 14. VOTED, that the Town raise and appropriate the sum of One Hundred Dollars, (\$100.00), for the support of Merrimack Valley Region Association.

Article 15. VOTED, that the Town raise and appropriate the sum of Eight Hundred Dollars, (\$800.00), to maintain the Town Dump for the ensuing year.

Article 16. VOTED, that the Town raise and appropriate the sum of Five Thousand Dollars, (\$5,000.00), for Old Age Assistance for the ensuing year.

Article 17. VOTED, that the Town raise and appropriate the sum of Six Hundred Ninety Three Dollars, (\$693.00), for the support of Concord Hospital.

Article 18. VOTED, that the Town raise and appropriate the sum of Five Hundred Dollars, (\$500.00), for legal expenses for the ensuing year.

Article 19. VOTED, that the Town raise and appropriate the sum of One Hundred Dollars, (\$100.00), for the use of the Planning Board.

Article 20. Section 1-VOTED, that the action taken at the Annual Town Meeting in 1946, specifically as follows: "that we annually set aside 40% of the income from the Straw Fund to be used for emergency purposes, such amount to be added to the principal until needed," be repealed, revoked and cancelled.

Article 20. Section 2-VOTED, that the action taken at the Annual Town Meeting in 1959 whereby it was voted "that the sum of Ten Thousand Dollars, (\$10,000.00), be taken from the so-called Emergency Fund, in order to save interest charges if money was borrowed, and that this money be used to finance the new F. W. D. Truck; that the Selectmen are further authorized to sell by sealed bids the 1945 Ford 1½ ton truck," be repealed, revoked and cancelled.

Article 21. VOTED, that a so-called Revolving Fund be established in place of the former so-called Emergency Fund, that money in the former Emergency Fund be transferred to said James R. Straw Revolving Fund, and that payments continue to be made to this James R. Straw Revolving Fund amounting to 40% of the income from the Straw Fund, monies in said Revolving Fund to be used as voted at any regular or special town meeting.

Article 22. Section 1-VOTED, that the Town raise and appropriate One Thousand Dollars, (\$1,000.00), and that the Town appropriate Eleven Thousand Dollars, (\$11,000.00), from the James R. Straw Revolving Fund just established; said monies to be used for the purchase of new and/or used equipment, and/or for alterations required in presently owned equipment, to be used by the Henniker Highway Department; and that a committee composed of Stephen C. Bennett, Lester E. Connor, and Harold A. Tucker, Jr. be given full authority to use as much of the above named sums of money as is necessary to accomplish the purposes set forth herein.

Article 22. Section 2-VOTED, that the Selectmen are further authorized to sell by sealed bids the 1945 Ford 1½ ton truck when suitable replacement equipment is purchased to replace said truck.

Article 24. VOTED, to indefinitely postpone action under this article.

Article 25. NOTE: Negative action taken under this article reconsidered by the meeting under Article 33.

Article 26. VOTED, that the Town approve the relocation, rearrangement and/or alteration of a portion of the Town's water supply system that is located within the reservoir area of the Hopkinton-Everett Dam and Reservoir Project and authorize the Selectmen and/or the Water Commissioners to enter into an agreement with the United States of America for such purpose, and further authorize said Selectmen and/or Water Commissioners to acquire the additional real estate interests needed to accomplish such work.

Article 27. VOTED, that the Town raise and appropriate the sum of Two Thousand Five Hundred Dollars, (\$2,500.00), for the repair and painting of the steel bridge at West Henniker.

Article 28. VOTED, that the Town raise and appropriate the sum of Two Hundred Dollars, (\$200.00), for Civil Defense.

Article 31. VOTED, that the Town establish a Park Board in accordance with the provisions set forth in Chapter 31, Sections 44-52, Revised Statutes Annotated.

Article 32. VOTED, that the Town observe Old Home Day in connection with the two hundredth anniversary of the settling of the Town of Henniker, and raise and appropriate the sum of Five Hundred Dollars, (\$500.00), for same, and the Selectmen be in-

structed to appoint a committee chairman to make arrangements for such observance.

Article 33. VOTED, to reconsider Article 8. VOTED, that earlier action under Article 8 be rescinded. VOTED, that the Town raise and appropriate the sum of Three Thousand Five Hundred Dollars, (\$3,500.00), for the maintenance of the Fire Department, and that the Fire Engineers be empowered to purchase a replacement for one 1945 Ford truck.

Article 33. VOTED, to reconsider Article 25. VOTED, that the Town authorize the Selectmen, when they are convinced, and after consulting town counsel, that it is in the best interests of the Town, except in the case of abandonment of any road only after approval by a regular or special town meeting, to approve the relocation, rearrangement, abandonment and/or alteration of Town roads located within the Hopkinton-Everett Dam and Reservoir Project, and to authorize the Selectmen to enter into an agreement with the United States of America for such purpose, and to further authorize the Selectmen to grant flowage easements over certain of said roads and to discontinue certain other roads at the appropriate time and to take any other action so that construction and operation of said project will not be unreasonably delayed.

### HEALTH OFFICER'S REPORT

January 5, 1961

## REPORT OF THE TOWN PLANNING BOARD

The Planning Board met seven times during the year.

One meeting was held with representatives of the Corps of Engineers to evaluate flood control developments in our community.

Three meetings were held to which local merchants were invited to discuss possible future industrial development. Representatives of the Merrimack Valley Region Association, the State Planning and Development Commission, the N. H. Department of Employment Security and the Concord Chamber of Commerce were present at these meetings. To further this work, surveys of available skills and other studies will be required to provide pertinent data for prospective seekers of industrial sites.

One meeting was held with the town Water Commissioners. At this meeting Mr. Holton of New England College presented the results of a year's efforts by his students. A complete set of plans of the water facilities of the entire community was given to the commissioners. It has been estimated that this work would cost from one to two thousand dollars to duplicate commercially.

It is planned to prepare an official map of street and road names and also to plot additional community facilities this coming year.

There have been two changes on the High School faculty this year. Mr. Robert J. Scully was employed as English and Social Studies teacher to replace Miss Sandra Greenleaf, and Mr. John Fessenden was employed as High School Social Studies teacher and Junior High Math teacher, replacing Mr. David Whitelaw. Mrs. Evelyn Woollett is starting her first complete year as Principal of the High School.

One of the big problems facing us is the problem of space in the high school. The building was not built for the number of pupils we now have in the various classes, so Mrs. Woollett is having considerable difficulty finding places to schedule classes. The size of the class is just too

large for the size of the rooms. There are now 138 pupils in the high school building arranged as follows with no relief in sight from smaller classes coming along.

Some adjustments can be made within the present high school building by knocking out walls to make larger class rooms, particularly for our junior high school classes. However, as we eliminate the two tiny classrooms on the second floor, we eliminate two classrooms as small as they are. Very small classes can be assigned to these rooms and they are. If the gym or stage are utilized for class rooms the physical education program suffers. I feel that this is a matter for considerable study.

Certainly Henniker has got to make some decisions in the next few years. The costs of education continue to rise and the property owner continues to pay the lions share of the cost of operation of the school program. There is no question about the fact that Henniker children deserve the best, nor of the fact that Henniker is trying to give them the best. The question is, "Where do we go from here?" Do we continue to be a comprehensive high school and go into a building program for the high school? (Comprehensive high school provides vocational training, shop, commercial and home making.) Do we have an academic high school and provide primarily for our college preparatory people and forget the other 60% of the people

or do we go into a cooperative high school program (grades 9 - 12) or a cooperative school program (grades 1 - 12)? These are questions that are going to have to be answered and they are not in the too distant future.

## PRINCIPAL'S REPORT

The responsibilities of education today are manifold. They range from driver training to advanced mathematics, from physical development to art appreciation, from character building to atomic principles, from vocational training to college preparation. No longer does the college open wide its doors to all who wish to enter. College admission is highly competitive, and selective standards will become more rigid within the next five years. Rapid changes are taking place in the labor market, and soon the unskilled worker will be as obsolete as the drinking dipper in the one room school. The rapid advance of the technological age and the world problems it has helped to create challenge the school more than any other institution. No thinking American can fail to recognize that the role of education is to serve society through effective development of the human being. The fulfillment of this role is no easy task.

It is imperative that we in education evaluate periodically our objectives, curriculum and teaching procedures. It is likewise imperative that the citizens be informed about their schools and concerned about the opportunities available to their children in order to evaluate the educational program in which they have invested a large portion of the tax dollar.

There is much that creditably reflects our efforts. We have a dedicated and competent staff. Our curriculum has been broadened. This year we have experimented with an activity program from which many valuable experiences have resulted. Six of our students are enrolled in the

advance science program sponsored by New England College in cooperation with surrounding secondary schools. Continuation of this program will be of considerable benefit to our college-bound students. A followup of the ten graduates of 1960 reveals that three are enrolled in four year colleges, one is attending a commercial college, one is married, one is in the armed service and four are employed. All of this is commendable, but if we are to continue to operate a comprehensive high school in Heniker, we face problems.

No longer can we ignore our crowded classrooms, lack of storage space and inadequate facilities. In 1930 when the school was built there were 96 pupils, five teachers, and a limited curriculum. Today the enrollment is 140, the staff numbers nine and the curriculum includes nearly twice as many subjects as it did three decades ago. Rooms designed for a maximum of twenty must now accommodate thirty-two. Small conference rooms must serve as classrooms and the laboratory is used as a homeroom. The faculty room has been converted to a classroom, the nurse's room to a faculty room, and new quarters for the nurse have been taken from an already overcrowded locker room. Most of these conversions were meant to be only temporary solutions.

Our needs include a larger typing room, one adjacent to a classroom which can be used for commercial classes, two additional rooms for the large junior high classes, a room for library purposes, and storage space.

Within the next three years in the high school we can anticipate a gain of twenty pupils. Without expansion we would then have to educate 160 pupils in a plant designed to fit the needs of 100 students enrolled in a limited curriculum. It appears, then, that an addition to our present plant is immediately urgent. On the other hand, it seems financially unsound to contemplate expansion until after a careful study is made of our present and future needs.

This consideration will involve our willingness to support a school that can provide adequately for the education of our children and fulfill the requirements for accreditation. It is my conviction that in the best interests of us all a study committee should be established without further delay.

Inasmuch as we can not operate our program next year without additional space, the alternative is to hold classes in the gym. By so doing, we probably shall, I regret to say, forfeit not only basketball, but also one of our most recent improvements in the curriculum — a fine physical education program that benefits both the elementary and junior high youngsters.

I wish to extend my appreciation to the school board, the superintendent, the faculty, the students, and the parents for their cooperation and support during the past year.
