## STATE OF NEW HAMPSHIRE

(L. S.)

*To the Inhabitants of the Town of Hopkinton in the County of Merrimack, in said State, qualified to vote in Town Affairs:*

You are hereby notified to meet at the Town Hall in said Hopkinton, on Tuesday, the fourteenth day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

1. To choose all necessary Town Officers for the year ensuing.

2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations of the same.

- (1) Town officers' salary.
- (2) Town officers' expenses.
- (3) Election and Registration.
- (4) Expense and care of Town Hall.
- (5) Police department.
- (6) Fire department.
- (7) Vital statistics.
- (8) Cemeteries.
- (9) Town poor.
- (10) Interest on notes.

3. To see if the Town will raise and appropriate the sum of \$5,000. for the repairs of highways and bridges, in addition to that required by law, estimated \$4100.

4. To see if the Town will raise and appropriate the sum of \$1,094.81 for Class V road assistance, the State to con-

tribute \$4,379.24, or to see if the Town will raise and appropriate the sum of \$2,466.00 and the State to contribute the same amount for State Aid Construction, the same must be expended on the Tyler Road.

5. To see what sum of money the town will raise and appropriate for general expense of highway department and street lighting.

6. To see if the Town will vote to raise and appropriate the sum of \$400.00 for the building of sidewalks in the precincts of Hopkinton and Contoocook, the amount to be divided as follows: \$300. to Contoocook and \$100. to Hopkinton; the appropriation to either precinct to be void unless said precinct raises a like amount; the amounts to be spent under the supervision of the executive committee of the Precinct and the Selectmen of the town.

7. To see if the Town will vote to raise and appropriate the sum of \$200. for the control of White Pine Blister Rust.

8. To see if the Town will vote to raise and appropriate the sum of \$115. for observance of Memorial Day.

9. To see what sum of money the Town will vote to raise and appropriate for the support of Hopkinton Free Public Libraries.

10. To see what sum of money the Town will vote to raise and appropriate for the employment of a District Nurse and other health expense.

11. To see if the Town will vote to raise and appropriate necessary funds to purchase forest fire fighting equipment, such as shovels, fire hose and back pumps on a fifty to fifty basis with the State, also a portable unit with 2,000 feet of hose which can be purchased for about \$700. through the State Forestry Department.

12. To see if the Town will vote to raise and appropriate the sum of \$400. for new equipment for the Road Agents.

13. To see if the Town will vote to expunge from the town records Trust Funds which were accepted and not turned over to the Trustees as follows:

- (a) March 9, 1926 from Annie Downes Bradley, \$100. for the care of the John Downes lot in the Contoocook Cemetery.
- (b) March 8, 1927, from Mrs. Charles Kempton, \$75 for the care of the Warren M. Kempton lot in the Contoocook Cemetery.
- (c) March 12, 1929, from George M. Putnam, \$200. for the care of the Wm. C. Clough and Charles E. Clough lots in the Clements Hill Cemetery.
- (d) March 11, 1930, from Estate of Cyrus F. Dustin, \$100. for the care of the Cyrus F. Dustin lot in the Contoocook Cemetery.

14. To see if the Town will vote to accept the following cemetery Trust Funds, the income to be used as directed, subject to provisions adopted at Town Meeting of March 10, 1925.

- (a) The sum of \$50. from the estate of Dixie H. Crowell for perpetual care of the cemetery lot of my father and mother Samuel and Mary (Hall) Crowell, located in the Hopkinton New Cemetery.
- (b) The sum of \$100. from the estate of William H. Dunbar for perpetual care of William H. Dunbar lot in Hopkinton Old Cemetery.
- (c) The sum of \$100. from Stevens and Norris for perpetual care of the Stevens & Norris lot in the Contoocook Cemetery.
- (d) The sum of \$50. from the estate of Samuel T. Symonds for perpetual care of the Samuel T. Symonds lot in the Contoocook Cemetery.

15. To see if the Town will vote to instruct the Selectmen to borrow money in anticipation of the 1939 tax levy.



16. To see if the Town will vote to allow two per cent discount on all taxes paid before July 15th, 1939.

17. To see if the Town will vote to instruct the Selectmen to distribute inventory blanks not earlier than April 1st, 1939.

18. To act on reports of the Town Officers, Library Trustees and Committees for 1938.

19. To hear and transact any other business that may properly come before said meeting.

From the financial and statistical reports and from the written reports of the Superintendent and teachers, any interested citizen of the town can secure a very complete picture of the school situation in Hopkinton. To make the picture absolutely complete, however, the citizens should visit the schools that he may see the conditions under which the teachers work, the points at which there is obvious overcrowding, and the other factors which must be considered. We hope that many citizens will take the time to acquaint themselves thoroughly with the problems of the school district.

The school board is confronted with a dilemma which must be solved before the beginning of another school year. The problem merits the careful consideration of all interested in school affairs. The Hopkinton Village school needs considerable repairing and is, for that matter, entirely inadequate. The grade school in Contoocook is overcrowded in the lower grades, part of which is due to the fact that some of the children should be attending the Village school. Either considerable work must be done at Hopkinton, including the possible addition of a room, or one of the one-room schools must be re-opened. The cost of running a one-room school for a year would go far toward doing the necessary work at the Village. Yet many obviously feel



that as long as there is still any possibility of flood control coming to the Contoocook Valley, expenditures for repairs should be curtailed as much as possible. We shall welcome opinions relative to this problem.

The budget which we submit with the report is based on anticipated expenditures, but makes no allowance for the repairs mentioned in the previous paragraphs. It had been planned to present this item as a separate article in the warrant, in order that the voters might decide. The cut effected by the budget committee will probably make such a procedure impossible.

We would express our appreciation for all the help and cooperation we have received from parents and teachers, as well as for the many constructive criticisms which have come to us.

From the table it will be noted that the average membership of the district remains about the same as the previous year. The percent of attendance is slightly lower on account of the epidemic of measles and whooping cough. The number of pupils registered was 279. Of these, 4 were high and elementary tuition pupils from other districts. In addition 7 pupils from Hopkinton attended school in Concord. This makes a total of 282 pupils residing in the district and attending public schools.

During the year it had been planned to make alterations in the Hopkinton Village school building, but on account of the attempt to secure a new building through Federal aid, these plans were not carried out. There still remains a pressing need of changes in this building so that there may be more room for the upper grade pupils, and other improvements. This building would then accommodate all the pupils of Grades I-VI who would naturally be assigned to this school, and thus make it unnecessary to transport them to the Contoocook school. This would also reduce the large number in the lower grades in Contoocook. The present indication is that there will be about forty pupils in Grades III-IV in Contoocook next year. This is a greater number of pupils than can possibly be accommodated in the room now occupied by those grades.

At the Hopkinton Village school there is not only need for more room, but also for more sanitary drinking fountains, flush toilets, and better ventilation, so that the children of this school may have facilities equal to those enjoyed by the pupils of the Contoocook elementary school. Many complaints about the Hopkinton building and its equipment have been received. Since the plan for a new building was rejected by the voters at a special district meeting called last September, the next best proposal which would be much less costly would be the addition of a third room with a basement to the present building. This would permit the installation of a heating plant, flush toilets, modern drinking

fountains, and better ventilation. The addition of the third room would permit arrangements for two grades in each room, and make room for some pupils now being transported to Contoocook. As this is a growing community the number of children in the vicinity is likely to increase rather than decrease. The provision of better school facilities would be likely to attract many desirable citizens to the village.

During the year there has been good progress in the schools. This is due to the cooperation of the parents, teachers, and school board, and has made our work very pleasant.

HEADMASTER'S REPORT — 1937-1938

---

The subjects taught this year are much the same as of two years ago and are as follows: U. S. Constitutional History, Business Organization and Commercial Law, Junior Business Training, Algebra II, and Commercial Geography. An attempt, with good success, was made to revitalize the last mentioned course by taking it out of the realm of a text book course and making it into a unit course with the oral report as the basis of study supplemented by maps, problems, booklets, and similar items. Junior Business Training makes an especially fine course for grades nine and ten as it considers topics of use to those going further as well as those who may leave school at some later time. Some of the topics follow: Meaning and Benefits of Economic Living, Money and Credit Essentials, Handling Money, Thrift of Time and Money, The Bank, Business Letters, The Telephone, The Telegram, Post Office, and Vocational Guidance.

The above teaching load is heavier than most headmasters carry and, when added to supervised study hall, does not leave much time for carrying out administrative and executive functions and for constructive thinking which is necessary for any business. This load can be lessened by dropping courses of small enrollments such as Algebra II but to do so may lessen the value of the school to those going to schools beyond high school. We have a few other courses of small enrollment which seem hardly justifiable from a purely money basis but perhaps there are other values of more importance which should not be sacrificed.

An attempt has been made during the past few years to round-out the school as a whole by adding more athletics, a field-day for all, by encouraging participation in sports for the joy of them, and by encouraging other extra-curricula activities. We have arrived at the point where greater expansion seems impossible for individual conflicts are already

appearing and it is impossible to do all things. Many schools are gradually doing away with interscholastic competition for girls and the tendency is growing. In our own case it seems as though we are doing nicely with a good program for participation by girls in sports the year around. All of us enjoyed immensely the first field day held last June and are looking forward to another.

Our greatest need for the school is an improved shop equipped with electricity and machinery which can be used as a result. It does not seem that this should necessitate any great expenditure all at once for most of the work could be done by the boys in agriculture and equipment can be added year by year. A new shop would be a fine addition to our present plant. The high school plant and its equipment is in the best condition of my knowledge and can be improved by small annual expenditures. Our text books are especially good when compared with many schools of this size, and larger.

In closing I would like to state that this is a six-year high school, fully approved by the state board of education, taught by teachers approved by the state board, is on the temporary approved list of the New England College Entrance Certificate Board and will remain on the temporary list until we send more pupils to those colleges yearly, and that its graduates have given fine accounts for themselves and their school. We are proud of our work and wish to thank you for your assistance, and for your consistent co-operation. We realize that we are your official delegates and as such are responsible to you for the kind of a school you wish to have.

### HOME ECONOMICS

Our many improvements and added equipment in the Home Economics department during this past year have made it possible to do our work more efficiently, and have certainly been an added incentive and pleasure to all of us.

We greatly appreciate the new electric range which is loaned to us each year by the Public Service Co. of N. H. I can assure those responsible for its loan that the students who have the privilege of using it agree with me in wondering how we ever "got along" without it—we'd certainly find it difficult now!

Another of this year's improvements is a little room built in a corner of the downstairs hall which serves us as a combined sick room, teachers' room, and practice room for those taking Home Nursing. This is something which we have needed for several years, for we have found it very difficult to make even an uncomfortable bed out of chairs in a room where a class was always in session. Though we are fortunate in not having many cases of illness during school hours, there are occasions when a room of this kind is greatly needed. Also on alternate years the Junior and Senior Home Economics girls who are studying Home Nursing have to practice bed making, moving sick persons in bed, bed bathing, and various other procedures which require a bed somewhere in the school. We found this room and its equipment very helpful for this class during this past year. These Junior and Senior Home Economics girls selected an attractive linoleum, made draperies, couch covers and cushions for the room and arranged the furnishings.

The material used for the draperies and couch cover, as well as a day bed and an attractive wicker chair were donated to us by the Contoocook Womens' Club. We wish to express our gratitude to each and every member of the Club, and especially to the committee in charge.

The Home Economics room has been repainted, varnished, etc., throughout with new cupboards added, a new foods table and considerable new equipment. All in all the Home Economics department is so much better than it was a few years ago, that every citizen in the town can be justly proud of it, and the students should feel privileged to be able to pursue their Home Economics work under such improved conditions.

In accordance with our alternate year program, this year (1937-38) the Freshmen and Sophomores combined studied "Foods and Nutrition" while the Juniors and Seniors combined took the course "Family and Its Members".

The units covered by the Foods and Nutrition class were: 1. Importance of food; 2. Digestion; 3. Meal Planning, Preparing and Serving; 4. Marketing; 5. Budgeting Food Allowances; 6. Table Setting and Etiquette; 7. Planning and Care of Kitchens and Dining Rooms; 8. Selection and Care of Kitchen and Dining-room Equipment; while the units studied in the Family and Its Members course were: 1. Family Relationships; 2. Uses of Leisure; 3. Vocations; 4. Home Nursing; 5. Child Care and Training; 6. First Aid.

Each unit in both courses covers a large field, and was studied in detail. Of course, as is the custom in all Home Economics work, considerable time was devoted to actual practice of subjects studied. Each girl also completed a minimum of one hundred and twenty hours of home project work.

The seventh and eighth grade girls were taught the fundamental stitches and seams of sewing, the proper use of the sewing machine, the use of commercial patterns, and the care and simple repairing processes of clothing. This knowledge was applied in making holders, towels, pillowslips, pajamas, nightgowns, slips, cotton dresses, darning and patching.

In the foods classes of these two grades, the principles involved in preparing and serving the simple types of food are

taught, and how to plan and prepare simple meals. The course is planned to teach them to choose their food wisely, how and when to eat it, as well as how to prepare and serve it.

#### REPORT OF THE MANUAL TRAINING DEPARTMENT

Our work this year has not been so extensive as last, but we have carried on many activities.

Among our first projects this year was our work in the Basketball Hall. This year our backboards needed repairing and painting and the lines on the floor needed repainting. The bulk of this work was done by Grade Eight, but Grade Seven came in for its share of the work also.

In our shop we had many projects. Some of these projects were :-

This list, as you will probably notice, lacks any projects such as tables, lamps, chairs or other pieces of furniture. This is due to many things. The most prominent of these is the lack of machinery and a suitable building.

It is really impossible to construct or finish projects in a first class condition where these facilities are lacking. We all know the solution to this condition is a new shop. A shop to be used for woodworking *alone*. A shop that the woodworking boys could be proud of, and one we could be as proud of as we are of the conditions that exist in other department of our school.

The cost of such a building or room need not be as prohibitive as one might think. One very good scheme that Mr. Emerson has given much thought to, is the idea of moving one of our abandoned schools onto the school grounds. This building at a nominal cost could be heated direct from the main building. As for getting the building ready for class use, what could make a better project for the boys?

I sincerely hope that before long some action will be taken on this matter. I do not know of anything that would show

greater rewards for so little expenditure. Surely, if under the present conditions, we are able to win third prize at our Fair, what would we do on an equal basis with other schools.

No report of this department would be complete without a brief account of the "Bird House Contest" sponsored by Mr. Timothy Burns. This year many types of houses were entered and the first three prizes were as follows:

### SOCIAL SCIENCE

The class has been studying the economic and social conditions of American civilization from the founding of the thirteen original colonies up to the present time. The textbooks for this course are a "History of American Civilization" and a "History of American Government and Culture" by Harold Rugg. To supplement the text, workbooks have been prepared which contain questions, exercises and other helps.

Drawing, accuracy in arithmetic and handicrafts are also correlated with the reading. There are many opportunities to improve these fundamentals by graphs, maps and sand table projects. For example, the class as a whole made a miniature Pilgrim village which illustrated the types of homes, dress, customs, punishment and other phases of early Pilgrim life.

The pupils have found, by their own experiments, that they understand and retain the subject matter better if they make out questions to ask others on their daily reading.

### ENGLISH

The seventh and eighth grades were fortunate in getting new Literature books. These books are much better than any previous ones because of more varied selections of stories and poems. This new Prose and Poetry has made possible a well balanced course of study for junior high literature.

The classes have been increasing in vocabulary consciousness. As they see words in the stories which are unfamiliar to them they make it a point to find the meanings, thereby increasing their vocabulary.

One of the objects in teaching literature is to bring into the discussions the real life situations of the class. There is so much opportunity to teach ideals and character building with the heroic and patriotic illustrations given in the poems and stories.

Individual and class projects help to create more interest and an example of this was a Dutch scene made by the seventh grade while reading "The Silver Skates".

### B and C Subjects

Fundamentals such as music, penmanship, spelling, health and arithmetic are taught as B and C subjects. Individual

attention is given to pupils who need drill in any one or more of these subjects.

In the eighth grade more attention has been paid to remedial reading. It seems that nearly all pupils have a comparatively poor ability to comprehend and retain what they have read. To overcome and improve this, each pupil reads aloud while the others listen. Then the class criticizes constructively and destructively marking the individual with the aid of the teacher. This offers an incentive to each one to improve his reading each time he reads orally. It makes him conscious of his phrasing, tone of voice and enunciation.

All organized play is conducted during a recreational period which is also considered as a B and C fundamental.

### LATIN

The main aim of the first year of Latin is to help the pupils to get skill in reading the language. To accomplish this aim the class translated 75 lessons from the text beside some sight work from other sources.

About 550 words were mastered to give the pupils a sufficient Latin vocabulary with which to carry on their second year work. The syntax and inflections were taken up as they were met in the Latin of the lesson that was being read.

Individuals in the class have special reports about Roman customs, religion, dress, homes, etc., getting their material from "A Day in Old Rome," by Davis.
