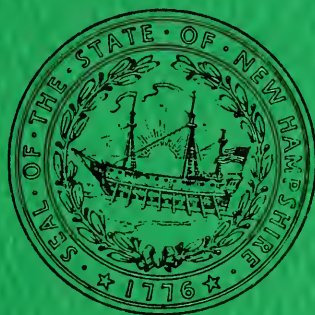

Article 9—Motion made by Donald Hall and seconded by George Tyler to raise \$300.00 as stated in the article. Passed by voice vote.

Article 10—Motion made by Loren Bort and seconded by Dorothy Lang to raise \$390.00 as stated in the article. Passed by voice vote.

Article 11—Motion made by Donald Hall and seconded by Arthur Lang to raise \$15,000.00 for State Aid Construction. Passed by voice vote.

Article 12—This article to extend the water system 2,000 ft. into Harleyview Acres with an appropriation of \$15,000.00 was presented as a motion by Harland E. Bedell. Ballot called for by Priscilla Powers.

Article 18—Motion made by Larkin Burrill and seconded by Merle Powers that the sum of \$5,000.00 be raised for the Sewer Reserve Fund. Passed by voice vote.

Article 19—Motion made by George Tyler and seconded by Wendell Winchester that this article be adopted. Passed by voice vote.

Article 20—Motion made by Larkin Burrill and seconded by Helen Clement that the Tax Map allocation be transferred to Library, and that the amended motion be passed. Passed by voice vote.

Article 21—Motion made by Larkin Burrill and seconded by Helen Clement that the Selectmen use their own discretion in accepting Federal or State Aid relative to disasters. Passed by voice vote.

Article 22—Motion made by Loren Bort and seconded by Laura Bort that the Town allot up to \$300.00 for driveways. Ballot called for.

Article 24—Motion made by Donald Hall and seconded by Ruby Emery that this article regarding evening town meetings be passed over. Passed by voice vote.

Article 25—Motion made by Helen Clement that the Selectmen be given the judgement regarding real estate taken for non-payment of taxes. Passed by voice vote.

Article 26—On non-Partisan ballot.

Article 27—Motion made by Larkin Burrill and seconded by Merle Powers that this article be accepted. Passed by voice vote.

Article 28—Loring Chace made the motion that the Moderator appoint a committee of three members to study the disposal of solid waste. Said committee to report their findings to the Selectmen prior to the 1975 town meeting. Passed by voice vote.

4. To see if the Town will vote to raise and appropriate the sum of \$1,340.00 to purchase a radar unit for the Police Department.
5. To see if the Town will vote to raise and appropriate the sum of \$1,500.00 to build a tank for the 1956 Fire Truck.
6. To see if the Town will vote to raise and appropriate the sum of \$500.00 for Water Hole Construction in North Monroe.
7. To see how much money the Town will raise and appropriate for Blister Rust Control.

8. To see how much money the Town will raise and appropriate for the support of Northeastern Vermont Regional Hospital, Littleton Hospital, Woodsville Hospital, Woodsville Ambulance Service, and NVRH ambulance service.

9. To see how much money the Town will raise and appropriate for keeping a Physician in town.

10. To see how much money the Town will raise and appropriate for the support of the Clinic.

11. To see how much money the Town will raise and appropriate for Town Road Aid.

12. To see if the Town will raise and appropriate the sum of \$1,500.00 to build a tennis court.

13. To see if the Town will vote to raise and appropriate the sum of \$450.00 for the North Country Health Agency.

14. To see if the Town will raise and appropriate the sum of \$488.75 for White Mt. Community Services.

15. To see if the Town will raise and appropriate \$300.00 for White Mountains Regional Association.

16. To see if the Town of Monroe will vote to become a member of the North Country Council, organized in July 1973. The Council has been designated by the State Office of Comprehensive Planning to be the Official planning commission for New Hampshire Planning Region One. The objects of the Council are to prepare a comprehensive plan for the region, work for consensus on major problems of regional concern, encourage and assist in cooperative projects to solve problems involving more than one town, and help member communities in their planning programs. The Council's authority is conferred by RSA Chapter 36:45-53. It is advisory to local governments in the region. The following is a report from the North Country Council regarding its activities on a regional and local basis. The Council's Board of Directors respectfully requests that the Selectmen include this report in their official Town Report. NCC's representatives have received a copy of this report and are requested to change it as they see fit.

The North Country Council (NCC) is the official planning organization (RSA 36:45-53) for the North Country. The Council undertakes area-wide planning programs, when appropriate, and provides community planning services and information to Towns. The Council's Board of Directors, two representatives from each of the 19 Member Towns, determines the work program and budget.

During 1974, the Council completed an Economic Base Study, assisted 30 towns in solid waste by organizing site inspections and planning by providing information on volume, cost and transportation of solid waste. The Council also prepared a model Town Kit Fact Book, and a model flood district ordinance. The Council is preparing a Public Transportation Plan for the North Country and has submitted an application to the Federal Highway Administration for a rural transportation demonstration project. NCC has updated the State's Outdoor Recreation Plan for the North Country. This enables communities to maintain eligibility for federal funds. The Council has sponsored meetings and conferences on flood insurance, solid waste, land use, and septic tank disposal.

While working in the Town of Monroe, the Council has provided assistance in the following areas:

Met with Selectmen and Planning Board to discuss Federal Flood Insurance Program.

Worked with Planning Board to organize public informational meeting on subdivision regulations.

NCC provided limited assistance to the Town to show the benefit of membership.

FIRE CHIEF'S REPORT

During 1974 the Fire Department answered five calls for assistance as follows:

- 1 grass fire on Hunt's Mountain
- 1 chimney fire
- 3 assistance calls to other towns

The Fire Department has actively been training its men in techniques of fire fighting. Not only have we conducted a forty-hour training session with State Instructors here in Monroe, but we have sent men to schools at Lilly Pond in Gilford, N.H., Woodsville, N.H., Bradford, Vt.

Looking toward 1975, we have asked for an increase in our budget. As you all must realize, fixed costs such as telephone, electricity, oil, etc., have just about doubled in the last few years. We are also asking for an appropriation to build a new tank for the Chevrolet tank truck in the village. This tank will be designed so, in the future, it can be used on another chassis. The present tank has numerous small leaks and, if not replaced in the very near future, this truck will be rendered out of service.

I would like to thank all of the firemen who have given their time attending these schools, attending meetings and keeping the equipment in repair throughout the year.

FOREST FIRE WARDEN'S REPORT

All open burning when the ground is not covered with snow is controlled by the Town Forest Fire Warden in cooperation with the New Hampshire Forest Fire Service. Anyone wishing to kindle a fire out-of-doors when the ground is not covered with snow must have a written permit signed by the Town Forest Fire Warden. If the fire is to be kindled on land not owned by the person kindling the fire then he must have the permission of the landowner. No outdoor fires can be kindled between 9 a.m. and 5 p.m. unless it is raining, without the additional approval of the District Forest Fire Chief.

The 1974 forest fire season was one of the worst in the past two decades. Woodlands in central and southern New Hampshire became so dry in mid-August that the Governor and Council, upon the recommendation of the State Forester, enacted a partial woodlands closure in Sullivan, Cheshire, Hillsborough, Merrimack and Belknap Counties and a complete woodlands closure in Strafford and Rockingham Counties plus the Towns of Barnstead, Gilmanton and Alton in Belknap County. Through the excellent cooperation of the citizens of our state no major forest fires occurred at any time during the year.

MONROE CLINIC REPORT

Our current year has been marked by changes.

The total number of office visits has been 1,259, with 196 new patients seen.

In September, 1974, forty-eight school children were examined.

Dr. Marvin Kendall started practice September 11, 1974. The Clinic opened with a four day per week schedule. Presently the Clinic is open on Saturdays with Dr. Kendall taking house calls through the weekend.

At the present time the Clinic is open on Wednesdays from 1 to 3 p.m., to serve patients who desire information or appointments for the weekend.

In September, Mrs. Laura Bort resigned as secretary for health reasons and was replaced by Mrs. Joan Kelso. Mrs. Bort worked efficiently and diligently to provide excellent service for the Clinic.

This year new paving has been extended to the area around the Clinic parking space.

Mrs. Catherine Hughes, R.N., became the Clinic nurse in October.

The total expenditures for 1974 were \$16,943.18.

Total received for medications \$2,467.00.

Total returned to the Town treasury \$3,359.00.

This report would not be complete without paying special tribute to our first Clinic nurse, Mrs. Dorothy Lang. She worked unstintingly and conscientiously often beyond the call of duty to provide for the comfort and welfare of the patients under her jurisdiction.

We wish to thank the people of Monroe for their continued financial support and we will continue to serve this town as well as surrounding towns in every way possible.

I wish to thank the members of the Clinic for their support, through the past year.

SUMMARY PROGRAM OF THE WHITE MOUNTAINS REGION ASSOCIATION

1974 (37th Year)

Your Region Association during the year 1974 was active in several cooperative programs. They included the White Mts. Center for Music and the Arts, an experimental mass highway transportation system, and the White Mts. '74 summer advertising program.

With respect to the Center (formerly called the White Mountains Art and Music Festival), your Region Association has contributed substantial in-kind services. As a board member and secretary, your Association's Executive Director handles many of the day to day details for the Center. In addition, the Association provided office space for the Center during May and June and was responsible for much publicity. Furthermore, the Association's secretary was on loan to the Center, half-time, for May and June.

Your Region Association provided assistance in setting up and implementing an experimental bus system. Communities served by the 10-week summer system included Berlin, Gorham, Milan, Groveton, Lancaster, Whitefield, Littleton, Franconia, Bethlehem, Twin Mountain, Jefferson, Randolph, Conway, North Conway and Jackson. During the first half of 1975, it is hoped a federal proposal will be approved which will permit the experiment to continue and to provide service to other communities.

Your Region Association was a major participant in White Mountains '74 cooperative advertising campaign designed to bolster the economy of the recreation industry this past summer. Your Region Association appropriated \$2500 to participate in the program. In addition to investing \$2500, your Association answered all written and telephoned inquiries which were generated by the advertising. As a result your Association responded to those inquiries with some 3500 vacation planning kits. Those participating included the White Mts. Attractions Association, the White Mts. Center for Music and the Arts, the New England Regional Commission, the Governor's office and Waumbek Village.

Other activities and projects of your Region Association include: participation in a newly created N. H. Travel Council, annual solicitation for the two accommodations brochures, distribution of WMRA folders, sponsorship of a conference on proposed wilderness areas in the White Mountain National Forest, solicitation for business memberships, presentation of 4-H awards and certificates, subscriptions to National 4-H magazines for group leaders in the three northern counties, assistance at the N. H. information booth at the Springfield Exposition to promote travel in northern N. H., the writing of several letters to the N. H. Congressional delegation and others protesting the proposed closing of numerous campgrounds

and picnic areas in the White Mt. National Forest, also the writing of letters to many of the same group protesting the low priority tourism and recreation was to receive under a fuel allocation program, financial contributions to the restoration of the Bedell Covered Bridge, to the Mount Washington Observatory (in memory of Joe Dodge), and to the White Mts. Museum of Forest History. The WMRA also has helped out on some publicity for the proposed museum as well as some modest fund raising.

In addition, earlier in the year, the WMRA surveyed some thirty gasoline stations each week. The information on gasoline supplies was then relayed to the Dept. of Resources and Economic Development where it was used to aid out-of-state travelers.

Finally, your executive director wrote numerous news releases, two newsletters, some special articles for publications, and spoke on several radio programs in the region.

Answered 5,942 inquiries and wrote 101 personal letters.

Planned activities for 1975 are: (1) investigate the possibility of helping to provide regularly scheduled air service to Whitefield and Berlin; (2) publish a new quarterly magazine for the region; (3) modernize and revise the White Mountains Map; (4) publish the Where to Stay and the New Hampshire Accommodations and Dining directories; (5) participate in the joint experimental rural highway and transportation project; (6) continue the Association's work with the White Mountains Center for Music and the Arts; (7) explore further the possibility of preparing and publishing a Christmas tree dealers vendor list; (8) participate in the Springfield, Mass. Exposition; (9) continue to answer some 6,000 inquiries generated through advertising; (10) distribute WMRA folders to information booths around the region and to some State Highway Rest areas; (11) continue the Association's efforts on behalf of the White Mountains Museum of Forest History; (12) continue writing news releases about White Mountains Region Association's activities and help promote other regional events; (14) keep abreast of all important legislation that pertains to the region during the next legislative session; (15) continue to participate actively in the newly created New Hampshire Travel Council; (16) continue to publish the Bulletin of Lodging Inquiries and Real Estate Bulletin.

All routine screening tests were completed and referrals were made if necessary.

The School physicals were done at the Monroe Medical Center.

Mrs. Stark, dental hygienist from the Division of Dental Health in Concord started a new dental program in grades 3 and 4. A dental survey was done and pupils were taught the proper use of tooth brush and dental floss. Mrs. Moore followed through by supervision of children's brushing and flossing. The follow up survey by Mrs. Stark showed marked improvement in mouth cleanliness.

In May registration was held for pupils entering school for the first time.

Following are copies of new laws relating to physical examinations and immunizations necessary for children entering school.

RSA 200:38

200:38-I States: "All children *shall be immunized prior* to school entrance according to the current recommendations of the State Public Health Agency."

The recommendations of the Division of Public Health become requirements of the State Board and local school boards by this statute.

The immunizations listed below must be completed prior to school entry:

1. Measles Vaccine (live attenuated) (having had measles is acceptable when verified).
2. Oral Trivalent Polio Vaccine (Sabin)
3. Diphtheria, Pertussia, and Tetanus (DPT) (Adult type DT when over 6 years of age)
4. Rubella Vaccine

Routine smallpox vaccination is not recommended.

Other vaccinations are optional.

200:38-III States: "All children shall be examined prior to school entrance to detect symptoms of tuberculosis and may be periodically examined during his school experience."

Tuberculin Test (intradermal) (within one year prior to school entrance.)

RSA 200:32 States: "A medical examination is required upon or prior to entrance into the public school system and thereafter as often as deemed necessary by the local school authority.

In the very near future, legislation from either the federal or state level, will mandate that school districts and public agencies negotiate with public employees on direct economic benefits. When this legislation becomes law, it will mean that school boards will have to negotiate with teachers. This procedure is now followed in the majority of the states, but New Hampshire is among the last to make negotiations a legal requirement. It is the sign of the times.

Also, another legislated mandate from the legislature or state board will be accountability in the area of learning outcomes. We have always been fiscally accountable to the New Hampshire Tax Commission, but this is a new area. We have had nine drafts of a state accountability model and, hopefully, one will be finalized this year. In essence, at the local level school districts will be asked to define their own objectives, build programs which will help students master these objectives, and develop evaluation plans for determining how well the objectives are being attained. This will be an elaborate challenge for everyone concerned with education in this district.

Last spring all elementary schools in Supervisory Union #23 were evaluated by the New Hampshire Department of Education concerning Elementary School Minimum Standards. Although we were extremely distressed with the final assessment, it appears that the evaluator was stretching the point in his indication that Monroe was not meeting Standard #3. It should be noted that an addendum to the report: "We need more

time to discuss the possibility presently at Monroe" indicates to us that the jury is still out.

A new program for the certification of all professional personnel in the state has been developed on a supervisory union level and has also been approved by the Department of Education. This new program will become effective on July 1, 1975. It might be apropos at this juncture to compliment the teachers and administrators of the union for their many hours of extra service and also the very fine document they produced.

Your recommended budget from the school board for 1975-76 shows an increase of \$3,224.42 or 1.32%. With the advent of a recessionary-inflationary economy this certainly is not an increase that one should consider is adding fuel to the inflationary fire.

One reason for our budget not increasing as rapidly as other years is the drop in tuition students. Although rates are climbing very quickly, our drop in enrollment is more than offsetting the sharp increases.

My appreciation and thanks are extended to the Monroe School Board members, faculty and voters of the district for their wonderful cooperation during the past year.

REPORT OF THE ASSISTANT SUPERINTENDENT OF SCHOOLS

I herewith submit my fifth annual report to the voters of the Monroe School District.

The school year began with our annual Orientation Workshop for all Supervisory Union Staff members. The workshop was held at Lin-Wood High on the 28th and 29th of August, 1974. The general theme of our conference was "Performance Objectives as a Means to Curriculum Development". The first day was spent with four special consultants, Mr. George Bussell, Mrs. Judy Chase, and Mr. Doug Brown from the State Department of Education and Mrs. Mary McKelvey our Science teacher at the Haverhill Academy Junior High. The special consultants worked with the teachers in small groups on the various approaches to the development of curriculum objectives. On the second day the teachers were divided into subject area groups and began to work on devising curriculum objectives at each level and in each subject area. These committees have continued their work into the school year. Our main concern is to write these objectives in precise and measurable terms.

In my last report I referred to the formation of a Staff Development Committee. This Committee was authorized to formulate a three year masterplan for the recertification of all staff members according to guidelines set down by the State Department of Education. We are very pleased to report that we have submitted our plan and it has been approved by the State Department of Education. The approval was dated January 17, 1975. The plan will go into effect on July 1, 1975 and run through June 30, 1978, at which time it will be considered for renewal.

On May 14th, 15th and 16th, 1974, Mr. John Economopoulos, Elementary School Services Coordinator, State Department of Education conducted an evaluation of the Elementary Schools in Supervisory Union #23. This evaluation was made with respect to the State's Minimum Standards. The results of this evaluation are printed separately verbatim.

You can see that the evaluation is extremely positive. The Monroe Consolidated School has met all of the minimum standards but one—Certified Librarian (part time). The State Department of Education indicates that we should give this matter a high priority in the near future. Overall the evaluation was very good and reflects credit on the School staff and the community.

Many thanks to our school lunch operators, Mrs. Parker and Mrs. Roth for their efficient and economical operation, no easy task these days.

My sincerest thanks to the School Board, and the staff for their excellent cooperation.

REPORT OF SUPERINTENDENT'S SALARY

Section 5, Chapter 243, Laws of 1953 of the State of New Hampshire requires that school district annual reports show the total amount paid to the superintendent.

One-half of the supervisory union expenses is prorated among the several school districts of the union on the basis of adjusted valuation. One-half is prorated on the basis of average daily membership in the schools for the previous school year ending June 30. The Superintendent of Supervisory Union #23, during 1974-1975, will receive a salary of \$20,300.00, which is made up as follows: \$2,500.00 to be paid by the State Department of Education and \$17,800.00 prorated among the several school districts. Allowance of \$1,500.00 for travel within the Union is also prorated as stated above.
