## Annual Town Meeting

#### March 10, 1964

The polls were declared open for voting at 10:00 a.m. The business meeting was opened at 7:30 p.m. The warrant was read by the Moderator, Dana Parks, Jr. Invocation was offered by Rev. David Hatch.

Mr. Dana Parks, Moderator, extended a thank you in behalf of the Town Officers to the Parent - Teachers Group for serving an excellent lunch and dinner.

Articles 1 and 3: Already being acted upon by balloting.

Articles 2, 4 and 5: (Budget items). It was voted in the affirmative that these articles be laid on the table for later discussion.

Article 6: Voted in the affirmative to authorize the Selectmen and Town Treasurer to borrow up to \$30,000.00 on notes of the Town in anticipation of taxes.

Article 7: Voted in the affirmative to hear reports of agents, lauditors, and officers heretofore chosen.

Article 8: It was voted in the affirmative to raise and appropriate a sum of money for the control of White Pine Blister Rust. (Estimate 98.04).

Article 9: It was voted in the affirmative that the Town petition the State Tax Commission, Division of Municipal Accounting, to have an audit made and make an appropriation to cover the expense of such audit. (Estimate \$300.00).

Article 10: It was voted in the affirmative that the Town raise and appropriate a sum of \$100.00 for the Franklin Hospital.

Article 11: It was voted in the affirmative that the Town raise and appropriate a sum of \$3,000.00 for a new fire truck. This sum of money to be raised, \$1,000.00 by taxation in 1964, and the balance by two serial notes - a \$1,000.00 note to mature in 1965 and a \$1,000.00 note to mature in 1966.

Article 12: To see if the Town will vote to raise and appropriate a sum of \$1,000.00 for a new straight blade plow. This sum of money to be raised by taxation in 1964. It was voted in the affirmative that we pass over the article.

Article 13: It was voted in the affirmative that the Selectmen were authorized to sell the Town Tractor by Sept. 1st, 1964 for whatever amount they could realize from same.

Article 14: It was voted in the affirmative that the Town use \$2,500.00 of the Capital Reserve Fund interest for road maintenance in the flood control basin.

Article 15: A resolution was made that the Town Meeting express

their appreciation to the Town Officers and the Zoning Committee for their efforts for the past year.

Articles 2 and 5: It was voted in the affirmative that the Town raise and appropriate such sums of money as maybe necessary for the Town Budget.

Article 4: It was voted in the affirmative that the Town accept the budget as submitted by the Budget Committee. (\$1,000.00 not included in Budget Committee recommendation for new plow.)

It was voted in the affirmative that the business meeting be adjourned at 8:20 p. m., and the polls were closed at 10:35 p. m.

Lovejoy — 108 votes, declared elected: Auditor, George Beauly — 9 votes, Edward Sawyer — 2 votes, — Audit to be made by State Tax Commission. Library Trustee for three years, U. Martha Patten — 76 votes, declared elected. Trustee of Trust Funds, Arthur Schaefer — 97 votes, declared elected. Budget Committee for three years (Three Members) Dorothea Lovejoy — 97 votes; Harley C. Shaw — 77 votes; Edward C. Fales — 61 votes, George Draper — 12 votes, Dorothea Lovejoy, Harley C. Shaw and Edward C. Fales declared elected. Road Agent, Charles Taylor — 82 votes, Leon Jones — 31 votes, Charles Taylor declared elected.

The following elected officers were sworn in at the meeting: Clarence Holmes, Norma C. Lovejoy, Mrs. Norma M. Lovejoy, and Ruth H. Benedict.

## Fire Department Report

The past year was another busy year for the Salisbury Volunteer Fire Department with 15 calls answered, one of which was to an out of town forest fire. Eight of these calls was to the Town Dump. We were fortunate that only one of these calls was for a building.

The department purchased a new Dodge truck and a 1250 gal. tank was built on it. The men are now working at building storage compartments around the tank. Although not fully completed, the truck has already been used for several fires and proved quite satisfactory.

Added to new equipment during the year was 200 ft. of 1 1/2" hose and ten pair of boots.

Townspeople, who seem to be fire cautious and conscientious, are to be commended for their cooperation during the year, especially during the dry spell last fall. Again our thanks to the ladies for their kindness to supply food and coffee to the men while at fires.

Again we remind you — when reporting a fire please use the fire phone number, 8-2200. When you call this number, three phones at three different locations, all ring at the same time, thus putting the fire call system into faster operation.

## Report of the Forest Fire Warden

The 1964 forest fire season surpassed the record year of 1963 in both length and severity. For the second successive year, we experienced a rainfall deficiency of more than ten inchs and the compounding of such drought conditions, together with the many days of strong dry winds, characterized 1964 as one of the most hazardous years in the past half century. Although our fire season was three weeks longer than that of 1963, the number of fires showed only a slight increase and more remarkable was the fact that the area burned dropped from 2280 acres in 1963 to 900 acres in 1964. Early detection and rapid response kept many potential fire disasters from becoming reality. We all owe a debt of gratitude to the men in this community who responded and fought our fires so efficiently. Our state is now 86% wooded and its economy - both industrial and recreational - is greatly dependent on this forest rsesource. The responsibility for adequate fire protection of this great area - 4,350,000 acres - is everyone's responsibility and prevention is one of our most effective tools.

Prevention is good common sense.

- 1. Take your rubbish to the town dump. If you must burn, obtain a permit and watch your fire until it is dead out.
- Instruct your children in fire safety. Keep matches from young children. Explain to them the dangers of lighting matches and making outdoor fires.
- 3. Be sure discarded smoking material and matches are out.

A major portion of our preventable fires this year are chargeable to three causes: (1) permit fires allowed to escape; (2) children playing with matches; and (3) smokers. Let's be mindful of the fact that all such fires endanger property and lives.

We wish to thank you for your very fine cooperation during the past fire season and with your continued cooperation we are confident that we can improve our fire record in 1965.

# **School District Meeting**

### Salisbury, N. H.

#### March 7, 1964

At the time and place mentioned in the warrant, the legal voters of the School District met and transacted business as follows:

At 6:30 P. M. the Moderator, Dana Parks Jr., read the warrant and declared the polls open for balloting for election of officers under Articles 1, 2, 3 and 4 in the warrant.

The business meeting was called to order at 8 o'clock by the Moderator. Invocation was offered by Rev. David Hatch.

- Art. 5. It was voted to lay this Article on the table until the consideration of Article 8 to which Article 5 pertains.
- Art. 6. Voted on motion made and seconded to accept the reports of the school district officers as printed in the Town Report. Vote in the affirmative.
- Art. 7. It was voted to lay this Article on the table until after article 10 had been considered.
- Art. 8. Voted on motion made and seconded that the district appropriate the sum of \$46,358.50 for the support of schools. Moderator declared the vote in the affirmative.
- Art. 9. It was a vote in the affirmative to accept this Article to petition the State Tax Commission to have an audit made by the Division of Municipal Accounting.
- Art. 5. Motion made and seconded to accept Article 5 as a part of Article 8. Vote in the affirmative.
- Art. 10. A motion was made and seconded that the district create a cooperative school district planning committee consisting of three qualified voters of the district, of whom at least one shall be a member of the school board, and that they be appointed by the moderator. An amendment to the motion that two alternate members be appointed was accepted. The Moderator declared the vote in the affirmative.
- Art. 11. A resolution was made asking the cooperative school district committee to report periodically at a public meeting with

any information to keep the town fully informed. It was moved to accept the resolution.

Upon motion made and seconded the polls were declared closed.

Art. 7. The Moderator appointed Donald Nixon, Lewis Bartlett and Edna Ballam as the three members of the cooperative school district committee with two alternates to be selected by the committee. Norma C. Lovjoy was later appointed to replace Lewis Bartlett.

A motion was made and seconded to adjourn the meeting. Vote in the affirmative.

Ballot counting results were as follows:

For Moderator: Dana Parks Jr. 40. Dana Parks Jr. declared elected.

For Clerk: Dorothy Bartlett 41. Dorothy Bartlett declared elected.
