To the Inhabitants of the Town of Groton in the County of Grafton in said State, qualified to vote in Town Affairs:

You are hereby notified to meet at the Town House in said Groton on Tuesday, the fourteenth day of March, next, at nine of the clock in the forenoon, to act upon the following subjects:

- 1. To choose all necessary Town Officers for year ensuing and three years.
- 2. To raise such sums of money as may be necessary to defray town charges for the ensuing year and make appropriations for same.
- 3. To see if the town will vote to accept the budget as prepared and make appropriations for same.
- 4. To see if the town will vote to give a discount of 3% on property taxes paid on or before August 1st.
- 5. To see if the town will vote to authorize the selectmen to dispose of or administer any real estate acquired by tax collector's deed.
- 6. To see if the town will vote to authorize the selectmen to borrow money in anticipation of taxes.
- 7. To see if the town will vote to raise a sum of money for blister rust control and make appropriations for same.
- 8. To see if the town will vote to accept state aid construction and make appropriations for same.
- 9. To see if the town will vote to accept T. R. A. for Class V Roads and make appropriations for same.
- 10. To see if the town will vote to raise a sum of money for fire fighting equipment and make appropriations for same.
- 11. To see if the town will vote to have state auditors and make appropriations for same.

- 12. To see if the town will vote to raise a sum of money for plow, either blade or V shape, for use with a truck for winter breaking and appropriate money for same.
- 13. To see if the town will vote to contract the snow removal and sanding for a term of years and make appropriation for same.
- 14. To see if the town will vote to raise a sum of money for rental of land for sticking lumber and make appropriation for same.
- 15. To see if the town will vote to open road to Mike Parris house and allow him to repair it for back taxes.
- 16. To see if the town will vote to raise and appropriate the sum of \$10 for the issuance and distribution of printed matter, calling attention to the resources and natural advantages of the town in co-operation with the other towns in the Dartmouth-Lake Sunapee region.
- 17. To see if the town will vote to raise and appropriate a sum of money to buy cloth for curtains for booths at town house.
- 18. And to transact any other business that may legally come before said meeting.
