Whereas S. S. Mauney has in his possession the sum of Five Hundred Dollars, bequeathed to Zion Baptist Church by the terms of the will of Mrs. Rachel Weathers, and has proposed to loan said sum to Zion Baptist Church now,

Therefore be it resolved;

That we, the membership of Zion Church instruct our Board of Deacons to execute to said S. S. Mauney the following promissory note for the above amount, to wit:

For value received, we the following named Deacons, or our successors, of Zion Baptist Church promise to pay within six months after the death of said S. S. Mauney, to the administrator of his estate, the sum of Five Hundred Dollars with six per cent interest, payable annually, from date,
