Abstract

The following research report will look at a series of domestic factors that posed a threat to Bulgaria's integration into the European Union in January 2007. In this light, this research report will evaluate the efforts that Bulgarian political leaders have taken to meet those existing domestic political challenges and thus assess Bulgaria's progress towards meeting the political and economic criteria towards EU membership. This research study will be explained by the theoretical tradition of the *multi-level governance* approach, which assumes the involvement of supranational, national and sub-national actors in the processes of European integration.

Preface

The following research report is an analysis of the dynamics and underlying themes leading up to Bulgaria's eventual accession into the EU. Therefore, the end point of this analysis is the actual event of Bulgaria's accession into the EU on the 1st of January 2007. In this light, the following research report will not try to predict what the political implications of Bulgaria's membership into the EU would be on Bulgarian politics, European politics or on the processes of European integration and enlargement per se. Put simply, this present work will not go so far as to offer an analysis of Bulgaria's membership into the EU from a post-enlargement perspective.

This research report will also not try to illuminate the controversy surrounding the debate of widening versus deepening or integration versus enlargement with regards to the study of European integration. Essentially, this present study will be an attempt to describe the process of Bulgaria's accession into the EU from a clearly enlargement perspective and not necessarily from an integrationist perspective. The main focus of this present study will be therefore the internal dynamics of the accession process seen mainly from a domestic perspective. The choice for this research topic has been deliberate, indeed.

My primary intention was to describe that the agenda towards integration has dominated Bulgarian foreign politics since the early days of democratisation and it has occupied a central place in Bulgaria's transition towards democracy and its whole pre-orientation to the West. I believe that this idea has not received much attention in the scholarly work on European integration and this present study could provide some insight into the link between democratisation and European integration by drawing a reference to this particular case-study.

On the other hand, there has not yet been a vast amount of literature published on this topic or looking at the process of Bulgaria's accession into the Community from a purely domestic perspective. In this regard, I think that the literature on European integration published lately (in fact, since 2004) tends to portray the process of EU enlargement mainly from an EU perspective and thus it neglects the cost of the enlargement process

for the small EU candidates and their long road towards accession. Therefore, my primary attempt throughout this study was to illustrate what it really meant and what it costs Bulgaria to become an EU member, and what series of domestic reforms needed to be implemented so Bulgaria could eventually reach the EU membership criteria.

Last but not least, this present work has been sort of a new experiment for examining the process of EU enlargement with a fairly new research technique. Firstly, the research report aims to describe the process of EU enlargement from a general integrationist perspective. Then, it narrows down the analysis with specific reference to the theme of Bulgaria's accession into the EU (domestic perspective). Lastly, it applies this present case-study back to the theme of European integration and illustrates the essential meaning of integration from the perspectives of both Bulgaria and the EU, and highlights their contribution to the process of integration. In this regard, the aim of the last chapter will be indeed, to illuminate *who* did *what* in the process of Bulgaria's accession into the Community.

I hope that this study may contribute to any older or younger scholar or fellow of European integration, and to anybody who is interested in this particular topic. I also hope that the readers might learn something new from this present work and could probably use it for further work in this area despite the existing limitations of this research report.
