- **G** Research approach involving the community
- Community members are active and equal partners*
 - □ Shared responsibilities and ownership
 - □ Shared decision making



Importance of CBPR

Bridges the divide of bias between the researchers and the community*
Aids towards social change

Utilization of CBPR

- Why is it not used often?
 - Requires additional time and resources (e.g., personnel, funds)*
- □ Why should it be used more often?
 - Explores local and community knowledge*

Examples of CBPR

- Project SELA
- System-level changes in health indicators that influence the well being of children and their families ¹
- improve shelter services on and off reserve in our area by engaging the voices of Indigenous women who had experienced domestic violence.²
- Community Advisory Boards
 - Utilizes cultural practices
 - □ Role-modeling
 - Native art
 - spirituality


CBPR ENGAGES THE COMMUNITY AS THE EXPERT
