Purpose

Goals

The next aim for our journal, now at five years of age, is to be recognized by PubMed. We are currently applying with feedback from both the Open Access Scholarly Publishers Association (OASPA) and the Committee on Publication Ethics (COPE) towards that goal. As Editors-in-Chief, we have been handed a journal with great potential. It is our responsibility to make decisions to make it prosper. We intend to continue to increase the expanding readership, while maintaining and raising the standard for scientific rigor for the journal.

For manuscripts of good scientific merit, but hampered by written language issues, we are adding previewing editors so that the efforts of the reviewers will be most efficient. Many publications charge for this service or make it exclusively the responsibility of the author, prior to submission. To keep publishing articles of high importance, we will adjust with the evolution of relevant topics. For example, last year, *ULJRI* adapted by devoting an entire issue to COVID-19. This year, we look forward to the trends of respiratory infections research. As an online journal, we are an inherently multimedia publication, but last year we introduced a dedicated Multimedia section to capitalize on this method of disseminating information. These are some of the endeavors we look forward to expanding.
