

PRESENTACIÓN

Esta bibliografía contiene una selección de la literatura disponible sobre el rol de la Educación Superior, de sus instituciones, y su aporte al desarrollo humano y social en el contexto de la globalización.

Para las instituciones de Educación superior ya no se trata solamente de transmitir conocimiento, de formar técnicos cada vez más altamente especializados, de hacer frente a los desafíos de las nuevas oportunidades originadas por las innovaciones tecnológicas; se trata también y cada vez con mayor exigencia, de participar activamente en la búsqueda de respuestas innovadoras frente a las necesidades de las complejas sociedades actuales.

Las diferentes publicaciones son un reflejo de cómo las Instituciones de Educación superior están siendo llamadas a estrechar sus lazos con la sociedad, por medio del análisis, de la investigación, del estudio de sus problemas y del planteo de posibles soluciones, a fortalecer sus funciones al servicio de la misma.

La degradación del medio ambiente (contaminación del agua, crisis de la energía, calentamiento global, etc.); la lucha contra la pobreza el hambre, contra la violencia y la intolerancia, la dificultad de acceso a los bienes públicos, el estudio de la contracción progresiva del mercado de trabajo y sus consecuencias, la grave crisis de valores que las sociedades atraviesan, la rapidez de los cambios que éstas sufren, son temas que se hacen cada vez más presentes e ineludibles en el debate universitario.

Los desafíos a la Educación Superior difieren según las regiones y se puede constatar que si bien la tecnología ha facilitado el fortalecimiento de la cooperación internacional, ha incrementado el intercambio de conocimientos y ha permitido anticipar algunas de las necesidades de la sociedad, se está aún lejos del cumplimiento de los objetivos enunciados en la *Declaración Mundial sobre la Educación Superior en el siglo XXI: Visión y Acción* aprobada por la UNESCO en la Conferencia mundial de 1998.

De la lectura de los textos presentados, surge también, que si bien un cambio ha comenzado, se continúa en la búsqueda de un papel verdaderamente protagónico; de un rol que permita a las instituciones de Enseñanza Superior contribuir decisivamente a generar una sociedad más equitativa y más justa con el fin de reducir la disparidad entre los países en desarrollo y los países industrializados.

Para la mayoría de los autores queda, por lo tanto en evidencia la necesidad, a pesar de las dificultades, de continuar la renovación, de continuar a promover por medio del conocimiento y de una acción local y global adecuada, el respeto de los derechos humanos, el desarrollo sostenible, la democracia y la paz.
