
It is declared that we have agreed to fulfill all the agreement conditions that are inside this agreement letter. As business partners, we are responsible fully toward all the profit and losses of the company.

For the witness of the content of this agreement letter, therefore business partner have to sign the agreement in front of witness on the date were this letter is declared.






