1) ISSUES

These are more or less verbatim except where acronyms had to be explained or additional explanation added. Where the same issue was raised several times we have tried to avoid repeating it below.

#### **1.1. RESEARCH EXCELLENCE FRAMEWORK (REF)**

Compliance with REF requirements starting with April 2016 deadline

• HEFCE have said that SHERPA FACT should facilitate this

What does a great OA research environment look like? (REF brownie points on offer!)

International authors difficult to comply if they are not at concerned.

Audit of date acceptance

Engagement of academic staff with OA agenda

If I have lots of publications with long embargoes I will have lots of exceptions - worried!

Resource increase required for managing acceptance date workflow

How to find out when a paper is published

Compliance –

Are we breaking our backs when HEFCE won't really care?

WHY DON'T THEY CARE?! (In theory) it's easy to provide compliance data.

ORCID mandate for REF

Convincing publishers to supply DOI on acceptance? (Where is the driver for them to do so currently?)

How will HEFCE collect REF audit info from repositories?

Why 90 days? (There will always be the need for exceptions, but with no apparent way to set an exception on this issue).

Staff are mobile; SO, How can we get information from other HEI's, relevant to the REF, if and when staff move from one HEI to another close to the next REF submission date? We will need metadata on publications for OA and not just a note of outputs themselves. There is an exception if movement is recent.

Our systems can capture data but is it reliable?

Action: Rob Johnson to take these concerns back to HEFCE. Valerie McCutcheon to input these to the forthcoming E2E REF workshop (planned for 10<sup>th</sup> September in Southampton) as well as sharing them with Jisc.

• Connecting grants with publications still a problem for some. Action – how can we help? Will showing how others have done this be any use? (Example from Glasgow EPrints below)


