aejaj8 I am interned at Ellis Island. I have received written notificat= ion by the Commanding Officer of the Fort Lincoln Internment Camp, Bismarck, North Dakota, that the Government has decided upon my removal from the United States.

"Court action to test the validity of the Alien Enemy Act of 1798 is pending, and until such time as a decision is rendered no action looking to the forced repatriation of alien enemies is contemplated."
(From a letter, last Paragraph from Mr. T. E. Shoemaker, Acting Commission= er of Immigration to Hon. Frank B. Keefe, member of the House of Representatives, Washingon D. C.).

May be it will take a long time before the Court action in the "Court of Appeal" (or later the "Supreme Court") is finished.

I am by occupation a Practitioner for Homoeopathy and Naturo= pathy. Lincensed in Germany from 1930 to 1937. Legally immigrated from Germany on July 29, 1937.

My American Diploma for Swedishy Massage, Diet, Hydro-Therapy etc. was not enough for me als a Practitioner, and I have been a student of the Sierra States University, Dept. Chiropractic, in San Francisco, since March 1939 and attended school regularly until December 7, 1941 at which time I was arrested and later interned by Federal Government.

I was arrested six months before final Examination!
