D. 1891, Elie Jackson, of Midalgo County, Itas, did execute and deliver a mortgage, upon the land heremafter described to the mercantile form of Bloomberg & Raphael of the City of Brownsolle in Said County of Cameron for the purpose of securing the payment of two promissory notes executed by the said Jackson to said firm, and two notes bearing date Rebruary 24 1/891, one being for the sunday five hundred and six dollars and sixty five cents \$506. (5) in mexican Coin and made payable to said firm on the first day of October 1891, and the other note being for the sum of five hundred and six dollars and sixty six cents \$506.
