PRESS RELEASE FROM THE PREMIER, MR. DUNSTAN.

OFFICIAL APPOINTMENTS.

7.8.73

Mr. Ray C. Taylor, at present South Australia's Agent-General in London, is to become chairman of the Monarto Authority, the Premier, Mr. Dunstan, announced tonight.

Mr. Taylor will be replaced as Agent-General by Mr. J.S. White, at present Secretary of the Department of the Premier and of Development.

The Premier said he was delighted that Mr. Taylor had agreed to the Government's request that he return to South Australia for this important new appointment.

"I am equally delighted that the State will be represented in the United Kingdom by a man of Mr. White's wide experience and administrative skills".

The Monarto Authority will be the guiding administrative body for the new city. Legislation for its establishment will be introduced into State Parliament shortly, the Premier said.

Mr. Taylor's central task as the Authority's chairman would be to oversee the establishment of the city's industrial employment base.

He will work closely with the Commission's recently appointed general manager, Mr. A.W. Richardson, and the Monarto Design Team which will be appointed later this year.

"Mr. Taylor's considerable experience in private industry together with his knowledge of Government administration gained in his present office make him an ideal choice for this appointment".

The Premier said Mr. White was a most distinguished South Australian public servant. He had served successive Governments in the Premier's Department and exemplified the highest standards of public administration.

One of his main tasks in London will be to co-ordinate the work of the Government's European trade activities.

Mr. Taylor is expected to return to Adelaide later this year and formally to take up his new appointment early in 1974.

Mr. White will take up his new post at the end of March 1974. In the interim, the Official Secretary at South Australia House, Mr. Allan Deane, will act as Agent-General.
