# CONSTITUTION OF THE WESTERN COLLEGE PHAYERS

## Article I.

This organisation shall be called the Western College Players

#### Article II.

The object of this club shall be to foster two major dramatic productions a year and to maintain a social spirit among students interested in the study of drama.

## Article III.

Participation in one major production and payment of dues shall be required for membership.

#### Article IV.

Section I. The officers of the organization shall be a president, a vice-president, a secretary-treasurer.

Section II. These officers shall be elected at the last meeting of the year for the following year.

#### Article V.

Section I. The regular meetings of the club shall be held once each month from September to May inclusive, except for November and March.

Section II. The president may call special meetings when he deems it necessary.

## BY-LAWS

- 1. Dues shall be twenty-five cents per semester.
- 2. The vice-president shall be the chairman of the program committee.
- 3. The secretary-treasurer shall be custodian of the club funds.
- 4. Privilege of wearing the Player's key or pin shall be an earned privilege achieved through participation in a second production in one capacity or another and attendance at two-thirds of the regular meetings. Any art student wishing to make a stage setting an individual project may earn the right to wear the key or pin by working on two such sets. A committee, composed of the club sponsor and two other members of the club to be appointed by the president, will decide upon those individuals who are eligible to wear the key or pin.

- 5. This constitution and by-laws may be amended at any regular meeting by a unanimous vote, or, if a month's notice has been given, by a three-fifth vote of the members present.
- 6. A copy of the constitution and by-laws shall be placed in the regular library of the school. A second copy of the constitution and by-laws shall be placed in the office of the club sponsor.
- 7. This constitution shall take effect immediately upon approval by a vote of three-fourths of those members present.
