so I feel very good over the results of this week.

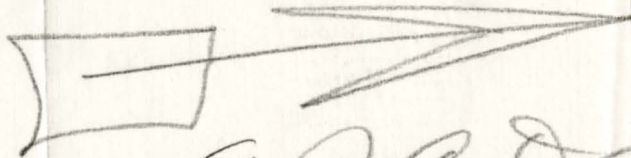
The regular term of our court begins next Monday
