**Biographical/Historical Note:** The president's office was created in 1906. As Dero Downing's resignation went into effect January 8, 1979 Vice President John Minton was appointed interim president. He held this position through July 31, 1979 when Donald Zacharias was elected president.

John Minton was born in Cadiz , Kentucky on July 29, 1921. He received his bachelor's and master's degrees from the University of Kentucky and a Ph.D. from Vanderbilt University. Prior to coming to WKU, Minton served as principal of Trigg County High School from 1953 to 1958. He became Associate Dean of Graduate Instruction in 1962, then Graduate Dean, and Administrative Vice-President in 1970. Minton served as Vice President of Student Affairs from 1979 until his retirement in 1986.

This university, as those who are here today know believes in tradition and in symbolism. I think the symbolic significance of a formal oath of office administered by a Western graduate and longtime friend and supporter of the university is in itself a good beginning for Dr. Minton, for you in this important position of interim president. Mr. Cole I'd like to congratulate you and other members of the Board of Regents for having chosen Dr. Minton and placing him in this position. I think you certainly have used excellent judgment in that regard and he unquestionably prove deserving of the confidence which you have placed in him. I want to express my personal thanks for the many ways in which those of you here and others throughout the university, across this community, across the Commonwealth of Kentucky have extended encouragement and support to the Downing family and through the years have given us the opportunity to serve this university.</i></p> <p><i>I called Dr. Minton at a fairly early hour this morning and told him that I wanted to be at least among the first to call to express the hope that as he sat in that chair that this first day would be pleasant, productive and the days in the future would be the same. I was calling from 2482 in the Alumni Center and that's where I'll be spending some time at least in the coming weeks and months and I will not in any way impose upon him or upon others in the university by being around other that times you may suggest that I might rendered some meaningful service. And I invited him to suggest ways that I might give support to his endeavors.</i></p> <p><i>I want to mention one other thing and that is that without exception every person in this university who has commented in any way on the appointment of Dr. Minton to this position has done so in a commendable, complimentary, positive, supportive way. That has been true all across the state as I have gone various places to alumni meetings and either in social gatherings or professional meetings there has been nothing Dr. Minton except positive support from every source. And I could hardly imagine how it could but as I look over this group and on this staff and as I look through this faculty and staff that situation is true today. The only other group that I probably did not specifically mention at that time was the friends of mine, special friends of mine that are here this morning. And so I want to express my appreciation to all of you, first as friends, then in the other categories that I have mentioned because I have worked and been with you in all of those areas. All of you know me well enough to know I hope that I'm just John Minton and that's the way I'm going to be until the Board selects a successor, a permanent president. I intend to be president while I'm in here and I intend to make whatever decisions are necessary to be made. It is with much humility and with a grateful heart and the solicitation of your support and your prayers that I engage in this undertaking. This university's been good to me and to my family. Two of them are here. One is out at Oklahoma State in the graduate work. For those of you that don't, haven't met my wife this is my first lady for several years.</i></p>

That's been the history of this university that the heart of the matter is the student. And a student that comes here as a student and leaves here as a citizen and the type of citizen that they've left here as is demonstrated by many of the people that are here this morning. And I think even though we could come to the second part of it I certainly being a faculty member and a professor of history cannot detract from the importance of the scholarly professors and teachers that we have.</i>
