BIOGRAPHICAL NOTE

Charles T. Crume, Jr. was born on 13 September 1933 in Bardstown, Kentucky. He received his Bachelor's degree in recreation from Western Kentucky University in 1971 and his doctorate in education curriculum and instruction from the University of Kentucky. He served (1952-1956) as a flight engineer in the Air Force during the Korean War. Crume was a faculty member from 1969 to 1995 at Western Kentucky University (WKU), where he taught physical education and recreation classes. Prior to his service at WKU, he was the chief naturalist at Bernheim Forest, a privately owned nature preserve in Bullitt County. He wrote a book on hunting ethics titled *Teaching Hunter Responsibility*, and taught numerous hunter education workshops. He was awarded the Kentucky Sportsmen's Outstanding Hunter Safety Education Instructor in 1980.

Crume was also an outstanding artist and produced a significant number of limited edition wildlife prints from the 1960s through the 1990s. He is also credited as designing the WKU Athletics' logo which features a hand holding a red towel.

Crume married Barbara J. Dunn and was a member of the Baptist Church. He died on 29 April 1996 in Louisville and was interred in the Bardstown Cemetery.

COLLECTION NOTE

This collection consists of materials related to various aspects of Bullitt County, Kentucky history collected by Charles T. Crume, Jr. In addition, notebooks kept by David W. Crume concerning drugs, chemical compounds, and jewelry and watch repairs are included. Of special interest are several detailed drawings by D.W. Crume of a timepiece. Also included are lists of Nelson County, Kentucky World War I veterans and some personal correspondence and items relating to Charles T. Crume, Sr., particularly a large number of daybooks that chronicle his daily activities and spending. Slides of Kentucky author, Jesse Hilton Stuart, and slides depicting the making of sorghum molasses are included in the collection.
