## **COLLECTION NOTE**

This collection contains two account books for general stores in Edmonson County, Kentucky. The account book in Folder 2 was kept by the H. E. James & Company store at Johnson's Mill in Edmonson County, chiefly for 1886. James' partners were James P. Read and G. W. Long. Other entries notate locations at Raymer in 1886 and Brownsville from 1891-1894. There is a treasurer's report for 1920-1921, possibly for a church, on pages 134 to 137. Folder 3 contains an account book for S. T. Brooks, a dealer in drugs and groceries located in Brownsville, Kentucky, 1886-1922. A treasurer's account for cash receipts received for a minister, Bro. Page, can be found on pages 190-198. The loose items in Folder 4 include a holographic receipt for cash donated for a pastor's salary at "the Brownsville Church" and a printed receipt from the S. T. Brooks establishment. Both of these items were removed from the S. T. Brooks account book.
