

### A MAN AND HIS WORK

William Leon Davis, a native of Christian County, Kentucky, is the oldest of nine children and a son of a sharecropper and Highway Department worker. Mr. Davis' artistic and sensitive nature led him to the photographic profession after moving to southern California in 1969 and returning to Kentucky in 1979. Mr. Davis expresses his love and appreciation for Kentucky's unique landscapes, people and architecture by sharing his experiences with others.

A small, but beautiful part of his work involves teaching photographic workshops and conducting field trips. Much of Mr. Davis' work is used in decorating restaurants, offices and homes. His photography has also been exhibited in museums, art galleries, libraries, banks and art shows.

### JULY LANDMARK MEETING\_\_\_\_

Landmark members and their guests are invited to attend the July Landmark Meeting to be held at the Bowling Green Public Library on Wednesday, July 27, 1983.

Mr. Joe DeSpain, Executive Director of the Commonwealth Preservation Council, will explain the activities of Kentucky's only state-wide historic preservation organization. During this program, the Commonwealth Preservation Council's recently completed media presentation will be shown. This presentation will be used throughout the state and highlights historic preservation efforts in Kentucky, including activities of the Landmark Association.

Following the program, a tour will be given of the newly rehabilitated McIntire Building, 1025 State Street. Owned by Mr. Joe Bill Campbell, this structure was built circa 1910 by George McIntire and is a fine example of early 19th century commercial architecture. This building was adapted for reuse by the law firm of Campbell, Smith and Kerrick.

## REHABILITATION WORKSHOP

A workshop concerning rehabilitation and repair of older homes will be held in Louisville on Saturday, July 23, 1983. Sponsored by the Lousiville Historic League and the Historical Confederation of Kentucky, this day-long workshop will be conducted at the Old Louisville Medical School, First and Chestnut Streets.

Discussions featured during the day include Permits and Regulations, How to Get the Most Out of Your Architect or Contractor, Exterior Structural Problems, Mechanical Systems, Interiors, External Structures and Landscaping.

### DOWNTOWN REHABILITATION\_

Revitalization in the Downtown Commercial Historic District is continuing with the recently completed rehabilitation of the McIntire Building, while revitalization is underway for the Gerard Hotel.

Mr. Joe Bill Campbell, owner of the McIntire Building, recently moved his law firm into the structure at 1025 State Street. Built circa 1910, this building originally housed a harness shop and hardware store.

Mr. and Mrs. Jim Kennedy have begun rehabilitation of the Gerard Hotel, 423 Park Row. Built circa 1870 by John C. Gerard, this building served as a hotel and housed commercial establishments on the first floor. This structure is currently the location of the Commonwealth of Kentucky Division of Licensing.
