## Chief Resident Education for Success Training

---

The Chief Resident Education for Success Training (CREST) program was held on June 6 and 7, 2002, at the Marriott Hotel in Philadelphia. Over 100 incoming chief residents from across the Delaware Valley attended the program, which was sponsored by the Office of Health Policy and Clinical Outcomes.

CREST is a series of programs designed to provide chief residents with the skills needed to become successful managers, leaders, educators, and health care providers. Session I, aimed at newly appointed chief residents, addresses topics such as time management, conflict management, clinical teaching, managing professionals, and other areas of leadership skills. The second session, held towards the end of the residency program, covers timely practical issues related to the individual physician's personal development and transition to the workforce.
