
2 million downloads

On September 14, 2014 the <u>Jefferson Digital Commons reached 2 million downloads</u>. To date the JDC contains 9,186 assets and has 2,013,794 full-text downloads. Thanks to the Jefferson community for helping to reach this milestone and we'll see you at 3 million downloads.




Historical Materials
