NURSES' RELIEF FUND

Computer Education: Teaching Students The New Way

There is an increasing awareness among health professionals of the inevitability of a partnership between nurses and computers within the patient care setting. Nurses are being called on to use computers for such widely varied areas as administration of patient care, quality assurance, staffing, evaluating the impact of nursing care, patient data recording, hospital administrative record keeping and automated patient monitoring. This is happening in hospitals, community health agencies, doctor's offices and all types of health care settings. Nurses have used data processing to develop nursing care plans, make patients' records more complete, decrease medication errors, free nursing time for increased patient care, and to increase job satisfaction.

One of the most exciting opportunities that computers offer nursing is the change to fully document nursing practice. Computer technology, with its ability to track huge amounts of data quickly and efficiently, supports the development of more comprehensive, permanent records of all aspects of the nursing process. Nurses in several institutions such as the National Institutes of Health in Bethesda, Maryland, have demonstrated that computer systems can be used not only to document the administrative tasks that nurses perform for others, but that computer systems can be designed to document total patient care. Systems which document nursing practice are termed Nursing Information Systems, in contrast to those which document the activities of other areas such as admissions, pharmacy, laboratories or medicine.

A high degree of nursing involvement in the development of a total Hospital Information System from the start will help to insure that a useful Nursing Information System becomes a part of any overall Hospital Information System. For example, nurses at NIH were highly involved in the early design of the total computer system. They developed several thousand light pen controlled computer screens that allowed the primary nurse to quickly record an in-depth assessment of each patient's needs, based on Maslow's Hierarchy of Needs. The nurses are then able to create an individualized care plan choosing nursing diagnoses, problems, and nursing actions. Expected outcomes are documented with checkpoints and carefully delineated time frames. The resulting permanent records, in conjunction with similar records from other disciplines, provide excellent data bases for research into nursing care. Thousands of bits of data are available to researchers who are studying such patient care related issues as, the actual use of nursing diagnoses in practice or the relationship of nursing care to cost factors and diagnostic related groups.

Although it is easy to see that nurses must be highly involved in the development and use of nursing documentation systems, nurses are also a key factor in the success or failure of any patient data management system within health care settings, whether it be a lab, pharmacy, admissions, billing or medical order system. Nurses have the longest sustained contact with the patient of any health personnel. Because of their long contact time with patient care technology, nurses

are frequently called on to interface between this technology and other health team members such as physicians, medical students and nursing students who may have only short periods of exposure.

Although nurses are at the hub of the information flow of all of these systems, they are just beginning to understand and effectively use computers in health care. Nurses as a whole have not, to this point, become highly active in searching for ways to harness the power of the computer. There are several possible reasons for this lack of initiative: lack of sufficient background in computer technology and systems; fear of the unknown, particularly related to such issues as security of data, confidentiality of data, and depersonalization of patient care; or possibly exposure to poorly designed systems which have hampered nursing care rather than enhancing it.

The faculty of the Department of Nursing of Thomas Jefferson University realizes that computer technology will have a major impact on nursing in the future and that nurses must be prepared to guide and control this impact. In an attempt to dispel the mystery that surrounds computers the faculty has made a commitment to the education of nurses who will be able to:

- Define the role of nursing, and their own specific role, in relationship to computer technology.
- 2. More quickly adapt to new computer technology.
- 3. Creatively seek ways to adapt electronic data processing for use in meeting patient care needs.
- Actively participate with other health care professionals and computer specialists to insure maximum utilization of computers for nursing.
- Provide role models for other nurses and other health care professionals.
- Generate more complete data bases for future nursing research on patient care.

In order to accomplish these goals, computer technology is being integrated into the curriculum through two methods, instruction about computers and instruction with computers.

Instruction about computers is being given to students and faculty as a means of developing "computer literate" nurses. Courses and programs are being developed to help all students become familiar with the basic concepts of computerized information processing; to understand and be able to use basic hardware and software; and to develop a clear understanding of the major applications of computers in all areas of nursing.

A pilot course, "Computers in Nursing," was developed in the spring of 1984 and was offered as a nursing elective to twenty-five nursing students. By 1985-86 all nursing students will be required to enter the nursing program with a lower division data processing course and will take "Computers in Nursing" as a required upper division course. In this course students study the ways in which computers are used to

enhance nursing care of patients, nursing administration, nursing research and nursing education as well as the relationships of Nursing Information Systems to all other parts of Hospital Information Systems. Issues of concern to nursing such as confidentiality of data, legality of data and possible depersonalization of care are studied and discussed. Students also have the opportunity to work at several computer terminals and to view demonstrations of special health care computing projects. Microcomputer facilities in the Department's new Learning Resource Center are utilized for hands-on experience, as well as computers in other departments on campus. The Department of Nursing of Thomas Jefferson University is one of only a very few programs in the country to offer this type of course to its students.

In the very near future students and faculty will also become more familiar with computers through the use of computer assisted instruction. It is hoped through this exposure that computers will be seen as an intellectual tool with great potential for a wide variety of situations. Computer simulations of clinical situations are currently being used with a limited number of students to allow them to make clinical decisions in a risk-free environment. Faculty members are then able to review the students decision making process. In the future these simulations will allow students to make decisions in a wide variety of areas such as ethical and management situations and to study the results of these decisions.

Tutorial programs and drill-and-practice programs will be available for individual study and remedial work in areas such as basic sciences and mathematics or for preparation for challenge examinations. The interaction of computers with videotapes and videodisc is being explored. This will provide exciting opportunities for students to view and interact with demonstrations of communication skills. Students will also utilize the computer in many clinical courses for a variety of projects. For example, students might choose to carry out an epidemiological study while in a community health experience, to do statistical projects for the nursing research course, or to use the computer to study and plan staffing patterns in leadership courses.

Clearly nursing education at Thomas Jefferson University is not only changing with the times. It is also assuming a leadership role, providing innovative education for today's world.

Life of service

In South Phila. or a Thai camp, a woman helps those in need

Early in the Thai morning, before the sun's rays beat with fierce intensity on the rows of refugee huts in the camp at Khao I Dang, Roseanne Murphy of Bala Cynwyd would stealthily enter a hut that was like any other—except that it had been transformed into a black-market coffee shop.

There, she would sleepily sip freshly brewed French roasted coffee and munch on a baguette fresh from the tin-can-overwood oven. Flour had been smuggled into camp the night before. Then she would set about the day's tasks: teaching public health, supervising the Khmer community-health program and immunizing children. There were 14,000 of them among the 48,000 refugees who lived behind barbed wire and under the supervision of armed Thai guards.

To an ascetic, it might seem that Ms. Murphy, 43, was pampering herself. But Mrs. Murphy, is not an ascetic. She is a 43-year-old divorced mother who spent years studying to be a nurse practitioner and who is raising an 18-year-old son, now in college.

"Because I'm working with refugees doesn't mean that I live like a refugee. I'm *not* a refugee," Ms. Murphy said a few weeks ago after her six-month tour of duty in Thailand had ended.

Still, it was not as if she had served her six months there for mercenary reasons. The volunteer salary she received as a pediatric nurse practitioner barely covered transportation, some pocket money and lodgings 20 miles away in a Thai house on stilts.

Ms. Murphy does not have a ready answer for why she went. Introspection makes her uncomfortable. "I got a lot out of this, but that's too corny," she said.

To her, there was nothing unusual about leaving home to travel halfway around the world. It does not matter whether children are sick in South Philadelphia or on the border between Cambodia and Thailand: If they are disadvantaged, she wants to help them.

On that day a few weeks ago, Ms. Murphy sat in her temporary South Philadelphia apartment above a vacant medical office dragging deeply on a cigarette. When she left for Thailand in February, she rented out her Bala Cynwyd house.

Since Ms. Murphy's return to the United States, her 5-foot-4 frame has returned to its customary 108 pounds. In Thailand, her weight reached the mid-90s thanks to parasites in the local water. "You die for ice. I'd eat ice with poison in it," she said.

Ms. Murphy thinks her medical career probably began when she was operated on at age 15. She woke up from the anesthesia, promptly disconnected herself from the various tubes, and tried to get out of bed. She then was placed in a private room with restraining straps; her mother and aunt kept continual watch. That did not keep her from biting a nurse.

Ms. Murphy found this perfectly reasonable at the time. "They kept coming in and inflicting pain on me. Where I'm from, if people hurt you, you hurt them back.

Despite the storminess of her stay there, she was fascinated with hospitals, and she began working at one after classes at the John W. Hallahan High School for Girls in Philadelphia. On Saturdays, she worked for a pathologist.

She got her registered-nurse degree at Thomas Jefferson University Hospital in 1961, worked at Children's Hospital of Philadelphia for several years, earned a bachelor's degree in psychology from LeMoyne College in Syracuse, N.Y., in 1974, and became a pediatric nurse practitioner in 1976.

Why pediatrics? "Ego stuff," she quipped. "I grew up in an area where everyone had seven kids. I baby-sat a lot because kids used to follow me around."

For all her airy replies, however, Ms. Murphy has never been one to shirk good deeds. She began the pediatric clinic at Casa del Carmen, a North Philadelphia health center sponsored by Catholic Social Service and a grant from the William Penn Foundation.

Basically, she ran the center, helped by phone consultations with Philadelphia pediatrician Mark Sey. She set up a filing system, bought a van, hired the driver and hired Hispanic social workers. Her Audi Fox was vandalized in that neighborhood, but she wholeheartedly said, "I loved the people there!"

When the financing ran out, however, so did Ms. Murphy's position. In 1979, she went to the Southeast Health Center, a federally financed health center for low income people at Ninth and South Streets in Philadelphia.

There, she worked with medical assistant Maria Elsie Delgado, 30. "She likes to jump to conclusions right away and speak her mind." Ms. Delgado who works at Booth Maternity Center, said in a telephone interview. "She'd say things, and get into trouble. I'd always try to calm her down.

"She didn't like it when the administration was pushing for more patients, like it was an assembly line. She said 'No way!' She'd spend as much time as she needed with each patient.

"She was very much into the patients, especially the adolescent mothers. They weren't sick—they'd use any excuse just to hang around and talk with her. They'd sit there with their babies in their laps and their thumbs in their own mouths."

One Christmas, Ms. Murphy wanted to get some toys for her patients. She collected \$1,000 from friends and went with Ms. Delgado to Kiddie City, returning with enormous bundles.

Another time, she got some old, unclothed, dirty dolls from her two nieces. She and Ms. Delgado bathed the dolls, combed their hair, dressed them and gave them to her patients.

Again, government money ran out and in 1982 Ms. Murphy began working at the Southern Home for children in South Philadelphia, a privately run center for emotionally disturbed children

"I loved those kids," Ms. Murphy said. "Those kids are surviving, God knows how."

That position also lasted only a few months. "You can get so frustrated with the [medical assistance] system," Ms. Delgado said. "If you want to start movement, get Roseanne. She's always rocking the boat."

An so it was that when she left Southern Home, Roseanne Murphy applied to 31 organizations that did health-care work overseas, received 12 replies and picked the one that promised quickest action: the International Rescue Committee (IRC), an organization founded to get refugees out of Nazi Germany.

Now, the volunteer network functions worldwide in two areas: resettling in the United States, Canada and France refugees who have fled tyranny in some part of the world; and helping refugees. Among its projects, according to Louis Wiesner, administrator of the IRC medical-programs division in Washington are:

- Assisting some of the 350,000 Ethiopian refugees in eastern Sudan and the 700,000 Ethiopian refugees in Somalia.
- Helping 120,000 of the 2.9 million Afghan refugees in Pakistan.
- Working with Palestinians in Sidon, Lebanon.
- Working with some of the 40,000 Guatemalan highland Indian refugees.
- Helping 48,000 Cambodian refugees in the Khao I Dang camp in Thailand. In Thailand, there are about 140,000 legally recognized Indochinese refugees — including 50,000 Cambodians — and 200,000 Cambodians on the border between the two countries.

In the Khao I Dang camp, the IRC, one of 20 volunteer agencies active there, is responsible for all public health, preventive medicine, a Khmer health-training center, two clinics, sanitation and a 14,000-student school system. Its camp staff includes two doctors, seven nurses and nurse-practitioners, an epidemiologist, a health educator and a sanitarian, plus 750 Cambodian health workers. In addition, it operates an indoor and outdoor theater, teaches classical ballet, music and sewing and operates a library.

At Khao I Dang, Ms. Murphy supervised community health workers, night-section workers, who were taught to administer rudimentary first aid, and school health workers. Every day, she rode 20 miles to the camp for a shift that lasted 12 hours.

The memories remain.

Back in South Philadelphia, as she spread photos over her kitchen table, she pointed out blossoms bright against the walls of the outpatient department, a long bamboo shed with a mud floor and a straw roof.

Out of all the children she saw, there was one baby that never smiled at her. After months of grim stares from the child, Ms. Murphy bribed her with a doll from Bangkok. Finally, the baby smiled, she said, the way the children had smiled in South Philadelphia.

In the work in Thailand there was an intensity that Ms. Murphy does not want to glorify and often can not describe. Life for the refugees came down to survival and resiliency.

In the camp, she said, it was difficult for her to stifle her emotions and do things the Eastern way. "They should never show anger; they should save face," she said.

At times when her temper flared, Mrs. Murphy would beckon the Cambodian administrator, Han Hok, into a nearby truck and with that modicum of privacy, scream about the current crisis.

"Mr. Hok would say 'No problem,'" she said. "I'm so compulsive, I always thought there was a problem about everything."

She sometimes sought diversion from the problems.

She started a movie club for other camp volunteers, obtaining the films through the IRC. She made up flyers, sold beer, provided free popcorn. She began a cocktail hour, and had parties at her house on stilts, wearing a slinky black silk outfit with a flower tucked behind one ear.

Ms. Murphy is the first to acknowledge that she likes to be surrounded with beautiful things. Back in the United States.

she buys her clothes at Bendel's and Bergdorf's in New York. "I think left, and I live right, and I don't feel defensive about it." she said with a grin.

But she finds it hard to talk about the pain and despair of the nation she has just left. "The stories are too gross, too tragic," she said.

"There are many people with many plights; I've left 100,000 of them."

Last week, Ms.Murphy rocked the boat once more. She

decided to go back to Thailand on Jan. 20 for another tour of duty.

Editor's Note: Roseanne Murphy graduated in 1960 from the School of Nursing, Diploma Program. After Roseanne returned from her second tour of duty in Thailand, she has been doing part-time private duty nursing at Jefferson to "keep in touch with nursing." In September 1984 she began to do a tour of duty in Lebanon with the International Rescue Committee.

DO YOU REMEMBER?


Miss Anna Shafer, night supervisor of nursing at Jefferson for thirty four years, died on December 15, 1956 after a short illness. Miss Shafer was born in Phillipsburg, NJ on November 3, 1873. She entered the School of Nursing April 1, 1907 and graduated December 20, 1910. She is best remembered for many long years of devoted service on night duty which began in 1912. She did private duty for 1 year and 4 months prior to starting night duty. On December 31, 1918, she resigned from night duty and worked in Dr. Carrington's office for 3 years, returning to night duty January 1, 1922. Retired from nursing May 1, 1949, completing 34 years.

During her long night duty career she learned to know 2411 graduates, knew that 1422 got married and that 264 married doctors.

Those of use who remember Miss Shafer will never forget the roll-call at breakfast each morning and how we anxiously awaited the morning when Miss Shafer would tell us of our new assignment.





The History of the Jefferson Cap

Jefferson graduated its first class of nurses in 1893. At that time the cap that was worn had a high crown and a wide brim with ruffle around the brim. It was made of a delicate material called "lawn", similar to material used to make handkerchiefs. The cap resembled the Philadelphia General Cap, which at that time was made of a similar material.


In 1894, Susan Hearle, a graduate of Philadelphia General became Directress of Nurses at Jefferson. When she noticed the similarity between caps, Miss Hearle decided that Jefferson Nurses should have their own distinctive cap.

The crown was lowered, the ruffle was removed and the brim was narrowed, flattened and spread like wing tips, across the front of the cap. The material was changed to organdy which gave the cap more body.

In 1932, the cap was worn with the brim starched and the wings made to stand out—that is the way we wear it today.

Initially, it was traditional to earn the cap by passing the six month probationary period. Now the cap is given to the student to wear as soon as she enters the school.

This was a great responsibility for the student, knowing that the Nurse's Cap originated historically from the veil worn by women who traditionally covered their heads in public, and the cap is a symbol of humility and service to mankind. A responsibility because the Jefferson Cap is recognized and respected the world over, being worn by more than 4500



graduates of the school; many of whom earned their cap and consider it an honor to wear it. (With the closing of the School of Nursing in June of 1982—the total number of graduates will be 5,078).

The student is entrusted with the cap and must wear it with dignity and respect for the tradition that is to be upheld. (The above article was presented at Capping Exercises for the Class of 1982, by Patricia Zarella '51, R.N., B.S.N., Instructor School of Nursing, September 1958 to July 1980).




