# Dirichlet means, Thorin measures, with explicit examples

#### Abstract

- In Section 1, we present a number of classical results concerning the Generalized Gamma Convolution (: GGC) variables, their Wiener-Gamma representations, and relation with the Dirichlet processes. - To a GGC variable, one may associate a unique Thorin measure. Let $G$ a positive r.v. and $\Gamma_{t}(G)\left(\right.$ resp. $\left.\Gamma_{t}(1 / G)\right)$ the Generalized Gamma Convolution with Thorin measure $t$-times the law of $G$ (resp. the law of $1 / G$ ). In Section 2, we compare the laws of $\Gamma_{t}(G)$ and $\Gamma_{t}(1 / G)$. - In Section 3, we present some old and some new examples of GGC variables, among which the lengths of excursions of Bessel processes straddling an independent exponential time.


Key words Laplace transform, Generalized Gamma Convolutions (GGC), Wiener Gamma representation, Stieltjes transform, Dirichlet processes.

## 1 Introduction.

Most results presented in this Introduction are classical. They are discussed here in detail in the hope that it may facilitate further reading of this survey for researchers in probability with different backgrounds.

## A writing convention.

1. Each time we write an equality in law between r.v.'s and that on one or the other side of this equality, several r.v.'s occur, we always assume that these r.v.'s are independent, without mentioning it systematically.
2. It will be convenient, in some instances, to speak of a r.v. instead of its law and vice versa. We hope that no confusion will ensue.

### 1.1 The Gamma process.

All through this paper, the reference process is the standard Gamma process $\left(\gamma_{t}, t \geq 0\right)$, which is a subordinator without drift, and with Lévy measure $\frac{d x}{x} e^{-x}(x>0)$. Thus, its Lévy-Khintchine representation writes (see [Ber1]) :

$$
\begin{align*}
E\left[e^{-\lambda \gamma_{t}}\right] & =\exp \left\{-t \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} e^{-x}\right\} \quad(\lambda, t \geq 0)  \tag{1.1}\\
& =\exp \{-t \log (1+\lambda)\}=\frac{1}{(1+\lambda)^{t}} \tag{1.2}
\end{align*}
$$

where formula (1.2) is obtained from (1.1) and from the elementary Frullani formula (see [Leb], p. 6) :

$$
\begin{equation*}
\int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} \int_{0}^{\infty} e^{-x z} \nu(d z)=\int_{0}^{\infty} \log \left(1+\frac{\lambda}{z}\right) \nu(d z) \tag{1.3}
\end{equation*}
$$

where, in general, $\nu$ denotes a positive measure on $\mathbb{R}_{+}$, which is $\sigma$-finite. Here, $\nu(d z)=$ $\delta_{1}(d z)$ is the Dirac measure at 1 , but formula (1.3) shall be useful in the sequel.
For each $t>0$ fixed, $\gamma_{t}$ follows a gamma law with parameter $t$ :

$$
\begin{equation*}
P\left(\gamma_{t} \in d a\right)=\frac{e^{-a}}{\Gamma(t)} a^{t-1} d a \quad(a \geq 0) \tag{1.4}
\end{equation*}
$$

This process $\left(\gamma_{t}, t \geq 0\right)$ enjoys a large number of remarkable properties which make it a "worthy companion" of Brownian motion. In particular, Emery and Yor [EY] establish a parallel between Brownian motion and its bridges on one hand, and the Gamma process and its bridges on the other hand. See also Vershik, Yor and Tsilevich([VYT]) and Yor $[\mathrm{Y}]$ for a survey of many properties of the gamma process.

### 1.2 Wiener-Gamma integrals and GGC variables.

1.2.a Many times throughout this work, we shall use properties of the integrals :

$$
\begin{equation*}
\widetilde{\Gamma}(h):=\int_{0}^{\infty} h(s) d \gamma_{s} \tag{1.5}
\end{equation*}
$$

where $h: \mathbb{R}_{+} \longrightarrow \mathbb{R}_{+}$is a Borel function such that:

$$
\begin{equation*}
\int_{0}^{\infty} \log (1+h(u)) d u<\infty \tag{1.6}
\end{equation*}
$$

Under this hypothesis (1.6), $\widetilde{\Gamma}(h)$ is finite a.s. (see Proposition 1.1 below). We call $\widetilde{\Gamma}(h)$ a Wiener-Gamma integral, in analogy with the Wiener integrals $\int_{0}^{\infty} f(u) d B_{u}, f \in$ $L^{2}\left(\mathbb{R}_{+}, d u\right)$ which constitute the Gaussian space generated by Brownian motion ( $\left.B_{u}, u \geq 0\right)$.
1.2.b We say, (following [B1], p. 29), that a positive r.v. $\Gamma$ is a generalized gamma convolution (GGC) - without translation term - if there exists a positive Radon measure $\mu$ on $] 0, \infty[$ such that :

$$
\begin{align*}
E\left[e^{-\lambda \Gamma}\right]= & \exp \left\{-\int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} \int_{0}^{\infty} e^{-x z} \mu(d z)\right\}  \tag{1.7}\\
= & \exp \left\{-\int_{0}^{\infty} \log \left(1+\frac{\lambda}{z}\right) \mu(d z)\right\}  \tag{1.8}\\
\text { with : } & \int_{[0,1]}|\log x| \mu(d x)<\infty \text { and } \int_{[1, \infty[ } \frac{\mu(d x)}{x}<\infty \tag{1.9}
\end{align*}
$$

The measure $\mu$ is called Thorin's measure associated with $\Gamma$. Thus, from the LévyKhintchine formula, a GGC r.v. is infinitely divisible. In fact, since its Lévy density $l_{\Gamma}(x)=\frac{1}{x} \int_{0}^{\infty} e^{-x z} \mu(d z)$ satisfies : $x \longrightarrow x l(x)$ is decreasing, then $\Gamma$ is a self decomposable r.v. (see, e.g. [Luk]). Such a self-decomposable r.v. $\Gamma$, assumed to be non degenerate, admits a density $f_{\Gamma}$ such that $f_{\Gamma}(x)>0$ for every $x>0$ (see [Sat, p.404]). The study of GGC variables was initiated by O. Thorin in a series of papers (see for instance [Thor]).

The following proposition is classical. The reader may refer to Lijoi and Regazzini [LR].
1.2.c GGC variables and Wiener-Gamma representations.

Proposition 1.1 The class of positive GGC variables coincides with the class of WienerGamma integrals. More precisely :

1. If $\widetilde{\Gamma}(h)=\int_{0}^{\infty} h(u) d \gamma_{u}$, then:

$$
\begin{equation*}
E\left(e^{-\lambda \widetilde{\Gamma}(h)}\right)=\exp \left\{-\int_{0}^{\infty} \log \left(1+\frac{\lambda}{x}\right) \mu_{h}(d x)\right\} \tag{1.10}
\end{equation*}
$$

where $\mu_{h}$ denotes the image of Lebesgue's measure on $\mathbb{R}_{+}$under the application :
$s \longrightarrow \frac{1}{h(s)}$. In other terms :

$$
\begin{equation*}
\int_{0}^{\infty} e^{-\frac{x}{h(s)}} d s=\int_{0}^{\infty} e^{-x z} \mu_{h}(d z) \quad(x>0) \tag{1.11}
\end{equation*}
$$

We note that, in (1.11), $h$ may vanish on some measurable set.
2. Let $\Gamma$ denote a GGC r.v. with Thorin measure $\mu$. Let $F_{\mu}(x):=\int_{[0, x]} \mu(d y) \quad(x \geq 0)$ and denote by $F_{\mu}^{-1}$ its right continuous inverse, in the sense of the composition of functions. Then :

$$
\begin{equation*}
\Gamma \stackrel{(l a w)}{=} \widetilde{\Gamma}(h), \text { with } h(u)=\frac{1}{F_{\mu}^{-1}(u)} \tag{1.12}
\end{equation*}
$$

Proof of Proposition 1.1 Let $\widetilde{\Gamma}(h):=\int_{0}^{\infty} h(u) d \gamma_{u}$. It is easily obtained, by approximation of $\widetilde{\Gamma}_{h}$ by Riemann sums, using also the fact that the Lévy measure of the process $\left(\gamma_{t}, t \geq 0\right)$ equals $\frac{d x}{x} e^{-x}$, that :

$$
\begin{align*}
E\left(e^{-\lambda \widetilde{\Gamma}(h)}\right) & =\exp \left\{-\int_{0}^{\infty} d u \int_{0}^{\infty}\left(1-e^{-\lambda x h(u)}\right) \frac{d x}{x} e^{-x}\right\} \\
& =\exp \left\{-\int_{0}^{\infty}\left(1-e^{-\lambda y}\right) \frac{d y}{y} \int_{0}^{\infty} e^{-\frac{y}{h(u)}} d u\right\} \tag{1.13}
\end{align*}
$$

after making the change of variable $x h(u)=y$. We observe, from (1.11) and (1.12), the equivalence of the conditions :

$$
\begin{aligned}
\int_{0}^{\infty} \log (1 & +h(u)) d u<\infty \Leftrightarrow \int \log \left(1+\frac{1}{x}\right) \mu_{h}(d x)<\infty \\
& \Leftrightarrow \int_{] 0,1]}|\log x| \mu_{h}(d x)<\infty \text { and } \int_{[1, \infty[ } \frac{\mu_{h}(d x)}{x}<\infty
\end{aligned}
$$

## Remark 1.2

1. Formula (1.13) may be obtained in a slightly different manner : the process $\left(\gamma_{s}-\gamma_{s^{-}}:=\right.$ $\left.e_{s}, s \geq 0\right)$ of jumps of the subordinator $\left(\gamma_{t}, t \geq 0\right)$ is a Poisson point process whose intensity measure $n$ equals the Lévy measure of $\left(\gamma_{t}, t \geq 0\right)$ (see [Ber1]) :

$$
\begin{equation*}
n(d x)=\frac{1}{x} e^{-x} d x \tag{1.14}
\end{equation*}
$$

Thus, from the exponential formula ([RY], p. 476) :

$$
E\left[\exp -\lambda \sum_{0<s \leq t} f\left(s, e_{s}\right)\right]=\exp \left\{-\int_{0}^{t} d s \int_{0}^{\infty}\left(1-e^{-\lambda f(s, u)}\right) n(d u)\right\}
$$

one gets :

$$
\begin{aligned}
E\left[\exp -\lambda \int_{0}^{\infty} h(s) d \gamma_{s}\right] & =E\left(\exp -\lambda \sum_{s>0} h(s)\left(\Delta \gamma_{s}\right)\right) \\
& =\exp \left\{-\int_{0}^{\infty} d s \int_{0}^{\infty}\left(1-e^{-\lambda h(s) u}\right) \frac{e^{-u}}{u} d u\right\}
\end{aligned}
$$

which agrees with the expression in (1.13).
2. Let $h, k: \mathbb{R}_{+} \longrightarrow \mathbb{R}_{+}$two Borel functions which satisfy (1.6) and assume that $\widetilde{\Gamma}(h) \stackrel{(\text { law })}{=} \widetilde{\Gamma}(k)$. Relation (1.13) and the uniqueness of the Lévy measure in the LévyKhintchine representation imply : the images by $h$ and $k$ of Lebesgue's measure on $\mathbb{R}_{+}$are identical. Thus, choosing for $k$ the increasing rearrangement $h^{*}$, (resp. : the decreasing rearrangement $h_{*}$ ) of $h$, we obtain that there exists essentially a unique increasing function $h^{*}$, (resp. a unique decreasing function $h_{*}$ ) such that:

$$
\begin{equation*}
\widetilde{\Gamma}(h) \stackrel{(l a w)}{=} \widetilde{\Gamma}\left(h^{*}\right)=\widetilde{\Gamma}\left(h_{*}\right) \tag{1.15}
\end{equation*}
$$

From Proposition 1.1, $\widetilde{\Gamma}(h)$ is a GGC r.v. and we shall denote by $\mu_{h}$ the Thorin measure associated with $\widetilde{\Gamma}(h)$.

## $1.3 m$-Wiener-Gamma integrals, $(m, G)$ GGC r.v.

In this work, we shall often consider a GGC r.v. whose associated Thorin measure has finite total mass. Thus, we shall now particularize Proposition 1.1 in this case.
1.3.a Let $m>0$ and $h:[0, m] \rightarrow \mathbb{R}_{+}$a Borel function such that:

$$
\begin{equation*}
\int_{0}^{m} \log (1+h(u)) d u<\infty \tag{1.16}
\end{equation*}
$$

We call $m$-Wiener integral of $h$ the r.v. :

$$
\begin{equation*}
\widetilde{\Gamma}_{m}(h):=\int_{0}^{m} h(u) d \gamma_{u} \tag{1.17}
\end{equation*}
$$

Since $\left(\gamma_{u}, 0 \leq u \leq m\right)$ and $\left(\gamma_{m}-\gamma_{(m-u)-}, 0 \leq u \leq m\right)$ have the same law, we deduce from (1.17), after making the change of variable $m-u=v$ :

$$
\begin{equation*}
\widetilde{\Gamma}_{m}(h) \stackrel{(l a w)}{=} \int_{0}^{m} h(u) d \gamma_{u} \stackrel{(l a w)}{=} \int_{0}^{m} h(m-u) d \gamma_{u} \tag{1.18}
\end{equation*}
$$

We note, in relation with (1.15) above, that if $h$ is increasing, resp. decreasing, then $u \rightarrow h(m-u)$ is decreasing, resp. increasing.
1.3.b Let $m>0$ and $G$ be a positive r.v. such that:

$$
\begin{equation*}
E\left(\log ^{+}(1 / G)\right)<\infty \tag{1.19}
\end{equation*}
$$

We say that a positive r.v. $\Gamma$ is $(m, G)$ GGC if :

$$
\begin{equation*}
E\left(e^{-\lambda \Gamma}\right)=\exp \left\{-m \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-x G}\right)\right\} \tag{1.20}
\end{equation*}
$$

Of course, from (1.7), a $(m, G)$ GGC r.v. is a GGC r.v. whose Thorin measure $\mu$ equals :

$$
\begin{equation*}
\mu(d x)=m P_{G}(d x) \tag{1.21}
\end{equation*}
$$

where $P_{G}$ denotes the law of $G$ and we have :

$$
\begin{equation*}
\mu(] 0, \infty[)=m \tag{1.22}
\end{equation*}
$$

Under (1.21), it is clear that :

$$
\begin{gather*}
\int_{10,1]}|\log x| \mu(d x)<\infty \text { and } \int_{[1, \infty[ } \frac{\mu(d x)}{x}<\infty \\
\Leftrightarrow E\left(\log ^{+}(1 / G)\right)<\infty \tag{1.23}
\end{gather*}
$$

We denote $\Gamma_{m}(G)$ the (law of the) r.v. $\Gamma$ defined by (1.20). Hence :

$$
\begin{align*}
E\left[e^{-\lambda \Gamma_{m}(G)}\right] & =\exp \left\{-m \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-x G}\right)\right\}  \tag{1.24}\\
& =\exp \left\{-m E\left(\log \left(1+\frac{\lambda}{G}\right)\right)\right\} \tag{1.25}
\end{align*}
$$

1.3.c $G$ or $1 / G$ ? How to choose?

We have used the notation $\Gamma_{m}(G)$ due to the relation (1.24). Of course, the relation (1.25) invites, on the contrary, to adopt the notation $\Gamma_{m}(1 / G)$. However, we shall not adopt this latter notation as the notation $\Gamma_{m}(G)$ is used by L. Bondesson [B1] who has contributed in an essential manner to the study of the GGC variables.
1.3.d Proposition 1.1, when the Thorin measure has a finite total mass $m$, admits the following translation.
Proposition 1.3 A r.v. is a $(m, G) G G C$ if and only if it is a $m$-Wiener integral. More precisely :

1) If $\quad \Gamma_{m}(G) \stackrel{(\text { law })}{=} \widetilde{\Gamma}_{m}(h)$, then

$$
\begin{equation*}
h(u)=\frac{1}{F_{G}^{-1}(u / m)} \quad(u \in[0, m]) \tag{1.26}
\end{equation*}
$$

where $F_{G}^{-1}$ denotes the right continuous inverse, in the sense of composition of functions, of $F_{G}$, the cumulative distribution function of $G$.
2) If

$$
\Gamma_{m}(h) \stackrel{(l a w)}{=} \Gamma_{m}(G), \text { then }
$$

$$
\begin{equation*}
G \stackrel{(\text { law })}{=} \frac{1}{h\left(U_{m}\right)} \tag{1.27}
\end{equation*}
$$

where $U_{m}$ denotes a uniform r.v. on $[0, m]$.
1.3.e Some classical results

We gather here some results which are due to L. Bondesson [B1] and which we shall use in the sequel. Let $m>0$ and $G$ satisfy (1.19). Then, denoting $f_{\Gamma_{m}(G)}$ the density of $\Gamma_{m}(G)$ :

$$
\begin{equation*}
f_{\Gamma_{m}(G)}(x)=\frac{x^{m-1}}{\Gamma(m)} g(x) \quad(x>0) \tag{1.28}
\end{equation*}
$$

where $g$ is a completely monotone function ([B1], p. 49). Moreover ([B1], p. 50) gadmits a limit on the right of 0 and :

$$
\begin{equation*}
g\left(0_{+}\right)=\exp \{m E(\log G)\} \tag{1.29}
\end{equation*}
$$

We note that, since by hypothesis $E\left(\log ^{+}(1 / G)\right)<\infty, g\left(0_{+}\right)$is finite if and only if $E\left(\log ^{+}(G)\right)<\infty$. In Section 2 of this work (see Theorem 2.1) we give an explicit form of $g$ when $E(|\log G|)<\infty$.

- $m$ may be determined from the knowledge of $f_{\Gamma_{m}(G)}$ :

$$
\begin{equation*}
m=\sup \left\{\alpha \geq 0 ; \lim _{x \downarrow 0_{+}} \frac{f_{\Gamma_{m}(G)}(x)}{x^{\alpha-1}}=0\right\} \tag{1.30}
\end{equation*}
$$

(see [B1], p. 51).

## $1.4 m$-Wiener Gamma integrals, $m$ Dirichlet means, Gamma ( $m$ ) mixtures.

1.4.a The preceding discussion leads us to introduce, for every $m>0$, the Dirichlet process with parameter $m$, denoted : $\left(D_{u}^{(m)}, 0 \leq u \leq m\right)$ and defined as :

$$
\begin{equation*}
\left(D_{u}^{(m)}, 0 \leq u \leq m\right)=\left(\frac{\gamma_{u}}{\gamma_{m}}, 0 \leq u \leq m\right) \tag{1.31}
\end{equation*}
$$

The Dirichlet process may be traced back to at least D. Freedman ([Freed]) and was popularized in Bayesian nonparametric statistics by T. Ferguson([Ferg]).
It is well known, and it is an easy consequence of the properties of the "beta-gamma algebra" that this process $\left(D_{u}^{(m)}, 0 \leq u \leq m\right)$ is independent from the r.v. $\gamma_{m}$, hence from $\left(\gamma_{v}, v \geq m\right)$. This allows to write, for $h$ which satisfies (1.16) :

$$
\begin{equation*}
\int_{0}^{m} h(u) d \gamma_{u} \stackrel{(l a w)}{=} \gamma_{m} \cdot \int_{0}^{m} h(u) d_{u}\left(D_{u}^{(m)}\right) \tag{1.32}
\end{equation*}
$$

Thus, from Proposition 1.3, we may write for $G$ which satisfies (1.19) :

$$
\begin{equation*}
\Gamma_{m}(G) \stackrel{(l a w)}{=} \gamma_{m} \cdot D_{m}(G) \tag{1.33}
\end{equation*}
$$

with

$$
\begin{equation*}
D_{m}(G):=\int_{0}^{m} \frac{1}{F_{G}^{-1}(u / m)} d_{u}\left(D_{u}^{(m)}\right) \tag{1.34}
\end{equation*}
$$

It follows that for every $(m, G)$ GGC r.v., the r.v. $\Gamma_{m}(G)$ is a Gamma ( $m$ ) mixture, i.e. it may be written as :

$$
\begin{equation*}
\Gamma_{m}(G) \stackrel{(l a w)}{=} \gamma_{m} \cdot Z \tag{1.35}
\end{equation*}
$$

where $Z$ is a positive r.v.
1.4.b The relation (1.35) determines the law of $Z$. Indeed, let $Z$ and $Z^{\prime}$ two positive r.v. such that :

$$
\gamma_{m} \cdot Z \stackrel{(l a w)}{=} \gamma_{m} Z^{\prime}
$$

Then, for every $s \in \mathbb{R}$ :

$$
E\left[\gamma_{m}^{i s}\right] E\left[Z^{i s}\right]=E\left[\gamma_{m}^{i s}\right] E\left[Z^{\prime i s}\right]
$$

Hence :

$$
E\left(Z^{i s}\right)=E\left(Z^{\text {is }}\right) \quad \text { and } \quad Z \stackrel{(l a w)}{=} Z^{\prime}
$$

## 1.4.c Remark 1.4

(We shall not use the present Remark in the sequel of this paper). We come back to the notation of point 1 of Remark 1.2 and we denote : $\left(J_{1}^{(m)} \geq J_{2}^{(m)} \geq \cdots\right)$ the sequel of the lengths of jumps of the process $\left(\gamma_{u}, u \leq m\right)$ ranked in decreasing order. It is not difficult to see that since the intensity measure of the Poisson point process $\left(\left(s, e_{s}\right), s \geq 0\right)$ is $d s \frac{e^{-x}}{x} d x$, then the jump times $\left(U_{1}^{(m)}, U_{2}^{(m)}, \cdots\right)$ constitute a sequence of i.i.d r.v.'s with uniform law on $[0, m]$ which is independent from the sequence $\left(J_{k}^{(m)}, k \geq 1\right)$. Thus :

$$
\begin{align*}
\int_{0}^{m} h(u) d \gamma_{u} & \stackrel{(l a w)}{=} \int_{0}^{m} \frac{1}{F_{G}^{-1}(u / m)} d \gamma_{u} \quad(\text { from }(1.26)) \\
& =\sum_{k \geq 1} \frac{1}{F_{G}^{-1}\left(\frac{U_{k}^{(m)}}{m}\right)} J_{k}^{(m)}=\sum_{k \geq 1} J_{k}^{(m)} \frac{1}{G_{k}} \tag{1.36}
\end{align*}
$$

where $\left(\frac{1}{G_{k}}, k \geq 1\right)$ is the sequence of i.i.d r.v.'s with common law $1 / G$ and is independent (as a sequence) from the r.v.'s $\left(J_{k}^{(m)}, k \geq 1\right)$. Indeed :

$$
\begin{aligned}
P\left[\frac{1}{F_{G}^{-1}\left(\frac{U_{k}^{(m)}}{m}\right)} \leq x\right] & =P\left[F_{G}^{-1}\left(\frac{U_{k}^{(m)}}{m}\right) \geq \frac{1}{x}\right] \\
& =P\left[\frac{U_{k}^{(m)}}{m} \geq F_{G}\left(\frac{1}{x}\right)\right]=1-F_{G}\left(\frac{1}{x}\right) \\
& =P\left(\frac{1}{G} \leq x\right)
\end{aligned}
$$

since $\frac{U_{k}^{(m)}}{m}$ is uniform on $[0,1]$. We deduce from (1.36) that :

$$
\begin{equation*}
\int_{0}^{m} h(u) d_{u}\left(D_{u}^{(m)}\right)=\frac{1}{\gamma_{m}} \cdot \int_{0}^{m} h(u) d \gamma_{u}=\sum_{k \geq 1} \frac{J_{k}^{(m)}}{\gamma_{m}} \cdot \frac{1}{G_{k}} \tag{1.37}
\end{equation*}
$$

We note that : $\sum_{k \geq 1} \frac{J_{k}^{(m)}}{\gamma_{m}}=1$.
We then define the random Dirichlet measure $P_{0, m}^{(1 / G)}(d x)$ by the formula :

This relation (1.38) justifies the denomination, for $D_{m}(G)$, of a Dirichlet means.
The study of the Dirichlet means can be traced back to an early work of Cifarelli and Regazzini ([CR1])which culminates into the more recognized ([CR2]). Additional early works on this topic include ([HHL],[Yam],[FT], [DS])
1.4.d Multiplication by a beta variable.

In this section we discuss what happens when $D_{m}(G)$ is multiplied by certain independent beta random variables. This idea, and restatements of the results (1.4.d i-iii) below, first appear in James (see [J], Theorem 3.1).
1.4.d i) We denote by $\mathcal{D}^{(m)}$ the set of the laws of r.v.'s of the form

If $D_{m}(h) \in \mathcal{D}^{(m)}$ and if $\beta_{m, m^{\prime}-m}$, with $m^{\prime}>m$, is a beta r.v. with parameters $\left(m, m^{\prime}-m\right)$ then :

\beta_{m, m^{\prime}-m} \cdot D_{m}(h) \in \mathcal{D}^{\left(m^{\prime}\right)} \tag{1.39}
\end{equation*}
$$

Indeed, $\frac{\gamma_{m}}{\gamma_{m^{\prime}}}$ is independent from $\gamma_{m^{\prime}}$ and follows a beta law, with parameters $\left(m, m^{\prime}-m\right)$. Hence :

\begin{aligned}
\beta_{m, m^{\prime}-m} \cdot D_{m}(h) & \stackrel{(l a w)}{=} \frac{\gamma_{m}}{\gamma_{m^{\prime}}} \cdot \int_{0}^{m} h(u) d_{u}\left(D_{u}^{(m)}\right) \\
& \stackrel{(l a w)}{=} \frac{\gamma_{m}}{\gamma_{m^{\prime}}} \int_{0}^{m} h(u) \frac{d \gamma_{u}}{\gamma_{m}} \stackrel{(\text { law })}{=} \frac{1}{\gamma_{m^{\prime}}} \int_{0}^{m^{\prime}} h(u) 1_{[0, m]}(u) d_{u}\left(D_{u}^{\left(m^{\prime}\right)}\right) \in \mathcal{D}^{\left(m^{\prime}\right)}
\end{aligned}
$$

1.4.d ii) In the same spirit as for the preceding point, we note that, if $G$ is a positive r.v. such that $E\left(\log ^{+} G\right)<\infty$ and if $m^{\prime}>m$, then :

\Gamma_{m}\left(\frac{1}{G}\right) \stackrel{(l a w)}{=} \Gamma_{m^{\prime}}\left(\frac{1}{G \cdot Y_{p}}\right) \tag{1.40}

where, on the RHS of (1.40), $G$ and $Y_{p}$ are independent and $Y_{p}$ is a Bernoulli r.v. with parameter $p=\frac{m}{m^{\prime}}$ :

\end{equation*}

Indeed, we deduce from (1.24) :

E\left(e^{-\lambda \Gamma_{m}(1 / G)}\right) & =\exp \left\{-m \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-x / G}\right)\right\} \\
& =\exp \left\{-m^{\prime} \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} \frac{m}{m^{\prime}} E\left(e^{-x / G}\right)\right\} \\
& =\exp \left\{-m^{\prime} \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-\left(\frac{x}{G Y_{p}}\right)}\right)\right\} \\
& =E\left(e^{-\lambda \Gamma_{m}\left(\frac{1}{G Y_{p}}\right)}\right)
\end{aligned}
$$

1.4.d iii) We now write the relation (1.40) in a slightly different manner with the introduction of the r.v.'s $D_{m}(1 / G)$ and $D_{m}\left(\frac{1}{G Y_{p}}\right)$. We have, from (1.40) and (1.35) for $m^{\prime}>m$ :

\frac{\gamma_{m}}{\gamma_{m^{\prime}}} \gamma_{m^{\prime}} D_{m}(1 / G) \stackrel{(l a w)}{=} \gamma_{m^{\prime}} D_{m^{\prime}}\left(\frac{1}{G Y_{p}}\right)
$$

so that, from point 1.4.b :

\begin{align*}
& \frac{\gamma_{m}}{\gamma_{m^{\prime}}} \cdot D_{m}(1 / G) \stackrel{(\text { law })}{=} D_{m^{\prime}}\left(\frac{1}{G Y_{p}}\right) \quad \text { i.e. : } \\
& \beta_{m, m^{\prime}-m} \cdot D_{m}(1 / G) \stackrel{(l a w)}{=} D_{m^{\prime}}\left(\frac{1}{G Y_{p}}\right) \quad\left(p=\frac{m}{m^{\prime}}\right) \tag{1.42}
\end{align*}
$$

In particular, for $m<1$ and $m^{\prime}=1$ :

$$
\begin{equation*}
\beta_{m, 1-m} \cdot D_{m}(1 / G) \stackrel{(\text { law })}{=} D_{1}\left(\frac{1}{G Y_{m}}\right) \tag{1.43}
\end{equation*}
$$

1.4.d iv) Some elements of $\mathcal{D}^{(m)}$.

Let $T$ denote a positive r.v. which belongs to the Bondesson class $\mathbb{B}$ (see [B1], p. 73, Th. $5.2 .2)$ i.e. whose density $f_{T}$ writes :

f_{T}(x)=C x^{\beta-1} h_{1}(x) h_{2}(1 / x) \quad(\beta \in \mathbb{R}, x>0)
$$

with

h_{j}(x)=\exp \left\{-b_{j} x+\int_{0}^{\infty} \log \left(\frac{1+y}{x+y}\right) \nu_{j}(d y)\right\} \quad j=1,2
$$

and

$$
\int_{0}^{\infty} \frac{\nu_{j}(d y)}{1+y}<\infty
$$

Then, from Bondesson ([B1], Th. 5.2.2, p. 79), we know that:

\Gamma_{m}:=\gamma_{m} \cdot T \tag{1.44}
\end{equation*}
$$

is GGC (for every $m>0$ ) with some, possibly unknown, associated Thorin measure we denote as $\mu_{m}$. Assuming furthermore that $E\left(T^{-m}\right)<\infty$, we get, from (1.30) :

Thus, from point 1.4.b

\begin{equation*}
T \stackrel{(l a w)}{=} D_{m}\left(G_{m}\right) \in \mathcal{D}^{(m)} \tag{1.48}
\end{equation*}
$$

We now summarize what we have just obtained :

## Proposition 1.5

Let $T$ denote a positive r.v. which belongs to $\mathbb{B}$, such that :

Then:

1) $\quad T \in \mathcal{D}^{(m)}$
2) For every $m^{\prime}>m, \beta_{m, m^{\prime}-m} \cdot T \in \mathcal{D}^{\left(m^{\prime}\right)} \quad$ (from (1.43))

In particular, Proposition 1.5 may be applied in the following cases :

- If $T$ is a generalized inverse Gaussian r.v., i.e. its density is given by :

$\left(\beta \in \mathbb{R}, c_{1}, c_{2}>0\right)$ then, for every $m>0, T \in \mathcal{D}^{(m)}$ (although $T$ is a GGC variable with infinite total mass for its Thorin measure (see [B1], p. 59)).

- If $T$ is a Gamma r.v. $\gamma_{\theta}$ with parameter $\theta$ then for every $m>0, \gamma_{\theta} \in \mathcal{D}^{(m)}$. Indeed $\gamma_{\theta} \in \mathbb{B}$ and for every $m<\theta: E\left(\frac{1}{\gamma_{\theta}^{m}}\right)<\infty$. On the other hand, assuming still $m<\theta$, we have :

\beta_{m, \theta-m} \cdot \gamma_{\theta} \stackrel{(l a w)}{=} \gamma_{m} \in \mathcal{D}^{(\theta)} \quad \text { from }(1.40)
$$

- If $T$ is a positive stable r.v. with index $\alpha$ :

E\left(e^{-\lambda T}\right)=\exp \left\{-C \lambda^{\alpha}\right\} \quad(\lambda, C>0, \alpha \in] 0,1[)
$$

then, for $\alpha \leq \frac{1}{2}, T \in \mathbb{B}$ (see [B1], p. 85-88) and hence $T \in \mathcal{D}^{(m)}$ for every $m>0$ since $E\left(\frac{1}{T^{m}}\right)<\infty$.

Remark 1.5 Epifani, Guglielmi and Melilli ([EGM1], section 4; see also [EGM2] ), posed the natural question of which kind of probability measures are the laws of Dirichlet means. They were able to find some examples in cases where those particular random variables possessed all finite moments. One sees that Proposition 1.5, in a rather simple way, identifies a large number of possible distributions.
1.4.e Another representation of $\Gamma_{m}(G)$.

Let $m>0$ and let $K$ be a positive r.v. We shall say that $\left(Y_{t}, t \geq 0\right)$ is a $(m, K) \mathbb{R}_{+}$valued compound Poisson process if :

$$
Y_{t}:=\sum_{i=1}^{N_{t}} K_{i}
$$

where $\left(K_{1}, K_{2}, \cdots\right)$ is a sequence of i.i.d. variables, distributed as $K$, and with $\left(N_{t}, t \geq 0\right)$ a Poisson process with parameter $m$, independent of the sequence $\left(K_{i}, i=1,2 \cdots\right)$. In particular, $N_{t}$ is a Poisson r.v. with parameter $m t$.

## Proposition 1.6.

Let $\Gamma_{m}(G) a(m, G) G G C$ r.v. $\left(\right.$ with $E\left(\log ^{+}\left(\frac{1}{G}\right)\right)<\infty$ and $\left.m>0\right)$. Define $K$ by :

K \stackrel{(l a w)}{=} \frac{\mathfrak{e}}{G} \quad(\mathfrak{e}, \text { a standard exponential r.v. })
$$

Then

1) $\Gamma_{m}(G) \stackrel{(\text { law })}{=} \int_{0}^{\infty} e^{-t} d Y_{t}$
where $\left(Y_{t}, t \geq 0\right)$ is a $(m, K)$ compound Poisson process.
2) $\Gamma_{m}(G)$ satisfies the affine equation:

$$
\Gamma_{m}(G) \stackrel{(\text { law })}{=} U^{1 / m}\left[\Gamma_{m}(G)+K\right]
$$

(with $U$ uniformly distributed on $[0,1]$ ).

## Proof of Proposition 1.6.

i) We first prove point 1 . We consider $\left(Y_{t}, t \geq 0\right)$ a ( $\mathrm{m}, \mathrm{K}$ ) compound Poisson process. Then, approximating $\int_{0}^{\infty} e^{-t} d Y_{t}$ by the Riemann sums

where $\mu$ is the Lévy measure of the subordinator $\left(Y_{t}, t \geq 0\right)$. Since this subordinator is a ( $m, K$ ) compound Poisson process, we have:

& =E\left(e^{-\lambda \Gamma_{m}(G)}\right)
\end{aligned}
$$

ii) We now prove point 2. We have :

\int_{0}^{\infty} e^{-t} d Y_{t}=\int_{0}^{T_{1}} e^{-t} d Y_{t}+\int_{T_{1}}^{\infty} e^{-t} d Y_{t}
$$

(where $T_{1}$ is the first jump time of $\left(N_{t}, t \geq 0\right)$ )

$$
=e^{-T_{1}} K_{1}+e^{-T_{1}} \int_{0}^{\infty} e^{-t} d\left(Y_{T_{1}+t}\right)
$$

and we observe that :

$$
e^{-T_{1}} \stackrel{(l a w)}{=} U^{1 / m}, \quad \int_{0}^{\infty} e^{-t} d\left(Y_{T_{1}+t}\right) \stackrel{(l a w)}{=} \int_{0}^{\infty} e^{-t} d Y_{t},
$$

and $\int_{0}^{\infty} e^{-t} d\left(Y_{T_{1}+t}\right)$ is independent of $T_{1}$.

### 1.5 The subordinators $\left(\Gamma_{t}(G), t \geq 0\right)$

1.5.a Let $\Gamma$ denote a GGC r.v. From Lévy-Khintchine formula, there exists a (unique) subordinator $\left(\Gamma_{t}, t \geq 0\right)$ such that :

E\left(e^{-\lambda \Gamma_{t}}\right)=\exp \left\{-t \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} \int_{0}^{\infty} e^{-x z} \mu(d x)\right\} \tag{1.50}
\end{equation*}
$$

where $\mu$ denotes the Thorin measure associated with $\Gamma$.
1.5.b Let $G$ denote a positive r.v. which satisfies (1.19). Then, there exists a subordinator $\left(\Gamma_{t}(G), t \geq 0\right)$ which is characterized by :

& =\exp \left\{-t E\left(\log \left(1+\frac{\lambda}{G}\right)\right)\right\} \tag{1.52}
\end{align*}

In particular, for every $t>0, \Gamma_{t}(G)$ is a $(t, G)$ GGC r.v. Thus, there exists, following (1.33), a family of r.v.'s $D_{t}(G), t \geq 0$, whose laws are characterized by :

and, for every $t>0$, from (1.34) and Proposition 1.3 :

& \Gamma_{t}(G) \stackrel{(l a w)}{=} \int_{0}^{t} \frac{1}{F_{G}^{-1}\left(\frac{u}{t}\right)} d \gamma_{u} \stackrel{(\text { law })}{=} \int_{0}^{t} \frac{1}{F_{G}^{-1}\left(1-\frac{u}{t}\right)} d \gamma_{u}  \tag{1.54}\\
& D_{t}(G) \stackrel{(\text { law })}{=} \int_{0}^{t} \frac{1}{F_{G}^{-1}\left(\frac{u}{t}\right)} d_{u}\left(D_{u}^{(t)} \stackrel{(\text { law })}{=} \int_{0}^{t} \frac{1}{F_{G}^{-1}\left(\frac{u}{t}\right)} d_{u}\left(D_{u}^{(t)}\right)\right. \tag{1.55}
\end{align*}
$$

We note that the relations (1.54) and (1.55) are only true for fixed $t$, for any $t>0$, but do not hold as equalities in law between processes. On the other hand, since :

1) The family of laws of the r.v.'s $D_{t}(G), t \geq 0$ solves the equation : for every $t, s \geq 0$ :

3) We assume furthermore that $E\left(\frac{1}{G}\right)<\infty\left(\right.$ which implies $E\left(\log ^{+}\left(\frac{1}{G}\right)<\infty\right)$. Then :

3 i) & \text { for every } t>0, \quad E\left(\Gamma_{t}(G)\right)=t E(1 / G) \text { and } E\left(D_{t}(G)\right)=E(1 / G) \\
3 \text { ii) } & \frac{1}{t} \Gamma_{t}(G) \xrightarrow[t \rightarrow 0]{\text { a.s. }} E(1 / G) \text { and } D_{t}(G) \xrightarrow[t \rightarrow \infty]{(\text { law })} E(1 / G) \\
3 \text { iii }) & {\left[\Gamma_{t}(G)\right]_{t \rightarrow 0}^{t(\text { law })} U \text { and }\left[D_{t}(G)\right] \xrightarrow[t \rightarrow 0]{t} 1} \tag{1.61}
\end{array}
$$

where $U$ is uniform on $[0,1]$.
Point 2 of this Proposition 1.7 is due to Hjort and Ongaro (see [HO]).

## Proof of Proposition 1.7

We now prove $3 i i$ ). The a.s. convergence (hence, the convergence in law) of $\frac{1}{t} \Gamma_{t}(G)$ as $t \rightarrow \infty$ towards $E(1 / G)$ follows from the law of large numbers.
We prove that $D_{t}(G) \underset{t \rightarrow \infty}{(\text { law })} E(1 / G)$. We first observe that the family $\left(D_{t}(G), t \geq 0\right)$ is tight. Indeed :

$$
\begin{equation*}
\sup _{t>0} P\left(D_{t}(G)>a\right) \leq \sup _{t>0} \frac{E\left(D_{t}(G)\right)}{a} \leq \frac{E(1 / G)}{a} \tag{1.64}
\end{equation*}
$$

We write now :

\frac{\Gamma_{t}(G)}{t} \stackrel{(\text { law })}{=} D_{t}(G)\left(\frac{\gamma_{t}}{t}-1\right)+D_{t}(G)
$$

and we shall prove that $D_{t}(G)\left|\frac{\gamma_{t}}{t}-1\right| \underset{t \rightarrow \infty}{P} 0$, which implies by the preceding equality that $D_{t}(G) \underset{t \rightarrow \infty}{P} E(1 / G)$. We have :

$$
E\left[\frac{D_{t}(G)\left|\frac{\gamma_{t}}{t}-1\right|}{1+D_{t}(G)\left|\frac{\gamma_{t}}{t}-1\right|}\right] \leq E\left[\frac{C\left|\frac{\gamma_{t}}{t}-1\right|}{1+C\left|\frac{\gamma_{t}}{t}-1\right|}\right]+P\left(D_{t}(G)>C\right)
$$

for all $C>0$. Hence, from (1.64):

\begin{aligned}
\varlimsup_{t \rightarrow \infty} E\left[\frac{D_{t}(G)\left|\frac{\gamma_{t}}{t}-1\right|}{1+D_{t}(G)\left|\frac{\gamma_{t}}{t}-1\right|}\right] & \leq \varlimsup_{t \rightarrow \infty} E\left[\frac{C\left|\frac{\gamma_{t}}{t}-1\right|}{1+C\left|\frac{\gamma_{t}}{t}-1\right|}\right]+\frac{E(1 / G)}{C} \\
& \leq \frac{E(1 / G)}{C}
\end{aligned}
$$

since $\left|\frac{\gamma_{t}}{t}-1\right| \underset{t \rightarrow \infty}{\longrightarrow} 0$ a.s. $C$ being arbitrary, the point $\left.3 i i\right)$ is proven.
We now prove point 3 iii).
If we knew that $\left(D_{t}(G)\right)^{t} \xrightarrow[t \rightarrow 0]{(l a w)} 1$, then, combining this result with the classical one : $\left(\gamma_{t}\right)^{t} \xrightarrow[t \rightarrow 0]{(\text { law })} U$, we would deduce :

\left(\Gamma_{t}(G)\right)^{t(l a w)} \stackrel{ }{=}\left(\gamma_{t}\right)^{t} \cdot\left(D_{t}(G)\right)^{t} \stackrel{t(\text { law })}{t \rightarrow 0} U

In fact, we shall proceed in the other direction. We shall show further (see point 7 of Remark 2.2) that $\left(\Gamma_{t}(G)\right) \xrightarrow[t \rightarrow 0]{(\text { law })} U$. The relation $\left(\Gamma_{t}(G)\right)^{t}=\left(\gamma_{t}\right)^{t}\left(D_{t}(G)\right)^{t}$ and :

\begin{aligned}
& \left(\gamma_{t}\right)^{t} \xrightarrow[t \rightarrow 0]{(\text { law })} U,\left(\Gamma_{t}(G)\right)^{t} \xrightarrow[t \rightarrow 0]{t(\text { law })} U \quad \text { then imply easily that: } \\
& \left(D_{t}(G)\right)^{t} \xrightarrow[t \rightarrow 0]{t(l a w)} 1 .
\end{aligned}
$$

Remark 1.7 Lijoi and Reggazini $[\mathrm{LR}]$ have shown that the support of the law of $D_{t}(G)$ is the closure of the convex hull of the support of the law of $1 / G$. In particular :

- If $G \leq a$ a.s., then $D_{t}(G) \geq \frac{1}{a}$ a.s.
- If $G \geq a$ a.s., then $D_{t}(G) \leq \frac{1}{a}$ a.s.

In section 3 of this survey, we shall verify this assertion with the help of numerous examples.

### 1.6 Some examples of GGC subordinators

Let $\Gamma$ denote a GGC variable with associated Thorin measure $\mu$, and let ( $\Gamma_{t}, t \geq 0$ ) denote the subordinator such that $\Gamma_{1} \stackrel{(\text { law })}{=} \Gamma$. We have :

$$
\begin{equation*}
E\left(e^{-\lambda \Gamma_{t}}\right)=\exp \left\{-t \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} \int_{0}^{\infty} e^{-x z} \mu(d z)\right\} \tag{1.67}
\end{equation*}
$$

Such a subordinator is called a GGC subordinator.
Here are now some examples of such subordinators. They are lifted from a paper by H. Matsumoto, L. Nguyen and M. Yor [MNY] on one hand, and from the study of hyperbolic subordinators made in Pitman and Yor $[\mathrm{PY}]$ on the other hand. The reader may refer to these papers for further information. In the study of these examples, we shall denote subordinators with curly letters, especially to avoid some possible confusion with the modified Bessel functions, which are traditionally written with ordinary capital letters.
1.6.a The hyperbolic subordinators (see [PY] for a probabilistic description of these subordinators.)
i) The subordinator $\left(\mathcal{C}_{t}, t \geq 0\right)$ is characterized by :

\begin{equation*}
E\left(e^{-\lambda \mathcal{C}_{t}}\right)=\exp \{-t \log \cosh \sqrt{2 \lambda}\}=\left(\frac{1}{\cosh \sqrt{2 \lambda}}\right)^{t} \quad(\lambda, t \geq 0) \tag{1.68}
\end{equation*}
$$

Its Lévy density $l_{\mathcal{C}}$ equals :

$$
\begin{equation*}
l_{\mathcal{C}}(x)=\frac{1}{x} \sum_{n=1}^{\infty} \exp \left(-\frac{\pi^{2}}{8}(2 n-1)^{2} x\right) \quad(x \geq 0) \tag{1.69}
\end{equation*}
$$

and its associated Thorin measure, (i.e. : the Thorin measure of $\mathcal{C}_{1}$ ) equals :

$$
\begin{equation*}
\mu_{\mathcal{C}}(d x)=\sum_{n=1}^{\infty} \delta_{\frac{\pi^{2}}{8}(2 n-1)^{2}}(d x) \tag{1.70}
\end{equation*}
$$

ii) The subordinator $\left(\mathcal{S}_{t}, t \geq 0\right)$ is characterized by :

$$
\begin{equation*}
E\left(e^{-\lambda \mathcal{S}_{t}}\right)=\left(\frac{\sqrt{2 \lambda}}{\sinh \sqrt{2 \lambda}}\right)^{t} \quad(\lambda, t \geq 0) \tag{1.71}
\end{equation*}
$$

Its Lévy density equals :

$$
\begin{equation*}
l_{\mathcal{S}}(x)=\frac{1}{x} \sum_{n=1}^{\infty} \exp \left(-\frac{\pi^{2}}{2} n^{2} x\right) \quad(x \geq 0) \tag{1.72}
\end{equation*}
$$

Hence, its Thorin measure equals :

$$
\begin{equation*}
\mu_{\mathcal{S}}(d x)=\sum_{n=1}^{\infty} \delta_{\frac{\pi^{2} n^{2}}{2}}(d x) \quad(x \geq 0) \tag{1.73}
\end{equation*}
$$

It has infinite total mass.
We note that the subordinator $\left(\mathcal{T}_{t}, t \geq 0\right)$ which is characterized by :

$$
\begin{equation*}
E\left(e^{-\lambda \mathcal{I}_{t}}\right)=\left(\frac{1}{\cosh \sqrt{2 \lambda}}\right)^{t} \cdot\left(\frac{\sinh \sqrt{2 \lambda}}{\sqrt{2 \lambda}}\right)^{t}=\left(\frac{\tanh \sqrt{2 \lambda}}{\sqrt{2 \lambda}}\right)^{t} \tag{1.74}
\end{equation*}
$$

satisfies :

$$
\begin{equation*}
\left(\mathcal{C}_{t}, t \geq 0\right) \stackrel{(l a w)}{=}\left(\mathcal{S}_{t}+\mathcal{T}_{t}, t \geq 0\right) \tag{1.75}
\end{equation*}
$$

and that its Lévy density equals :

$$
l_{\mathcal{T}}(x)=l_{\mathcal{C}}(x)-l_{\mathcal{S}}(x)
$$

However, this subordinator ( $\left.\mathcal{T}_{t} t \geq 0\right)$ is not GGC, as its would be 'Thorin measure' $\mu_{\mathcal{T}}$ is a signed measure :

$$
\mu_{\mathcal{T}}=\mu_{\mathcal{C}}-\mu_{\mathcal{S}} .
$$

1.6.b The subordinators $\left(\mathcal{J}_{t}^{(0)}, t \geq 0\right)$ and $\left(\mathcal{K}_{t}^{(0)}, t \geq 0\right)$

We denote by $I_{\nu}$ and $K_{\nu}$ the modified Bessel functions with index $\nu$ (see [Leb], p. 108). i) The subordinator $\left(\mathcal{J}_{t}^{(0)}, t \geq 0\right)$ is characterized by :

\begin{equation*}
E\left(e^{-\lambda \mathcal{J}_{t}^{(0)}}\right)=\left(1+\lambda+\sqrt{(1+\lambda)^{2}-1}\right)^{-t}=\exp \left\{-t \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} I_{0}(x) e^{-x}\right\} \tag{1.76}
\end{equation*}
$$

Its Lévy density $l_{\mathcal{J}^{(0)}}$ equals :

$$
\begin{equation*}
l_{\mathcal{J}^{(0)}}(x)=I_{0}(x) \frac{e^{-x}}{x} \quad(x \geq 0) \tag{1.77}
\end{equation*}
$$

and its Thorin measure $\mu_{\mathcal{J}^{(0)}}$, with total mass equal to 1 , equals :

\begin{equation*}
\mu_{\mathcal{J}^{(0)}}(d x)=\frac{1}{\pi} \frac{d x}{\sqrt{x(2-x)}} 1_{[0,2]}(x) \tag{1.78}
\end{equation*}
$$

This formula was obtained by Bondesson ([B3], Ex. 5.2). In Section 3, Theorem 3.1, we shall meet again this subordinator $\left(\mathcal{J}_{t}^{(0)}, t \geq 0\right)$.
ii) The subordinator $\left(\mathcal{K}_{t}^{(0)}, t \geq 0\right)$ is characterized by :

& =\exp \left\{-t \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} K_{0}(x) e^{-x}\right\} \tag{1.79}
\end{align*}
$$

Hence, its Lévy density equals :

l_{\mathcal{K}^{(0)}}(x)=K_{0}(x) \frac{e^{-x}}{x} \quad x \geq 0 \tag{1.80}
\end{equation*}
$$

and its Thorin measure $\mu_{\mathcal{K}_{(0)}}$ equals:

\mu_{\mathcal{K}^{(0)}}(d x)=\frac{d x}{\sqrt{x(x-2)}} 1_{[2, \infty[ }(x) d x \tag{1.81}
\end{equation*}
$$

We note that this latter formula follows from :

& =e^{-x} \int_{1}^{\infty} e^{-x u} \frac{d u}{\sqrt{u^{2}-1}}=\int_{2}^{\infty} e^{-x v} \frac{d v}{\sqrt{v(v-2)}}
\end{aligned}
$$

iii) The subordinators $\left(\mathcal{K}_{t}^{(0)}, t \geq 0\right)$ and $\left(\mathcal{J}_{t}^{(0)}, t \geq 0\right)$ are connected via the subordination relation :

where, on the RHS from (1.82), the processes $\left(\mathcal{K}_{u}^{(0)}, u \geq 0\right)$ and $\left(S_{1 / 2}(t), t \geq 0\right)$ are independent, and where ( $S_{1 / 2}(t), t \geq 0$ ) is the stable subordinator with index $1 / 2$ characterized by :

iv) The v.a. $\mathcal{K}_{t}^{(0)}$, for $t$ fixed, may be realized in the following manner :
let $\left(b_{u}(s) ; 0 \leq s \leq u\right)$ the brownian bridge with length $u$ (with $b_{u}(0)=b_{u}(u)=0$ ) and let :

\mathcal{K}_{t}^{(0)} \stackrel{(l a w)}{=}\left[A\left(b_{1 / t}\right)\right] \stackrel{-1(l a w)}{=} t\left(\int_{0}^{1} \exp \left(\frac{2 b(s)}{\sqrt{t}}\right) d s\right)^{-1} \tag{1.84}
\end{equation*}
$$

where, in $(1.84),(b(s), 0 \leq s \leq 1)$ denotes the standard brownian bridge $b_{1}$.
$v$ ) In relation with the preceding, D. Dufresne and M. Yor, in a work in preparation [ $D Y$ ], establish the following formula : let $\left(b_{u}^{(x)}(s), 0 \leq s \leq u\right)$ denote the brownian bridge with length $u$, starting from 0 and such that $b_{u}^{(x)}(u)=x$. Let :

Then, D. Dufresne and M. Yor obtain the representation as a Wiener-Gamma integral of the r.v. $\frac{1}{A\left[b_{u}^{(x)}\right]}$ :

$$

and in particular :

\begin{equation*}
\frac{1}{A\left[b_{u}\right]} \stackrel{(\text { law })}{=} \int_{0}^{\infty} \frac{d \gamma_{s}}{1+\cosh (s u)} \tag{1.87}
\end{equation*}
$$

1.6.c The subordinators $\left(\mathcal{J}_{t}^{(\nu)}, t \geq 0\right)$ and $\left(\mathcal{K}_{t}^{(\nu)}, t \geq 0\right)$

They are obtained by replacing in (1.76), resp. (1.79), $I_{0}$ by $I_{\nu}$, resp. $K_{0}$ by $K_{\nu}$.
i) The subordinator $\left(\mathcal{J}_{t}^{(\nu)}, t \geq 0\right)$, which is defined for $\nu>-1$, is characterized by :

E\left(e^{-\lambda \mathcal{J}_{t}^{(\nu)}}\right)=\exp \left\{-t \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} e^{-x} I_{\nu}(x)\right\} \tag{1.88}
\end{equation*}
$$

Thus, its Lévy density $l_{\mathcal{I}^{(\nu)}}$ equals :

\begin{equation*}
l_{\mathcal{J}^{(\nu)}}(x)=\frac{e^{-x}}{x} I_{\nu}(x) \quad x \geq 0 \tag{1.89}
\end{equation*}
$$

Its Thorin measure, in the case $-1 / 2<\nu<0$, is obtained by the following calculus :

I_{\nu}(z)=\frac{\left(\frac{z}{2}\right)^{\nu}}{\sqrt{\pi} \Gamma(\nu+1 / 2)} \cdot \int_{0}^{1}\left(1-t^{2}\right)^{\nu-1 / 2}\left(e^{z t}+e^{-z t}\right) d t \quad(\operatorname{Re} \nu>-1 / 2)
$$

(see [Leb], p. 119, form.5.10.22)
and :

e^{-z} I_{\nu}(z)=C_{\nu} z^{\nu} \int_{0}^{1}\left(1-t^{2}\right)^{\nu-1 / 2}\left(e^{-z(1-t)}+e^{-z(1+t)}\right) d t
$$

But, for $\nu<0$ :

z^{\nu} e^{-z a}=\frac{1}{\Gamma(-\nu)} \int_{0}^{\infty} s^{-\nu-1} e^{-z(a+s)} d s
$$

Hence :

& e^{-z} I_{\nu}(z) \\
& =C_{\nu}^{\prime} \int_{0}^{1}\left(1-t^{2}\right)^{\nu-1 / 2} d t \int_{0}^{\infty} s^{-\nu-1}\left(e^{-z(1-t+s)}+e^{-z(1+t+s)}\right) d s \\
& =C_{\nu}^{\prime} \int_{0}^{1}\left(1-t^{2}\right)^{\nu-1 / 2} d t\left[\int_{1-t}^{\infty} e^{-z h}(h-1+t)^{-\nu-1} d h+\int_{1+t}^{\infty} e^{-z h}(h-1-t)^{-\nu-1} d h\right] \\
& =C_{\nu}^{\prime} \int_{0}^{1} e^{-z h} d h \int_{0}^{1} d t\left(1-t^{2}\right)^{\nu-1 / 2}\left[(h-1+t)^{-\nu-1} \mathbf{1}_{h>1-t}+(h-1-t)^{-\nu-1} \mathbf{1}_{h>1+t}\right]
\end{aligned}
$$

Hence, in the case $-1 / 2<\nu<0$, the Thorin measure of $\left(\mathcal{J}_{t}^{(\nu)}, t \geq 0\right)$ admits a density equal to :

\left.\left.+(x-(1+t))^{-\nu-1} \mathbf{1}_{x>1+t}\right\} d t\right]

Hence, if $-1 / 2<\nu<0,\left(\mathcal{J}_{t}^{\nu}, t \geq 0\right)$ is a GGC subordinator.
ii) The subordinator $\left(\mathcal{K}_{t}^{(\nu)}, t \geq 0\right)$, defined for $\nu<1$, is characterized by :

Its Lévy density $l_{\mathcal{K}^{(\nu)}}$ equals :

l_{\mathcal{K}^{(\nu)}}(x)=\frac{e^{-x}}{x} K_{\nu}(x) \quad(x \geq 0) \tag{1.91}
\end{equation*}
$$

Its Thorin measure $\mu_{\mathcal{K}^{(\nu)}}$, obtained by using the formula ([Leb], p. 119)

K_{\nu}(z)=\int_{0}^{\infty} e^{-z \cosh u}(\cosh \nu u) d u
$$

equals :

\begin{equation*}
\mu_{\mathcal{K}^{(\nu)}}(d x)=\cosh [\nu \arg \cosh (x-1)] \frac{d x}{\sqrt{x(x-2)}} 1_{[2, \infty[ }(x) \tag{1.92}
\end{equation*}
$$

The formula in (1.92) simplifies using,

\cosh [\nu \arg \cosh (x-1)]=\frac{1}{2}\left\{((x-1)+\sqrt{(x-2) x})^{\nu}+((x-1)+\sqrt{(x-2) x})^{-\nu}\right\},

1.7 The subordinator $\left(\Gamma_{t}\left(S_{\beta}\right), t \geq 0\right) \quad(0<\beta<1)$

We give here a realisation for the subordinator $\left(\Gamma_{t}\left(S_{\beta}\right), t \geq 0\right)$, where $S_{\beta}$ is a positive $\beta$-stable r.v.
Let $\alpha>0$. We denote $\sigma_{t, n}:=\left\{s_{1}=0<s_{2} \cdots<s_{n}=t\right\}$ a subdivision of the interval $[0, t]$ with mesh $\delta\left(\sigma_{t, n}\right):=\sup _{i}\left(s_{i+1}-s_{i}\right)$. The limit along the decreasing filtering set of sequences $\sigma_{t, n}$ whose meshes $\delta\left(\sigma_{t, n}\right)$ tend to zero, of $\sum_{s_{k} \in \sigma_{t, n}}\left(\gamma_{s_{k+1}}-\gamma_{s_{k}}\right)^{\alpha}$ exists a.s. Observe that : $E\left(\sum_{s_{k} \in \sigma_{t, n}}\left(\gamma_{s_{k+1}}-\gamma_{s_{k}}\right)^{\alpha}\right)=\sum_{s_{k} \in \sigma_{t, n}} \frac{\Gamma\left(\alpha+s_{k+1}-s_{k}\right)}{\Gamma\left(s_{k+1}-s_{k}\right)} \underset{\delta\left(\sigma_{t, n}\right) \rightarrow 0}{\longrightarrow} t \Gamma(\alpha)$. Let :

$$
\begin{equation*}
V^{(\alpha)}(t):=\lim _{\delta\left(\sigma_{t, n}\right) \rightarrow 0} \sum_{s_{k} \in \sigma_{t, n}}\left(\gamma_{s_{k+1}}-\gamma_{s_{k}}\right)^{\alpha}=\sum_{0<s \leq t}\left(\gamma_{s}-\gamma_{s^{-}}\right)^{\alpha} \tag{1.93}
\end{equation*}
$$

Let

$$
N_{t, x}:=\#\left\{s \leq t ; \gamma_{s}-\gamma_{s^{-}}>x^{1 / \alpha}\right\}
$$

From Section 1.4, $N_{t, x}$ is a Poisson r.v. with parameter $t \cdot \int_{x^{1 / \alpha}}^{\infty} \frac{e^{-u}}{u} d u$. But, evidently :

\begin{equation*}
N_{t, x}=\#\left\{s \leq t ;\left(\gamma_{s}-\gamma_{s^{-}}\right)^{\alpha}>x\right\} \tag{1.94}
\end{equation*}
$$

We deduce from (1.94) that the Poisson point process

\left\{\left(\gamma_{s}-\gamma_{s^{-}}\right)^{\alpha}, s \geq 0\right\} \text { admits } n^{(\alpha)}(d x)=\frac{1}{\alpha} \frac{d x}{x} e^{-x^{1 / \alpha}} \quad(x>0)
$$

as intensity measure. Hence $\left(V^{(\alpha)}(t), t \geq 0\right)$ is a subordinator whose Lévy measure equals $n^{(\alpha)}(d x)$ :

E\left(e^{-\lambda V^{(\alpha)}(t)}\right)=\exp \left\{-\frac{t}{\alpha} \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} e^{-x^{1 / \alpha}}\right\}
$$

This subordinator, for every $\alpha>0$, is self-decomposable but it is GGC only in the case $\alpha \geq 1$. In this case : $\alpha \geq 1$ we have :

$$
E\left(e^{-\lambda V^{(\alpha)}(t)}\right)=\exp \left(-\frac{t}{\alpha} \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-x S_{1 / \alpha}}\right)\right\}
$$

where $S_{1 / \alpha}$ is a positive $\frac{1}{\alpha}$ stable r.v. In other terms, with the notation of Section 1.5.b :

$$
\begin{equation*}
\left(\Gamma_{t}\left(S_{\beta}\right), t \geq 0\right) \stackrel{(l a w)}{=}\left(V^{(\alpha)}(t \alpha), t \geq 0\right) \quad\left(\alpha=\frac{1}{\beta} \geq 1\right) \tag{1.95}
\end{equation*}
$$

### 1.8 Remark.

We now end up this Introduction by indicating how the study of the GGC subordinators may be embedded in a more general one.
A subordinator $\left(N_{t}, t \geq 0\right)$ is said to belong to the Thorin class $T^{(\chi)}\left(\mathbb{R}_{+}\right)$, with $\chi>0$ (see [Grig]), if its Lévy measure admits a density $l_{N}$ of the form :

$$
\begin{equation*}
l_{N}(x)=x^{\chi-2} k(x) \quad x>0 \tag{1.96}
\end{equation*}
$$

where $k$ is a completely monotonic function, i.e. it may be represented as :

$$
\begin{equation*}
k(x):=\int_{0}^{\infty} e^{-x y} \mu(d y) \tag{1.97}
\end{equation*}
$$

for a positive Radon measure $\mu$ carried by $\mathbb{R}_{+}^{*}$. Thus, the subordinators which we study in this work, i.e. : the GGC subordinators, belong to the class $T^{(1)}\left(\mathbb{R}_{+}\right)$. The class $T^{(2)}\left(\mathbb{R}_{+}\right)$ has been studied by Goldie [Gol], Steutel [Steu] and Bondesson [B2]. The r.v's which belong to this class are the generalized convolutions of mixtures of exponential laws. Note that $T^{(\chi)}\left(\mathbb{R}_{+}\right) \subset T^{\left(\chi^{\prime}\right)}\left(\mathbb{R}_{+}\right)$if $\chi<\chi^{\prime}$. We also note that [BNMS] present extensions of these notions to $\mathbb{R}^{d}$.
In the same manner as condition (1.9) is necessary and sufficient for a measure $\mu$ to be the Thorin measure associated to a positive r.v., B. Grigelionis [Grig] obtains a necessary and sufficient analytical condition so that a measure $\mu$ defines, via (1.96) and (1.97), a subordinator ( $N_{t}, t \geq 0$ ) which belongs to the class $T^{(\chi)}\left(\mathbb{R}_{+}\right)$.
1.9 We now detail the contents of the sequel of this paper :

- In Section 2, we present a duality result which connects on one hand the r.v.'s $\Gamma_{t}(G)$ and $D_{t}(G)$ to the r.v.'s $\Gamma_{t}(1 / G)$ and $\Gamma_{t}(G)$ on the other hand.
- In Section 3, we study in depth the examples of subordinators $\Gamma_{t}\left(\mathbb{G}_{\alpha}\right)(0 \leq \alpha \leq 1)$ for which we know how to compute explicitly their Laplace transforms, i.e. : their Lévy exponents, as well as their densities at any time, and their Wiener-Gamma representations.


## 2 A duality principle.

Throughout this section, $G$ denotes a positive r.v. such that $E(|\log G|)<\infty$. Thus, we have :

$$
\begin{equation*}
E\left(\log ^{+}(1 / G)\right)<\infty \quad \text { and } \quad E\left(\log ^{+}(G)\right)<\infty \tag{2.1}
\end{equation*}
$$

Consequently, the subordinators $\left(\Gamma_{t}(G), t \geq 0\right)$ and $\left(\Gamma_{t}(1 / G), t \geq 0\right)$ are well defined. We denote by $\psi_{G}\left(\right.$ resp. $\left.\psi_{1 / G}\right)$ the characteristic exponent (i.e. : the Bernstein function or Lévy exponent) of the subordinator $\left(\Gamma_{t}(G), t \geq 0\right)$, resp. $\left(\Gamma_{t}(1 / G), t \geq 0\right)$.

$$
\begin{equation*}
\psi_{G}(\lambda):=\int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-x G}\right) \tag{2.2}
\end{equation*}
$$

and the same formula for $\psi_{1 / G}$ obtained when replacing $G$ by $1 / G$. We denote by $F_{G}$ the cumulative distribution function of $G$ and by $F_{G}^{-1}$ its right continuous inverse, in the sense of the composition of functions.

### 2.1 The duality theorem.

Theorem 2.1 (Duality)

1) $\quad F_{1 / G}^{-1}(y) \cdot F_{G}^{-1}(1-y)=1 \quad$ a.e. $\quad(y \in[0,1])$
2) For any $\lambda \geq 0$ :

$$
\begin{equation*}
\psi_{1 / G}(\lambda)-\psi_{G}(1 / \lambda)=E(\log G)+\log \lambda \tag{2.4}
\end{equation*}
$$

3) i) $f_{\Gamma_{t}(1 / G)}$ the density of the r.v. $\Gamma_{t}(1 / G)$, equals :

$$
\begin{equation*}
f_{\Gamma_{t}(1 / G)}(x)=e^{-t E(\log G)} E\left\{\left(\frac{\Gamma_{t}(G)}{x}\right)^{\frac{1-t}{2}} J_{t-1}\left(2 \sqrt{x \Gamma_{t}(G)}\right)\right\} \tag{2.5}
\end{equation*}
$$

where $J_{\nu}$ denotes the Bessel function with index $\nu$ :

$$
\begin{align*}
& \quad J_{\nu}(z)=\sum_{k=0}^{\infty}(-1)^{k} \frac{1}{\Gamma(k+1) \Gamma(k+\nu+1)}\left(\frac{z}{2}\right)^{\nu+2 k}, \quad|z|<\infty,|\operatorname{Arg} z|<\pi  \tag{2.6}\\
& \text { (see [Leb], p. 102) }
\end{align*}
$$

ii) $f_{\Gamma_{t}(1 / G)}(x)=\frac{x^{t-1}}{\Gamma(t)} e^{-t E(\log G)} E\left(e^{-x D_{t}(G)}\right) \quad(x>0)$
iii) $E\left(\frac{1}{\left(D_{t}(G)\right)^{t}}\right)=e^{t E(\log G)}$
4) i) $E\left(\frac{1}{\left(\lambda+D_{t}(G)\right)^{t}}\right)=\exp \left\{-t\left(\psi_{1 / G}(\lambda)-E(\log G)\right\}\right.$
ii) The densities $f_{D_{t}(G)}$ and $f_{D_{t}(1 / G)}$ of, resp., $D_{t}(G)$ and $D_{t}(1 / G)$ are related by :

$$
\begin{equation*}
f_{D_{t}(1 / G)}(x)=x^{t-2} e^{-t E(\log G)} f_{D_{t}(G)}(1 / x) \quad(x>0) \tag{2.10}
\end{equation*}
$$

## Remark 2.2.

1) The relation (2.4) is found, under a slightly different form, in Bondesson ([B1], p. 48, III "Curious composition"), under the only hypothesis $E\left(\log ^{+}(1 / G)\right)<\infty$. We have chosen to work under the stronger hypothesis $E(|\log G|)<\infty$ since it seems that only under this hypothesis can we obtain the most interesting results.
2) Of course, all formulae of Theorem 2.1 are "involutive", in that $G$ may be replaced there by $1 / G$.
3) Formula (2.7) agrees with, and makes more precise, the result of Bondesson which we recalled in (1.28) and (1.30). In particular :

\begin{equation*}
f_{\Gamma_{t}(G)}(x) \underset{x \rightarrow 0}{\sim} \frac{x^{t-1}}{\Gamma(t)} e^{t E(\log G)} \tag{2.11}
\end{equation*}
$$

4) Formula (2.4) may be generalized as follows :

Let $a, b, c, d \in \mathbb{R}^{4}$, with $a d-b c= \pm 1$ and let, for $x, \lambda \geq 0$ :

$$
\begin{equation*}
\sigma(x)=\frac{a x+b}{c x+d}, \quad \tilde{\sigma}(\lambda)=\frac{d \lambda+b}{c \lambda+a} \tag{2.12}
\end{equation*}
$$

so that $\sigma(G)$ be a positive r.v. Then :

$$
-\psi_{G}(\widetilde{\sigma}(\lambda))+\psi_{\sigma(G)}(\lambda)=\log (c \lambda+a)+k
$$

with $k:=E\left(\log \left(\frac{G+\lambda_{0}}{\sigma(G)+\lambda_{0}} \cdot \frac{\sigma(G)}{G}\right)\right)-\log \left(c \lambda_{0}+a\right)$ where $\lambda_{0}$ is a fixed point of $\widetilde{\sigma}$. The relation (2.4) corresponds to $a=d=0, b=c=1$. We shall study, in the Appendix, the case where $a=d=\sinh u, b=c=\cosh u \quad(u \geq 0)$.
5) Cifarelli and Regazzini ([CR2]), Cifarelli and Melilli [CM] have obtained the density of $D_{t}(G)$ for $t \geq 1$ and James, Lijoi and Prünster [JLP] have obtained it for $t \leq 1$. For $t \leq 1$, they obtained :

$$
\begin{equation*}
f_{D_{t}(G)}(x)=\int_{0}^{x}(x-u)^{t-1} \frac{d}{d u}\left(\theta_{t}(u)\right) d u \tag{2.13}
\end{equation*}
$$

with

$$
\begin{equation*}
\theta_{t}(u):=\frac{1}{\pi} \sin \left(t \pi F_{1 / G}(u)\right) \exp \left\{-t E\left(\log \left(u-\frac{1}{G}\right) 1_{u \neq \frac{1}{G}}\right)\right\} \tag{2.14}
\end{equation*}
$$

The proof of this formula (2.13) hinges upon the knowledge of the density of the r.v. $D_{1}\left(\frac{1}{G Y_{t}}\right)$ which is defined by : (see (1.41) and (1.42) with $m=t$ and $m^{\prime}=1$ ).

$$
\beta_{t, 1-t} \cdot D_{t}(1 / G) \stackrel{(l a w)}{=} D_{1}\left(\frac{1}{G \cdot Y_{t}}\right) \quad(t \leq 1)
$$

This density equals :

$$
\begin{equation*}
f_{D_{1}}\left(\frac{1}{G \cdot Y_{t}}\right)(x)=\frac{\sin \left(t \pi F_{G}(1 / x)\right)}{\pi} x^{t-1} \exp \left\{-t E\left(\log \left(x-\frac{1}{G}\right) \cdot 1_{G \neq \frac{1}{x}}\right)\right\} \tag{2.15}
\end{equation*}
$$

which is obtained by inverting its Stieltjes transform.
Other formulae for densities of Dirichlet means may be found in Regazzini, Guglielmi and DiNunno [RGdN]
6) Formula (2.8) is obtained from (2.7) by integrating between 0 and $\infty$ :

$$
\begin{align*}
1=\int_{0}^{\infty} f_{\Gamma_{t}(1 / G)}(x) d x & =\int_{0}^{\infty} \frac{1}{\Gamma(t)} x^{t-1} e^{-t E(\log G)} E\left(e^{-x D_{t}(G)}\right) d x \\
& =\frac{e^{-t E(\log G)}}{\Gamma(t)} E\left[\frac{1}{\left(D_{t}(G)\right)^{t}}\right] \Gamma(t), \text { hence }: \\
E\left(\frac{1}{\left(D_{t}(G)\right)^{t}}\right) & =e^{t E(\log G)} \tag{2.16}
\end{align*}
$$

The interest of this formula (2.16) is the following : it allows, in a situation where the law of $G$ is not known but when one knows the laws of $D_{t}(G)$ and $D_{t}(1 / G)$ to show that $E(|\log G|)<\infty$ as soon as $E\left(\left(D_{t}(G)\right)^{-t}\right)<\infty$ and $E\left(\left(D_{t}(1 / G)\right)^{-t}\right)<\infty$.
Formula (2.7), once multiplied by $x^{\nu}$, and integrated between 0 and $\infty$, leads to :

$$
\begin{equation*}
E\left[\left(\Gamma_{t}(1 / G)\right)^{\nu}\right]=\frac{\Gamma(\nu+t)}{\Gamma(t)} e^{-t E(\log G)} E\left(\frac{1}{\left(D_{t}(G)\right)^{\nu+t}}\right) \tag{2.17}
\end{equation*}
$$

The formula is also true even when the expectations which appear in this expression are infinite.
7) The result :

$$
\begin{equation*}
\left(\Gamma_{t}(G)\right)^{t} \underset{t \rightarrow 0}{(\text { law })} U \tag{2.18}
\end{equation*}
$$

with $U$ uniform on $[0,1]$ (see point 3 iii) of Proposition 1.7) is a consequence of (2.7). Indeed:

$$
\begin{aligned}
P\left(\left(\Gamma_{t}(G)\right)^{t} \leq e^{-a}\right) & =P\left(\Gamma_{t}(G) \leq e^{-\frac{a}{t}}\right) \\
& =\int_{0}^{e^{-\frac{a}{t}}} f_{\Gamma_{t}(G)}(x) d x \\
& =\frac{e^{t E(\log G)}}{\Gamma(t)} \int_{0}^{e^{-\frac{a}{t}}} x^{t-1} E\left(e^{-x D_{t}(1 / G)}\right) d x
\end{aligned}
$$

(from (2.7) applied when replacing $G$ by $1 / G$ ):

$$
\underset{t \rightarrow 0}{\sim} \frac{1}{\Gamma(t)} \int_{0}^{e^{-\frac{a}{t}}} x^{t-1} d x=\frac{e^{-a}}{\Gamma(t+1)} \underset{t \downarrow 0}{\longrightarrow} e^{-a}
$$

We note that, from (1.64), the family of the laws of $D_{t}(1 / G), t \leq 1$ is tight as soon as $E(G)<\infty$.

### 2.2 Proof of Theorem 2.1.

2.2.a Point 1 is trivial. We show point 2 :

Since, from Frullani's formula :

$$
\begin{aligned}
\psi_{G}(\lambda) & =E\left(\log \left(1+\frac{\lambda}{G}\right)\right)=E\left(\log \left(\frac{\lambda}{G}\left(1+\frac{G}{\lambda}\right)\right)\right) \\
& =\log \lambda-E(\log G)+E\left(\log \left(1+\frac{G}{\lambda}\right)\right.
\end{aligned}
$$

we have, by changing $\lambda$ in $1 / \lambda$ :

$$
-\psi_{G}(1 / \lambda)+\psi_{1 / G}(\lambda)=-\log \lambda+E(\log G)
$$

2.2.b We now show point 3 of Theorem 2.1 :
i) From formula (2.4), after multiplying by $t$ and exponentiating, we obtain :

$$
\begin{equation*}
E\left(e^{-\lambda \Gamma_{t}(1 / G)}\right)=\frac{e^{-t E(\log G)}}{\lambda^{t}} E\left(e^{-\frac{1}{\lambda} \Gamma_{t}(G)}\right) \tag{2.19}
\end{equation*}
$$

Then, taking the Laplace transform of both sides of (2.19) in the variable $\lambda$, we obtain :

$$
\begin{align*}
\int_{0}^{\infty} E\left(e^{-\lambda\left(\Gamma_{t}(1 / G)\right.}\right) e^{-\beta \lambda} d \lambda & =E\left(\frac{1}{\beta+\Gamma_{t}(1 / G)}\right) \\
& =e^{-t E(\log G)} E\left(\int_{0}^{\infty} e^{-\beta \lambda-\frac{1}{\lambda} \Gamma_{t}(G)} \frac{d \lambda}{\lambda^{t}}\right) \\
& =2 e^{-t E(\log G)} E\left\{\left(\frac{\Gamma_{t}(G)}{\beta}\right)^{\frac{1-t}{2}} K_{1-t}\left(2 \sqrt{\beta \Gamma_{t}(G)}\right)\right\} \tag{2.20}
\end{align*}
$$

where $K_{\nu}$ denotes the Bessel-McDonald function with index $\nu$ and where we have used formula 5.10.25 in [Leb], p. 108 and 119.
We now use (2.20) to compute $f_{\Gamma_{t}(1 / G)}$ by inverting its Stieltjes transform (see [Wid]).

$$
\begin{align*}
f_{\Gamma_{t}(1 / G)}(u)= & \frac{1}{2 i \pi} \lim _{\eta \downarrow 0}\left\{E\left(\frac{1}{-u-i \eta+\Gamma_{t}(1 / G)}-\frac{1}{-u+i \eta+\Gamma_{t}(1 / G)}\right)\right\} \\
= & \frac{e^{-t E(\log G)}}{i \pi} E\left(( \frac { \Gamma _ { t } ( G ) } { u } ) ^ { \frac { 1 - t } { 2 } } \left[e^{\frac{i \pi(1-t)}{2}} K_{1-t}\left(2 \sqrt{u \Gamma_{t}(G)} e^{-\frac{i \pi}{2}}\right)\right.\right. \\
& \left.\left.-e^{-\frac{i \pi(1-t)}{2}} K_{1-t}\left(2 \sqrt{u \Gamma_{t}(G)} e^{-\frac{i \pi}{2}}\right)\right]\right) \tag{2.21}
\end{align*}
$$

However, it is well known that (see [Leb], p. 108 and 109) :

- $K_{\nu}=K_{-\nu}$
- $\pi<\operatorname{Arg} z<\frac{\pi}{2} \Rightarrow K_{\nu}(z)=\frac{i \pi}{2} e^{\frac{i \nu \pi}{2}} H_{\nu}^{(1)}\left(z e^{\frac{i \pi}{2}}\right)$
- $\frac{\pi}{2}<\operatorname{Arg} z<\pi \Rightarrow K_{\nu}(z)=-\frac{i \pi}{2} e^{-\frac{i \nu \pi}{2}} H_{\nu}^{(2)}\left(z e^{-\frac{i \pi}{2}}\right)$
where the Hankel functions $H_{\nu}^{(1)}$ and $H_{\nu}^{(2)}$ satisfy ([Leb], p. 108)

$$
H_{\nu}^{(1)}+H_{\nu}^{(2)}=2 J_{\nu}
$$

Plugging these relations into (2.21), we obtain :

$$
f_{\Gamma_{t}(1 / G)}(u)=e^{-t E(\log G)} E\left\{\left(\frac{\Gamma_{t}(G)}{u}\right)^{\frac{1-t}{2}} J_{t-1}\left(2 \sqrt{u \Gamma_{t}(G)}\right)\right\}
$$

ii) We now prove (2.7), which is a consequence of (2.5). Indeed, from (2.5) and (2.6) :

$$
\begin{aligned}
f_{\Gamma_{t}(1 / G)}(u) & =e^{-t E(\log G)} E\left\{\left(\frac{\Gamma_{t}(G)}{u}\right)^{\frac{1-t}{2}} \sum_{k=0}^{\infty} \frac{(-1)^{k}}{\Gamma(k+1) \Gamma(k+t)}\left(u \Gamma_{t}(G)\right)^{k+\frac{t-1}{2}}\right\} \\
& =e^{-t E(\log G)} u^{t-1} E\left\{\sum_{k=0}^{\infty} \frac{(-1)^{k}}{\Gamma(k+1) \Gamma(k+t)}\left(u \gamma_{t} D_{t}(G)\right)^{k}\right\}
\end{aligned}
$$

from (1.53). But, since $E\left(\gamma_{t}^{k}\right)=\frac{\Gamma(k+t)}{\Gamma(t)}$, we have :

$$
\begin{align*}
f_{\Gamma_{t}(1 / G)}(u) & =\frac{e^{-t E(\log G)}}{\Gamma(t)} u^{t-1} E\left(\sum_{k=0}^{\infty} \frac{(-1)^{k}}{k!}\left(u D_{t}(G)\right)^{k}\right) \\
& =\frac{e^{-t E(\log G)}}{\Gamma(t)} u^{t-1} E\left(e^{-u D_{t}(G)}\right) \tag{2.22}
\end{align*}
$$

On the other hand, as we already noticed in point 6 of Remark 2.2, formula (2.8) may be obtained by integrating from 0 to $\infty$ in (2.22).
2.2.c We now prove point 4 of Theorem 2.1.
i) Formula (2.9) is immediate. Indeed, since $\Gamma_{t}(G) \stackrel{(\text { law })}{=} \gamma_{t} D_{t}(G)$ we get :

E\left(e^{-\lambda \Gamma_{t}(G)}\right)=\exp \left(-t \psi_{G}(\lambda)\right)=E\left(\frac{1}{\left(1+\lambda D_{t}(G)\right)^{t}}\right)
$$

Replacing then $\lambda$ by $1 / \lambda$ in this latter formula, we obtain :

\begin{align*}
E\left[\frac{1}{\left(\lambda+D_{t}(G)\right)^{t}}\right] & =\exp \left\{-t\left(\psi_{G}(1 / \lambda)+\log \lambda\right)\right\} \\
& =\exp \left\{-t\left(\psi_{1 / G}(\lambda)-E(\log G)\right)\right\} \tag{2.23}
\end{align*}
$$

from (2.4). We note that (2.8) may also be obtained by taking $\lambda=0$ in (2.23).
ii) We now show (2.10). For this purpose, we shall prove that the two members of (2.10) admit the same Stieltjes transform with index $t$. Indeed :

\int_{0}^{\infty} \frac{e^{-t E(\log G)}}{(\lambda+x)^{t}} x^{t-2} f_{D_{t}(G)}\left(\frac{1}{x}\right) d x=e^{-t E(\log G)} \int_{0}^{\infty} \frac{1}{(1+\lambda x)^{t}} f_{D_{t}(G)}(x) d x
$$

after making the change of variables $y=1 / x$

$$
\begin{align*}
& =e^{-t E(\log G)} E\left(e^{-\lambda \Gamma_{t}(G)}\right) \quad \text { from (1.56) } \\
& =\exp -t\left(E(\log G)+\psi_{G}(\lambda)\right) \tag{2.24}
\end{align*}
$$

whereas:

$$
\begin{align*}
\int_{0}^{\infty} \frac{1}{(\lambda+x)^{t}} f_{D_{t}(1 / G)}(x) d x & =\frac{1}{\lambda^{t}} \int_{0}^{\infty} \frac{1}{\left(1+\frac{x}{\lambda}\right)^{t}} f_{D_{t}(1 / G)}(x) d x \\
& =\exp \left\{-t\left(\log \lambda+\psi_{1 / G}(1 / \lambda)\right)\right\} \quad(\text { from }(1.56)) \\
& =\exp \left\{-t\left(E(\log G)+\psi_{G}(\lambda)\right)\right\} \quad(\text { from }(2.4)) \tag{2.25}
\end{align*}
$$

The comparison of (2.24) and (2.25) and the injectivity of the Stieltjes transform of index $t$ imply (2.10).
iii) We now show (2.10), for $t=1$, by using (2.13). For $t=1$, (2.13) writes :

\begin{equation*}
f_{D_{1}(G)}(x)=\frac{\sin \left(\pi F_{1 / G}(x)\right)}{\pi} e^{-E\left(\left(\log \left|x-\frac{1}{G}\right|\right) 1_{x \neq 1 / G}\right)} \tag{2.26}
\end{equation*}
$$

Thus:

$$
\begin{aligned}
f_{D_{1}(1 / G)}(x) & =\frac{\sin \left(\pi F_{G}(x)\right)}{\pi} e^{-E\left((\log |x-G|) 1_{x \neq G}\right)} \\
& =\frac{\sin \left(\pi F_{G}(x)\right)}{\pi} \exp \left\{-E\left(\log \left(x G\left|\frac{1}{x}-\frac{1}{G}\right|\right) \cdot 1_{x \neq G}\right)\right\} \\
& =\frac{\sin \left(\pi F_{G}(x)\right)}{\pi} \frac{e^{-E(\log G)}}{x} e^{-E\left(\log \left|\frac{1}{x}-\frac{1}{G}\right| 1_{x \neq G}\right)} \\
& =\frac{1}{x} e^{-E(\log G)} f_{D_{1}(G)}(1 / x), \quad \text { from }(2.26)
\end{aligned}
$$

since $\sin \left(\pi F_{G}(x)\right)=\sin \left(\pi\left(1-F_{G}(x)\right)=\sin \left(\pi F_{1 / G}(1 / x)\right)\right.$. It is possible, by using (2.13), to extend this proof for all $t<1$. We leave the details to the interested reader.

### 2.3 A complement to the duality theorem.

Here again, $G$ denotes a r.v. such that $E(|\log G|)<\infty$, and we recall that, for any $t \leq 1 Y_{t}$ denotes a Bernoulli r.v. with parameter $t$ (see (1.41) and (1.42), with $m=t$ and $m^{\prime}=1$ ).
Theorem 2.3. For all $t \in[0,1[$ :

1) The density $f_{D_{1}\left(\frac{G}{Y_{t}}\right)}$ may be expressed in terms of $G$, as:
$f_{D_{1}\left(\frac{G}{Y_{t}}\right)}(x)=\frac{\sin \left(\pi t F_{G}(1 / x)\right)}{\pi} x^{t-1} \exp \left\{-t E\left(\left(\log \left|x-\frac{1}{G}\right|\right) 1_{x \neq \frac{1}{G}}\right)\right\} \quad x>0$,
and when $1 / x$ is in the support of $F_{G}$. Otherwise replace $\sin \left(\pi t F_{G}(1 / x)\right)$ by $\sin (\pi(1-t))$ when $x>0$.
2) The following duality formula holds :

f_{D_{1}\left(\frac{G}{Y_{t}}\right)}(x)=\frac{\sin \left(\pi t F_{G}(1 / x)\right)}{\sin \left(\pi t\left(1-F_{G}(1 / x)\right)\right)} \cdot x^{t-2} f_{D_{1}\left(\frac{1}{G Y_{t}}\right)}\left(\frac{1}{x}\right) \cdot e^{t E(\log G)} \tag{2.28}
\end{equation*}
$$

3) Let $\wedge_{t}:[0, \infty[\longrightarrow[0,1]$ be defined by :

\wedge_{t}(y):=1-\frac{1}{\pi t} \operatorname{arctg}\left(\frac{\sin (\pi t)}{\cos (\pi t)+y}\right) \tag{2.29}
\end{equation*}
$$

Then :

F_{G}(1 / x)=\wedge_{t}\left(\frac{f_{D_{1}\left(\frac{G}{Y_{t}}\right)}(x)}{x^{t-2} f_{D_{1}\left(\frac{1}{G Y_{t}}\right)}\left(\frac{1}{x}\right) e^{t E(\log G)}}\right) \tag{2.30}
\end{equation*}
$$

## Remark 2.4.

1) We note that the right-hand side of (2.30) depends on $t(t \in[0,1[)$, whereas the lefthand side does not depend on $t$.
2) Since (see (1.43)) $D_{1}\left(\frac{1}{G Y_{t}}\right) \stackrel{(\text { law })}{=} \beta_{t, 1-t} \cdot D_{t}(1 / G)$, the knowledge of the law of $D_{t}(1 / G)$ and of that of $D_{t}(G)$, for one $t<1$, allow to determine that of $G$. We shall exploit this fact, in points 2.5 and 2.6 below, to determine the Thorin measure of a Pareto distribution and of a power of a gamma variable.
3) We note that finding an explicit Thorin measure of an arbitrary GGC is akin to finding the Lévy measure of some infinitely divisible random variable. Bondesson([B1],Theorem 4.3 .2 , p. 61), using inversion techniques, obtains an expression for the Thorin measure, but notes that it seldom yields explicit expressions. On the other hand the use of statement 3) of Theorem 2.3 will often lead to tractable expressions for the Thorin measure.
4) We shall prove (see Section 3.1.b) that $\wedge_{t}$ is the cumulative distribution function of a r.v. $Z_{t}$ which we shall describe. On the other hand, some trigonometric computations allow to see that $\Lambda_{t}^{-1}$, the inverse of $\Lambda_{t}$ in the sense of composition of functions, equals :

5) Point 1 of Theorem 2.3 is due to James (see [J]).

### 2.4 Proof of Theorem 2.3.

## 2.4. a We first prove point 1.

As this point has already been established by James (see [J]), we shall only give a quick proof.
We have, from (1.56) :

& =\exp ((t-1) \log \lambda) \cdot e^{t E(\log )} \exp \left(-t \psi_{1 / G}(\lambda)\right) \tag{2.32}
\end{align*}
$$

We then compute $f_{D_{1}\left(\frac{G}{Y_{t}}\right)}$ by inverting its Stieltjes transform:

& \quad \frac{e^{t E(\log G)}}{2 i \pi} \lim _{\eta \downarrow 0}\left\{\exp \left[((t-1) \log (-u-i \eta))-t \psi_{1 / G}(-u-i \eta)\right]\right. \\
& \left.\quad-\exp \left[((t-1) \log (-u+i \eta))-t \psi_{1 / G}(-u+i \eta)\right]\right\} \quad(u>0) \tag{2.33}
\end{align*}
$$

It then suffices to observe that:

\exp (t-1) \log (-u-i \eta) \underset{\eta \downarrow 0_{+}}{\longrightarrow} \exp \{(t-1) \log |u|-i \pi(t-1)\}=u^{t-1} e^{-i \pi(t-1)}
$$

and :

\lim _{\eta \downarrow 0_{+}} \exp \{(t-1) \log (-u+i \eta)\}=u^{t-1} e^{i \pi(t-1)}
$$

as well as :

\begin{aligned}
& t \psi_{1 / G}(-u-i \eta)=t E(\log (1-u G-i \eta G)) \\
= & t E\left(\log (1-u G-i \eta G) 1_{u G<1}+\log (1-u G-i \eta G) 1_{u G>1}\right) \\
\xrightarrow[\eta \downarrow 0_{+}]{\longrightarrow} & t E\left(\log (|1-u G|) 1_{u G \neq 1}-i \pi P(u G>1)\right)
\end{aligned}
$$

whereas :

t \psi_{1 / G}(-u+i \eta) \underset{\eta \backslash 0_{+}}{\longrightarrow} t E\left(\log (|1-u G|) 1_{u G \neq 1}+i \pi P(u G>1)\right.
$$

Then, plugging the values of these different limits in (2.33), we obtain point 1 of Theorem 2.3 .
2.4.b We now prove point 2 of Theorem 2.3.

We deduce from (2.7) that :

& \quad=\frac{\sin \left(\pi t F_{G}(1 / x)\right)}{\pi} x^{t-1} \exp \left\{-t E\left(\log \left(\frac{1}{G}|1-x G|\right) 1_{x G \neq 1}\right)\right\} \\
& \quad=\frac{\sin \left(\pi t F_{G}(1 / x)\right)}{\pi} x^{t-1} e^{t E(\log G)} \exp \left\{-t E\left((\log |1-x G|) 1_{x G \neq 1}\right)\right\} \tag{2.34}
\end{align*}
$$

whereas:

$$
\begin{align*}
& x^{t-2} f_{D_{1}\left(\frac{1}{G Y_{t}}\right)}\left(\frac{1}{x}\right) e^{t E(\log G)}=x^{t-2} \frac{\sin \left(\pi t F_{1 / G}(x)\right)}{\pi} e^{t E(\log G)} \cdot x^{1-t} \\
& \cdot \exp \left\{-t E\left(\log \left(\left|\frac{1}{x}-\frac{1}{G}\right|\right) 1_{x G \neq 1}\right)\right\} \\
& =\frac{1}{x} \frac{\sin \left(\pi t F_{1 / G}(x)\right)}{\pi} e^{t E(\log G)} \exp \left\{-t E\left(\log \left(\frac{1}{x}|1-x G|\right) 1_{x G \neq 1}\right)\right\} \\
& \left.=\frac{\sin \left(\pi t F_{1 / G}(x)\right)}{\pi} x^{t-1} e^{t E(\log G)} \exp \left\{-t E(\log |1-x G|) 1_{x G \neq 1}\right)\right\} \tag{2.35}
\end{align*}
$$

hence, point 2 of Theorem 2.3 follows, by comparison of (2.35) and (2.34).
2.4.c We now prove point 3 of Theorem 2.3.

From (2.28), we obtain :

& \frac{f_{D_{1}\left(\frac{G}{Y_{t}}\right)}(x)}{x^{t-2} f_{D_{1}\left(\frac{1}{G Y_{t}}\right)}\left(\frac{1}{x}\right) e^{t E(\log G)}}=\frac{\sin \left(\pi t F_{G}(1 / x)\right)}{\sin \left(\pi t\left(1-F_{G}(1 / x)\right)\right)}=\wedge_{t}^{-1}\left(F_{G}(1 / x)\right) \\
& \text { with } \quad \wedge_{t}^{-1}(x)=\frac{\sin (\pi t x)}{\sin \pi t(1-x)} \quad(\text { see }(2.31))
\end{aligned}
$$

Then, inverting this formula, since $\wedge_{t} \circ \wedge_{t}^{-1}(x)=x, \quad x \in[0,1]$ we obtain :

F_{G}(1 / x)=\wedge_{t}\left(\frac{f_{D_{1}\left(\frac{G}{Y_{t}}\right)}(x)}{x^{t-2} e^{t E(\log G)} f_{D_{1}\left(\frac{1}{G Y_{t}}\right)}\left(\frac{1}{x}\right)}\right)
$$

### 2.5 Computation of the Thorin measure of a Pareto r.v.

Here is a first application of Theorem 2.3.
2.5.a Let $m>0$ fixed and :

& =\frac{\Gamma(\theta+m)}{\Gamma(\theta) \cdot \Gamma(m)} x^{\theta-1} E\left(e^{-x \gamma_{\theta+m}}\right) \tag{2.38}
\end{align*}
$$

The r.v. $X_{\theta}$ is a GGC r.v. (see Bondesson [B1], p. 59). The rationale of our work is now the following :

- We first compute the Thorin measure associated with $X_{\theta}$.
- Then, letting $\theta$ converge 1 , we shall obtain - as the Thorin measure depends continuously (for the narrow topology) on the law of $X_{\theta}$ (see Bondesson, [B1]) - the Thorin measure associated with the r.v. $X_{1}=\frac{\gamma_{1}}{\gamma_{m}}$, i.e. to a Pareto r.v. with parameter $m(m>0)$.
2.5.b Thorin measure associated with $X_{\theta}, \theta<1$.

Since, from (2.37) :

\sup \left\{\alpha>0 ; \lim _{x \rightarrow 0} \frac{f_{X_{\theta}}(x)}{x^{\alpha-1}}=0\right\}=\theta
$$

we deduce from (1.30) the existence of a r.v. $G_{\theta}$, such that $E\left(\log ^{+}\left(\frac{1}{G_{\theta}}\right)\right)<\infty$ and such that $X_{\theta}$ is a $\left(\theta, G_{\theta}\right)$ GGC r.v. :

\end{equation*}

On the other hand, from (2.7) :

\end{equation*}
$$

Comparing (2.40) and (2.38) yields :

& D_{\theta}\left(1 / G_{\theta}\right) \stackrel{(l a w)}{=} \gamma_{\theta+m} \tag{2.43}
\end{align*}
$$

Since, on the other hand :

D_{1}\left(\frac{1}{G_{\theta} Y_{\theta}}\right) & \stackrel{(l a w)}{=} \beta_{\theta, 1-\theta} \cdot D_{\theta}\left(1 / G_{\theta}\right) & \stackrel{(\text { law })}{=} \beta_{\theta, 1-\theta} \cdot \gamma_{\theta+m} \\
D_{1}\left(\frac{G_{\theta}}{Y_{\theta}}\right) & \stackrel{(\text { law })}{=} \beta_{\theta, 1-\theta} \cdot D_{\theta}\left(G_{\theta}\right) & \stackrel{(\text { law })}{=} \beta_{\theta, 1-\theta} \cdot \frac{1}{\gamma_{m}} \tag{2.45}
\end{array}
$$

we easily deduce from these formulae that :

f_{D_{1}\left(\frac{1}{G_{\theta} Y_{\theta}}\right)}(z) & =\frac{\sin \pi \theta}{\pi \Gamma(\theta+m)} z^{\theta-1} \int_{z}^{\infty} e^{-y} \frac{y^{m+\theta-1}}{(y-z)^{\theta}} d y  \tag{2.46}\\
f_{D_{1}\left(\frac{G_{\theta}}{Y_{\theta}}\right)}(z) & =\frac{\sin \pi \theta}{\pi \Gamma(\theta)} z^{-m-1} \int_{0}^{1} e^{-\frac{y}{z}} y^{m+\theta-1}(1-y)^{-\theta} d y \tag{2.47}
\end{align*}
$$

The Thorin measure of $X_{\theta}$, which equals : $\theta P_{G_{\theta}}(d x)$, where $P_{G_{\theta}}$ is the law of $G_{\theta}$, is then, by applying (2.30) :

\end{equation*}

where, to obtain (2.48), we have used (2.42).
2.5.c Thorin measure of $\frac{\gamma_{1}}{\gamma_{m}} \quad(m>0)$.

By continuity, the r.v. $\frac{\gamma_{1}}{\gamma_{m}}$ is a $(1, G)$ GGC r.v. and its Thorin measure is the law of $G$ whose cumulative distribution function is obtained by letting $\theta$ tend to 1 in (2.48). To obtain this limit, we shall develop several computations.
2.5.i) Development of $\int_{z}^{\infty} e^{-y} \frac{y^{m+\theta-1}}{(y-z)^{\theta}} d y \quad$ as $\beta=1-\theta \rightarrow 0$

& \quad=\frac{e^{-z}}{\beta} \int_{0}^{\infty} e^{-u} u^{\beta}\left[(z+u)^{m-\beta}-(m-\beta)(z+u)^{m-\beta-1}\right] d u
\end{aligned}

with $(\beta=1-\theta)$ and after integrating by parts :

& +e^{-z} \int_{0}^{\infty} e^{-u}(z+u)^{m}\left(\log \frac{u}{1+u}+\frac{1}{z+u}\right) d u+o(\beta) \\
= & \frac{e^{-z} z^{m}}{\beta}+e^{-z} z^{m} \int_{0}^{\infty} e^{-u}\left(1+\frac{u}{z}\right)^{m}\left(\log \frac{u}{1+u}+\frac{1}{z+u}\right) d u+o(\beta)
\end{aligned}
$$

since $\int_{0}^{\infty} e^{-u}(z+u)^{m}\left(1-\frac{m}{z+u}\right) d u=z^{m}$, by integration by parts. Finally :

& \quad=\frac{e^{-z} z^{m}}{\beta} \int_{0}^{1} e^{z u}\left((m-\beta)(1-u)^{m-\beta-1}-z(1-u)^{m-\beta}\right) u^{\beta} d u
\end{aligned}

with $\beta=1-\theta$, and after integrating by parts :

& \underset{\beta \rightarrow 0}{\sim} \frac{e^{-z} z^{m}}{\beta} \int_{0}^{1} e^{z u}(1-u)^{m}\left(\frac{m}{1-u}-z\right) d u+e^{-z} z^{m} \int_{0}^{1} e^{z u}(1-u)^{m} . \\
& \\
& =\frac{e^{-z} z^{m}}{\beta}+e^{-z} z^{m} \widetilde{C}_{m}(z)+o(\beta) \tag{2.51}
\end{align*}
$$

with

\begin{equation*}
\widetilde{C}_{m}(z)=\int_{0}^{1} e^{z u}(1-u)^{m}\left(-\frac{1}{1-u}+\left(\frac{m}{1-u}-z\right) \log \frac{u}{1-u}\right) d u \tag{2.52}
\end{equation*}
$$

since : $\int_{0}^{1} e^{z u}(1-u)^{m}\left(\frac{m}{1-u}-z\right) d u=1$, by integrating by parts.
2.5. iii) Let

\end{equation*}

where $C_{m}(z)$ and $\widetilde{C}_{m}(z)$ are given by (2.50) and (2.52). Hence :

& \underset{\beta \rightarrow 0}{\longrightarrow} \quad 1-\frac{1}{\pi} \operatorname{arctg}\left(\frac{\pi}{C_{m}(z)-\widetilde{C}_{m}(z)}\right)=F(1 / z) \tag{2.56}
\end{align*}
$$

where $F$ is the cumulative distribution function of the Thorin measure associated to the Pareto r.v. $\frac{\gamma_{1}}{\gamma_{m}}$, with parameter $m>0$.
2.6 Thorin measure associated with $\gamma_{1}^{1 / \alpha}, 0<\alpha<1$.

E\left(e^{-\lambda S_{\alpha}}\right)=\exp \left(-\lambda^{\alpha}\right) \quad(\lambda \geq 0) \tag{2.58}
\end{equation*}
$$

From Bondesson ([B1], p. 60), $X_{\alpha}$ is a GGC r.v. Since :

$$
\alpha=\sup \left\{\nu>0, \lim _{x \downarrow 0} \frac{f_{X_{\alpha}}(x)}{x^{\nu-1}}=0\right\}
$$

$X_{\alpha}$ is a $\left(\alpha, G_{\alpha}\right)$ GGC r.v., for a r.v. $G_{\alpha}$ such that : $E\left(\log ^{+}\left(1 / G_{\alpha}\right)\right)<\infty$. Thus :

$$
\begin{equation*}
X_{\alpha} \stackrel{(\text { law })}{=}\left(\gamma_{1}\right)^{1 / \alpha}=\Gamma_{\alpha}\left(G_{\alpha}\right)=\gamma_{\alpha} D_{\alpha}\left(G_{\alpha}\right) \tag{2.59}
\end{equation*}
$$

We shall now devote some effort to finding the law of $G_{\alpha}$, making use in particular of formula (2.10)
From (2.7) :

$$
\begin{equation*}
f_{\Gamma_{\alpha}\left(G_{\alpha}\right)}(x)=\frac{x^{\alpha-1}}{\Gamma(\alpha)} e^{\alpha E\left(\log G_{\alpha}\right)} E\left(e^{-x D_{\alpha}\left(1 / G_{\alpha}\right)}\right) \tag{2.60}
\end{equation*}
$$

we deduce, by comparison with (2.57) :

$$
\begin{equation*}
e^{\alpha E\left(\log G_{\alpha}\right)}=\alpha \Gamma(\alpha)=\Gamma(\alpha+1) \tag{2.61}
\end{equation*}
$$

and

$$
\begin{equation*}
D_{\alpha}\left(1 / G_{\alpha}\right) \stackrel{(\text { law })}{=} S_{\alpha} \tag{2.62}
\end{equation*}
$$

Since :

$$
D_{1}\left(\frac{1}{G_{\alpha} Y_{\alpha}}\right) \stackrel{(l a w)}{=} \beta_{\alpha, 1-\alpha} \cdot D_{\alpha}\left(1 / G_{\alpha}\right) \stackrel{(l a w)}{=} \beta_{\alpha, 1-\alpha} \cdot S_{\alpha}
$$

we deduce that the density of $D_{1}\left(\frac{1}{G_{\alpha} Y_{\alpha}}\right)$ equals :

$$
\begin{equation*}
f_{D_{1}\left(\frac{1}{G_{\alpha} Y_{\alpha}}\right)}(y)=\frac{\sin (\pi \alpha)}{\pi} y^{\alpha-1} \int_{y}^{\infty} \frac{1}{(x-y)^{\alpha}} f_{\alpha}(x) d x \tag{2.63}
\end{equation*}
$$

where $f_{\alpha}$ denotes the density of $S_{\alpha}$. On the other hand, from Chaumont-Yor ([CM], p. 112) :

$$
\begin{equation*}
\gamma_{1}^{1 / \alpha} \stackrel{(l a w)}{=} \frac{\gamma_{1}}{S_{\alpha}} \tag{2.64}
\end{equation*}
$$

hence, since :

$$
\begin{equation*}
\frac{\gamma_{1}}{S_{\alpha}} \stackrel{(l a w)}{=} \gamma_{\alpha} \cdot D_{\alpha}\left(G_{\alpha}\right) \stackrel{(\text { law })}{=} \beta_{\alpha, 1-\alpha} \cdot \gamma_{1} D_{\alpha}\left(G_{\alpha}\right) \stackrel{(l a w)}{=} \gamma_{1} \cdot D_{1}\left(\frac{G_{\alpha}}{Y_{\alpha}}\right) \tag{2.65}
\end{equation*}
$$

we get :

$$
\begin{gather*}
D_{1}\left(\frac{G_{\alpha}}{Y_{\alpha}}\right) \stackrel{(\text { law })}{=} \frac{1}{S_{\alpha}} \quad \text { and }  \tag{2.66}\\
f_{D_{1}\left(\frac{G_{\alpha}}{Y_{\alpha}}\right)}(x)=\frac{1}{x^{2}} f_{\alpha}\left(\frac{1}{x}\right) \tag{2.67}
\end{gather*}
$$

Then, applying (2.30), we get :

$$
\begin{equation*}
F_{1 / G_{\alpha}}\left(\frac{1}{y}\right)=\wedge_{\alpha}\left(\frac{\frac{\Gamma(\alpha+1) \sin (\pi \alpha)}{\pi} \int_{y}^{\infty} \frac{1}{(x-y)^{\alpha}} f_{\alpha}(x) d x}{y f_{\alpha}(y)}\right) \tag{2.68}
\end{equation*}
$$

where, to obtain (2.68), we have used (2.60). This expression (2.68), provides us then with the explicit form of the Thorin measure of $\left(\gamma_{1}\right)^{1 / \alpha}$, which is equal to $P_{G_{\alpha}}$.
2.6.b. We shall now give a more suitable expression of (2.68). From the relations (2.65) and (2.66), we deduce :

$$
\begin{equation*}
\beta_{\alpha, 1-\alpha} \cdot D_{\alpha}\left(G_{\alpha}\right) \stackrel{(l a w)}{=} D_{1}\left(\frac{G_{\alpha}}{Y_{\alpha}}\right)=\frac{1}{S_{\alpha}} \tag{2.69}
\end{equation*}
$$

hence :

$$
\begin{equation*}
\frac{1}{y^{2}} f_{\alpha}\left(\frac{1}{y}\right)=\frac{\sin \pi \alpha}{\pi} y^{\alpha-1} \int_{y}^{\infty} \frac{1}{(z-y)^{\alpha}} f_{D_{\alpha}\left(G_{\alpha}\right)}(z) d z \tag{2.70}
\end{equation*}
$$

But, the density of $D_{\alpha}\left(G_{\alpha}\right)$ may be computed from that of $D_{\alpha}\left(1 / G_{\alpha}\right)$, thanks to (2.10):

$$
f_{D_{\alpha}\left(G_{\alpha}\right)}(x)=x^{\alpha-2} e^{\alpha E\left(\log G_{\alpha}\right)} f_{D_{\alpha}\left(G_{\alpha}\right)}(1 / x)
$$

Now from (2.62) and (2.61), we obtain:

$$
\begin{equation*}
f_{D_{\alpha}\left(G_{\alpha}\right)}(x)=x^{\alpha-2} \Gamma(\alpha+1) f_{\alpha}(1 / x) \tag{2.71}
\end{equation*}
$$

We now note the interesting relationship concerning the law of $S_{\alpha}$.

## Lemma 2.4

Let $0<\alpha<1$, and $S$ denote a positive random variables with density $(f(y), y>0)$ such that:

$$
\begin{equation*}
y f(y)=C E\left[\frac{1}{(y-S)^{\alpha}} 1_{\{S<y\}}\right] \tag{2.72}
\end{equation*}
$$

for some $C>0$. Then, $S$ is a stable ( $\alpha$ ) variable; precisely:

$$
E(\exp \{-\lambda S\})=\exp \left\{-\frac{C \Gamma(1-\alpha)}{\alpha} \lambda^{\alpha}\right\}
$$

We postpone the proof of the Lemma for the moment, and we note that, plugging (2.72) into (2.68), we obtain:

$$
\begin{align*}
& F_{1 / G_{\alpha}}\left(\frac{1}{y}\right) \\
& \quad=\wedge_{\alpha}\left(\frac{E\left(\frac{1}{\left(S_{\alpha}-y\right)^{\alpha}} 1_{S_{\alpha}>y}\right)}{E\left(\frac{1}{\left(y-S_{\alpha}\right)^{\alpha}} 1_{S_{\alpha}<y}\right.}\right) \\
& \quad=1-\frac{1}{\pi \alpha} \operatorname{arctg}\left[\frac{\sin (\pi \alpha) \cdot E\left(\frac{1}{\left(y-S_{\alpha}\right)^{\alpha}} 1_{S_{\alpha}<y}\right)}{\cos (\pi \alpha) \cdot E\left(\frac{1}{\left(y-S_{\alpha}\right)^{\alpha}} 1_{S_{\alpha}<y}\right)+E\left(\frac{1}{\left(S_{\alpha}-y\right)^{\alpha}} 1_{S_{\alpha}>y}\right)}\right] \tag{2.73}
\end{align*}
$$

from (2.29).
Proof of Lemma 2.4 From (2.72), we take the Laplace transform of both sides:

$$
\begin{aligned}
\int_{0}^{\infty} \mathrm{e}^{-\lambda y} y f(y) d y & =C E\left[\int_{S}^{\infty} \frac{e^{-\lambda y}}{(y-S)^{\alpha}} d y\right] \\
& =C E\left[e^{-\lambda S} \int_{0}^{\infty} \frac{e^{-\lambda z}}{z^{\alpha}} d y\right] \\
& =C \Gamma(1-\alpha) \lambda^{\alpha-1} E\left(\mathrm{e}^{-\lambda S}\right)
\end{aligned}
$$

Denoting $\phi(\lambda)=E\left(\mathrm{e}^{-\lambda S}\right)$, we get:

$$
-\phi^{\prime}(\lambda)=C \Gamma(1-\alpha) \lambda^{\alpha-1} \phi(\lambda),
$$

from which we deduce:

$$
\phi(\lambda)=\exp \left\{-\frac{C \Gamma(1-\alpha)}{\alpha} \lambda^{\alpha}\right\} .
$$

## 3 Explicit examples of GGC variables associated with the $\left(\mathbb{G}_{\alpha}, \mathbf{0} \leq \alpha \leq \mathbf{1}\right)$ family.

All the examples discussed in this Section are related to the r.v.'s. ( $\mathbb{G}_{\alpha}, 0 \leq \alpha \leq 1$ ) introduced in [BFRY]. Below, we indicate the properties of these r.v.'s which we shall use. We also recall our notation :

$$
\begin{align*}
& \Gamma_{t}\left(\mathbb{G}_{\alpha}\right)=\gamma_{t} \cdot D_{t}\left(\mathbb{G}_{\alpha}\right) \quad \text { and }  \tag{3.1}\\
& E\left(e^{-\lambda \Gamma_{t}\left(\mathbb{G}_{\alpha}\right)}\right)=\exp \left\{-t \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-x \mathbb{G}_{\alpha}}\right)\right\} \quad(\lambda, t \geq 0) \tag{3.2}
\end{align*}
$$

### 3.1 The family $\left(\mathbb{G}_{\alpha}, 0 \leq \alpha \leq 1\right)$. (see [BFRY]))

3.1.a. For $0<\alpha<1$, the density $f_{\mathbb{G}_{\alpha}}$ of $\mathbb{G}_{\alpha}$ equals :

$$
\begin{equation*}
f_{\mathbb{G}_{\alpha}}(x)=\frac{\alpha \sin (\pi \alpha)}{(1-\alpha) \pi} \frac{x^{\alpha-1}(1-x)^{\alpha-1}}{(1-x)^{2 \alpha}-2(1-x)^{\alpha} x^{\alpha} \cos (\pi \alpha)+x^{2 \alpha}} 1_{[0,1]}(x) \tag{3.3}
\end{equation*}
$$

In particular :

- for $\alpha=1 / 2, \mathbb{G}_{1 / 2}$ follows the arc sine law :

$$
\begin{equation*}
f_{\mathbb{G}_{1 / 2}}(x)=\frac{1}{\pi} \frac{1}{\sqrt{x(1-x)}} 1_{[0,1]}(x), \quad \mathbb{G}_{1 / 2} \stackrel{(\text { law })}{=} \beta_{1 / 2,1 / 2} \tag{3.4}
\end{equation*}
$$

- for $\alpha=1, \mathbb{G}_{1}$ is uniform on $[0,1]$
- for $\alpha=0, \mathbb{G}_{0} \stackrel{(\text { law })}{=} \frac{1}{1+\exp (\pi C)}$
where $C$ is a standard Cauchy variable.
In general, for $0<\alpha<1$ one has :

$$
\begin{align*}
E\left[e^{-\lambda \Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right)}\right] & =\exp \left\{-(1-\alpha) \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-x \mathbb{G}_{\alpha}}\right)\right\} \\
& =(1+\lambda)^{\alpha}-\lambda^{\alpha} \tag{3.7}
\end{align*}
$$

The density $f_{\Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right)}$ of $\Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right)$ equals :

$$
\begin{equation*}
f_{\Gamma_{1-\alpha}\left(G_{\alpha}\right)}(x)=\frac{\alpha}{\Gamma(1-\alpha)} \frac{1}{x^{1+\alpha}}\left(1-e^{-x}\right) 1_{[0, \infty]}(x) \tag{3.8}
\end{equation*}
$$

which may be translated as the following identities in law :

$$
\begin{equation*}
\Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right) \stackrel{(\text { law })}{=} \frac{\gamma_{1-\alpha}}{\beta_{\alpha, 1}} \stackrel{(\text { law })}{=} \frac{\gamma_{1-\alpha}}{U^{1 / \alpha}} \tag{3.9}
\end{equation*}
$$

3.1.b. We note, for $0<\mu<1, S_{\mu}$ and $S_{\mu}^{\prime}$ two independent copies of positive stable ( $\mu$ ) r.v.'s, i.e. :

$$
\begin{equation*}
E\left(e^{-\lambda S_{\mu}}\right)=\exp \left(-\lambda^{\mu}\right) \quad(\lambda \geq 0) \tag{3.10}
\end{equation*}
$$

and, we let :

$$
\begin{equation*}
Z_{\mu}:=\left(\frac{S_{\mu}}{S_{\mu}^{\prime}}\right)^{\mu} \tag{3.11}
\end{equation*}
$$

Then (see [Lam] or [CY], p. 116), the density $f_{Z_{\mu}}$ of $Z_{\mu}$ equals :

$$
\begin{equation*}
f_{Z_{\mu}}(x)=\frac{\sin (\pi \mu)}{\pi \mu} \frac{1}{x^{2}+2 x \cos (\pi \mu)+1} 1_{[0, \infty]}(x) \tag{3.12}
\end{equation*}
$$

and we have :

$$
\begin{equation*}
\mathbb{G}_{\alpha} \stackrel{(\text { law })}{=} \frac{\left(Z_{1-\alpha}\right)^{1 / \alpha}}{1+\left(Z_{1-\alpha}\right)^{1 / \alpha}} \tag{3.13}
\end{equation*}
$$

or equivalently :

$$
\begin{equation*}
\frac{1}{\mathbb{G}_{\alpha}} \stackrel{(\text { law })}{=} 1+\frac{1}{\left(Z_{1-\alpha}\right)^{1 / \alpha}} \stackrel{(\text { law })}{=} 1+\frac{S_{1-\alpha}^{\prime}}{S_{1-\alpha}} \tag{3.14}
\end{equation*}
$$

We note that the cumulative distribution function $F_{Z_{\mu}}$ of $Z_{\mu}$ equals :

$$
\begin{equation*}
F_{Z_{\mu}}(x)=1-\frac{1}{\pi \mu} \operatorname{arctg}\left[\frac{\sin (\pi \mu)}{\cos (\pi \mu)+x}\right] \quad x \geq 0 \tag{3.15}
\end{equation*}
$$

and that its inverse, in the sense of composition of functions, is given by :

$$
\begin{equation*}
F_{Z_{\mu}}^{-1}(x)=\frac{\sin (\pi \mu x)}{\sin (\pi \mu(1-x))} \quad(0 \leq x \leq 1) \tag{3.16}
\end{equation*}
$$

(see Remark 2.4, point 3).
3.1.c. Although this will not be used in the sequel, we indicate a realization of the r.v. $\Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right)$ which has been at the start of [BFRY]. Let $\left(R_{t}, t \geq 0\right)$ denote a Bessel process starting from 0 , with dimension $d=2(1-\alpha)$, with $0<d<2$, or equivalently $0<\alpha<1$. Let, for any $t>0$ :

$$
\begin{equation*}
g_{t}^{(\alpha)}:=\sup \left\{s \leq t ; R_{s}=0\right\}, \quad d_{t}^{(\alpha)}:=\inf \left\{s \geq t, \quad R_{s}=0\right\} \tag{3.17}
\end{equation*}
$$

and let $\mathfrak{e} \stackrel{(\text { law })}{=} \gamma_{1}$ an exponentially distributed r.v., with mean 1 , independent from $\left(R_{t}, t \geq 0\right)$. Then :

$$
\begin{equation*}
\Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right) \stackrel{(\text { law })}{=} d_{\mathfrak{e}}^{(\alpha)}-g_{\mathfrak{e}}^{(\alpha)} \tag{3.18}
\end{equation*}
$$

A more general study of quantities such as the RHS of (3.18), has been developed by M. Winkel [Wink].

### 3.2 Study of the subordinators $\left(\Gamma_{t}\left(\mathbb{G}_{1 / 2}\right), t \geq 0\right)$ and $\left(\Gamma_{t}\left(1 / \mathbb{G}_{1 / 2}\right), t \geq 0\right)$.

In this Section, $\mathbb{G}_{1 / 2}$ is a beta $(1 / 2,1 / 2)$ variable, i.e. : its law is the arc sine distribution. (see (3.4)).

## 3.2.a. Theorem 3.1.

Let $\left(\Gamma_{t}\left(\mathbb{G}_{1 / 2}\right), t \geq 0\right)$ denote the subordinator characterized by :

$$
\begin{equation*}
E\left(e^{-\lambda \Gamma_{t}\left(\mathbb{G}_{1 / 2}\right)}\right)=\exp \left\{-t \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-x \mathbb{G}_{1 / 2}}\right)\right\} \tag{3.19}
\end{equation*}
$$

The following explicit formulae hold:

1. Laplace transform of $\Gamma_{t}\left(\mathbb{G}_{1 / 2}\right)$.

$$
\begin{align*}
& E\left(e^{-\lambda \Gamma_{t}\left(\mathbb{G}_{1 / 2}\right)}\right)=\exp \left\{-t \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} I_{0}\left(\frac{x}{2}\right) e^{-\frac{x}{2}}\right\}  \tag{3.20}\\
& \quad=(\sqrt{1+\lambda}-\sqrt{\lambda})^{2 t}=\left(\frac{1}{\sqrt{1+\lambda}+\sqrt{\lambda}}\right)^{2 t}=(1+2 \lambda+2 \sqrt{\lambda(1+\lambda)})^{-t} \tag{3.21}
\end{align*}
$$

where, in (3.20), $I_{0}$ denotes the modified Bessel function with index 0. (see [Leb], p. 108)
2. Laws of $\Gamma_{t}\left(\mathbb{G}_{1 / 2}\right)$ and of $D_{t}\left(\mathbb{G}_{1 / 2}\right)$.

$$
\begin{equation*}
\Gamma_{t}\left(\mathbb{G}_{1 / 2}\right) \stackrel{(\text { law })}{=} \frac{\gamma_{t}}{\beta_{1 / 2,1 / 2+t}}, \quad D_{t}\left(\mathbb{G}_{1 / 2}\right) \stackrel{(\text { law })}{=} \frac{1}{\beta_{1 / 2,1 / 2+t}} \stackrel{(\text { law })}{=} 1+\frac{\gamma_{t+1 / 2}}{\gamma_{1 / 2}} \tag{3.22}
\end{equation*}
$$

The density of $f_{\Gamma_{t}\left(\mathbb{G}_{1 / 2}\right)}$ equals:

$$
\begin{equation*}
f_{\Gamma_{t}\left(\mathbb{G}_{1 / 2}\right)}(x)=\frac{2^{2 t} \Gamma(1+t)}{2 \pi \Gamma(2 t)} x^{t-1}\left(\int_{0}^{1} e^{-x y}(y(1-y))^{t-1 / 2} d y\right) 1_{[0, \infty]}(x) \tag{3.23}
\end{equation*}
$$

## 3. Wiener-Gamma representation of $\Gamma_{t}\left(\mathbb{G}_{1 / 2}\right)$.

For any $t>0$ :

$$
\begin{equation*}
\Gamma_{t}\left(\mathbb{G}_{1 / 2}\right) \stackrel{(\text { law })}{=} \int_{0}^{t} \frac{d \gamma_{u}}{\sin ^{2}\left(\frac{\pi u}{2 t}\right)} \stackrel{(\text { law })}{=} \int_{0}^{t} \frac{d \gamma_{u}}{\cos ^{2}\left(\frac{\pi u}{2 t}\right)} \tag{3.24}
\end{equation*}
$$

Here is the dual version of Theorem 3.1:
Theorem 3.1*. (Cifarelli and Melilli, $[\mathrm{CM}])$ Let $\left(\Gamma_{t}\left(1 / \mathbb{G}_{1 / 2}\right), t \geq 0\right)$ denote the subordinator characterized by :

$$
\begin{equation*}
E\left(e^{-\lambda \Gamma_{t}\left(1 / \mathbb{G}_{1 / 2}\right)}\right)=\exp \left\{-t \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-\frac{x}{\mathbb{G}_{1 / 2}}}\right)\right\} \tag{3.25}
\end{equation*}
$$

Then :

1. Laplace transform of $\Gamma_{t}\left(1 / \mathbb{G}_{1 / 2}\right)$.

$$
\begin{equation*}
E\left(e^{-\lambda \Gamma_{t}\left(1 / \mathbb{G}_{1 / 2}\right)}\right)=\left(\frac{2}{1+\sqrt{1+\lambda}}\right)^{2 t} \quad(\lambda, t \geq 0) \tag{3.26}
\end{equation*}
$$

2. Laws of $\Gamma_{t}\left(1 / \mathbb{G}_{1 / 2}\right)$ and of $D_{t}\left(1 / \mathbb{G}_{1 / 2}\right)$.

$$
\begin{equation*}
\Gamma_{t}\left(1 / \mathbb{G}_{1 / 2}\right) \stackrel{(\text { law })}{=} \gamma_{t} \cdot \beta_{t+1 / 2, t+1 / 2}, \quad D_{t}\left(1 / \mathbb{G}_{1 / 2}\right) \stackrel{(\text { law })}{=} \beta_{t+1 / 2, t+1 / 2} \tag{3.27}
\end{equation*}
$$

The density $f_{\Gamma_{t}\left(1 / \mathbb{G}_{1 / 2}\right)}$ of $\Gamma_{t}\left(\frac{1}{\mathbb{G}_{1 / 2}}\right)$ equals :

$$
\begin{equation*}
f_{\Gamma_{t}\left(1 / \mathbb{G}_{1 / 2}\right)}(x)=\frac{t \cdot 2^{2 t}}{\Gamma(1 / 2+t) \sqrt{\pi}} x^{t-1}\left(\int_{0}^{1} e^{-\frac{x}{y}} \frac{(1-y)^{t-1 / 2}}{\sqrt{y}} d y\right) 1_{[0, \infty]}(x) \tag{3.28}
\end{equation*}
$$

3. Wiener-Gamma representation of $\Gamma_{t}\left(1 / \mathbb{G}_{1 / 2}\right)$.

For any $t \geq 0$ :

$$
\begin{equation*}
\Gamma_{t}\left(\frac{1}{\mathbb{G}_{1 / 2}}\right) \stackrel{(l a w)}{=} \int_{0}^{t} \cos ^{2}\left(\frac{\pi u}{2 t}\right) d \gamma_{u} \stackrel{(l a w)}{=} \int_{0}^{t} \sin ^{2}\left(\frac{\pi u}{2 t}\right) d \gamma_{u} \tag{3.29}
\end{equation*}
$$

## Remark 3.2.

1) Theorem 3.1*. has been obtained by Cifarelli and Melilli [CM]. It would be possible to prove Theorem 3.1 by first using Theorem 3.1* and then by applying the duality Theorem 2.1. In fact, we shall operate conversely, as we shall first prove Theorem 3.1, then we shall show that Theorem 3.1* may be deduced from it, due to the duality Theorem 2.1.
2) By comparing formula (3.20) with formula (1.76), we deduce :

$$
\left(\mathcal{J}_{t}^{(0)}, t \geq 0\right) \stackrel{(l a w)}{=}\left(\frac{1}{2} \Gamma_{t}\left(\mathbb{G}_{1 / 2}\right), t \geq 0\right)
$$

3) We come back to (3.26) and we write :

$$
\begin{align*}
\frac{2}{1+\sqrt{1+\lambda}} & =\frac{1}{1+\frac{1}{2}(\sqrt{1+\lambda}-1)}=\int_{0}^{\infty} e^{-u-\frac{u}{2}(\sqrt{1+\lambda}-1)} d u \\
& =E\left(\exp -\lambda S_{1 / 2}^{(1)}\left(\frac{\mathfrak{e}}{2}\right)\right) \tag{3.30}
\end{align*}
$$

where $\left(S_{1 / 2}^{(1)}(t), t \geq 0\right)$ denotes the stable (1/2) subordinator, Esscher transformed, with the Esscher transformation with parameter 1 (see [Sat]). In (3.30), $\mathfrak{e}$ denotes a standard exponential r.v. independent from $\left(S_{1 / 2}^{(1)}(t), t \geq 0\right)$. Hence :

\left(\frac{2}{1+\sqrt{1+\lambda}}\right)^{2 t}=E\left(\exp \left(-\lambda S_{1 / 2}^{(1)}\left(\frac{\gamma_{2 t}}{2}\right)\right)\right) \tag{3.31}

where the subordinators $\left(S_{1 / 2}^{(1)}(t), t \geq 0\right)$ and $\left(\gamma_{2 t}, t \geq 0\right)$ featured in (3.31) being assumed independent. This formula led James and Yor to consider, more generally, the subordinator $\left(S_{1 / 2}^{(\nu)}\left(\gamma_{t}\right), t \geq 0\right)$. In the article [JY], the following is obtained :

\left(\Gamma_{t}\left(\mathbb{G}_{1 / 2}\right), t \geq 0\right) \stackrel{(l a w)}{=}\left(S_{1 / 2}\left(\gamma_{2 t}\right)+\widetilde{S}_{1 / 2}^{(1)}\left(\gamma_{2 t}\right), t \geq 0\right) \tag{3.32}
\end{equation*}
$$

where, on the right-hand side of (3.32), the three subordinators $S_{1 / 2}, \widetilde{S}_{1 / 2}^{(1)}$ and $\gamma$ are assumed independent, and $\left(S_{1 / 2}(t), t \geq 0\right) \stackrel{(\text { law })}{=}\left(\widetilde{S}_{1 / 2}(t), t \geq 0\right)$.

## 3.2.b. Proof of Theorem 3.1.

i) We already prove (3.21). In fact, (3.21) follows immediately from (3.6), since :

& =(\sqrt{1+\lambda}-\sqrt{\lambda})^{2 t}=\left(\frac{1}{\sqrt{1+\lambda}+\sqrt{\lambda}}\right)^{2 t}=\left(\frac{1}{1+2 \lambda+2 \sqrt{\lambda(1+\lambda)}}\right)^{t}
\end{aligned}
$$

ii) We now prove (3.20), which is equivalent to :

\begin{equation*}
E\left(e^{-x \mathbb{G}_{1 / 2}}\right)=e^{-\frac{x}{2}} I_{0}\left(\frac{x}{2}\right), \quad x \geq 0 \tag{3.33}
\end{equation*}
$$

From the Lipschitz-Hankel formula (see [Wat] or [MNY], Th. 1.1) :

\begin{equation*}
\nu \int_{0}^{\infty} e^{-a x} I_{\nu}(x) \frac{d x}{x}=\left(a+\sqrt{a^{2}-1}\right)^{-\nu} \quad(a \geq 1, \nu>0) \tag{3.34}
\end{equation*}
$$

we deduce :

$$
\begin{equation*}
\nu \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) e^{-\frac{x}{2}} I_{\nu}\left(\frac{x}{2}\right) \frac{d x}{x}=1-(2 \lambda+1+2 \sqrt{\lambda(1+\lambda)})^{-\nu} \tag{3.35}
\end{equation*}
$$

then, letting $\nu \rightarrow 0$ in (3.35) :

$$
\begin{equation*}
\int_{0}^{\infty}\left(1-e^{-\lambda x}\right) e^{-\frac{x}{2}} I_{0}\left(\frac{x}{2}\right) \frac{d x}{x}=\log (2 \lambda+1+2 \sqrt{\lambda(1+\lambda)}) \tag{3.36}
\end{equation*}
$$

Hence :

$$
\begin{aligned}
E\left(e^{-\lambda \Gamma_{1}\left(\mathbb{G}_{1 / 2}\right)}\right) & =\exp \left\{-\int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-x \mathbb{G}_{1 / 2}}\right)\right\} \\
& =\left(\frac{1}{\sqrt{1+\lambda}+\sqrt{\lambda}}\right)^{2} \\
& =\frac{1}{2 \lambda+1+2 \sqrt{\lambda(1+\lambda)}}=\exp \left\{-\int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} e^{-\frac{x}{2}} I_{0}\left(\frac{x}{2}\right)\right\}
\end{aligned}
$$

This formula, which is of interest by itself, shall not be used in the sequel of this proof.
iii) We now prove point 2 of Theorem 3.1.

For this purpose, we shall use the following property of hypergeometric functions: (see [Leb], p. 238). Let, for $\alpha, \delta, \gamma$ reals (cf [Leb], p. 239):

& =E\left(\left(1-z \beta_{\delta, \gamma-\delta}\right)^{-\alpha}\right) \tag{3.38}
\end{align*}

Lemma 3.3. Let $a, b, c$ three positive reals. Then :

\begin{align*}
\text { 1) } E\left(e^{-\lambda \frac{\gamma_{a}}{\beta_{b, c}}}\right) & =\frac{\Gamma(a+b) \Gamma(b+c)}{\Gamma(b)(\Gamma(a+b+c)} \frac{1}{\lambda^{a}} F\left(a, a+b, a+b+c ;-\frac{1}{\lambda}\right) & & (\lambda \geq 0)  \tag{3.39}\\
\text { 2) } & E\left(e^{-\lambda \gamma_{a} \beta_{b, c}}\right) & =F(a, b, b+c ;-\lambda) &
\end{align*}
$$

## Proof of Lemma 3.3.

Since $E\left(e^{-\lambda \gamma_{a}}\right)=\frac{1}{(1+\lambda)^{a}}, \quad$ we have :

$$
\begin{aligned}
E\left(e^{-\lambda \frac{\gamma_{a}}{\beta_{b, c}}}\right) & =E\left[\left(\frac{1}{1+\frac{\lambda}{\beta_{b, c}}}\right)^{a}\right] \\
& =\frac{1}{B(b, c)} \int_{0}^{1} \frac{x^{a} x^{b-1}}{(x+\lambda)^{a}}(1-x)^{c-1} d x
\end{aligned}
$$

(by definition of the beta $(b, c)$ law)

$$
\begin{aligned}
& =\frac{B(a+b, c)}{B(b, c)} \frac{1}{B(a+b, c)} \frac{1}{\lambda^{a}} \int_{0}^{1} \frac{x^{a+b-1}(1-x)^{c-1}}{\left(1+\frac{x}{\lambda}\right)^{a}} d x \\
& =\frac{\Gamma(a+b) \Gamma(b+c)}{\Gamma(b) \Gamma(a+b+c)} \frac{1}{\lambda^{a}} E\left(\left(1+\frac{\beta_{a+b, c}}{\lambda}\right)^{-a}\right),
\end{aligned}
$$

hence point 1 of Lemma 3.3, from (3.38). Point 2 of Lemma 3.3 may be obtained from similar arguments.
We now end the proof of point 2 of Theorem 3.1. From Lemma 3.3, we have :

& =\frac{\Gamma\left(t+\frac{1}{2}\right) \Gamma(t+1)}{\Gamma\left(\frac{1}{2}\right) \Gamma(2 t+1)} \frac{1}{\lambda^{t}}\left(\frac{1+\sqrt{1+\frac{1}{\lambda}}}{2}\right)^{-2 t} \tag{3.41}
\end{align*}
$$

since (see [Leb], p. 259) :

$$
F\left(\alpha, \alpha+\frac{1}{2}, 2 \alpha+1 ; z\right)=\left(\frac{1+\sqrt{1-z}}{2}\right)^{-2 \alpha}
$$

Using Legendre's duplication formula ([Leb], p. 4) :

$$
\Gamma\left(t+\frac{1}{2}\right) \Gamma(t+1)=2^{-2 t} \sqrt{\pi}(2 t+1) \quad\left(\text { with } \Gamma\left(\frac{1}{2}\right)=\sqrt{\pi}\right)
$$

we obtain :

$$
E\left(e^{-\lambda \frac{\gamma_{t}}{\beta_{1}^{2}, \frac{t}{2}+t}}\right)=\left(\frac{1}{\sqrt{1+\lambda}+\sqrt{\lambda}}\right)^{2 t}=E\left(e^{-\lambda \Gamma_{t}\left(\mathbb{G}_{1 / 2}\right)}\right)
$$

from (3.21). Hence :

$$
\begin{equation*}
\frac{\gamma_{t}}{\beta_{\frac{1}{2}, \frac{1}{2}+t}} \stackrel{(l a w)}{=} \Gamma_{t}\left(\mathbb{G}_{1 / 2}\right) \tag{3.42}
\end{equation*}
$$

The form of the density of $\Gamma_{t}\left(\mathbb{G}_{1 / 2}\right)$ follows easily from (3.42).
iv) From Proposition 1.3 and (1.18), to show point 3 amounts to compute the inverse of the cumulative distribution function of $\mathbb{G}_{1 / 2}$. Now, we have :

F_{\mathbb{G}_{1 / 2}}(x) & :=P\left(\mathbb{G}_{1 / 2} \leq x\right)=\frac{1}{\pi} \int_{0}^{x} \frac{d u}{\sqrt{u(1-u)}} \\
& =\frac{2}{\pi} \operatorname{Arcsin}(\sqrt{x}) \quad x \geq 0
\end{aligned}
$$

so that $F_{\mathbb{G}_{1 / 2}}^{-1}(y)=\sin ^{2}\left(\frac{\pi y}{2}\right) \quad(0 \leq y \leq 1)$.

## 3.2.c Proof of Theorem 3.1*.

i) We prove point 1 , in two different ways :

- A direct proof.

We deduce, as a particular case of the beta-gamma algebra, that :

$$

Thus:

\int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-\frac{x}{G_{1 / 2}}}\right) & =E\left(\int_{0}^{\gamma_{1 / 2}} \frac{d x}{x}\left(1-e^{-\lambda x}\right) d x\right) \\
& =\int_{0}^{1} \frac{d u}{u}\left(1-E\left(\exp \left(-\lambda u \gamma_{1 / 2}\right)\right)\right) \\
& =\int_{0}^{1} \frac{d u}{u}\left(1-\frac{1}{(1+\lambda u)^{1 / 2}}\right)=2(\log (\sqrt{1+\lambda}+1)-\log 2)
\end{aligned}
$$

hence :

$$
\begin{aligned}
E\left(e^{\left.-\lambda \Gamma_{t\left(\frac{1}{G_{1 / 2}}\right)}\right)}\right. & =\exp \left\{-2 t \log \left(\frac{\sqrt{1+\lambda}+1}{2}\right)\right\} \\
& =\left(\frac{2}{1+\sqrt{1+\lambda}}\right)^{2 t}=\left(\frac{4}{2+\lambda+2 \sqrt{1+\lambda}}\right)^{t}
\end{aligned}
$$

- We may also prove (3.26) with the help of the duality Theorem 2.1. Indeed, from (2.4) :

$$
\begin{aligned}
E\left(e^{\left.-\lambda \Gamma_{t\left(\frac{(1)}{\mathbb{G}_{1 / 2}}\right)}\right)}\right. & =E\left(\exp -\frac{1}{\lambda} \Gamma_{t}\left(\mathbb{G}_{1 / 2}\right)\right) \cdot \frac{\exp -t E\left(\log \mathbb{G}_{1 / 2}\right)}{\lambda^{t}} \\
& =\frac{4^{t}}{\left(1+\frac{2}{\lambda}+2 \sqrt{\frac{1}{\lambda}\left(1+\frac{1}{\lambda}\right)}\right)^{t}} \cdot \frac{1}{\lambda^{t}}
\end{aligned}
$$

from (3.21) and since $E\left(\log \mathbb{G}_{1 / 2}\right)=-\log 4$, from (2.7) and (3.22). Thus :

$$
E\left(e^{-\lambda \Gamma_{t}\left(\frac{1}{\mathbb{G}_{1 / 2}}\right)}\right)=\frac{4^{t}}{(2+\lambda+2 \sqrt{1+\lambda})^{t}}=\left(\frac{2}{1+\sqrt{1+\lambda}}\right)^{2 t}
$$

ii) We now prove point 2 of Theorem 3.1*.

Of course, it would be possible to use point 2 of Lemma 3.3 to make this proof, in the same manner that we have used point 1 of this Lemma 3.3 to show point 2 of Theorem 3.1. In fact, we prefer to use formula (2.7) of the duality Theorem 2.1. We have :

& =\frac{4^{t}}{\Gamma(t)} u^{t-1} E\left(e^{-\frac{u}{\beta_{1}, \frac{1}{2}+t}}\right) \quad(\text { from }(3.22)) \tag{3.44}
\end{align*}
$$

Considering now the Laplace transform of the two sides of (3.44) we obtain :

$$
\begin{align*}
E\left(e^{-\lambda \Gamma_{t}\left(\frac{1}{G_{1} / 2}\right)}\right) & =\frac{4^{t}}{\Gamma(t)} E\left(\int_{0}^{\infty} e^{-\lambda u} u^{t-1} e^{-\frac{u}{\beta_{2}, \frac{1}{2}+t}} d u\right) \\
& =\frac{4^{t}}{\Gamma(t)} E\left[\left(\frac{\beta_{\frac{1}{2}, \frac{1}{2}+t}}{1+\lambda \beta_{\frac{1}{2}, \frac{1}{2}+t}}\right)^{t}\right] \\
& =\frac{4^{t} B\left(t+\frac{1}{2}, t+\frac{1}{2}\right)}{B\left(\frac{1}{2}, \frac{1}{2}+t\right)} E\left[\left(\frac{1}{1+\lambda \beta_{t+\frac{1}{2}, \frac{1}{2}+t}}\right)^{t}\right] \tag{3.45}
\end{align*}
$$

Note that, by taking $\lambda=0$ in (3.45), we get :

$$
\frac{4^{t} B\left(t+\frac{1}{2}, t+\frac{1}{2}\right)}{B\left(\frac{1}{2}, t+\frac{1}{2}\right)}=1
$$

(which may also be recovered from the duplication formula for the Gamma function). Hence :

E\left(e^{-\lambda \Gamma_{t}\left(\frac{1}{G_{1 / 2}}\right)}\right)=E\left[\left(\frac{1}{1+\lambda \beta_{t+1 / 2, t+1 / 2}}\right)^{t}\right]=E\left(e^{-\lambda \gamma_{t} \beta_{t+1 / 2, t+1 / 2}}\right)
$$

The other formulae of Theorem 3.1* are now easily obtained. In particular, since : $F_{1 / \mathbb{G}_{1 / 2}}^{-1}(u)=\frac{1}{F_{\mathbb{G}_{1 / 2}}^{-1}(1 / u)}=\frac{1}{\sin ^{2} \frac{\pi u}{2}}$, we have, from Proposition 1.3 :

3.3 Study of the r.v.'s $\Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right)$ and $\Gamma_{1-\alpha}\left(1 / \mathbb{G}_{\alpha}\right), \quad 0<\alpha<1$
3.3.a. Theorem 3.4. Let, for $0<\alpha<1,\left(\Gamma_{t}\left(\mathbb{G}_{\alpha}\right), t \geq 0\right)$ the subordinator characterized by :

E\left(e^{-\lambda \Gamma_{t}\left(\mathbb{G}_{\alpha}\right)}\right)=\exp \left\{-t \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-x \mathbb{G}_{\alpha}}\right)\right\} \tag{3.46}
\end{equation*}
$$

We then have the following explicit formulae :

1. Laplace transform of $\Gamma_{t}\left(\mathbb{G}_{\alpha}\right)$.

$$
\begin{equation*}
E\left(e^{-\lambda \Gamma_{t}\left(\mathbb{G}_{\alpha}\right)}\right)=\left((1+\lambda)^{\alpha}-\lambda^{\alpha}\right)^{\frac{t}{1-\alpha}} \quad(\lambda, t \geq 0) \tag{3.47}
\end{equation*}
$$

2. Distributions of $\Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right)$ and of $D_{1-\alpha}\left(\mathbb{G}_{\alpha}\right)$.

$$
\begin{align*}
& \Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right) \stackrel{(\text { law })}{=} \frac{\gamma_{1-\alpha}}{\beta_{\alpha, 1}} \stackrel{(\text { law })}{=} \frac{\gamma_{1-\alpha}}{U^{1 / \alpha}}  \tag{3.48}\\
& D_{1-\alpha}\left(\mathbb{G}_{\alpha}\right) \stackrel{(\text { law })}{=} \frac{1}{\beta_{\alpha, 1}} \stackrel{(\text { law })}{=} \frac{1}{U^{1 / \alpha}} \stackrel{(\text { law })}{=} 1+\frac{\gamma_{1}}{\gamma_{\alpha}} \tag{3.49}
\end{align*}
$$

(where $\frac{\gamma_{1}}{\gamma_{\alpha}}$ is, by definition, a Pareto r.v. with parameter $\alpha$ ). The density $f_{\Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right)}$ of $\Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right)$ equals :

f_{\Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right)}(x)=\frac{\alpha}{\Gamma(1-\alpha)} \frac{1}{x^{1+\alpha}}\left(1-e^{-x}\right) 1_{[0, \infty[ }(x) \tag{3.50}
\end{equation*}
$$

## 3. Wiener-Gamma representation of $\Gamma_{t}\left(\mathbb{G}_{\alpha}\right)$.

For every $t \geq 0$ and $0<\alpha<1$ :

\begin{align*}
\Gamma_{t}\left(\mathbb{G}_{\alpha}\right) & \stackrel{(\text { law })}{=} \int_{0}^{t}\left[1+\left(\frac{\sin \left(\pi(1-\alpha)\left(\frac{t-u}{t}\right)\right)}{\sin \left(\pi(1-\alpha) \frac{u}{t}\right)}\right)^{1 / \alpha}\right] d \gamma_{u}  \tag{3.51}\\
& \stackrel{(\text { law })}{=} \int_{0}^{t}\left[1+\left(\frac{\sin \left(\pi(1-\alpha) \frac{u}{t}\right)}{\sin \left(\pi(1-\alpha)\left(\frac{t-u}{t}\right)\right)}\right)^{1 / \alpha}\right] d \gamma_{u}
\end{align*}
$$

In particular, for $t=1-\alpha$ :

$$
\begin{equation*}
\Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right) \stackrel{(\text { law })}{=} \int_{0}^{1-\alpha}\left[1+\left(\frac{\sin (\pi u)}{\sin \pi(1-\alpha-u)}\right)^{1 / \alpha}\right] d \gamma_{u} \tag{3.52}
\end{equation*}
$$

We note that, for $\alpha=1 / 2$, formula (3.52) coïncides with (3.24). The dual version of Theorem 3.4 is :
Theorem 3.4*. Let $0<\alpha<1$ and let $\left(\Gamma_{t}\left(1 / \mathbb{G}_{\alpha}\right), t \geq 0\right)$ the subordinator characterized by :

\begin{equation*}
E\left(e^{-\lambda \Gamma_{t}\left(1 / \mathbb{G}_{\alpha}\right)}\right)=\exp \left\{-t \int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-\frac{x}{\mathbb{G}_{\alpha}}}\right)\right\} \tag{3.53}
\end{equation*}
$$

Then :

1. Laplace transform of $\Gamma_{t}\left(1 / \mathbb{G}_{\alpha}\right)$.

$$
\begin{equation*}
E\left(e^{-\lambda \Gamma_{t}\left(1 / \mathbb{G}_{\alpha}\right)}\right)=\left(\frac{1}{\alpha} \frac{(1+\lambda)^{\alpha}-1}{\lambda}\right)^{\frac{t}{1-\alpha}} \tag{3.54}
\end{equation*}
$$

2. Laws of $\Gamma_{1-\alpha}\left(1 / \mathbb{G}_{\alpha}\right)$ and of $D_{1-\alpha}\left(1 / \mathbb{G}_{\alpha}\right)$.

$$
\begin{equation*}
\Gamma_{1-\alpha}\left(1 / \mathbb{G}_{\alpha}\right) \stackrel{(l a w)}{=} \gamma_{1-\alpha} \cdot U, \quad D_{1-\alpha}\left(1 / \mathbb{G}_{\alpha}\right) \stackrel{(l a w)}{=} U \tag{3.55}
\end{equation*}
$$

(we note that the law of $D_{1-\alpha}\left(1 / \mathbb{G}_{\alpha}\right)$ does not depend on $\alpha$, and it may be compared with (3.27) : $\left.\beta_{1,1}=U\right)$. The density $f_{\Gamma_{1-\alpha}\left(1 / \mathbb{G}_{\alpha}\right)}$ of $\Gamma_{1-\alpha}\left(1 / \mathbb{G}_{\alpha}\right)$ equals :

\begin{equation*}
f_{\Gamma_{1-\alpha}\left(1 / \mathbb{G}_{\alpha}\right)}(x)=\frac{1}{\Gamma(1-\alpha)} \frac{1}{x^{\alpha}}\left(\int_{1}^{\infty} e^{-x y} \frac{d y}{y^{\alpha+1}}\right) 1_{[0, \infty[ }(x) \tag{3.56}
\end{equation*}
$$

3. Wiener-Gamma representation of $\Gamma_{t}\left(1 / \mathbb{G}_{\alpha}\right)$.

For every $t \geq 0$ :

$$
\begin{align*}
\Gamma_{t}\left(\frac{1}{\mathbb{G}_{\alpha}}\right) & \stackrel{(\text { law })}{=} \int_{0}^{t} \frac{d \gamma_{u}}{1+\left(\frac{\sin \left(\pi(1-\alpha)\left(\frac{t-u}{t}\right)\right)}{\sin \left(\pi(1-\alpha) \frac{u}{t}\right)}\right)^{1 / \alpha}}  \tag{3.57}\\
& \stackrel{(\text { law })}{=} \int_{0}^{t} \frac{d \gamma_{u}}{1+\left(\frac{\sin \left(\pi(1-\alpha) \frac{u}{t}\right)}{\sin \left(\pi(1-\alpha)\left(\frac{t-u}{t}\right)\right)}\right)^{1 / \alpha}} \tag{3.58}
\end{align*}
$$

## Remark 3.5.

1) Formula (3.51) was originally obtained by T. Fujita and M. Yor (see [FY]).
2) We deduce from Proposition 1.6 :

$$
\begin{equation*}
E\left(D_{1-\alpha}\left(\frac{1}{\mathbb{G}_{\alpha}}\right)\right)=E\left(\mathbb{G}_{\alpha}\right)=E(U)=\frac{1}{2} \quad(\text { from }(3.55)) \tag{3.59}
\end{equation*}
$$

Of course, we may verify directly that :

3) In [BFRY], Section 4.2.1, the positive variables $X_{\alpha, 1}$ whose Laplace transforms equal :

X_{\alpha, 1} \stackrel{(\text { law })}{=} \Gamma_{1-\alpha}\left(\frac{1}{\mathbb{G}_{\alpha}}\right) \tag{3.61}
\end{equation*}
$$

4) Since $\Gamma_{1-\alpha}\left(1 / \mathbb{G}_{\alpha}\right) \stackrel{(\text { law })}{=} \gamma_{1-\alpha} \cdot U$ and $\Gamma_{1-\alpha}\left(\mathbb{G}_{\alpha}\right) \stackrel{(l a w)}{=} \frac{\gamma_{1-\alpha}}{U^{1 / \alpha}}$ the relations (3.51) and (3.57)
may also be written as :

$$
\begin{aligned}
\frac{1}{U^{1 / \alpha}}-1 & \stackrel{(\text { law })}{=} \int_{0}^{1-\alpha}\left(\frac{\sin (\pi u)}{\sin (\pi(1-\alpha-u))}\right)^{1 / \alpha} d_{u}\left(D_{u}^{(1-\alpha)}\right) \\
& \stackrel{(\text { law })}{=} \int_{0}^{1-\alpha}\left(\frac{\sin (\pi(1-\alpha-u))}{\sin (\pi u)}\right)^{1 / \alpha} d_{u}\left(D_{u}^{(1-\alpha)}\right)
\end{aligned}
$$

and

$$
\begin{align*}
U & \stackrel{(\text { law })}{=} \int_{0}^{1-\alpha} \frac{d_{u}\left(D_{u}^{(1-\alpha)}\right)}{1+\left(\frac{\sin (\pi(1-\alpha-u))}{\sin (\pi u)}\right)^{1 / \alpha}} \\
& \stackrel{(\text { law })}{=} \int_{0}^{1-\alpha} \frac{d_{u}\left(D_{u}^{(1-\alpha)}\right)}{1+\left(\frac{\sin (\pi u)}{\sin \pi(1-\alpha-u)}\right)^{1 / \alpha}} \tag{3.62}
\end{align*}
$$

In particular, for $\alpha=\frac{1}{2}$, one finds :

U \stackrel{(\text { law })}{=} \int_{0}^{1 / 2} \cos ^{2}(\pi u) d_{u}\left(D_{u}^{(1 / 2)}\right) \stackrel{(\text { law })}{=} \int_{0}^{1 / 2} \sin ^{2}(\pi u) d_{u}\left(D_{u}^{(1 / 2)}\right)
$$

## 3.3.b. Proof of Theorem 3.4.

i) Point 1) is an immediate consequence of (3.6) and point 2 ) of (3.7), as may be shown after some elementary computations.
ii) We now prove point 3. From Proposition 1.3, it amounts to compute $F_{\mathbb{G}_{\alpha}}$ and its inverse. However, from (3.12) and (3.11), we find, successively :

F_{\mathbb{G}_{\alpha}}(x)=F_{Z_{1-\alpha}}\left(\left(\frac{x}{1-x}\right)^{\alpha}\right) \quad(0 \leq x \leq 1) \tag{3.63}
\end{equation*}
$$

hence :

$$
\begin{equation*}
F_{\mathbb{G}_{\alpha}}^{-1}(x)=\frac{\left(F_{Z_{1-\alpha}}^{-1}(x)\right)^{1 / \alpha}}{1+\left(F_{Z_{1-\alpha}}^{-1}(x)\right)^{1 / \alpha}} \tag{3.64}
\end{equation*}
$$

then :

$$
\begin{align*}
F_{Z_{1-\alpha}}(x) & =P\left(Z_{1-\alpha} \leq x\right)=\frac{\sin \pi(1-\alpha)}{\pi(1-\alpha)} \int_{0}^{x} \frac{d y}{y^{2}+2 y(\cos \pi(1-\alpha))+1} \\
& =1-\frac{1}{\pi(1-\alpha)} \operatorname{arctg}\left(\frac{\sin \pi(1-\alpha)}{\cos \pi(1-\alpha)+x}\right)  \tag{3.65}\\
& =\wedge_{1-\alpha}(x) \quad \text { with the notation of }(2.29)
\end{align*}
$$

and, from (3.15) :

$$
\begin{equation*}
F_{Z_{1-\alpha}}^{-1}(x)=\frac{\sin (\pi(1-\alpha) x)}{\sin (\pi(1-\alpha)(1-x))} \tag{3.66}
\end{equation*}
$$

hence, plugging (3.66) in (3.64), we obtain :

$$
\begin{equation*}
\frac{1}{F_{\mathbb{G}_{\alpha}}^{-1}(x)}=1+\left(\frac{\sin (\pi(1-\alpha)(1-x))}{\sin (\pi(1-\alpha) x)}\right)^{1 / \alpha} \tag{3.67}
\end{equation*}
$$

which, thanks to Proposition 1.3, proves point 3) of Theorem 3.4.

## 3.3.c. Proof of Theorem 3.4*.

We use the duality theorem. From formula (2.7) :

E\left(\log \mathbb{G}_{\alpha}\right)=\frac{\log \alpha}{1-\alpha} \tag{3.69}
\end{equation*}
$$

Then, using this time (2.4) :

$$
\begin{aligned}
E\left(e^{-\lambda \Gamma_{t}\left(\frac{1}{\mathbb{G}_{\alpha}}\right)}\right) & =\exp \left\{-t\left(E\left(\log \mathbb{G}_{\alpha}\right)+\log \lambda+\psi_{\mathbb{G}_{\alpha}}\left(\frac{1}{\lambda}\right)\right)\right\} \\
& =\left[\exp \left(-\frac{t}{1-\alpha} \log \alpha\right)\right] \frac{1}{\lambda^{t}}\left[\left(1+\frac{1}{\lambda}\right)^{\alpha}-\left(\frac{1}{\lambda}\right)^{\alpha}\right]^{\frac{t}{1-\alpha}}
\end{aligned}
$$

from (3.69) and (3.47) :

$$
\begin{equation*}
=\left[\frac{1}{\alpha} \frac{(1+\lambda)^{\alpha}-1}{\lambda}\right]^{\frac{t}{1-\alpha}} \tag{3.70}
\end{equation*}
$$

which establishes (3.54). The density of $\Gamma_{1-\alpha}\left(\frac{1}{\mathbb{G}_{\alpha}}\right)$ may be computed from the density formula (2.7) and the knowledge of the law of $D_{1-\alpha}\left(\mathbb{G}_{\alpha}\right) \stackrel{(\text { law })}{=} \frac{1}{U^{1 / \alpha}}$, given by (3.49). All the formulae in point 2 of Theorem $3.4^{*}$ follow easily from the explicit expression of $f_{\Gamma_{1-\alpha}\left(\frac{1}{G_{\alpha}}\right)}$, and point 3 of Theorem 3.4* follows from :

F_{1 / \mathbb{G}_{\alpha}}^{-1}(y) \cdot F_{\mathbb{G}_{\alpha}}^{-1}(1-y)=1,
$$

and from Proposition 1.3.

### 3.4 Study of the subordinators $\left(\Gamma_{t}\left(\mu+\mathbb{G}_{0}\right), t \geq 0\right)$ and $\left(\Gamma_{t}\left(\frac{1}{\mu+\mathbb{G}_{0}}\right), t \geq 0\right)$

We recall the following formula, which was established in [BFRY] (see formulae (3.11) and (3.9) in [BFRY]) :

This formula was obtained in [BFRY] by "letting $\alpha$ tend to 0 in the study of the r.v.'s $\mathbb{G}_{\alpha} "$. Here, $\mathbb{G}_{0}$ satisfies (see (3.5)):

E\left(e^{-\lambda \Gamma_{t}\left(\mu+\mathbb{G}_{0}\right)}\right)=\left(\frac{\log \left(1+\frac{1}{\lambda+\mu}\right)}{\log \left(1+\frac{1}{\mu}\right)}\right)^{t} \tag{3.74}
\end{equation*}
$$

2. Laws of $\Gamma_{1}\left(\mu+\mathbb{G}_{0}\right)$ and $D_{1}\left(\mu+\mathbb{G}_{0}\right)$.

The densities of $\Gamma_{1}\left(\mu+\mathbb{G}_{0}\right)$ and $D_{1}\left(\mu+\mathbb{G}_{0}\right)$ equal:

$$
\begin{align*}
& f_{\Gamma_{1}\left(\mu+\mathbb{G}_{0}\right)}(x)=\frac{1}{\log \left(1+\frac{1}{\mu}\right)} e^{-\mu x} \frac{1-e^{-x}}{x} 1_{[0, \infty[ }(x)  \tag{3.75}\\
& f_{D_{1}\left(\mu+G_{0}\right)}(x)=\frac{1}{\log \left(1+\frac{1}{\mu}\right)} \frac{1}{x} 1_{\left[\frac{1}{\mu+1}, \frac{1}{\mu}\right]}(x) \tag{3.76}
\end{align*}
$$

3. Wiener-Gamma representation of $\Gamma_{t}\left(\mu+\mathbb{G}_{0}\right)$.

For every $t \geq 0$ :

$$
\begin{equation*}
\Gamma_{t}\left(\mu+\mathbb{G}_{0}\right) \stackrel{(l a w)}{=} \int_{0}^{t} \frac{1+\exp \left(\operatorname{cotg}\left(\frac{\pi u}{t}\right)\right)}{1+\mu\left(1+\exp \left(\operatorname{cotg}\left(\frac{\pi u}{t}\right)\right)\right)} d \gamma_{u} \tag{3.77}
\end{equation*}
$$

Here is the dual version of Theorem 3.6.
Theorem 3.6*. Let $\mu \geq 0$ and $\left(\Gamma_{t}\left(\frac{1}{\mu+\mathbb{G}_{0}}\right), t \geq 0\right)$ denote the subordinator characterized by :

## 1. Laplace transform of $\Gamma_{t}\left(\frac{1}{\mu+\mathbb{G}_{0}}\right)$.

\begin{equation*}
E\left[e^{-\lambda \Gamma_{t}\left(\frac{1}{\mu+\epsilon_{0}}\right)}\right]=\left[\frac{1}{\lambda} \log \left(\frac{1+\lambda(1+\mu)}{1+\lambda \mu}\right)\right]^{t} \tag{3.79}
\end{equation*}
$$

2. Laws of $\Gamma_{1}\left(\frac{1}{\mu+\mathbb{G}_{0}}\right)$ and $D_{1}\left(\frac{1}{\mu+\mathbb{G}_{0}}\right)$.

$$
\begin{equation*}
\Gamma_{1}\left(\frac{1}{\mu+\mathbb{G}_{0}}\right) \stackrel{(\text { law })}{=} \mathfrak{e}(U+\mu), \quad D_{1}\left(\frac{1}{\mu+\mathbb{G}_{0}}\right) \stackrel{(\text { law })}{=} U+\mu \tag{3.80}
\end{equation*}
$$

In particular, for $\mu=0$ :

$$
\begin{equation*}
\Gamma_{1}\left(\frac{1}{\mathbb{G}_{0}}\right) \stackrel{(l a w)}{=} \mathfrak{e} \cdot U, \quad D_{1}\left(\frac{1}{\mathbb{G}_{0}}\right) \stackrel{(l a w)}{=} U \tag{3.81}
\end{equation*}
$$

The density of $\Gamma_{1}\left(\frac{1}{\mu+\mathbb{G}_{0}}\right)$ equals:

$$
\begin{equation*}
f_{\Gamma_{1}\left(\frac{1}{\mu+\epsilon_{0}}\right)}(x)=\left(\int_{0}^{1} \frac{1}{\mu+y} \exp \left(-\frac{x}{\mu+y}\right) d y\right) 1_{[0, \infty[ }(x) \tag{3.82}
\end{equation*}
$$

## 3. Wiener-Gamma representation of $\Gamma_{t}\left(\frac{1}{\mu+\mathbb{G}_{0}}\right)$.

For every $\mu \geq 0$ and $t \geq 0$ :

$$
\begin{equation*}
\Gamma_{t}\left(\frac{1}{\mu+\mathbb{G}_{0}}\right) \stackrel{(\text { law })}{=} \int_{0}^{t} \frac{1+\mu\left(1+\exp \left(-\operatorname{cotg} \frac{\pi u}{t}\right)\right)}{1+\exp \left(-\operatorname{cotg} \frac{\pi u}{t}\right)} d \gamma_{u} \tag{3.83}
\end{equation*}
$$

## Remark 3.7.

1) We may take $\mu=0$ in the statement of Theorem $3.6^{*}$, since $E\left(\log ^{+}\left(\mathbb{G}_{0}\right)\right)<\infty$, but not in that of Theorem 3.6.
2) Formula (3.79), with $\mu=0$, was obtained by Bondesson ([B1], Ex. 3.3.1, p. 42) and the relation $D_{1}\left(\frac{1}{\mathbb{G}_{0}}\right) \stackrel{(\text { law })}{=} U$ has been obtained, independently, by Diaconis and Freedman ([DF], Ex. 7.4, p. 74) and by Cifarelli and Melilli ([CM], Ex. 2, p. 1393).
3) The formula $D_{1}\left(\frac{1}{\mathbb{G}_{0}}\right) \stackrel{(\text { law })}{=} U$ may be obtained by letting $\alpha \longrightarrow 0$, in (3.55) and formula $\Gamma_{1}\left(\frac{1}{\mathbb{G}_{0}}\right)=\mathfrak{e} . U$ is formula (3.55) with $\alpha=0$.

& =\frac{1}{\log \left(1+\frac{1}{\mu}\right)} \int_{\lambda+\mu-1}^{\lambda+\mu} d v \int_{0}^{\infty} e^{-x(1+v)} d x \\
& =\frac{1}{\log \left(1+\frac{1}{\mu}\right)} \int_{0}^{\infty} e^{-x} d x \int_{\lambda+\mu-1}^{\lambda+\mu} \exp (-x v) d v \\
& =\frac{1}{\log \left(1+\frac{1}{\mu}\right)} \int_{0}^{\infty} e^{-(\lambda+\mu) x} \frac{1-e^{-x}}{x} d x
\end{aligned}
$$

On the other hand, formula (3.76), which yields the density of $f_{D_{1}\left(\mu+\mathbb{G}_{0}\right)}$ follows from :

\begin{aligned}
& E\left[e^{-\lambda \Gamma_{1}\left(\mu+\mathbb{G}_{0}\right)}\right]=\frac{\log \left(1+\frac{1}{\lambda+\mu}\right)}{\log \left(1+\frac{1}{\mu}\right)}=E\left(\frac{1}{1+\lambda D_{1}\left(\mu+\mathbb{G}_{0}\right)}\right) \\
& \frac{1}{\log \left(1+\frac{1}{\mu}\right)} \int_{\frac{1}{\mu+1}}^{\frac{1}{\mu}} \frac{d x}{x} \cdot \frac{1}{1+\lambda x} \quad\left(\text { after writing } \frac{1}{x(1+\lambda x)}=\frac{1}{x}-\frac{\lambda}{1+\lambda x}\right)
\end{aligned}
$$

Then, the last point in Theorem 3.6 follows, with the help of (3.72), from :

\begin{align*}
F_{\mu+\mathbb{G}_{0}}^{-1}(y) & =\mu+\frac{1}{1+\exp \operatorname{tg}\left(\frac{\pi}{2}(1-2 y)\right)} \\
& =\frac{1+\mu(\exp (\operatorname{cotg}(\pi y))+1)}{1+\exp \operatorname{cotg}(\pi y)} \tag{3.84}
\end{align*}
$$

## Proof of Theorem 3.6*.

It may be proven by using the duality theorem. From (2.7) and (3.75) :

E\left(e^{-\lambda \Gamma_{t}\left(\frac{1}{\mu+G_{0}}\right)}\right) & =E\left(e^{-\frac{1}{\lambda} \Gamma_{t}\left(\mu+G_{0}\right)}\right) \cdot \frac{1}{\lambda^{t}} \cdot e^{-t E\left(\log \left(\mu+\mathbb{G}_{0}\right)\right)} \\
& =\left(\frac{\log \left(1+\frac{1}{\mu}\right)}{\lambda}\right)^{t} \cdot\left(\frac{\log \left(1+\frac{1}{\frac{1}{\lambda}+\mu}\right)}{\log \left(1+\frac{1}{\mu}\right)}\right)^{t}
\end{aligned}
$$

(from (3.85) and (3.79))

$$
=\left[\frac{1}{\lambda} \log \left(\frac{1+\lambda(1+\mu)}{1+\lambda \mu}\right)\right]^{t}
$$

We now compute the density of $\Gamma_{1}\left(\frac{1}{\mu+\mathbb{G}_{0}}\right)$ by using (2.7) :

$$
\begin{aligned}
f_{\Gamma_{1}\left(\frac{1}{\mu+\mathbb{G}_{0}}\right)}(x) & =e^{-E\left(\log \left(\mu+\mathbb{G}_{0}\right)\right)} E\left(e^{-x D_{1}\left(\mu+\mathbb{G}_{0}\right)}\right) \\
& =\log \left(1+\frac{1}{\mu}\right) \cdot \int_{\frac{1}{\mu+1}}^{\frac{1}{\mu}} \frac{1}{y \log \left(1+\frac{1}{\mu}\right)} e^{-x y} d y
\end{aligned}
$$

(from (3.85) and (3.76))

$$
\begin{equation*}
=\int_{0}^{1} \frac{1}{\mu+y} e^{-\frac{x}{\mu+y}} d y \tag{3.86}
\end{equation*}
$$

Formula (3.80) now follows easily from (3.86).
We deduce, from Proposition 1.6, that :

\end{equation*}

2. Laws of $\Gamma_{1}\left(\mathbb{G}_{1}\right)$ and $D_{1}\left(\mathbb{G}_{1}\right)$.

The expressions of the densities of $\Gamma_{1}\left(\mathbb{G}_{1}\right)$ and $D_{1}\left(\mathbb{G}_{1}\right)$ are :

f_{D_{1}\left(G_{1}\right)}(x) & =\frac{\sin \left(\frac{\pi}{x}\right)}{\pi(x-1)^{1-\frac{1}{x}}} 1_{[1, \infty[ }(x) \tag{3.90}
\end{align*}
$$

3. Wiener-Gamma representation of $\Gamma_{t}\left(\mathbb{G}_{1}\right)$.

For every $t \geq 0$ :

\end{equation*}

2. Laws of $\Gamma_{1}\left(1 / \mathbb{G}_{1}\right)$ and $D_{1}\left(1 / \mathbb{G}_{1}\right)$.

The densities of $\Gamma_{1}\left(1 / \mathbb{G}_{1}\right)$ and $D_{1}\left(1 / \mathbb{G}_{1}\right)$ equal :

& f_{\Gamma_{1}\left(1 / \mathbb{G}_{1}\right)}(x)=\frac{e}{\pi}\left(\int_{0}^{1} e^{-\frac{x}{y}} \frac{\sin (\pi y) d y}{y^{y+1}(1-y)^{1-y}}\right) 1_{[0, \infty[ }(x)  \tag{3.94}\\
& f_{D_{1}\left(1 / \mathbb{G}_{1}\right)}(x)=\frac{e \sin (\pi x)}{\pi} \frac{1}{x^{x}(1-x)^{1-x}} 1_{[0,1]}(x) \tag{3.95}
\end{align*}
$$

3. Wiener-Gamma representation of $\Gamma_{t}\left(1 / \mathbb{G}_{1}\right)$.

For every $t \geq 0$ :

\begin{equation*}
\Gamma_{t}\left(1 / \mathbb{G}_{1}\right) \stackrel{(l a w)}{=} \frac{1}{t} \int_{0}^{t}(t-u) d \gamma_{u} \stackrel{(l a w)}{=} \frac{1}{t} \int_{0}^{t} u d \gamma_{u} \tag{3.96}
\end{equation*}
$$

## Remark 3.9.

1) Theorem $3.8^{*}$, and in particular formula (3.95), are due to P. Diaconis and J. Kemperman [DK]. Formula (3.95) may also be found in ([CY], Ex. 4.4, p. 98) corrected with multiplication by $e$ in that formula.
2) $i$ ) A r.v. $Z$, which takes values on $\mathbb{R}$, is said to be a Luria-Delbrück r.v. if it satisfies :

from Frullani's integral. (3.88) now follows from the comparison of (3.104) and (3.105).

& =\int_{1}^{\infty} \frac{d u}{u^{2}} \log \left(1+\frac{\lambda}{u}\right)
\end{aligned}
$$

(from Frullani's formula (see [Leb], p. 6, and (1.3) above )).

$$
=\int_{0}^{1} \log (1+\lambda w) d w=\frac{1}{\lambda}((1+\lambda) \log (1+\lambda)-\lambda)
$$

Thus :

\begin{aligned}
E\left(e^{-\lambda \Gamma_{1}\left(1 / \mathbb{G}_{1}\right)}\right) & =\exp \left\{-\int_{0}^{\infty}\left(1-e^{-\lambda x}\right) \frac{d x}{x} E\left(e^{-\frac{x}{\mathbb{G}_{1}}}\right)\right\} \\
& =\exp \left\{-\frac{1}{\lambda}((1+\lambda) \log (1+\lambda)-\lambda)\right\}=\frac{e}{(1+\lambda)^{\frac{1+\lambda}{\lambda}}} .
\end{aligned}
$$

We may also show (3.93) with the help of the duality Theorem :

& =\frac{\sin \left(\frac{\pi}{x}\right)}{\pi(x-1)^{1-\frac{1}{x}}} 1_{[1, \infty[ }(x)
\end{aligned}

## Interpolation between the subordinators $\left(\Gamma_{t}(1 / G), t \geq 0\right)$ and $\left(\gamma_{t}, t \geq 0\right)$.

Let $\left(\Gamma_{t}\left(\sigma_{u}(G)\right), t \geq 0\right)$ denote the subordinator defined by :

Thus, the family of subordinators $\left(\Gamma_{t}\left(\sigma_{u}(G)\right), t \geq 0\right)$ interpolates, as $u$ describes $\mathbb{R}_{+}$, between $\left(\Gamma_{t}(1 / G), t \geq 0\right)$ and $\left(\gamma_{t}, t \geq 0\right)$.
The aim of this appendix is to show that one may compute "explicitly" the Laplace transform, the density, and the Wiener-Gamma representation of the r.v.'s $\Gamma_{t}\left(\sigma_{u}(G)\right)$ in terms of those of $\left(\Gamma_{t}(G), t \geq 0\right)$, for every $u \geq 0$.

\end{align*}

\Gamma_{t}\left(\sigma_{u}(G)\right) \stackrel{(\text { law })}{=} \int_{0}^{t} \frac{d \gamma_{s}}{\sigma_{u}\left[F_{G}^{-1}\left(1-\frac{s}{t}\right)\right]} \stackrel{(\text { law })}{=} \int_{0}^{t} \frac{d \gamma_{s}}{\sigma_{u}\left[F_{G}^{-1}\left(\frac{s}{t}\right)\right]} \tag{3.113}
\end{equation*}
$$

3) The density $f_{\Gamma_{t}\left(\sigma_{u}(G)\right)}$ of $\Gamma_{t}\left(\sigma_{u}(G)\right)$, equals:

& =\frac{e^{-x \tanh u-t k_{u}}}{\cosh u} E\left\{e^{-\Gamma_{t}(G) \tanh u}\left(\frac{\Gamma_{t}(G)}{x}\right)^{\frac{1-t}{2}} \cdot J_{t-1}\left(\frac{2 \sqrt{y \Gamma_{t}(G)}}{\cosh u}\right)\right\} 1_{x>0} \\
& =x^{t-1} \frac{e^{-x \tanh u-t k_{u}}}{\Gamma(t)} E\left[\left(\cosh u+D_{t}(G) \sinh u\right)^{-t} e^{-\frac{x D_{t(G)}}{\cosh u\left(\cosh h+D_{t}(G) \sinh u\right.}}\right] \tag{3.114}
\end{align*}
$$

## Remark A.2.

1. For $u=0$, we have : $\sigma_{0}(G)=\frac{1}{G}, k_{0}=E(\log G)$ and the preceding formulae and indeed those of Theorem 2.1.

\text { with } k(\sigma):=E\left(\frac{G}{a G+b}\right) \tag{3.117}
\end{equation*}

We observe that (3.116) and (3.117) follow immediately from :

& =E\left[\log \frac{(c \lambda+a) G}{a G+d}\right] .

$E\left(\int_{-\tanh u}^{\infty} e^{-\lambda \Gamma_{t}\left(\sigma_{u}(G)\right)-\beta \lambda} d \lambda\right)=e^{-t k_{u}} E\left(\int_{-\tanh u}^{\infty} e^{-\Gamma_{t}(G) \sigma_{u}(\lambda)-\beta \lambda} \frac{d \lambda}{(\lambda \cosh u+\sinh u)^{t}}\right)$
Making, on the LHS of (3.119) the change of variable : $\lambda \cosh u+\sinh u=\mu$, we obtain :

$$
\begin{aligned}
& E\left[\frac{1}{\left(\beta+\Gamma_{t}\left(\sigma_{u}(G)\right)\right.} e^{(\tanh u)\left(\Gamma_{t}\left(\sigma_{u}(G)\right)+\beta\right)}\right] \\
& =\frac{e^{-t k_{u}}}{\cosh u} E\left[e^{-\Gamma_{t}(G) \tanh u+\beta \tanh u} \int_{0}^{\infty} \frac{e^{-\frac{1}{\cosh u}\left(\frac{\Gamma_{t}(G)}{\mu}+\beta \mu\right)}}{\mu^{t}} d \mu\right]
\end{aligned}
$$

Thus, after simplifying by $\exp (\beta \tanh u)$ and using formula 5.10 .25 , p. 109 in [Leb], we obtain :

$$
\begin{aligned}
& E\left[\frac{1}{\left(\beta+\Gamma_{t}\left(\sigma_{u}(G)\right)\right.} e^{\tanh u \Gamma_{t}\left(\sigma_{u}(G)\right)}\right] \\
& =\frac{2 e^{-t k_{u}}}{\cosh u} E\left[e^{-\Gamma_{t}(G) \tanh u}\left(\frac{\Gamma_{t}(G)}{\beta}\right)^{\frac{1-t}{2}} \cdot K_{1-t}\left(\frac{2 \sqrt{\beta \Gamma_{t}(G)}}{\cosh u}\right)\right]
\end{aligned}
$$

We then use the inversion formula of the Stieltjes transform, and thanks to a very similar computation to the one made in section 2.2.b, we arrive to the identity :

$$
e^{x \tanh u} f_{\Gamma_{t}\left(\sigma_{u}(G)\right)}(x)=\frac{e^{-t k_{u}}}{\cosh u} E\left[e^{-\Gamma_{t}(G) \tanh u}\left(\frac{\Gamma_{t}(G)}{x}\right)^{\frac{1-t}{2}} J_{t-1}\left(\frac{2 \sqrt{x \Gamma_{t}(G)}}{\cosh u}\right)\right]
$$

then to (3.116), by using the series development of $J_{t-1}$ :

$$
f_{\Gamma_{t}\left(\sigma_{u}(G)\right)}(x)=\frac{e^{-x \tanh u-t k_{u}} x^{t-1}}{\Gamma(t)} E\left\{\left(\cosh u+D_{t}(G) \sinh u\right)^{-t} e^{-\frac{x D_{t}(G)}{\cosh u\left(\cosh u+D_{t}(G) \tanh u\right)}}\right\}
$$

Remark A.3. Formulae (3.114) and (3.115), in the more general situation when : $\sigma(G)=$ $\frac{a G+b}{c G+d}$ become :

f_{\Gamma_{t}(\sigma(G))}(x)=\frac{e^{-x \frac{a}{c}-t k(\sigma)}}{c} E\left(e^{-\frac{d}{c} \Gamma_{t}(G)}\left(\frac{\Gamma_{t}(G)}{x}\right)^{\frac{1-t}{2}} J_{t-1}\left(\frac{2 \sqrt{x \Gamma_{t}(G)}}{c}\right)\right) \tag{3.120}
\end{equation*}
$$

where $k(\sigma)$ is given by (3.117), and :

f_{\Gamma_{t}(\sigma(G))}(x)=\frac{x^{t-1}}{\Gamma(t)} e^{-x \frac{a}{c}-t k(\sigma)} E\left\{\left(c+d D_{t}(G)\right)^{-t} e^{\left.-\frac{x D_{t(G)}}{c\left(c+d D_{t}(G)\right.}\right)}\right\} \tag{3.121}
\end{equation*}
