# A subdiffusive behaviour of recurrent random walk in random environment on a regular tree

#### Abstract

Summary. We are interested in the random walk in random environment on an infinite tree. Lyons and Pemantle [11] give a precise recurrence/transience criterion. Our paper focuses on the almost sure asymptotic behaviours of a recurrent random walk $\left(X_{n}\right)$ in random environment on a regular tree, which is closely related to Mandelbrot [13]'s multiplicative cascade. We prove, under some general assumptions upon the distribution of the environment, the existence of a new exponent $\nu \in\left(0, \frac{1}{2}\right]$ such that $\max _{0 \leq i \leq n}\left|X_{i}\right|$ behaves asymptotically like $n^{\nu}$. The value of $\nu$ is explicitly formulated in terms of the distribution of the environment.


Keywords. Random walk, random environment, tree, Mandelbrot's multiplicative cascade.

## 1 Introduction

Random walk in random environment (RWRE) is a fundamental object in the study of random phenomena in random media. RWRE on $\mathbb{Z}$ exhibits rich regimes in the transient case (Kesten, Kozlov and Spitzer [6]), as well as a slow logarithmic movement in the recurrent case (Sinai 21]). On $\mathbb{Z}^{d}$ (for $d \geq 2$ ), the study of RWRE remains a big challenge to mathematicians (Sznitman [22], Zeitouni [23]). The present paper focuses on RWRE on a regular
rooted tree, which can be viewed as an infinite-dimensional RWRE. Our main result reveals a rich regime à la Kesten-Kozlov-Spitzer, but this time even in the recurrent case; it also strongly suggests the existence of a slow logarithmic regime à la Sinai.

Let $\mathbb{T}$ be a b-ary tree ( $\mathrm{b} \geq 2$ ) rooted at $e$. For any vertex $x \in \mathbb{T} \backslash\{e\}$, let $\overleftarrow{x}$ denote the first vertex on the shortest path from $x$ to the root $e$, and $|x|$ the number of edges on this path (notation: $|e|:=0$ ). Thus, each vertex $x \in \mathbb{T} \backslash\{e\}$ has one parent $\overleftarrow{x}$ and b children, whereas the root $e$ has b children but no parent. We also write $\overleftarrow{\widehat{x}}$ for the parent of $\overleftarrow{x}$ (for $x \in \mathbb{T}$ such that $|x| \geq 2)$.

Let $\omega:=(\omega(x, y), x, y \in \mathbb{T})$ be a family of non-negative random variables such that $\sum_{y \in \mathbb{T}} \omega(x, y)=1$ for any $x \in \mathbb{T}$. Given a realization of $\omega$, we define a Markov chain $X:=\left(X_{n}, n \geq 0\right)$ on $\mathbb{T}$ by $X_{0}=e$, and whose transition probabilities are

$$
P_{\omega}\left(X_{n+1}=y \mid X_{n}=x\right)=\omega(x, y) .
$$

Let $\mathbf{P}$ denote the distribution of $\omega$, and let $\mathbb{P}(\cdot):=\int P_{\omega}(\cdot) \mathbf{P}(\mathrm{d} \omega)$. The process $X$ is a $\mathbb{T}$ valued RWRE. (By informally taking $\mathrm{b}=1, X$ would become a usual RWRE on the half-line $\mathbb{Z}_{+}$.)

For general properties of tree-valued processes, we refer to Peres 18 and Lyons and Peres [12]. See also Duquesne and Le Gall [2] and Le Gall [7] for continuous random trees. For a list of motivations to study RWRE on a tree, see Pemantle and Peres [16], p. 106.

We define

$$
\begin{equation*}
A(x):=\frac{\omega(\overleftarrow{x}, x)}{\omega(\overleftarrow{x}, \overleftarrow{x})}, \quad x \in \mathbb{T},|x| \geq 2 \tag{1.1}
\end{equation*}
$$

Following Lyons and Pemantle [11], we assume throughout the paper that $(\omega(x, \bullet))_{x \in \mathbb{T} \backslash\{e\}}$ is a family of i.i.d. non-degenerate random vectors and that $(A(x), x \in \mathbb{T},|x| \geq 2)$ are identically distributed. We also assume the existence of $\varepsilon_{0}>0$ such that $\omega(x, y) \geq \varepsilon_{0}$ if either $x=\overleftarrow{y}$ or $y=\overleftarrow{x}$, and $\omega(x, y)=0$ otherwise; in words, $\left(X_{n}\right)$ is a nearest-neighbour walk, satisfying an ellipticity condition.

Let $A$ denote a generic random variable having the common distribution of $A(x)$ (for $|x| \geq 2)$. Define

$$
\begin{equation*}
p:=\inf _{t \in[0,1]} \mathbf{E}\left(A^{t}\right) . \tag{1.2}
\end{equation*}
$$

We recall a recurrence/transience criterion from Lyons and Pemantle ( 11$]$, Theorem 1 and Proposition 2).

Theorem A (Lyons and Pemantle [11]) With $\mathbb{P}$-probability one, the walk $\left(X_{n}\right)$ is recurrent or transient, according to whether $p \leq \frac{1}{\mathrm{~b}}$ or $p>\frac{1}{\mathrm{~b}}$. It is, moreover, positive recurrent if $p<\frac{1}{\mathrm{~b}}$.

We study the recurrent case $p \leq \frac{1}{\mathrm{~b}}$ in this paper. Our first result, which is not deep, concerns the positive recurrent case $p<\frac{1}{\mathrm{~b}}$.

Theorem 1.1 If $p<\frac{1}{b}$, then

$$
\begin{equation*}
\lim _{n \rightarrow \infty} \frac{1}{\log n} \max _{0 \leq i \leq n}\left|X_{i}\right|=\frac{1}{\log [1 /(q \mathrm{~b})]}, \quad \mathbb{P} \text {-a.s. } \tag{1.3}
\end{equation*}
$$

where the constant $q$ is defined in (2.1), and lies in ( $0, \frac{1}{\mathrm{~b}}$ ) when $p<\frac{1}{\mathrm{~b}}$.

Despite the warning of Pemantle [15] ("there are many papers proving results on trees as a somewhat unmotivated alternative ...to Euclidean space"), it seems to be of particular interest to study the more delicate situation $p=\frac{1}{\mathrm{~b}}$ that turns out to possess rich regimes. We prove that, similarly to the Kesten-Kozlov-Spitzer theorem for transient RWRE on the line, $\left(X_{n}\right)$ enjoys, even in the recurrent case, an interesting subdiffusive behaviour.

To state our main result, we define

$$
\begin{align*}
\kappa & :=\inf \left\{t>1: \mathbf{E}\left(A^{t}\right)=\frac{1}{\mathrm{~b}}\right\} \in(1, \infty], \quad(\inf \emptyset=\infty)  \tag{1.4}\\
\psi(t) & :=\log \mathbf{E}\left(A^{t}\right), \quad t \geq 0 \tag{1.5}
\end{align*}
$$

We use the notation $a_{n} \approx b_{n}$ to denote $\lim _{n \rightarrow \infty} \frac{\log a_{n}}{\log b_{n}}=1$.
Theorem 1.2 If $p=\frac{1}{\mathrm{~b}}$ and if $\psi^{\prime}(1)<0$, then

$$
\begin{equation*}
\max _{0 \leq i \leq n}\left|X_{i}\right| \approx n^{\nu}, \quad \mathbb{P} \text {-a.s. } \tag{1.6}
\end{equation*}
$$

where $\nu=\nu(\kappa)$ is defined by

$$
\nu:=1-\frac{1}{\min \{\kappa, 2\}}= \begin{cases}(\kappa-1) / \kappa, & \text { if } \kappa \in(1,2]  \tag{1.7}\\ 1 / 2 & \text { if } \kappa \in(2, \infty] .\end{cases}
$$

Remark. (i) It is known (Menshikov and Petritis [14) that if $p=\frac{1}{b}$ and $\psi^{\prime}(1)<0$, then for $\mathbf{P}$-almost all environment $\omega,\left(X_{n}\right)$ is null recurrent.
(ii) For the value of $\kappa$, see Figure 1. Under the assumptions $p=\frac{1}{b}$ and $\psi^{\prime}(1)<0$, the value of $\kappa$ lies in $(2, \infty]$ if and only if $\mathbf{E}\left(A^{2}\right)<\frac{1}{\mathrm{~b}}$; and $\kappa=\infty$ if moreover ess $\sup (A) \leq 1$.
(iii) Since the walk is recurrent, $\max _{0 \leq i \leq n}\left|X_{i}\right|$ cannot be replaced by $\left|X_{n}\right|$ in (1.3) and (1.6).
(iv) Theorem 1.2, which could be considered as a (weaker) analogue of the Kesten-Kozlov-Spitzer theorem, shows that tree-valued RWRE has even richer regimes than RWRE on $\mathbb{Z}$. In fact, recurrent RWRE on $\mathbb{Z}$ is of order of magnitude $(\log n)^{2}$, and has no $n^{a}$ (for $0<a<1$ ) regime.
(v) The case $\psi^{\prime}(1) \geq 0$ leads to a phenomenon similar to Sinai's slow movement, and is studied in a forthcoming paper.



Figure 1: The function $t \rightarrow \mathbf{E}\left(A^{t}\right)$ in the case $\psi^{\prime}(1)<0$ and $p=\frac{1}{\mathrm{~b}}$.

The rest of the paper is organized as follows. Section 2 is devoted to the proof of Theorem 1.1. In Section 3 , we collect some elementary inequalities, which will be of frequent use later on. Theorem 1.2 is proved in Section 4, by means of a result (Proposition 4.2) concerning the solution of a recurrence equation which is closely related to Mandelbrot's multiplicative cascade. We prove Proposition 4.2 in Section 5 .

Throughout the paper, $c$ (possibly with a subscript) denotes a finite and positive constant; we write $c(\omega)$ instead of $c$ when the value of $c$ depends on the environment $\omega$.

## 2 Proof of Theorem 1.1

We first introduce the constant $q$ in the statement of Theorem 1.1, which is defined without the assumption $p<\frac{1}{\mathrm{~b}}$. Let

$$
\varrho(r):=\inf _{t \geq 0}\left\{r^{-t} \mathbf{E}\left(A^{t}\right)\right\}, \quad r>0 .
$$

Let $\underline{r}>0$ be such that

$$
\log \underline{r}=\mathbf{E}(\log A) .
$$

We mention that $\varrho(r)=1$ for $r \in(0, \underline{r}]$, and that $\varrho(\cdot)$ is continuous and (strictly) decreasing on $[\underline{r}, \Theta)($ where $\Theta:=\operatorname{ess} \sup (A)<\infty)$, and $\varrho(\Theta)=\mathbf{P}(A=\Theta)$. Moreover, $\varrho(r)=0$ for $r>\Theta$. See Chernoff [1].

We define

$$
\bar{r}:=\inf \left\{r>0: \varrho(r) \leq \frac{1}{\mathrm{~b}}\right\} .
$$

Clearly, $\underline{r}<\bar{r}$.
We define

$$
\begin{equation*}
q:=\sup _{r \in[r, \bar{r}]} r \varrho(r) . \tag{2.1}
\end{equation*}
$$

The following elementary lemma tells us that, instead of $p$, we can also use $q$ in the recurrence/transience criterion of Lyons and Pemantle.

Lemma 2.1 We have $q>\frac{1}{\mathrm{~b}}$ (resp., $q=\frac{1}{\mathrm{~b}}, q<\frac{1}{\mathrm{~b}}$ ) if and only if $p>\frac{1}{\mathrm{~b}}$ (resp., $p=\frac{1}{\mathrm{~b}}, p<\frac{1}{\mathrm{~b}}$ ).

Proof of Lemma 2.1. By Lyons and Pemantle ([1], p. 129), $p=\sup _{r \in(0,1]} r \varrho(r)$. Since $\varrho(r)=1$ for $r \in(0, \underline{r}]$, there exists $\min \{\underline{r}, 1\} \leq r^{*} \leq 1$ such that $p=r^{*} \varrho\left(r^{*}\right)$.
(i) Assume $p<\frac{1}{\mathrm{~b}}$. Then $\varrho(1) \leq \sup _{r \in(0,1]} r \varrho(r)=p<\frac{1}{\mathrm{~b}}$, which, by definition of $\bar{r}$, implies $\bar{r}<1$. Therefore, $q \leq p<\frac{1}{\mathrm{~b}}$.
(ii) Assume $p \geq \frac{1}{\mathrm{~b}}$. We have $\varrho\left(r^{*}\right) \geq p \geq \frac{1}{\mathrm{~b}}$, which yields $r^{*} \leq \bar{r}$. If $\underline{r} \leq 1$, then $r^{*} \geq \underline{r}$, and thus $p=r^{*} \varrho\left(r^{*}\right) \leq q$. If $\underline{r}>1$, then $p=1$, and thus $q \geq \underline{r} \varrho(\underline{r})=\underline{r}>1=p$.

We have therefore proved that $p \geq \frac{1}{b}$ implies $q \geq p$.
If moreover $p>\frac{1}{\mathrm{~b}}$, then $q \geq p>\frac{1}{\mathrm{~b}}$.
(iii) Assume $p=\frac{1}{\mathrm{~b}}$. We already know from (ii) that $q \geq p$.

On the other hand, $\varrho(1) \leq \sup _{r \in(0,1]} r \varrho(r)=p=\frac{1}{\mathrm{~b}}$, implying $\bar{r} \leq 1$. Thus $q \leq p$.
As a consequence, $q=p=\frac{1}{\mathrm{~b}}$.

Having defined $q$, the next step in the proof of Theorem 1.1 is to compute invariant measures $\pi$ for $\left(X_{n}\right)$. We first introduce some notation on the tree. For any $m \geq 0$, let

$$
\mathbb{T}_{m}:=\{x \in \mathbb{T}:|x|=m\}
$$

For any $x \in \mathbb{T}$, let $\left\{x_{i}\right\}_{1 \leq i \leq b}$ be the set of children of $x$.
If $\pi$ is an invariant measure, then

$$
\pi(x)=\frac{\omega(\overleftarrow{x}, x)}{\omega(x, \overleftarrow{x})} \pi(\overleftarrow{x}), \quad \forall x \in \mathbb{T} \backslash\{e\}
$$

By induction, this leads to (recalling $A$ from (1.1)): for $x \in \mathbb{T}_{m}(m \geq 1)$,

$$
\pi(x)=\frac{\pi(e)}{\omega(x, \overleftarrow{x})} \frac{\omega\left(e, x^{(1)}\right)}{A\left(x^{(1)}\right)} \exp \left(\sum_{z \in \llbracket e, x \rrbracket} \log A(z)\right)
$$

where $\rrbracket e, x \rrbracket$ denotes the shortest path $x^{(1)}, x^{(2)}, \cdots, x^{(m)}=: x$ from the root $e$ (but excluded) to the vertex $x$. The identity holds for any choice of $\left(A\left(e_{i}\right), 1 \leq i \leq \mathrm{b}\right)$. We choose $\left(A\left(e_{i}\right), 1 \leq i \leq \mathrm{b}\right)$ to be a random vector independent of $(\omega(x, y),|x| \geq 1, y \in \mathbb{T})$, and distributed as $\left(A\left(x_{i}\right), 1 \leq i \leq \mathrm{b}\right)$, for any $x \in \mathbb{T}_{m}$ with $m \geq 1$.

By the ellipticity condition on the environment, we can take $\pi(e)$ to be sufficiently small so that for some $c_{0} \in(0,1]$,

$$
\begin{equation*}
c_{0} \exp \left(\sum_{z \in \llbracket e, x \rrbracket} \log A(z)\right) \leq \pi(x) \leq \exp \left(\sum_{z \in \llbracket e, x \rrbracket} \log A(z)\right) . \tag{2.2}
\end{equation*}
$$

By Chebyshev's inequality, for any $r>\underline{r}$,

$$
\begin{equation*}
\max _{x \in \mathbb{T}_{n}} \mathbf{P}\left\{\pi(x) \geq r^{n}\right\} \leq \varrho(r)^{n} \tag{2.3}
\end{equation*}
$$

Since $\# \mathbb{T}_{n}=\mathrm{b}^{n}$, this gives $\mathbf{E}\left(\#\left\{x \in \mathbb{T}_{n}: \pi(x) \geq r^{n}\right\}\right) \leq \mathrm{b}^{n} \varrho(r)^{n}$. By Chebyshev's inequality and the Borel-Cantelli lemma, for any $r>\underline{r}$ and $\mathbf{P}$-almost surely for all large $n$,

$$
\begin{equation*}
\#\left\{x \in \mathbb{T}_{n}: \pi(x) \geq r^{n}\right\} \leq n^{2} \mathbf{b}^{n} \varrho(r)^{n} . \tag{2.4}
\end{equation*}
$$

On the other hand, by (2.3),

$$
\mathbf{P}\left\{\exists x \in \mathbb{T}_{n}: \pi(x) \geq r^{n}\right\} \leq \mathrm{b}^{n} \varrho(r)^{n} .
$$

For $r>\bar{r}$, the expression on the right-hand side is summable in $n$. By the Borel-Cantelli lemma, for any $r>\bar{r}$ and $\mathbf{P}$-almost surely for all large $n$,

$$
\begin{equation*}
\max _{x \in \mathbb{T}_{n}} \pi(x)<r^{n} \tag{2.5}
\end{equation*}
$$

Proof of Theorem 1.1: upper bound. Fix $\varepsilon>0$ such that $q+3 \varepsilon<\frac{1}{\mathrm{~b}}$.
We follow the strategy given in Liggett ( $[8]$, p. 103) by introducing a positive recurrent birth-and-death chain $\left(\widetilde{X}_{j}, j \geq 0\right)$, starting from 0 , with transition probability from $i$ to $i+1$ (for $i \geq 1$ ) equal to

$$
\frac{1}{\widetilde{\pi}(i)} \sum_{x \in \mathbb{T}_{i}} \pi(x)(1-\omega(x, \overleftarrow{x}))
$$

where $\widetilde{\pi}(i):=\sum_{x \in \mathbb{T}_{i}} \pi(x)$. We note that $\widetilde{\pi}$ is a finite invariant measure for $\left(\widetilde{X_{j}}\right)$. Let

$$
\tau_{n}:=\inf \left\{i \geq 1: X_{i} \in \mathbb{T}_{n}\right\}, \quad n \geq 0
$$

By Liggett ([《]

$$
P_{\omega}\left(\tau_{n}<\tau_{0}\right) \leq \widetilde{P}_{\omega}\left(\widetilde{\tau}_{n}<\widetilde{\tau}_{0}\right)
$$

where $\widetilde{P}_{\omega}\left(\widetilde{\tau}_{n}<\widetilde{\tau}_{0}\right)$ is the probability that $\left(\widetilde{X}_{j}\right)$ hits $n$ before returning to 0 . According to Hoel et al. ([5] p. 32, Formula (61)),

$$
\widetilde{P}_{\omega}\left(\widetilde{\tau}_{n}<\widetilde{\tau}_{0}\right)=c_{1}(\omega)\left(\sum_{i=0}^{n-1} \frac{1}{\sum_{x \in \mathbb{T}_{i}} \pi(x)(1-\omega(x, \overleftarrow{x}))}\right)^{-1}
$$

where $c_{1}(\omega) \in(0, \infty)$ depends on $\omega$. We arrive at the following estimate: for any $n \geq 1$,

$$
\begin{equation*}
P_{\omega}\left(\tau_{n}<\tau_{0}\right) \leq c_{1}(\omega)\left(\sum_{i=0}^{n-1} \frac{1}{\sum_{x \in \mathbb{T}_{i}} \pi(x)}\right)^{-1} \tag{2.6}
\end{equation*}
$$

We now estimate $\sum_{i=0}^{n-1} \frac{1}{\sum_{x \in \mathrm{~T}_{i}} \pi(x)}$. For any fixed $0=r_{0}<\underline{r}<r_{1}<\cdots<r_{\ell}=\bar{r}<r_{\ell+1}$,

$$
\sum_{x \in \mathbb{T}_{i}} \pi(x) \leq \sum_{j=1}^{\ell+1}\left(r_{j}\right)^{i} \#\left\{x \in \mathbb{T}_{i}: \pi(x) \geq\left(r_{j-1}\right)^{i}\right\}+\sum_{x \in \mathbb{T}_{i}: \pi(x) \geq\left(r_{\ell+1}\right)^{i}} \pi(x)
$$

By (2.5), $\sum_{x \in \mathbb{T}_{i}: \pi(x) \geq\left(r_{\ell+1}\right)^{i}} \pi(x)=0$ P-almost surely for all large $i$. It follows from (2.4) that $\mathbf{P}$-almost surely, for all large $i$,

$$
\sum_{x \in \mathbb{T}_{i}} \pi(x) \leq\left(r_{1}\right)^{i} \mathrm{~b}^{i}+\sum_{j=2}^{\ell+1}\left(r_{j}\right)^{i} i^{2} \mathrm{~b}^{i} \varrho\left(r_{j-1}\right)^{i}
$$

Recall that $q=\sup _{r \in[r, \bar{r}]} r \varrho(r) \geq \underline{r} \varrho(\underline{r})=\underline{r}$. We choose $r_{1}:=\underline{r}+\varepsilon \leq q+\varepsilon$. We also choose $\ell$ sufficiently large and $\left(r_{j}\right)$ sufficiently close to each other so that $r_{j} \varrho\left(r_{j-1}\right)<q+\varepsilon$ for all $2 \leq j \leq \ell+1$. Thus, $\mathbf{P}$-almost surely for all large $i$,

$$
\sum_{x \in \mathbb{T}_{i}} \pi(x) \leq\left(r_{1}\right)^{i} \mathrm{~b}^{i}+\sum_{j=2}^{\ell+1} i^{2} \mathrm{~b}^{i}(q+\varepsilon)^{i}=\left(r_{1}\right)^{i} \mathrm{~b}^{i}+\ell i^{2} \mathrm{~b}^{i}(q+\varepsilon)^{i}
$$

which implies (recall: $\mathrm{b}(q+\varepsilon)<1$ ) that $\sum_{i=0}^{n-1} \frac{1}{\sum_{x \in \mathbb{T}_{i}} \pi(x)} \geq \frac{c_{2}}{n^{2} \mathrm{~b}^{n}(q+\varepsilon)^{n}}$. Plugging this into (2.6) yields that, $\mathbf{P}$-almost surely for all large $n$,

$$
P_{\omega}\left(\tau_{n}<\tau_{0}\right) \leq c_{3}(\omega) n^{2} \mathrm{~b}^{n}(q+\varepsilon)^{n} \leq[(q+2 \varepsilon) \mathrm{b}]^{n}
$$

In particular, by writing $L\left(\tau_{n}\right):=\#\left\{1 \leq i \leq \tau_{n}: X_{i}=e\right\}$, we obtain:

$$
P_{\omega}\left\{L\left(\tau_{n}\right) \geq j\right\}=\left[P_{\omega}\left(\tau_{n}>\tau_{0}\right)\right]^{j} \geq\left\{1-[(q+2 \varepsilon) \mathrm{b}]^{n}\right\}^{j}
$$

which, by the Borel-Cantelli lemma, yields that, $\mathbf{P}$-almost surely for all large $n$,

$$
L\left(\tau_{n}\right) \geq \frac{1}{[(q+3 \varepsilon) \mathrm{b}]^{n}}, \quad P_{\omega} \text {-a.s. }
$$

Since $\left\{L\left(\tau_{n}\right) \geq j\right\} \subset\left\{\max _{0 \leq k \leq 2 j}\left|X_{k}\right|<n\right\}$, and since $\varepsilon$ can be as close to 0 as possible, we obtain the upper bound in Theorem 1.1.

Proof of Theorem 1.1: lower bound. Assume $p<\frac{1}{\mathrm{~b}}$. Recall that in this case, we have $\bar{r}<1$. Let $\varepsilon>0$ be small. Let $r \in(\underline{r}, \bar{r})$ be such that $\varrho(r)>\frac{1}{\mathrm{~b}} \mathrm{e}^{\varepsilon}$ and that $r \varrho(r) \geq q \mathrm{e}^{-\varepsilon}$. Let $L$ be a large integer with $\mathrm{b}^{-1 / L} \geq \mathrm{e}^{-\varepsilon}$ and satisfying (2.7) below.

We start by constructing a Galton-Watson tree $\mathbb{G}$, which is a certain subtree of $\mathbb{T}$. The first generation of $\mathbb{G}$, denoted by $\mathbb{G}_{1}$ and defined below, consists of vertices $x \in \mathbb{T}_{L}$ satisfying a certain property. The second generation of $\mathbb{G}$ is formed by applying the same procedure to each element of $\mathbb{G}_{1}$, and so on. To be precise,

$$
\mathbb{G}_{1}=\mathbb{G}_{1}(L, r):=\left\{x \in \mathbb{T}_{L}: \min _{z \in \rrbracket e, x \rrbracket} \prod_{y \in \rrbracket e, z \rrbracket} A(y) \geq r^{L}\right\},
$$

where $\rrbracket e, x \rrbracket$ denotes as before the set of vertices (excluding $e$ ) lying on the shortest path relating $e$ and $x$. More generally, if $\mathbb{G}_{i}$ denotes the $i$-th generation of $\mathbb{G}$, then

$$
\mathbb{G}_{n+1}:=\bigcup_{u \in \mathbb{G}_{n}}\left\{x \in \mathbb{T}_{(n+1) L}: \min _{z \in \rrbracket u, x \rrbracket} \prod_{y \in \rrbracket u, z \rrbracket} A(y) \geq r^{L}\right\}, \quad n=1,2, \ldots
$$

We claim that it is possible to choose $L$ sufficiently large such that

$$
\begin{equation*}
\mathbf{E}\left(\# \mathbb{G}_{1}\right) \geq \mathrm{e}^{-\varepsilon L} \mathrm{~b}^{L} \varrho(r)^{L} . \tag{2.7}
\end{equation*}
$$

Note that $\mathrm{e}^{-\varepsilon L} \mathrm{~b}^{L} \varrho(r)^{L}>1$, since $\varrho(r)>\frac{1}{\mathrm{~b}} \mathrm{e}^{\varepsilon}$.
We admit (2.7) for the moment, which implies that $\mathbb{G}$ is super-critical. By theory of branching processes (Harris [4], p. 13), when $n$ goes to infinity, $\frac{\# \mathbb{G}_{n / L}}{\left[\mathbf{E}\left(\# \mathbb{G}_{1}\right)^{n / L}\right.}$ converges almost surely (and in $L^{2}$ ) to a limit $W$ with $\mathbf{P}(W>0)>0$. Therefore, on the event $\{W>0\}$, for all large $n$,

$$
\begin{equation*}
\#\left(\mathbb{G}_{n / L}\right) \geq c_{4}(\omega)\left[\mathbf{E}\left(\# \mathbb{G}_{1}\right)\right]^{n / L} . \tag{2.8}
\end{equation*}
$$

(For notational simplification, we only write our argument for the case when $n$ is a multiple of $L$. It is clear that our final conclusion holds for all large $n$.)

Recall that according to the Dirichlet principle (Griffeath and Liggett [3]),

$$
\begin{align*}
2 \pi(e) P_{\omega}\left\{\tau_{n}<\tau_{0}\right\} & =\inf _{h: h(e)=1, h(z)=0, \forall|z| \geq n} \sum_{x, y \in \mathbb{T}} \pi(x) \omega(x, y)(h(x)-h(y))^{2} \\
& \geq c_{5} \inf _{h: h(e)=1, h(z)=0, \forall z \in \mathbb{T}_{n}} \sum_{|x|<n} \sum_{y: x=\overleftarrow{y}} \pi(x)(h(x)-h(y))^{2}, \tag{2.9}
\end{align*}
$$

the last inequality following from ellipticity condition on the environment. Clearly,

$$
\begin{aligned}
\sum_{|x|<n} \sum_{y: x=\overleftarrow{y}} \pi(x)(h(x)-h(y))^{2} & =\sum_{i=0}^{(n / L)-1} \sum_{x: i L \leq|x|<(i+1) L} \sum_{y: x=\overleftarrow{y}} \pi(x)(h(x)-h(y))^{2} \\
& :=\sum_{i=0}^{(n / L)-1} I_{i},
\end{aligned}
$$

with obvious notation. For any $i$,

$$
I_{i} \geq \mathrm{b}^{-L} \sum_{v \in \mathbb{G}_{i+1}} \sum_{x \in \llbracket v^{\uparrow}, v \llbracket} \sum_{y: x=\overleftarrow{y}} \pi(x)(h(x)-h(y))^{2},
$$

where $v^{\uparrow} \in \mathbb{G}_{i}$ denotes the unique element of $\mathbb{G}_{i}$ lying on the path $\llbracket e, v \rrbracket$ (in words, $v^{\dagger}$ is the parent of $v$ in the Galton-Watson tree $\mathbb{G})$, and the factor $\mathrm{b}^{-L}$ comes from the fact that each term $\pi(x)(h(x)-h(y))^{2}$ is counted at most $\mathrm{b}^{L}$ times in the sum on the right-hand side.

By (2.2), for $x \in \llbracket v^{\uparrow}, v \llbracket, \pi(x) \geq c_{0} \prod_{u \in \rrbracket e, x \rrbracket} A(u)$, which, by the definition of $\mathbb{G}$, is at least $c_{0} r^{(i+1) L}$. Therefore,

$$
\begin{aligned}
I_{i} & \geq c_{0} \mathrm{~b}^{-L} \sum_{v \in \mathbb{G}_{i+1}} \sum_{x \in \llbracket v^{\uparrow}, v \llbracket} \sum_{y: x=\overleftarrow{y}} r^{(i+1) L}(h(x)-h(y))^{2} \\
& \geq c_{0} \mathrm{~b}^{-L} r^{(i+1) L} \sum_{v \in \mathbb{G}_{i+1}} \sum_{y \in \rrbracket v \uparrow, v \rrbracket}(h(\overleftarrow{y})-h(y))^{2} .
\end{aligned}
$$

By the Cauchy-Schwarz inequality, $\sum_{y \in \rrbracket \imath^{\uparrow}, v \rrbracket}(h(\overleftarrow{y})-h(y))^{2} \geq \frac{1}{L}\left(h\left(v^{\uparrow}\right)-h(v)\right)^{2}$. Accordingly,

$$
I_{i} \geq c_{0} \frac{\mathrm{~b}^{-L} r^{(i+1) L}}{L} \sum_{v \in \mathbb{G}_{i+1}}\left(h\left(v^{\uparrow}\right)-h(v)\right)^{2}
$$

which yields

$$
\begin{aligned}
\sum_{i=0}^{(n / L)-1} I_{i} & \geq c_{0} \frac{\mathrm{~b}^{-L}}{L} \sum_{i=0}^{(n / L)-1} r^{(i+1) L} \sum_{v \in \mathbb{G}_{i+1}}\left(h\left(v^{\uparrow}\right)-h(v)\right)^{2} \\
& \geq c_{0} \frac{\mathrm{~b}^{-L}}{L} \mathrm{~b}^{-n / L} \sum_{v \in \mathbb{G}_{n / L}} \sum_{i=0}^{(n / L)-1} r^{(i+1) L}\left(h\left(v^{(i)}\right)-h\left(v^{(i+1)}\right)\right)^{2}
\end{aligned}
$$

where, $e=: v^{(0)}, v^{(1)}, v^{(2)}, \cdots, v^{(n / L)}:=v$, is the shortest path (in $\mathbb{G}$ ) from $e$ to $v$, and the factor $\mathrm{b}^{-n / L}$ results from the fact that each term $r^{(i+1) L}\left(h\left(v^{(i)}\right)-h\left(v^{(i+1)}\right)\right)^{2}$ is counted at most $\mathrm{b}^{n / L}$ times in the sum on the right-hand side.

By the Cauchy-Schwarz inequality, for all $h: \mathbb{T} \rightarrow \mathbb{R}$ with $h(e)=1$ and $h(z)=0$ $\left(\forall z \in \mathbb{T}_{n}\right)$, we have

$$
\begin{aligned}
\sum_{i=0}^{(n / L)-1} r^{(i+1) L}\left(h\left(v^{(i)}\right)-h\left(v^{(i+1)}\right)\right)^{2} & \geq \frac{1}{\sum_{i=0}^{(n / L)-1} r^{-(i+1) L}}\left(\sum_{i=0}^{(n / L)-1}\left(h\left(v^{(i)}\right)-h\left(v^{(i+1)}\right)\right)\right)^{2} \\
& =\frac{1}{\sum_{i=0}^{(n / L)-1} r^{-(i+1) L}} \geq c_{6} r^{n}
\end{aligned}
$$

Therefore,

$$
\sum_{i=0}^{(n / L)-1} I_{i} \geq c_{0} c_{6} r^{n} \frac{\mathrm{~b}^{-L}}{L} \mathrm{~b}^{-n / L} \#\left(\mathbb{G}_{n / L}\right) \geq c_{0} c_{6} c_{4}(\omega) r^{n} \frac{\mathrm{~b}^{-L}}{L} \mathrm{~b}^{-n / L}\left[\mathbf{E}\left(\# \mathbb{G}_{1}\right)\right]^{n / L} \mathbf{1}_{\{W>0\}},
$$

the last inequality following from (2.8). Plugging this into (2.9) yields that for all large $n$,

$$
P_{\omega}\left\{\tau_{n}<\tau_{0}\right\} \geq c_{7}(\omega) r^{n} \frac{\mathrm{~b}^{-L}}{L} \mathrm{~b}^{-n / L}\left[\mathbf{E}\left(\# \mathbb{G}_{1}\right)\right]^{n / L} \mathbf{1}_{\{W>0\}} .
$$

Recall from (2.7) that $\mathbf{E}\left(\# \mathbb{G}_{1}\right) \geq \mathrm{e}^{-\varepsilon L} \mathrm{~b}^{L} \varrho(r)^{L}$. Therefore, on $\{W>0\}$, for all large $n$, $P_{\omega}\left\{\tau_{n}<\tau_{0}\right\} \geq c_{8}(\omega)\left(\mathrm{e}^{-\varepsilon} \mathrm{b}^{-1 / L} \mathrm{~b} \varrho(r)\right)^{n}$, which is no smaller than $c_{8}(\omega)\left(\mathrm{e}^{-3 \varepsilon} q \mathrm{~b}\right)^{n}$ (since $\mathrm{b}^{-1 / L} \geq \mathrm{e}^{-\varepsilon}$ and $r \varrho(r) \geq q \mathrm{e}^{-\varepsilon}$ by assumption). Thus, by writing $L\left(\tau_{n}\right):=\#\{1 \leq i \leq$ $\left.n: X_{i}=e\right\}$ as before, we have, on $\{W>0\}$,

$$
P_{\omega}\left\{L\left(\tau_{n}\right) \geq j\right\}=\left[P_{\omega}\left(\tau_{n}>\tau_{0}\right)\right]^{j} \leq\left[1-c_{8}(\omega)\left(\mathrm{e}^{-3 \varepsilon} q \mathrm{~b}\right)^{n}\right]^{j} .
$$

By the Borel-Cantelli lemma, for $\mathbf{P}$-almost all $\omega$, on $\{W>0\}$, we have, $P_{\omega}$-almost surely for all large $n, L\left(\tau_{n}\right) \leq 1 /\left(\mathrm{e}^{-4 \varepsilon} q \mathrm{~b}\right)^{n}$, i.e.,

$$
\max _{0 \leq k \leq \tau_{0}\left(\left\lfloor 1 /\left(\mathrm{e}^{-4 \varepsilon} q \mathrm{~b}\right)^{n}\right\rfloor\right)}\left|X_{k}\right| \geq n
$$

where $0<\tau_{0}(1)<\tau_{0}(2)<\cdots$ are the successive return times to the root $e$ by the walk (thus $\left.\tau_{0}(1)=\tau_{0}\right)$. Since the walk is positive recurrent, $\tau_{0}\left(\left\lfloor 1 /\left(\mathrm{e}^{-4 \varepsilon} q \mathrm{~b}\right)^{n}\right\rfloor\right) \sim \frac{1}{\left(\mathrm{e}^{-4 \varepsilon} q \mathrm{~b}\right)^{n}} E_{\omega}\left[\tau_{0}\right]$ (for $n \rightarrow \infty), P_{\omega}$-almost surely $\left(a_{n} \sim b_{n}\right.$ meaning $\left.\lim _{n \rightarrow \infty} \frac{a_{n}}{b_{n}}=1\right)$. Therefore, for $\mathbf{P}$-almost all $\omega \in\{W>0\}$,

$$
\liminf _{n \rightarrow \infty} \frac{\max _{0 \leq k \leq n}\left|X_{k}\right|}{\log n} \geq \frac{1}{\log [1 /(q \mathrm{~b})]}, \quad P_{\omega} \text {-a.s. }
$$

Recall that $\mathbf{P}\{W>0\}>0$. Since modifying a finite number of transition probabilities does not change the value of ${\lim \inf _{n \rightarrow \infty}}^{\max _{0 \leq k \leq n}\left|X_{k}\right|}$, we obtain the lower bound in Theorem 1.1.

It remains to prove (2.7). Let $\left(A^{(i)}\right)_{i \geq 1}$ be an i.i.d. sequence of random variables distributed as $A$. Clearly, for any $\delta \in(0,1)$,

$$
\begin{aligned}
\mathbf{E}\left(\# \mathbb{G}_{1}\right) & =\mathrm{b}^{L} \mathbf{P}\left(\sum_{i=1}^{\ell} \log A^{(i)} \geq L \log r, \forall 1 \leq \ell \leq L\right) \\
& \geq \mathrm{b}^{L} \mathbf{P}\left((1-\delta) L \log r \geq \sum_{i=1}^{\ell} \log A^{(i)} \geq L \log r, \forall 1 \leq \ell \leq L\right)
\end{aligned}
$$

We define a new probability $\mathbf{Q}$ by

$$
\frac{\mathrm{d} \mathbf{Q}}{\mathrm{~d} \mathbf{P}}:=\frac{\mathrm{e}^{t \log A}}{\mathbf{E}\left(\mathrm{e}^{t \log A}\right)}=\frac{A^{t}}{\mathbf{E}\left(A^{t}\right)}
$$

for some $t \geq 0$. Then

$$
\begin{aligned}
\mathbf{E}\left(\# \mathbb{G}_{1}\right) & \geq \mathrm{b}^{L} \mathbf{E}_{\mathbf{Q}}\left[\frac{\left[\mathbf{E}\left(A^{t}\right)\right]^{L}}{\exp \left\{t \sum_{i=1}^{L} \log A^{(i)}\right\}} \mathbf{1}_{\left\{(1-\delta) L \log r \geq \sum_{i=1}^{\ell} \log A^{(i)} \geq L \log r, \forall 1 \leq \ell \leq L\right\}}\right] \\
& \geq \mathrm{b}^{L} \frac{\left[\mathbf{E}\left(A^{t}\right)\right]^{L}}{r^{t(1-\delta) L}} \mathbf{Q}\left((1-\delta) L \log r \geq \sum_{i=1}^{\ell} \log A^{(i)} \geq L \log r, \forall 1 \leq \ell \leq L\right)
\end{aligned}
$$

To choose an optimal value of $t$, we fix $\widetilde{r} \in(r, \bar{r})$ with $\widetilde{r}<r^{1-\delta}$. Our choice of $t=t^{*}$ is such that $\varrho(\widetilde{r})=\inf _{t \geq 0}\left\{\widetilde{r}^{-t} \mathbf{E}\left(A^{t}\right)\right\}=\widetilde{r}^{-t^{*}} \mathbf{E}\left(A^{t^{*}}\right)$. With this choice, we have $\mathbf{E}_{\mathbf{Q}}(\log A)=\log \widetilde{r}$, so that $\mathbf{Q}\left\{(1-\delta) L \log r \geq \sum_{i=1}^{\ell} \log A^{(i)} \geq L \log r, \forall 1 \leq \ell \leq L\right\} \geq c_{9}$. Consequently,

$$
\mathbf{E}\left(\# \mathbb{G}_{1}\right) \geq c_{9} \mathrm{~b}^{L} \frac{\left[\mathbf{E}\left(A^{t^{*}}\right)\right]^{L}}{r^{t^{*}(1-\delta) L}}=c_{9} \mathrm{~b}^{L} \frac{\left[\widetilde{r} t^{*}\right.}{\left.r^{t^{*}(1-\delta) L}\right]^{L}} \geq c_{9} r^{\delta t^{*} L} \mathrm{~b}^{L} \varrho(\widetilde{r})^{L}
$$

Since $\delta>0$ can be as close to 0 as possible, the continuity of $\varrho(\cdot)$ on $[\underline{r}, \bar{r}$ ) yields (2.7), and thus completes the proof of Theorem 1.1.

## 3 Some elementary inequalities

We collect some elementary inequalities in this section. They will be of use in the next sections, in the study of the null recurrence case.

Lemma 3.1 Let $\xi \geq 0$ be a random variable.
(i) Assume that $\mathbb{E}\left(\xi^{a}\right)<\infty$ for some $a>1$. Then for any $x \geq 0$,

$$
\begin{equation*}
\frac{\mathbb{E}\left[\left(\frac{\xi}{x+\xi}\right)^{a}\right]}{\left[\mathbb{E}\left(\frac{\xi}{x+\xi}\right)\right]^{a}} \leq \frac{\mathbb{E}\left(\xi^{a}\right)}{[\mathbb{E} \xi]^{a}} \tag{3.1}
\end{equation*}
$$

(ii) If $\mathbb{E}(\xi)<\infty$, then for any $0 \leq \lambda \leq 1$ and $t \geq 0$,

$$
\begin{equation*}
\mathbb{E}\left\{\exp \left(-t \frac{(\lambda+\xi) /(1+\xi)}{\mathbb{E}[(\lambda+\xi) /(1+\xi)]}\right)\right\} \leq \mathbb{E}\left\{\exp \left(-t \frac{\xi}{\mathbb{E}(\xi)}\right)\right\} \tag{3.2}
\end{equation*}
$$

Remark. When $a=2$, (3.1) is a special case of Lemma 6.4 of Pemantle and Peres 17.
Proof of Lemma 3.1. We actually prove a very general result, stated as follows. Let $\varphi$ : $(0, \infty) \rightarrow \mathbb{R}$ be a convex $\mathcal{C}^{1}$-function. Let $x_{0} \in \mathbb{R}$ and let $I$ be an open interval containing $x_{0}$. Assume that $\xi$ takes values in a Borel set $J \subset \mathbb{R}$ (for the moment, we do not assume $\xi \geq 0)$. Let $h: I \times J \rightarrow(0, \infty)$ and $\frac{\partial h}{\partial x}: I \times J \rightarrow \mathbb{R}$ be measurable functions such that

- $\mathbb{E}\left\{h\left(x_{0}, \xi\right)\right\}<\infty$ and $\mathbb{E}\left\{\left|\varphi\left(\frac{h\left(x_{0}, \xi\right)}{\mathbb{E} h\left(x_{0}, \xi\right)}\right)\right|\right\}<\infty ;$
- $\mathbb{E}\left[\sup _{x \in I}\left\{\left|\frac{\partial h}{\partial x}(x, \xi)\right|+\left|\varphi^{\prime}\left(\frac{h(x, \xi)}{\mathbb{E} h(x, \xi)}\right)\right|\left(\frac{\left|\frac{\partial h}{\partial x}(x, \xi)\right|}{\mathbb{E}\{h(x, \xi)\}}+\frac{h(x, \xi)}{[\mathbb{E}\{h(x, \xi)\}]^{2}}\left|\mathbb{E}\left\{\frac{\partial h}{\partial x}(x, \xi)\right\}\right|\right)\right\}\right]<\infty$;
- both $y \rightarrow h\left(x_{0}, y\right)$ and $\left.y \rightarrow \frac{\partial}{\partial x} \log h(x, y)\right|_{x=x_{0}}$ are monotone on $J$.

Then

$$
\begin{equation*}
\left.\frac{\mathrm{d}}{\mathrm{~d} x} \mathbb{E}\left\{\varphi\left(\frac{h(x, \xi)}{\mathbb{E} h(x, \xi)}\right)\right\}\right|_{x=x_{0}} \geq 0, \quad \text { or } \quad \leq 0 \tag{3.3}
\end{equation*}
$$

depending on whether $h\left(x_{0}, \cdot\right)$ and $\frac{\partial}{\partial x} \log h\left(x_{0}, \cdot\right)$ have the same monotonicity.
To prove (3.3), we observe that by the integrability assumptions,

$$
\begin{aligned}
& \left.\frac{\mathrm{d}}{\mathrm{~d} x} \mathbb{E}\left\{\varphi\left(\frac{h(x, \xi)}{\mathbb{E} h(x, \xi)}\right)\right\}\right|_{x=x_{0}} \\
= & \frac{1}{\left(\mathbb{E} h\left(x_{0}, \xi\right)\right)^{2}} \mathbb{E}\left(\varphi^{\prime}\left(h\left(x_{0}, \xi\right)\right)\left[\frac{\partial h}{\partial x}\left(x_{0}, \xi\right) \mathbb{E} h\left(x_{0}, \xi\right)-h\left(x_{0}, \xi\right) \mathbb{E} \frac{\partial h}{\partial x}\left(x_{0}, \xi\right)\right]\right) .
\end{aligned}
$$

Let $\widetilde{\xi}$ be an independent copy of $\xi$. The expectation expression $\mathbb{E}\left(\varphi^{\prime}\left(h\left(x_{0}, \xi\right)\right)[\cdots]\right)$ on the right-hand side is

$$
\begin{aligned}
& =\mathbb{E}\left(\varphi^{\prime}\left(h\left(x_{0}, \xi\right)\right)\left[\frac{\partial h}{\partial x}\left(x_{0}, \xi\right) h\left(x_{0}, \widetilde{\xi}\right)-h\left(x_{0}, \xi\right) \frac{\partial h}{\partial x}\left(x_{0}, \widetilde{\xi}\right)\right]\right) \\
& =\frac{1}{2} \mathbb{E}\left(\left[\varphi^{\prime}\left(h\left(x_{0}, \xi\right)\right)-\varphi^{\prime}\left(h\left(x_{0}, \widetilde{\xi}\right)\right)\right]\left[\frac{\partial h}{\partial x}\left(x_{0}, \xi\right) h\left(x_{0}, \widetilde{\xi}\right)-h\left(x_{0}, \xi\right) \frac{\partial h}{\partial x}\left(x_{0}, \widetilde{\xi}\right)\right]\right) \\
& =\frac{1}{2} \mathbb{E}\left(h\left(x_{0}, \xi\right) h\left(x_{0}, \widetilde{\xi}\right) \eta\right)
\end{aligned}
$$

where

$$
\eta:=\left[\varphi^{\prime}\left(h\left(x_{0}, \xi\right)\right)-\varphi^{\prime}\left(h\left(x_{0}, \widetilde{\xi}\right)\right)\right]\left[\frac{\partial \log h}{\partial x}\left(x_{0}, \xi\right)-\frac{\partial \log h}{\partial x}\left(x_{0}, \widetilde{\xi}\right)\right] .
$$

Therefore,

$$
\left.\frac{\mathrm{d}}{\mathrm{~d} x} \mathbb{E}\left\{\varphi\left(\frac{h(x, \xi)}{\mathbb{E} h(x, \xi)}\right)\right\}\right|_{x=x_{0}}=\frac{1}{2\left(\mathbb{E} h\left(x_{0}, \xi\right)\right)^{2}} \mathbb{E}\left(h\left(x_{0}, \xi\right) h\left(x_{0}, \widetilde{\xi}\right) \eta\right)
$$

Since $\eta \geq 0$ or $\leq 0$ depending on whether $h\left(x_{0}, \cdot\right)$ and $\frac{\partial}{\partial x} \log h\left(x_{0}, \cdot\right)$ have the same monotonicity, this yields (3.3).

To prove (3.1) in Lemma 3.1, we take $x_{0} \in(0, \infty), J=\mathbb{R}_{+}, I$ a finite open interval containing $x_{0}$ and away from $0, \varphi(z)=z^{a}$, and $h(x, y)=\frac{y}{x+y}$, to see that the function $x \mapsto \frac{\left.\mathbb{E}\left[\frac{\xi}{x+\xi}\right)^{a}\right]}{\left[\mathbb{E}\left(\frac{\xi}{x+\xi}\right)\right]^{a}}$ is non-decreasing on $(0, \infty)$. By dominated convergence,

$$
\lim _{x \rightarrow \infty} \frac{\mathbb{E}\left[\left(\frac{\xi}{x+\xi}\right)^{a}\right]}{\left[\mathbb{E}\left(\frac{\xi}{x+\xi}\right)\right]^{a}}=\lim _{x \rightarrow \infty} \frac{\mathbb{E}\left[\left(\frac{\xi}{1+\xi / x}\right)^{a}\right]}{\left[\mathbb{E}\left(\frac{\xi}{1+\xi / x}\right)\right]^{a}}=\frac{\mathbb{E}\left(\xi^{a}\right)}{[\mathbb{E} \xi]^{a}}
$$

yielding (3.1).
The proof of (3.2) is similar. Indeed, applying (3.3) to the functions $\varphi(z)=\mathrm{e}^{-t z}$ and $h(x, y)=\frac{x+y}{1+y}$ with $x \in(0,1)$, we get that the function $x \mapsto \mathbb{E}\left\{\exp \left(-t \frac{(x+\xi) /(1+\xi)}{\mathbb{E}[(x+\xi) /(1+\xi)]}\right)\right\}$ is non-increasing on $(0,1)$; hence for $\lambda \in[0,1]$,

$$
\mathbb{E}\left\{\exp \left(-t \frac{(\lambda+\xi) /(1+\xi)}{\mathbb{E}[(\lambda+\xi) /(1+\xi)]}\right)\right\} \leq \mathbb{E}\left\{\exp \left(-t \frac{\xi /(1+\xi)}{\mathbb{E}[\xi /(1+\xi)]}\right)\right\}
$$

On the other hand, we take $\varphi(z)=\mathrm{e}^{-t z}$ and $h(x, y)=\frac{y}{1+x y}($ for $x \in(0,1))$ in (3.3) to see that $x \mapsto \mathbb{E}\left\{\exp \left(-t \frac{\xi /(1+x \xi)}{\mathbb{E}[\xi /(1+x \xi)]}\right)\right\}$ is non-increasing on $(0,1)$. Therefore,

$$
\mathbb{E}\left\{\exp \left(-t \frac{\xi /(1+\xi)}{\mathbb{E}[\xi /(1+\xi)]}\right)\right\} \leq \mathbb{E}\left\{\exp \left(-t \frac{\xi}{\mathbb{E}(\xi)}\right)\right\}
$$

which implies (3.2).

Lemma 3.2 Let $\xi_{1}, \cdots, \xi_{k}$ be independent non-negative random variables such that for some $a \in[1,2], \mathbb{E}\left(\xi_{i}^{a}\right)<\infty(1 \leq i \leq k)$. Then

$$
\mathbb{E}\left[\left(\xi_{1}+\cdots+\xi_{k}\right)^{a}\right] \leq \sum_{k=1}^{k} \mathbb{E}\left(\xi_{i}^{a}\right)+(k-1)\left(\sum_{i=1}^{k} \mathbb{E} \xi_{i}\right)^{a}
$$

Proof. By induction on $k$, we only need to prove the lemma in case $k=2$. Let

$$
h(t):=\mathbb{E}\left[\left(\xi_{1}+t \xi_{2}\right)^{a}\right]-\mathbb{E}\left(\xi_{1}^{a}\right)-t^{a} \mathbb{E}\left(\xi_{2}^{a}\right)-\left(\mathbb{E} \xi_{1}+t \mathbb{E} \xi_{2}\right)^{a}, \quad t \in[0,1] .
$$

Clearly, $h(0)=-\left(\mathbb{E} \xi_{1}\right)^{a} \leq 0$. Moreover,

$$
h^{\prime}(t)=a \mathbb{E}\left[\left(\xi_{1}+t \xi_{2}\right)^{a-1} \xi_{2}\right]-a t^{a-1} \mathbb{E}\left(\xi_{2}^{a}\right)-a\left(\mathbb{E} \xi_{1}+t \mathbb{E} \xi_{2}\right)^{a-1} \mathbb{E}\left(\xi_{2}\right)
$$

Since $(x+y)^{a-1} \leq x^{a-1}+y^{a-1}$ (for $1 \leq a \leq 2$ ), we have

$$
\begin{aligned}
h^{\prime}(t) & \leq a \mathbb{E}\left[\left(\xi_{1}^{a-1}+t^{a-1} \xi_{2}^{a-1}\right) \xi_{2}\right]-a t^{a-1} \mathbb{E}\left(\xi_{2}^{a}\right)-a\left(\mathbb{E} \xi_{1}\right)^{a-1} \mathbb{E}\left(\xi_{2}\right) \\
& =a \mathbb{E}\left(\xi_{1}^{a-1}\right) \mathbb{E}\left(\xi_{2}\right)-a\left(\mathbb{E} \xi_{1}\right)^{a-1} \mathbb{E}\left(\xi_{2}\right) \leq 0,
\end{aligned}
$$

by Jensen's inequality (for $1 \leq a \leq 2$ ). Therefore, $h \leq 0$ on $[0,1]$. In particular, $h(1) \leq 0$, which implies Lemma 3.2.

The following inequality, borrowed from page 82 of Petrov [19], will be of frequent use.

Fact 3.3 Let $\xi_{1}, \cdots, \xi_{k}$ be independent random variables. We assume that for any $i, \mathbb{E}\left(\xi_{i}\right)=$ 0 and $\mathbb{E}\left(\left|\xi_{i}\right|^{a}\right)<\infty$, where $1 \leq a \leq 2$. Then

$$
\mathbb{E}\left(\left|\sum_{i=1}^{k} \xi_{i}\right|^{a}\right) \leq 2 \sum_{i=1}^{k} \mathbb{E}\left(\left|\xi_{i}\right|^{a}\right)
$$

Lemma 3.4 Fix $a>1$. Let $\left(u_{j}\right)_{j \geq 1}$ be a sequence of positive numbers, and let $\left(\lambda_{j}\right)_{j \geq 1}$ be a sequence of non-negative numbers.
(i) If there exists some constant $c_{10}>0$ such that for all $n \geq 2$,

$$
u_{j+1} \leq \lambda_{n}+u_{j}-c_{10} u_{j}^{a}, \quad \forall 1 \leq j \leq n-1,
$$

then we can find a constant $c_{11}>0$ independent of $n$ and $\left(\lambda_{j}\right)_{j \geq 1}$, such that

$$
u_{n} \leq c_{11}\left(\lambda_{n}^{1 / a}+n^{-1 /(a-1)}\right), \quad \forall n \geq 1 .
$$

(ii) Fix $K>0$. Assume that $\lim _{j \rightarrow \infty} u_{j}=0$ and that $\lambda_{n} \in\left[0, \frac{K}{n}\right]$ for all $n \geq 1$. If there exist $c_{12}>0$ and $c_{13}>0$ such that for all $n \geq 2$,

$$
u_{j+1} \geq \lambda_{n}+\left(1-c_{12} \lambda_{n}\right) u_{j}-c_{13} u_{j}^{a}, \quad \forall 1 \leq j \leq n-1,
$$

then for some $c_{14}>0$ independent of $n$ and $\left(\lambda_{j}\right)_{j \geq 1}\left(c_{14}\right.$ may depend on $\left.K\right)$,

$$
u_{n} \geq c_{14}\left(\lambda_{n}^{1 / a}+n^{-1 /(a-1)}\right), \quad \forall n \geq 1 .
$$

Proof. (i) Put $\ell=\ell(n):=\min \left\{n, \lambda_{n}^{-(a-1) / a}\right\}$. There are two possible situations.
First situation: there exists some $j_{0} \in[n-\ell, n-1]$ such that $u_{j_{0}} \leq\left(\frac{2}{c_{10}}\right)^{1 / a} \lambda_{n}^{1 / a}$. Since $u_{j+1} \leq \lambda_{n}+u_{j}$ for all $j \in\left[j_{0}, n-1\right]$, we have

$$
u_{n} \leq\left(n-j_{0}\right) \lambda_{n}+u_{j_{0}} \leq \ell \lambda_{n}+\left(\frac{2}{c_{10}}\right)^{1 / a} \lambda_{n}^{1 / a} \leq\left(1+\left(\frac{2}{c_{10}}\right)^{1 / a}\right) \lambda_{n}^{1 / a}
$$

which implies the desired upper bound.
Second situation: $u_{j}>\left(\frac{2}{c_{10}}\right)^{1 / a} \lambda_{n}^{1 / a}, \forall j \in[n-\ell, n-1]$. Then $c_{10} u_{j}^{a}>2 \lambda_{n}$, which yields

$$
u_{j+1} \leq u_{j}-\frac{c_{10}}{2} u_{j}^{a}, \quad \forall j \in[n-\ell, n-1] .
$$

Since $a>1$ and $(1-y)^{1-a} \geq 1+(a-1) y$ (for $0<y<1$ ), this yields, for $j \in[n-\ell, n-1]$,

$$
u_{j+1}^{1-a} \geq u_{j}^{1-a}\left(1-\frac{c_{10}}{2} u_{j}^{a-1}\right)^{1-a} \geq u_{j}^{1-a}\left(1+\frac{c_{10}}{2}(a-1) u_{j}^{a-1}\right)=u_{j}^{1-a}+\frac{c_{10}}{2}(a-1)
$$

Therefore, $u_{n}^{1-a} \geq c_{15} \ell$ with $c_{15}:=\frac{c_{10}}{2}(a-1)$. As a consequence, $u_{n} \leq\left(c_{15} \ell\right)^{-1 /(a-1)} \leq$ $\left(c_{15}\right)^{-1 /(a-1)}\left(n^{-1 /(a-1)}+\lambda_{n}^{1 / a}\right)$, as desired.
(ii) Let us first prove:

$$
\begin{equation*}
u_{n} \geq c_{16} n^{-1 /(a-1)} \tag{3.4}
\end{equation*}
$$

To this end, let $n$ be large and define $v_{j}:=u_{j}\left(1-c_{12} \lambda_{n}\right)^{-j}$ for $1 \leq j \leq n$. Since $u_{j+1} \geq\left(1-c_{12} \lambda_{n}\right) u_{j}-c_{13} u_{j}^{a}$ and $\lambda_{n} \leq K / n$, we get

$$
v_{j+1} \geq v_{j}-c_{13}\left(1-c_{12} \lambda_{n}\right)^{(a-1) j-1} v_{j}^{a} \geq v_{j}-c_{17} v_{j}^{a}, \quad \forall 1 \leq j \leq n-1 .
$$

Since $u_{j} \rightarrow 0$, there exists some $j_{0}>0$ such that for all $n>j \geq j_{0}$, we have $c_{17} v_{j}^{a-1}<1 / 2$, and

$$
v_{j+1}^{1-a} \leq v_{j}^{1-a}\left(1-c_{17} v_{j}^{a-1}\right)^{1-a} \leq v_{j}^{1-a}\left(1+c_{18} v_{j}^{a-1}\right)=v_{j}^{1-a}+c_{18} .
$$

It follows that $v_{n}^{1-a} \leq c_{18}\left(n-j_{0}\right)+v_{j_{0}}^{1-a}$, which implies (3.4).

It remains to show that $u_{n} \geq c_{19} \lambda_{n}^{1 / a}$. Consider a large $n$. The function $h(x):=\lambda_{n}+$ $\left(1-c_{12} \lambda_{n}\right) x-c_{13} x^{a}$ is increasing on $\left[0, c_{20}\right]$ for some fixed constant $c_{20}>0$. Since $u_{j} \rightarrow 0$, there exists $j_{0}$ such that $u_{j} \leq c_{20}$ for all $j \geq j_{0}$. We claim there exists $j \in\left[j_{0}, n-1\right]$ such that $u_{j}>\left(\frac{\lambda_{n}}{2 c_{13}}\right)^{1 / a}$ : otherwise, we would have $c_{13} u_{j}^{a} \leq \frac{\lambda_{n}}{2} \leq \lambda_{n}$ for all $j \in\left[j_{0}, n-1\right]$, and thus

$$
u_{j+1} \geq\left(1-c_{12} \lambda_{n}\right) u_{j} \geq \cdots \geq\left(1-c_{12} \lambda_{n}\right)^{j-j_{0}} u_{j_{0}}
$$

in particular, $u_{n} \geq\left(1-c_{12} \lambda_{n}\right)^{n-j_{0}} u_{j_{0}}$ which would contradict the assumption $u_{n} \rightarrow 0$ (since $\left.\lambda_{n} \leq K / n\right)$.

Therefore, $u_{j}>\left(\frac{\lambda_{n}}{2 c_{13}}\right)^{1 / a}$ for some $j \geq j_{0}$. By monotonicity of $h(\cdot)$ on $\left[0, c_{20}\right]$,

$$
u_{j+1} \geq h\left(u_{j}\right) \geq h\left(\left(\frac{\lambda_{n}}{2 c_{13}}\right)^{1 / a}\right) \geq\left(\frac{\lambda_{n}}{2 c_{13}}\right)^{1 / a}
$$

the last inequality being elementary. This leads to: $u_{j+2} \geq h\left(u_{j+1}\right) \geq h\left(\left(\frac{\lambda_{n}}{2 c_{13}}\right)^{1 / a}\right) \geq\left(\frac{\lambda_{n}}{2 c_{13}}\right)^{1 / a}$. Iterating the procedure, we obtain: $u_{n} \geq\left(\frac{\lambda_{n}}{2 c_{13}}\right)^{1 / a}$ for all $n>j_{0}$, which completes the proof of the Lemma.

## 4 Proof of Theorem 1.2

Let $n \geq 2$, and let as before

$$
\tau_{n}:=\inf \left\{i \geq 1: X_{i} \in \mathbb{T}_{n}\right\}
$$

We start with a characterization of the distribution of $\tau_{n}$ via its Laplace transform $\mathbb{E}\left(\mathrm{e}^{-\lambda \tau_{n}}\right)$, for $\lambda \geq 0$. To state the result, we define $\alpha_{n, \lambda}(\cdot), \beta_{n, \lambda}(\cdot)$ and $\gamma_{n}(\cdot)$ by $\alpha_{n, \lambda}(x)=\beta_{n, \lambda}(x)=1$ and $\gamma_{n}(x)=0$ (for $x \in \mathbb{T}_{n}$ ), and

$$
\begin{align*}
\alpha_{n, \lambda}(x) & =\mathrm{e}^{-\lambda} \frac{\sum_{i=1}^{\mathrm{b}} A\left(x_{i}\right) \alpha_{n, \lambda}\left(x_{i}\right)}{1+\sum_{i=1}^{\mathrm{b}} A\left(x_{i}\right) \beta_{n, \lambda}\left(x_{i}\right)},  \tag{4.1}\\
\beta_{n, \lambda}(x) & =\frac{\left(1-\mathrm{e}^{-2 \lambda}\right)+\sum_{i=1}^{\mathrm{b}} A\left(x_{i}\right) \beta_{n, \lambda}\left(x_{i}\right)}{1+\sum_{i=1}^{\mathrm{b}} A\left(x_{i}\right) \beta_{n, \lambda}\left(x_{i}\right)},  \tag{4.2}\\
\gamma_{n}(x) & =\frac{[1 / \omega(x, \stackrel{\overleftarrow{x}}{x})]+\sum_{i=1}^{\mathrm{b}} A\left(x_{i}\right) \gamma_{n}\left(x_{i}\right)}{1+\sum_{i=1}^{\mathrm{b}} A\left(x_{i}\right) \beta_{n}\left(x_{i}\right)}, \quad 1 \leq|x|<n, \tag{4.3}
\end{align*}
$$

where $\beta_{n}(\cdot):=\beta_{n, 0}(\cdot)$, and for any $x \in \mathbb{T},\left\{x_{i}\right\}_{1 \leq i \leq b}$ stands as before for the set of children of $x$.

Proposition 4.1 We have, for $n \geq 2$,

$$
\begin{align*}
E_{\omega}\left(\mathrm{e}^{-\lambda \tau_{n}}\right) & =\mathrm{e}^{-\lambda} \frac{\sum_{i=1}^{\mathrm{b}} \omega\left(e, e_{i}\right) \alpha_{n, \lambda}\left(e_{i}\right)}{\sum_{i=1}^{\mathrm{b}} \omega\left(e, e_{i}\right) \beta_{n, \lambda}\left(e_{i}\right)}, \quad \forall \lambda \geq 0,  \tag{4.4}\\
E_{\omega}\left(\tau_{n}\right) & =\frac{1+\sum_{i=1}^{\mathrm{b}} \omega\left(e, e_{i}\right) \gamma_{n}\left(e_{i}\right)}{\sum_{i=1}^{\mathrm{b}} \omega\left(e, e_{i}\right) \beta_{n}\left(e_{i}\right)} . \tag{4.5}
\end{align*}
$$

Proof of Proposition 4.1. Identity (4.5) can be found in Rozikov [20]. The proof of (4.4) is along similar lines; so we feel free to give an outline only. Let $g_{n, \lambda}(x):=E_{\omega}\left(\mathrm{e}^{-\lambda \tau_{n}} \mid X_{0}=x\right)$. By the Markov property, $g_{n, \lambda}(x)=\mathrm{e}^{-\lambda} \sum_{i=1}^{\mathrm{b}} \omega\left(x, x_{i}\right) g_{n, \lambda}\left(x_{i}\right)+\mathrm{e}^{-\lambda} \omega(x, \overleftarrow{x}) g_{n, \lambda}(\overleftarrow{x})$, for $|x|<n$. By induction on $|x|$ (such that $1 \leq|x| \leq n-1$ ), we obtain: $g_{n, \lambda}(x)=\mathrm{e}^{\lambda}\left(1-\beta_{n, \lambda}(x)\right) g_{n, \lambda}(\overleftarrow{x})+$ $\alpha_{n, \lambda}(x)$, from which (4.4) follows.

Probabilistic interpretation: for $1 \leq|x|<n$, if $T_{\overleftarrow{x}}:=\inf \left\{k \geq 0: X_{k}=\overleftarrow{x}\right\}$, then $\alpha_{n, \lambda}(x)=E_{\omega}\left[\mathrm{e}^{-\lambda \tau_{n}} \mathbf{1}_{\left\{\tau_{n}<T_{\breve{x}}\right\}} \mid X_{0}=x\right], \beta_{n, \lambda}(x)=1-E_{\omega}\left[\mathrm{e}^{-\lambda\left(1+T_{\breve{x}}\right)} \mathbf{1}_{\left\{\tau_{n}>T_{\overparen{x}}\right\}} \mid X_{0}=x\right]$, and $\gamma_{n}(x)=E_{\omega}\left[\left(\tau_{n} \wedge T_{\overleftarrow{x}}\right) \mid X_{0}=x\right]$. We do not use these identities in the paper.

It turns out that $\beta_{n, \lambda}(\cdot)$ is closely related to Mandelbrot's multiplicative cascade 13]. Let

$$
\begin{equation*}
M_{n}:=\sum_{x \in \mathbb{T}_{n}} \prod_{y \in \llbracket e, x \rrbracket} A(y), \quad n \geq 1, \tag{4.6}
\end{equation*}
$$

where $\rrbracket e, x \rrbracket$ denotes as before the shortest path relating $e$ to $x$. We mention that $\left(A\left(e_{i}\right), 1 \leq\right.$ $i \leq \mathrm{b})$ is a random vector independent of $(\omega(x, y),|x| \geq 1, y \in \mathbb{T})$, and is distributed as $\left(A\left(x_{i}\right), 1 \leq i \leq \mathrm{b}\right)$, for any $x \in \mathbb{T}_{m}$ with $m \geq 1$.

Let us recall some properties of $\left(M_{n}\right)$ from Theorem 2.2 of Liu [9] and Theorem 2.5 of Liu [10]: under the conditions $p=\frac{1}{\mathrm{~b}}$ and $\psi^{\prime}(1)<0,\left(M_{n}\right)$ is a martingale, bounded in $L^{a}$ for any $a \in[1, \kappa)$; in particular,

$$
\begin{equation*}
M_{\infty}:=\lim _{n \rightarrow \infty} M_{n} \in(0, \infty), \tag{4.7}
\end{equation*}
$$

exists $\mathbf{P}$-almost surely and in $L^{a}(\mathbf{P})$, and

$$
\begin{equation*}
\mathbf{E}\left(\mathrm{e}^{-s M_{\infty}}\right) \leq \exp \left(-c_{21} s^{c_{22}}\right), \quad \forall s \geq 1 ; \tag{4.8}
\end{equation*}
$$

furthermore, if $1<\kappa<\infty$, then we also have

$$
\begin{equation*}
\frac{c_{23}}{x^{\kappa}} \leq \mathbf{P}\left(M_{\infty}>x\right) \leq \frac{c_{24}}{x^{\kappa}}, \quad x \geq 1 . \tag{4.9}
\end{equation*}
$$

We now summarize the asymptotic properties of $\beta_{n, \lambda}(\cdot)$ which will be needed later on.

Proposition 4.2 Assume $p=\frac{1}{\mathrm{~b}}$ and $\psi^{\prime}(1)<0$.
(i) For any $1 \leq i \leq \mathrm{b}, n \geq 2, t \geq 0$ and $\lambda \in[0,1]$, we have

$$
\begin{equation*}
\mathbf{E}\left\{\exp \left[-t \frac{\beta_{n, \lambda}\left(e_{i}\right)}{\mathbf{E}\left[\beta_{n, \lambda}\left(e_{i}\right)\right]}\right]\right\} \leq\left\{\mathbf{E}\left(\mathrm{e}^{-t M_{n} / \Theta}\right)\right\}^{1 / \mathrm{b}} \tag{4.10}
\end{equation*}
$$

where, as before, $\Theta:=\operatorname{ess} \sup (A)<\infty$.
(ii) If $\kappa \in(2, \infty]$, then for any $1 \leq i \leq \mathrm{b}$ and all $n \geq 2$ and $\lambda \in\left[0, \frac{1}{n}\right]$,

$$
\begin{equation*}
c_{25}\left(\sqrt{\lambda}+\frac{1}{n}\right) \leq \mathbf{E}\left[\beta_{n, \lambda}\left(e_{i}\right)\right] \leq c_{26}\left(\sqrt{\lambda}+\frac{1}{n}\right) \tag{4.11}
\end{equation*}
$$

(iii) If $\kappa \in(1,2]$, then for any $1 \leq i \leq \mathrm{b}$, when $n \rightarrow \infty$ and uniformly in $\lambda \in\left[0, \frac{1}{n}\right]$,

$$
\begin{equation*}
\mathbf{E}\left[\beta_{n, \lambda}\left(e_{i}\right)\right] \approx \lambda^{1 / \kappa}+\frac{1}{n^{1 /(\kappa-1)}} \tag{4.12}
\end{equation*}
$$

where $a_{n} \approx b_{n}$ denotes as before $\lim _{n \rightarrow \infty} \frac{\log a_{n}}{\log b_{n}}=1$.

The proof of Proposition 4.2 is postponed until Section 目. By admitting it for the moment, we are able to prove Theorem 1.2.

Proof of Theorem 1.7. Assume $p=\frac{1}{\mathrm{~b}}$ and $\psi^{\prime}(1)<0$.
Let $\pi$ be an invariant measure. By (2.2) and the definition of $\left(M_{n}\right), \sum_{x \in \mathbb{T}_{n}} \pi(x) \geq c_{0} M_{n}$. Therefore by (4.7), we have $\sum_{x \in \mathbb{T}} \pi(x)=\infty, \mathbf{P}$-a.s., implying that $\left(X_{n}\right)$ is null recurrent.

We proceed to prove the lower bound in (1.6). By (4.3) and the ellipticity condition on the environment, $\gamma_{n}(x) \leq \frac{1}{\omega(x, \overleftarrow{x})}+\sum_{i=1}^{\mathrm{b}} A\left(x_{i}\right) \gamma_{n}\left(x_{i}\right) \leq c_{27}+\sum_{i=1}^{\mathrm{b}} A\left(x_{i}\right) \gamma_{n}\left(x_{i}\right)$. Iterating the argument yields

$$
\gamma_{n}\left(e_{i}\right) \leq c_{27}\left(1+\sum_{j=2}^{n-1} M_{j}^{\left(e_{i}\right)}\right), \quad n \geq 3
$$

where

$$
M_{j}^{\left(e_{i}\right)}:=\sum_{x \in \mathbb{T}_{j}} \prod_{y \in \rrbracket \mathbb{e}_{i}, x \rrbracket} A(y)
$$

For future use, we also observe that

$$
\begin{equation*}
M_{n}=\sum_{i=1}^{\mathrm{b}} A\left(e_{i}\right) M_{n}^{\left(e_{i}\right)}, \quad n \geq 2 \tag{4.13}
\end{equation*}
$$

Let $1 \leq i \leq \mathrm{b}$. Since $\left(M_{j}^{\left(e_{i}\right)}, j \geq 2\right)$ is distributed as $\left(M_{j-1}, j \geq 2\right)$, it follows from (4.7) that $M_{j}^{\left(e_{i}\right)}$ converges (when $j \rightarrow \infty$ ) almost surely, which implies $\gamma_{n}\left(e_{i}\right) \leq c_{28}(\omega) n$. Plugging this into (4.5), we see that for all $n \geq 3$,

$$
\begin{equation*}
E_{\omega}\left(\tau_{n}\right) \leq \frac{c_{29}(\omega) n}{\sum_{i=1}^{\mathrm{b}} \omega\left(e, e_{i}\right) \beta_{n}\left(e_{i}\right)} \leq \frac{c_{30}(\omega) n}{\beta_{n}\left(e_{1}\right)} \tag{4.14}
\end{equation*}
$$

the last inequality following from the ellipticity assumption on the environment.
We now bound $\beta_{n}\left(e_{1}\right)$ from below (for large $n$ ). Let $1 \leq i \leq \mathrm{b}$. By (4.10), for $\lambda \in[0,1]$ and $s \geq 0$,

$$
\mathbf{E}\left\{\exp \left[-s \frac{\beta_{n, \lambda}\left(e_{i}\right)}{\mathbf{E}\left[\beta_{n, \lambda}\left(e_{i}\right)\right]}\right]\right\} \leq\left\{\mathbf{E}\left(\mathrm{e}^{-s M_{n} / \Theta}\right)\right\}^{1 / \mathrm{b}} \leq\left\{\mathbf{E}\left(\mathrm{e}^{-s M_{\infty} / \Theta}\right)\right\}^{1 / \mathrm{b}}
$$

where, in the last inequality, we used the fact that $\left(M_{n}\right)$ is a uniformly integrable martingale. Let $\varepsilon>0$. Applying (4.8) to $s:=n^{\varepsilon}$, we see that

$$
\begin{equation*}
\sum_{n} \mathbf{E}\left\{\exp \left[-n^{\varepsilon} \frac{\beta_{n, \lambda}\left(e_{i}\right)}{\mathbf{E}\left[\beta_{n, \lambda}\left(e_{i}\right)\right]}\right]\right\}<\infty \tag{4.15}
\end{equation*}
$$

In particular, $\sum_{n} \exp \left[-n^{\varepsilon} \frac{\beta_{n}\left(e_{1}\right)}{\mathbf{E}\left[\beta_{n}\left(e_{1}\right)\right]}\right]$ is $\mathbf{P}$-almost surely finite (by taking $\lambda=0$; recalling that $\left.\beta_{n}(\cdot):=\beta_{n, 0}(\cdot)\right)$. Thus, for $\mathbf{P}$-almost all $\omega$ and all sufficiently large $n, \beta_{n}\left(e_{1}\right) \geq n^{-\varepsilon} \mathbf{E}\left[\beta_{n}\left(e_{1}\right)\right]$. Going back to (4.14), we see that for $\mathbf{P}$-almost all $\omega$ and all sufficiently large $n$,

$$
E_{\omega}\left(\tau_{n}\right) \leq \frac{c_{30}(\omega) n^{1+\varepsilon}}{\mathbf{E}\left[\beta_{n}\left(e_{1}\right)\right]}
$$

Let $m(n):=\left\lfloor\frac{n^{1+2 \varepsilon}}{\mathbf{E}\left[\beta_{n}\left(e_{1}\right)\right]}\right\rfloor$. By Chebyshev's inequality, for $\mathbf{P}$-almost all $\omega$ and all sufficiently large $n, P_{\omega}\left(\tau_{n} \geq m(n)\right) \leq c_{31}(\omega) n^{-\varepsilon}$. Considering the subsequence $n_{k}:=\left\lfloor k^{2 / \varepsilon}\right\rfloor$, we see that $\sum_{k} P_{\omega}\left(\tau_{n_{k}} \geq m\left(n_{k}\right)\right)<\infty, \mathbf{P}$-a.s. By the Borel-Cantelli lemma, for $\mathbf{P}$-almost all $\omega$ and $P_{\omega}$-almost all sufficiently large $k, \tau_{n_{k}}<m\left(n_{k}\right)$, which implies that for $n \in\left[n_{k-1}, n_{k}\right]$ and large $k$, we have $\tau_{n}<m\left(n_{k}\right) \leq \frac{n_{k}^{1+2 \varepsilon}}{\mathbf{E}\left[\beta_{n}\left(e_{1}\right)\right]} \leq \frac{n^{1+3 \varepsilon}}{\mathbf{E}\left[\beta_{n}\left(e_{1}\right)\right]}$ (the last inequality following from the estimate of $\mathbf{E}\left[\beta_{n}\left(e_{1}\right)\right]$ in Proposition 4.2). In view of Proposition 4.2, and since $\varepsilon$ can be as small as possible, this gives the lower bound in (1.6) of Theorem 1.2.

To prove the upper bound, we note that $\alpha_{n, \lambda}(x) \leq \beta_{n}(x)$ for any $\lambda \geq 0$ and any $0<$ $|x| \leq n$ (this is easily checked by induction on $|x|)$. Thus, by (4.4), for any $\lambda \geq 0$,

$$
E_{\omega}\left(\mathrm{e}^{-\lambda \tau_{n}}\right) \leq \frac{\sum_{i=1}^{\mathrm{b}} \omega\left(e, e_{i}\right) \beta_{n}\left(e_{i}\right)}{\sum_{i=1}^{\mathrm{b}} \omega\left(e, e_{i}\right) \beta_{n, \lambda}\left(e_{i}\right)} \leq \sum_{i=1}^{\mathrm{b}} \frac{\beta_{n}\left(e_{i}\right)}{\beta_{n, \lambda}\left(e_{i}\right)}
$$

We now fix $r \in\left(1, \frac{1}{\nu}\right)$, where $\nu:=1-\frac{1}{\min \{\kappa, 2\}}$ is defined in (1.7). It is possible to choose a small $\varepsilon>0$ such that

$$
\frac{1}{\kappa-1}-\frac{r}{\kappa}>3 \varepsilon \quad \text { if } \kappa \in(1,2], \quad 1-\frac{r}{2}>3 \varepsilon \quad \text { if } \kappa \in(2, \infty] .
$$

Let $\lambda=\lambda(n):=n^{-r}$. By (4.15), we have $\beta_{n, n^{-r}}\left(e_{i}\right) \geq n^{-\varepsilon} \mathbf{E}\left[\beta_{n, n^{-r}}\left(e_{i}\right)\right]$ for $\mathbf{P}$-almost all $\omega$ and all sufficiently large $n$, which yields

$$
E_{\omega}\left(\mathrm{e}^{-n^{-r} \tau_{n}}\right) \leq n^{\varepsilon} \sum_{i=1}^{\mathrm{b}} \frac{\beta_{n}\left(e_{i}\right)}{\mathbf{E}\left[\beta_{n, n^{-r}}\left(e_{i}\right)\right]}
$$

It is easy to bound $\beta_{n}\left(e_{i}\right)$. For any given $x \in \mathbb{T} \backslash\{e\}$ with $|x| \leq n, n \mapsto \beta_{n}(x)$ is nonincreasing (this is easily checked by induction on $|x|)$. Chebyshev's inequality, together with the Borel-Cantelli lemma (applied to a subsequence, as we did in the proof of the lower bound) and the monotonicity of $n \mapsto \beta_{n}\left(e_{i}\right)$, readily yields $\beta_{n}\left(e_{i}\right) \leq n^{\varepsilon} \mathbf{E}\left[\beta_{n}\left(e_{i}\right)\right]$ for almost all $\omega$ and all sufficiently large $n$. As a consequence, for $\mathbf{P}$-almost all $\omega$ and all sufficiently large $n$,

$$
E_{\omega}\left(\mathrm{e}^{-n^{-r} \tau_{n}}\right) \leq n^{2 \varepsilon} \sum_{i=1}^{\mathrm{b}} \frac{\mathbf{E}\left[\beta_{n}\left(e_{i}\right)\right]}{\mathbf{E}\left[\beta_{n, n^{-r}}\left(e_{i}\right)\right]}
$$

By Proposition 4.2, this yields $E_{\omega}\left(\mathrm{e}^{-n^{-r} \tau_{n}}\right) \leq n^{-\varepsilon}$ (for P-almost all $\omega$ and all sufficiently large $n$; this is where we use $\frac{1}{\kappa-1}-\frac{r}{\kappa}>3 \varepsilon$ if $\kappa \in(1,2]$, and $1-\frac{r}{2}>3 \varepsilon$ if $\left.\kappa \in(2, \infty]\right)$. In particular, for $n_{k}:=\left\lfloor k^{2 / \varepsilon}\right\rfloor$, we have $\mathbf{P}$-almost surely, $E_{\omega}\left(\sum_{k} \mathrm{e}^{-n_{k}^{-r} \tau_{n_{k}}}\right)<\infty$, which implies that, $\mathbb{P}$-almost surely for all sufficiently large $k, \tau_{n_{k}} \geq n_{k}^{r}$. This implies that $\mathbb{P}$-almost surely for all sufficiently large $n, \tau_{n} \geq \frac{1}{2} n^{r}$. The upper bound in (1.6) of Theorem 1.2 follows.

Proposition 4.2 is proved in Section 5 .

## 5 Proof of Proposition 4.2

Let $\theta \in[0,1]$. Let $\left(Z_{n, \theta}\right)$ be a sequence of random variables, such that $Z_{1, \theta} \stackrel{\text { law }}{=} \sum_{i=1}^{\mathrm{b}} A_{i}$, where ( $A_{i}, 1 \leq i \leq \mathrm{b}$ ) is distributed as $\left(A\left(x_{i}\right), 1 \leq i \leq \mathrm{b}\right.$ ) (for any $x \in \mathbb{T}$ ), and that

$$
\begin{equation*}
Z_{j+1, \theta} \stackrel{\text { law }}{=} \sum_{i=1}^{\mathrm{b}} A_{i} \frac{\theta+Z_{j, \theta}^{(i)}}{1+Z_{j, \theta}^{(i)}}, \quad \forall j \geq 1 \tag{5.1}
\end{equation*}
$$

where $Z_{j, \theta}^{(i)}$ (for $1 \leq i \leq \mathrm{b}$ ) are independent copies of $Z_{j, \theta}$, and are independent of the random vector $\left(A_{i}, 1 \leq i \leq \mathrm{b}\right)$.

Then, for any given $n \geq 1$ and $\lambda \geq 0$,

$$
\begin{equation*}
Z_{n, 1-\mathrm{e}^{-2 \lambda}} \stackrel{\text { law }}{=} \sum_{i=1}^{\mathrm{b}} A_{i} \beta_{n, \lambda}\left(e_{i}\right), \tag{5.2}
\end{equation*}
$$

provided $\left(A_{i}, 1 \leq i \leq \mathrm{b}\right)$ and $\left(\beta_{n, \lambda}\left(e_{i}\right), 1 \leq i \leq \mathrm{b}\right)$ are independent.

Proposition 5.1 Assume $p=\frac{1}{\mathrm{~b}}$ and $\psi^{\prime}(1)<0$. Let $\kappa$ be as in (1.4). For all $a \in(1, \kappa) \cap$ (1, 2], we have

$$
\sup _{\theta \in[0,1]} \sup _{j \geq 1} \frac{\left[\mathbf{E}\left(Z_{j, \theta}\right)^{a}\right]}{\left(\mathbf{E} Z_{j, \theta}\right)^{a}}<\infty .
$$

Proof of Proposition 5.1. Let $a \in(1,2]$. Conditioning on $A_{1}, \ldots, A_{\mathrm{b}}$, we can apply Lemma 3.2 to see that

$$
\begin{aligned}
& \mathbf{E}\left[\left.\left(\sum_{i=1}^{\mathrm{b}} A_{i} \frac{\theta+Z_{j, \theta}^{(i)}}{1+Z_{j, \theta}^{(i)}}\right)^{a} \right\rvert\, A_{1}, \ldots, A_{\mathrm{b}}\right] \\
\leq & \sum_{i=1}^{\mathrm{b}} A_{i}^{a} \mathbf{E}\left[\left(\frac{\theta+Z_{j, \theta}}{1+Z_{j, \theta}}\right)^{a}\right]+(\mathrm{b}-1)\left[\sum_{i=1}^{\mathrm{b}} A_{i} \mathbf{E}\left(\frac{\theta+Z_{j, \theta}}{1+Z_{j, \theta}}\right)\right]^{a} \\
\leq & \sum_{i=1}^{\mathrm{b}} A_{i}^{a} \mathbf{E}\left[\left(\frac{\theta+Z_{j, \theta}}{1+Z_{j, \theta}}\right)^{a}\right]+c_{32}\left[\mathbf{E}\left(\frac{\theta+Z_{j, \theta}}{1+Z_{j, \theta}}\right)\right]^{a},
\end{aligned}
$$

where $c_{32}$ depends on $a, \mathrm{~b}$ and the bound of $A$ (recalling that $A$ is bounded away from 0 and infinity). Taking expectation on both sides, and in view of (5.1), we obtain:

$$
\mathbf{E}\left[\left(Z_{j+1, \theta}\right)^{a}\right] \leq \mathrm{b} \mathbf{E}\left(A^{a}\right) \mathbf{E}\left[\left(\frac{\theta+Z_{j, \theta}}{1+Z_{j, \theta}}\right)^{a}\right]+c_{32}\left[\mathbf{E}\left(\frac{\theta+Z_{j, \theta}}{1+Z_{j, \theta}}\right)\right]^{a}
$$

We divide by $\left(\mathbf{E} Z_{j+1, \theta}\right)^{a}=\left[\mathbf{E}\left(\frac{\theta+Z_{j, \theta}}{1+Z_{j, \theta}}\right)\right]^{a}$ on both sides, to see that

$$
\frac{\mathbf{E}\left[\left(Z_{j+1, \theta}\right)^{a}\right]}{\left(\mathbf{E} Z_{j+1, \theta}\right)^{a}} \leq \mathrm{b} \mathbf{E}\left(A^{a}\right) \frac{\mathbf{E}\left[\left(\frac{\theta+Z_{j, \theta}}{1+Z_{j, \theta}}\right)^{a}\right]}{\left[\mathbf{E}\left(\frac{\theta+Z_{j, \theta}}{1+Z_{j, \theta}}\right)\right]^{a}}+c_{32}
$$

Put $\xi=\theta+Z_{j, \theta}$. By (3.1), we have

$$
\frac{\mathbf{E}\left[\left(\frac{\theta+Z_{j, \theta}}{1+Z_{j, \theta}}\right)^{a}\right]}{\left[\mathbf{E}\left(\frac{\theta+Z_{j, \theta}}{1+Z_{j, \theta}}\right)\right]^{a}}=\frac{\mathbf{E}\left[\left(\frac{\xi}{1-\theta+\xi}\right)^{a}\right]}{\left[\mathbf{E}\left(\frac{\xi}{1-\theta+\xi}\right)\right]^{a}} \leq \frac{\mathbf{E}\left[\xi^{a}\right]}{[\mathbf{E} \xi]^{]}} .
$$

Applying Lemma 3.2 to $k=2$ yields that $\mathbf{E}\left[\xi^{a}\right]=\mathbf{E}\left[\left(\theta+Z_{j, \theta}\right)^{a}\right] \leq \theta^{a}+\mathbf{E}\left[\left(Z_{j, \theta}\right)^{a}\right]+(\theta+$ $\left.\mathbf{E}\left(Z_{j, \theta}\right)\right)^{a}$. It follows that $\frac{\mathbf{E}\left[\xi^{a}\right]}{[\mathbf{E} \xi]^{a}} \leq \frac{\mathbf{E}\left[\left(Z_{j, \theta}\right)^{a}\right]}{\left[\mathbf{E} Z_{j, \theta}\right]^{a}}+2$, which implies that for $j \geq 1$,

$$
\frac{\mathbf{E}\left[\left(Z_{j+1, \theta}\right)^{a}\right]}{\left(\mathbf{E} Z_{j+1, \theta}\right)^{a}} \leq \mathrm{b} \mathbf{E}\left(A^{a}\right) \frac{\mathbf{E}\left[\left(Z_{j, \theta}\right)^{a}\right]}{\left(\mathbf{E} Z_{j, \theta}\right)^{a}}+\left(2 \mathrm{~b} \mathbf{E}\left(A^{a}\right)+c_{32}\right)
$$

Thus, if $\mathrm{bE}\left(A^{a}\right)<1$ (which is the case if $1<a<\kappa$ ), then

$$
\sup _{j \geq 1} \frac{\mathbf{E}\left[\left(Z_{j, \theta}\right]^{a}\right]}{\left(\mathbf{E} Z_{j, \theta}\right)^{a}}<\infty,
$$

uniformly in $\theta \in[0,1]$.
We now turn to the proof of Proposition 4.2. For the sake of clarity, the proofs of (4.10), (4.11) and (4.12) are presented in three distinct parts.

### 5.1 Proof of (4.10)

By (3.2) and (5.1), we have, for all $\theta \in[0,1]$ and $j \geq 1$,

$$
\mathbf{E}\left\{\exp \left(-t \frac{Z_{j+1, \theta}}{\mathbf{E}\left(Z_{j+1, \theta}\right)}\right)\right\} \leq \mathbf{E}\left\{\exp \left(-t \sum_{i=1}^{\mathrm{b}} A_{i} \frac{Z_{j, \theta}^{(i)}}{\mathbf{E}\left(Z_{j, \theta}^{(i)}\right)}\right)\right\}, \quad t \geq 0
$$

Let $f_{j}(t):=\mathbf{E}\left\{\exp \left(-t \frac{Z_{j, \theta}}{\mathbf{E} Z_{j, \theta}}\right)\right\}$ and $g_{j}(t):=\mathbf{E}\left(\mathrm{e}^{-t M_{j}}\right)$ (for $j \geq 1$ ). We have

$$
f_{j+1}(t) \leq \mathbf{E}\left(\prod_{i=1}^{\mathrm{b}} f_{j}\left(t A_{i}\right)\right), \quad j \geq 1
$$

On the other hand, by (4.13),

$$
g_{j+1}(t)=\mathbf{E}\left\{\exp \left(-t \sum_{i=1}^{\mathrm{b}} A\left(e_{i}\right) M_{j+1}^{\left(e_{i}\right)}\right)\right\}=\mathbf{E}\left(\prod_{i=1}^{\mathrm{b}} g_{j}\left(t A_{i}\right)\right), \quad j \geq 1
$$

Since $f_{1}(\cdot)=g_{1}(\cdot)$, it follows by induction on $j$ that for all $j \geq 1, f_{j}(t) \leq g_{j}(t)$; in particular, $f_{n}(t) \leq g_{n}(t)$. We take $\theta=1-\mathrm{e}^{-2 \lambda}$. In view of (5.2), we have proved that

$$
\begin{equation*}
\mathbf{E}\left\{\exp \left(-t \sum_{i=1}^{\mathrm{b}} A\left(e_{i}\right) \frac{\beta_{n, \lambda}\left(e_{i}\right)}{\mathbf{E}\left[\beta_{n, \lambda}\left(e_{i}\right)\right]}\right)\right\} \leq \mathbf{E}\left\{\mathrm{e}^{-t M_{n}}\right\} \tag{5.3}
\end{equation*}
$$

which yields (4.10).

Remark. Let

$$
\beta_{n, \lambda}(e):=\frac{\left(1-\mathrm{e}^{-2 \lambda}\right)+\sum_{i=1}^{\mathrm{b}} A\left(e_{i}\right) \beta_{n, \lambda}\left(e_{i}\right)}{1+\sum_{i=1}^{\mathrm{b}} A\left(e_{i}\right) \beta_{n, \lambda}\left(e_{i}\right)} .
$$

By (5.3) and (3.2), if $\mathbf{E}(A)=\frac{1}{\mathrm{~b}}$, then for $\lambda \geq 0, n \geq 1$ and $t \geq 0$,

$$
\mathbf{E}\left\{\exp \left(-t \frac{\beta_{n, \lambda}(e)}{\mathbf{E}\left[\beta_{n, \lambda}(e)\right]}\right)\right\} \leq \mathbf{E}\left\{\mathrm{e}^{-t M_{n}}\right\}
$$

### 5.2 Proof of (4.11)

Assume $p=\frac{1}{\mathrm{~b}}$ and $\psi^{\prime}(1)<0$. Since $Z_{j, \theta}$ is bounded uniformly in $j$, we have, by (5.1), for $1 \leq j \leq n-1$,

$$
\begin{align*}
\mathbf{E}\left(Z_{j+1, \theta}\right) & =\mathbf{E}\left(\frac{\theta+Z_{j, \theta}}{1+Z_{j, \theta}}\right) \\
& \leq \mathbf{E}\left[\left(\theta+Z_{j, \theta}\right)\left(1-c_{33} Z_{j, \theta}\right)\right] \\
& \leq \theta+\mathbf{E}\left(Z_{j, \theta}\right)-c_{33} \mathbf{E}\left[\left(Z_{j, \theta}\right)^{2}\right]  \tag{5.4}\\
& \leq \theta+\mathbf{E}\left(Z_{j, \theta}\right)-c_{33}\left[\mathbf{E} Z_{j, \theta}\right]^{2} .
\end{align*}
$$

By Lemma 3.4, we have, for any $K>0$ and uniformly in $\theta \in\left[0, \frac{K}{n}\right]$,

$$
\begin{equation*}
\mathbf{E}\left(Z_{n, \theta}\right) \leq c_{34}\left(\sqrt{\theta}+\frac{1}{n}\right) \leq \frac{c_{35}}{\sqrt{n}} . \tag{5.5}
\end{equation*}
$$

We mention that this holds for all $\kappa \in(1, \infty]$. In view of (5.2), this yields the upper bound in (4.11).

To prove the lower bound, we observe that

$$
\begin{equation*}
\mathbf{E}\left(Z_{j+1, \theta}\right) \geq \mathbf{E}\left[\left(\theta+Z_{j, \theta}\right)\left(1-Z_{j, \theta}\right)\right]=\theta+(1-\theta) \mathbf{E}\left(Z_{j, \theta}\right)-\mathbf{E}\left[\left(Z_{j, \theta}\right)^{2}\right] . \tag{5.6}
\end{equation*}
$$

If furthermore $\kappa \in(2, \infty]$, then $\mathbf{E}\left[\left(Z_{j, \theta}\right)^{2}\right] \leq c_{36}\left(\mathbf{E} Z_{j, \theta}\right)^{2}$ (see Proposition 5.1). Thus, for all $1 \leq j \leq n-1$,

$$
\mathbf{E}\left(Z_{j+1, \theta}\right) \geq \theta+(1-\theta) \mathbf{E}\left(Z_{j, \theta}\right)-c_{36}\left(\mathbf{E} Z_{j, \theta}\right)^{2} .
$$

By (5.5), $\mathbf{E}\left(Z_{n, \theta}\right) \rightarrow 0$ uniformly in $\theta \in\left[0, \frac{K}{n}\right]$ (for any given $K>0$ ). An application of (5.2) and Lemma 3.4 readily yields the lower bound in (4.11).

### 5.3 Proof of (4.12)

We assume in this part $p=\frac{1}{\mathrm{~b}}, \psi^{\prime}(1)<0$ and $1<\kappa \leq 2$.
Let $\varepsilon>0$ be small. Since $\left(Z_{j, \theta}\right)$ is bounded, we have $\mathbf{E}\left[\left(Z_{j, \theta}\right)^{2}\right] \leq c_{37} \mathbf{E}\left[\left(Z_{j, \theta}\right)^{\kappa-\varepsilon}\right]$, which, by Proposition 5.1, implies

$$
\begin{equation*}
\mathbf{E}\left[\left(Z_{j, \theta}\right)^{2}\right] \leq c_{38}\left(\mathbf{E} Z_{j, \theta}\right)^{\kappa-\varepsilon} \tag{5.7}
\end{equation*}
$$

Therefore, (5.6) yields that

$$
\mathbf{E}\left(Z_{j+1, \theta}\right) \geq \theta+(1-\theta) \mathbf{E}\left(Z_{j, \theta}\right)-c_{38}\left(\mathbf{E} Z_{j, \theta}\right)^{\kappa-\varepsilon} .
$$

By (5.5), $\mathbf{E}\left(Z_{n, \theta}\right) \rightarrow 0$ uniformly in $\theta \in\left[0, \frac{K}{n}\right]$ (for any given $K>0$ ). An application of Lemma 3.4 implies that for any $K>0$,

$$
\begin{equation*}
\mathbf{E}\left(Z_{\ell, \theta}\right) \geq c_{14}\left(\theta^{1 /(\kappa-\varepsilon)}+\frac{1}{\ell^{1 /(\kappa-1-\varepsilon)}}\right), \quad \forall \theta \in\left[0, \frac{K}{n}\right], \quad \forall 1 \leq \ell \leq n \tag{5.8}
\end{equation*}
$$

The lower bound in (4.12) follows from (5.2).
It remains to prove the upper bound. Define

$$
Y_{j, \theta}:=\frac{Z_{j, \theta}}{\mathbf{E}\left(Z_{j, \theta}\right)}, \quad 1 \leq j \leq n
$$

We take $Z_{j-1, \theta}^{(x)}\left(\right.$ for $\left.x \in \mathbb{T}_{1}\right)$ to be independent copies of $Z_{j-1, \theta}$, and independent of $(A(x), x \in$ $\mathbb{T}_{1}$ ). By (5.1), for $2 \leq j \leq n$,

$$
\begin{aligned}
Y_{j, \theta} & \stackrel{\text { law }}{=} \sum_{x \in \mathbb{T}_{1}} A(x) \frac{\left(\theta+Z_{j-1, \theta}^{(x)}\right) /\left(1+Z_{j-1, \theta}^{(x)}\right)}{\mathbf{E}\left[\left(\theta+Z_{j-1, \theta}^{(x)}\right) /\left(1+Z_{j-1, \theta}^{(x)}\right)\right]} \geq \sum_{x \in \mathbb{T}_{1}} A(x) \frac{Z_{j-1, \theta}^{(x)} /\left(1+Z_{j-1, \theta}^{(x)}\right)}{\theta+\mathbf{E}\left[Z_{j-1, \theta}\right]} \\
& =\frac{\mathbf{E}\left[Z_{j-1, \theta}\right]}{\theta+\mathbf{E}\left[Z_{j-1, \theta}\right]} \sum_{x \in \mathbb{T}_{1}} A(x) Y_{j-1, \theta}^{(x)}-\frac{\mathbf{E}\left[Z_{j-1, \theta}\right]}{\theta+\mathbf{E}\left[Z_{j-1, \theta}\right]} \sum_{x \in \mathbb{T}_{1}} A(x) \frac{\left(Z_{j-1, \theta}^{(x)}\right)^{2} / \mathbf{E}\left(Z_{j-1, \theta}\right)}{1+Z_{j-1, \theta}^{(x)}} \\
& \geq \sum_{x \in \mathbb{T}_{1}} A(x) Y_{j-1, \theta}^{(x)}-\Delta_{j-1, \theta},
\end{aligned}
$$

where

$$
\begin{aligned}
Y_{j-1, \theta}^{(x)} & :=\frac{Z_{j-1, \theta}^{(x)}}{\mathbf{E}\left(Z_{j-1, \theta}\right)}, \\
\Delta_{j-1, \theta} & :=\frac{\theta}{\theta+\mathbf{E}\left[Z_{j-1, \theta}\right]} \sum_{x \in \mathbb{T}_{1}} A(x) Y_{j-1, \theta}^{(x)}+\sum_{x \in \mathbb{T}_{1}} A(x) \frac{\left(Z_{j-1, \theta}^{(x)}\right)^{2}}{\mathbf{E}\left(Z_{j-1, \theta}\right)} .
\end{aligned}
$$

By (5.7), $\mathbf{E}\left[\frac{\left(Z_{j-1, \theta}^{(i)}\right)^{2}}{\mathbf{E}\left(Z_{j-1, \theta}\right)}\right] \leq c_{38}\left(\mathbf{E} Z_{j-1, \theta}\right)^{\kappa-1-\varepsilon}$. On the other hand, by (5.8), $\mathbf{E}\left(Z_{j-1, \theta}\right) \geq$ $c_{14} \theta^{1 /(\kappa-\varepsilon)}$ for $2 \leq j \leq n$, and thus $\frac{\theta}{\theta+\mathbf{E}\left[Z_{j-1, \theta}\right]} \leq c_{39}\left(\mathbf{E} Z_{j-1, \theta}\right)^{\kappa-1-\varepsilon}$. As a consequence, $\mathbf{E}\left(\Delta_{j-1, \theta}\right) \leq c_{40}\left(\mathbf{E} Z_{j-1, \theta}\right)^{\kappa-1-\varepsilon}$.

If we write $\xi \stackrel{\text { st. }}{\geq} \eta$ to denote that $\xi$ is stochastically greater than or equal to $\eta$, then we have proved that $Y_{j, \theta} \stackrel{s t .}{\geq} \sum_{x \in \mathbb{T}_{1}}^{\mathrm{b}} A(x) Y_{j-1, \theta}^{(x)}-\Delta_{j-1, \theta}$. Applying the same argument to each of $\left(Y_{j-1, \theta}^{(x)}, x \in \mathbb{T}_{1}\right)$, we see that, for $3 \leq j \leq n$,

$$
Y_{j, \theta} \stackrel{s t .}{\geq} \sum_{u \in \mathbb{T}_{1}} A(u) \sum_{v \in \mathbb{T}_{2}: u=\overleftarrow{v}} A(v) Y_{j-2, \theta}^{(v)}-\left(\Delta_{j-1, \theta}+\sum_{u \in \mathbb{T}_{1}} A(u) \Delta_{j-2, \theta}^{(u)}\right),
$$

where $Y_{j-2, \theta}^{(v)}\left(\right.$ for $\left.v \in \mathbb{T}_{2}\right)$ are independent copies of $Y_{j-2, \theta}$, and are independent of $(A(w), w \in$ $\left.\mathbb{T}_{1} \cup \mathbb{T}_{2}\right)$, and $\left(\Delta_{j-2, \theta}^{(u)}, u \in \mathbb{T}_{1}\right)$ are independent of $\left(A(u), u \in \mathbb{T}_{1}\right)$ and are such that $\mathbb{E}\left[\Delta_{j-2, \theta}^{(u)}\right] \leq c_{40}\left(\mathbf{E} Z_{j-2, \theta}\right)^{\kappa-1-\varepsilon}$.

By induction, we arrive at: for $j>m \geq 1$,

$$
\begin{equation*}
Y_{j, \theta} \stackrel{s t .}{\geq} \sum_{x \in \mathbb{T}_{m}}\left(\prod_{y \in \rrbracket e, x \rrbracket} A(y)\right) Y_{j-m, \theta}^{(x)}-\Lambda_{j, m, \theta}, \tag{5.9}
\end{equation*}
$$

where $Y_{j-m, \theta}^{(x)}$ (for $x \in \mathbb{T}_{m}$ ) are independent copies of $Y_{j-m, \theta}$, and are independent of the random vector $(A(w), 1 \leq|w| \leq m)$, and $\mathbf{E}\left(\Lambda_{j, m, \theta}\right) \leq c_{40} \sum_{\ell=1}^{m}\left(\mathbf{E} Z_{j-\ell, \theta}\right)^{\kappa-1-\varepsilon}$.

Since $\mathbf{E}\left(Z_{i, \theta}\right)=\mathbf{E}\left(\frac{\theta+Z_{i-1, \theta}}{1+Z_{i-1, \theta}}\right) \geq \mathbf{E}\left(Z_{i-1, \theta}\right)-\mathbf{E}\left[\left(Z_{i-1, \theta}\right)^{2}\right] \geq \mathbf{E}\left(Z_{i-1, \theta}\right)-c_{38}\left[\mathbf{E} Z_{i-1, \theta}\right]^{\kappa-\varepsilon}$ (by (5.7)), we have, for all $j \in\left(j_{0}, n\right]$ (with a large but fixed integer $j_{0}$ ) and $1 \leq \ell \leq j-j_{0}$,

$$
\begin{aligned}
\mathbf{E}\left(Z_{j, \theta}\right) & \geq \mathbf{E}\left(Z_{j-\ell, \theta}\right) \prod_{i=1}^{\ell}\left\{1-c_{38}\left[\mathbf{E} Z_{j-i, \theta}\right]^{\kappa-1-\varepsilon}\right\} \\
& \geq \mathbf{E}\left(Z_{j-\ell, \theta}\right) \prod_{i=1}^{\ell}\left\{1-c_{41}(j-i)^{-(\kappa-1-\varepsilon) / 2}\right\}
\end{aligned}
$$

the last inequality being a consequence of (5.5). Thus, for $j \in\left(j_{0}, n\right]$ and $1 \leq \ell \leq$ $j^{(\kappa-1-\varepsilon) / 2}, \mathbf{E}\left(Z_{j, \theta}\right) \geq c_{42} \mathbf{E}\left(Z_{j-\ell, \theta}\right)$, which implies that for all $m \leq j^{(\kappa-1-\varepsilon) / 2}, \mathbf{E}\left(\Lambda_{j, m, \theta}\right) \leq$ $c_{43} m\left(\mathbf{E} Z_{j, \theta}\right)^{\kappa-1-\varepsilon}$. By Chebyshev's inequality, for $j \in\left(j_{0}, n\right], m \leq j^{(\kappa-1-\varepsilon) / 2}$ and $r>0$,

$$
\begin{equation*}
\mathbf{P}\left\{\Lambda_{j, m, \theta}>\varepsilon r\right\} \leq \frac{c_{43} m\left(\mathbf{E} Z_{j, \theta}\right)^{\kappa-1-\varepsilon}}{\varepsilon r} . \tag{5.10}
\end{equation*}
$$

Let us go back to (5.9), and study the behaviour of $\sum_{x \in \mathbb{T}_{m}}\left(\prod_{y \in \rrbracket e, x \rrbracket} A(y)\right) Y_{j-m, \theta}^{(x)}$. Let $M^{(x)}$ (for $x \in \mathbb{T}_{m}$ ) be independent copies of $M_{\infty}$ and independent of all other random variables.

Since $\mathbf{E}\left(Y_{j-m, \theta}^{(x)}\right)=\mathbf{E}\left(M^{(x)}\right)=1$, we have, by Fact 3.3, for any $a \in(1, \kappa)$,

$$
\begin{aligned}
& \mathbf{E}\left\{\left|\sum_{x \in \mathbb{T}_{m}}\left(\prod_{y \in \rrbracket e, x \rrbracket} A(y)\right)\left(Y_{j-m, \theta}^{(x)}-M^{(x)}\right)\right|^{a}\right\} \\
\leq & 2 \mathbf{E}\left\{\sum_{x \in \mathbb{T}_{m}}\left(\prod_{y \in \rrbracket e, x \rrbracket} A(y)^{a}\right) \mathbf{E}\left(\left|Y_{j-m, \theta}^{(x)}-M^{(x)}\right|^{a}\right)\right\} .
\end{aligned}
$$

By Proposition 5.1 and the fact that $\left(M_{n}\right)$ is a martingale bounded in $L^{a}$, we have $\mathbf{E}\left(\mid Y_{j-m, \theta^{-}}^{(x)}\right.$ $\left.\left.M^{(x)}\right|^{a}\right) \leq c_{44}$. Thus,

$$
\begin{aligned}
\mathbf{E}\left\{\left|\sum_{x \in \mathbb{T}_{m}}\left(\prod_{y \in \rrbracket e, x \rrbracket} A(y)\right)\left(Y_{j-m, \theta}^{(x)}-M^{(x)}\right)\right|^{a}\right\} & \leq 2 c_{44} \mathbf{E}\left\{\sum_{x \in \mathbb{T}_{m}} \prod_{y \in \rrbracket e, x \rrbracket} A(y)^{a}\right\} \\
& =2 c_{44} \mathrm{~b}^{m}\left[\mathbf{E}\left(A^{a}\right)\right]^{m}
\end{aligned}
$$

By Chebyshev's inequality,

$$
\begin{equation*}
\mathbf{P}\left\{\left|\sum_{x \in \mathbb{T}_{m}}\left(\prod_{y \in \llbracket e, x \rrbracket} A(y)\right)\left(Y_{j-m, \theta}^{(x)}-M^{(x)}\right)\right|>\varepsilon r\right\} \leq \frac{2 c_{44} \mathrm{~b}^{m}\left[\mathbf{E}\left(A^{a}\right)\right]^{m}}{\varepsilon^{a} r^{a}} \tag{5.11}
\end{equation*}
$$

Clearly, $\sum_{x \in \mathbb{T}_{m}}\left(\prod_{y \in \rrbracket e, x \rrbracket} A(y)\right) M^{(x)}$ is distributed as $M_{\infty}$. We can thus plug (5.11) and (5.10) into (5.9), to see that for $j \in\left[j_{0}, n\right], m \leq j^{(\kappa-1-\varepsilon) / 2}$ and $r>0$,

$$
\begin{equation*}
\mathbf{P}\left\{Y_{j, \theta}>(1-2 \varepsilon) r\right\} \geq \mathbf{P}\left\{M_{\infty}>r\right\}-\frac{c_{43} m\left(\mathbf{E} Z_{j, \theta}\right)^{\kappa-1-\varepsilon}}{\varepsilon r}-\frac{2 c_{44} \mathrm{~b}^{m}\left[\mathbf{E}\left(A^{a}\right)\right]^{m}}{\varepsilon^{a} r^{a}} \tag{5.12}
\end{equation*}
$$

We choose $m:=\left\lfloor j^{\varepsilon}\right\rfloor$. Since $a \in(1, \kappa)$, we have $\mathrm{b} \mathbf{E}\left(A^{a}\right)<1$, so that $\mathrm{b}^{m}\left[\mathbf{E}\left(A^{a}\right)\right]^{m} \leq$ $\exp \left(-j^{\varepsilon / 2}\right)$ for all large $j$. We choose $r=\frac{1}{\left(\mathbf{E} Z_{j, \theta}\right)^{1-\delta}}$, with $\delta:=\frac{4 \kappa \varepsilon}{\kappa-1}$. In view of (4.9), we obtain: for $j \in\left[j_{0}, n\right]$,

$$
\mathbf{P}\left\{Y_{j, \theta}>\frac{1-2 \varepsilon}{\left(\mathbf{E} Z_{j, \theta}\right)^{1-\delta}}\right\} \geq c_{23}\left(\mathbf{E} Z_{j, \theta}\right)^{(1-\delta) \kappa}-\frac{c_{43}}{\varepsilon} j^{\varepsilon}\left(\mathbf{E} Z_{j, \theta}\right)^{\kappa-\varepsilon-\delta}-\frac{2 c_{44}\left(\mathbf{E} Z_{j, \theta}\right)^{(1-\delta) a}}{\varepsilon^{a} \exp \left(j^{\varepsilon / 2}\right)} .
$$

Since $c_{14} / j^{1 /(\kappa-1-\varepsilon)} \leq \mathbf{E}\left(Z_{j, \theta}\right) \leq c_{35} / j^{1 / 2}$ (see (5.8) and (5.5), respectively), we can pick up sufficiently small $\varepsilon$, so that for $j \in\left[j_{0}, n\right]$,

$$
\mathbf{P}\left\{Y_{j, \theta}>\frac{1-2 \varepsilon}{\left(\mathbf{E} Z_{j, \theta}\right)^{1-\delta}}\right\} \geq \frac{c_{23}}{2}\left(\mathbf{E} Z_{j, \theta}\right)^{(1-\delta) \kappa}
$$

Recall that by definition, $Y_{j, \theta}=\frac{Z_{j, \theta}}{\mathbf{E}\left(Z_{j, \theta}\right)}$. Therefore, for $j \in\left[j_{0}, n\right]$,

$$
\mathbf{E}\left[\left(Z_{j, \theta}\right)^{2}\right] \geq\left[\mathbf{E} Z_{j, \theta}\right]^{2} \frac{(1-2 \varepsilon)^{2}}{\left(\mathbf{E} Z_{j, \theta}\right)^{2(1-\delta)}} \mathbf{P}\left\{Y_{j, \theta}>\frac{1-2 \varepsilon}{\left(\mathbf{E} Z_{j, \theta}\right)^{1-\delta}}\right\} \geq c_{45}\left(\mathbf{E} Z_{j, \theta}\right)^{\kappa+(2-\kappa) \delta} .
$$

Of course, the inequality holds trivially for $0 \leq j<j_{0}$ (with possibly a different value of the constant $c_{45}$ ). Plugging this into (5.4), we see that for $1 \leq j \leq n-1$,

$$
\mathbf{E}\left(Z_{j+1, \theta}\right) \leq \theta+\mathbf{E}\left(Z_{j, \theta}\right)-c_{46}\left(\mathbf{E} Z_{j, \theta}\right)^{\kappa+(2-\kappa) \delta} .
$$

By Lemma 3.4, this yields $\mathbf{E}\left(Z_{n, \theta}\right) \leq c_{47}\left\{\theta^{1 /[\kappa+(2-\kappa) \delta]}+n^{-1 /[\kappa-1+(2-\kappa) \delta]}\right\}$. An application of (5.2) implies the desired upper bound in (4.12).

Remark. A close inspection on our argument shows that under the assumptions $p=\frac{1}{\mathrm{~b}}$ and $\psi^{\prime}(1)<0$, we have, for any $1 \leq i \leq \mathrm{b}$ and uniformly in $\lambda \in\left[0, \frac{1}{n}\right]$,

$$
\left(\frac{\alpha_{n, \lambda}\left(e_{i}\right)}{\mathbf{E}\left[\alpha_{n, \lambda}\left(e_{i}\right)\right]}, \frac{\beta_{n, \lambda}\left(e_{i}\right)}{\mathbf{E}\left[\beta_{n, \lambda}\left(e_{i}\right)\right]}, \frac{\gamma_{n}\left(e_{i}\right)}{\mathbf{E}\left[\gamma_{n}\left(e_{i}\right)\right]}\right) \xrightarrow{l a w}\left(M_{\infty}, M_{\infty}, M_{\infty}\right),
$$

where " $\xrightarrow{\text { law } " ~ s t a n d s ~ f o r ~ c o n v e r g e n c e ~ i n ~ d i s t r i b u t i o n, ~ a n d ~} M_{\infty}$ is the random variable defined in (4.7).
