How did IAEVG begin?

1951: During the late 1940's a group of vocational guidance counsellors across Europe had been in contact with each other expressing concern that guidance issues needed a wider focus and that there was a need to share good practice and ideas across wider boundaries. These communications culminated in a meeting of interested individuals from several countries in Paris in 1951 when the formation of an Association Internationale d'Orientation Scolaire et Profesionelle was proposed. Founder members and early officials included Hans Z Hoxter (UK), Emile Lobet (Belgium), Richard Bertrand (Belgium), Eric Steuer (Germany, Carlo Lo Gatto, James Schwar, Florence A Taylor (UK), A L C Knook (Netherlands), Henri Lachoix (France), Louis Abraham (France), Rene Gille (France), Frederick G Leasure (UNESCO).

The objectives of the Association were designed to provide guidance professionals with the opportunity to exchange views and experiences and to benefit from mutual exchanges and experiences. The Association's vision was to promote international and regional seminars and to facilitate international exchanges of information on studying and work and the creation of an international accessible resource for careers and vocational guidance.

- **1952:** The second meeting held in Geneva consolidated the purpose of the Association and a subsequent meeting was held in Paris during the same year.
- 1953: During a meeting held on 15 January in Brussels, the Constitution in the form of the Statutes was established and the first seminar took place in Montecatani (Italy) which attrached 104 delegates from 16 countries - a clear indication that there was support for an international group. "Guidance for special needs" was a key topic of the seminar.
- 1954: Professor Emile Lobet (Belgium) was elected the first IAEVG President and over 400 delegates from 27 countries attended the first international conference in Bonn (Germany). Key themes included the importance of guidance to the economy, the relationship and co-operation between educational based practitioners and work-based practitioners. The concept of National Correspondents, who are still around today, was introduced and the UNESCO conference at Montevideo (Uraguay) confirmed the status of consultative body upon IAEVG. In 1954, the International Journal and Newsletter was launched and from then on, a wide variety of events, seminars and research has taken place every year across the world. These include:

In 50 years, the issues debated and researched by IAEVG have been wide reaching. However, in analysing all the activities, there are certain themes than seem to occur again and again over the years. Support for Special Needs students; the importance of guidance to the economy; co-operation between educationalists and employers; the role of parents; integrating young people into a world of changing technology (first discussed in 1962!); the transition from school to work; choices in higher education; the training and quality of guidance practitioners. Many of these topics still exercise the minds of today's guidance practitioners.
