



Researching the Provenance

Provenance is the record of ownership of a collection.

Emilio Estrada, an Ecuadorian archaeologist, excavates ancient Indigenous ruins. (circa 1950 - 1960)





In 1960, Salem Hyde visits Estrada and obtains a portion of the Estrada collection.

Salem Hyde, an amateur archaeologist from Cleveland, TN, travels with his wife Louise Patten-Hyde through Latin America. (circa 1950 - circa 1963)

Hyde donates the collection to the University of Chattanooga in 1969.


Reflections and Repatriation

The Investigating Provenance and Post-colonial Perspectives in the George and Louise Patten Collection of Salem Hyde *Cultural Artifacts* exhibition recognize that scholars must rethink their approaches to curating pre-Columbian artifacts. Despite Salem Hyde's goal of encouraging research in the United States on the rich cultural heritage of Latin America, his gift poses of hundreds of pre-Columbian artifacts poses many ethical questions. Why did Salem Hyde donate this collection in memory of his late wife instead of crediting Emilio Estrada, the archaeologist who excavated the artifacts, or the original creators of the valuable objects when he donated the gift?
