STATE OF MAINE

IN THE YEAR OF OUR LORD NINETEEN HUNDRED FIFTY-NINE

AN ACT to Create a Commission to Commemorate the Centennial of the American Civil War.

it enacted by the People of the State of Maine, as follows:

- ec. 1. Purpose. It is just and right that the people of the State of Maine, embering the valor and sacrifice of its sons, who fought and died for prines which they believed eternal, and the sons of other states who also made supreme sacrifice for their convictions, should commemorate the 100th anreary of the War Between the States. It is further declared that it shall be policy of the State to perpetuate a knowledge of the deeds and traditions of liant people, who through the terrible ordeals of a great war, forged one naundivided, under God. To that end there shall be a proper observance ighout Maine of the years that wrote their history in the blood of our naand in its observance, to take those actions which will endure in the underling and memory of the people of our State and those who visit with us.
- c. 2. Commission. There is created the Maine Civil War Commission to nemorate the centennial of the American Civil War, hereafter referred to as commission". The commission shall be composed of 17 members including tovernor, the President of the Senate, and the Speaker of the House of Reptatives, who shall be ex officio members of the commission. The other memshall be appointed as follows:
- . Eight members shall be appointed by the Speaker of the House of Representatives from the membership thereof;
- II. Four members shall be appointed by the President of the Senate from the membership thereof; and
- III. Five members shall be appointed by the Governor from the State at large.

All members shall be appointed for terms to expire December 31, 1965, and vacancies shall be filled in the same manner as the original appointments were made. The commission shall name 5 of its members to constitute an executive committee, which shall act for the commission pursuant to its direction.

The commission may appoint honorary members, and shall establish an Advisory Council, composed of such persons as it deems especially interested in the

celebration of the centennial of the Civil War, to assist it in its work. The Law Librarian of the Maine State Library shall be a member of said council.

The commission shall employ an executive director and such other assistants when they may be required.

Sec. 3. Duties. It shall be the duty of the commission to develop and coordinate the plans of the public and private agencies for commemorating the 100th anniversary of the Civil War. All agencies of the State and all political subdivisions are authorized to cooperate with the commission and to grant funds, property and services to it for the furtherance of the commemoration.

With the consent of the Governor first obtained, the commission may lease or purchase lands, property and structures deemed necessary for the purposes of such commemoration. The title to property acquired shall be taken in the name of the State.

The commission is authorized to enter into contracts, provided the same have been approved by the Attorney General, and to do all things proper and necessary for the proper commemoration of the events in the Civil War which occurred in the State of Maine.

The commission is empowered to adopt an official flag, seal and other emblems for such celebration, and to copyright the same in the name of the State. With the approval of the Governor, the commission may lease or sell the title to the use of such seal and other emblems upon such terms and conditions as seem proper.

In the lease or sale of any property or right of use, the commission shall provide that the revenues therefrom shall be paid into the State Treasury to the credit of the commission and they are hereby reappropriated to the commission for its purposes. The commission is authorized to accept donations of money, property or personal services; to cooperate with the United States, state, civic, patriotic and historical groups, and with the institutions of learning.

- Sec. 4. Proclamations. The Governor is authorized and requested to issue proclamations inviting the people of the State and of the United States to participate in and observe the centennial anniversaries of the significant historic events, the commemorations of which are provided for herein.
- Sec. 5. Commission expenses. The members of the commission and Advisory Council shall serve without compensation, but shall receive their actual traveling expenses incident to the discharge of their duties as provided for herein.
- **Sec. 6. Report.** An annual report of the activities of the commission shall be furnished by the commission to the Governor and Legislature.
- Sec. 7. Appropriation. There is appropriated to the commission from the Unappropriated Surplus of the General Fund the sum of \$3500.00 for the expenses and operation of the commission. Any unexpended balance shall not lapse but shall remain a continuing carrying account until the purposes of this act have been accomplished.

OF THE

CIVIL WAR CENTENNIAL COMMISSION

To Governor John H. Reed, the Honorable Senate and House of Representatives:

Introduction

The Maine Civil War Centennial Commission was established by vote of the 99th Legislature late in 1959, under provisions of Legislative Document No. 179, "AN ACT to Create a Commission to Commemorate the Centennial of the American Civil War." The Commission was organized on November 7, 1959. Present for the Organizational Meeting at the State House were: Senator Arthur H. Charles, Rep. Arnold W. Briggs, Rep. Edwin H. Pert, Senator Robert Martin, Major William J. Dow, Rep. Roy K. Dennison, Rep. Edwin F. Maddox, Maurice Warner and Mrs. Ruth Hussey. John E. Byrne, Press Secretary to Governor Clinton A. Clauson, was Acting Recording Secretary and welcomed the group.

At the first meeting on December 9, 1959, officers were elected as follows: Maurice J. Warner, Chairman; Prof. Robert York, Vice Chairman; Ruth V. Hussey, Secretary. Members of the Executive Committee: Maurice Warner, Prof. Robert York, Sen. Robert Martin, Rep. Arnold Briggs, Rep. Edwin F. Maddox. Mrs. Ruth Hussey elected as Recording Secretary.

NEW ENGLAND CONFERENCES OF CIVIL WAR CENTENNIAL COMMISSIONS

On November 15, 1959 Massachusetts was host to representatives of similar commissions of the other five New England States at the First New England Conference of Civil War Centennial Commissions held in the Gardner Auditorium.

Mr. Maurice Warner, of the Maine Civil War Centennial Commission proposed that the next conference be held at Augusta, Maine, July, 1960. Mr. Warner represented the Maine Commission; other Maine citizens attending were Rep. William Earles, member of the Maine Commission, Philip Boyd of Bath, representing Maine Dept. Sons of Union Veterans and Mrs. Maurice Warner of the Bath Civil War Centennial Commission.

The Second New England Conference was held at the State House, Augusta Maine on Saturday, April 30, 1960. Maurice Warner, Chairman, opened the Conference and welcomed the members and guests present. Governor John Reed addressed the gathering and welcomed them to Maine. Karl S. Betts, Executive Director of the National Civil War Centennial Commission, told of plans for the Civil War Centennial. Greetings were received from Senator Charles Hedges-Mass.; A. Waller Lewis, Jr.—Rhode Island; Dr. Richard Wood—Vermont Committee; Mr. Wm. Finan—temporary chairman, Conn.; and a representative of N. H. Commission. The afternoon speaker was Congressman Frank M. Coffin, member of the National Civil War Centennial Commission.

The third New England Conference of Civil War Centennial Commissions opened informally at the Hotel Viking, Newport, R. I. on Friday evening, October 7th, 1960. Present from the Maine Civil War Centennial Commission were Mrs. Ruth Hussey, Rep. Arnold Briggs, Rep. William Earles and Daniel Lambert. The report for the Maine Commission was given by the Recording Secretary, Mrs. Ruth Hussey, in the absence of the Chairman, Maurice Warner, who could not attend because of the death of his father-in-law. The report told of the fifty member Advisory Council to the Maine Commission: entertaining the Second New England Conference: Trophy to Maine Muzzle Loading Association with name of Maine Commission on same: Float in 200th Anniversary of Cumberland County Parade: Seal, for use of the Maine Civil War Centennial Commission, designed by a member, Major William Dow; Printing of minutes of Second New England Conference in booklet (copies sent to Chairmen of N. E. Commissions; town and city Civil War Centennial Commissions being set up.)

The meeting on Saturday, October 8th, was at the historic Old Colony House in Newport, R. I. Maj. General Ulysses Grant, 3rd, grandson of the famous Union General, was introduced. Karl Betts, Executive Director, Nat. C.W.C.C., gave an informative talk. At the banquet at Hotel Viking the speaker was Vice Admiral Stuart W. Ingersol, U.S.N., whose ancestor founded Falmouth Neck, Mc. Sunday included a tour with a visit to the Armory of the Newport Artillery Company, inspection of Fort Adams which is now in neglect in its scenic location, a drive past Newport's famous homes, then to Brown University, Providence, R. I. where delegates viewed the famous Lincoln Collection in the John Hay Library.

The Fourth New England Conference of Civil War Centennial Commissions was held April 20, 1961 in Durham, New Hampshire at the University of New Hampshire. Maurice Warner had car trouble in Saco, so did not reach the Conference to represent the Maine Commission.

At the Fifth New England Conference on December 2, 1961, at Hartford, Connecticut, Maurice Warner, Chairman, and Mrs. Leroy Hussey, Secretary, were delegates. Meetings were held in the House of Representatives, State House. Lt. Governor Armentana, in his greetings from Governor John Dempsey, related the history of that section of Hartford, Conn., especially the Memorial Arch near the State House.

Thomas Mulligan, Executive Director of the New York Civil War Centennial Commission, spoke on "What the New York Commission Is Doing," and how they will observe the Centennial so 18 million New Yorkers can get something from it. The New York State Commission publishes a monthly Bulletin "New York in the Civil War." This outstanding booklet is sent to the Maine Commission.

A recording by Bruce Catton, New York Chairman, was played.

The original Draft of the Emancipation Proclamation in Lincoln's Handwriting is in Albany. This valuable document has been locked up in a vault and not seen. It was rescued from the Capitol fire. A proper display of the Emancipation Proclamation in a Memorial is the project of the Centennial.

Each State Civil War Centennial Commission was called on to report the work or plans in their state. Maurice Warner, Chairman Maine CWCC, reported the work of the Commission and the Advisory Council, especially the equipping and sending seventeen Maine National Guard Personnel to Manassas, Va.; the presentation of a 35 star flag and a Civil War sword to our Commission; the week observance at Phillips, Maine, centered around the Civil War; work in caring for Civil War Veterans' graves according to State Law; and our plans for presenting a "History of Maine in the Civil War."

Reports from other New England states showed that Connecticut stresses Round Tables, printing of monthly bulletin and writing of town histories during Civil War; Massachusetts has many special observances and has printed "Massachusetts in the Civil War" in two booklets, Part 1 and Part 2; Vermont has procured a painting "Vermont in the Civil War," obtained Civil War letters and diaries; New Hampshire has a quarterly newsletter, radio talks, and gathered historical data.

The Sixth New England Conference of Civil War Centennial Commissions was held on Saturday, July 7, 1962 at the State House in Montpelier, Vt. Governor Ray Keyser brought greetings. Hon. Consuelo Bailey, member of National Civil War Centennial Commission and only woman to serve as Lieutenant Governor of Vermont, spoke briefly. Dr. James I. Robertson, new Executive Director NCWCC, said to keep the Centennial observance on an impartial nature—"Americans All." Maurice Warner, Chairman, and Mrs. Leroy Hussey, Secretary, represented the Maine Commission.

The Seventh New England Conference will be held May 22-24 in Boston, Mass.

PRESENTATIONS TO THE COMMISSION

The Presentation, in the Hall of Flags, State House, Augusta, Maine, of a 35 Star Flag by Mrs. Henry Snell of Gorham, Maine was held April 19, 1961 at 2:00 P.M. The Flag was given in memory of Patrick Henry Snell, of Gorham, Maine, a soldier in Co. K - 3rd Maine during the Civil War.

The Presentation of a sword of Capt. William P. Jordan of 10th Me. Volunteers of Civil War fame was made by Mrs. Basil Lamb, Portland, Maine, Honorary State Regent Maine Society Daughters of the American Revolution, and member of Advisory Council. The ceremony took place at the meeting of the Commission and the Advisory Council Nov. 19, 1960.

Original letters from Civil War Soldiers have been received from Rep. Edwin F. Maddox, Vinalhaven; Mrs. Earle M. Hillman, Bangor; and Mrs. Arthur N. Gosline, Gardiner.

A copy of Harper's Weekly, December 19, 1863 edition—received.

PRESENTATIONS BY THE COMMISSION

A Trophy has been given each year to the Maine Muzzle Loading Association. The first presentation was August 24, 1960, when the Auburn target shooting contest was held. The trophy was inscribed with the words "Maine Civil War Centennial Commission Trophy." Military Aggregate.

A wreath at Soldiers & Sailors Monument, Fort Allen Park, July 4, 1961, when Civil War theme brought into observance.

ACCOMPLISHMENTS

At the request of the MCWCC the Maine State Library, thru the State Librarian, Miss Ruth Hazelton, prepared a bibliography of the material available in the State Library pertaining to Maine's participation in the Civil War.

Civil War Seal for use of the Maine Civil War Centennial Commission, was designed by Major William Dow, Commission member, South Portland, Maine.

Stationery, with Seal, printed for use of the Commission.

Membership cards issued to members of the Commission and of the Advisory Council.

Supported the efforts of the National Commission in securing the printing of Commemorative Stamps.

497 letters were sent to Maine towns and cities asking that a Civil War Centennial Commission be set up in their locality.

Various historical window displays throughout the State were arranged by the State and local commissions.

Appearing before the Appropriations Committee of the 100th Legislature, Rep. Edwin Maddox, Maurice Warner, Hon. Robert Martin and Mrs. Leroy Hussey spoke on behalf of the Commission at the Hearing Feb. 28, 1961.

Sponsored Float at 200th Anniversary of Cumberland County Parade at Portland. Me.

The Chairman, Maurice Warner, attended Eastern States Exposition, Springfield, Mass. Sept. 16 and 17, 1961, representing the Maine Civil War Centennial Commission. The Battle of Philippi was reenacted. He spoke at a meeting of the Maine Cemetery Association, Lafayette Hotel, Portland; gave a Memorial Address at Bryant's Pond; attended Army Exhibit at Civil War Museum, Portland.

The members of the Maine Civil War Centennial Commission were invited to the Annual Old Home Week at Phillips, Maine on Wednesday, August 9, 1961. The theme of the parade and other activities was "The Civil War." The speaker was Hon. Earle Hillman, President of the Maine Senate and Ex officio Member of the Maine Civil War Centennial Commission. Maurice Warner spoke on "Phillips and the Civil War."

Tentative plans are made for an observance of the Capture of the Caleb Cushing on June 26, 1963; also to observe the intended Raid on Calais in July, 1964.

ACTIVITIES

The observance of the Civil War Centennial started in the churches on Sunday, January 8, 1961, with special church services. The ringing of church bells announced the beginning of the Centennial. At the Winthrop Street Universalist Church, Augusta, Maine, Mrs. Emma Finley (100 years old in May, 1961), one of the four surviving widows of Civil War Veterans in the State, was honor guest at special services arranged by the Augusta Civil War Centennial Commission Chairman. A radio broadcast by Mrs. Ruth Hussey, secretary, told of the Centennial observance.

Frank Southard, Jr., Lt. Col. I.G.C., Supt. Maine Military Academy, had charge of the detail of cadets of the Maine Military Academy, which represented Maine at the re-enactment of the First Battle of Bull Run at Manassas, Virginia on July 22 and 23, 1961. Authentic uniforms were purchased. Stanley McCurdy, Augusta, made a handsome Civil War period National Color with the Coat of Arms of the United States and the Union, surrounded by 33 gold stars, in the fashion of colors carried by quite a number of Maine regiments. Lt. Col. Southard left Augusta on Thursday, July 20th, with the fourteen cadets, who deserve credit for their superior appearance and military conduct. Taking part in the parade in the Village of Manassas, the group attracted considerable favorable comment.

The cost of the trip ws \$1233.24 including purchase of uniforms, which will be used for other observances during the Centennial. 1st Manassas Participation Medals were received by the Maine National Guard personnel, who were present for the reenactment.

The 100th Anniversary of the Battle of Antietam was observed September 15, 16 and 17, 1962. The State of Maine was represented by ten members of the Second United States Sharpshooters Co. D (Maine), an affiliated unit of the North-South Skirmish Association. The Commander-Sgt. Maj. Harry A. Crowley, New Gloucester, Me., and Adjutant-Sgt. William B. Jordan, Jr., Cape Elizabeth, Me. head the Unit. \$400 (\$500 grant — \$100 returned by the Unit) was contributed by the Commission towards the trip to Maryland for reenactment of the Battle of Antietam.

The Militia-Mobile, a Civil War Centennial Display for exhibit in states designed to show the unique function of the Militia in the Civil War was brought to Maine by the Maine Civil War Centennial Commission. Adjutant General Edwin Heywood was in charge of the schedule, the publicity and the contacts with persons responsible for having the display in their city or town. The Militia-Mobile visited 25 Maine Communities where 10,000 people — predominantly school students — viewed the Civil War Display. Two men, who drove the bus, are students of Civil War History. 12 Press Releases were used. 1500 sheets "The Part the State of Maine Had in the Civil War 1861-1865" were distributed on the visit of the Militia-Mobile.

FUTURE ACTIVITIES

The Battle of Gettysburg will be the next observance in which Maine will participate. Many monuments will be rededicated on July 1, 1963, the first day of the Centennial ceremonies.

A "History of Maine in the Civil War" will be printed when funds are available. Prof. Robert York is writing the book. A bill was presented to the 100th Maine Legislature for \$6,000 for books, but was rejected by the Legislature.
