This Deed made and entered into this
17th day of January 1904 between H. B.
Barrow and S. B. Barrow his wife of the
first-part and S. W. Poulett of the second
part - all of the Town of Ferrisville in
Wilkesett that for and in consideration
of the sum of Five Thousand (\$5000.⁰⁰)
Dollars paid to the said H. B. Barrow
and wife by said Poulett the receipt
whereof is hereby acknowledged the
said H. B. Barrow and S. B. his wife
do hereby grant - bargain sell and con-
vey unto the said S. W. Poulett with
General Warranty the following property
to wit - Part of Lot No. 41 Inlith Randolphs
survey of the Town of Ferrisville Prince Ed-
ward Co. Virginia fronting Twenty four (24)
feet on the East side of Main Street of said
Town and running back between parallel
lines One Hundred and fifty (150) feet
together with all the buildings and improve-
ments thereon. It being the same property
conveyed to said H. B. Barrow by deed from H. B.
Wall and wife dated 14th Jan'y 1889 and duly recorded
in Deed Book No. 38 Page 209 Clerk's Office of Prince Ed-
ward Co. Va. Witness our hands and seals this 17th day of Jan'y 1904
