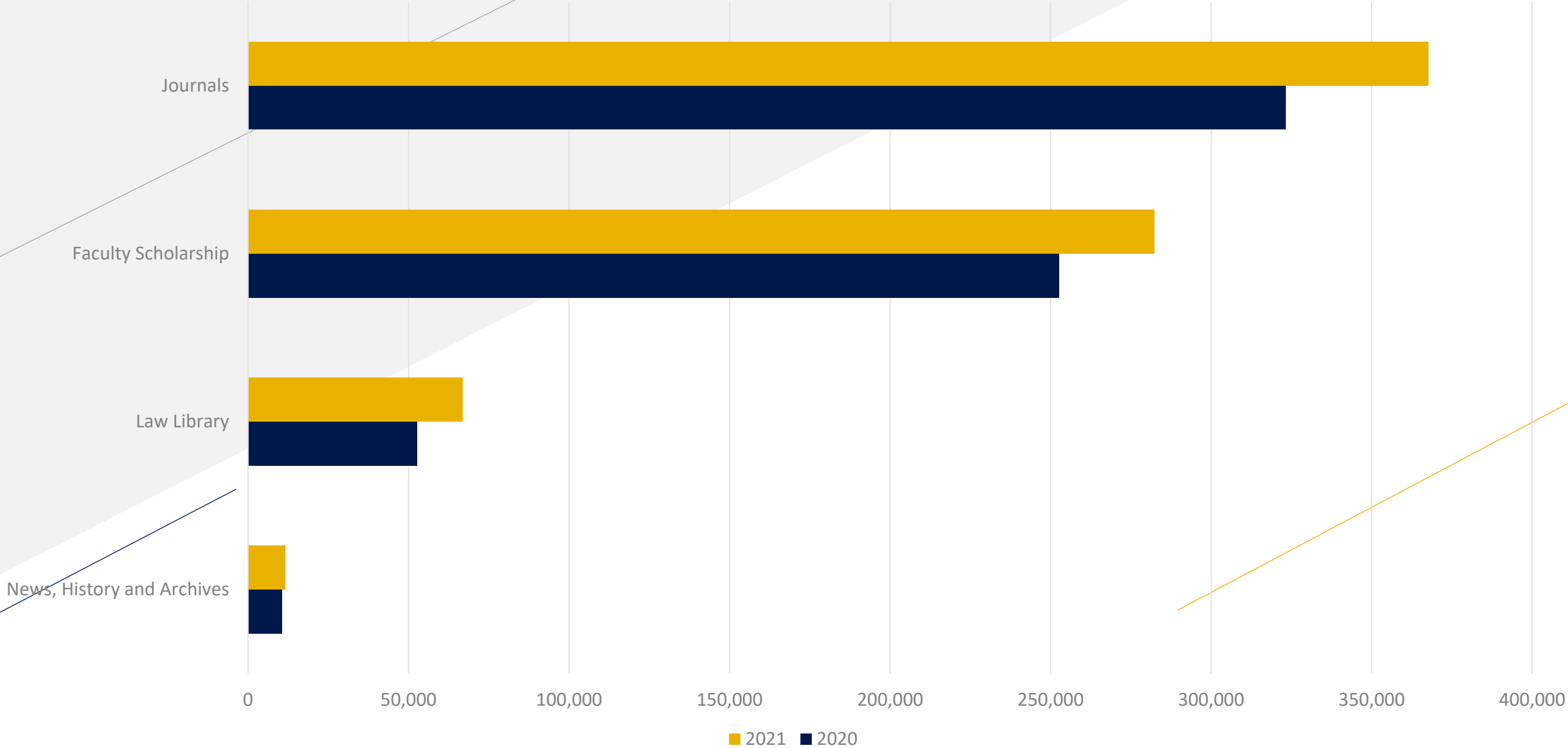

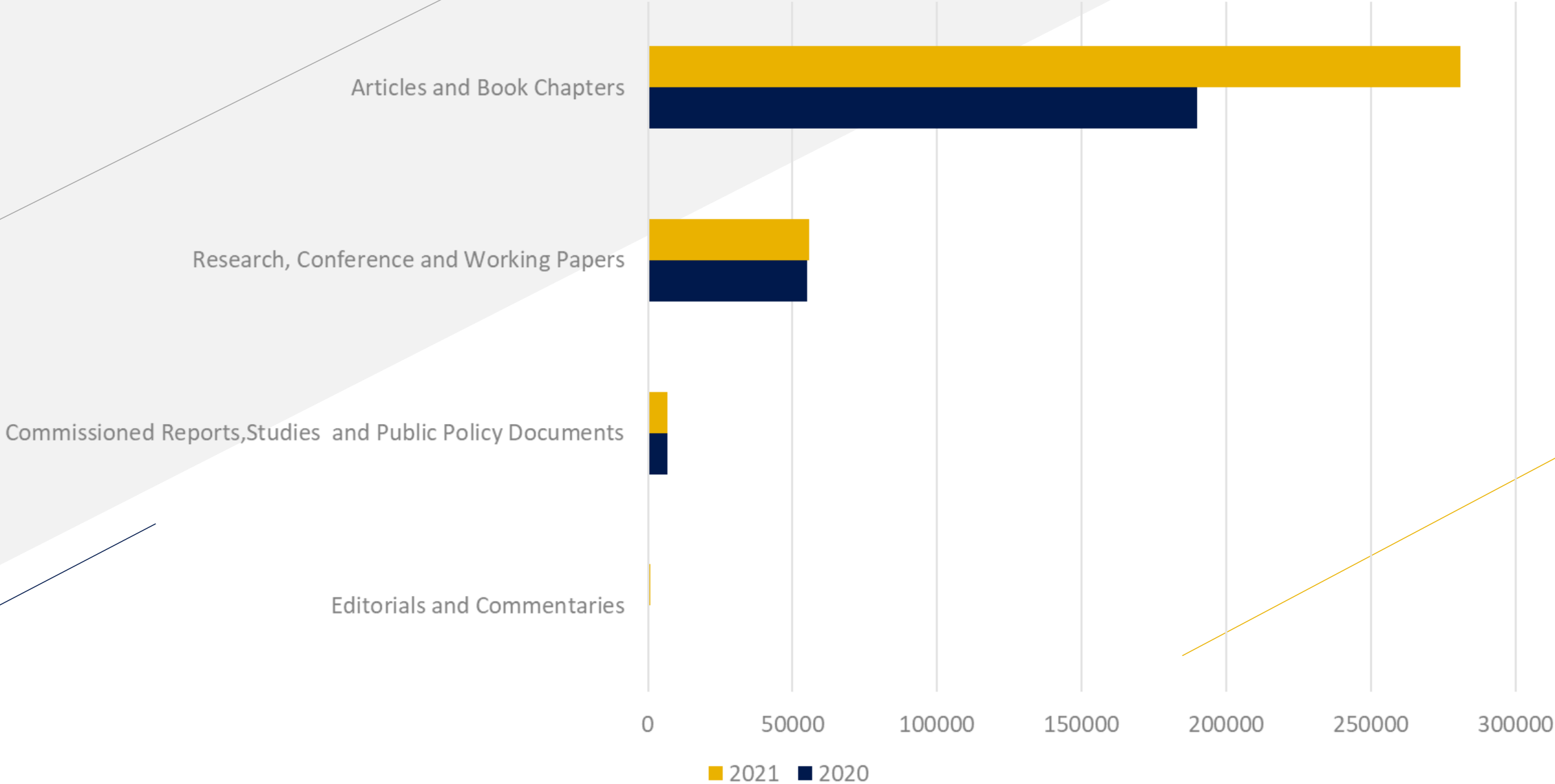

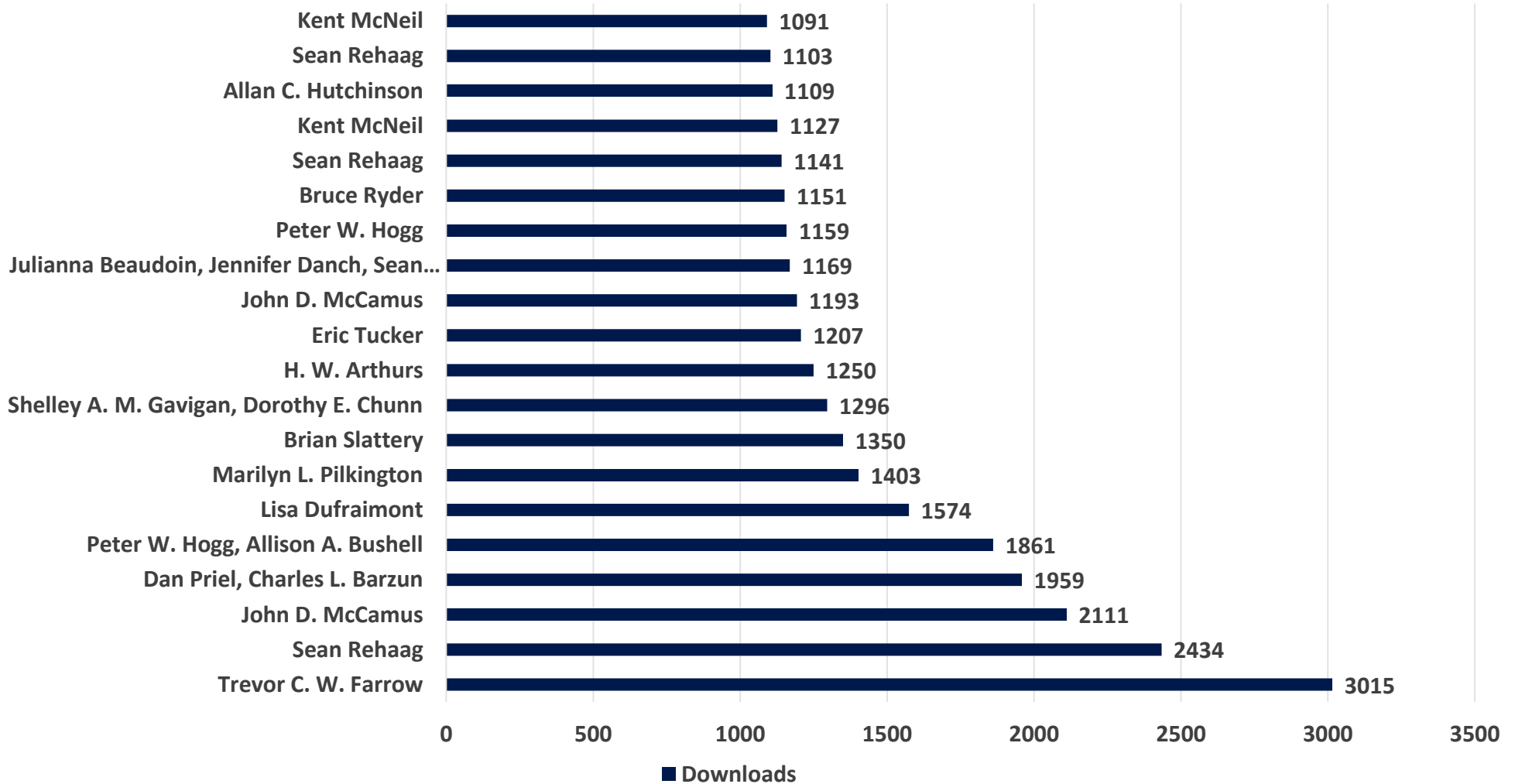

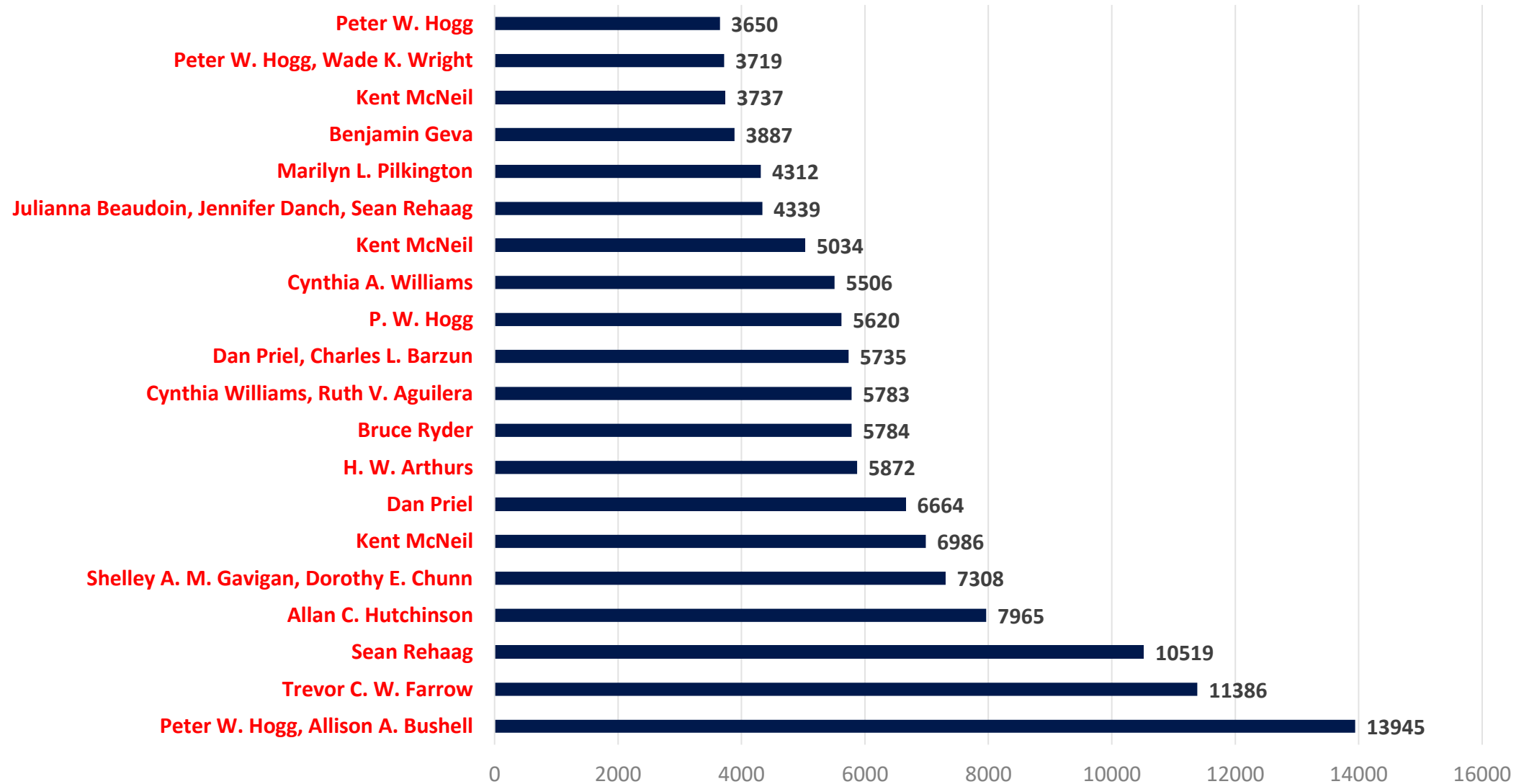

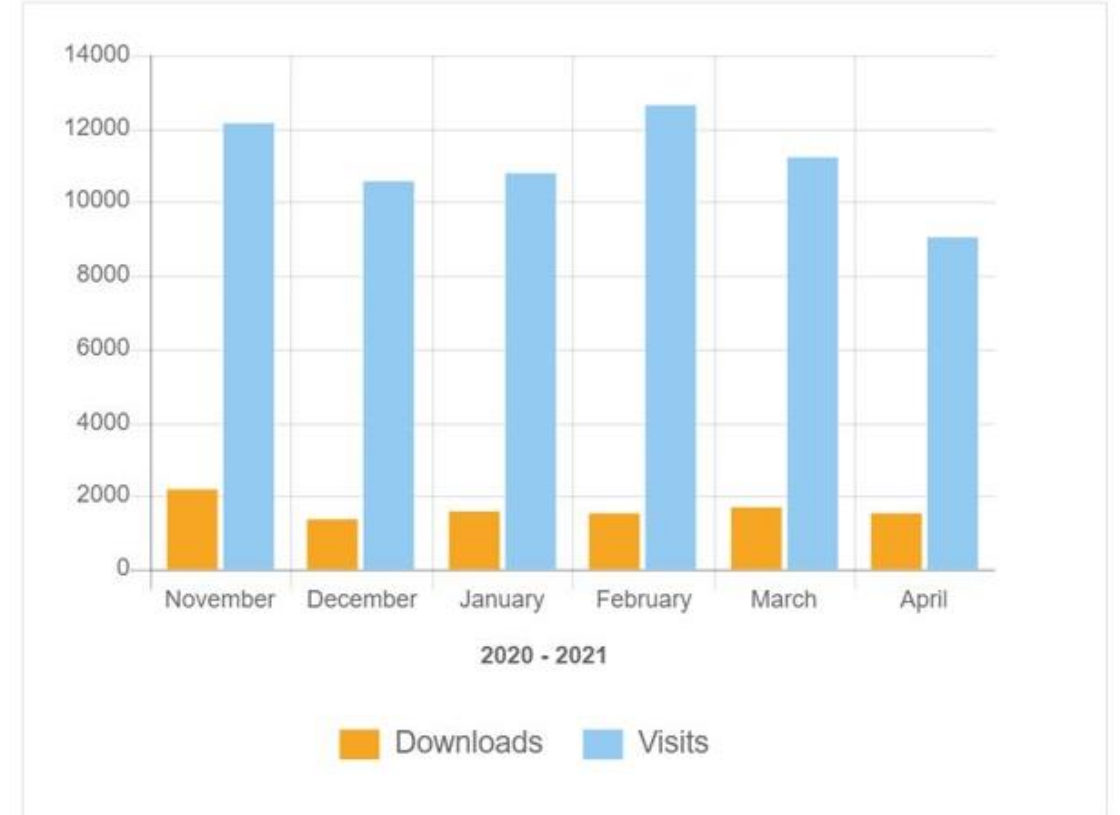
## Geographical Distribution of Downloads & Subscribers

Unique page visits and downloads for individual papers.

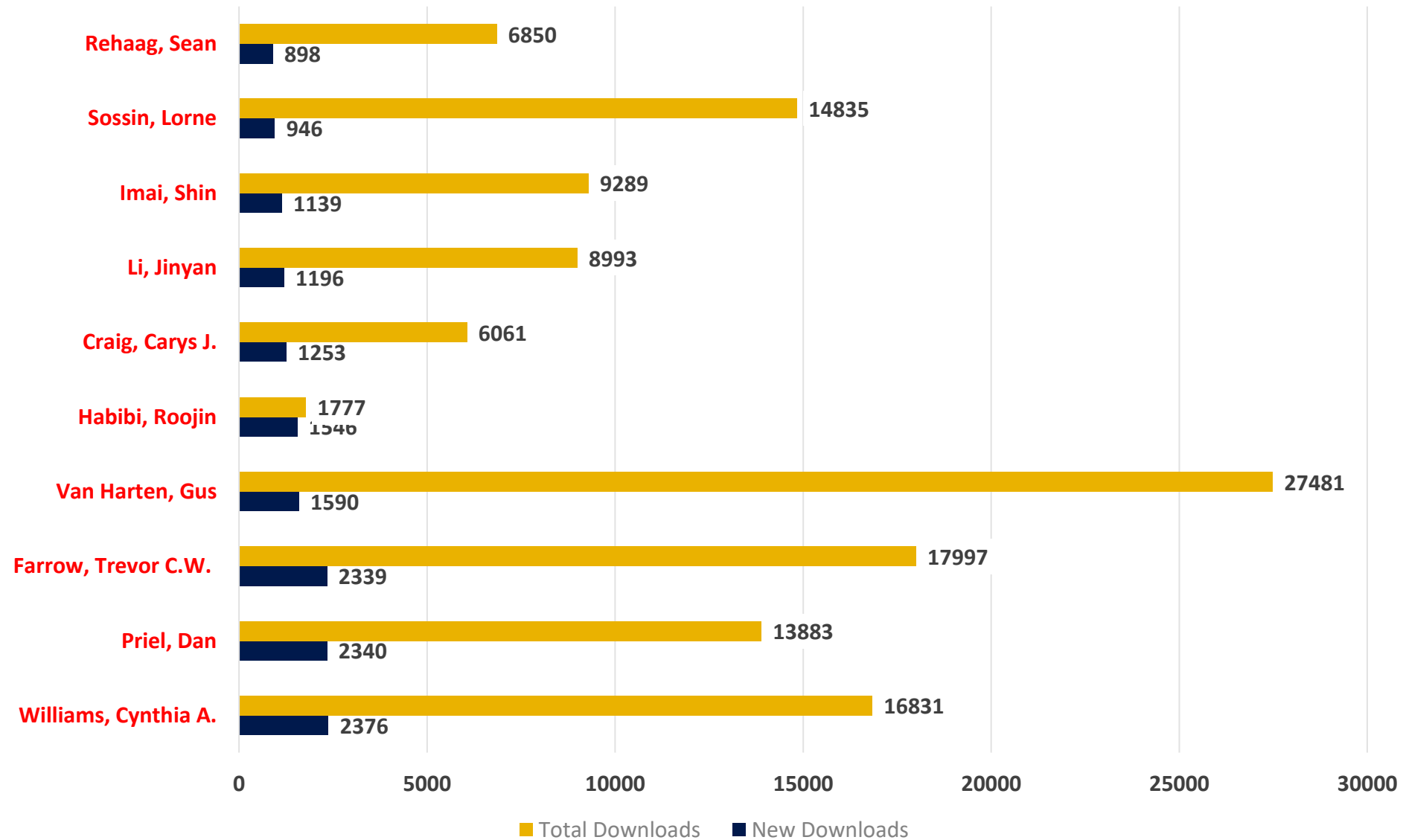
