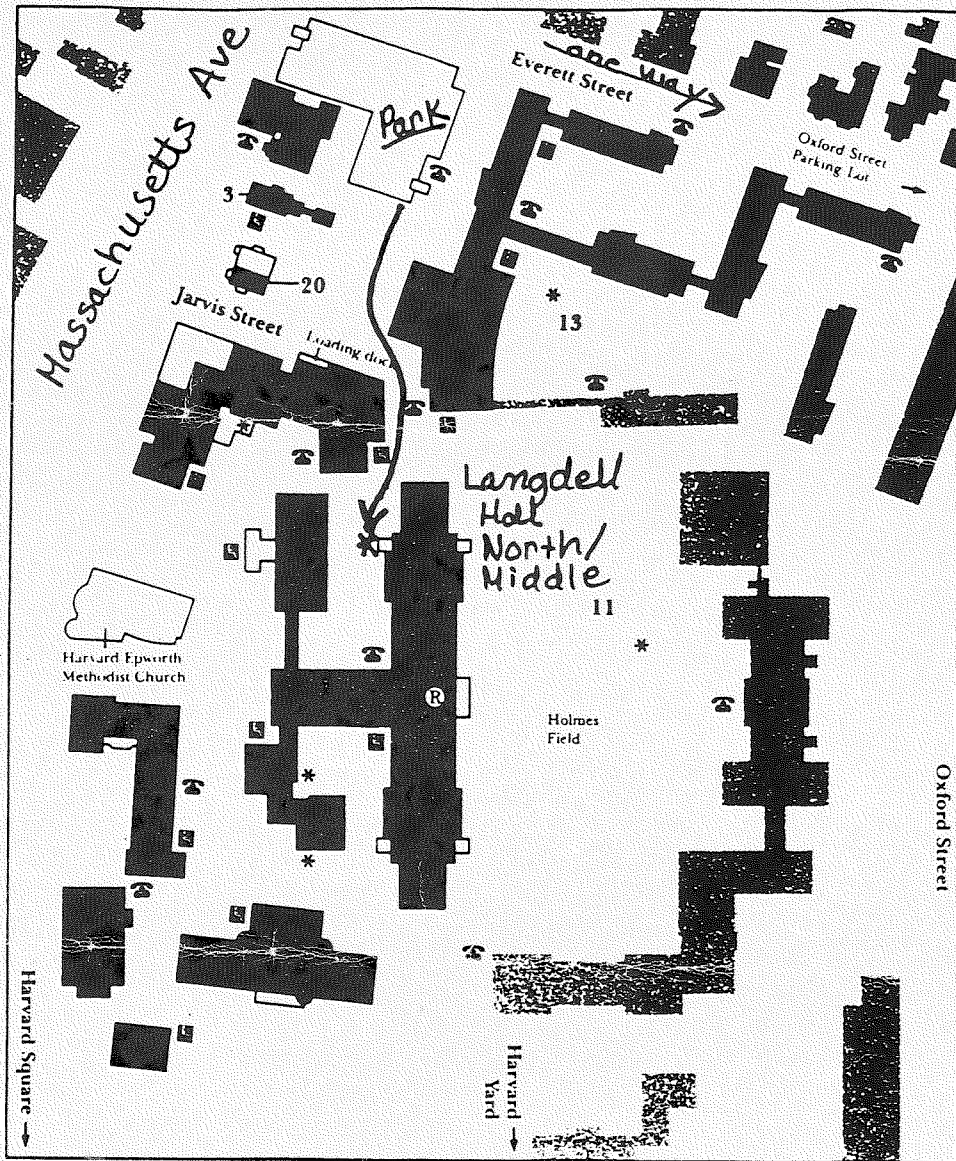

Map of the Harvard Law School Building complex and parking directions:

Use the Everett Street Garage located at the top of the map. Enter from Everett Street, which is a one way street off of Massachusetts Ave. Make an immediate turn to your right and an attendant will be at the garage entrance. There is no charge for parking to this event.
