7 Whereas, The Associated Students of the University of Montana (ASUM) adheres to a model
8 emphasizing trust and transparency among students, faculty, and staff;

9
10 Whereas, In order to fulfill the tenant of transparency it is important for the names of all ASUM
11 boards, councils, agencies, and committees to accurately reflect their purpose;

12
13 Whereas, The purposes of ASUM committees are continually changing and the names of those
14 committees should reflect those changes;

15
16 Whereas, The Kless Revolving Energy Loan Fund (KRELF) is one of those committees that has
17 changed;

18
19 Whereas, The KRELF committee now actively funds projects that pertain to broader
20 sustainability issues than just energy conservation;

21
22 Whereas, It is important to honor the legacy of Sonny Kless and the rest of Sonny Kless's family
23 due to their support of ASUM, KRELF, and sustainability efforts in general;

25 Whereas, The importance of keeping the Kless name in the title of the fund cannot be
26 overstated;

28 Whereas, The lack of student engagement and general student knowledge about KRELF has
29 been a persisting issue;

31 Whereas, The title of an ASUM Agency, an ASUM paid position and a University paid position
32 all include the word "Sustainability";

34 Whereas, Article V, Section 23 of the ASUM Bylaws currently reads, "Section 23. KRELF
35 Committee";

37 Whereas, The title "Kless Revolving Energy Loan Fund" is agreed on by committee members to
38 be outdated and inaccurate;

40 Therefore, Let It Be Resolved, That Article V, Section 23 of the ASUM Bylaws be amended to
41 read "Kless Sustainability Fund";

43 Therefore, Let It Be Further Resolved, That all subsequent mentions of the committee be
44 changed to read "Kless Sustainability Fund" in the ASUM Bylaws;

46 Therefore, Let It Be Further Resolved, That this resolution be sent to Gwen Coon, ASUM Office
47 Manager; Madeleine Jones, ASUM Sustainability Coordinator; Eva Rocke, University of
48 Montana Sustainability Coordinator.
