Kaphaja Kasa, a disease of Pranavaha Strotas is a variety of Kasa where early intervention is of paramount importance in the field of medicine. According to Ayurveda, Kasa is an independent disease. This is the Excellency of Ayurveda, because Ayurved not only mentioned Kasa as a symptom in various diseases, but also described it is an independent Vyadhi with its separate pathogenesis, signs, symptoms, types and treatment. Shamana is the easiest and economical therapy for Kaphaja Kasa. For that Charakacharya mentioned Katu, Ruksha, Ushana Kaphaghna Dravya.^[1] So in this study we evaluated efficacy of Chitrakadi Churna in the management of Kaphaja Kasa as mentioned in Bharatbhaishjya Ratnakar Grantha.^[2]

MATERIALS AND METHODS

Patients - 60 patients will be selected by simple random sampling method with sign and symptoms suggestive of *Kaphaja Kasa* irrespective to their age, sex, occupation, religion.

Drug - Chitrakadi churna

Method of administration of drug

Selection Criteria

- 1. The 60 pts who fulfill the inclusive criteria and classical *Lakshanas* of *Kaphaja Kasa* will be selected for present study.
- Among all the selected who will be legally mature and every patient will be asked to sign voluntarily the written consent.
- 3. Selected 60 pts randomly for present study.

Criteria for selection of patients

A) Inclusion Criteria

- 1. Sex Both Male and Female
- 2. Age Between 18 to 60 yrs
- 3. Patients with sign and symptoms of Kaphaja Kasa.
- **B)** Exclusion Criteria
- 1. Patients with severe systemic disease like IHD, DM, Liver disease, CVA, T.B, HIV, Ca lungs.
- 2. Psycotic patients.
- 3. Garbhini and lactating mothers.

Sign and symptoms such as Shtivan, Angagaurav, Utklesha, Chardi, Mandagni, Jwara, Kasa Vega, Swaskashtata was adopted for assesement.

So it can be said that *Chitrakadi Churna* had good efficacy in treating *Kaphaja Kasa*.

After the completion of this present clinical study it can be concluded that *Chitrakadi Churna* is effective in the management of *Kaphaja Kasa*. It reduces the symptoms of *Kaphaja Kasa*. Clinically no adverse reactions were seen due to this drug. *Chitrakadi Churna* is well tolerated by patients of different types of *Prakruti*. Thus we can conclude that *Chitarkadi Churna* can be one of the main drug of choice in the management of *Kaphaja Kasa*.
