COURSE INFORMATION

Course Description: Introduction to Forensic Psychology is multidimensional, demonstrating how to analyze psychological knowledge and research findings and apply these findings to the civil and criminal justice systems. This course will introduce students to research-based forensic practice and application which they will utilize to define and explore forensic psychology. Students will be introduced to emerging specializations within forensic psychology, including investigative psychology, family forensic psychology, police and public safety psychology. Research related to bias, diversity, and discrimination are included throughout the course to give students a multicultural perspective that is critical to understanding the practice of forensic psychology.

- Understand theories of behavior (normal and deviant) and apply them to the forensic setting which is applicable.
- Understand the different areas and subspecialties of forensic psychology and its practice.
- Gain a multicultural perspective of forensic psychology and how it impacts behavior.
- Understand the connection between forensic psychology and the justice systems, both civil and criminal.

Attendance Policy: Attendance at classes will be recorded and is mandatory. Each class is a learning experience that cannot be replicated through simply "getting the notes." You are expected to read the relevant chapter(s) and/or reading assignment(s) prior to the lecture. Students who participate in the lectures will receive points towards their class participation grade.

Homework Policy: Homework is an expectation of the course. The homework problems set by the instructor are to be handed in for grading and will be used in the determination of the final letter grade as described above.

Quizzes: Four (4) quizzes will be given during the semester. You will have until the next day following class to complete the quiz on your own time. The quizzes will be material from the lectures and reading and done online via Lockdown Browser and Respondus Monitor. You will need a computer and good internet connection when taking the quizzes.

Exams: There will be one midterm exam and one final exam held in class during the semester. The following exam periods are tentative and therefore possibly subject to change:

Final Exam	December 21, 2021

The final exam will test your knowledge of all the course material taught in the entire course.

Presentation: This assignment is for you to select a topic in forensic psychology, identify a criminal with a forensic psychological diagnosis, their crime and explain how they ended up in the judicial system and what was the outcome of their case. The presentation is designed to evaluate your public speaking skills and your understanding of the forensic psychology of the criminal. The presentation should be approximately 20-30 minutes in length and 20-25 power point slides. You must get approval from me for your presentation/person by October 1, 2021. No two people may choose the same topic/psychological disorder/person/case. The presentation will be given in alphabetical order by last name and during the last two class sessions. You must also turn in the presentation using Turnitin.com.

- 1. Choose a topic in forensic psychology or deviant behavior and develop an explanation of your topic.
- 2. Analyze a relevant criminal who has your chosen behavior or illness and explain in detail what the illness is and how it impacted the person you are writing about.
- 3. Create a timeline of events showcasing the illness and how it impacted this person's life and eventual crime.
- **4.** Provide credible academic and peer reviewed sources (at least 3 and current). You may use other sources in addition.
- **5.** Communicate effectively through your slides and bullet points. Do not read off your slides during your presentation as you should be very familiar and comfortable with your topic. Pictures are acceptable.

Makeup Exam Policy: There will normally be NO MAKE-UP QUIZZES OR EXAMS during the semester. In the event that a student has a legitimate reason for missing a quiz or exam, the student should contact the Dean of Students office and present written verifiable proof of the reason for missing the exam, e.g., a doctor's note, police report, court notice, etc. clearly stating the date AND time of the mitigating problem. The student must also notify the CES Department Office/Instructor that the exam will be missed so that appropriate steps can be taken to make up the grade.
