ABSTRACT:

The weatherization training for the State of Florida Dept of Community Affairs continues at the Florida Solar Energy Center's Training Facility. Progress for the fifth three months of the contract included minor course refinement of presentation materials and handouts as the result of the June 2010 updates to the P & G. Four I-day IR classes were completed (45 students).

INTRODUCTION:

The contract to provide training for the weatherization inspectors was assigned on July 10, 2009. The scope of work includes:

- Five (5) days of classroom and hands-on training per student to perform building diagnostics in accordance to the prescribed reference materials provided by DCA Weatherization Program. This includes health & safety concerns, combustion safety, building airtightness, insulation, ventilation concerns, duct system evaluation, and appliance measures.
 - Class size currently limited to 18 students per session with expectations increasing class size to 40 students as soon as possible.
 - Course will be divided into 4 main sections: Weatherization Introduction, Health & Safety, Building Diagnostics and Weatherizing Homes.
 - o Each of the four sections will have an evaluation that is both written and practical.
 - Appropriate handouts for each section.
 - A short remedial training (up to 2 hours) with retest if needed after each section (beginning of following day).
 - o Each student the course will receive a certification of attendance.
 - o Report of student assessment will be provided.
 - o Lunches will be provided
 - o Course training will be presented via LCD projector, hands-on module and field testing of a house with combustion appliances.
- Short video training segments (up to 5) providing information on various diagnostic procedures. These may include the following topics:
 - Basics of blower door testing
 - Basics of duct system testing
 - Combustion appliances and safety
 - Zonal pressures and air barriers
 - Form completion
- Follow-up field evaluations on students who have passed the five day course.
 - Review of diagnostic testing and forms
 - Review of recommendations
 - Review of completed work inspection
- Provide an "on call" expert to help with in field diagnostics (up to 600 hours for first year).
 - Support provided via telephone and email.
 - An experienced Building Scientist will be available to coach caller to the solution or provide feedback within I business day.
- Revision/extension
 - o Provide training for an additional 50 students
 - o Provide an additional one day course "IR Camera Basics"

ACCOMPLISHMENTS:

Training: In the third quarter of 2010, no classes were held. The next training class has been set for the 18th of October. The training materials have been updated to reflect the changes found in the June2010 Procedures and Guidelines.

IR Training: The one day IR training course was given four times this quarter (July 19th 20th 21st and Aug 11th). A total of 45 students attended this quarter (71 overall).

FIELD QC REPORTING

Dennis Stroer and Jon Klongerbo of Calcs-Plus (a subcontractor to the project), continue to perform the field QC and on call phone services. Since the last quarterly report, 7 field QC inspections were performed throughout the state. Following is their report.
