- **A.** Title IX Whittier College Sexual Misconduct Policy and Procedure Review -Lafayette Baker J.D. Associate Dean, Title IX Coordinator
  - 1. The principal objective of Title IX is to avoid the use of federal money to support sex discrimination in education programs and to provide individual citizens effective protection against those practices.
  - **2.** In may 2020 the US Department of Education released new regulations governing campus sexual assault under Title IX.

# **Mandated Reporting**

- ▶ College faculty, staff, and student employees when working, are expected to report actual or suspected discrimination or harassment to appropriate officials immediately.
- What you should do as a Mandated Reporter?
- ▶ Who to report to?



#### Notice/Complaints of Discrimination, Harassment, and/or Retaliation

- Notice or complaints of discrimination, harassment, and/or retaliation may be made:
  - ▶ 1) File a complaint with the Title IX Coordinator, or Deputy Title IX Coordinators.
  - ▶ 2) Report online, using the reporting form posted at:

**3.** The Title IX coordinator initiate at least one of three responses: offer supportive measures, informal resolution, or formal grievance process

# Supportive measures

- Supportive measures, can include:
  - Referral to counseling, medical, and/or other healthcare services
  - Referral to community-based service providers
  - Visa and immigration assistance
  - Student financial aid counseling
  - Altering campus housing assignment(s)
  - ▶ Altering work arrangements for employees or student-employees
  - Safety planning
  - No Contact Directives
  - ▶ Class schedule modifications, withdrawals, or leaves of absence



### Informal resolution

#### Informal Resolution:

- ▶ Alternative resolution mechanism such as mediation or restorative practices, usually before a formal investigation takes place.
- Respondent accepts responsibility for violating policy, and desires to accept a sanction and end the resolution process (similar to above, but usually occurs post-investigation, and prior to a hearing.

#### **4.** Formal Grievance has the Investigation process and the hearing process.

- a) Once the decision to commence a formal investigation is made, the Title IX Coordinator appoints Pool members to conduct the investigation, typically using a team of two Investigators.
- b) For the Hearing, the Title IX Coordinator will designate a three-member Hearing panel from the Pool. One of the three members will be appointed as Chair by the Title IX Coordinator.

#### **5.** The Advisor:

- a) *Advisor* means a person chosen by a party or appointed by the institution to accompany the party to meetings related to the resolution process, to advise the party on that process, and to conduct cross-examination for the party at the hearing.
- b) The Advisor may be a friend, mentor, family member, attorney, or any other individual a party chooses to advise, support, and/or consult with them throughout the resolution process.
- c) The parties may choose Advisors from inside or outside of the College community.



### Cross-examination

- Colleges and universities will now be required to allow cross-examination of the complaining and responding parties, as well as any witnesses, during a live hearing.
- Cross-examination will be conducted by advisers for parties, including legal counsel, but not the parties themselves.

### Retaliation

► The College and any member of the College community are prohibited from taking or attempting to take materially adverse action by intimidating, threatening, coercing, harassing, or discriminating against any individual for the purpose of interfering with any right or privilege secured by law or policy.

### Consent

#### Consent is:

- knowing, and
- voluntary, and
- clear permission
- by word or action
- to engage in sexual activity.



### Consent

- Affirmative consent means affirmative, conscious, and voluntary agreement to engage in sexual activity.
- ▶ Individuals may experience the same interaction in different ways. Therefore, it is the responsibility of each party to determine that the other has consented before engaging in the activity.

### Incapacitation

- ▶ A person cannot consent if they are unable to understand what is happening or is disoriented, helpless, asleep, or unconscious, for any reason, including by alcohol or other drugs.
- A Respondent violates this policy if they engage in sexual activity with someone who is incapable of giving consent.

# Preponderance of the evidence

- ▶ Many legal scholars define the preponderance of the evidence standard as requiring a finding that at least 51% of the evidence shown favors the plaintiff's story and outcome.
- Another way to think of the standard is to simply ask whether the plaintiff's proposition is more likely to be true than not true.



#### 6. Prevention and Outreach Programs:

- a) The College will implement comprehensive prevention and outreach programs to address issues of sexual harassment, sexual violence, domestic violence, dating violence, and stalking.
- b) These programs will include but are not limited to, information about the Colleges policies and procedures, rights and responsibilities, the practical implications of an affirmative consent standard, empowerment programming, awareness-raising campaigns, primary prevention, bystander intervention, and risk reduction programs.
