Peer-reviewed journals in public health are important vehicle of scientific information [1]-[8]. Currently, there are more than 136 titles in the Public, Environmental and Occupational Health category in the Social Sciences Citation Index. It is expected that their number will continue to increase, as many publishers wish to invest in electronic publication with open access model. In this model, the authors cover all or part of the cost of the publication of their paper.

There are several differences between Peer-reviewed journals in public health [3],[4]. These include for example, the scope of the journal, the sponsoring society, the frequency of publication and the language.

The top 5 journals in public health in 2013 as reported in Journal Citation Reports (JCR) Science and Social Science Editions, Institute for Scientific Information, Subject Category: Public, Environmental and Occupational Health International, were as follow: Journal of Epidemiology (Impact Factor,9.197), Epidemiologic Reviews, Environmental Health Perspectives, Annual Review of Public Health, and Epidemiology.

In Table 1, we tried to shed some light on selected current peer-reviewed periodicals in public health. In our listing we tried to include only the journals with a wider scope rather than public health journal focusing on particular aspect of public health like those focusing on epidemiology only.

Needless to say that there are many challenges (which are not in the scope of this report) facing these periodicals [7],[8]. For example the utilization of internet and technologies to allow their contents to be available in social media website and e-mail and to be reached easily in cell phones.

Raising the impact factor and inclusion in the PubMed remain an important task for the newly launched journals.
