






Familiarise yourself with the principles

- NIHR defines public involvement in research as being carried out WITH or BY members of the public (not to/about/for them).
- **Involvement** is sometimes confused with:
 - **Engagement** (dissemination and raising awareness of research or its findings).
 - Participation (requires consent and ethical approval).

Public involvement in our study



- Lay co-applicant Mr John Potts
 - Identify and prioritise the aims and objectives of the partnership.
 - Draft and review the Plain English Summary.
 - Gain support for from other public groups.
 - Respond to panel and peer review comments.
 - Co-lead PPI Working Group with Gina Walton (KCC)....

PPI Working Group

- 8-10 people with lived experience of adult social care:
 - People using services
 - Informal carers
 - Volunteers/retired care workers
- The group will
 - Help agree strategic research priorities for the partnership priority setting.
 - Consult on themes and activities regarding Communities of Practice.
 - Review fellowship pilot projects and partnership funding applications.
 - Opportunities for co-research within funded projects.
 - Support wider dissemination.

All working group members will be paid by Kent County Council for their time at INVOLVE rates (£150 per day or £75 per half day).

Study Steering Committee

- Three people with lived experience
 - 2 informal carers of people who have used social care
 - 1 person using social care services.
- All steering committee members will be paid by University of Kent for their time at INVOLVE rates (£150 per day or £75 per half day).

Training and Support

- Innovation Delivery Team at KCC testing new training scheme with Health Education England.
 - Blends insights from leadership psychology and communication with techniques used by professional performers.
- 1-day training course can help Public Involvement representatives feel more confident in multi-stakeholder meetings and events.

Types of involvement

- Identifying and prioritising
 - From proposal stage
 - Through communities of practice.
- Developing funding applications
 - Review applications and have opportunities to be co-applicants.
- Managing and undertaking research
 - Study Steering Committee (managing)
 - Opportunities for co-research (undertaking).
- Evaluating the research
 - One working group member will be involved in evaluation of the programme.
- Dissemination and impact
 - Invited to contribute to outputs, presentations, write blogs, speak at events....

My experiences of being involved

- Already had strong networks with the sector:
 - Adult Social Care People's Panel
 - Chair of the Patient and Public Advisory Group (Kent and Medway Strategic Transformation Project)
- Invited to the first meeting by Gina Walton, KCC.
- Complete access to every stage of the process.
- Given time to participate in a comprehensive manner.
- Appointed as a member of the study's Senior Management Group and joint lead of the PPI Working Group.

Top Tips

Researchers

- Ensure you have sufficient time to involve people properly.
- Involve people in every stage (not just 'here's a summary').
- Listen to and value the advice public co-applicants/advisors give you.
- Support your public involvement representatives (training/pre-meetings).
- Recognise and value involvement by paying people for their time.

Public involvement representatives

- Be confident in your views and experience.
- Don't be afraid to ask for help.
- Challenge the research team and make sure you fully understand the issues.
- Use your networks and personal experience.
