Dr. K Venkatagiri Gowda obtained his Bachelor's and Master's Economics from the University of Mysore and Ph.D in Economics from the London School of Economics. He began his career as a Lecturer with the University of Mysore, where he went on to become Reader from 1967 to 1983, he worked as Professor and Chariman of the Dept. of Economics in Bangalore University. He had specialisation in Monetary Economics and International Finance.

His works have been internationally acclaimed as definitive and path breaking in the area of Monetary Economics, International Finance and Planning. He published the following books: Fiscal Policy and Inflation (1959), Appreciation of the Indian Rupee (1960), Keynes-Triffin Plans for International Liquidity (1961), European Common Market and India (1962), Commonwealth Common Market (1963), International Currency Plans and Expansion of World Trade (1964), Euro-Dollar Flows and International Monetary Stability (1979), A Plan for Eradication of Black Money and Black Wealth (1983), Perestroika and Glasnost for India (1988), Democracy in Deficits (1995), New Dimensions for Indian Planning (1995), Economic Performance of the Government (1997).

Professor Gowda was an incisive man par excellence. His economic analysis on the budget was greatly valued by the economists and administrators in the country. He was invited by the Government of U.S.A. to deliver lectures on "Oil Crisis" in U.S. Universities.

He represented the Bangalore South Constituency (from BJP) in the Lok Sabha during 1991-96. As a Member of Parliament, his contribution to the economic policy was substantial. I was closely associated with Prof. Gowda for nearly three decades. I had the opportunity to be his Doctoral Pupil from 1986-89. I used to have long and frequent discussions with him. He possessed an uncanny analytical ability and a perfect command over English. Prof. Gowda received Lord Leverhulme Special

Research Award, London School of Economics. In 1983, he received the Karnataka Rajostava Award.

He was a great scholar and perfectional, known for his sincerity and honesty. His scholarship, frank opinions and expertise in economics was always appreciated by the prime ministers of our country. His five decades of crusade to bring about economic reforms in our country will never go unnoticed in the annals of our history.

The present book is a collection of memoranda of Professor Gowda mostly addressed to the Late Hon'ble Prime Minister Sri P V Narasimha Rao and the present Hon'ble Prime Minister Sri Manmohan Singh, during 1991-96.


