#### Dear Matthew,

We want to let you know that there have been some updates at UMaine, effective today, October 15, 2021. We'd like to thank you for your continued patience and understanding.

Per University of Maine System Guidance, the following COVID-19 protocols and guidelines have been put in place at the Collins Center for the Arts.

### For all performances and events:

- Attendees must wear masks at all times when inside the Collins Center for the Arts or Hudson Museum except while eating or drinking.
- Patrons are encouraged to purchase tickets to events prior to the performance and are encouraged to arrive early.
- Stay home if experiencing any symptoms of COVID-19.

#### Additional guidelines apply depending on the anticipated number of attendees:

For events with an expected number of 250 attendees or fewer, including: Met Opera, NT Live broadcasts, and chamber music concerts:

• To facilitate distancing, certain rows will be unavailable for seating and we ask that you leave two open seats between you (or your group) and the next closest person.

For events with an expected number of 250 attendees or more, including: John McCutcheon, A Very Electric Christmas, Jay Leno, Choir of Man, Nobuntu, Cirque FLIP Fabrique, Robert Cray, Martina McBride, and Anne of Green Gables – The Ballet:

 Attendees must provide proof that they are fully vaccinated with an FDA approved COVID-19 vaccine.

-OR-

Provide proof of a negative COVID-19 test, which includes a negative PCR test or rapid

antigen which must be administered within 72 hours of the start of the performance or event. NOTE: Children under the age of twelve (12) will not be required to provide proof of a negative COVID-19 test or a valid COVID-19 vaccination.

- Attendees must present valid ID alongside above proof of vaccination or negative test.
- The University of Maine reserves the right to request additional screening of patrons prior to
  entering the building, including children under the age of 12. The additional screening would
  consist of being asked a short list of questions related to COVID-19 symptoms and a
  temperature scan that must have a reading of 100.4 Fahrenheit or lower to be granted entry.
- If unable to provide valid proof of vaccination or a valid negative test, or if unable to pass the enhanced screening, guests will be turned away from the event.

## For all Bangor Symphony Orchestra concerts:

Provide proof that they are fully vaccinated with an FDA approved COVID-19 vaccine,

-OR-

- Provide proof of a negative COVID-19 PCR test conducted within 72 hours of the
  performance start time or a negative COVID-19 rapid (antigen) test within 12 hours of the
  performance start time. This includes children under 12 who are not yet eligible to be
  vaccinated.
- Present valid ID alongside above proof of vaccination or negative test.
