

<u>ROLE OF PARA-LEGAL SERVICES IN ADMINISTRATION OF JUSTICE:</u> <u>AN EMPIRICAL STUDY OF GWALIOR DISTRICT</u>

Abstract:

In today's context, rule of law is in existence, subjecting to principle of natural justice, equity, justice, good conscious & morality in Democratic and republic India. Para-Legal Services have got the most specific in primary role in administration of justice as a back bone in delivery of justice. Law is the means & it is having the highest goal of justice. This Research paper has been focused and emphasized on The Role of Para-Legal Services in Administration of Justice: An Empirical Study of Gwalior District. Gwalior is situated in heart of India namely The State of Madhya Pradesh. Gwalior is a division including Gwalior itself. This Research has been conducted with respect to Institutions/colleges/universities where LL.B./ B.A.LL.B./ B.Com.LL.B./ B.B.A.LL.B.(5Ydc) & LL.B (3Ydc) namely Legal/Law education are being conducted in accordance with UGC rules & regulations& approval of Bar Council of India's rules & regulations. With this respect this research reveals the genuine conditions or other related facts of Para-Legal Services, Its conduction, legal aid clinics Para-Legal Aid clinics, Para-Legal Training, Education, Literacy, Awareness, Accessibility, Paralegals, Volunteers & other connected things with it. This research paper is beneficial, useful and helpful for professors, Lecturers, teachers, researchers, students, NGO's, Trusts, Governments, Organizations, Commissions, Institutions, Colleges, Universities, Establishments and others connected there with.

Introduction:

In present scenario Para-legal services are playing a key and significant role in administration of justice as one of the major foundations, ensuring its own specific place to ensure the ends & delivery of justice in India. The concept of Para-Legal services is as old as administration of justice. Para-Legal & Legal –Aid services are correlated, inter connected, complement & depend on each

other. The Para-Legal services have been developed by looking at Para-military forces which were created for help of military in emergency and also in medical fields as Para-medics in India. The Implementation of Legal aid services, schemes, programs, legal services or other connected things in administration of justice is not possible without paralegals and Para-legal services. Paralegals are the major and integral organ of Para-legal services and legal system. It is relevant to mention over here that Legal Services means "literally legal service means help or assistance or free services in the field of law. Previously the word legal aid was used in place of legal service but the Apex Court of India from time to time asserted that legal aid is not a charity but a paramount duty of a welfare State. Now legal assistance from State can be claimed as matter of right, therefore, the word legal service is being used in place of legal aid. Some of the jurists considered legal services as legal assistance to needy persons."³

AN EMPIRICAL STUDY OF GWALIOR DISTRICT:

There are the five districts in Gwalior division and the data analysis of Gwalior district is as under:

Gwalior District:

Gwalior is located at 26.22 N 78.18 E. It has an average elevation of 197 metres (646 feet). Gwalior is a historical Indian city - is located on the periphery of Madhya Pradesh State, 321 Kms (199.5 Miles) from Delhi and 121 Kms (76 Miles) from Agra.Gwalior is a city in Madhya Pradesh in India. It lies 76 miles (122 km) south of Agra. Gwalior occupies a special mention in India's medieval history and freedom struggle. The city also enjoys a unique position with regard to education and boasts of several colleges and schools well known across the country.Gwalior occupies a strategic location in the Gird region of North India, and the city and its fortress have served as the center of several of North India's historic kingdoms. At present also its strategic location is marked by the presence of major air base at Maharajpura. Gwalior is the administrative headquarters of Gwalior district and Gwalior division.⁴At the heart of Gwalior is its fortress (Gwalior Fort), built by Raja Man

Singh Tomar, of the Tomar dynasty. This formidable structure had the reputation of being one of the most invincible forts of India. It occupies an isolated rock outcrop. The hill is steepened to make it virtually unscalable and is surrounded by high walls which enclose buildings from several periods. The old town of Gwalior lies at the eastern base of the fortress. Lashkar, formerly a separate town that originated as a military camp, lies to the south, and Morar, also a formerly separate town, lies to the east. Gwalior, Lashkar and Morar are presently part of Gwalior Municipality.⁵

1. <u>Organization the Legal-Aid & Para-Legal Services at District Legal Services Authority</u> <u>&Tahseel Legal Service Committee, District Gwalior MadhyaPradesh:</u>

On the perusal of the conferred pieces information by the District Legal Services Authority Gwalior in the year of 2012-13 to 2016-17 reveal that Legal-Aid & Para-Legal Service are implemented by District Legal Services Authority Gwalior, Tahseel Legal Services committees are organizing the Legal Literacy and Legal-Aid camp at urban, rural and remote areas of District Gwalior like that Ghatigaon, Badagaon, Aron, Barai, Sitholi, Hastanapur, and Colleges, Communities centers etc.⁶ The data relating to all aforesaid is as under the table no.02from the year 2012 to 2017 till February Month details are given below.....

1. M.L.B. Govt. College of Excellence, Gwalior, Madhya Pradesh:

It is one of the oldest colleges of Gwalior which situated in heart of Gwalior near Achlewar Temple Gwalior is offered the courses as follows B.A.LL.B. (5Ydc), LL.B.(3Ydc), LL.M. and it also are our research center for doctorate Ph.D. in Law. Legal-Aid Clinic and Para-Legal Services have been established in this college. Some activities in respect of Legal-Aid and Para-Legal services and other connected things are conducted in it but it has been observed that the above same has not been found as requisite or required and the conditions of Legal-Aid clinic, Para-Legal Services, Programs, services, schemes, Legal Literacy, Paralegals, Volunteers and related things with it are not satisfactory and the same is very less or little or equal to nothing in accordance with requirements, rules, regulations, laws other facts or things connected, time & circumstances. This regard, besides above the affirmative efforts of Dr. Vinod Kumar Shirotriya for Legal & Para-Legal Services are worth appreciating.

2. Govt. Kamla Raja Girls Post Graduate (Autonomous) College, Gwalior, M.P.:

In this college only B.A.LL.B. (5Ydc) under its self-finance scheme is conducted. Legal-Aid clinic has been established in this college in June 2016 but the same could not start to function. In this regard, Legal- Aid cell has also been constituted on dated: 23.06.2016. The place/venue for the above same is fixed in a room of gallery of Central Library of this college. No activity has been conducted with respect to Legal-Aid clinic, Para-Legal Aid Clinic, Services and also other connected things in college according to rules, regulations & laws respective.

3. Amity University Maharajpura, Gwalior:

It is a private State university and situated in Maharajpura, Gwalior. In this connection, same activities in respect of Legal-Aid and Para-Legal Services are conducted in Legal study centre room no. 208-A, Block-B, in the premises of the university but the required data/ details or other relevant records have not been furnished by the university.

4. MadhavVidhiMahavidhyalaya, Mahatma Gandhi Law College, Gwalior Law College, SarveDharam Law College, Institute of Law (SOS), Jiwaji University & I.T.M. University, Gwalior, Madhya Pradesh:

It has been observed, found & presumed that the activities in respect of Legal-Aid, Legal-Aid clinic, Services, Para-Legal Services, Para-Legal Aid clinic, Training, Literacy and other things related are not conducted as per requirements rule, regulations & connected other things with the




same. The establishment of Legal aid Clinics also is in suspicious condition. It may be presumed that little or very less or nothing is as required according to laws & Norms. The implementation of all aforesaid is in question in the heretofore contained institutions/colleges/universities. With this respect, the required data/details facts/material have not been conferred by the institutions/colleges/universities.

Sample Survey Relating to Awareness of Para-Legal Services to the Masses in Gwalior District:

It has been observed and found that the activities in respect of Legal-Aid, Legal-Aid clinic, Services, Para-Legal Services, Para-Legal Aid clinic, Training, Literacy and other things related are not conducted as per requirements rule, regulations, laws & connected other things with the same. And the data has been collected by using various tools or techniques or methods as: 1. Questionnaire, 2. Interviews, schedule, and other required etc. other rural and urban areas and villages were visited and conducted the interviews & sampling method also has been used and filled-up the questionnaire forms of the people or masses and sample of 40 respondents/persons who belong to rural and urban areas of Gwalior District, Gwalior Division, Madhya Pradesh. 













- 2. The Law/ Legal education system should be varied, changed, amended and reformed as required according to time & circumstances.
- 3. Law Students as paralegals should be made curious, skilled, trained, efficient, proficient and educated more to more for the welfare of all sections of people.
- 4. The Certificates/Diplomas and other connected things of Legal-Aid & Para-Legal services should be initiated and developed to promote and encourage of people.
- 5. Legal-Aid Clinics & Para-Legal Clinics should be constituted and functioned separately.
- 6. Legal-Aid & Para-Legal literacy, knowledge and education should be promoted, developed & researched more to more at the earliest for the same pamphlets, News papers, Magazines, T.V., Radio, Booklets, Hand books, Dairies, Posters and other related things also should be distributed to people or masses for its awareness and accessibility.
- 7. The Awareness, literacy, knowledge, Accessibility towards masses or people should also be given by electronic means as e-media, social media, social sites etc.
- 8. The experienced, eligible, proficient, skilled and efficient trainers should be available to train of Para-Legal Volunteers (PLVs).
- 9. The directive administrative control of District Legal Services Authority on Legal-Aid Clinics are total negative and as equivalent to nothing due to this the conditions of the clinics are the worst and the most miserable furthermore it can be said that the above said clinic are functioning only in documents in some colleges/ institutions/ universities and etc. so the power of administrative control should be exercised properly and strictly.
- 10. The literacy Legal & Para-Legal Services should be spreaded, increase and promoted in all sections of people especially economic weaker, other disable and vulnerable group of persons.
- 11. The system of Legal-Aid & Para-Legal Services clinics and etc. should be reformed, established, reconstituted and amended at the earliest on the grass root level firstly.
- 12. NALSA/SALSA/DALSA/Legal-Aid Committee, Governments, Departments, Organizations, persons, society, establishment and all concerned must take all required necessary steps measures for the same with the co-ordination, help and co-operation of all aforesaid collectively.



Conclusion:

It can be concluded that NALSA/SALSA/DALSA/Legal-Aid Committee, Governments, Departments, Organizations, establishment and persons are functioning but the same is not sufficient in proportion to population of Gwalior district. The conditions of colleges/institutions/universities are worst and most miserable and anxious. Our conducted survey reveals that few persons/masses are having very little information about only Lok Adalat hence it appears that Legal-Aid, Para-Legal services, Clinics, Literacy, Awareness, accessibility, implementation and other related things are in documents only because the required things /facts/activities/ are not being conducted as per requirements, time, necessity, laws and circumstances. The aforesaid must be reformed, amended, varied, altered, reconstituted and done the needful in this matter at the earliest from the very grassroots level for the interest of people/masses and delivery of the required and satisfactory justice to bridge the gap among people/masses, advocates/legal practitioner, judiciary, court an administration of justice in welfare state.
