Introduction

This Resource List is not intended to be an exhaustive bibliography on all aspects of historic preservation, prairie restoration, historic gardening and landscaping. Rather it is designed to be suggestive of the kinds of materials which are available to do all of these praiseworthy activities, and even more important, to indicate that they really belong together in researching historic environments and in planning their preservation, restoration and reconstruction. People are beginning to think of all of these activities under the rubric of "historic environmental preservation." This Resource List is intended primarily for those who want to undertake such work here in the Midwest, especially in Illinois. Thus two of the three main sections concern materials available from or for the region and this state.

The list is comprehensive for anyone intending to restore or reconstruct Illinois environments before 1860. It has been compiled over the past year for particular use at the Clayville Rural Life Center and Museum with partial support coming from the National Endowment for the Humanities.

the numerous articles about aspects of the historic landscape and natural environment in the 1850s listed in Section III.2 will be especially useful in the process of research and planning.

The mode of organization of the sections and sub-sections is the same as that utilized in the other Resource Lists published by the Clayville Center and Museum. Roman numerals designate the general area covered:

I for the United States (and General items in this case), II for the Midwest, and III for Illinois. The arabic numeral in the first decimal place indicates whether the resources are secondary (.1) or primary (.2) in the other lists. Here since the division does not easily hold, the first indicates "twentieth century sources." The next place designates books (.1), periodicals (.2), articles and brochures (.3), and archival materials (.4). Where a catagory has no entries, it is omitted, and the listing simply moves on, as it does repeatedly here, for instance, from .1.1 to .1.3, since no periodicals were included separately.

Bibliographies are assigned the numeral .0 in the first decimal place. The ones cited, especially Jakle's and Marshall's, will take the reader much further into the literature from particular perspectives. Other bibliographies which are very short are included because they are little-known but very valuable. The standard periodicals are not included. The reader may find the names and addresses of publishers of many of them in Resource List No. 11, Museum and Historic Preservation Methods (Springfield: Sangamon State Univ., 1978) along with the names and addresses of key organizations involved in preservation and interpretation in museums and historic sites.
