- Maintaining a working relationship with the Michigan Department of Education.
- Maintaining and furthering development of our program for Parents and Reading, Young Authors.
- 7. Extending the Study of Michigan Authors as an outgrowth of the recent conference.
- 8. Help the MRA Association to become the (Parent) group to the councils through leadership and ex-

panded services. The MRA Board and local council officers retreat is at St. Mary's Lake, August 21, 22, 23, 1978.

The MRA is a vital, working organization. During the coming year we will need to look at the inner development and structure of the organization as we develop the guidelines for implementing the new By-Laws. The new By-Laws call for the following changes:

- A change in officers, Vice-President elect has been added.
- Expansion of Board of Directors by electing eight (8) regional representatives and two members-atlarge.
- Broader focus with the councils, to act as a parent council to the local council with extended rights and privileges for councils and special interest councils.

During the coming months we will be informing you on our continued effort to monitor and be heard on current issues in reading. Reports of our work with such areas as: Michigan Department of Education, Right to Read, Certification changes, New reading objectives pilot testing, Associations meetings on Minimal Educational Programs, TRIM (Teachers of Reading Improvement Model) are but a few of the issues being studied.
