Background

- Work-related musculoskeletal disorders (WMSD) due to manual patient handling pose a significant negative impact on the health, well-being, and occupational engagement of occupational therapy practitioners (Darragh & Campo, 2017; Kotejoshyer et al., 2019; Park & Park, 2017; Przybysz et al, 2017).
- Safe patient handling and mobility (SPHM) is shown to reduce WMSDs due to manual patient handling (Combs et al., 2021; Harwood et al., 2016, 2018; Kang et al, 2020; Teeple et al., 2017).
- Occupational therapy practitioners contribute to the widespread adoption of SPHM but aren't recognized as leaders in SPHM.

Problem

Occupational therapy practitioners lack a position statement recognizing OT's role in SPHM to reduce WMSD among occupational therapy practitioners.

Purpose

Create a position statement, in response to AOTA Representative Assembly Spring 2021 Motion 9, on occupational therapy's role in SPHM to reduce WMSD (American Occupational Therapy Association [AOTA], 2021).






