# Malliavin-Skorohod calculus and Paley-Wiener integral for covariance singular processes

#### Abstract

We develop a stochastic analysis for a Gaussian process $X$ with singular covariance by an intrinsic procedure focusing on several examples such as covariance measure structure processes, bifractional Brownian motion, processes with stationary increments. We introduce some new spaces associated with the self-reproducing kernel space and we define the Paley-Wiener integral of first and second order even when $X$ is only a square integrable process continuous in $L^{2}$. If $X$ has stationary increments, we provide necessary and sufficient conditions so that its paths belong to the self-reproducing kernel space. We develop Skorohod calculus and its relation with symmetric-Stratonovich type integrals and two types of Itô's formula. One of Skorohod type, which works under very general (even very singular) conditions for the covariance; the second one of symmetricStratonovich type, which works, when the covariance is at least as regular as the one of a fractional Brownian motion of Hurst index equal to $H=\frac{1}{4}$.

## 1 Introduction

Classical stochastic calculus is based on Itô's integral. It operates when the integrator $X$ is a semimartingale. The present paper concerns some specific aspects of calculus for Gaussian non-semimartingales, with some considerations about Paley-Wiener integrals for non Gaussian processes. Physical modeling, hydrology, telecommunications, economics and finance has generated the necessity to make stochastic calculus with respect to more general processes than semimartingales. In the family of Gaussian processes, the most adopted and celebrated example is of course Brownian motion. In this paper we will consider Brownian motion $B$ (and the processes having the same type of path regularity) as the frontier of two large classes of processes: those whose path regularity is more regular than $B$ and those whose path regularity is more singular than $B$. It is well-known that $B$ is a finite quadratic variation process in the sense of [13] or 40, 41]. Its quadratic variation process is given by $[B]_{t}=t$. If we have a superficial look to path regularity, we can macroscopically distinguish three classes.

1. Processes $X$ which are more regular than Brownian motion $B$ are such that $[X]=0$.
2. Processes $X$ which are as regular as $B$ are finite non-zero quadratic variation processes.
3. Processes $X$ which are more singular than $B$ are processes which do not admit a quadratic variation.

Examples of processes $X$ summarizing previous classification are given by the so called fractional Brownian motions $B^{H}$ with Hurst index $0<H<1$. If $H>\frac{1}{2}$ (resp. $H=$ $\frac{1}{2}, \quad H<\frac{1}{2}$ ), $B^{H}$ belongs to class 1. (resp. 2., 3.).
Calculus with respect to integrators which are not semimartingales is more than thirty-five years old, but a real activity acceleration was produced since the mid-eighties. A significant starting lecture note in this framework is (24): well-written lecture articles from H. Kuo, D. Nualart, D. Ocone constitute excellent pedagogical articles on Wiener analysis (Malliavin calculus, white noise calculus) and its application to anticipative calculus via Skorohod integrals.

Since then, a huge amount of papers have been produced, and it is impossible to list them here, so we will essentially quote monographs.

There are two mainly techniques for studying non-semimartingales integrators.

- Wiener analysis, as we mentioned before. It is based on the so-called Skorohod integral (or divergence operator); it allows to "integrate" anticipative integrands with respect to various Gaussian processes. We quote for instance [33], [7], [47, 31], for Malliavin calculus and [17, 18] for white noise calculus. In principle, Malliavin calculus can be abstractly implemented on any Wiener space generated by any Gaussian process $X$, see for instance [49], but in the general abstract framework, integrands may live in some abstract spaces. In most of the present literature about Malliavin-Skorohod calculus, integrands are supposed to live in a space $L$ which is isomorphic to the self-reproducing kernel space. One condition for an integrand $Y$ to belong to the classical domain of the divergence operator is that its paths belong a.s. to $L$. More recent papers as [8, 32] allow integrands to live outside the classical domain of the divergence operator. Some activity about Skorohod integration was also performed in the framework of Poisson measures integrators, see e.g. 11.
- Pathwise and quasi-pathwise related techniques, as rough paths techniques [29], regularization (see for instance [39, 42]) or discretization techniques [13], but also fractional integrals techniques [50, 51] and also [20 for connections between rough paths and fractional calculus.

This paper is the continuation of [25], which focused on the processes belonging to categories 1. and 2 . Here we are mainly interested in processes of category 3 . We develop some intrinsic stochastic analysis with respect to those processes. The qualification intrinsic is related to the fact that in opposition to (1, 2, 8, 32], where there is no underlying Wiener process. We formulate a class of general assumptions Assumptions (A), (B), (C $(\nu)$ ), (D) under which the calculus runs. Many properties hold only under the two three first hypotheses. Sometimes, however, we also make use of a supplementary assumption that we believe to be technical, i.e.

In some more specific situations, we also introduce Hypothesis (6.35) which intervenes for instance to guarantee, that $X$ itself belongs to the classical domain of the divergence operator. At Section 6.1 we also define a suitable Hilbert space $L_{R}$ for integrand processes, which is related to self-reproducing kernel space. We describe the content of $L_{R}$ in many situations. We implement the analysis and we verify the assumptions in the following examples: the case when the process $X$ is defined through a kernel integration with respect to a Wiener process, the case of processes with a covariance measure structure, the processes
with stationary increments, the case of bifractional Brownian motion. We provide a stochastic analysis framework starting from Paley-Wiener integral for second order processes. The Wiener integral with respect to the subclass of processes with stationary increments was studied with different techniques in 22. In our paper, we also define the notion to a multiple Paley-Wiener integral, involving independent processes $X^{1}, \cdots, X^{n}$. If $n=2$ those integrals have a natural relation with the notion of Lévy's area in rough path theory.

Starting from Section 7, we concentrate on Malliavin-Skorohod calculus, with Itô's type formulae and connections with symmetric-Stratonovich integrals via regularization. Calculus via regularizations was started by F. Russo and P. Vallois 38 developing a regularization procedure, whose philosophy is similar to the discretization. They introduced a forward (generalizing Itô) integral, and the symmetric (generalizing Stratonovich) integral.

As we said, in the first six sections, we redefine a Paley-Wiener type integral with respect to an $L^{2}$-continuous square integrable process. We aim at showing some interesting features and difficulties, which are encountered if one wants to define the integral in a natural function space avoiding distributions.

This allows in particular, but not only, to settle the basis of Malliavin-Skorohod calculus for Gaussian processes with singular covariance.

As we said, Malliavin calculus, according to 49], can be developed abstractly for any Gaussian process $X=\left(X_{t}\right)_{t \in[0, T]}$. The Malliavin derivation can be naturally defined on a general Gaussian abstract Wiener space. A Skorohod integral (or divergence) can also be defined as the adjoint of the Malliavin derivative.

The crucial ingredient is the canonical Hilbert space $\mathcal{H}$ (called also, improperly, by some authors reproducing kernel Hilbert space) of the Gaussian process $X$ which is defined as the closure of the linear space generated by the indicator functions $\left\{1_{[0, t]}, t \in[0, T]\right\}$ with respect to the scalar product

$$
\begin{equation*}
\left\langle 1_{[0, t]}, 1_{[0, s]}\right\rangle_{\mathcal{H}}=R(t, s), \tag{1.2}
\end{equation*}
$$

where $R$ denotes the covariance of $X$. Nevertheless, this calculus remains more or less abstract if the structure of the elements of the Hilbert space is not known. When we say abstract, we refer to the fact that, for example, it is difficult to characterize the processes which are integrable with respect to $X$, or to establish Itô formulae.

In this paper, as we have anticipated, we formulate some natural assumptions (A), (B), (C $(\nu)),(\mathrm{D})$, that the underlying process has to fulfill, which let us efficiently define a Skorohod intrinsic calculus and Itô formulae, when integrators belong to categories 2. and
3. In particular, Assumption (D) truly translates the singular character of the covariance.

We link Skorohod integral with integrals via regularization (so of almost pathwise type) similarly to [25], where the connection was established with forward integrals. We recall that the process $X$ is forward integrable (in symbols $\int_{0} X d^{-} X$ exists) if and only if $X$ has a finite quadratic variation, see for instance (15] or [16]. Therefore if $X$ is a fractional Brownian motion with Hurst index $H$, the forward integral $\int_{0}^{0} X d^{-} X$ exists if and only if $H \geq \frac{1}{2}$; on the other hand the symmetric integral $\int_{0}^{0} X d^{\circ} X$ always exists. Since we are mainly interested in singular covariance processes (category 3.), which are not of finite quadratic variation, Skorohod type integrals will be linked with the symmetric integrals.

As we have mentioned before, a particular case was deeply analyzed in the literature. We refer here to the situation when the covariance $R$ can be explicitly written as

R(t, s)=\int_{0}^{t \wedge s} K(t, u) K(s, u) d u
$$

where $K(t, s), 0<s<t<T$, is a deterministic kernel satisfying some regularity conditions. Enlarging, if needed, our probability space, we can express the process $X$ as

X_{t}=\int_{0}^{t} K(t, s) d W_{s} \tag{1.3}
\end{equation*}
$$

where $\left(W_{t}\right)_{t \in[0, T]}$ is a standard Wiener process and the above integral is understood in the Wiener sense. In this case, more concrete results can be proved, see [8, Q, 32]. In this framework the underlying Wiener process $\left(W_{t}\right)$ is strongly used for developing anticipating calculus.

For illustration, we come back to the case, when $X$ is a fractional Brownian motion $B^{H}$ and $H$ is the Hurst index. The process $B^{H}$ admits the Wiener integral representation (1.3) and the kernel $K$ together with the space $\mathcal{H}$ can be characterized by the mean of fractional integrals and derivatives, see 2, 2, 20, 36, 8, (4) among others. As a consequence, one can prove for any $H>\frac{1}{4}$ (to guarantee that $B^{H}$ is in the domain of the divergence), the following Itô's formula:

f\left(B_{t}^{H}\right)=f(0)+\int_{0}^{t} f^{\prime}\left(B_{s}^{H}\right) \delta B_{s}^{H}+H \int_{0}^{t} f^{\prime \prime}\left(B_{s}^{H}\right) s^{2 H-1} d s
$$

[32] puts emphasis on the case $K(t, s)=g(t-s)$, when the variance scale of the process is as general as possible, including logarithmic scales.

In section 局, we establish some connections between the "kernel approach" discussed in the literature and the "covariance intrinsic approach" studied here.

As we mentioned, if the deterministic kernel $K$ in the representation (1.3) is not explicitly known, then the Malliavin calculus with respect to the Gaussian process $X$ remains in an abstract form and there are of course many situations when this kernel is not explicitly known. As a typical example, we have in mind the case of the bifractional Brownian motion (BFBM) $B^{H, K}$, where $\left.\left.H \in\right] 0,1[, K \in] 0,1\right]$; a kernel representation is known in a particular case, but with respect to a space-time white noise: in fact the solution $F(t)=u(t, x)$ of a classical stochastic heat equation driven by a white noise with zero initial condition, is distributed as $B^{H, K}$, for any fixed $x$, see [46]. Another interesting representation is provided by [27, which shows the existence of real constants $c_{1}, c_{2}$ and an absolutely continuous process $X(H, K)$ independent of $B^{H, K}$, such that $c_{1} B^{H, K}+c_{2} X(H, K)$ is distributed as a fractional Brownian motion with parameter $H K$. In spite of those considerations, finding a kernel $K$, such that $B_{t}^{H, K}=\int_{0}^{t} K(t, s) d W_{s}$, is still an open problem. Bifractional Brownian motion was introduced in (19) and a quasi-pathwise type of regularization (42) type approach to stochastic calculus was provided in 37. It is possible for instance to obtain an Itô formula of the Stratonovich type (see [37]), i.e.

f\left(B_{t}^{H, K}\right)=f(0)+\int_{0}^{t} f^{\prime}\left(B_{s}^{H, K}\right) d^{\circ} B_{s}^{H, K} \tag{1.4}
\end{equation*}
$$

for any parameters $H \in(0,1)$ and $K \in(0,1]$ such that $H K>\frac{1}{6}$. An interesting property of $B^{H, K}$ consists in the expression of its quadratic variation, defined as usual, as a limit of Riemann sums, or in the sense of regularization. The following properties hold true.

- If $2 H K>1$, then the quadratic variation of $B^{H, K}$ is zero and $B^{H, K}$ belongs to category 1.
- If $2 H K<1$ then the quadratic variation of $B^{H, K}$ does not exist and $B^{H, K}$ belongs to category 3.
- If $2 H K=1$ then the quadratic variation of $B^{H, K}$ at time $t$ is equal to $2^{1-K} t$ and $B^{H, K}$ belongs to category 2 .

The last property is remarkable; indeed, for $H K=\frac{1}{2}$ we have a Gaussian process which has the same quadratic variation as the Brownian motion. Moreover, the processes is not a semimartingale (except for the case $K=1$ and $H=\frac{1}{2}$ ), it is self-similar, has no stationary increments.

Motivated by the consideration above, one developed in 25 a Malliavin-Skorohod calculus with respect to Gaussian processes $X$ having a covariance measure structure in
sense that the covariance is the distribution function of a (possibly signed) measure $\mu_{R}$ on $\mathcal{B}\left([0, T]^{2}\right)$. We denote by $D_{t}$ the diagonal set

\{(s, s) \mid s \in[0, t]\}
$$

The processes having a covariance measure structure belong to the category 1. (resp. 2.), i.e. they are more regular than Brownian motion (resp. as regular as Brownian motion) if $\mu_{R}$ restricted to the diagonal $D_{T}$ vanishes (resp. does not vanish). In particular, it was shown that in this case $X$ is a finite quadratic variation process and $[X]_{t}=\mu\left(D_{t}\right)$. This paper continues the spirit of 25, but it concentrates on the case when $X$ is less regular or equal than Brownian motion.

A significant paper, is [35], which establishes a Itô-Stratonovich (of quasi-pathwise type, in the discretization spirit) for processes belonging to class 3., i.e. less regular than Brownian motion. In particular, the paper rediscovers Itô's formula of 37] for $B^{H, K}$, if $H K>\frac{1}{6}$; for this purpose the authors implement innovating Malliavin calculus techniques. Their main objective was however not to obtain a Skorohod type calculus, but more to use some Malliavin calculus ideas to recover pathwise type techniques.

In this paper, for simplicity of notations and without restriction of generality, we consider processes indexed by the whole first quarter of the completed plane $\overline{\mathbb{R}}_{+}^{2}=[0, \infty]^{2}$. In particular we suppose that $X$ is a continuous process in $L^{2}$, such that $\lim _{s \rightarrow \infty} X_{s}$ exists, and it is denoted $X_{\infty}$ and under some circumstances we suppose even (1.1). Let $R\left(s_{1}, s_{2}\right), s_{1}, s_{2} \in[0, \infty]$ be the covariance function of $X$. As we said, we introduce a class of natural assumptions which have to be fulfilled in most of the results in order to get an efficient Skorohod calculus.
The processes of class 2. and 3., so essentially less regular than Brownian motion, will fulfill the following:

- $R(d s, \infty)$ is a non-negative real measure.
- If $D$ is the first diagonal of $\mathbb{R}_{+}^{2}$, the Schwartz distribution $\partial_{s_{1}, s_{2}}^{2} R$ restricted to $\mathbb{R}_{+}^{2} \backslash D$ is a non-positive $\sigma$-finite measure.

This will constitute the convenient Assumption (D).
The basic space of integrands for which Paley-Wiener integral is defined is $L_{R}$. This space, under Assumption (D), plays the role of self-reproducing kernel space. A necessary
condition for the process $X$ itself to be in the natural domain (Dom $\delta$ ) of the divergence operator is that it belongs a.s. to $L_{R}$. Following the ideas of [8, 32] one defines for our general class of processes an extended domain called $D o m^{*} \delta$ which allows to proceed when $X$ does not always belong a.s. to $L_{R}$.

Other products of this paper are the following.

- We define a corresponding appropriate Paley-Wiener integral with respect to second order processes in Section 6. In particular, see Section 6.17, we extend some significant considerations of 36] made in the context of fractional Brownian motion; 36] illustrates that the natural space where Wiener integral is defined, is complete if the Hurst index is smaller or equal to $\frac{1}{2}$.
- The link between symmetric and Skorohod integrals, see Theorem 13.5, is given by suitable trace of Malliavin derivative of the process.
- If the process $X$ is continuous, Gaussian and has stationary increments, we provide necessary and sufficient conditions such that the paths of $X$ belong to $L_{R}$, see Corollary 6.29.
- We establish an Itô type formula for Skorohod integrals for very singular covariation when the underlying process $X$ is quite general, continuing the work of (8] and [32]. This is done in Proposition 11.7: if $f \in C^{\infty}$ with bounded derivatives

f\left(X_{t}\right)=f\left(X_{0}\right)+\int_{0}^{t} f^{\prime}\left(X_{s}\right) \delta X_{s}+\frac{1}{2} \int_{0}^{t} f^{\prime \prime}\left(X_{s}\right) d \gamma(s) \tag{1.5}
\end{equation*}
$$

where $\gamma(t)$ is the variance of $X_{t}$.
We recall that if $X$ is a bifractional Brownian motion with indexes $H, K$ such that $H K=\frac{1}{2}$, then $\gamma(t)=t$ and so equation (1.5) looks very similar to the one related to classical Wiener process.

Formula (1.5) implies the corresponding formula with respect to the symmetric integral, see Corollary 13.7, i.e.

$$
f\left(X_{t}\right)=f\left(X_{0}\right)+\int_{0}^{t} f^{\prime}\left(X_{s}\right) d^{\circ} X_{s}
$$

We organize our paper as follows. After some preliminaries stated at Section 2, we introduce the basic assumptions (A), (B), (C) (or only its restricted version (C $(\nu)$ )), (D)
in Section 3 followed by the motivating examples in Section 0 , including the case when the process has a covariance measure structure treated in [25]. Section 5 discusses the link with the case that the process is of the type $X_{t}=\int_{0}^{t} K(t, s) d W_{s}$ for a suitable kernel $K$. At Section 6 we define the Wiener integral for second order processes together with a multiorder version; in the same section we discuss some path properties of the underlying process and the relation with the integrals via regularization. Starting from Section 7 until 9, we introduce and discuss the basic notions of Malliavin calculus. At Section 10 we introduce Skorohod integrals, at Section 11 we discuss Itô formula in the very singular case. Section 12 shows that Skorohod integral is truly an extension of Wiener integral. Finally Section 13 provides the link with integrals via regularization and Itô's formula with respect to symmetric integrals.

## 2 Preliminaries

Let $J$ be a closed set of the type $\mathbb{R}_{+}, \mathbb{R}^{m}$ or $\mathbb{R}_{+}^{2}=[0,+\infty[\times[0,+\infty[$, and $k \geq 1$. In this paper $C_{0}^{\infty}(J)$ (resp. $\left.C_{b}^{\infty}(J), C_{0}^{k}(J), C_{p o l}^{k}(J), C_{b}(J)\right)$ stands for the set of functions $f: J \rightarrow \mathbb{R}$ which are infinitely differentiable with compact support (resp. smooth with all bounded partial derivatives, of class $C^{k}$ with compact support, of class $C^{k}$ such that the partial derivatives of order smaller or equal to $k$ have polynomial growth, bounded functions).

If $g_{1}, g_{2}: \mathbb{R}_{+} \longrightarrow \mathbb{R}$, we denote $g=g_{1} \otimes g_{2}$, the function $g: \mathbb{R}_{+}^{2} \longrightarrow \mathbb{R}$ defined by $g\left(s_{1}, s_{2}\right)=g_{1}\left(s_{1}\right) g_{2}\left(s_{2}\right)$.

Let $I$ be a subset of $\mathbb{R}_{+}^{2}$ of the form

Given $g: \mathbb{R}_{+}^{2} \rightarrow \mathbb{R}$ we will denote

\Delta_{I} g=g\left(b_{1}, b_{2}\right)+g\left(a_{1}, a_{2}\right)-g\left(a_{1}, b_{2}\right)-g\left(b_{1}, a_{2}\right)
$$

It constitutes the planar increment of $g$.

Definition 2.1. $g: \mathbb{R}_{+}^{2} \rightarrow \mathbb{R}$ will be said to have a bounded planar variation if

where $\tau=\left\{0=t_{0}<\ldots<t_{n}<\infty\right\}, n \geq 1$, i.e. $\tau$ is a subdivision of $\mathbb{R}_{+}$. Previous quantity will be denoted by $\|g\|_{p v}$.

If $g$ has bounded planar variation and is vanishing on the axes, then there exists a signed measure $\chi$ (difference of two positive measures) such that

For references, see a slight adaptation of Lemma 2.2 in (25] and Theorem 12.5 in [5].
Some elementary calculations allow to show the following.
Proposition 2.1. Let $g: \mathbb{R}_{+}^{2} \longrightarrow \mathbb{R}$ of class $C^{2}, g$ has a bounded planar variation if and only if

In particular, if $g$ has compact support, then $g$ has a bounded planar variation.
Let $X=\left(X_{t}\right)_{t \geq 0}$, be a zero-mean continuous process in $L^{2}(\Omega)$ such that $X_{0}=0$ a.s. For technical reasons we will suppose that

(2.2) is verified if for instance

for some $T>0$.
We denote by $R$ the covariance function, i.e. such that:

R\left(s_{1}, s_{2}\right)=\operatorname{Cov}\left(X_{s_{1}}, X_{s_{2}}\right)=E\left(X_{s_{1}} X_{s_{2}}\right), s_{1}, s_{2} \in \overline{\mathbb{R}}_{+}^{2}=[0, \infty]^{2}

In particular $R$ is continuous and vanishes on the axes.
We convene that all the continuous functions on $\mathbb{R}_{+}$are extended by continuity to $\mathbb{R}_{-}$. A continuous function $f: \mathbb{R}_{+}^{2} \longrightarrow \mathbb{R}$ such that $f(s)=0$, if $s$ belongs to the axes, will also be extended by continuity to the whole plane.

In this paper $D$ will denote the diagonal $\{(t, t) \mid t \geq 0\}$ of the first plane quarter $\mathbb{R}_{+}^{2}$.
Definition 2.2. $X$ is said to have a covariance measure structure if $\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}$ is a finite Radon measure $\mu$ on $\mathbb{R}_{+}^{2}$ with compact support. We also say that $X$ has a covariance measure $\mu$.

A priori $\frac{\partial R}{\partial s_{1}}, \frac{\partial R}{\partial s_{2}}, \frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}$ are Schwartz distributions. In particular for $s=\left(s_{1}, s_{2}\right)$ we have

$$
R\left(s_{1}, s_{2}\right)=\mu\left(\left[0, s_{1}\right] \times\left[0, s_{2}\right]\right)
$$

Remark 2.2. The class of processes defined in Definition 2.8 was introduced in [25], where the parameter set was $[0, T]$, for some $T>0$, instead of $\mathbb{R}_{+}$. Such processes can be easily extended by continuity to $\mathbb{R}_{+}$setting $X_{t}=X_{T}$, if $t \geq T$. In that case the support of the measure is $[0, T]^{2}$.

The present paper constitutes a natural continuation of [25] trying to extend Wiener integral and Malliavin-Skorohod calculus to a large class of more singular processes.

The covariance approach is an intrinsic way of characterizing square integrable processes. These processes include Gaussian processes defined through a kernel, as for instance (2, 32).

We will see later that a process $X_{t}=\int_{0}^{t} K(t, s) d W_{s}$, where $\left(W_{t}\right)_{t \geq 0}$ is a classical Wiener process and $K$ is a deterministic kernel with some regularity, provide examples of processes with covariance measure structure. Other examples were given in [25].

One relevant object of [25] was Wiener integral with respect to $X$. Let $\varphi: \mathbb{R}_{+} \longrightarrow \mathbb{R}$ has locally bounded variation with compact support. We set

\int_{0}^{\infty} \varphi d X=-\int_{0}^{\infty} X d \varphi
$$

If $\varphi$ is a Borel function such that

then similarly to Section 5 of [25], the Wiener integral $\int_{0}^{\infty} \varphi d X$ can be defined through the isometry property

E\left(\int_{0}^{\infty} \varphi d X\right)^{2}=\int_{\mathbb{R}_{+}^{2}} \varphi \otimes \varphi d \mu .
$$

Remark 2.3. If $\varphi$ fulfills (2.4), then the process $Z_{t}=\int_{0}^{t} \varphi d X$ has again a covariance measure structure with measure $\nu$ defined by

$$
d \nu=\varphi \otimes \varphi d \mu
$$

## 3 Basic assumptions

In this section we formulate a class of fundamental hypotheses, which will be in force for the present paper.
Assumption (A)
i) $\forall s \in \overline{\mathbb{R}}_{+}: R(s, d x)$ is a signed measure,
ii) $s \longmapsto \int_{0}^{\infty}|R|(s, d x)$ is a bounded function.

Remark 3.1. Since $R$ is symmetric, Assumption (A) implies the following.
i)' $\forall s \in \overline{\mathbb{R}}_{+}: R(d x, s)$ is a signed measure,
ii)' $s \longmapsto \int_{0}^{\infty}|R|(d x, s)$ is a bounded function.

Remark 3.2. Suppose that $X$ has a covariance measure $\mu$. For $s \geq 0$ we have

$$
x \longmapsto R(s, x)=\int_{[0, s] \times[0, x]} d \mu .
$$

which is a bounded variation function whose total variation is clearly given by

$$
\int_{0}^{\infty}|R|(s, d x)=\int_{[0, s] \times \mathbb{R}_{+}} d|\mu|\left(s_{1}, s_{2}\right) \leq \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(s_{1}, s_{2}\right)
$$

Hence Assumption (A) is fulfilled.
Assumption (B) We suppose that

$$
\begin{equation*}
\bar{\mu}\left(d s_{1}, d s_{2}\right):=\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}\left(s_{1}, s_{2}\right)\left(s_{1}-s_{2}\right) \tag{3.1}
\end{equation*}
$$

is a Radon measure. In this paper by a Radon measure we mean the difference of two (positive Radon) measures.

Remark 3.3. i) The right-hand side of (3.1) is well defined being the product if a $C^{\infty}$ function and a Schwartz distribution.
ii) If $D$ is the diagonal introduced before in Definition 2.8, Assumption (B) implies that $\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}$ restricted to $\mathbb{R}_{+}^{2} \backslash D$ is a $\sigma$-finite measure. Indeed, given $\varphi \in C_{0}^{\infty}\left(\mathbb{R}_{+}^{2} \backslash D\right)$, we symbolize by $d$ the distance between $\operatorname{supp} \varphi$ and $D$. Setting $g\left(s_{1}, s_{2}\right)=s_{1}-s_{2}$, since $\frac{\varphi}{g} \in C_{0}^{\infty}\left(\mathbb{R}_{+}^{2} \backslash D\right)$, we have

$$
\left|\left\langle\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}, \varphi\right\rangle\right|=\left|\left\langle\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}} \cdot g, \frac{\varphi}{g}\right\rangle\right|=\left|\int_{\mathbb{R}_{+}^{2}} d \bar{\mu} \frac{\varphi}{g}\right| \leq \frac{1}{\inf _{|x| \geq d}|g|(x)}\|\varphi\|_{\infty}|\bar{\mu}|\left(\mathbb{R}_{+}^{2}\right)
$$

iii) On each compact subset of $\mathbb{R}_{+}^{2} \backslash D$, the total variation measure $|\mu|$ is absolutely continuous with density $\frac{1}{|g|}$ with respect to $|\bar{\mu}|$.

Assumption ( $\mathbf{C}(\nu)$ ) We suppose the existence of a positive Borel measure $\nu$ on $\mathbb{R}_{+}$such that:
i) $R(d s, \infty) \ll \nu$,
ii) The marginal measure of the symmetric measure $|\bar{\mu}|$ is absolutely continuous with respect to $\nu$.

If Assumption $(\mathrm{C}(\nu))$ is realized with $\nu(d s)=|R|(d s, \infty)$ then we will simply say that Assumption (C) is fulfilled.

Proposition 3.4. Suppose that $X$ has a covariance measure structure and $\mu=\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}$ has compact support, then Assumption $(C(\nu))$ is fulfilled with $\nu$ being the marginal measure of $|\mu|$.

Proof: Let $f: \mathbb{R}_{+} \longrightarrow \mathbb{R}$ be a bounded non-negative Borel function.
i) $\left|\int_{\mathbb{R}_{+}} f(s)\right| R|(d s, \infty)| \leq \int_{\mathbb{R}_{+} \times \mathbb{R}_{+}} f\left(s_{1}\right) d|\mu|\left(s_{1}, s_{2}\right)=\int_{\mathbb{R}_{+}} f(s) d \nu(s)$. Take $f$ being the indicator of a null set related to $\nu$.
ii) $\left|\int_{\mathbb{R}_{+}^{2}} f\left(s_{1}\right) d\right| \bar{\mu}\left|\left(s_{1}, s_{2}\right)\right| \leq k\left|\int_{\mathbb{R}_{+}^{2}} f\left(s_{1}\right) d\right| \mu\left|\left(s_{1}, s_{2}\right)\right|=k \int_{0}^{\infty} f d \nu$, where $k$ is the diameter of the compact support of $\mu$.

Corollary 3.5. If $X$ has a covariance measure $\mu$, which is non-negative and with compact support, then Assumption ( $C$ ) is verified.

Proof: This follows because $|R|(d s, \infty)=R(d s, \infty)$ is the marginal measure of $\mu$.
Next proposition is technical but useful.
Proposition 3.6. We suppose Assumptions (A), (B). Let $f: \mathbb{R}_{+} \longrightarrow \mathbb{R}$ be a bounded variation and $\frac{1}{2}$-Hölder continuous function with compact support. Then

$$
\begin{equation*}
\int_{\mathbb{R}_{+}^{2}} R\left(s_{1}, s_{2}\right) d f\left(s_{1}\right) d f\left(s_{2}\right)=\int_{\mathbb{R}_{+}} f^{2}(s) R(d s, \infty)-\frac{1}{2} \int_{\mathbb{R}_{+}^{2} \backslash D}\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)^{2} d \mu\left(s_{1}, s_{2}\right) \tag{3.2}
\end{equation*}
$$

Remark 3.7. The statement holds of course if $f$ is Lipschitz with compact support.

Proof: a) We extend $R$ to the whole plane by continuity. We suppose first $f \in$ $C_{0}^{\infty}\left(\mathbb{R}_{+}\right)$. Let $\rho$ be a smooth, real function with compact support and $\int \rho(x) d x=1$. We set $\rho_{\varepsilon}(x)=\frac{1}{\varepsilon} \rho\left(\frac{x}{\varepsilon}\right)$, for any $\varepsilon>0$. The left-hand side of (3.2) can be approximated by

where we recall that $\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}$ is a distribution. By Fubini's theorem on the plane, (3.3) gives

Let $\chi_{\varepsilon} \in C^{\infty}(\mathbb{R})$ such that $\chi_{\varepsilon}=1$ for $|x| \leq \frac{1}{\varepsilon}$ and $\chi_{\varepsilon}(x)=0$ for $|x| \geq \frac{1}{\varepsilon}+1$. Moreover we choose $\varepsilon>0$ large enough such that $\left[-\frac{1}{\varepsilon}, \frac{1}{\varepsilon}\right]$ includes the support of $f$. We have

\int_{\mathbb{R}^{2}} \frac{\partial^{2} R_{\varepsilon}}{\partial s_{1} \partial s_{2}}\left(s_{1}, s_{2}\right) f\left(s_{1}\right) f\left(s_{2}\right) \chi_{\varepsilon}\left(s_{1}\right) \chi_{\varepsilon}\left(s_{2}\right) d s_{1} d s_{2}=\frac{1}{2}\left(-I_{1}(\varepsilon)+I_{2}(\varepsilon)+I_{3}(\varepsilon)\right)
$$

where

$$
\begin{aligned}
& I_{1}(\varepsilon)=\int_{\mathbb{R}^{2}} \frac{\partial^{2} R_{\varepsilon}}{\partial s_{1} \partial s_{2}}\left(s_{1}, s_{2}\right)\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)^{2} \chi_{\varepsilon}\left(s_{1}\right) \chi_{\varepsilon}\left(s_{2}\right) d s_{1} d s_{2} \\
& I_{2}(\varepsilon)=\int_{\mathbb{R}^{2}} \frac{\partial^{2} R_{\varepsilon}}{\partial s_{1} \partial s_{2}}\left(s_{1}, s_{2}\right) f\left(s_{1}\right)^{2} \chi_{\varepsilon}\left(s_{1}\right) \chi_{\varepsilon}\left(s_{2}\right) d s_{1} d s_{2} \\
& I_{3}(\varepsilon)=\int_{\mathbb{R}^{2}} \frac{\partial^{2} R_{\varepsilon}}{\partial s_{1} \partial s_{2}}\left(s_{1}, s_{2}\right) f\left(s_{2}\right)^{2} \chi_{\varepsilon}\left(s_{1}\right) \chi_{\varepsilon}\left(s_{2}\right) d s_{1} d s_{2}
\end{aligned}
$$

Since $\chi_{\varepsilon}=1$ on $\operatorname{supp} f, I_{2}(\varepsilon)$ gives

& -\int_{0}^{\infty} d s_{1}\left(f^{2}\right)^{\prime}\left(s_{1}\right) \int_{0}^{\infty} d s_{2} \frac{\partial R_{\varepsilon}}{\partial s_{2}}\left(s_{1}, s_{2}\right) \chi_{\varepsilon}\left(s_{2}\right) \\
& =-\int_{0}^{\infty} d s_{1}\left(f^{2} \chi_{\varepsilon}\right)^{\prime}\left(s_{1}\right) \int_{0}^{\infty} R_{\varepsilon}\left(s_{1}, d s_{2}\right) \chi_{\varepsilon}\left(s_{2}\right)=-\left(I_{2,1}+I_{2,2}\right)(\varepsilon)
\end{aligned}
$$

where

$$
\begin{aligned}
& I_{2,1}(\varepsilon)=\int_{0}^{\infty} d s_{1}\left(f^{2}\right)^{\prime}\left(s_{1}\right) \int_{0}^{\infty} R_{\varepsilon}\left(s_{1}, d s_{2}\right)\left(\chi_{\varepsilon}-1\right)\left(s_{2}\right) \\
& I_{2,2}(\varepsilon)=\int_{0}^{\infty} d s_{1}\left(f^{2}\right)^{\prime}\left(s_{1}\right) \int_{0}^{\infty} R_{\varepsilon}\left(s_{1}, d s_{2}\right)
\end{aligned}
$$

$I_{2,1}(\varepsilon)$ is bounded by

$$
\begin{equation*}
\int_{0}^{\infty} d s_{1}\left|\left(f^{2}\right)^{\prime}\right|\left(s_{1}\right) \int_{\frac{1}{\varepsilon}}^{\infty}\left|R_{\varepsilon}\right|\left(s_{1}, d s_{2}\right) \tag{3.5}
\end{equation*}
$$

For each $s_{1} \geq 0$, we have

\begin{equation*}
\int_{\frac{1}{\varepsilon}}^{\infty}\left|R_{\varepsilon}\right|\left(s_{1}, d s_{2}\right)=\int_{\frac{1}{\varepsilon}}^{\infty}\left|\frac{\partial R_{\varepsilon}}{\partial s_{2}}\left(s_{1}, s_{2}\right)\right| d s_{2} \tag{3.6}
\end{equation*}
$$

Now

\begin{aligned}
\frac{\partial R_{\varepsilon}}{\partial s_{2}}\left(s_{1}, s_{2}\right) & =\int_{\mathbb{R}^{2}} d y_{1} d y_{2} R\left(y_{1}, y_{2}\right) \rho_{\varepsilon}\left(s_{1}-y_{1}\right) \rho_{\varepsilon}^{\prime}\left(s_{2}-y_{2}\right) \\
& =\int_{0}^{\infty} d y_{1} \rho_{\varepsilon}\left(s_{1}-y_{1}\right) \int_{0}^{\infty} R\left(y_{1}, d y_{2}\right) \rho_{\varepsilon}\left(s_{2}-y_{2}\right)
\end{aligned}
$$

Using Fubini's theorem, (3.6) gives

Let $M>0$ such that suppf $\subset[-M, M]$. Hence (3.5) is bounded by

& \quad \leq \sup \left|\left(f^{2}\right)^{\prime}\right| \int_{0}^{M} d y_{1} \int_{0}^{\infty}|R|\left(y_{1}, d y_{2}\right) \int_{\frac{1}{\varepsilon}\left(\frac{1}{\varepsilon}-y_{2}\right)}^{\infty} d s_{2} \rho\left(s_{2}\right)
\end{aligned}
$$

because $\int_{-\infty}^{\infty} \rho_{\varepsilon}(y) d y=1$. This is bounded by $\left(I_{2,1,1}(\varepsilon)+I_{2,1,2}(\varepsilon)\right) \sup \left|\left(f^{2}\right)^{\prime}\right|$ with

& I_{2,1,1}(\varepsilon)=\int_{0}^{M} d y_{1} \int_{0}^{\frac{1}{\varepsilon}}|R|\left(y_{1}, d y_{2}\right) \int_{\left(\frac{1}{\varepsilon}-y_{2}\right) \frac{1}{\varepsilon}}^{\infty} d s_{2} \rho\left(s_{2}\right) \\
& I_{2,1,2}(\varepsilon)=\int_{0}^{M} d y_{1} \int_{\frac{1}{\varepsilon}}^{\infty}|R|\left(y_{1}, d y_{2}\right)
\end{aligned}
$$

Both expressions above converge to zero because of Assumption (A) ii) and Lebesgue dominated convergence theorem. Hence $I_{2,1}(\varepsilon) \rightarrow 0$.

As far as $I_{2,2}(\varepsilon)$ is concerned, when $\varepsilon \rightarrow 0$ we get

according to Assumption (A) i). Consequently $\lim _{\varepsilon \rightarrow 0} I_{2}(\varepsilon)=\int_{0}^{\infty} f^{2}(s) R(d s, \infty)$. Since $I_{2}(\varepsilon)=I_{3}(\varepsilon)$, we also have $\lim _{\varepsilon \rightarrow 0} I_{3}(\varepsilon)=\int_{0}^{\infty} f^{2}(s) R(d s, \infty)$.

It remains to prove that $\lim _{\varepsilon \rightarrow 0} I_{1}(\varepsilon)=\int_{\mathbb{R}_{+}^{2} \backslash D}\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)^{2} d \mu\left(s_{1}, s_{2}\right)$. By (3.4), transferring the convolution against $\rho_{\varepsilon} \otimes \rho_{\varepsilon}$ to the test function, $I_{1}(\varepsilon)$ becomes the expression

& f^{\varepsilon}=f * \rho^{\varepsilon} \\
& \chi_{\varepsilon}^{\varepsilon}=\chi_{\varepsilon} * \rho^{\varepsilon}
\end{aligned}
$$

This gives

\int_{\mathbb{R}_{+}^{2}} d \bar{\mu}\left(s_{1}, s_{2}\right) \frac{\left(f^{\varepsilon}\left(s_{1}\right)-f^{\varepsilon}\left(s_{2}\right)\right)^{2}}{\left(s_{1}-s_{2}\right)} \chi_{\varepsilon}^{\varepsilon}\left(s_{1}\right) \chi_{\varepsilon}^{\varepsilon}\left(s_{2}\right) \tag{3.7}
\end{equation*}

We observe that the functions

0 & , s_{1}=s_{2}
\end{array}\right.
$$

and

g\left(s_{1}, s_{2}\right)=\left\{\begin{array}{cl}
\frac{\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)^{2}}{s_{1}-s_{2}} & , s_{1} \neq s_{2}  \tag{3.9}\\
0 & , s_{1}=s_{2}
\end{array}\right.
$$

are bounded by the square of the $\frac{1}{2}$-Hölder norm of $f$.
Using Lebesgue's dominated convergence theorem, (3.7) goes to

\int_{\mathbb{R}_{+}^{2}} d \bar{\mu}\left(s_{1}, s_{2}\right) \frac{\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)^{2}}{\left(s_{1}-s_{2}\right)}=\int_{\mathbb{R}_{+}^{2} \backslash D} d \mu\left(s_{1}, s_{2}\right)\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)^{2}

This justifies the case $f \in C_{0}^{\infty}(\mathbb{R})$. We consider now the general case. Let $\rho_{n}$ be a sequence of mollifiers converging to the Dirac delta function and we set $f_{n}=\rho_{n} * f$. Taking into account previous arguments, identity (3.2) holds for $f$ replaced with $f_{n}$. Therefore we have

& -\frac{1}{2} \int_{\mathbb{R}_{+}^{2} \backslash D}\left(f_{n}\left(s_{1}\right)-f_{n}\left(s_{2}\right)\right)^{2} d \mu\left(s_{1}, s_{2}\right)
\end{align*}
$$

The total variation of $f_{n}$ is bounded by a constant times the total variation of $f$ and $f_{n} \longrightarrow f$ pointwise. So $d f_{n} \longrightarrow d f$ weakly and also $d f_{n} \otimes d f_{n} \longrightarrow d f \otimes d f$ by use of monotone class theorem. Since $R$ is continuous and bounded,

Therefore the left-hand side of (3.10) converges to the left-hand side of (3.2). On the other hand $f_{n}\left(s_{1}\right)-f_{n}\left(s_{2}\right) \longrightarrow_{n \rightarrow \infty} f\left(s_{1}\right)-f\left(s_{2}\right)$ for every $\left(s_{1}, s_{2}\right) \in \mathbb{R}_{+}^{2}$. Since $\bar{\mu}$ and $|R|(d s, \infty)$ are finite non-atomic measures and because of considerations around (3.8) and (3.9), the sequence of right-hand sides of ( $\overline{3.10}$ ) converges to the right-hand side of (3.2).

## Assumption (D)

i) $R\left(d s_{1}, \infty\right)$ is a non-negative, $\sigma$-finite measure,
ii) $\left.\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}\right|_{\mathbb{R}_{+}^{2} \backslash D}$ is a non-positive measure.

In the next section, we will expand some examples of processes for which Assumptions (A), (B), (C) and (D) are fulfilled.

## 4 Examples

### 4.1 Processes with covariance measure structure

The first immediate example arises if $X$ has a covariance measure $\mu$ with compact support, see Definition 2.2. In this case $\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}$ is a measure $\mu$. In Remark 3.2 we proved that Assumption (A) is satisfied; obviously Assumption (B) is fulfilled and $\bar{\mu}$ is absolutely continuous with respect to $\mu$. We recall that $D$ is the diagonal of the first quarter of the plane.

Remark 4.1. i) If $\mu$ restricted to $D$ vanishes, Assumption ( $D$ ) cannot be satisfied except if process $X$ is deterministic. Indeed, suppose that for some $a>0, X_{a}$ is non-deterministic. Then, taking $f=1_{[0, a]}$, we have

$$
\int_{\mathbb{R}_{+}^{2}} f\left(x_{1}\right) f\left(x_{2}\right) d \mu\left(x_{1}, x_{2}\right)=\operatorname{Var}\left(X_{a}\right),
$$

which is strictly positive. On the other hand previous integral equals

$$
\int_{\mathbb{R}_{+}^{2} \backslash D} f\left(x_{1}\right) f\left(x_{2}\right) d \mu\left(x_{1}, x_{2}\right)=\mu\left([0, a]^{2}\right) \leq 0 .
$$

ii) However, Assumption ( $D$ ) is satisfied if supp $\mu \subset D$ and $R\left(d s_{1}, \infty\right)$ is positive. In this case $\left.\mu\right|_{\mathbb{R}_{+}^{2} \backslash D}$ is even zero. Consider as an example the case of classical Brownian motion or a martingale.

### 4.2 Fractional Brownian motion

Let $X=B^{H}, 0<H<1, H \neq \frac{1}{2}$ be a fractional Brownian motion with Hurst parameter $H$ stopped at some fixed time $T>0$. Therefore we have $X_{t}=X_{T}, t \geq T$. Its covariance is

$$
R\left(s_{1}, s_{2}\right)=\frac{1}{2}\left(\tilde{s}_{1}^{2 H}+\tilde{s}_{2}^{2 H}-\left|\tilde{s}_{2}-\tilde{s}_{1}\right|^{2 H}\right)
$$

with $\tilde{s}_{i}=s_{i} \wedge T$. Now

$$
s_{1} \mapsto R\left(s_{1}, \infty\right)=R\left(s_{1}, T\right)
$$

has bounded variation and is even absolutely continuous since

$$
\frac{\partial R}{\partial s_{1}}\left(s_{1}, \infty\right)=\left\{\begin{array}{cl}
H\left[s_{1}^{2 H-1}+\left(T-s_{1}\right)^{2 H-1}\right] & \text { if } s_{1}<T \\
0 & \text { if } s_{1}>T
\end{array}\right.
$$

So Assumption (A) is verified. Assumptions (B) and (C) are fulfilled because

$$
\begin{aligned}
\bar{\mu}\left(d s_{1}, d s_{2}\right) & =\left(s_{1}-s_{2}\right) \frac{\partial^{2} R\left(s_{1}, s_{2}\right)}{\partial s_{1} \partial s_{2}} \\
& =H(2 H-1)\left|s_{1}-s_{2}\right|^{2 H-1} 1_{[0, T]^{2}}\left(s_{1}, s_{2}\right) \operatorname{sign}\left(s_{1}-s_{2}\right) d s_{1} d s_{2} \\
\left.\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}\right|_{\mathbb{R}^{2} \backslash D} & =H(2 H-1)\left|s_{1}-s_{2}\right|^{2 H-2} 1_{[0, T]^{2}}\left(s_{1}, s_{2}\right)
\end{aligned}
$$

Remark 4.2. In this example $R(d s, \infty)$ is non-negative; $\mu$ is non-positive if and only if $H \leq \frac{1}{2}$. In that case Assumption ( $D$ ) is fulfilled.

### 4.3 Bifractional Brownian motion

Suppose that $X=B^{H, K}$ is a bifractional Brownian motion with parameters $\left.H \in\right] 0,1[$, $K \in] 0,1]$ stopped at some fixed time $T>0$. We recall that $B^{H, 1}$ is a fractional Brownian motion with Hurst index $H$. Moreover its covariance function, see 37] and 19], is given by

$$
R\left(s_{1}, s_{2}\right)=2^{-K}\left[\left({\tilde{s_{1}}}^{2 H}+{\tilde{s_{2}}}^{2 H}\right)^{K}-\left|\tilde{s_{1}}-\tilde{s_{2}}\right|^{2 H K}\right]
$$

again with $\tilde{s}_{i}=s_{i} \wedge T$.

We have,

$$
\begin{equation*}
\frac{\partial R}{\partial s_{1}}\left(s_{1}, s_{2}\right)=2 H K 2^{-K}\left[\left[s_{1}^{2 H}+s_{2}^{2 H}\right]^{K-1} s_{1}^{2 H-1}-\left|s_{1}-s_{2}\right|^{2 H K-1} \operatorname{sign}\left(s_{1}-s_{2}\right)\right] \tag{4.1}
\end{equation*}
$$

for $\left.s_{1}, s_{2} \in\right] 0, T[$. Hence

$$
\begin{aligned}
& \left.\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}\right|_{[0, T]^{2} \backslash D} \\
& =2^{-K}\left[\left(4 H^{2} K(K-1)\left(s_{1}^{2 H}+s_{2}^{2 H}\right)^{K-2}\left(s_{1} s_{2}\right)^{2 H-1}+2 H K(2 H K-1)\left|s_{1}-s_{2}\right|^{2 H K-2}\right] .\right.
\end{aligned}
$$

Consequently

$$
\frac{\partial R}{\partial s_{1}}\left(s_{1}, \infty\right)=\left\{\begin{array}{cl}
\left.2 H K 2^{-K}\left[\left(s_{1}^{2 H}+T^{2 H}\right)^{K-1} s_{1}^{2 H-1}+\left(T-s_{1}\right)^{2 H K-1}\right)\right] & \text { if } \left.s_{1} \in\right] 0, T[ \\
0 & \text { if } s_{1}>T
\end{array}\right.
$$

Moreover

$$
\begin{aligned}
& \bar{\mu}\left(d s_{1}, d s_{2}\right) \\
&=1_{[0, T]^{2}}\left(s_{1}, s_{2}\right) 2^{-K} {\left[4 H^{2} K(K-1)\left(s_{1}^{2 H}+s_{2}^{2 H}\right)^{K-2}\left(s_{1} s_{2}\right)^{2 H-1}\left(s_{1}-s_{2}\right)^{2}\right.} \\
&\left.+2 H K(2 H K-1)\left|s_{1}-s_{2}\right|^{2 H K} d s_{1} d s_{2}\right] .
\end{aligned}
$$

## Conclusions

i) Assumptions (A) and (B) are verified. Assumption (C) is verified because $R(d s, \infty)$ and the marginal measure of $|\bar{\mu}|$ are equivalent to Lebesgue measure on $] 0, T]$ and they vanish on $] T, \infty\left[\right.$. If $H K \geq \frac{1}{2}, X$ has even a covariance measure $\mu$, see [25], Section 4.4.
ii) Assumption (D) is verified only if $H K \leq \frac{1}{2}$. Indeed, $R(d s, \infty)$ is non-negative and $\left.\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}\right|_{\mathbb{R}_{+}^{2} \backslash D}$ is non-positive.

Remark 4.3. If $H K=\frac{1}{2}$, then Assumption ( $D$ ) is verified even if $K \neq 1$. In that case $B^{H, K}$ is not a semimartingale, see [3], Proposition 3. This shows existence of a finite quadratic variation process which verifies Assumption (D) and it is not a local martingale.

### 4.4 Processes with weak stationary increments

Definition 4.1. A square $\left(\tilde{X}_{t}\right)_{t \geq 0}$, such that $\tilde{X}_{0}=0$, is said with weak stationary increments if for every $s, t, \tau \geq 0$

$$
\operatorname{Cov}\left(\tilde{X}_{s+\tau}-\tilde{X}_{\tau}, \tilde{X}_{t+\tau}-\tilde{X}_{\tau}\right)=\operatorname{Cov}\left(\tilde{X}_{s}, \tilde{X}_{t}\right) .
$$

In particular setting $Q(t)=\operatorname{Var}\left(\tilde{X}_{t}\right)$ we have

$$
\operatorname{Var}\left(\tilde{X}_{t+\tau}-\tilde{X}_{\tau}\right)=Q(t), \forall t \geq 0 .
$$

In general $\tilde{X}$ does not fulfill the technical assumption (2.2) and therefore we will work with $X$, where $X_{t}=\tilde{X}_{t \wedge T}$. This is no longer a process with weak stationary increments and its covariance is the following:

$$
R\left(s_{1}, s_{2}\right)=\left\{\begin{array}{cl}
\frac{1}{2}\left(Q\left(s_{1}\right)+Q\left(s_{2}\right)-Q\left(s_{1}-s_{2}\right)\right) & , s_{1}, s_{2} \leq T  \tag{4.2}\\
\frac{1}{2}\left(Q\left(s_{1}\right)+Q(T)-Q\left(T-s_{1}\right)\right) & , s_{2}>T, s_{1} \leq T \\
\frac{1}{2}\left(Q\left(s_{2}\right)+Q(T)-Q\left(T-s_{2}\right)\right) & , s_{2} \leq T, s_{1}>T \\
Q(T) & , s_{1}, s_{2}>T
\end{array}\right.
$$

Remark 4.4. Without restriction of generality we will suppose

$$
\begin{equation*}
Q(t)=Q(T), \quad t \geq T \tag{4.3}
\end{equation*}
$$

so that $Q$ is bounded and continuous and can be extended to the whole line.
Proposition 4.5. Assumption (A) is verified if $Q$ has bounded variation.
Proof: We have

$$
R\left(\infty, s_{2}\right)=\left\{\begin{array}{cl}
\frac{Q\left(s_{2}\right)+Q(T)-Q\left(T-s_{2}\right)}{2} & , s_{2} \leq T  \tag{4.4}\\
Q(T) & , s_{2}>T
\end{array}\right.
$$

so that

R\left(\infty, d s_{2}\right)=\left\{\begin{array}{cl}
\frac{1}{2}\left(Q\left(d s_{2}\right)-Q\left(T-d s_{2}\right)\right) & , s_{2} \leq T  \tag{4.5}\\
0 & , s_{2}>T
\end{array}\right.
$$

(4.2), (4.4) and (4.5) imply the validity of Assumption (A).

Proposition 4.6. We suppose the following.
i) $Q$ is absolutely continuous with derivative $Q^{\prime}$.
ii) $F_{Q}(s):=s Q^{\prime}(s), s>0$ prolongates to zero by continuity to a bounded variation function, which is therefore bounded.

Then $\bar{\mu}$ is the finite Radon measure

$$
1_{[0, T]^{2}}\left(s_{1}, s_{2}\right)\left(-Q^{\prime}\left(s_{1}-s_{2}\right) d s_{1} d s_{2}+F_{Q}\left(s_{1}\right) d s_{1} \delta_{0}\left(d s_{2}\right)-F_{Q}\left(s_{1}-d s_{2}\right) d s_{1}\right) .
$$

Moreover Assumption (B) is verified as well as Assumption $(C(\nu))$ with $\nu\left(d s_{2}\right)=1_{] 0, T[ }\left(s_{2}\right) d s_{2}$.

Remark 4.7. i) $F_{Q}$ can be prolongated to $\mathbb{R}$ by setting $F_{Q}(-s)=F_{Q}(s), s \geq 0$.
ii) In the sense of distributions we have

$$
\left(Q^{\prime}(s) s\right)^{\prime}=Q^{\prime \prime}(s) s+Q^{\prime}(s)
$$

Under $i)$, ii) is equivalent to saying that $Q^{\prime \prime}(d s) \cdot s$ is a finite measure.
iii) Consequently for any $\rho_{\dot{z}} 0,\left.Q^{\prime \prime}\right|_{]-\infty,-\rho] \cup[\rho,+\infty[ }$ is a finite, signed measure.

Proof (of Proposition 4.6): We will evaluate

$$
\begin{equation*}
\left\langle\frac{\partial R^{2}}{\partial s_{1} \partial s_{2}}\left(s_{1}, s_{2}\right)\left(s_{1}-s_{2}\right), \varphi\right\rangle \tag{4.6}
\end{equation*}
$$

for $\varphi \in C_{0}^{\infty}\left(\mathbb{R}_{+}^{2}\right)$. This gives

$$
\int_{\mathbb{R}_{+}^{2}} R\left(s_{1}, s_{2}\right) \frac{\partial^{2}}{\partial s_{1} \partial s_{2}}\left(\varphi\left(s_{1}, s_{2}\right)\left(s_{1}-s_{2}\right)\right) d s_{1} d s_{2}=\frac{1}{2}\left(I_{1}+I_{2}-I_{3}\right)
$$

where

$$
\begin{aligned}
I_{1} & =\int_{\mathbb{R}_{+}^{2}} Q\left(s_{1}\right) \frac{\partial^{2}}{\partial s_{1} \partial s_{2}}\left(\varphi\left(s_{1}, s_{2}\right)\left(s_{1}-s_{2}\right)\right) d s_{1} d s_{2} \\
I_{2} & =\int_{\mathbb{R}_{+}^{2}} Q\left(s_{2}\right) \frac{\partial^{2}}{\partial s_{1} \partial s_{2}}\left(\varphi\left(s_{1}, s_{2}\right)\left(s_{1}-s_{2}\right)\right) d s_{1} d s_{2} \\
I_{3} & =\int_{\mathbb{R}_{+}^{2}} \tilde{Q}\left(s_{1}, s_{2}\right) \frac{\partial^{2}}{\partial s_{1} \partial s_{2}}\left(\varphi\left(s_{1}, s_{2}\right)\left(s_{1}-s_{2}\right)\right) d s_{1} d s_{2}
\end{aligned}
$$

where

$$
\tilde{Q}\left(s_{1}, s_{2}\right)=\left\{\begin{array}{cl}
Q\left(s_{1}-s_{2}\right) & , s_{1}, s_{2} \leq T \\
Q\left(T-s_{1}\right) & , s_{2}>T, s_{1} \leq T \\
Q\left(T-s_{2}\right) & , s_{1}>T, s_{2} \leq T \\
0 & , s_{1}, s_{2}>T
\end{array}\right.
$$

First we evaluate $I_{3}$. Using assumption i) it is clear that for every $s_{2} \geq 0, s_{1} \longmapsto \tilde{Q}\left(s_{1}, s_{2}\right)$ is absolutely continuous. Similarly, for every $s_{1} \geq 0, s_{2} \longmapsto \tilde{Q}\left(s_{1}, s_{2}\right)$ has the same property. Therefore integrating by parts we obtain

& +\int_{T}^{\infty} d s_{1}\left(\int_{0}^{T} d s_{2} Q^{\prime}\left(T-s_{2}\right) \frac{\partial}{\partial s_{1}}\left(\varphi\left(s_{1}, s_{2}\right)\left(s_{1}-s_{2}\right)\right)\right) .
\end{aligned}
$$

Using Fubini's theorem we get

& \quad-\int_{0}^{T} d s_{2} Q^{\prime}\left(T-s_{2}\right) \varphi\left(T, s_{2}\right)\left(T-s_{2}\right) .
\end{aligned}
$$

Therefore

I_{3}= & -\int_{0}^{T} d s_{2} \int_{0}^{T} d s_{1} F_{Q}\left(d s_{1}-s_{2}\right) \varphi\left(s_{1}, s_{2}\right)+\int_{0}^{T} d s_{2}\left\{F_{Q}\left(T-s_{2}\right) \varphi\left(T, s_{2}\right)-F_{Q}\left(-s_{2}\right) \varphi\left(0, s_{2}\right)\right\} \\
& +\int_{0}^{T} d s_{2} \int_{0}^{T} d s_{1} Q^{\prime}\left(s_{1}-s_{2}\right) \varphi\left(s_{1}, s_{2}\right)-\int_{0}^{T} d s_{2} Q^{\prime}\left(T-s_{2}\right) \varphi\left(T, s_{2}\right)\left(T-s_{2}\right) .
\end{aligned}
$$

Consequently

\end{align*}

Concerning $I_{1}$ we obtain

& \left.\int_{0}^{\infty} d s_{1} Q\left(s_{1}\right) \frac{\partial}{\partial s_{1}}\left(\varphi\left(s_{1}, s_{2}\right)\left(s_{1}, s_{2}\right)\right)\right|_{s_{2}=0} ^{\infty}=-\int_{0}^{\infty} d s_{1} Q\left(s_{1}\right)\left(\frac{\partial \varphi}{\partial s_{1}} \varphi\left(s_{1}, 0\right) s_{1}+\varphi\left(s_{1}, 0\right)\right)  \tag{4.8}\\
& =-\int_{0}^{\infty} d s_{1} Q\left(s_{1}\right) \frac{d}{d s_{1}}\left(\varphi\left(s_{1}, 0\right) s_{1}\right)=\int_{0}^{T} Q^{\prime}\left(s_{1}\right) s_{1} \varphi\left(s_{1}, 0\right) d s_{1}=\int_{0}^{T} F_{Q}\left(s_{1}\right) \varphi\left(s_{1}, 0\right) d s_{1} .
\end{align*}
$$

Concerning $I_{2}$ we obtain

I_{2}=-\int_{0}^{T} F_{Q}\left(s_{2}\right) \varphi\left(0, s_{2}\right) d s_{2} \tag{4.9}
\end{equation*}
$$

Using (4.8), (4.9) and (4.7) it follows

I_{1}+I_{2}-I_{3} & =\int_{\mathbb{R}_{+}} F_{Q}\left(s_{1}\right) \varphi\left(s_{1}, 0\right) d s_{1} \\
& +\int_{0}^{T} d s_{2} \int_{0}^{T} F_{Q}\left(d s_{1}-s_{2}\right) \varphi\left(s_{1}, s_{2}\right)-\int_{\mathbb{R}_{+}^{2}} d s_{1} d s_{2} \varphi\left(s_{1}, s_{2}\right) Q^{\prime}\left(s_{1}-s_{2}\right) .
\end{aligned}
$$

This allows to conclude taking into account the fact, by symmetry,

d s_{1} F_{Q}\left(d s_{1}-s_{2}\right)=d s_{2} F_{Q}\left(s_{1}-d s_{2}\right)
$$

At this point Assumptions (B) and $(\mathrm{C}(\nu))$ follow directly.

Corollary 4.8. Under the assumptions of Proposition 4.6, Assumption (D) is verified if $Q$ is increasing and $Q^{\prime \prime}$ restricted to $] 0, T[$ is a non-positive measure.

Remark 4.9. Previous Assumption ( $D$ ) is equivalent to $Q$ increasing and concave.
Proof (of Corollary 4.8): By (4.5), $R\left(d s_{1}, \infty\right)$ is a non-negative measure if $Q$ is increasing. $Q^{\prime \prime}$ restricted to $] 0, \infty\left[\right.$ is a Radon measure, hence $Q^{\prime}$ restricted to $] 0, \infty[$ is of locally bounded variation and

$$
\left.\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}\right|_{\mathbb{R}_{+}^{2} \backslash D}=Q^{\prime \prime}\left(s_{1}-d s_{2}\right) 1_{] 0, T\left[^{2}\right.}\left(s_{1}, s_{2}\right) d s_{1}
$$

and the result follows.

Corollary 4.10. Under the same assumptions as Proposition 4.0, if $Q^{\prime} 1_{10, T[ }>0$ then Assumption (C) is verified.

Proof: The result follows because in this case $\nu=|R|(\infty, d s)=R(\infty, d s)=$ $\frac{1}{2}\left(Q^{\prime}(s)+Q^{\prime}(T-s)\right) 1_{] 0, T[ } d s$.

Example 4.11. Processes with weak stationary increments (particular cases).
Let $\left(\tilde{X}_{t}\right)_{t \geq 0}$ be a zero-mean second order process with weakly stationary increments. We set

$$
Q(t)=\operatorname{Var}\left(\tilde{X}_{t}\right)
$$

We refer again to $X_{t}=\tilde{X}_{t \wedge T}$.

1. Suppose

$$
Q(t)=\left\{\begin{array}{cl}
t^{2 H} & , t<T \\
T^{2 H} & , t \geq T
\end{array}\right.
$$

Then Assumptions (A), (B) and (C) are verified. If $H \leq \frac{1}{2}$, Assumption (D) is fulfilled.
2. We consider a more singular kernel than every fractional scale. We set $T=1$.

$$
Q(t)=\left\{\begin{array}{cl}
\frac{1}{\log \left(\frac{1}{t}\right)} & , 0<t<e^{-2} \\
0 & , t=0 \\
\frac{1}{2} & , t \geq e^{-2}
\end{array}\right.
$$

Then Assumption ( $A$ ) is verified since $Q$ is increasing. Moreover $Q$ is absolutely continuous with

$$
Q^{\prime}(t)=\left\{\begin{array}{cl}
\left(\log \frac{1}{t}\right)^{-2} \frac{1}{t} & , 0<t<e^{-2} \\
0 & , t>e^{-2}
\end{array}\right.
$$

We observe that

$$
F_{Q}(t)=t Q^{\prime}(t)=\left\{\begin{array}{cl}
\left(\log \frac{1}{t}\right)^{-2} & , 0<t<e^{-2} \\
0 & , t>e^{-2}
\end{array}\right.
$$

and $\lim _{t \rightarrow 0} F_{Q}(t)=0$. It is not difficult to show that $F_{Q}$ has bounded variation, therefore Assumption (B) is fulfilled by Proposition 4.0. Since $Q^{\prime}>0$, on $] 0, T$ [ a.e., Assumption (C) is verified because of Corollary 4.10. Finally

-\left(\log \frac{1}{t}\right)^{-2} t^{-2}\left[1-2 \log \frac{1}{t}\right] & , 0<t<e^{-2} \\
0 & , t>e^{-2}
\end{array}\right.
$$

Since $Q^{\prime \prime}$ is negative, Assumption (D) is fulfilled.

## 5 Comparison with the kernel approach

We consider a process $X$ continuous in $L^{2}(\Omega)$ of the type

$$
\begin{equation*}
X_{t}=\int_{0}^{t} K(t, s) d W_{s}, t \in[0, T] \tag{5.10}
\end{equation*}
$$

where $K: \mathbb{R}_{+}^{2} \longrightarrow \mathbb{R}$ is a measurable function, such that for every $t \geq 0, \int_{0}^{t} K^{2}(t, s) d s<\infty$.
Remark 5.1. $\left(X_{t}\right)_{t \in[0, T]}$ is a Gaussian process with covariance

$$
R\left(t_{1}, t_{2}\right)=\int_{0}^{t_{1} \wedge t_{2}} K\left(t_{1}, s\right) K\left(t_{2}, s\right) d s
$$

We extend $\left(X_{t}\right)$ to the whole line, setting $X_{t}=X_{T}, t \geq T, X_{t}=0, t<0$.
We want to investigate here natural, sufficient conditions on $K$ so that $X$ has a covariance measure structure. We take inspiration from a paper of Alos-Mazet-Nualart [2], which discusses Malliavin calculus with respect to general processes of type (5.10). That paper distinguishes between the regular and singular case.

The aim of this section is precisely to provide some general considerations related to the approach presented in [2] in relation to ours. In their regular context, we will show
that the process has covariance measure structure. Concerning their singular case, we will restrict to the case that $K(t, s)=\kappa(t-s), t \geq s \geq 0$, where $\kappa: \mathbb{R}_{+} \longrightarrow \mathbb{R}$. We will provide natural conditions so that Assumptions (A) and (B) are verified. We formulate first two general assumptions on $K$.

Assumption (K1) For each $s \geq 0, \bar{K}(d t, s)=K(d t, s)(t-s)$ is a finite measure. This implies in particular, for $\varepsilon>0$,

$$
\begin{equation*}
K(d t, s) 1_{(s+\varepsilon, \infty)}(t) \text { is a finite measure. } \tag{5.11}
\end{equation*}
$$

## Assumption (K2)

$$
\varepsilon \sup _{s} K(s+\varepsilon, s) \longrightarrow 0
$$

Let $T>0$. We extend $K$ to $\tilde{K}: \mathbb{R}_{+}^{2} \longrightarrow \mathbb{R}$, so that

$$
\tilde{K}(t, s)=\left\{\begin{array}{cl}
K(t, s) & , 0<s<t<T  \tag{5.12}\\
K(T, s) & , 0<s<T<t \\
0 & , \text { otherwise }
\end{array}\right.
$$

Let $\left(W_{t}\right)_{t \geq 0}$ be a standard Brownian motion. Indeed

$$
\begin{equation*}
\tilde{X}_{t}=\int_{0}^{t} \tilde{K}(t, s) d W_{s}, t \in \mathbb{R}_{+} \tag{5.13}
\end{equation*}
$$

extends $X$ by continuity in $L^{2}(\Omega)$ from $[0, T]$ to $\mathbb{R}_{+}$. In the sequel $\tilde{K}$ and $\tilde{X}$ will often be denoted again by $K$ and $X$. For processes $X$ defined for $t \in[0, T]$, [2] introduces two maps $G$ and $G^{*}$. Similarly to [2], we define

$$
G: L^{2}[0, T] \longrightarrow L^{2}[0, T]
$$

by

G \varphi(t)=\int_{0}^{t} K(t, s) \varphi(s) d s, t \in[0, T]
$$

Let $W^{1, \infty}([0, T])$ be the space of $\varphi \in L^{2}([0, T])$ absolutely continuous such that $\varphi^{\prime} \in$ $L^{\infty}([0, T])$. We set

$$
G^{*}: W^{1, \infty}([0, T]) \longrightarrow L^{2}[0, T]
$$

by

$$
G^{*} \varphi(s)=\varphi(s) K(T, s)+\int_{[s, T]}(\varphi(t)-\varphi(s)) K(d t, s)
$$

We remark that $G^{*}$ is well defined because (K1) is verified.

Remark 5.2. In order to better understand the definition of $G^{*}$, we consider the following "regular" case: for $s \geq 0, t \longmapsto K(t, s), 0 \leq s \leq t \leq T$ has bounded variation and

\sup _{s \in[0, T]}|K|(d t, s)<\infty
$$

Then integration by parts shows that

$$
G^{*} \varphi(s)=\int_{s}^{T} \varphi(t) K(d t, s),
$$

since $K(s-, s)=0$.
Lemma 5.3. Under Assumptions (K1) and (K2), for $\varphi \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$we have

\int_{0}^{T} G^{*} \varphi d W=\varphi(T) X_{T}-\int_{0}^{T} X_{s} d \varphi_{s} . \tag{5.14}
\end{equation*}

Proof: Let $\varepsilon>0$. Since

& \leq \sup \left|\varphi^{\prime}\right||\bar{K}|([s, T], s)<\infty,
\end{aligned}
$$

Lebesgue's dominated convergence theorem gives

\left(G^{*} \varphi\right)(s)=\varphi(s) K(T, s)+\lim _{\varepsilon \rightarrow 0} \int_{s+\varepsilon}^{T}(\varphi(t)-\varphi(s)) K(d t, s) .
$$

Integration by parts gives

$$
\begin{aligned}
\varphi(s) & K(T, s)+\lim _{\varepsilon \rightarrow 0}\{(\varphi(T)-\varphi(s)) K(T, s)+(\varphi(s+\varepsilon)-\varphi(s)) K(s+\varepsilon, s)\} \\
& -\int_{s+\varepsilon}^{T} \varphi^{\prime}(t) K(t, s) d t .
\end{aligned}
$$

Again Lebesgue's dominated convergence theorem implies

\varphi(T) K(T, s)-\int_{s}^{T} \varphi^{\prime}(t) K(t, s) d t-\lim _{\varepsilon \rightarrow 0}(\varphi(s+\varepsilon)-\varphi(s)) K(s+\varepsilon, s) .

Since $\varphi \in C_{0}^{1}$, Assumption (K2) says that the limit above is zero. Through stochastic Fubini's, the left member of (5.14) gives

So the result is proven.
We leave now the general case and consider one assumption stated in [2].

Remark 5．4．［⿴囗才 considers the following assumption

which characterizes their＂regular＂context．Proposition 5.6 below shows that，（5．15）implies that $X$ has a covariance measure structure．

Remark 5．5．Under（5．15），assumptions（K1）and（K2）are in particular fulfilled．
Proposition 5．6．Let $\left(X_{t}\right)_{t \in[0, T]}$ be a process defined by

X_{t}=\int_{0}^{t} K(t, s) d W_{s}, t \in[0, T],
$$

where $\left(W_{t}\right)_{t \geq 0}$ is a classical Wiener process．Then $X$ has a covariance measure structure if （5．1）is verified．

Proof：We recall that here $K$（resp．$X$ ）is prolongated to $\mathbb{R}_{+}^{2}$（resp． $\mathbb{R}$ ）in conformity with（5．12）and（5．13）．It is enough to show that there is a constant $C$ ，such that

Let $\varphi \in C_{0}^{\infty}\left(\mathbb{R}_{+}^{2}\right)$ ．We have

R\left(t_{1}, t_{2}\right)=\int_{0}^{\infty} K\left(t_{1}, s\right) K\left(t_{2}, s\right) d s

Indeed，using Fubini＇s，we have

\left\langle\frac{\partial^{2} R}{\partial t_{1} \partial t_{2}}, \varphi\right\rangle= & \int_{\mathbb{R}_{+}^{2}} R\left(t_{1}, t_{2}\right) \frac{\partial^{2} \varphi}{\partial t_{1} \partial t_{2}}\left(t_{1}, t_{2}\right) d t_{1} d t_{2} \\
& =\int_{0}^{\infty} d s \int_{\mathbb{R}_{+}^{2}} \frac{\partial^{2} \varphi}{\partial t_{1} \partial t_{2}}\left(t_{1}, t_{2}\right) K\left(t_{1}, s\right) K\left(t_{2}, s\right) d t_{1} d t_{2} . \tag{5.16}
\end{align*}
$$

Now $K\left(d t_{1}, s\right) K\left(d t_{2}, s\right)$ is a Radon measure on $\mathbb{R}_{+}^{2}$ because of Remark 5.2. According to [5], Theorem 12.5, its total variation is the supremum over $s=t_{0}<t_{1}<\cdots<t_{N}=T$, of

\begin{aligned}
\sum_{i, j=0}^{N-1} & \left|K\left(t_{i+1}, s\right) K\left(t_{j+1}, s\right)+K\left(t_{i}, s\right) K\left(t_{j}, s\right)-K\left(t_{i}, s\right) K\left(t_{j+1}, s\right)-K\left(t_{i+1}, s\right) K\left(t_{j}, s\right)\right| \\
& =\sum_{i, j=0}^{N-1}\left|\int_{\left.\left.\left.j t_{i}, t_{i+1}\right] \times\right] t_{j}, t_{j+1}\right]} K\left(d t_{1}, s\right) K\left(d t_{2}, s\right)\right| \leq \sum_{i, j=0}^{N-1} \int_{] t_{i}, t_{i+1}\right]}|K|\left(d t_{1}, s\right) \int_{] t_{j}, t_{j+1}\right]}|K|\left(d t_{2}, s\right) \\
& \left.\left.=\left(\int_{] s, T]}|K|(d t, s)\right)^{2}=|K|(] s, T\right], s\right)^{2} .
\end{aligned}
$$

Hence (5.16) equals

$$
\int_{0}^{\infty} \int_{\mathbb{R}_{+}^{2}} \varphi\left(t_{1}, t_{2}\right) K\left(d t_{1}, s\right) K\left(d t_{2}, s\right)
$$

and

$$
\left.\left|\left\langle\frac{\partial^{2} R}{\partial t_{1} \partial t_{2}}, \varphi\right\rangle\right| \leq\|\varphi\|_{\infty} \int_{0}^{\infty} d s \| K\left(d t_{1}, s\right) K\left(d t_{2}, s\right)\right)\left\|_{v a r} \leq C\right\| \varphi \|_{\infty}
$$

with $\left.\left.C=\int_{0}^{\infty}|K|^{2}(] s, T\right], s\right) d s$ and $\|\cdot\|_{\text {var }}$ denotes the total variation norm.
In order to prepare the sequel, we specify $\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}$ if $X_{t}=\int_{0}^{t} \kappa(t-s) d W_{s}$, where $\kappa: \mathbb{R}_{+} \longrightarrow \mathbb{R}$ has bounded variation, supposed cadlag by convention. So we remain for the moment in the regular case.

Remark 5.7. a) We prolongate $\kappa$ to $\kappa: \mathbb{R} \longrightarrow \mathbb{R}$ setting $\kappa(t)=0$ if $t<0$.
b) $R\left(t_{1}, t_{2}\right)=\int_{0}^{t_{1} \wedge t_{2}} \kappa\left(t_{1}-s\right) \kappa\left(t_{2}-s\right) d s=\int_{0}^{\infty} \kappa\left(t_{1}-s\right) \kappa\left(t_{2}-s\right) d s$.
c) If $\kappa$ has bounded variation then $\kappa 1_{] \varepsilon, \infty[ }$ has bounded variation for any $\varepsilon>0$, which will constitute Assumption (K1') below. It is equivalent to Assumption (K1), when the kernel $K$ is not necessarily homogeneous.

Lemma 5.8. For $\phi \in C_{0}^{\infty}\left(\mathbb{R}_{+}^{2}\right)$

$$
\left\langle\frac{\partial^{2} R}{\partial t_{1} \partial t_{2}}, \phi\right\rangle=\left\langle I_{1}+I_{2}+I_{3}+I_{4}, \phi\right\rangle
$$

where $I_{1}, I_{2}, I_{3}, I_{4}$ are the following Radon measures:

$$
\begin{aligned}
I_{1} & =\kappa^{2}(0) d t_{1} \delta\left(d t_{2}-t_{1}\right), \\
I_{2} & =\kappa(0) 1_{\left[t_{2}, \infty\right.}\left[\left(t_{1}\right) \kappa\left(d t_{1}-t_{2}\right),\right. \\
I_{3} & =\kappa(0) 1_{\left[t_{1}, \infty[ \right.}\left[t_{2}\right) \kappa\left(d t_{2}-t_{1}\right), \\
\left\langle I_{4}, \phi\right\rangle & =\int_{\mathbb{R}_{+}^{2}} \kappa\left(d t_{1}\right) \kappa\left(d t_{2}\right) \int_{0}^{\infty} \phi\left(t_{1}+s, t_{2}+s\right) d s .
\end{aligned}
$$

Remark 5.9. If $\kappa$ has bounded variation, Lemma 5.8 shows that $X$ has a covariance measure structure.

In view of the verification of Assumption (B) we have the following result.
Corollary 5.10. Suppose that $\kappa(0)=0$, $\kappa$ with bounded variation. Let $\phi \in C_{0}^{\infty}\left(\mathbb{R}_{+}^{2}\right)$. We have

Proof (of Lemma 5.8): By density arguments we will reduce to the case, where $\phi=\varphi \otimes \psi, \varphi, \psi \in C_{0}^{\infty}\left(\mathbb{R}_{+}^{2}\right)$. The left-hand side equals

We recall that by convention we extend $\kappa$ to $\mathbb{R}$ by setting zero on $]-\infty, 0[$. Hence, by Fubini's theorem it equals

& =I_{1}+I_{2}+I_{3}+I_{4},
\end{aligned}
$$

where

\begin{aligned}
& I_{1}=\kappa^{2}(0) \int_{0}^{\infty} \varphi(s) \psi(s) d s=\kappa(0)^{2} \int_{\mathbb{R}_{+}^{2}} d s_{1} \delta\left(d s_{2}-s_{1}\right) \varphi\left(s_{1}\right) \psi\left(s_{2}\right), \\
& I_{2}=\int_{0}^{\infty} \psi(s) \kappa(0) \int_{s}^{\infty} \varphi\left(t_{1}\right) \kappa\left(d t_{1}-s\right)=\int_{\mathbb{R}_{+}^{2}} \varphi\left(t_{1}\right) \psi(s) 1_{[s, \infty[ }\left(t_{1}\right) \kappa\left(d t_{1}-s\right) d s \kappa(0), \\
& I_{3}=\int_{\mathbb{R}_{+}^{2}} \varphi(s) \psi\left(t_{2}\right) 1_{[s, \infty[ }\left(t_{2}\right) \kappa\left(d t_{2}-s\right) d s \kappa(0), \\

By Fubini's theorem

& =\int_{0}^{\infty} d s \int_{0}^{\infty} \varphi\left(t_{1}+s\right) \kappa\left(d t_{1}\right) \int_{0}^{\infty} \psi\left(t_{2}+s\right) \kappa\left(d t_{2}\right)
\end{aligned}
$$

This concludes the proof.

We examine now some aspects related to the singular case. It is of course possible to give sufficient conditions on the kernel $K$, so that $X_{t}=\int_{0}^{t} K(t, s) d W_{s}$ fulfills Assumptions (A) and (B), however these conditions are too technical and not readable.

So we decided to consider the homogeneous case in the sense that $K(t, s)=\kappa(t-s)$, $\kappa: \mathbb{R} \longrightarrow \mathbb{R}$, where $\left.\kappa\right|_{\mathbb{R}_{-}}=0$. Clearly the minimal assumption, so that $X$ is defined, is $\kappa \in L^{2}([0, t]), \forall t \geq 0$. This is equivalent to $\kappa \in L^{2}\left(\mathbb{R}_{+}\right)$.

We formulate first an assumption on $\kappa$.
Assumption (K1') $\left.\kappa\right|_{] \varepsilon, \infty}$ is with bounded variation for any $\varepsilon>0$.
We recall that this is equivalent to (K1), when $K$ is homogeneous.
Proposition 5.11. Let $\left(X_{t}\right)_{t \geq 0}$ be a process defined by

$$
X_{t}=\int_{0}^{t} \kappa(t-s) d W_{s}, t \geq 0
$$

We suppose (K1'),(K2) and moreover
a) $\kappa$ has compact support,
b)

$$
\begin{equation*}
\sup _{s \geq 0} \int_{0}^{\infty} d u\left|\int_{0}^{u}(\kappa(d x) \kappa(s+x-u)-\kappa(s-u))\right|<\infty \tag{5.17}
\end{equation*}
$$

Then Assumption (A) is fulfilled.
Remark 5.12. 1. If we assume ( $K 1^{\prime}$ ), then $\kappa(d x)$ is a finite measure on $] \varepsilon, \infty[$, so the left-hand side of (5.17) is a priori not always finite. Indeed $|\kappa|(d x)$ on $[0, \infty[$ is only a $\sigma$-finite measure which may be infinite. $\int_{0}^{u} \kappa(d x)(\kappa(s+x-u)-\kappa(s-u))$ is evaluated as

\lim _{\varepsilon \rightarrow 0} \int_{\varepsilon}^{\infty} \kappa(d x)(\kappa(s+x-u)-\kappa(s-u))

2. Assumption (K2) implies here that $\kappa(\varepsilon) \varepsilon \underset{\varepsilon \rightarrow 0+}{\longrightarrow} 0$.

Proof (of Proposition 5.11): Let $\alpha \in C_{0}^{\infty}\left(\mathbb{R}_{+}\right)$. We want to show the existence of a constant $\mathcal{C}$ such that, for any $s \geq 0$

This would establish the validity of Assumption (A). The left-hand side of (5.18) is given by

& =\lim _{\varepsilon \rightarrow 0} \int_{0}^{s} d u \kappa(s-u) \int_{\varepsilon}^{\infty} d x \frac{d}{d x}(\alpha(x+u)-\alpha(u)) \kappa(x) . \\

& =\lim _{\varepsilon \rightarrow 0} \int_{\varepsilon}^{\infty} d u \alpha(u) \int_{\varepsilon}^{u} \kappa(d x) \kappa(s+x-u)-\int_{\varepsilon}^{\infty} d u \alpha(u) \int_{\varepsilon}^{\infty} \kappa(d x) \kappa(s-u) \\

& I_{1}(\alpha)=\int_{0}^{\infty} d u \alpha(u) \int_{0}^{u} \kappa(d x)(\kappa(s+x-u)-\kappa(s-u)) \\
& I_{2}(\alpha)=\int_{0}^{\infty} d u \alpha(u) \int_{u}^{\infty} \kappa(d x) \kappa(s-u)
\end{aligned}
$$

We remark that

$$
\left|I_{2}(\alpha)\right| \leq\|\alpha\|_{\infty} \int_{0}^{\infty} d u \kappa^{2}(u)
$$

because of Cauchy-Schwarz. Moreover

$$
\left|I_{1}(\alpha)\right| \leq\|\alpha\|_{\infty} \int_{0}^{\infty} d u\left|\int_{0}^{u} \kappa(d x)(\kappa(s+x-u)-\kappa(s-u))\right|
$$

The right-hand side is bounded because of (5.17).

Remark 5.13. We remark that (5.17) is a quite general assumption. It is for instance verified if

\int_{0}^{\infty}|\kappa|(d x) \int_{0}^{\infty}|\kappa(x+u)-\kappa(u)| d u<\infty \tag{5.20}
\end{equation*}

In particular, taking $\kappa(x)=x^{H-\frac{1}{2}}, H>0$, (5.2d) is always verified.
We go on establishing sufficient conditions so that Assumption (B) is verified.
Proposition 5.14. We suppose again (K1'). In particular $|\kappa|_{\text {var }}(x):=-\int_{x}^{\infty} d|\kappa|(y), x>0$ exists. Suppose there is $\delta>0$ with

\end{equation*}

Then Assumption (B) is fulfilled.
Remark 5.15. If $\kappa$ is monotonous and $\kappa(+\infty)=0$, then (5.21) is always fulfilled since $|\kappa|_{\text {var }}(x)=-\kappa(x)$, which is square integrable.

Proof(of Proposition 5.14): Let $\varphi \in C_{0}^{\infty}\left(\mathbb{R}_{+}^{2}\right)$. We need to show that

\left|\int_{\mathbb{R}_{+}^{2}} R\left(t_{1}, t_{2}\right) \frac{\partial^{2}}{\partial t_{1} \partial t_{2}}\left(\varphi\left(t_{1}, t_{2}\right)\left(t_{1}-t_{2}\right)\right)\right| \leq \text { const. }\|\varphi\|_{\infty} \tag{5.22}
\end{equation*}
$$

where

$$
R\left(t_{1}, t_{2}\right)=\int_{0}^{t_{1} \wedge t_{2}} \kappa\left(t_{1}-s\right) \kappa\left(t_{2}-s\right) d s
$$

The left-hand side of 5.22 is the limit when $\varepsilon \rightarrow 0$ of

\begin{equation*}
\int_{\mathbb{R}_{+}^{2}} R_{\varepsilon}\left(t_{1}, t_{2}\right) \frac{\partial^{2}}{\partial t_{1} \partial t_{2}}\left(\varphi\left(t_{1}, t_{2}\right)\left(t_{1}-t_{2}\right)\right) d t_{1} d t_{2} \tag{5.23}
\end{equation*}
$$

where

$$
\begin{aligned}
& R_{\varepsilon}\left(t_{1}, t_{2}\right)=\int_{0}^{t_{1} \wedge t_{2}} \kappa_{\varepsilon}\left(t_{1}-s\right) \kappa_{\varepsilon}\left(t_{2}-s\right) d s \\
& \kappa_{\varepsilon}(u)=1_{] \varepsilon, \infty} \kappa(u)
\end{aligned}
$$

$\kappa_{\varepsilon}$ being of bounded variation. Applying Lemma 5.8 and the fact that $\kappa_{\varepsilon}(0)=0$, expression (5.23) gives

We set $\left|\kappa_{\varepsilon}\right|_{v a r}(x):=-\int_{x \vee \varepsilon}^{\infty} d|\kappa|(y)$. Let $M>0$ such that $\operatorname{supp} \varphi \subset[0, M]^{2}$. Previous quantity is bounded by

\int_{\mathbb{R}_{+}^{2}}\left|\kappa_{\varepsilon}\right| \operatorname{var}\left(d t_{1}\right)\left|\kappa_{\varepsilon}\right| \operatorname{var}\left(d t_{2}\right)\left(t_{1}-t_{2}\right)=\left.2 \int_{0}^{\infty}\left|\kappa_{\varepsilon}\right|_{\operatorname{var}}\left(d t_{1}\right)\left|\int_{0}^{t_{1}}\right| \kappa_{\varepsilon}\right|_{\operatorname{var}}\left(d t_{2}\right)\left(t_{1}-t_{2}\right) .
$$

Integrating by parts, previous expression equals

& 2 \int_{0}^{\infty}\left|\kappa_{\varepsilon}\right|_{v a r}\left(d t_{1}\right) \int_{0}^{\infty}\left|\kappa_{\varepsilon}\right|_{v a r}\left(t_{2}\right) d t_{2}=2 \int_{0}^{\infty} d t_{2}\left|\kappa_{\varepsilon}\right|_{v a r}\left(t_{2}\right) \int_{t_{2}}^{\infty}\left|\kappa_{\varepsilon}\right|_{v a r}\left(d t_{1}\right) \\
& =2 \int_{\varepsilon}^{\infty} d t_{2}|\kappa|_{\text {var }}^{2}\left(t_{2}\right) \xrightarrow[\varepsilon \rightarrow 0]{\longrightarrow} 2 \int_{0}^{\infty} d t_{2}|\kappa|_{v a r}^{2}\left(t_{2}\right), \tag{5.25}
\end{align*}
$$

which is finite because of Assumption (5.21).

## 6 Definition of the Paley-Wiener integral

### 6.1 Functional spaces and related properties

The aim of this section is to define a natural class of integrands for the so called PaleyWiener integral (or simply Wiener integral). Let $X=\left(X_{t}\right)$ be a second order process, i.e. a square integrable process which is continuous in $L^{2}(\Omega)$. We suppose moreover $X_{0}=0$ and $\lim _{t \rightarrow \infty} X_{t}=X_{\infty}$ in $L^{2}(\Omega)$, as in (2.2). As observed for instance in [22], the natural strategy is to extend the linear map

$$
\begin{equation*}
I: C_{0}^{1}\left(\mathbb{R}_{+}\right) \longrightarrow L^{2}(\Omega) \tag{6.1}
\end{equation*}
$$

defined by $I(f)$ :

$$
\begin{equation*}
I(f):=\int_{0}^{\infty} f d X=f(\infty) X_{\infty}-\int_{0}^{\infty} X d f \tag{6.2}
\end{equation*}
$$

In this section, we introduce a natural Banach space of integrands for which the Wiener integral is defined trough prolongation of operator $I$. In the whole section $X$ will be supposed to verify Assumptions (A), (B) and (C $(\nu)$ ) for some $\nu$ by default.

We recall that $\mu=\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}$ restricted to $\mathbb{R}_{+}^{2} \backslash D$ is a $\sigma$-finite measure but $\frac{\partial^{2} R}{\partial s_{1} \partial s_{2}}$ is only a distribution.

Definition 6.1. We denote by $\tilde{L}_{R}$ the linear space of Borel functions $f: \mathbb{R}_{+} \longrightarrow \mathbb{R}$, such that
i) $\int_{0}^{\infty} f^{2}(s)|R|(d s, \infty)<\infty$,
ii) $\int_{\mathbb{R}_{+}^{2} \backslash D}\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)^{2} d|\mu|\left(s_{1}, s_{2}\right)<\infty$,
where $|\mu|$ is the total variation measure of the $\sigma$-finite measure $\mu$.
Remark 6.1. The integral in ii) equals

$$
\int_{\mathbb{R}_{+}^{2}}\left|f\left(s_{1}\right)-f\left(s_{2}\right)\right|^{2} d|\mu|\left(s_{1}, s_{2}\right)
$$

For $f \in \tilde{L}_{R}$ we define

$$
\begin{align*}
\|f\|_{\mathcal{H}}^{2} & =\int_{0}^{\infty} f^{2}(s) R(d s, \infty)-\frac{1}{2} \int_{\mathbb{R}_{+}^{2}}\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)^{2} d \mu\left(s_{1}, s_{2}\right)  \tag{6.3}\\
\|f\|_{R}^{2} & =\int_{0}^{\infty} f^{2}(s)|R|(d s, \infty)+\frac{1}{2} \int_{\mathbb{R}_{+}^{2}}\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)^{2} d|\mu|\left(s_{1}, s_{2}\right) \tag{6.4}
\end{align*}
$$

Let $H_{X}$ be the Hilbert subspace of $L^{2}(\Omega)$ constituted by the closure of $I(f), f \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$.
Remark 6.2. If $f \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$, then (6.2) and Proposition 3.6 give

$$
E\left(I(f)^{2}\right)=E\left(\int_{0}^{\infty} X_{u} d f(u)\right)^{2}=\int_{\mathbb{R}_{+}^{2}} R\left(s_{1}, s_{2}\right) d f\left(s_{1}\right) d f\left(s_{2}\right)=\|f\|_{\mathcal{H}}^{2}
$$

So $C_{0}^{1}\left(\mathbb{R}_{+}\right)$equipped with $\|\cdot\|_{\mathcal{H}}$ is isometrically embedded into $L^{2}(\Omega)$.
Let $\mathcal{H}$ be an abstract completion of $C_{0}^{1}\left(\mathbb{R}_{+}\right)$with respect to $\|\cdot\|_{\mathcal{H}} . \mathcal{H}$ will be called "self-reproducing kernel space". The application I: $C_{0}^{1}\left(\mathbb{R}_{+}\right) \longrightarrow H_{X}$ uniquely prolongates to $\mathcal{H}$. If $\mathcal{H}$ were a space of functions, the prolongation $I$ would be candidate to be called Paley-Wiener integral.

Remark 6.3. i) For $f \in \tilde{L}_{R}$, we have

$$
\|f\|_{\mathcal{H}} \leq\|f\|_{R},
$$

ii) $\|\cdot\|_{\mathcal{H}}$ and $\|\cdot\|_{R}$ are seminorms on $\tilde{L}_{R}$ because they derive from the semi-scalar products

\begin{aligned}
& \langle f, g\rangle_{R}=\int_{0}^{\infty}(f g)(s)|R|(d s, \infty)+\int_{\mathbb{R}_{+}^{2}} d|\mu|\left(s_{1}, s_{2}\right)\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)\left(g\left(s_{1}\right)-g\left(s_{2}\right)\right) \\
& \langle f, g\rangle_{\mathcal{H}}=\int_{0}^{\infty}(f g)(s) R(d s, \infty)-\int_{\mathbb{R}_{+}^{2}} d \mu\left(s_{1}, s_{2}\right)\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)\left(g\left(s_{1}\right)-g\left(s_{2}\right)\right)
\end{aligned}
$$

iii) $\langle\cdot, \cdot\rangle_{\mathcal{H}}$ is a semi-scalar product because it is a bilinear symmetric form; moreover it is positive definite on $C_{0}^{1}$ because $\langle\varphi, \varphi\rangle_{\mathcal{H}}=E\left(I(\varphi)^{2}\right)$.
iv) We remark however that $\|f\|_{R}=0$ implies in any case $f=0|R|(d s, \infty)$ a.e.
v) $\tilde{L}_{R} / \sim$ is naturally equipped with a scalar product inherited by $\langle\cdot, \cdot\rangle_{R}$, where $f \sim g$ if $f=g|R|(d s, \infty)$ a.e. and

$$
f\left(s_{1}\right)-f\left(s_{2}\right)-\left(g\left(s_{1}\right)-g\left(s_{2}\right)\right)=0|\mu| \text { a.e. . }
$$

In particular

$$
f\left(s_{1}\right)-f\left(s_{2}\right)-\left(g\left(s_{1}\right)-g\left(s_{2}\right)\right)=0|\bar{\mu}| \text { a.e. . }
$$

However it may not be complete.
vi) The linear space of $\frac{1}{2}$-Hölder continuous functions with compact support $S$ included in $\tilde{L}_{R}$. Indeed, if $f$ belongs to such space then

\int_{0}^{\infty} f^{2}(s)|R|(d s, \infty) \leq\|f\|_{\infty}^{2} \int_{0}^{\infty}|R|(d s, \infty)
$$

Moreover, expression ii) in Definition 6.1 is bounded by

k^{2} \int_{S}\left|s_{1}-s_{2}\right| d|\mu|\left(s_{1}, s_{2}\right)=k^{2}|\bar{\mu}|(S \times S)
$$

where $k$ is a Hölder constant for $f$.
We denote by $L_{R}$ the closure of $C_{0}^{1}$ onto $\tilde{L}_{R}$ with respect to $\|\cdot\|_{R}$.
Remark 6.4. $L_{R}$ is a normed linear space (as $\tilde{L}_{R}$ ) which is not necessarily complete.
We repeat that we will not consider the (abstract) completion of $C_{0}^{1}\left(\mathbb{R}_{+}\right)$with respect to norm $\|\cdot\|_{\mathcal{H}}$ excepted if it is identifiable with a concrete space of functions.

Next proposition shows that in many situations $L_{R}$ is a rich subspace of $\tilde{L}_{R}$.
Proposition 6.5. Suppose the existence of an even function $\phi: \mathbb{R} \longrightarrow \mathbb{R}_{+}$, such that $d|\mu|$ is equivalent to $\phi\left(x_{1}-x_{2}\right) d x_{1} d x_{2}$. Let $f: \mathbb{R}_{+} \longrightarrow \mathbb{R}$ be a bounded Borel function with compact support with at most countable jumps. Then $f \in \tilde{L}_{R} \Rightarrow f \in L_{R}$.

Proof (of Proposition 6.5): Let $\rho: \mathbb{R}_{+} \longrightarrow \mathbb{R}_{+}$smooth with $\int_{0}^{\infty} \rho(y) d y=1$. We set $\rho_{\varepsilon}=\frac{1}{\varepsilon} \rho\left(\frac{1}{\varepsilon}\right)$, for $\varepsilon>0$. We show that $f$ is a limit with respect to $\|\cdot\|_{R}$ of a sequence of smooth bounded functions with compact support (which belong to $L_{R}$ ). We consider the sequence $f_{n}: \mathbb{R}_{+} \longrightarrow \mathbb{R}$ defined by

$$
f_{n}(x)=\int_{0}^{\infty} f(x-y) \rho_{\frac{1}{n}}(y) d y=\int_{0}^{\infty} f\left(x-\frac{y}{n}\right) \rho(y) d y
$$

Clearly $\left\|f_{n}\right\|_{\infty} \leq\|f\|_{\infty}, f_{n}(x) \longrightarrow f(x)$, for every continuity point $x$ of $f$. Therefore

$$
\int_{0}^{\infty}\left|f_{n}(s)-f(s)\right||R|(d s, \infty) \xrightarrow[n \rightarrow \infty]{ } 0
$$

since $|R|(d s, \infty)$ is a non-atomic finite measure. It remains to prove

$$
\begin{equation*}
\int_{\mathbb{R}_{+}^{2}}\left(f_{n}\left(x_{1}\right)-f\left(x_{1}\right)-f_{n}\left(x_{2}\right)+f\left(x_{2}\right)\right)^{2} d|\mu|\left(x_{1}, x_{2}\right) \underset{n \rightarrow \infty}{ } 0 \tag{6.5}
\end{equation*}
$$

The left-hand side of (6.5) equals

$$
\begin{aligned}
& \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(x_{1}, x_{2}\right)\left[\int_{\mathbb{R}_{+}} d y \rho(y) f\left(x_{1}-\frac{y}{n}\right)-f\left(x_{1}\right)-f\left(x_{2}-\frac{y}{n}\right)+f\left(x_{2}\right)\right]^{2} \\
& \quad \leq \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(x_{1}, x_{2}\right) \int_{\mathbb{R}_{+}} d y \rho(y)\left[f\left(x_{1}-\frac{y}{n}\right)-f\left(x_{1}\right)-f\left(x_{2}-\frac{y}{n}\right)+f\left(x_{2}\right)\right]^{2}
\end{aligned}
$$

Last inequality comes from Jensen's. By Fubini's the right-hand side of previous expression equals

$$
\begin{align*}
\int_{0}^{\infty} & d y \rho(y) \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(x_{1}, x_{2}\right)\left[f\left(x_{1}-\frac{y}{n}\right)-f\left(x_{1}\right)-f\left(x_{2}-\frac{y}{n}\right)+f\left(x_{2}\right)\right]^{2} \\
& =\int_{0}^{\infty} d y \rho(y) I_{n}(y) \tag{6.6}
\end{align*}
$$

where

$$
I_{n}(y)=\int_{\mathbb{R}_{+}^{2}} d|\mu|\left(x_{1}, x_{2}\right)\left[f\left(x_{1}-\frac{y}{n}\right)-f\left(x_{1}\right)-f\left(x_{2}-\frac{y}{n}\right)+f\left(x_{2}\right)\right]^{2}
$$

$I_{n}(y)$ is bounded by

$$
\begin{gather*}
2\left[\int_{\mathbb{R}_{+}^{2}} d x_{1} d x_{2} \phi\left(x_{1}-x_{2}\right)\left(f\left(x_{1}-\frac{y}{n}\right)-f\left(x_{2}-\frac{y}{n}\right)\right)^{2}\right.  \tag{6.7}\\
\left.\quad+\int_{\mathbb{R}_{+}^{2}} d x_{1} d x_{2} \phi\left(x_{1}-x_{2}\right)\left(f\left(x_{1}\right)-f\left(x_{2}\right)\right)^{2}\right]
\end{gather*}
$$

Setting $\tilde{x}_{i}=x_{i}-\frac{y}{n}, i=1,2$, in the first integral, (6.7) is upper bounded by

$$
2 \int_{\mathbb{R}_{+}^{2}} \phi\left(x_{1}-x_{2}\right)\left(f\left(x_{1}\right)-f\left(x_{2}\right)\right)^{2} d x_{1} d x_{2}=2 \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(x_{1}, x_{2}\right)\left(f\left(x_{1}\right)-f\left(x_{2}\right)\right)^{2}
$$

On the other hand $I_{n}$ converges pointwise to zero. Lebesgue's dominated convergence theorem applied to (6.6) allows to conclude (6.5).

Remark 6.6. 1) We recall that for instance a cadlag function with compact support is a bounded function with at most countable jumps.
2) The assumption related to $\mu$ in the statement of Proposition 6.5 is for instance verified if $X$ is a fractional (or bifractional) Brownian motion.
3) If $|R|(d s, \infty)$ is absolutely continuous with respect to Lebesgue, it is easy to show that the statement of Proposition 6.5 holds for every bounded Borel function with compact support $f: \mathbb{R}_{+} \longrightarrow \mathbb{R}$. In particular no jump condition is required.

An easy consequence of the definition of the $L_{R}$-norm is the following.
Proposition 6.7. Let $g: \mathbb{R} \longrightarrow \mathbb{R}$ be a Lipschitz function, $f \in L_{R}$. Then $g \circ f \in L_{R}$.
Proof: $\nu(d s)=|R|(d s, \infty)$. Calling $k$ the Lipschitz constant, since $|g|(s) \leq k(1+|s|)$ it follows

\int_{0}^{\infty} & g^{2}(f(s)) \nu(d s)+\frac{1}{2} \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(s_{1}, s_{2}\right)\left(g\left(f\left(s_{1}\right)\right)-g\left(f\left(s_{2}\right)\right)\right)^{2} \\
\leq & k^{2} \nu\left(\mathbb{R}_{+}\right)+k^{2} \int_{0}^{\infty} f^{2}(s) \nu(d s)+\frac{k^{2}}{2} \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(s_{1}, s_{2}\right)\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)^{2} \\
= & k^{2} \nu\left(\mathbb{R}_{+}\right)+k^{2}\|f\|_{R}^{2}
\end{aligned}
$$

This shows that $g \circ f \in \tilde{L}_{R} . g \circ f$ is indeed in $L_{R}$ since, if $f_{n} \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$converges to $f \in L_{R}$, then performing similar calculations as before, we have

\left\|g \circ f_{n}-g \circ f\right\|_{R}^{2} \longrightarrow 0
$$

By analogous arguments, we obtain the following result.
Proposition 6.8. Let $f, g \in L_{R}$ and bounded. Then $f g \in L_{R}$.

Proposition 6.9. Let $V: \mathbb{R} \longrightarrow \mathbb{R}_{+}$increasing on $\mathbb{R}_{+}$such that

$$
\begin{equation*}
\int_{\mathbb{R}_{+}^{2}} V^{2}\left(x_{1}-x_{2}\right) d|\mu|\left(x_{1}, x_{2}\right)<\infty \tag{6.8}
\end{equation*}
$$

Then every Borel function $f: \mathbb{R} \longrightarrow \mathbb{R}_{+}$with compact support such that

$$
\begin{equation*}
\left|f\left(x_{1}\right)-f\left(x_{2}\right)\right| \leq V\left(x_{1}-x_{2}\right) \tag{6.9}
\end{equation*}
$$

belongs to $L_{R}$.
Corollary 6.10. Every bounded $\frac{1}{2}$-Hölder continuous function $f$ with compact support belongs to $L_{R}$.

Proof of Corollary 6.10: We apply Proposition 6.9 with $V(x)=|x|^{\frac{1}{2}}$.
Remark 6.11. i) If $V$ is continuous, condition (6.9) is equivalent to saying that $V$ is the continuity modulus of $f$.
ii) If $V$ is continuous, then $f$ fulfilling (6.9) is continuous.

Proof (of Proposition 6.9): It follows the same scheme as the proof of Proposition 6.5. Let $f_{n}$ be as in that proof.
i) $f_{n} \longrightarrow f$ pointwise and $\left|f_{n}\right| \leq\|f\|_{\infty}$,
ii) $\int_{0}^{\infty}\left|f_{n}-f\right|(s)|R|(d s, \infty) \longrightarrow 0$ because of Lebesgue's dominated convergence theorem.
iii) (6.5) is again a consequence of Lebesgue's; (6.6) still holds with

$$
\left|I_{n}(y)\right| \leq 2 \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(x_{1}, x_{2}\right) V^{2}\left(x_{1}-x_{2}\right)
$$

Remark 6.12. If $X$ has a covariance measure with compact support, then every bounded function with compact support belongs to $L_{R}$. This follows by Proposition 6.9 taking $V(x) \equiv$ $2 \sup |f|$. However the property of compact support will be raised in Proposition 6.13.

Proposition 6.13. If $X$ has a covariance measure with compact support, any bounded function still belongs to $L_{R}$.

Proposition 6.14. $\tilde{L}_{R}$ is a Hilbert space if Assumption (C) is fulfilled.

Remark 6.15. Suppose that $X$ has a covariance measure with compact support, with corresponding signed measure $\mu$. We link below the present approach with the one in [25].

1) One alternative approach would be to consider the measure $\nu$ which was introduced in [25], Section 5, i.e. the marginal measure of $|\mu|$. The space $L^{2}(d \nu):=L^{2}\left(\mathbb{R}_{+}, d \nu\right)$ was a natural space, where the Wiener integral could be defined.
2) In this paper $\|\cdot\|_{R}$ is the norm which allows to prolongate the Wiener integral operator
I. Point 1) suggests that $\|\cdot\|_{R}$ should be somehow related to $\|\cdot\|_{L^{2}(\nu)}$. By Cauchy-Schwarz, we have

$$
\int_{\mathbb{R}_{+}^{2}}\left|f\left(s_{1}\right) f\left(s_{2}\right)\right| d|\mu|\left(s_{1}, s_{2}\right) \leq \int_{0}^{\infty} f^{2}(s) d \nu(s) .
$$

This shows that the seminorm of $L^{2}(d \nu)$ is equivalent to $\|f\|_{R, \nu}$ where

$$
\|f\|_{R, \nu}^{2}=\int_{0}^{\infty} f^{2}(s) \nu(d s)+\frac{1}{2} \int_{\mathbb{R}_{+}^{2}}\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)^{2} d|\mu|\left(s_{1}, s_{2}\right) .
$$

This looks similarly to $\|\cdot\|_{R}$ norm but they could be different. Indeed, we only have

$$
\|f\|_{L^{2}(d \nu)} \sim\|f\|_{R, \nu} \geq\|f\|_{R}
$$

which implies that

$$
\begin{equation*}
L^{2}(d \nu) \subset L_{R} . \tag{6.10}
\end{equation*}
$$

This implies that $\|\cdot\|_{R}$ will provide a larger space, where the Wiener integral is defined.
3) In particular, if $\mu$ is non-negative (as for the case $X$ being a fractional Brownian motion with Hurst index $H \geq \frac{1}{2}$ stopped at some time $T$ ), we have

$$
\|\cdot\|_{R}=\|\cdot\|_{R, \nu} \sim\|\cdot\|_{L^{2}(d \nu)} .
$$

Consequently by item 2) it follows that $L_{R}=L^{2}(d \nu)$.
4) If $\mu$ is non-negative, then $L_{R}=\tilde{L}_{R}$ since $C_{0}^{1}(\mathbb{R})$ is dense in $L^{2}(d \nu)$, see Lemma 3.8 of [2I].

Proof (of Proposition 6.13): This follows by Remark 6.15, point 2). Indeed, any bounded function belongs to $L^{2}(d \nu)$ because $\nu$ is finite.
Proof (of Proposition 6.14): It is enough to show that $\tilde{L}_{R}$ is complete. We set $\chi(d s)=$ $|R|(d s, \infty)$. Let $\left(f_{n}\right)$ be a Cauchy sequence in $\tilde{L}_{R}$. We recall that

$$
\left\|f_{n}-f_{m}\right\|_{R}^{2}=\int_{0}^{\infty}\left(f_{n}-f_{m}\right)^{2}(s) \chi(d s)+\frac{1}{2} \int_{\mathbb{R}_{+}^{2}}|\mu|\left(d s_{s}, d s_{2}\right)\left(g_{n}-g_{m}\right)^{2}\left(s_{1}, s_{2}\right),
$$

where $g_{n}\left(s_{1}, s_{2}\right)=f_{n}\left(s_{1}\right)-f_{n}\left(s_{2}\right)$. Since both integrals are non-negative, the Cauchy sequence $\left(f_{n}\right)$ is Cauchy in $L^{2}(d \chi)$ and $\left(g_{n}\right)$ is Cauchy in $L^{2}(d|\mu|)$. Since $L^{2}(d \chi)$ is complete, there is $f \in L^{2}(d \chi)$ being the limit of $f_{n}$ when $n \longrightarrow \infty$. On the other hand, since $L^{2}\left(\mathbb{R}_{+}^{2},|\mu|\right)$ is complete, $g_{n}$ converges to some $g \in L^{2}\left(\mathbb{R}_{+}^{2} ; d|\mu|\right)$.

It remains to show that

$$
g\left(s_{1}, s_{2}\right)=f\left(s_{1}\right)-f\left(s_{2}\right) \mu \text { a.e., } \quad s_{1}, s_{2}>0 .
$$

Since $f_{n} \longrightarrow f$ in $L^{2}(d \chi)$, there is a subsequence $\left(n_{k}\right)$ such that $f_{n_{k}}(s) \longrightarrow f(s)$, for $s \notin N$, where $\chi(N)=0$. Consequently for $\left(s_{1}, s_{2}\right) \in N^{c} \times N^{c}$

$$
\begin{equation*}
f_{n}\left(s_{1}\right)-f_{n}\left(s_{2}\right) \longrightarrow f\left(s_{1}\right)-f\left(s_{2}\right) . \tag{6.11}
\end{equation*}
$$

Moreover, obviously if $s_{1}=s_{2}$, (6.11) holds. Hence for $\left(s_{1}, s_{2}\right) \in\left(N^{c} \times N^{c}\right) \cup D$,

$$
g\left(s_{1}, s_{2}\right)=f\left(s_{1}\right)-f\left(s_{2}\right),
$$

where we recall that $D=\left\{(s, s) \mid s \in \mathbb{R}_{+}\right\}$is the diagonal. This concludes the proof if we show that $\left(\left(N^{c} \times N^{c}\right) \cup D\right)^{c}$ is $|\mu|$-null.

This set equals

$$
\left(N^{c} \times N^{c}\right)^{c} \cap D^{c}
$$

and it is included in $\left(\left(N \times \mathbb{R}_{+}\right) \cap D^{c}\right) \cup\left(\left(\mathbb{R}_{+} \times N\right) \cap D^{c}\right)$. Since $|\mu|$ and $|\bar{\mu}|$ are equivalent outside $D^{c}$, it is enough to show that

$$
|\bar{\mu}|\left(\left(N \times \mathbb{R}_{+}\right) \cap D^{c}\right)=0 \text { and }|\bar{\mu}|\left(\left(\mathbb{R}_{+} \times N\right) \cap D^{c}\right)=0 .
$$

Previous quantities are bounded by

$$
|\bar{\mu}|\left(N \times \mathbb{R}_{+}\right), \text {and }|\bar{\mu}|\left(\mathbb{R}_{+} \times N\right),
$$

which coincide with the marginal measures of $|\bar{\mu}|$ evaluated on $N$. Assumption (C) allows to conclude.

Corollary 6.16. If Assumptions $(C),(D)$ are in force, then $L_{R}$ is the closure of $C_{0}^{1}\left(\mathbb{R}_{+}\right)$ under $\|\cdot\|_{\mathcal{H}}$; in particular $L_{R}$ is a "self-reproducing kernel space".

Proof: According to Assumption (D), we have $\|\cdot\|_{R}=\|\cdot\|_{\mathcal{H}}$ for $\psi \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$. According to Proposition 6.14 $L_{R}$ is a Hilbert space equipped with $\|\cdot\|_{\mathcal{H}}$, which is by definition the closure of $C_{0}^{1}\left(\mathbb{R}_{+}\right)$.

Remark 6.17. 1) We will see that the Paley-Wiener integral can be naturally defined on space $L_{R}$.
2) Corollary 6.16 is interesting because it shows that a natural space where the Wiener integral will be defined is complete under Assumptions ( $A$ ), (B), (C), (D).
3) This result is of the same nature as the one of [36], which shows that the space, where its Wiener integral is defined, is also complete with respect to the norm $\|\cdot\|_{\mathcal{H}}$ when $X$ is a fractional Brownian motion, with parameter $H \leq \frac{1}{2}$. In Section 4.5 we have proved that Assumptions (A), (B), (C), (D) are indeed fulfilled in that case.

Proposition 6.18. We suppose that Assumption ( $D$ ) is fulfilled. Then any bounded variation function with compact support belongs to $L_{R}$ and

$$
\begin{equation*}
\|\varphi\|_{R}^{2}=E\left(-\int_{0}^{\infty} X d \varphi\right)^{2} \tag{6.12}
\end{equation*}
$$

That property does not seem easy to prove in the general case.
Corollary 6.19. We suppose Assumption (D) to be fulfilled. Then every step function belongs to $L_{R}$. In particular, if $t>0,1_{[0, t]} \in L_{R}$
and

$$
\left\|1_{[0, t]}\right\|_{R}^{2}=E\left(X_{t}^{2}\right) .
$$

Corollary 6.20. Under Assumption $(D)$, if $f: \mathbb{R}_{+} \longrightarrow \mathbb{R}$ is a bounded variation function with compact support, then

$$
\int_{\mathbb{R}_{+}^{2}}\left(f\left(t_{1}\right)-f\left(t_{2}\right)\right)^{2} d|\mu|\left(t_{1}, t_{2}\right)<\infty
$$

Proof (of Corollary 6.20): This follows from Proposition 6.18 and the fact that $L_{R} \subset \tilde{L}_{R}$.

Proof: (of Proposition 6.18): Let $\varphi$ be a bounded variation function with compact support, defined on $\mathbb{R}_{+}$. Let $\left(\rho_{n}\right)$ be a sequence of mollifiers converging to the Dirac delta function. We set

$$
\varphi_{n}=\rho_{n} * \varphi .
$$

Since $\varphi_{n}$ is smooth with compact support, it belongs to $L_{R}$. Now $d \varphi_{n} \longrightarrow d \varphi$ and

$$
d \varphi_{n} \otimes d \varphi_{m} \xrightarrow[n, m \rightarrow \infty]{ } d \varphi \otimes d \varphi \text { weakly. }
$$

Since $R$ is continuous it follows that

$$
\begin{equation*}
\int_{\mathbb{R}_{+}^{2}} R\left(s_{1}, s_{2}\right) d \varphi_{n}\left(s_{1}\right) d \varphi_{m}\left(s_{2}\right) \longrightarrow \int_{\mathbb{R}_{+}^{2}} R\left(s_{1}, s_{2}\right) d \varphi\left(s_{1}\right) d \varphi\left(s_{2}\right) \tag{6.13}
\end{equation*}
$$

By Remark 6.2, we have

$$
\begin{align*}
\left\|\varphi_{n}\right\|_{R}^{2} & =E\left(-\int_{0}^{\infty} X d \varphi_{n}\right)^{2} \\
& =\int_{\mathbb{R}_{+}^{2}} R\left(s_{1}, s_{2}\right) d \varphi_{n}\left(s_{1}\right) d \varphi_{n}\left(s_{2}\right) \tag{6.14}
\end{align*}
$$

Using (6.13), the limit of the right-hand side of (6.14) gives

$$
E\left(-\int_{0}^{\infty} X d \varphi\right)^{2}
$$

Again using (6.13), it follows that

$$
\lim _{n, m \rightarrow \infty}\left\|\varphi_{n}-\varphi_{m}\right\|_{R}^{2}=0
$$

so $\left(\varphi_{n}\right)$ is Cauchy in $L_{R}$. Since $L_{R}$ is complete, there is $\psi \in L_{R}$ such that

$$
\left\|\varphi_{n}-\psi\right\|_{R} \underset{n \rightarrow \infty}{ } 0
$$

On the other hand $\varphi_{n} \longrightarrow \varphi R(d s, \infty)$ a.e. since $R(d s, \infty)$ is a non-atomic measure. By Lebesgue's dominated convergence theorem,

$$
\lim _{n \rightarrow \infty}\left\|\varphi_{n}-\varphi\right\|_{R(d s, \infty)}=0
$$

But we also have

$$
\left\|\varphi_{n}-\psi\right\|_{R(d s, \infty)} \leq\left\|\varphi_{n}-\psi\right\|_{R} \underset{n \rightarrow \infty}{ } 0
$$

By uniqueness of the limit, $\varphi=\psi R(d s, \infty)$ a.e. and so $\psi=\varphi d \nu$ a.e. this shows that $\varphi \in L_{R}$. The limit of the left-hand side in (6.14) gives $\|\varphi\|_{R}^{2}$, which finally shows (6.12).

A natural question concerns whether the constant function 1 belongs to $L_{R}$. The answer is of course well-known if $X$ has a covariance measure structure with compact support because of Proposition 6.13. Again it will be also the case if Assumptions (A), (B), (C) and (D) are fulfilled.

Proposition 6.21. If Assumptions (C) and (D) are fulfilled, then $1 \in L_{R}$ and $\|1\|_{\mathcal{H}}^{2}=$ $\|1\|_{R}^{2}=R(\infty, \infty)=E\left(X_{\infty}^{2}\right)$.

Proof: For $n \in \mathbb{N}^{*}$, we consider a smooth, decreasing function $\chi_{[0, n]}: \mathbb{R}_{+} \rightarrow[0,1]$ which equals 1 on $[0, n]$ and zero on $\left[n+1, \infty\left[\right.\right.$ and it is bounded by 1 . Clearly $\chi_{[0, n]} \in L_{R}$ for any $n$ and

$$
\begin{aligned}
\left\|\chi_{[0, n]}-\chi_{[0, m]}\right\|_{\mathcal{H}}^{2} & =E\left(\int_{0}^{\infty}\left(\chi_{[0, n]}-\chi_{[0, m]}\right) d X\right)^{2} \\
& =E\left(-\int_{0}^{\infty} X d\left(\chi_{[0, n]}-\chi_{[0, m]}\right)\right)^{2}=I(n, n)+I(m, m)-2 I(n, m)
\end{aligned}
$$

where

$$
\begin{aligned}
I(n, m) & =\int_{\mathbb{R}_{+}^{2}} R\left(s_{1}, s_{2}\right) d \chi_{[0, n]}\left(s_{1}\right) d \chi_{[0, m]}\left(s_{2}\right), \\
& =\int_{[n, n+1] \times[m, m+1]} R\left(s_{1}, s_{2}\right) d\left(1-\chi_{[0, n]}\right)\left(s_{1}\right) d\left(1-\chi_{[0, m]}\right)\left(s_{2}\right) .
\end{aligned}
$$

We have

$$
\inf _{\xi \in[n, n+1] \times[m, m+1]} R(\xi) \leq I(n, m) \leq \sup _{\xi \in[n, n+1] \times[m, m+1]} R(\xi) .
$$

Since $\lim _{s_{1}, s_{2} \rightarrow \infty} R\left(s_{1}, s_{2}\right)=R(\infty, \infty)$, if follows that

$$
I(n, m) \xrightarrow[n, m \rightarrow \infty]{ } R(\infty, \infty)
$$

and $\chi_{[0, n]}$ is a Cauchy sequence in $\|\cdot\|_{\mathcal{H}}$. On the other hand $\chi_{[0, n]} \longrightarrow 1$ pointwise when $n \longrightarrow \infty$ and in particular a.e. with respect to the measure $|R|(d t, \infty)$.
An important question concerns the separability of the Hilbert space $L_{R}$.
Proposition 6.22. Suppose the validity of Assumptions (C) and (D). Then the Hilbert space $L_{R}$ is separable. Moreover there is an orthonormal basis $\left(e_{n}\right)$ in $C_{0}^{1}$ of $L_{R}$.

Proof: We denote by $\mathcal{S}$ the closed linear span $\left\{1_{[0, t]}, t \geq 0\right\}$ into $\tilde{L}_{R}$. We first prove

$$
\begin{equation*}
\mathcal{S}=L_{R} \tag{6.15}
\end{equation*}
$$

a) $1_{[0, t]}, \forall t \geq 0$ belongs to $L_{R}$ because of Corollary 6.19, so it follows that $\mathcal{S} \subset L_{R}$.
b) We prove the converse inclusion. It is enough to show that $C_{0}^{1}\left(\mathbb{R}_{+}\right) \subset \mathcal{S}$. Let $\varphi \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$ and consider a sequence of step functions of the type

$$
\varphi_{n}(t)=\sum_{l} 1_{\left[t_{l}, t_{l+1}[ \right.}(t) \varphi\left(t_{l}\right),
$$

which converges pointwise to $\varphi$. Since the total variation of $\varphi_{n}$ is bounded by the total variation of $\varphi$, then $\varphi_{n} \longrightarrow \varphi$ weakly. Let $\left(Y_{t}\right)$ be a Gaussian process with the same covariance as $X$. A consequence of previous observations shows that

$$
\begin{equation*}
\int_{0}^{\infty} \varphi_{n} d Y:=-\int_{0}^{\infty} Y d \varphi_{n} \underset{n \rightarrow \infty}{\longrightarrow}-\int_{0}^{\infty} Y d \varphi \text { a.s. } \tag{6.16}
\end{equation*}
$$

Since $Y$ is a Gaussian process, the sequence in the left-hand side of (6.16) is Cauchy in $L^{2}(\Omega)$, so $\left(\varphi_{n}\right)$ is Cauchy in $L_{R}$ by Proposition 6.18; the result follows because $\varphi_{n} \in \mathcal{S}$ for every $n$. This concludes b) and (6.15).

Since $\|\cdot\|_{R}=\|\cdot\|_{\mathcal{H}}$, taking into account the consideration preceding Remark 6.3 and (6.15), $H_{X}$ is the closure in $L^{2}(\Omega)$ of $-\int_{0}^{\infty} X d \varphi, \varphi$ of the type $1_{[0, t]}, t \geq 0$. Since $X$ is continuous, $H_{X}$ (and therefore $L_{R}$ ) is separable. The existence of an orthonormal basis in $C_{0}^{1}\left(\mathbb{R}_{+}\right)$follows by Gram-Schmidt orthogonalization procedure.

### 6.2 Path properties of some processes with stationary increments

In this subsection we are interested in expressing necessary and sufficient conditions under which the paths of Gaussian continuous processes with stationary increments restricted to any compact intervals, belong to $L_{R}$. We have some relatively complete elements of answer.

We reconsider the example treated in Section 4.4. Let $\tilde{X}$ be a process with weak, stationary increments, continuous in $L^{2}$ such that $\tilde{X}_{0}=0$. We denote by $Q(t)=\operatorname{Var}\left(\tilde{X}_{t}\right)$, and we consider again $X$ defined by $X_{t}=\tilde{X}_{t \wedge T}$. We recall that without restrictions to generality, we can suppose $Q(t)=Q(T), t \geq T$.

We recall that in Proposition 4.6 we provided conditions so that Assumptions (A) and (B) are verified, i.e.

Hypothesis 6.23. i) $Q$ is absolutely continuous with derivative $Q^{\prime}$,
ii) $F_{Q}(s):=s Q^{\prime}(s), s>0$ prolongates to zero by continuity to a bounded variation function.

In Corollary 4.8 we provided conditions so that Assumption (D) is verified. This gave the following

Hypothesis 6.24. i) $Q$ is non-decreasing,
ii) $Q^{\prime \prime}$ non-positive $\sigma$-finite measure.

Proposition 6.25. We suppose the validity of Hypothesis 6.23. If

$$
\begin{equation*}
\int_{0+} Q(y)\left|Q^{\prime \prime}\right|(d y)<\infty, \tag{6.17}
\end{equation*}
$$

then almost all paths of $X$ belong to $\tilde{L}_{R}$.

Proof: We recall that Hypothesis 6.23 implies that $Q^{\prime \prime}$ is a finite Radon measure on $] \delta, \infty[$ for every $\delta>0$. Hence (6.17) implies that

$$
\begin{equation*}
\int_{0}^{\infty} Q(y)\left|Q^{\prime \prime}\right|(d y)<\infty \tag{6.18}
\end{equation*}
$$

Since $\int_{0}^{\infty}|R|(d s, \infty) X_{s}^{2}<\infty$ a.s. being $|R|(d s, \infty)$ a finite measure, it remains to prove that

$$
\begin{equation*}
\int_{[0, T]^{2}}\left(X_{s_{1}}-X_{s_{2}}\right)^{2}\left|Q^{\prime \prime}\right|\left(d s_{2}-s_{1}\right) d s_{1}<\infty . \tag{6.19}
\end{equation*}
$$

To prove (6.19), it is enough to evaluate the expectation of its left-hand side. We get

$$
\int_{[0, T]^{2}}\left|Q^{\prime \prime}\right|\left(d s_{2}-s_{1}\right) d s_{1} Q\left(s_{1}-s_{2}\right)=2 \int_{0}^{T} d s_{1} \int_{0}^{s_{1}} Q\left(s_{2}\right)\left|Q^{\prime \prime}\right|\left(d s_{2}\right)
$$

This concludes the proof.

Remark 6.26. If $X$ has a covariance measure structure, then Assumption (6.17) is trivially verified.

Remark 6.27. 1) Assumption (6.17) implies (6.18) which ensures (6.43) in Proposition 6.48. Suppose (6.18), if Assumptions (C), (D) are fulfilled, then Proposition 6.48 says that a.s. $X \in L_{R}$.
2) In the sequel we will express necessary conditions.

Proposition 6.28. We suppose $X$ Gaussian and continuous. We suppose again the validity of Hypotheses 6.23, 6.24 and the following technical conditions. There are $c_{1}, c_{2}>0, \alpha_{1}<1$, $\alpha_{2}>0$ such that

$$
\begin{align*}
& c_{1} t^{\alpha_{1}} \leq Q(t) \leq c_{2} t^{\alpha_{2}}  \tag{6.20}\\
& -\int_{0+} Q(y) Q^{\prime \prime}(d y)=\infty \tag{6.21}
\end{align*}
$$

then $X \notin \tilde{L}_{R}$ a.s.

Corollary 6.29. Let $\tilde{X}$ be a continuous mean-zero Gaussian process with stationary increments such that $\tilde{X}_{0}=0$ a.s. $Q(t)=\operatorname{Var} \tilde{X}_{t}$. Set $X_{t}=\tilde{X}_{t \wedge T}, t \geq 0$. We suppose Hypotheses 6.23 and 6.24 together with 6.20).

Then $X \in L_{R}$ a.s. if and only if

$$
\int_{0+} Q(y)\left|Q^{\prime \prime}\right|(d y)<\infty
$$

Proof: It follows from Remark 6.2才 and Proposition 6.28, and the fact that $L_{R} \subset \tilde{L}_{R}$.
Remark 6.30. 1) The importance of Corollary 6.29 is related to the problem of finding sufficient and necessary conditions on the paths of a continuous Gaussian process $X$ to belong to its "self-reproducing kernel space".

When it is the case, $X$ belongs to the natural domain of the divergence operator in Malliavin calculus (Skorohod integral); in the other cases $X$ will be shown to belong the extended domain Dom ${ }^{*}$, see Definition 10.3 introduced in the spirit of [8, 39].
2) We conjecture that assumption (6.20) and Hypothesis 6.24 can be omitted, but this would have considerably complicated the proof.

Proof (of Proposition 6.28): Since $X$ is continuous, therefore locally bounded, we observe that

$$
\int_{0}^{T} X_{s}^{2}|R|(d s, \infty)<\infty \text { a.s. }
$$

To prove that $X \notin \tilde{L}_{R}$ a.s., it will be enough to prove that

$$
\begin{equation*}
\int_{\mathbb{R}_{+}^{2}}\left(X_{s_{1}}-X_{s_{2}}\right)^{2}\left|Q^{\prime \prime}\right|\left(d s_{2}-s_{1}\right)=\infty \text { a.s. } \tag{6.22}
\end{equation*}
$$

The left-hand side of ( 6.22 ) gives

$$
\begin{align*}
& 2 \int_{0}^{T} d s_{1} \int_{0}^{s_{1}}\left(X_{s_{1}}-X_{s_{2}}\right)^{2}\left(-Q^{\prime \prime}\right)\left(d s_{2}-s_{1}\right)=2 \int_{0}^{T} d s_{1} \int_{0}^{s_{1}}\left(X_{s_{1}}-X_{s_{1}-s_{2}}\right)^{2}\left(-Q^{\prime \prime}\right)\left(d s_{2}\right) \\
& =2 \int_{0}^{T}\left(-Q^{\prime \prime}\right)\left(d s_{2}\right) Q\left(s_{2}\right) \Phi\left(s_{2}\right) \tag{6.23}
\end{align*}
$$

where

$$
\Phi\left(s_{2}\right)=\int_{s_{2}}^{T} d s_{1} \frac{\left(X_{s_{1}}-X_{s_{1}-s_{2}}\right)^{2}}{Q\left(s_{2}\right)}
$$

In Lemma 6.31 below we will show that

$$
\Phi\left(s_{2}\right) \xrightarrow[s_{2} \rightarrow 0+]{\longrightarrow} T \text { a.s. }
$$

so a.s. $s_{2} \longmapsto \Phi\left(s_{2}\right)$ can be extended by continuity to $[0, T]$. If (6.21) holds, then (6.23) is also infinite and so (6.22) is established. It remains to establish the following lemma.

Lemma 6.31. Under the hypotheses of Proposition 6.28, we have

\begin{equation*}
Z_{\varepsilon}:=\frac{1}{Q(\varepsilon)} \int_{\varepsilon}^{T} d s\left(X_{s}-X_{s-\varepsilon}\right)^{2} \underset{\varepsilon \rightarrow 0}{\longrightarrow} T \text { a.s. } \tag{6.24}
\end{equation*}
$$

Proof: 1) We have $E\left(Z_{\varepsilon}\right)=T-\varepsilon$ and this obviously converges to $T$ when $\varepsilon \rightarrow 0$. In order to prove that the convergence in (6.24) holds in $L^{2}(\Omega)$, it would be enough to show that

\operatorname{Var}\left(Z_{\varepsilon}\right) \underset{\varepsilon \rightarrow 0}{\longrightarrow} 0

2) In order to prove the a.s. convergence we will implement the program of 14], see in particular Lemma 3.1. This will only be possible because of technical assumption (6.20). We will show that

\operatorname{Var}\left(Z_{\varepsilon}\right)=O\left(\frac{\varepsilon}{Q(\varepsilon)}\right) \tag{6.25}
\end{equation*}
$$

Consequently

\operatorname{Var}\left(Z_{\varepsilon}\right)=O\left(t^{\alpha}\right)
$$

$\alpha=1-\alpha_{1}$ and (3.1) in 14] is verified. The upper bound of (6.20) allows to show that $X$ is Hölder continuous, by use of Kolmogorov lemma.
3) We prove finally (6.25). We remark that $Q(\varepsilon) \neq 0$ for $\varepsilon$ in a neighbourhood of zero, otherwise (6.22) cannot be true. We have

\operatorname{Var}\left(Z_{\varepsilon}\right)=\frac{1}{Q(\varepsilon)^{2}} \int_{\varepsilon}^{T} d s_{1} \int_{\varepsilon}^{T} d s_{2} \operatorname{Cov}\left(\left(X_{s_{1}}-X_{s_{1}-\varepsilon}\right)^{2},\left(X_{s_{2}}-X_{s_{2}-\varepsilon}\right)^{2}\right)
$$

It is well-known that given two mean-zero Gaussian random variables $\xi$ and $\eta$

\operatorname{Cov}\left(\xi^{2}, \eta^{2}\right)=3 \operatorname{Cov}(\xi, \eta)^{2}
$$

This, together with the stationary increments property, implies that

\operatorname{Var}\left(Z_{\varepsilon}\right)=\frac{6}{Q^{2}(\varepsilon)} \int_{\varepsilon}^{T} d s_{1} \int_{0}^{s_{1}-\varepsilon} d s_{2}\left[\operatorname{Cov}\left(X_{s_{2}+\varepsilon}-X_{s_{2}}, X_{\varepsilon}\right)\right]^{2}
$$

Since, by Cauchy-Schwarz

$$
\operatorname{Cov}\left(X_{s_{2}+\varepsilon}-X_{s_{2}}, X_{\varepsilon}\right) \leq Q(\varepsilon)
$$

then

$$
\operatorname{Var}\left(Z_{\varepsilon}\right)=\frac{3}{Q^{2}(\varepsilon)} I(\varepsilon)+O(\varepsilon)
$$

where

$$
I(\varepsilon)=\int_{0}^{T} d s_{1} \int_{\varepsilon}^{s_{1}} d s_{2}\left(-\operatorname{Cov}\left(X_{s_{2}+\varepsilon}-X_{s_{2}}, X_{\varepsilon}\right)\right)^{2}
$$

Since Hypothesis 6.24 holds, Assumption (D) is verified and

$$
-\operatorname{Cov}\left(X_{s_{2}+\varepsilon}-X_{s_{2}}, X_{\varepsilon}\right) \geq 0
$$

Hence

$$
\begin{aligned}
I(\varepsilon) & \leq Q(\varepsilon) \int_{0}^{T} d s_{1} \int_{\varepsilon}^{s_{1}} d s_{2}\left(2 Q\left(s_{2}\right)-Q\left(s_{2}+\varepsilon\right)-Q\left(s_{2}-\varepsilon\right)\right) \\
& \leq Q(\varepsilon) \int_{0}^{T} d s_{1} \int_{\varepsilon}^{s_{1}} d s_{2}\left(\int_{s_{2}-\varepsilon}^{s_{2}} Q^{\prime}(y) d y-\int_{s_{2}}^{s_{2}+\varepsilon} Q^{\prime}(y) d y\right)
\end{aligned}
$$

Using Fubini's theorem, we obtain

$$
\begin{aligned}
& \frac{I(\varepsilon)}{Q^{2}(\varepsilon)}=\frac{1}{Q(\varepsilon)} \int_{0}^{T} d s_{1}\left(\int_{0}^{s_{1}} d y Q^{\prime}(y) \int_{\varepsilon \vee y}^{(y+\varepsilon) \wedge s_{1}} d s_{2}-\int_{\varepsilon}^{s_{1}+\varepsilon} d y Q^{\prime}(y) \int_{(y-\varepsilon) \vee \varepsilon}^{y \wedge s_{1}} d s_{2}\right) \\
& =\frac{1}{Q(\varepsilon)}\left(\int_{0}^{T} d s_{1}\left\{\int_{0}^{\varepsilon} d y Q^{\prime}(y) y+\varepsilon \int_{\varepsilon}^{s_{1}-\varepsilon} d y Q^{\prime}(y)+\int_{s_{1}-\varepsilon}^{s_{1}} d y Q^{\prime}(y)\left(s_{1}-y\right)\right\}\right. \\
& -\frac{1}{Q(\varepsilon)}\left(\int_{0}^{T} d s_{1}\left\{\int_{\varepsilon}^{2 \varepsilon} d y Q^{\prime}(y)(y-\varepsilon)+\varepsilon \int_{2 \varepsilon}^{s_{1}} d y Q^{\prime}(y)+\int_{s_{1}}^{s_{1}+\varepsilon} d y Q^{\prime}(y)\left(s_{1}-y+\varepsilon\right)\right\}\right)
\end{aligned}
$$

Performing carefully the calculations, in particular commuting $d s_{1}$ and $d y$ through Fubini's, it is possible to show that

$$
\frac{I(\varepsilon)}{Q^{2}(\varepsilon)} \leq O(\varepsilon)+O\left(\frac{\varepsilon}{Q(\varepsilon)}\right)
$$

Assumption (6.20) allows to conclude.

### 6.3 Paley-Wiener integral and integrals via regularization

We start introducing the definition of Paley-Wiener integral.

Proposition 6.32. Let $g \in L_{R}$, then

E\left(\int_{0}^{\infty} g d X\right)^{2}=\|g\|_{\mathcal{H}}^{2} \tag{6.26}
\end{equation*}
$$

Therefore the map $g \longrightarrow \int_{0}^{\infty} g d X$ is continuous with respect to $\|\cdot\|_{\mathcal{H}}$.

Proof: (6.26) follows from Remark 6.2. The second part of the statement follows because

$$
\|g\|_{\mathcal{H}} \leq\|g\|_{R} .
$$

At this point the map $I: C_{0}^{1}\left(\mathbb{R}_{+}\right) \subset L_{R} \longrightarrow L^{2}(\Omega)$ defined as $g \longrightarrow I(g)$ admits a linear continuous extension to $L_{R}$. It will still be denoted by $I$.

Definition 6.2. Let $g \in L_{R}$. We define the Paley-Wiener integral of $g$ with respect to $X$ denoted by $\int_{0}^{\infty} g d X$ the random variable $I(g)$.

Proposition 6.33. Under Assumptions (C), (D), if $\varphi$ has bounded variation with compact support, then

$$
\begin{equation*}
\int_{0}^{\infty} \varphi d X=-\int_{0}^{\infty} X d \varphi \tag{6.27}
\end{equation*}
$$

In particular

$$
\int_{0}^{\infty} 1_{[0, t]} d X=X_{t} .
$$

Proof: By definition, (6.27) holds for $g \in C_{0}^{1}$. We introduce the same sequence $\left(\varphi_{n}\right)$ as in the proof of Proposition 6.18. By (6.26)

$$
E\left(\int_{0}^{\infty}\left(\varphi_{n}-\varphi\right) d X\right)^{2}=\left\|\varphi_{n}-\varphi\right\|_{R}^{2} .
$$

This converges to zero when $n \longrightarrow \infty$ as it was shown in the proof of Proposition 6.18. In the same proof it was established that $\int_{0}^{\infty} X d \varphi_{n} \longrightarrow \int_{0}^{\infty} X d \varphi$ in $L^{2}(\Omega)$.
We recall briefly the notion of integrals via regularization in the spirit of [39] or 42]. We propose here a definite type integral.

Definition 6.3. Let $Y$ be a process with paths in $L_{\text {loc }}^{1}(\mathbb{R})$. We say that the forward (resp. backward, symmetric) integral of $Y$ with respect to $X$ exists, if the following conditions hold.
a) For $\varepsilon>0$ small enough the following Lebesgue integral

I(\varepsilon, Y, d X)= & \int_{0}^{\infty} Y_{s} \frac{X_{s+\varepsilon}-X_{s}}{\varepsilon} d s \\
\text { (resp. } & \int_{0}^{\infty} Y_{s} \frac{X_{s}-X_{s-\varepsilon}}{\varepsilon} d s \\
& \int_{0}^{\infty} Y_{s} \frac{X_{s+\varepsilon}-X_{s-\varepsilon}}{\varepsilon} d s \text { ) }
\end{aligned}
$$

with the usual condition $X_{s}=0, s \leq 0$ exists.
b) $\lim _{\varepsilon \rightarrow 0} I(\varepsilon, Y, d X)$ exists in probability.

The limit above will be denoted by

$$
\int_{0}^{\infty} Y d^{-} X\left(\text { resp. } \int_{0}^{\infty} Y d^{+} X, \int_{0}^{\infty} Y d^{o} X\right) .
$$

Proposition 6.34. Let $f: \mathbb{R}_{+} \longrightarrow \mathbb{R}$ cadlag bounded. Suppose the existence of $V_{f}: \mathbb{R}_{+} \longrightarrow$ $\mathbb{R}_{+}$such that
i)

$$
\left|f\left(s_{2}\right)-f\left(s_{1}\right)\right| \leq V_{f}\left(s_{2}-s_{1}\right), s_{1}, s_{2} \geq 0
$$

ii)

$$
\begin{equation*}
\int_{\mathbb{R}_{+}^{2}} V_{f}^{2}\left(s_{2}-s_{1}\right) d|\mu|\left(s_{1}, s_{2}\right)<\infty \tag{6.28}
\end{equation*}
$$

Then

$$
\int_{0}^{\infty} f d^{*} X=\int_{0}^{\infty} f d X, \quad * \in\{-,+, 0\} .
$$

In particular $\int_{0}^{\infty} f d^{*} X$ exists.
Proof: We consider the case $*=-$, the other cases being similar. The quantity

$$
\int_{0}^{\infty} f(s) \frac{X_{s+\varepsilon}-X_{s}}{\varepsilon} d s
$$

equals

$$
\int_{0}^{\infty} f_{\varepsilon}(u) d X_{u}
$$

where

$$
f_{\varepsilon}(u)=\frac{1}{\varepsilon} \int_{u-\varepsilon}^{u} f(s) d s=\frac{1}{\varepsilon} \int_{-\varepsilon}^{0} f(s+u) d s,
$$

with the convention that $f$ is prolongated by zero on $\mathbb{R}_{-}$.
It remains to show that $f_{\varepsilon} \longrightarrow f$ in $L_{R}$. By Lebesgue's dominated convergence theorem and the fact that $f$ is bounded, cadlag and $|R|(d s, \infty)$ is non-atomic, we have

\int_{0}^{\infty}\left(f_{\varepsilon}-f\right)^{2}(s) d|R|(d s, \infty) \underset{\varepsilon \rightarrow 0}{\longrightarrow} 0
$$

It remains to show that

$$
\lim _{\varepsilon \rightarrow 0} \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(s_{1}, s_{2}\right)\left(\left(f_{\varepsilon}-f\right)\left(s_{1}\right)-\left(f_{\varepsilon}-f\right)\left(s_{2}\right)\right)^{2}=0
$$

Indeed

$$
\begin{aligned}
& \left|\left(f_{\varepsilon}-f\right)\left(s_{1}\right)-\left(f_{\varepsilon}-f\right)\left(s_{2}\right)\right|=\frac{1}{\varepsilon}\left|\int_{-\varepsilon}^{0}\left[\left(f\left(y+s_{1}\right)-f\left(s_{1}\right)\right)-\left(f\left(y+s_{2}\right)-f\left(s_{2}\right)\right)\right] d y\right| \\
& \quad=\frac{1}{\varepsilon}\left|\int_{-\varepsilon}^{0}\left[\left(f\left(y+s_{1}\right)-f\left(y+s_{2}\right)\right)-\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)\right] d y\right| \\
& \left.\quad \leq \frac{1}{\varepsilon} \int_{-\varepsilon}^{0} \right\rvert\,\left(f\left(y+s_{1}\right)-f\left(y+s_{2}\right)\left|d y-\left|f\left(s_{1}\right)-f\left(s_{2}\right)\right| d y \leq 2 V\left(s_{2}-s_{1}\right) .\right.\right.
\end{aligned}
$$

Since $f_{\varepsilon} \longrightarrow f$, (6.28) and Lebesgue's dominated convergence theorem allow to conclude.

### 6.4 About some second order Paley-Wiener integral

We introduce now a second order Wiener integral of the type:

$$
I_{2}(g):=\int_{\mathbb{R}_{+}^{2}} g\left(s_{1}, s_{2}\right) d X_{s_{1}}^{1} d X_{s_{2}}^{2},
$$

where $g: \mathbb{R}_{+}^{2} \longrightarrow \mathbb{R}$ is a suitable function and $X^{1}, X^{2}$ are two independent copies of X.
In fact all the considerations can be extended to Wiener integrals with respect to $n$ copies $X^{1}, \ldots, X^{n}$ of $X$, but in order not to introduce technical complications we only consider the case $n=2$. This case will be helpful in section 9 in order to topologize the tensor product $L_{R} \otimes L_{R}$.

We will make use of tensor product spaces in the Hilbert framework. For a complete information about tensor product spaces and topologies the reader can consult 43]. We suppose here the validity of Assumption (C). We denote $\nu=|R|(d t, \infty)$ as before. If $g=g_{1} \otimes g_{2}, g_{1}, g_{2} \in L_{R}$ then we set

$$
\begin{equation*}
I_{2}(g)=\int_{0}^{\infty} g_{1} d X_{1} \int_{0}^{\infty} g_{2} d X_{2} \tag{6.29}
\end{equation*}
$$

We remark that $g\left(s_{1}, s_{2}\right)=g_{1}\left(s_{1}\right) g_{2}\left(s_{2}\right)$. We denote by $L_{R} \otimes L_{R}$ the algebraic tensor product space of linear combinations of functions of the type $g_{1} \otimes g_{2}, g_{1}, g_{2} \in L_{R}$.

We define $\tilde{L}_{2, R}$ as the space of Borel functions $g: \mathbb{R}_{+}^{2} \longrightarrow \mathbb{R}$ such that

$$
\begin{equation*}
\|g\|_{2, R}^{2}=\int_{0}^{\infty} \nu(d t)\|g(t, \cdot)\|_{R}^{2}+\frac{1}{2} \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(s_{1}, s_{2}\right)\left\|g\left(s_{1}, \cdot\right)-g\left(s_{2}, \cdot\right)\right\|_{R}^{2}<\infty . \tag{6.30}
\end{equation*}
$$

An easy property which can be established by inspection is given below.

Lemma 6.35. For $g: \mathbb{R}_{+}^{2} \longrightarrow \mathbb{R}$ we have

\begin{aligned}
\|g\|_{2, R}^{2}= & \int_{\mathbb{R}_{+}^{2}} \nu\left(d s_{1}\right) \nu\left(d s_{2}\right) g^{2}\left(s_{1}, s_{2}\right) \\
& +\frac{1}{4} \int_{\mathbb{R}_{+}^{2} \times \mathbb{R}_{+}^{2}}\left(g\left(s_{1}, t_{1}\right)-g\left(s_{2}, t_{1}\right)-g\left(s_{1}, t_{2}\right)+g\left(s_{2}, t_{2}\right)\right)^{2} d|\mu|\left(t_{1}, t_{2}\right) d|\mu|\left(s_{1}, s_{2}\right) \\
& +\frac{1}{2} \int_{0}^{\infty} d \nu(s)\left\{\int_{\mathbb{R}_{+}^{2}}\left(g\left(s, t_{1}\right)-g\left(s, t_{2}\right)\right)^{2} d|\mu|\left(t_{1}, t_{2}\right)+\int_{\mathbb{R}_{+}^{2}}\left(g\left(s_{1}, s\right)-g\left(s_{2}, s\right)\right)^{2} d|\mu|\left(s_{1}, s_{2}\right)\right\} \\
= & \int_{0}^{\infty} \nu(d t)\|g(\cdot, t)\|_{R}^{2}+\frac{1}{2} \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(t_{1}, t_{2}\right)\left\|g\left(\cdot, t_{1}\right)-g\left(\cdot, t_{2}\right)\right\|_{\mathbb{R}_{+}^{2}}^{2}
\end{aligned}
$$

Remark 6.36. We observe that second term of the right-hand side equals

$$
\frac{1}{4} \int_{\mathbb{R}_{+}^{2} \times \mathbb{R}_{+}^{2}}\left(\Delta_{\left.\left.\left.s_{1}, s_{2}\right] \times\right] t_{1}, t_{2}\right]} g\right)^{2} d|\mu|\left(t_{1}, t_{2}\right) d|\mu|\left(s_{1}, s_{2}\right)
$$

where $\Delta_{\int_{\left.\left.\left.s_{1}, s_{2}\right] \times\right] t_{1}, t_{2}\right]} g}$ is the planar increment introduced in Section 0 .
Remark 6.37. 1. The (semi)-norm $\|\cdot\|_{2, R}$ derives from an inner product. We have

$$
\begin{aligned}
\langle f, g\rangle_{2, R}= & \int_{0}^{\infty} \nu(d s)\langle f(s, \cdot), g(s, \cdot)\rangle_{R} \\
& +\frac{1}{2} \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(s_{1}, s_{2}\right)\left\langle f\left(s_{1}, \cdot\right)-f\left(s_{2}, \cdot\right), g\left(s_{1}, \cdot\right)-g\left(s_{2}, \cdot\right)\right\rangle_{R}
\end{aligned}
$$

2. An analogous expression to Lemma's 6.35 statement, can be written for $\langle\cdot, \cdot\rangle_{2, R}$ instead of $\|\cdot\|_{2, R}$.
3. If $f=f_{1} \otimes f_{2}, f_{1}, f_{2} \in L_{R}$ then $f \in \tilde{L}_{2, R}$. If $g=g_{1} \otimes g_{2}, g_{1}, g_{2} \in L_{R}$

$$
\langle f, g\rangle_{2, R}=\left\langle f_{1}, g_{1}\right\rangle_{R}\left\langle f_{2}, g_{2}\right\rangle_{R}
$$

4. $L_{R} \otimes L_{R}$ is included in $\tilde{L}_{2, R}$. In particular any linear combination of the type $\phi \otimes \phi$ belong to $L_{R} \otimes L_{R}$.
5. Similarly to the proof of Proposition 6.14, taking into account Assumption (C), it is possible to show that $\tilde{L}_{2, R}$ is complete and it is therefore a Hilbert space.
6. Since $\langle\cdot, \cdot\rangle_{2, R}$ is a scalar product and because of 3., it follows that $\|\cdot\|_{2, R}$ is the Hilbert tensor norm of $L_{R} \otimes L_{R}$. For more information about tensor topologies, see e.g. 4Y3. The closure of $L_{R} \otimes L_{R}$ with respect to $\|\cdot\|_{2, R}$ can be identified with the Hilbert tensor product space $L_{R} \otimes^{h} L_{R}$; it will be denoted by $L_{2, R}$.
7. $\tilde{L}_{2, R}$ can also be equipped with the scalar product $\langle\cdot, \cdot\rangle_{2, \mathcal{H}}$

\begin{aligned}
\langle f, g\rangle_{2, \mathcal{H}}= & \int_{0}^{\infty} R(d s, \infty)\langle f(s, \cdot), g(s, \cdot)\rangle_{\mathcal{H}} \\
& -\frac{1}{2} \int_{\mathbb{R}_{+}^{2}} \mu\left(d s_{1}, d s_{2}\right)\left\langle f\left(s_{1}, \cdot\right)-f\left(s_{2}, \cdot\right), g\left(s_{1}, \cdot\right)-g\left(s_{2}, \cdot\right)\right\rangle_{\mathcal{H}}
\end{aligned}
$$

Remark 6.38. Similar considerations as in Remark 6.3才 can be made for the inner product $\langle\cdot, \cdot\rangle_{2, \mathcal{H}}$.

1. If $f, g$ are as in 3. of Remark 6.37, then

\langle f, g\rangle_{2, \mathcal{H}}=\left\langle f_{1}, g_{1}\right\rangle_{\mathcal{H}}\left\langle f_{2}, g_{2}\right\rangle_{\mathcal{H}} .

2. We denote by $\|\cdot\|_{2, \mathcal{H}}$ the associated norm. Analogous expressions as for Lemma 6.35 can be found for $\|\cdot\|_{2, \mathcal{H}}$.
3. If Assumption ( $D$ ) is fulfilled then $L_{R}$ can be identified with $\mathcal{H}$ and $\langle\cdot, \cdot\rangle_{2, \mathcal{H}}$ coincides with $\langle\cdot, \cdot\rangle_{2, R}$. The Hilbert tensor product $\mathcal{H} \otimes^{h} \mathcal{H}$ can be identified with $L_{2, R}$.
4. If $f \in \tilde{L}_{2, R}$ then

$$
\|f\|_{2, \mathcal{H}} \leq\|f\|_{2, R} .
$$

The double integral application $g \longmapsto I_{2}(g)$ extends by linearity through (6.29) to the algebraic tensor product $L_{R} \otimes L_{R}$.

Proposition 6.39. $I_{2}: L_{R} \otimes L_{R} \longrightarrow L^{2}(\Omega, \mathcal{F}, P)$ extends continuously to $L_{2, R}$. In particular for every $g \in L_{2, R}$ we have

E\left(I_{2}(g)^{2}\right)=\|g\|_{2, R}^{2} .
$$

Proof: Let $g \in L_{2, R}$, so $g=\sum_{i=1}^{n} g_{i 1} \otimes g_{i 2}, g_{i 1}, g_{i 2} \in L_{R}$, then

\begin{aligned}
E\left(I_{2}(g)^{2}\right) & =\sum_{i, j=1}^{n} E\left(I_{2}\left(g_{i 1} \otimes g_{i 2}\right) I_{2}\left(g_{j 1} \otimes g_{j 2}\right)\right) \\
& =\sum_{i, j=1}^{n} E\left(\int_{0}^{\infty} g_{i 1} d X^{1} \int_{0}^{\infty} g_{i 2} d X^{2} \int_{0}^{\infty} g_{j 1} d X^{1} \int_{0}^{\infty} g_{j 2} d X^{2}\right) \\
& =\sum_{i, j=1}^{n} E\left(\int_{0}^{\infty} g_{i 1} d X^{1} \int_{0}^{\infty} g_{j 1} d X^{1}\right) E\left(\int_{0}^{\infty} g_{i 2} d X^{2} \int_{0}^{\infty} g_{j 2} d X^{2}\right)
\end{aligned}
$$

using the independence of $X^{1}$ and $X^{2}$. Therefore by Remark 6.38 1. and bilinearity of the inner product, it follows

$$
\begin{aligned}
E\left(I_{2}(g)\right)^{2} & =\sum_{i, j=1}^{n}\left\langle g_{i 1}, g_{j 1}\right\rangle_{\mathcal{H}}\left\langle g_{i 2}, g_{j 2}\right\rangle_{\mathcal{H}} \\
& =\sum_{i, j=1}^{n}\left\langle g_{i 1} \otimes g_{i 2}, g_{j 1} \otimes g_{j 2}\right\rangle_{2, \mathcal{H}}=\|g\|_{2, \mathcal{H}}^{2} \leq\|g\|_{2, R}^{2}
\end{aligned}
$$

This allows to conclude the proof of the proposition.

Remark 6.40. The proof of Proposition 6.33 allows to establish (as a by product) that for $g \in L_{2, R}$ the double integral is unambiguously defined.

Given $g \in L_{2, R}$, we denote

This quantity is called double (Paley-)Wiener integral of $g$ with respect to $X^{1}$ and $X^{2}$.
We will characterize now some significant functions which belongs to $L_{2, R}$.
Lemma 6.41. Suppose that $1_{[0, t]} \in L_{R}$ for every $t>0$ and Assumption ( $C$ ). Then for any $t_{1}, t_{2}>0, y_{1}, y_{2}>0, h=1_{\left.\left.\left[t_{1}, t_{2}\right] \times\right] y_{1}, y_{2}\right]}$ belongs to $L_{2, R}$.

Proof: Since $1_{\left.] t_{1}, t_{2}\right]}, 1_{\left.] y_{1}, y_{2}\right]} \in L_{R}$, clearly $h \in L_{R} \otimes L_{R} \subset L_{2, R}$.
Remark 6.42. 1) If $g$ is a sum of functions of the type $g^{1} \otimes g^{2}$, where $g^{1}, g^{2}: \mathbb{R}_{+} \longrightarrow \mathbb{R}$ are bounded variation functions with compact support, then $g$ has bounded planar variation.
2) If $g$ is as in item 1) and $X^{1}, X^{2}$ are independent copies of $X$, then

where the right-hand side is a Lebesgue integral with respect to the signed measure $\chi$ such that

This follows because of the following reasons.
If $g=g_{1} \otimes g_{2}, g_{1}, g_{2}$ have bounded variation with compact support then
i) $I_{2}(g)=\int_{0}^{\infty} g_{1} d X^{1} \int_{0}^{\infty} g_{2} d X^{2}$,
ii) $\int_{] 0, \infty\left[^{2}\right.} \varphi d g=\int_{j 0, \infty\left[^{2}\right.} \varphi\left(s_{1}, s_{2}\right) d g_{1}\left(s_{1}\right) d g_{2}\left(s_{2}\right)$,
iii) $\int_{0}^{\infty} g_{1} d X^{1}=-\int_{0}^{\infty} X_{s}^{1} d g_{1}(s)$, because of Proposition 6.33.

A significant proposition characterizing elements of $L_{2, R}$ under Assumption (D) is the following.

Proposition 6.43. We suppose, that Assumptions ( $C$ ) and ( $D$ ) are verified. Moreover we suppose that $h: \mathbb{R}_{+}^{2} \longrightarrow \mathbb{R}$ has bounded planar variation. Then $h \in L_{2, R}$.

Remark 6.44. If $X_{t}=X_{T}, t \geq T$ then the statement of Proposition 6.4 holds if $\left.h\right|_{[0, T]^{2}}$ has bounded planar variation.

Indeed, by definition of $L_{2, R}$, if $h$ is prolongated by zero outside $[0, T]^{2}$ denoted by $\bar{h}$, then $\|h-\bar{h}\|_{2, R}=0$. In particular $h=\bar{h} \nu_{\infty} \otimes \nu_{\infty}$ a.e. since

Of course $h^{N}$ belongs to $L_{R} \otimes L_{R} \subset L_{2, R}$.
On the other hand $h^{N} \longrightarrow h$ for every continuity point. The total variation of $d h^{N}$ is bounded by

Previous quantity is bounded by $\|h\|_{p v}$. Finally $h^{N}$ converges weakly to $h$, by the theory of two-parameter distribution functions of measures. Therefore, if $X^{1}$ and $X^{2}$ are two independent copies of $X$, then

This converges to zero because $d h^{N} \otimes d h^{M}$ weakly converges when $N, M \rightarrow \infty$ and $\left(t_{1}, s_{1}, t_{2}, s_{2}\right) \mapsto$ $R\left(t_{1}, s_{1}\right) R\left(t_{2}, s_{2}\right)$ is a continuous function. Consequently the sequence $\left(h^{N}\right)$ is Cauchy in $L_{2, R}$.

Since $L_{2, R}$ is complete, there is $\psi: \mathbb{R}_{+}^{2} \longrightarrow \mathbb{R} \in L_{2, R}$ such that

Since $h^{N} \longrightarrow h$ excepted on a countable quantity of points and $\nu_{\infty} \otimes \nu_{\infty}$ is nonatomic, then $h^{N} \longrightarrow h \nu_{\infty} \otimes \nu_{\infty}$ a.e. Finally $h=\psi \nu_{\infty} \otimes \nu_{\infty}$ a.e. and therefore

& \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(t_{1}, t_{2}\right) \int_{0}^{\infty} d \rho(s) \operatorname{Var}\left(X_{\left(t_{2}+a\right)_{+}+\varepsilon s}-X_{\left(t_{1}+a\right)_{+}+\varepsilon s}\right) \\
& =\int_{0}^{\infty} d \rho(s) \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(t_{1}, t_{2}\right) \operatorname{Var}\left(X_{\left(t_{2}+a\right)_{+}+\varepsilon s}-X_{\left(t_{1}+a\right)_{+}+\varepsilon s}\right) .
\end{aligned}
$$

Lebesgue's dominated convergence theorem says that previous expression goes to

& \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(t_{1}, t_{2}\right) \operatorname{Var}\left(X_{\left(t_{2}+a\right)_{+}}-X_{\left(t_{1}+a\right)_{+}}\right) \\
& =\int_{\mathbb{R}_{+}^{2}} d|\mu|\left(t_{1}, t_{2}\right)\left\|1_{\left[0,\left(t_{2}+a\right)_{+}\right]}-1_{\left[\left(t_{1}+a\right)_{+}\right]}\right\|_{R}^{2} . \tag{6.42}

This shows that

equals the right-hand side of (6.42). By similar arguments we can show that

converges again to the right-hand side of (6.42). This finally shows $\lim _{\varepsilon \rightarrow 0} I_{2}(\varepsilon)=0$ and the final result.

An interesting consequence is the following.
Proposition 6.48. We suppose Assumptions (C), (D). Let $g \in L_{2, R}$. Suppose that $X$ fulfills the following assumption

\int_{\mathbb{R}_{+}^{2}} g(s, t) d X_{s}^{1} d X_{t}=\int_{0}^{\infty}\left(\int_{0}^{\infty} g(s, t) d X_{t}\right) d X_{s}^{1} \tag{6.44}
\end{equation*}
$$

if $X^{1}$ is an independent copy distributed as $X$.
Corollary 6.49. We suppose Assumptions (C), (D), (6.35) and $X_{t}=X_{T}$ for $t \geq T$.

1) We have $s \longmapsto X_{s} \in L_{R}$ a.s. and it belongs to $L^{2}\left(\Omega ; L_{R}\right)$.
2) Let $X^{1}$ be an independent copy of $X$. If $h\left(s_{1}, s_{2}\right)=1_{\left[0, s_{1} \wedge T\right]}\left(s_{2}\right)$, then
i)

\int_{\mathbb{R}_{+}^{2}} h\left(s_{1}, s_{2}\right) d X_{s_{1}}^{1} d X_{s_{2}}=\int_{0}^{\infty} X_{s} d X_{s}^{1} .
$$

ii)

E\left(\int_{\mathbb{R}_{+}^{2}} h\left(s_{1}, s_{2}\right) d X_{s_{1}}^{1} d X_{s_{2}}\right)^{2}=E\left(\|X\|_{R}^{2}\right) . \tag{6.45}
\end{equation*}

Proof (of Corollary 6.49): It is a consequence of Proposition 6.47 setting $g=h$, with $a=0$ and Proposition 6.48.

Proof(of Proposition 6.48): The fact that $g(s, \cdot) \in L_{R}$ for $R(d s, \infty)$ a.e. comes from the definition of $L_{2, R}$. Let $g^{N} \in L_{R} \otimes L_{R}$ of the type $g^{N}(s, t)=\sum_{i=1}^{N} f_{i}(s) h_{i}(t), f_{i}, h_{i} \in L_{R}$ and

We observe that $Z^{N}(s)=$ $\sum_{i=1}^{N}\left(\int_{0}^{\infty} h_{i}(t) d X_{t}\right) f_{i}(s)$. Clearly $Z^{N} \in L_{R}$ a.s. The result would follow if we show the existence of a subsequence $\left(N_{k}\right)$ such that $Z^{N_{k}} \longrightarrow Z$ a.s. in $L_{R}$. For this it will be enough to show that

We have indeed

& -\frac{1}{2} E\left(\int_{\mathbb{R}_{+}^{2}}\left(\left(Z^{N}-Z\right)\left(s_{1}\right)-\left(Z^{N}-Z\right)\left(s_{2}\right)\right)^{2} d \mu\left(s_{1}, s_{2}\right)\right) \\
& =\int_{0}^{\infty} R(d s, \infty) E\left(\int_{0}^{\infty}\left(g^{N}-g\right)(s, t) d X_{t}\right)^{2} \\
& \left.-\frac{1}{2} \int_{\mathbb{R}_{+}^{2}} d \mu\left(s_{1}, s_{2}\right)\right) E\left(\int_{0}^{\infty}\left[\left(g^{N}-g\right)\left(s_{1}, t\right)-\left(g^{N}-g\right)\left(s_{2}, t\right)\right] d X_{t}\right)^{2}
\end{aligned}
$$

By Assumption (D) and Corollary 6.32, previous expression equals

& +\frac{1}{2} \int_{\mathbb{R}_{+}^{2}} d \mu\left(s_{1}, s_{2}\right)\left\|\left(g^{N}-g\right)\left(s_{1}, \cdot\right)-\left(g^{N}-g\right)\left(s_{2}, \cdot\right)\right\|_{R}^{2} \\
& =\left\|g^{N}-g\right\|_{2, R}^{2} \tag{6.47}
\end{align*}
$$

The result follows by (6.46).

## 7 Basic considerations on Malliavin calculus

The aim of this paper is to implement Wiener analysis in the case when our basic process $X$ fulfills Assumptions (A), (B) and $(\mathrm{C}(\nu))$. In the sequel we will also often suppose the validity of Assumptions (C), (D). The spirit is still the one of [25] in which the process $X$ was supposed to have a covariance measure structure but in a much more singular context. The target of this is the study of a suitable framework of Skorohod calculus with Itô formulae including the case when the covariance is singular. We also explore the connection with calculus via regularization.

Let $X=\left(X_{t}\right)_{t \in[0, \infty]}$ be an $L^{2}$-continuous process with continuous paths. For simplicity we suppose $X_{0}=0$. We denote by $C^{0,0}\left(\overline{\mathbb{R}}_{+}\right)$the set of continuous functions defined on $\mathbb{R}_{+}$vanishing at zero with a limit at infinity. As in 25], we will also suppose that the law $\Xi$ of process $X$ on $C^{0,0}\left(\overline{\mathbb{R}}_{+}\right)$has full support, i.e. the probability that $X$ belongs to any non-empty, open subset of $C^{0,0}\left(\overline{\mathbb{R}}_{+}\right)$is strictly positive. This allows to state the following result.

Proposition 7.1. We set $\Omega_{0}=C^{0,0}\left(\overline{\mathbb{R}}_{+}\right)$, equipped with its Borel $\sigma$-algebra and probability $\Xi$. We denote by $\mathcal{F} C_{b}^{\infty}$ the linear space of $f\left(l_{1}, \ldots, l_{m}\right), m \in \mathbb{N}^{*}, f \in C_{b}^{\infty}\left(\mathbb{R}^{m}\right), l_{1}, \ldots, l_{m} \in$ $\Omega_{0}^{*}$. Then $\mathcal{F} C_{b}^{\infty}$ is dense into $L^{2}\left(\Omega_{0}, \Xi\right)$.

Remark 7.2. i) A reference for this result is 30], Section II.3.
ii) We apply Proposition 7.1 on the canonical probability space related to a continuous square integrable process $X$.

We introduce a technical assumption, which will be verified in the most examples.

$$
\begin{equation*}
1_{[0, t]} \in L_{R}, \quad \forall t \geq 0,1 \in L_{R} . \tag{7.1}
\end{equation*}
$$

For instance it is fulfilled if Assumptions (C) and (D) hold or if $X$ has a covariance measure structure, see Corollary 6.19 and Proposition 6.13.

Remark 7.3. Taking into account (7.1), we denote by $\bar{L}_{R}$ the linear space of functions $\bar{f}: \mathbb{R}_{+} \longrightarrow \mathbb{R}$ such that there is $f \in L_{R}$ with

\bar{f}(t)=\left\langle f, 1_{[0, t]}\right\rangle_{\mathcal{H}} \tag{7.2}
\end{equation*}
$$

$\bar{L}_{R}$ is the classical self-reproducing kernel space appearing in the literature. We equip $\bar{L}_{R}$ with the Hilbert norm inherited from $L_{R}$ i.e. $\|\bar{f}\|_{\bar{L}_{R}}=\|f\|_{R}$. Therefore $\bar{f}_{n} \longrightarrow \bar{f}$ in $\bar{L}_{R}$ if and only if $f_{n} \longrightarrow f$ in $L_{R}$. We set $\gamma_{\infty}=\sup _{t \geq 0} \sqrt{\operatorname{Var}\left(X_{t}\right)}$. Since for $0 \leq s<t$,

|\bar{f}(t)-\bar{f}(s)|=\left|E\left(\left(X_{t}-X_{s}\right) \int_{0}^{\infty} f d X\right)\right| \leq\left\{E\left(X_{t}-X_{s}\right)^{2}\right\}^{\frac{1}{2}}\|f\|_{\mathcal{H}}
$$

and $X$ is continuous in $L^{2}(\Omega)$. We have the following.

1. If $f \in L_{R}$, then $\sup _{t \geq 0}|\bar{f}(t)| \leq \gamma_{\infty}\|f\|_{\mathcal{H}} \leq \gamma_{\infty}\|f\|_{R}=\gamma_{\infty}\|\bar{f}\|_{\bar{L}_{R}}$.
2. $\bar{L}_{R} \subset C_{b}\left(\mathbb{R}_{+}\right)$.

We denote by Cyl the set of smooth and cylindrical random variables of the form

F=f\left(\int_{0}^{\infty} \phi_{1} d X, \ldots, \int_{0}^{\infty} \phi_{m} d X\right), \tag{7.3}
\end{equation*}
$$

where $f \in C_{b}^{\infty}\left(\mathbb{R}^{m}\right), \phi_{1}, \ldots, \phi_{m} \in C_{0}^{1}(\mathbb{R})$ and $\int_{0}^{\infty} \phi_{i} d X, 1 \leq i \leq m$ still denotes the PaleyWiener integral developed in Section 6 .

An important basic consequence of Proposition 7.1 for developing Malliavin calculus is the following.

Theorem 7.4. Cyl is dense into $L^{2}(\Omega)$.
Before entering the proof we make some preliminary considerations. We first suppose that $\Omega$ coincides with the canonical space $\Omega_{0}$ and $X_{t}(\omega)=\omega(t), t \geq 0$, so $P=\Xi$. In this case, if $f \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$(which is an element of $L_{R}$ ), the following Wiener integral

$$
\int_{0}^{\infty} f d X(\omega)=-\int_{0}^{\infty} X_{s}(\omega) d f(s)=-\int_{0}^{\infty} \omega(s) d f(s)
$$

is pathwise defined.
Lemma 7.5. Let $l: \Omega_{0} \longrightarrow \mathbb{R}$ be linear and continuous. There is a sequence $\left(g_{n}\right)$ in $C_{0}^{1}(\mathbb{R})$, $a_{n} \in \mathbb{R}$ with $\left(\int_{0}^{\infty} g_{n} d X\right)(\omega)+a_{n} X_{\infty} \longrightarrow l(\omega), \forall \omega \in \Omega_{0}$ and so in particular $\Xi$ a.s.

Proof: Since $l: \Omega_{0} \longrightarrow \mathbb{R}$ is linear and continuous, there is a finite signed, Borel measure $\ell$ on $\overline{\mathbb{R}}_{+}$such that for every $\tilde{h} \in \Omega_{0}$

l(\tilde{h})=-\int_{] 0, \infty[ } \tilde{h} d \ell+\tilde{h}(+\infty) \ell(\{+\infty\})
$$

Now

& g(x)=\ell([x, \infty[)
\end{aligned}

where $\left(\rho_{n}\right)$ is the usual sequence of mollifiers with compact support approaching Dirac delta function. In particular $\left.d g_{n} \longrightarrow \ell\right|_{\mathbb{R}_{+}}$weakly. We set

l_{n}(\tilde{h})=-\int_{0}^{\infty} \tilde{h} d g_{n}, \quad a_{n}=\ell(\{+\infty\})
$$

so that

l_{n}(X)=\int_{0}^{\infty} g_{n} d X
$$

Since $l_{n}(\tilde{h}) \longrightarrow-\int_{0}^{\infty} \tilde{h} d \ell$ pointwise, the result follows.

Lemma 7.6. The statement of Theorem 7.4 holds whenever $\Omega=\Omega_{0}, P=\Xi$.
Proof: By Proposition 7.1 it is enough to show that any element of $\mathcal{F} C_{b}^{\infty}$ can be approached by a sequence of random variables in $C y l$. Let $F \in \mathcal{F} C_{b}^{\infty}$ given by $f\left(l_{1}, \ldots, l_{m}\right)$ as in Proposition 7.1. By truncation it is clear that we can reduce to the case, when $f$ is bounded. Lemma 7.5 implies that it can be pointwise approximated (so a.s.) by a sequence of random variables of the type $f\left(\int_{0}^{\infty} \phi_{0} d X, \ldots, \int_{0}^{\infty} \phi_{m} d X\right)$ for $\phi_{0}=1$, and $\phi_{1} \ldots, \phi_{n} \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$. Since $f$ is bounded, the convergence also holds in $L^{2}(\Omega ; \Xi)$.
Proof (of Theorem 7.4): Any r.v. $h \in L^{2}(\Omega)$ can be represented through $F(X)$, where $F \in L^{2}\left(\Omega_{0}, \Xi\right)$. According to Lemma 7.6 there is a sequence of elements of the type $f\left(\int_{0}^{\infty} \phi_{0} d i, \ldots, \int_{0}^{\infty} \phi_{m} d i\right), i(s)=s, \phi_{0}=1, \phi_{1}, \ldots, \phi_{n} \in C_{0}^{1}\left(\mathbb{R}_{+}\right), f \in C_{b}^{\infty}(\mathbb{R})$ converging in $L^{2}\left(\Omega_{0}, \Xi\right)$ to $F$. Since Wiener integrals $\int_{0}^{\infty} \phi_{j} d X, 1 \leq j \leq n$, can be pathwise represented, then

$$
f\left(\int_{0}^{\infty} \phi_{0} d X, \ldots, \int_{0}^{\infty} \phi_{m} d X\right)=\left.f\left(\int_{0}^{\infty} \phi_{0} d i, \ldots, \int_{0}^{\infty} \phi_{m} d i\right)\right|_{i=X}
$$

and the general result follows.

## 8 Malliavin derivative and related properties

In this section we suppose again Assumptions (A), (B) and $(\mathrm{C}(\nu))$. We will suppose from now on that $X$ is Gaussian. We start with a technical lemma.

Lemma 8.1. Let $\phi_{1}, \ldots \phi_{n} \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$orthogonal with respect to $\langle\cdot, \cdot\rangle_{\mathcal{H}}$, not vanishing. Then then the law of the vector

$$
V=\left(\int_{0}^{\infty} \phi_{1} d X, \ldots, \int_{0}^{\infty} \phi_{m} d X\right)
$$

has full support in the sense that for any non empty open set $I$ of $\mathbb{R}^{n}, P\{V \in I\}>0$.
Proof: Clearly we can reduce the question to the case $\left.I=\prod_{j=1}^{m}\right] a_{j}, b_{j}\left[, a_{j}<b_{j}\right.$. Since the random variables $\int_{0}^{\infty} \phi_{1} d X, \ldots, \int_{0}^{\infty} \phi_{m} d X$ are independent, it is enough to write the proof in the case $m=1, \phi=\phi_{1} \in C_{0}^{1}(\mathbb{R}), \phi \neq 0$.
Let $\Xi$ be the law of $X$ on $\Omega_{0}$. Then

$$
\begin{equation*}
P\left\{\int_{0}^{\infty} \phi d X \in\right] a_{1}, b_{1}[ \}=\Xi\left\{\omega \in \Omega_{0} \mid l(\omega) \in\right] a_{1}, b_{1}[ \} \tag{8.1}
\end{equation*}
$$

where $l(\omega)=-\int \omega d \phi$, which is clearly an element of the topological dual $\Omega_{0}^{*}$. Since $l$ is continuous,

$$
\begin{equation*}
\left\{\omega \in \Omega_{0} \mid l(\omega) \in\right] a_{1}, b_{1}[ \} \tag{8.2}
\end{equation*}
$$

is an open subset of $\Omega_{0}$. Since $\Xi$ has full support, it remains to show that the set (8.2) is non empty.
It is always possible to find $\omega_{0} \in \Omega_{0}$ such that $l\left(\omega_{0}\right) \neq 0$. Otherwise the derivative $\dot{\phi}$ would be orthogonal with respect to the $L^{2}\left(\mathbb{R}_{+}\right)$norm to the linear space

$$
\left\{\omega \in L^{2}\left(\mathbb{R}_{+}\right) \cap C\left(\mathbb{R}_{+}\right) \mid \omega(0)=0\right\}
$$

This would not be possible since that space is dense in $L^{2}\left(\mathbb{R}_{+}\right)$. Consequently, there exists $\lambda \in \mathbb{R}$ such that

\left.l\left(\lambda \omega_{0}\right)=\lambda l\left(\omega_{0}\right) \in\right] a_{1}, b_{1}[.
$$

It is enough to choose $\lambda$ between $\frac{a_{1}}{l\left(\omega_{0}\right)}$ and $\frac{b_{1}}{l\left(\omega_{0}\right)}$. Finally $\lambda \omega_{0}$ belongs to the set defined in (8.2).

For $F \in C y l$ of the form (7.3), we define

D_{t} F=\sum_{i=1}^{n} \partial_{i} f\left(\int_{0}^{\infty} \phi_{1} d X, \ldots, \int_{0}^{\infty} \phi_{m} d X\right) \phi_{i}(t) \tag{8.3}
\end{equation*}
$$

Remark 8.2. Let $F \in$ Cyl. Since $\phi_{i} \in L_{R}$ and $\partial_{i} f, 1 \leq i \leq n$ are bounded, then $t \longrightarrow$ $D_{t} F \in L_{R}$ a.s. Moreover

$$
E\left(\|D F\|_{R}^{2}\right)<\infty
$$

Consequently $D F \in L^{2}\left(\Omega ; L_{R}\right)$.
Proposition 8.3. Expression (8.3) does not depend on the explicit form (7.3).
Proof: We can of course reduce the problem as follows. Let $f: \mathbb{R}^{n} \longrightarrow \mathbb{R}$, $f \in C_{b}^{\infty}\left(\mathbb{R}^{n}\right), \phi_{1}, \ldots, \phi_{n} \in C_{0}^{1}$ such that

f\left(Z_{1}, \ldots, Z_{n}\right)=0
$$

where $Z_{i}=\int_{0}^{\infty} \phi_{i} d X$. We need to prove that

$$
\begin{equation*}
\sum_{k=1}^{n} \partial_{k} f\left(Z_{1}, \ldots, Z_{n}\right) \phi_{k}=0 \quad \text { a.s. } \tag{8.4}
\end{equation*}
$$

By a classical orthogonalization procedure with respect to the inner product $\langle\cdot, \cdot\rangle_{\mathcal{H}}$, there is $m \leq n, A=\left(a_{i j}\right)_{1 \leq i \leq n, 1 \leq j \leq m}$ such that $\phi_{i}=\sum_{j=1}^{m} a_{i j} \psi_{j}, \psi_{1}, \ldots \psi_{m}$ being orthogonal. Writing $Y_{j}=\int_{0}^{\infty} \psi_{j} d X$, we also have

\tilde{f}\left(Y_{1}, \ldots, Y_{m}\right)=0 \tag{8.5}
\end{equation*}
$$

with

$$
\tilde{f}\left(y_{1}, \ldots, y_{m}\right)=f\left(\sum_{j=1}^{m} a_{1 j} y_{j}, \ldots, \sum_{j=1}^{m} a_{n j} y_{j}\right)
$$

By usual rules of calculus, (8.4) implies that

\sum_{l=1}^{m} \partial_{l} \tilde{f}\left(Y_{1}, \ldots, Y_{m}\right) \psi_{l}=\sum_{k=1}^{m} \partial_{k} f\left(Z_{1}, \ldots, Z_{n}\right) \phi_{k} \tag{8.6}
\end{equation*}
$$

(8.5) implies that

\int_{\mathbb{R}^{m}} \tilde{f}^{2}\left(y_{1}, \ldots, y_{m}\right) d \mu_{V}\left(y_{1}, \ldots, y_{n}\right)=0 \tag{8.7}
\end{equation*}
$$

where $\mu_{V}$ is the law of $\left(Y_{1}, \ldots, Y_{n}\right)$. Since $\tilde{f}$ is continuous and because of Lemma 8.1, (8.7) implies that $\tilde{f} \equiv 0$. This finally allows to conclude (8.4).

Before going on, we need to show that $D: C y l \longrightarrow L^{2}(\Omega)$ is closable. We observe first the following property.

Proposition 8.4. Let $F \in C y l, h \in L_{R}$. Then

E\left(\langle D F, h\rangle_{\mathcal{H}}\right)=E\left(F \int_{0}^{\infty} h d X\right) .
$$

Proof: It is very similar to Lemma 6.7 of [25] or Lemma 1.1 of [33].
Remark 8.5. Cyl is a vector algebra. Moreover, if $F, G \in C y l$, then

D(F G)=G D F+F D G \tag{8.8}
\end{equation*}
$$

A consequence of Proposition 8.4 and Remark 8.5 is the following.
Corollary 8.6. Let $F, G \in C y l, h \in L_{R}$. Then

\begin{aligned}
& E\left(G\langle D F, h\rangle_{\mathcal{H}}\right) \\
& \quad=E\left(-F\langle D G, h\rangle_{\mathcal{H}}\right)+E\left(F G \int_{0}^{\infty} h d X\right) .
\end{aligned}
$$

Finally we can state the following result.
Proposition 8.7. The map $D: C y l \longrightarrow L^{2}\left(\Omega ; L_{R}\right)$ is closable.
Proof: Let $F_{n}$ be a sequence in Cyl such that $\lim _{n \rightarrow \infty} E\left(F_{n}^{2}\right)=0$ and there is $Z \in L^{2}\left(\Omega ; L_{R}\right)$ such that $\lim _{n \rightarrow \infty} E\left(\left\|D F_{n}-Z\right\|_{R}^{2}\right)=0$. We need to prove that $Z=0$ a.s. It is enough to show that $\|Z\|_{\mathcal{H}}^{2}=0$ a.s. Since $\mathcal{H}$ is separable and $C_{0}^{1}$ is dense in $\mathcal{H}$, it is enough to show that $\langle Z, h\rangle_{\mathcal{H}}=0$ a.s. Since $C y l$ is dense in $L^{2}(\Omega)$, we only have to prove that

$$
E\left(\langle Z, h\rangle_{\mathcal{H}} G\right)=0 \forall G \in C y l .
$$

By Corollary 8.6, previous expectation equals

$$
\begin{align*}
& \lim _{n \rightarrow \infty} E\left(\left\langle D F_{n}, h\right\rangle_{\mathcal{H}} G\right) \\
& \quad=\lim _{n \rightarrow \infty}\left(E\left(-F_{n}\langle D G, h\rangle_{\mathcal{H}}\right)+E\left(F_{n} G \int_{0}^{\infty} h d X\right)\right)=0 . \tag{8.9}
\end{align*}
$$

This concludes the proof of the proposition.
We denote by $\left|\mathbb{D}^{1,2}\right|$ the space constituted by $F \in L^{2}(\Omega)$ such that there is a sequence $\left(F_{n}\right)$ of the form (7.3) verifying the following conditions.
i) $F_{n} \longrightarrow F$ in $L^{2}(\Omega)$,
ii) $E\left(\left\|D F_{n}-Z\right\|_{R}^{2}\right) \xrightarrow[n \rightarrow \infty]{\longrightarrow} 0$,
for some $Z \in L^{2}\left(\Omega ; L_{R}\right)$. In agreement with Proposition 8.7, we denote $D F=Z$.
The set $\mathbb{D}^{1,2}$ will stand for the vector subspace of $L^{2}(\Omega)$ constituted by functions $F$ such that there is a sequence $\left(F_{n}\right)$ of the form (7.3) with
i) $F_{n} \longrightarrow F$ in $L^{2}(\Omega)$,
ii) $E\left(\left\|D F_{n}-D F_{m}\right\|_{\mathcal{H}}^{2}\right) \xrightarrow[n, m \rightarrow \infty]{ } 0$.

Note that $\left|\mathbb{D}^{1,2}\right| \subset \mathbb{D}^{1,2} .\left|\mathbb{D}^{1,2}\right|$, equipped with the scalar product

$$
\langle F, G\rangle_{1,2}=E(F G)+E\left(\langle D F, D G\rangle_{R}\right)
$$

is a Hilbert space.
From previous definitions we can easily prove the following.
Proposition 8.8. Let $\left(F_{n}\right)$ be a sequence in $\left|\mathbb{D}^{1,2}\right|$ (resp. $\left.\mathbb{D}^{1,2}\right)$, $F \in L^{2}(\Omega), \mathcal{Y} \in L^{2}\left(\Omega ; L_{R}\right)$ such that

$$
E\left(\left(F_{n}-F\right)^{2}+\left\|D F_{n}-\mathcal{Y}\right\|_{R}^{2}\right) \underset{n \rightarrow \infty}{\longrightarrow} 0
$$

(resp.

$$
\left.E\left(\left(F_{n}-F\right)^{2}+\left\|D\left(F_{n}-F_{m}\right)\right\|_{\mathcal{H}}^{2}\right) \xrightarrow[m, n \rightarrow \infty]{ } 0 .\right)
$$

Then $F \in\left|\mathbb{D}^{1,2}\right|$ and $\mathcal{Y}=D F$ (resp. $F \in \mathbb{D}^{1,2}$ ).
Remark 8.9. If Assumption ( $D$ ) is fulfilled, then $\left|\mathbb{D}^{1,2}\right|=\mathbb{D}^{1,2}$ and

$$
\langle F, G\rangle_{1,2}=E(F G)+E\left(\langle D F, D G\rangle_{\mathcal{H}}\right) .
$$

Remark 8.10. The notation $\left|\mathbb{D}^{1,2}\right|$ does not have the same meaning as in 255. Indeed $\|\cdot\|_{|\mathcal{H}|}$ introduced there is not exactly a norm.

Remark 8.11. By definition of $\mathbb{D}^{1,2}$ the statement of Corollary 8.0 extends to $F, G \in \mathbb{D}^{1,2}$. We have therefore the following

$$
E\left(G\langle D F, h\rangle_{\mathcal{H}}\right)=E\left(-F\langle D G, h\rangle_{\mathcal{H}}\right)+E\left(F G \int_{0}^{\infty} h d X\right)
$$

for every $F, G \in \mathbb{D}^{1,2}, h \in L_{R}$.

Proposition 8.12. Let $f: \mathbb{R} \longrightarrow \mathbb{R}$, be absolutely continuous. Let $\phi \in L_{R}$. We suppose that $f^{\prime}$ is subexponential.

Then $f\left(\int_{0}^{\infty} \phi d X\right) \in \mathbb{D}^{1,2}$ and

$$
D_{r} f\left(\int_{0}^{\infty} \phi d X\right)=f^{\prime}\left(\int_{0}^{\infty} \phi d X\right) \phi(r) .
$$

Remark 8.13. 1. A function $g: \mathbb{R}^{n} \longrightarrow \mathbb{R}$ is said to be subexponential if there is $\gamma>0, c>0$ with $|f(x)| \leq c e^{\gamma|x|}, \forall x \in \mathbb{R}^{n}$.
2. In particular if $f$ is a polynomial, previous result holds.

Proof (of Proposition 8.12) i) We first suppose $f \in C_{b}^{\infty}(\mathbb{R})$. There is a sequence $\phi_{n}$ in $C_{0}^{1}$ such that $\left\|\phi-\phi_{n}\right\| \xrightarrow[n \rightarrow \infty]{ } 0$. Clearly

$$
E\left(f\left(\int_{0}^{\infty} \phi d X\right)-f\left(\int_{0}^{\infty} \phi_{n} d X\right)\right)^{2} \xrightarrow[n \rightarrow \infty]{ } 0
$$

since

$$
\int_{0}^{\infty} \phi_{n} d X \longrightarrow \int_{0}^{\infty} \phi d X
$$

in $L^{2}(\Omega)$ and by Lebesgue dominated convergence theorem. On the other hand

$$
D_{t} f\left(\int_{0}^{\infty} \phi_{n} d X\right)=f^{\prime}\left(\int_{0}^{\infty} \phi_{n} d X\right) \phi_{n}(t), \quad t \geq 0
$$

so

$$
\begin{aligned}
& E\left(\left\|D f\left(\int_{0}^{\infty} \phi_{n} d X\right)-f^{\prime}\left(\int_{0}^{\infty} \phi d X\right) \phi\right\|_{R}^{2}\right) \\
& \leq\left\|\phi-\phi_{n}\right\|_{R}^{2} E\left(f^{\prime}\left(\int_{0}^{\infty} \phi d X\right)^{2}\right)+E\left(f^{\prime}\left(\int_{0}^{\infty} \phi_{n} d X\right)-f^{\prime}\left(\int_{0}^{\infty} \phi d X\right)\right)^{2}\left\|\phi_{n}\right\|_{R}^{2}
\end{aligned}
$$

This converges to zero by usual integration theory arguments. The result for $f \in C_{b}^{\infty}(\mathbb{R})$ follows by Proposition 8.8.
ii) We suppose now that $f^{\prime}$ is subexponential nad let $\phi \in L_{R}$. $\int_{0}^{\infty} \phi d X$ is Gaussian zeromean variable with covariance $\sigma^{2}=\|\phi\|_{R}^{2}$. In fact it is the limit in $L^{2}(\Omega)$ of r.v. of the type $\int_{0}^{\infty} \phi_{n} d X, \phi_{n} \in C_{0}^{1}$. We proceed setting $\tilde{f}_{M}^{\prime}=\left(f^{\prime} \wedge M\right) \vee(-M)$ for $M>0$ and

$$
\tilde{f}_{M}:=f(0)+\int_{0}^{x} \tilde{f}_{M}^{\prime}(y) d y
$$

We also set

$$
f_{M}(x)=\int_{\mathbb{R}} \rho_{\frac{1}{M}}(x-y) \tilde{f}_{M}(y) d y,
$$

where $\rho_{\varepsilon}$ is a sequence of Gaussian mollifiers converging to the Dirac delta function. It is easy to show that

$$
\begin{align*}
& \int_{\mathbb{R}}\left(f_{M}-f\right)^{2}(x) p_{\sigma}(x) d x \underset{M \rightarrow \infty}{ } 0,  \tag{8.10}\\
& \int_{\mathbb{R}}\left(f_{M}^{\prime}-f^{\prime}\right)^{2}(x) p_{\sigma}(x) d x \xrightarrow[M \rightarrow \infty]{ } 0, \tag{8.11}
\end{align*}
$$

where $p_{\sigma}$ is the density related to the Gaussian law $N\left(0, \sigma^{2}\right)$. (8.10) implies that

$$
\left(f_{M}-f\right)\left(\int_{0}^{\infty} \phi d X\right) \longrightarrow 0
$$

in $L^{2}(\Omega)$. By point i) of the running proof we have

$$
D_{r} f^{M}\left(\int_{0}^{\infty} \phi d X\right)=\left(f^{M}\right)^{\prime}\left(\int_{0}^{\infty} \phi d X\right) \phi(r) .
$$

(8.11) implies

$$
E\left(\left\|D . f_{M}\left(\int_{0}^{\infty} \phi d X\right)-f^{\prime}\left(\int_{0}^{\infty} \phi d X\right) \phi\right\|^{2}\right) \underset{M \rightarrow \infty}{ } 0 .
$$

which together with Proposition 8.8 clearly gives the result.
Proposition 8.12 extends to the case, where $f$ depends on more than one variable. The proof is a bit more complicated, but it follows the same idea. Therefore we omit it.

Proposition 8.14. Let $f: \mathbb{R}^{n} \longrightarrow \mathbb{R}$ of class $C^{1}$, with subexponential partial derivatives. Let $\phi_{1}, \ldots, \phi_{n} \in L_{R}$. Then

$$
f\left(\int_{0}^{\infty} \phi_{1} d X, \ldots, \int_{0}^{\infty} \phi_{n} d X\right) \in \mathbb{D}^{1,2}
$$

and

$$
\begin{align*}
& D_{r} f\left(\int_{0}^{\infty} \phi_{1} d X, \ldots, \int_{0}^{\infty} \phi_{n} d X\right) \\
& =\sum_{j=1}^{n} \partial_{j} f\left(\phi_{1} d X, \ldots, \int_{0}^{\infty} \phi_{n} d X\right) \phi_{j}(r) . \tag{8.12}
\end{align*}
$$

We establish some immediate properties of the Malliavin derivative.

Lemma 8.15. Let $F \in C y l, G \in\left|\mathbb{D}^{1,2}\right|$. Then $F \cdot G \in\left|\mathbb{D}^{1,2}\right|$ and (8.8) still holds.

Proof: According to the definition of $\left|\mathbb{D}^{1,2}\right|$, let $\left(G_{n}\right)$ be a sequence in $C y l$ with the following properties.
i) $E\left(G_{n}-G\right)^{2} \xrightarrow[n \rightarrow \infty]{ } 0$,
ii) $E\left(\int_{0}^{\infty}\left(D_{r}\left(G_{n}-G\right)\right)^{2}|R|(d r, \infty)\right) \underset{n \rightarrow \infty}{\longrightarrow} 0$,
iii) $E\left(\int_{\mathbb{R}_{+}^{2}} d|\mu|\left(r_{1}, r_{2}\right)\left(D_{r_{1}}\left(G_{n}-G\right)-D_{r_{2}}\left(G_{n}-G\right)\right)^{2}\right) \xrightarrow[n \rightarrow \infty]{ } 0$.

Since $F \in L^{\infty}(\Omega)$ then $F G_{n} \longrightarrow F G$ in $L^{2}(\Omega)$. Remark 8.5 implies that

$$
D\left(F G_{n}\right)=G_{n} D F+F D G_{n}
$$

It remains to show ii) and iii) for $G_{n}$ (resp. $G$ ) replaced with $F G_{n}$. We only check ii), because iii) follows similarly. If $F$ is of the type (7.3) then

$$
D F=\sum_{i=1}^{m} Z_{i} \phi_{i}
$$

where $\phi_{i} \in L_{R}, Z_{i} \in L^{\infty}(\Omega)$. This implies, by subadditivity, that

$$
\int_{0}^{\infty}|R|(d r, \infty)\left(D_{r} F\right)^{2} \leq 2^{m}\left(\sum_{i=1}^{m}\left\|Z_{i}\right\|_{\infty}^{2} \int_{0}^{\infty} \phi_{i}^{2}(r)|R|(d r, \infty)\right)
$$

Hence

$$
\begin{aligned}
& E\left(\int_{0}^{\infty}|R|(d r, \infty)\left(G_{n}-G\right)^{2}\left(D_{r} F\right)^{2}\right) \\
& \leq E\left(G_{n}-G\right)^{2} \max _{i \in\{1, \ldots, m\}}\left\|Z_{i}\right\|_{\infty}^{2}\left(2^{m} \sum_{i=1}^{m} \int_{0}^{\infty} \phi_{i}^{2}(r)|R|(d r, \infty)\right) \underset{n \rightarrow \infty}{\longrightarrow} 0
\end{aligned}
$$

Moreover, since $F \in L^{\infty}$ and taking into account ii)

$$
E\left(\int_{0}^{\infty}|R|(d r, \infty)\left(F D_{r}\left(G_{n}-G\right)\right)^{2}\right) \underset{n \rightarrow \infty}{ } 0
$$

Hence ii) is proven for $F\left(G_{n}-G\right)$ instead of $G_{n}-G$.
A natural question is the following. Does $X_{t}$ belong to $\mathbb{D}^{1,2}$ for fixed $t$ ? The proposition and corollary below partially answers the question.

Proposition 8.16. If $\psi \in L_{R}$, then $\int_{0}^{\infty} \psi d X \in\left|\mathbb{D}^{1,2}\right|$ and $D_{t}\left(\int_{0}^{\infty} \psi d X\right)=\psi(t)$.
Proof: We consider a sequence $\left(\psi_{n}\right)$ in $C_{0}^{1}(\mathbb{R})$ such that $\left\|\psi-\psi_{n}\right\|_{R} \xrightarrow[n \rightarrow \infty]{ } 0$. We know that $\int_{0}^{\infty} \psi_{n} d X \in C y l$. Obviously

$$
E\left(\int_{0}^{\infty}\left(\psi_{n}-\psi\right) d X\right)^{2}=\left\|\psi-\psi_{n}\right\|_{\mathcal{H}}^{2} \leq\left\|\psi-\psi_{n}\right\|_{R}^{2} \xrightarrow[n \rightarrow \infty]{ } 0
$$

On the other hand

$$
D_{r} \int_{0}^{\infty} \psi_{n} d X=\psi_{n}(r), r>0
$$

so

$$
E\left(\left\|D \int_{0}^{\infty}\left(\psi_{n}-\psi_{m}\right) d X\right\|_{R}^{2}\right)=\left\|\psi_{n}-\psi_{m}\right\|_{R}^{2} \xrightarrow[n, m \rightarrow \infty]{ } 0
$$

Corollary 8.17. If $1_{[0, t]} \in L_{R}$, then $X_{t} \in\left|\mathbb{D}^{1,2}\right|$ and $D X_{t}=1_{[0, t]}$.
Remark 8.18. The conclusion of Corollary 8.1才 holds if Assumptions (C) and (D) hold, see Corollary 6.19.

## 9 About vector valued Malliavin-Sobolev spaces

We suppose here the validity of Assumption (C) and we use the notations introduced in Section 6.4. We denote again $\nu(d t)=|R|(d t, \infty)$.

We will first define $C y l\left(L_{R}\right)$ as the set of smooth cylindrical random elements of the form

$$
u(t)=\sum_{l=1}^{n} \psi_{l}(t) G_{l}, t \in \mathbb{R}_{+},
$$

$G_{l} \in C y l, \psi_{l} \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$. If $u \in \operatorname{Cyl}\left(L_{R}\right)$, we define

$$
\tilde{D}_{s} u(t)=\sum_{l=1}^{n} \psi_{l}(t) D_{s} G_{l}, s, t \geq 0
$$

Clearly $\tilde{D} u=\left(\tilde{D}_{s} u(t)\right)$ belongs to $L_{2, R}$ for each underlying $\omega \in \Omega$.
Remark 9.1. 1. If $u \in \operatorname{Cyl}\left(L_{R}\right)$, it is easy to see that a.s. the paths of $\tilde{D} u$ belong to $L_{R} \otimes L_{R}$.
2. Taking into account Assumption (C), if $u \in \operatorname{Cyl}\left(L_{R}\right)$, then $u(t) \in\left|\mathbb{D}^{1,2}\right|$.
3. By analogous arguments as in Proposition 8.7, is is possible to show that $\tilde{D}: C y l\left(L_{R}\right) \longrightarrow$ $L^{2}\left(L_{2, R}\right)$ is well-defined and closable. This allows to set $Z=\tilde{D} u$, called the Malliavin derivative of process $u$.

Similarly to $\left|\mathbb{D}^{1,2}\right|$ we will define $\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$. We denote $\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$ the vector space of random elements $u: \Omega \longrightarrow L_{R}$ such that there is a sequence $\left(u_{n}\right)$ in $C y l\left(L_{R}\right)$ and
i) $\left\|u-u_{n}\right\|_{R}^{2} \xrightarrow[n \rightarrow \infty]{ } 0$ in $L^{2}(\Omega)$.
ii) There is $Z: \Omega \longrightarrow L_{2, R}$ with $\left\|\tilde{D} u_{n}-Z\right\|_{2, R} \longrightarrow 0$ in $L^{2}(\Omega)$.

We denote $Z$ again by $\tilde{D} u$.
Remark 9.2. i) Let $\left(u_{n}\right)$ be a sequence in $\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|, u \in L^{2}\left(\Omega ; L_{R}\right), Z \in L^{2}\left(\Omega ; L_{2, R}\right)$. If

$$
\lim _{n \rightarrow \infty} E\left(\left\|u-u_{n}\right\|_{R}^{2}+\left\|\tilde{D} u_{n}-Z\right\|_{2, R}^{2}\right)=0
$$

it is not difficult to show that $u \in\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$ and

$$
\tilde{D} u=Z
$$

ii) Let $u_{t}=\psi(t) G$, $t \geq 0 ; G \in \mathbb{D}^{1,2}, \psi \in L_{R}$. Then $u \in\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$. Moreover $\tilde{D}_{r} u(t)=$ $\psi(t) D_{r} G, r \geq 0$. This follows by point i) and the fact that $u$ can be approximated by $u_{t}^{n}=\psi_{n}(t) G_{n}$, where $\psi_{n} \in C_{0}^{1}$ and $G_{n} \in C y l$.

Remark 9.3. 1. $\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$ is a Hilbert space if equipped with the norm $\|\cdot\|$ associated with the inner product

$$
\langle u, v\rangle=E\left(\langle u, v\rangle_{R}+\langle\tilde{D} u, \tilde{D} v\rangle_{2, R}\right)
$$

Moreover $\operatorname{Cyl}\left(L_{R}\right)$ is dense in $\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$.
2. We convene here that

$$
\tilde{D} u:(s, t) \longmapsto \tilde{D}_{s} u(t) .
$$

3. If Assumption $(D)$ is fulfilled, it is possible to show that $\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|=\mathbb{D}^{1,2}\left(L_{R}\right)$, where $\mathbb{D}^{1,2}\left(L_{R}\right)$ is constituted by the vector space of random elements $u: \Omega \longrightarrow L_{R}$ such that there is a sequence $\left(u_{n}\right)$ is $C y l\left(L_{R}\right)$ with the following properties
i) $\left\|u-u_{n}\right\|_{\mathcal{H}}^{2} \xrightarrow[n \rightarrow \infty]{ } 0$ in $L^{2}(\Omega)$.
ii) There is $Z: \Omega \longrightarrow L_{R} \otimes^{h} L_{R}=L_{2, R}$ with

$$
\left\|\tilde{D} u_{n}-Z\right\|_{2, R} \xrightarrow[n \rightarrow \infty]{ } 0
$$

in $L^{2}(\Omega)$.
4. If there is a sequence $u_{n}$ verifying points $i$ ), ii), then it is not difficult to show that $u \in \mathbb{D}^{1,2}\left(L_{R}\right)$. Of course $Z=\tilde{D} u$.

We focus the attention on some technical point. The derivative $\tilde{D}$ of process $(u(t))$ may theoretically not be compatible with the family of derivatives of random variables $u(t)$.

Proposition 9.4. Let $u \in\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$. Then $\nu(d t)$ a.e. $u(t) \in\left|\mathbb{D}^{1,2}\right|$ and

$$
D_{r} u(t)=\tilde{D}_{r} u(t), \nu \otimes \nu \otimes \text { P. a.e. }
$$

Proof: Since $u \in\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$, there is a sequence $u_{n} \in \operatorname{Cyl}\left(L_{R}\right)$ such that $u_{n} \longrightarrow u$ in $\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$. According to $(6.30)$ and Point ii), it follows that

$$
\left.E\left(\int_{0}^{\infty} \nu(d t)\left\|\tilde{D} \cdot u_{n}(t)-\tilde{D} \cdot u(t)\right\|_{R}^{2}\right)\right) \underset{n \rightarrow \infty}{\longrightarrow} 0
$$

Consequently $\nu(d t)$ a.e. we have

$$
E\left(\left\|\tilde{D} \cdot u_{n}(t)-\tilde{D} \cdot u(t)\right\|_{R}^{2}\right) \xrightarrow[n \rightarrow \infty]{ } 0 .
$$

By a similar argument, it follows that

$$
\lim _{n \rightarrow \infty} \int_{0}^{\infty} \nu(d t) E\left(u_{n}(t)-u(t)\right)^{2}=0
$$

We observe that $u_{n}(t) \in C y l$ for every $t \geq 0$. By definition of $\tilde{D}$ on $C y l\left(L_{R}\right)$, we have

$$
\tilde{D} u_{n}(t)=D u_{n}(t) .
$$

Finally the result follows.
From now on we will not distinguish between $D$ and $\tilde{D}$.
A delicate point consists in proving that the process $X \in \mathbb{D}^{1,2}\left(L_{R}\right)$. First we state a lemma.

Lemma 9.5. We suppose Assumption ( $D$ ). Let $g \in C^{1}$ such that there is $T>0$ with $g(t)=g(T), t \geq T$. Then $g \in L_{R}$ and for every $f \in C_{0}^{1}$

$$
\begin{equation*}
\langle f, g\rangle_{R}=\int_{\mathbb{R}_{+}^{2}} f^{\prime}\left(s_{1}\right) g^{\prime}\left(s_{2}\right) R\left(s_{1}, s_{2}\right) d s_{1} d s_{2} \tag{9.1}
\end{equation*}
$$

Proof: We consider a family of functions $\chi^{n}$ in $C_{b}^{\infty}\left(\mathbb{R}_{+}\right)$such that $\chi^{n}=1$ on $[0, n]$ and $\chi^{n}=0$ on $[n+1, \infty]$. We define $g_{n}=g \chi^{n}$. For $n, m, n>m$, we have

$$
\begin{aligned}

& =E\left(\int_{] 0, \infty[2} X_{s_{1}} X_{s_{2}} d\left(g_{n}-g_{m}\right)\left(s_{1}\right) d\left(g_{n}-g_{m}\right)\left(s_{2}\right)\right) \underset{n, m \rightarrow \infty}{ } 0
\end{aligned}
$$

This shows that $g_{n}$ is Cauchy; $g_{n}$ is also Cauchy in $L^{2}(\nu)$. Consequently, there is a subsequence $\left(n_{k}\right)$ such that $g_{n_{k}} \longrightarrow g$ in $L^{2}(d \nu)$. Since $g_{n} \longrightarrow g$ pointwise, then $g \in L_{R}$. By Remark 6.2, we recall that (9.1) holds for every $f, g \in C_{0}^{1}$. Therefore it holds for $f$ and $g_{n}$. Letting $n \longrightarrow \infty$ on both sides, the result follows.

We operate now a restriction on $X$, supposing the existence of $T>0$ with $X_{t}=X_{T}$ if $t \geq T$.

Cauchy-Schwarz implies that

$$
\begin{gathered}
I_{1} \leq \int_{0}^{\infty}|R|(d t, \infty)\left(\int_{0}^{\infty} a^{2}(s, t) d \rho_{s}\right)\left(\int_{0}^{\infty} Y_{u}^{2} d \rho_{u}\right), \\
I_{2} \leq \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(t_{1}, t_{2}\right) \int_{0}^{\infty}\left(a\left(s, t_{1}\right)-a\left(s, t_{2}\right)\right)^{2} d \rho_{s} \int_{0}^{\infty} Y_{s}^{2} d \rho_{s} .
\end{gathered}
$$

Consequently

$$
E\left(I_{1}+I_{2}\right) \leq E\left(\int_{0}^{\infty} Y_{s}^{2} d \rho_{s}\right) \int_{0}^{\infty}\|a(s, \cdot)\|_{R}^{2} d \rho_{s}<\infty .
$$

On the other hand, Bochner integration theory implies

$$
I_{3}+I_{4} \leq \int_{0}^{\infty}\left\|D . Y_{s}\right\|_{R}^{2} d \rho_{s} \int_{0}^{\infty} d \rho_{s}\|a(s, \cdot)\|_{R}^{2}
$$

Taking the expectation it follows

$$
E\left(I_{3}+I_{4}\right)<\infty .
$$

Next result allows to relax the boundedness property on $\|Y\|_{R}$ and $\|D . Y\|_{R}$ required in Proposition 9.14.

Corollary 9.17. Let $\left(d \rho_{t}\right)$ be a finite measure on $\mathbb{R}_{+}, a: \mathbb{R}_{+}^{2} \longrightarrow \mathbb{R}$ be a Borel function. Let $\left(Y_{t}\right)$ be a stochastic process continuous in $\mathbb{D}^{1,2}$ such that

$$
E\left(\int_{0}^{\infty} Y_{t}^{2} d \rho_{t}+\int_{0}^{\infty}\left\|D . Y_{t}\right\|_{R}^{2} d \rho_{t}\right)<\infty
$$

We only suppose i), ii) as in Proposition 9.14. Then the same conclusion as therein holds.
Proof: We use Lemma 9.16 and we approximate $Y$ by $Y^{m}$, where $Y^{m}=\phi^{m}(Y)$ for $\phi=\phi^{m}: \mathbb{R} \longrightarrow \mathbb{R}$ smooth, with

$$
\phi(y)= \begin{cases}y & ,|y| \leq m \\ 0 & ,|y|>m+1 .\end{cases}
$$

Clearly

$$
\begin{equation*}
E\left(\int_{0}^{\infty}\left(Y_{t}-Y_{t}^{m}\right)^{2} d \rho_{t}\right) \xrightarrow[m \rightarrow \infty]{ } 0 \tag{9.43}
\end{equation*}
$$

by Lebesgue's dominated convergence theorem. Moreover Proposition 9.9 implies

$$
D Y^{m}=\phi^{\prime}(Y) D Y,
$$

and of course $\phi$ is smooth, bounded such that

$$
\phi^{\prime}(y)= \begin{cases}1 & ,|y| \leq m \\ 0 & ,|y|>m+1 .\end{cases}
$$

Therefore we have again

$$
D Y^{m}-D Y=D Y\left(1-\phi^{\prime}(Y)\right)
$$

and by similar arguments, we obtain

$$
\begin{equation*}
E\left(\int_{0}^{\infty}\left\|D .\left(Y_{t}^{m}-Y_{t}\right)\right\|_{R}^{2} d \rho_{t}\right) \xrightarrow[m \rightarrow \infty]{ } 0 . \tag{9.44}
\end{equation*}
$$

Finally (9.43), (9.44) and Lemma 9.16 allow to conclude.

## 10 Skorohod integrals

### 10.1 Generalities

We suppose again Assumptions (A), (B), (C) by default. Similarly as in [B] and [32], we will define two natural domains for the divergence operators, i.e. Skorohod integral, which will be in some sense the dual map of the related Malliavin derivative. We denote by $L^{2}\left(\Omega ; L_{R}\right)$ the set of stochastic processes $\left(u_{t}\right)_{t \in[0, T]}$ verifying $E(\|u\|)_{R}^{2}<\infty$. We say that $u \in L^{2}\left(\Omega ; L_{R}\right)$ belongs to $\operatorname{Dom}(\delta)$ if there is a zero-mean square integrable random variable $Z$ such that

$$
\begin{equation*}
E(F Z)=E\left(\langle D F, u\rangle_{\mathcal{H}}\right) \tag{10.1}
\end{equation*}
$$

for every $F \in C y l$. In other words we have

$$
\begin{equation*}
E(F Z)=E\left(\int_{0}^{\infty} R(d s, \infty) D_{s} F u_{s}\right)-E\left(\int_{\mathbb{R}_{+}^{2}} \mu\left(d s_{1}, d s_{2}\right)\left(D_{s_{1}} F-D_{s_{2}} F\right)\left(u_{s_{1}}-u_{s_{2}}\right)\right) \tag{10.2}
\end{equation*}
$$

for every $F \in C y l$. Using the Riesz theorem, we can see that $u \in \operatorname{Dom}(\delta)$ if and only if the map

$$
F \longrightarrow E\left(\langle D F, u\rangle_{\mathcal{H}}\right)
$$

is continuous linear form with respect to $\|\cdot\|_{L^{2}(\Omega)}$. Since $C y l$ is dense in $L^{2}(\Omega), Z$ is uniquely characterized. We will call $Z=\int_{0}^{\infty} u \delta X$ the Skorohod integral of $u$ towards $X$.

We continue investigating general properties of Skorohod integral.
Definition 10.1. If $u 1_{[0, t]} \in \operatorname{Dom}(\delta)$, for any $t \geq 0$, then we define

$$
\int_{0}^{t} u_{s} \delta X_{s}:=\int_{0}^{\infty} u_{s} 1_{[0, t]} \delta X_{s} .
$$

A consequence of the duality formula defining Skorohod integral appears below.
Remark 10.1. If (10.1) holds, then it will be valid by density for every $F \in\left|\mathbb{D}^{1,2}\right|$.
Proposition 10.2. Let $u \in \operatorname{Dom}(\delta), F \in\left|\mathbb{D}^{1,2}\right|$. Suppose $F \int_{0}^{\infty} u_{s} \delta X_{s} \in L^{2}(\Omega)$. Then $F u \in \operatorname{Dom}(\delta)$ and

$$
\int_{0}^{\infty} F u_{s} \delta X_{s}=F \int_{0}^{\infty} u_{s} \delta X_{s}-<D F, u>_{\mathcal{H}}
$$

Proof: The proof is very similar to the one of Proposition 6.4 in [25]. Let $F_{0} \in C y l$. We need to show

$$
E\left(F_{0}\left\{F \int_{0}^{\infty} u_{s} \delta X_{s}-<D F, u>_{\mathcal{H}}\right\}\right)=E\left(<D F_{0}, F u>_{\mathcal{H}}\right)
$$

We proceed using Lemma 8.15, which says that $F_{0} F \in\left|\mathbb{D}^{1,2}\right|$ and (8.8) holds (with $G=F_{0}$ ), together with Remark 10.1, which extends the duality relation.

We state now Fubini's theorem, which allows to interchange Skorohod and measure theory integrals. When $X$ has a covariance measure structure, this was established in [25], Proposition 6.5. When $X$ is a Brownian motion the result is stated in 33].

Proposition 10.3. Let $(G, \mathcal{G}, \lambda)$ be a $\sigma$-finite measure space. Let $u: G \times \mathbb{R}_{+} \times \Omega \longrightarrow \mathbb{R}$ be a measurable random field with the following properties.
i) For every $x \in G, u(x, \cdot) \in \operatorname{Dom}(\delta)$.
ii)

$$
E\left(\int_{G} d \lambda(x)\|u(x, \cdot)\|_{R}^{2}\right)<\infty
$$

iii) There is a measurable version in $\Omega \times G$ of the random field

$$
\left(\int_{0}^{\infty} u(x, t) \delta X_{t}\right)_{x \in G}
$$

iv) It holds that

$$
\int_{G} d \lambda(x) E\left(\int_{0}^{\infty} u(x, t) \delta X_{t}\right)^{2}<\infty
$$

Then $\int_{G} d \lambda(x) u(x, \cdot) \in \operatorname{Dom}(\delta)$ and

$$
\int_{0}^{\infty}\left(\int_{G} d \lambda(x) u(x, \cdot)\right) \delta X_{t}=\int_{G} d \lambda(x)\left(\int_{0}^{\infty} u(x, t) \delta X_{t}\right)
$$

Proof: We will prove two following properties,
a) $\int_{G} d \lambda(x) u(x, \cdot) \in L^{2}\left(\Omega, L_{R}\right)$
b) For every $F \in C y l$ we have

$$
\begin{equation*}
E\left(F\left(\int_{G} d \lambda(x) \int_{0}^{\infty} u(x, \cdot) \delta X_{t}\right)\right)=E\left(\left\langle D F, \int_{G} d \lambda(x) u(x, \cdot)\right\rangle_{\mathcal{H}}\right) \tag{10.3}
\end{equation*}
$$

Without restriction to the generality we can suppose $\lambda$ to be a finite measure. Concerning a), Jensen's inequality implies
$E\left(\left\|\int_{G} d \lambda(x) u(x, \cdot)\right\|_{R}^{2}\right) \leq \lambda(G) E\left(\int_{G} d \lambda(x)\|u(x, \cdot)\|_{R}^{2}\right)=\lambda(G) \int_{G} d \lambda(x)\|u(x, \cdot)\|_{R}^{2}<\infty$ because of ii). For part b), by classical Fubini's theorem, the left-hand side of (10.3) gives

$$
\begin{align*}
& \int_{G} d \lambda(x) E\left(F \int_{0}^{\infty} u(x, t) \delta X_{t}\right)=\int_{G} d \lambda(x) E\left(\langle D F, u(x, \cdot)\rangle_{\mathcal{H}}\right) \\
& =E\left(\int_{G} d \lambda(x)\langle D F, u(x, \cdot)\rangle_{\mathcal{H}}\right) . \tag{10.4}
\end{align*}
$$

This is possible because

$$
\left|\langle D F, u(x, \cdot)\rangle_{\mathcal{H}}\right| \leq\|D F\|_{\mathcal{H}}\|u(x, \cdot)\|_{R} .
$$

(10.4) equals the right-hand side of (10.3) because

$$
\begin{aligned}
& \int_{G} d \lambda(x)\langle D F, u(x, \cdot)\rangle_{\mathcal{H}} \\
& =\int_{G} d \lambda(x)\left(\int_{0}^{\infty} D_{s} F u(x, s) R(d s, \infty)\right. \\
& \left.\quad-\frac{1}{2} \int_{\mathbb{R}_{+}^{2}}\left(D_{s_{1}} F-D_{s_{2}} F\right)\left(u\left(x, s_{1}\right)-u\left(x, s_{2}\right)\right) d \mu\left(s_{1}, s_{2}\right)\right) \\
& =\int_{0}^{\infty} R(d s, \infty) D_{s} F \int_{G} u(x, s) d \lambda(x) \\
& \quad-\frac{1}{2} \int_{\mathbb{R}_{+}^{2}}\left(D_{s_{1}} F-D_{s_{2}} F\right) \int_{G}\left(u\left(x, s_{1}\right)-u\left(x, s_{2}\right)\right) d \lambda(x) d \mu\left(s_{1}, s_{2}\right) .
\end{aligned}
$$

Last equality is possible by means of classical Fubini's theorem and assumption ii). This equals

$$
\left\langle D F, \int_{G} d \lambda(x) u(x, \cdot)\right\rangle
$$

and the proof is concluded.

### 10.2 Malliavin calculus and Hermite polynomials

We introduce here shortly Hermite polynomials. For more information, refer to [33], Section 1.1.1. Those polynomials have the following properties. For every integer $n \geq 1$
i) $n H_{n}(x)=x H_{n-1}(x)-H_{n-2}(x)$,
ii) $H_{n}^{\prime}(x)=H_{n-1}(x)$,
iii) $H_{0}(x) \equiv 1, H_{-1}(x)=0$.

From Proposition 8.12 the following result follows.
Proposition 10.4. Let $h \in L_{R}$.
i) For any $n \geq 1, F:=H_{n}\left(\int_{0}^{\infty} h d X\right) \in \mathbb{D}^{1,2}$ and

$$
D_{t} F=H_{n-1}\left(\int_{0}^{\infty} h d X\right) h(t) .
$$

ii) $F=\exp \left(\int_{0}^{\infty} h d X\right)$. Then $F \in \mathbb{D}^{1,2}$ and

$$
D_{t} F=F h(t) .
$$

We recall that $\left\{H_{k}, k \geq n\right\}$ constitute a basis of the linear span generated by $\left\{1, \ldots, x^{n}\right\}$. We denote by $\mathcal{E}_{\text {Herm }}$ the linear subspace of $L^{2}(\Omega)$ constituted by all finite linear combinations of elements of the type $H_{n}\left(\int_{0}^{\infty} \phi_{n} d X\right), \phi_{n} \in C_{0}^{1}\left(\mathbb{R}_{+}\right), n \in \mathbb{N}$.

Proposition 10.5. $\overline{\mathcal{E}}_{\text {Herm }}=L^{2}(\Omega)$.
Proof: We first observe that

$$
\left\{\exp \left(\int_{0}^{\infty} h d X\right), h \in C_{0}^{1}\left(\mathbb{R}_{+}\right)\right\}
$$

is total in $L^{2}(\Omega)$. The idea is to show that a random variable $F \in L^{2}(\Omega)$, such that $E\left(F \exp \left(\int_{0}^{\infty} h d X\right)\right)=0$ for every $h \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$, fulfills

$$
E\left(F g\left(\int_{0}^{\infty} h_{1} d X, \ldots, \int_{0}^{\infty} h_{n} d X\right)\right)=0
$$

for every $h_{1}, \ldots, h_{n} \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$and $g \in C_{b}^{\infty}\left(\mathbb{R}^{n}\right)$. This can be done adapting the proof of Lemma 1.1.2 of [33].

Let us now consider $F \in L^{2}(\Omega), h \in C_{0}^{1}\left(\mathbb{R}_{+}\right)$such that

$$
\begin{equation*}
E\left(F H_{n}\left(\int_{0}^{\infty} h d X\right)\right)=0, \forall \in \mathbb{N} . \tag{10.5}
\end{equation*}
$$

It remains to show

$$
\begin{equation*}
E\left(F \exp \left(\int_{0}^{\infty} h d X\right)\right)=0 \tag{10.6}
\end{equation*}
$$

By (10.5) it follows obviously that

$$
E\left(F\left(\int_{0}^{\infty} h d X\right)^{n}\right)=0, \forall n \in \mathbb{N}
$$

and consequently (10.6) holds.
We denote by $\mathcal{E}_{n}$ the linear span of $H_{n}\left(\int_{0}^{\infty} \phi d X\right), \phi \in C_{0}^{1}(\mathbb{R}),\|\phi\|_{\mathcal{H}}=1$, and by $\mathcal{H}_{n}$ the closure of $\mathcal{E}_{n}$ in $L^{2}(\Omega)$. We recall that all the considered Wiener integrals are Gaussian random variables. Adapting Theorem 1.1.1 and Lemma 1.1.1 of [33], we obtain the following result.

Proposition 10.6. 1. The spaces $\left(\mathcal{H}_{n}\right)$ are orthogonal.
2. $L^{2}(\Omega)=\oplus_{n=0}^{\infty} \mathcal{H}_{n}$.

We discuss here some technical points related to Malliavin derivative and chaos spaces.

Lemma 10.7. Let $n \geq 1$. The $\operatorname{map} D: \mathcal{E}_{n} \subset L^{2}(\Omega) \longrightarrow L^{2}\left(\Omega ; L_{R}\right)$ verifies the following. For any sequence $\left(F_{k}\right)$ in $\mathcal{E}_{n}$ converging to zero in $L^{2}(\Omega),\left(D F_{k}\right)$ is Cauchy in the sense that

$$
\lim _{k, l \rightarrow \infty} E\left(\left\|D F_{k}-D F_{l}\right\|_{\mathcal{H}}^{2}\right)=0
$$

Proof: The result will follow if, for every $F \in \mathcal{E}_{n}$ we prove

$$
\begin{equation*}
E\left(\|D F\|_{\mathcal{H}}^{2}\right)=n E\left(F^{2}\right) \tag{10.7}
\end{equation*}
$$

Let $F=\sum_{k=1}^{m} H_{n}\left(\int_{0}^{\infty} h_{k} d X\right), h_{k} \in C_{0}^{1}$. Item i) of Proposition 10.4 and Lemma 1.1.1 of [33] imply that

$$
\begin{aligned}
E\left(\|D F\|_{\mathcal{H}}^{2}\right) & =\sum_{k, l=1}^{m} E\left(H_{n-1}\left(\int_{0}^{\infty} h_{k} d x\right) H_{n-1}\left(\int_{0}^{\infty} h_{l} d X\right)\right)\left\langle h_{l}, h_{k}\right\rangle_{\mathcal{H}} \\
& =\sum_{k, l=1}^{m}\left\langle h_{k}, h_{l}\right\rangle_{\mathcal{H}} \frac{1}{(n-1)!}\left\{E\left(\int_{0}^{\infty} h_{k} d X \int_{0}^{\infty} h_{l} d X\right)\right\}^{n-1}
\end{aligned}
$$

In fact $\int_{0}^{\infty} h d X$ is a standard Gaussian random variable. This gives

$$
\frac{1}{(n-1)!} \sum_{k, l=1}^{m}\left\langle h_{k}, h_{l}\right\rangle_{\mathcal{H}}\left\langle h_{k}, h_{l}\right\rangle_{\mathcal{H}}^{n-1}=n \frac{1}{n!} \sum_{k, l=1}^{n}\left\langle h_{k}, h_{l}\right\rangle_{\mathcal{H}}^{n}=n E\left(F^{2}\right)
$$

again by Lemma 1.1.1 of [33].

Corollary 10.8. Let $n \geq 1$.
i) $\mathcal{H}_{n} \subset \mathbb{D}^{1,2}$
ii) If Assumption $(D)$ is verified, then $D: \mathcal{H}_{n} \subset L^{2}(\Omega) \longrightarrow L^{2}\left(\Omega ; L_{R}\right)$ is continuous.
iii) Suppose that Assumption $(D)$ is verified. For every $F \in \mathcal{H}_{n}$, we have $\langle D F, h\rangle_{\mathcal{H}} \in \mathcal{H}_{n-1}$, $\forall h \in L_{R}$.

Proof: i) Let $F \in \mathcal{H}_{n}$ and $\left(F_{k}\right)$ a sequence in $\mathcal{E}_{n}$ converging to $F$ in $L^{2}(\Omega)$. By Lemma 10.7 and Proposition 8.8, $F \in \mathbb{D}^{1,2}$.
ii) It is an obvious consequence of Lemma 10.7.
iii) Let $h \in L_{R}$. By items i) and ii) $T_{h}: \mathcal{H}_{n} \longrightarrow L^{2}(\Omega)$ defined by $T_{h}(F)=\langle D F, h\rangle_{\mathcal{H}}$ is continuous. By Proposition 10.4 i) the image of $\mathcal{E}_{n}$ through $T_{h}$ is included in $\mathcal{H}_{n-1}$. Since $\mathcal{H}_{n-1}$ is a closed subspace of $L^{2}(\Omega)$, the result follows.

Proposition 10.9. We suppose the validity of Assumptions ( $C$ ) and ( $D$ ). Let $F \in \mathbb{D}^{1,2}$, $h \in L_{R}$. Then there is a sequence $\left(F_{n}\right)$ such that $F_{n} \in \mathcal{H}_{n}, h \in L_{R}$,

$$
\begin{gathered}
F=\sum_{n=0}^{\infty} F_{n} \\
\langle D F, h\rangle_{\mathcal{H}}=\sum_{n=1}^{\infty}\left\langle D F_{n}, h\right\rangle_{\mathcal{H}}, \quad \forall h \in L_{R}
\end{gathered}
$$

where the convergence holds in $L^{2}(\Omega)$.
Proof: Let $h \in L_{R}$ and $F=\sum_{n=0}^{\infty} F_{n}$ according to Proposition 10.6. By Corollary 10.8, iii), $\left\langle D F_{m+1}, h\right\rangle_{\mathcal{H}}$ belongs to $\mathcal{H}_{m}$; since $\langle D F, h\rangle_{\mathcal{H}} \in L^{2}(\Omega)$, we need to show that for $m \geq 0$

$$
\begin{equation*}
E\left(\langle D F, h\rangle_{\mathcal{H}} \mathcal{G}_{m}\right)=E\left(\left\langle D F_{m+1}, h\right\rangle_{\mathcal{H}} \mathcal{G}_{m}\right) \tag{10.8}
\end{equation*}
$$

for every $\mathcal{G}_{m} \in \mathcal{H}_{m}$. To prove (10.8), taking into account Corollary 10.8 i) and Remark 8.11, we write

$$
\begin{aligned}
E\left(\langle D F, h\rangle_{\mathcal{H}} \mathcal{G}_{m}\right) & =E\left(F\left\{\mathcal{G}_{m} \int_{0}^{\infty} h d X-\left\langle D \mathcal{G}_{m}, h\right\rangle_{\mathcal{H}}\right\}\right) \\
& =\sum_{n=0}^{\infty} E\left(F_{n}\left\{\mathcal{G}_{m} \int_{0}^{\infty} h d X-\left\langle D \mathcal{G}_{m}, h\right\rangle_{\mathcal{H}}\right\}\right) \\
& =\sum_{n=0}^{\infty} E\left(\left\langle D F_{n}, h\right\rangle_{\mathcal{H}} \mathcal{G}_{m}\right)=E\left(\left\langle D F_{m+1}, h\right\rangle_{\mathcal{H}} \mathcal{G}_{m}\right)
\end{aligned}
$$

### 10.3 Generalized Skorohod integrals and Hermite polynomials

We define now, implementing the idea of [8] and [32], an extension of $\operatorname{Dom}(\delta)$ denoted by $\operatorname{Dom}(\delta)^{*}$. The idea is to use a similar duality relation to (10.2), but keeping in mind that an element $u$ of $\operatorname{Dom}(\delta)^{*}$ will not necessarily live in $L^{2}\left(\Omega ; L_{R}\right)$. We denote by $\mathcal{L}^{2}$ the space of processes $\left(u_{t}\right)_{t \geq 0}$ with

$$
E\left(\int_{0}^{\infty} u_{s}^{2}|R|(d s, \infty)+\int_{0}^{\infty}\left|u_{s}\right|^{2} \bar{m}(d s)\right)<\infty
$$

where $\bar{m}$ is the marginal measure of $|\bar{\mu}|$.
We will denote by $\mathcal{M}$ the linear space of Borel functions $f: \mathbb{R}_{+} \longrightarrow \mathbb{R}$ such that

$$
\begin{equation*}
\|f\|_{\mathcal{M}}:=\int_{0}^{\infty} f^{2}(s)|R|(d s, \infty)+\int_{\mathbb{R}_{+}^{2}}\left(f\left(s_{1}\right)-f\left(s_{2}\right)\right)^{2}|\bar{\mu}|\left(d s_{1}, d s_{2}\right)<\infty . \tag{10.9}
\end{equation*}
$$

Remark 10.10. 1. Obviously $\|\cdot\|_{\mathcal{M}} \leq\|\cdot\|_{R}$ and so $\tilde{L}_{R} \subset \mathcal{M}$.
2. $\mathcal{M}$ is complete (therefore it is a Hilbert space) because of Assumption (C). The argument is similar to the one used in proof of Proposition 6.14.
3. Expanding the second integral of (10.9) and applying Cauchy-Schwarz, we can show that $\mathcal{L}^{2} \subset \mathcal{M}$.

Definition 10.2. A process $u \in L^{2}(\Omega ; \mathcal{M})$ is said to belong to $\operatorname{Dom}(\delta)^{*}$ if there is a square integrable r.v. $Z \in L^{2}(\Omega)$ such that

$$
\begin{align*}
E(F Z) & =E\left(\int_{0}^{\infty} R(d s, \infty) D_{s} F u_{s}\right. \\
& \left.-\int_{\mathbb{R}_{+}^{2}} \mu\left(d s_{1}, d s_{2}\right)\left(\left(D_{s_{1}} F-D_{s_{2}} F\right)\left(u_{s_{1}}-u_{s_{2}}\right)\right)\right) \tag{10.10}
\end{align*}
$$

for any $F=H_{n}\left(\int_{0}^{\infty} h d X\right), h \in C_{0}^{1}, n \geq 0$.
Remark 10.11. 1. If $u \in \operatorname{Dom}(\delta)^{*}$ then (10.19) holds by linearity for every $F \in \mathcal{E}_{\text {Herm }}$.
2. Since $\mathcal{E}_{\text {Herm }}$ is dense in $L^{2}(\Omega), Z$ is uniquely determined. $Z$ will be called the $*-$ Skorohod integral of $u$ with respect to $X$, it will be denoted $\int_{0}^{\infty} u_{s} \delta^{*} X_{s}$.
3. The right-hand side of (10.10) is well-defined for any $u \in L^{2}(\Omega, \mathcal{M})$ and $F=f\left(\int_{0}^{\infty} \varphi_{1} d X, \ldots, \int_{0}^{\infty} \varphi_{n} d X\right), \varphi_{1}, \ldots, \varphi_{n} \in C_{0}^{1}\left(\mathbb{R}_{+}\right), f \in C_{p o l}^{1}\left(\mathbb{R}^{n}\right)$, in particular for $F$ as in Definition 10.g. We observe that in this case $F^{i}=\partial_{i} f\left(\int_{0}^{\infty} \varphi_{1} d X, \ldots, \int_{0}^{\infty} \varphi_{n} d X\right)$, $1 \leq i \leq n$, is a square integrable random variable.

Indeed, we only discuss the second addend of the right-hand side of (10.10), since the first one is obviously meaningful.
This is bounded by

& =\sum_{j=1}^{n} E\left(\int_{\mathbb{R}_{+}^{2}}|\mu|\left(d s_{1}, d s_{2}\right)\left|F^{i}\left(\varphi_{j}\left(s_{1}\right)-\varphi_{j}\left(s_{2}\right)\right)\left(u_{s_{1}}-u_{s_{2}}\right)\right|\right) \\
& \leq \sum_{j=1}^{n}\left\|\varphi_{j}^{\prime}\right\|_{\infty}\left(\int_{\mathbb{R}_{+}^{2}}|\bar{\mu}|\left(d s_{1}, d s_{2}\right)\left|u_{s_{1}}-u_{s_{2}}\right| F^{j}\right) \\
& \leq \sum_{j=1}^{n}\left\|\varphi_{j}^{\prime}\right\|_{\infty} \sqrt{E\left(F^{j}\right)^{2} E\left(\int_{\mathbb{R}_{+}^{2}}|\bar{\mu}|\left(d s_{1}, d s_{2}\right)\left|u_{s_{1}}-u_{s_{2}}\right|\right)^{2}} \\
& \leq \sum_{j=1}^{n}\left\|\varphi_{j}^{\prime}\right\|_{\infty}\left\|F^{j}\right\|_{L^{2}(\Omega)} \sqrt{|\bar{\mu}|\left(\mathbb{R}_{+}^{2}\right)} E\left(\int_{\mathbb{R}_{+}^{2}}|\bar{\mu}|\left(d s_{1}, d s_{2}\right)\left|u_{s_{1}}-u_{s_{2}}\right|^{2}\right)
\end{aligned}
$$

If $u \in L^{2}(\Omega ; \mathcal{M})$, then previous quantity is finite.
Proposition 10.12. $\operatorname{Dom}(\delta) \subset \operatorname{Dom}(\delta)^{*}$.
Proof: Let $u \in \operatorname{Dom}(\delta), Z=\int_{0}^{\infty} u \delta X$. First of all $u \in L^{2}(\Omega ; \mathcal{M})$ since $\|u\|_{\mathcal{M}} \leq$ $\|u\|_{R}$. For any $F \in C y l$ we have

If $\left(f^{M}\right)$ is such a sequence, setting $F^{M}=f^{M}\left(\int_{0}^{\infty} h d X\right)$ and taking into account Proposition 8.12, we clearly obtain

This implies in particular that (10.11) holds for $F$ of the type $H_{n}\left(\int_{0}^{\infty} h d X\right)$, where $n \geq 0$, $h \in C_{0}^{1}$. For such an element, the right-hand side of (10.11) coincides with the right-hand side of $(10.10)$ and the result follows.

## 11 It formula in the very singular case

We suppose again Assumptions (A), (B), (C) by default. We start with a technical observation.

Lemma 11.1. Let $\left(G_{1}, G_{2}\right)$ be a Gaussian vector such that $\operatorname{Var} G_{2}=1$. Let $f \in C^{1}(\mathbb{R})$ such that $f^{\prime}$ is subexponential. Then

n E\left(f\left(G_{1}\right) H_{n}\left(G_{2}\right)\right)=E\left(f^{\prime}\left(G_{1}\right) H_{n-1}\left(G_{2}\right)\right) \operatorname{Cov}\left(G_{1}, G_{2}\right)

Remark 11.2. It follows in particular that $E\left(H_{n}\left(G_{2}\right)\right)=0, \forall n \geq 1$.
Proof: According to relation i) about Hermite polynomials, the left-hand side equals $I_{1}-I_{2}$, where

& I_{1}=E\left(f\left(G_{1}\right) G_{2} H_{n-1}\left(G_{2}\right)\right. \\
& I_{2}=E\left(f\left(G_{1}\right) H_{n-2}\left(G_{2}\right)\right.

According to Wick theorem, recalled briefly in Lemma 11.3 below, $I_{1}$ gives.

Using relation ii) about Hermite polynomials, we have

The lemma below was recalled and for instance proved in 12.
Lemma 11.3. (Wick) Let $\underline{Z}=\left(Z_{1}, \ldots, Z_{N}\right)$ be a zero-mean Gaussian vector, $\phi \in C^{1}\left(\mathbb{R}^{N}, \mathbb{R}\right)$ such that the derivatives are subexponential. Then for $1 \leq l \leq N$, we have

Applying Lemma 11.1 iteratively, it is possible to show the following.
Proposition 11.4. Let $f \in C^{n+2}(\mathbb{R})$, such that $f^{(n+2)}$ is subexponential. Let $\left(G_{1}, G_{2}\right)$ be a Gaussian vector such that $\operatorname{Var}\left(G_{2}\right)=1$. We have the following.
a) $n!E\left(f\left(G_{1}\right) H_{n}\left(G_{2}\right)\right)=E\left(f^{(n)}\left(G_{1}\right)\right) \operatorname{Cov}\left(G_{1}, G_{2}\right)^{n}$,
b) $(n-1)!E\left(f^{\prime}\left(G_{1}\right) H_{n-1}\left(G_{2}\right)\right)=E\left(f^{(n)}\left(G_{1}\right)\right) \operatorname{Cov}\left(G_{1}, G_{2}\right)^{n-1}$,
c) $\left.n!E\left(f^{\prime \prime}\left(G_{1}\right) H_{n}\left(G_{2}\right)\right)=E\left(f^{(n+2)}\left(G_{1}\right)\right) \operatorname{Cov}\left(G_{1}, G_{2}\right)^{n}\right)$.

Let $\left(X_{t}\right)$ be a process such that $1_{[0, t]} \in L_{R}$ and $X_{t}=\int_{0}^{\infty} 1_{[0, t]} d X$ for every $t \geq 0$. We recall that under Assumption (D) this is always verified.

We denote $\gamma(t)=\operatorname{Var}\left(X_{t}\right)$.
Remark 11.5. a) $R(t, \infty)=\operatorname{Var}\left(X_{t}\right)-\operatorname{Cov}\left(X_{t}, X_{\infty}-X_{t}\right)$
b) $t \longrightarrow \operatorname{Var}\left(X_{t}\right)$ has locally bounded variation if and only if $t \longrightarrow \operatorname{Cov}\left(X_{t}, X_{\infty}-X_{t}\right)$ has locally bounded variation.

Remark 11.6. It is not easy to find general conditions so that $t \longrightarrow \gamma(t)$ has locally bounded variation even though this condition is often realized. We give for the moment some examples.

1. If $X$ has a convergence measure structure $\gamma$ has always bounded variation, see [2耳], Lemma 8.12.
2. If $X_{t}=\tilde{X}_{t \wedge T}$, and $\left(\tilde{X}_{t}\right)$ is a process with weak stationary increments, then $\gamma(t)=Q(t)$ has always bounded variation, under for instance the assumptions of Proposition 4.6.
3. 

$$
X_{t}=\int_{0}^{t} G(t-s) d W_{s}, G \in L_{l o c}^{2}(\mathbb{R}) .
$$

In this case $\gamma(t)=\int_{0}^{t} G^{2}(u) d u$, which is increasing and therefore locally of bounded variation.
4. In all explicit examples considered until now, e.g. fractional Brownian motion, bifractional Brownian motion, then $\gamma$ has locally bounded variation.

We can now state the Itô's formula in the singular case. We recall that from the beginning we suppose $E\left(X_{t}\right)=0, \forall t \geq 0$.

Proposition 11.7. We denote $\gamma(t)=\operatorname{Var}\left(X_{t}\right)$, which is supposed to have locally bounded variation. Let $f: \mathbb{R} \longrightarrow \mathbb{R}$ of class $C_{b}^{\infty}$. Then $f^{\prime}(X) 1_{[0, t]}$ belongs to Dom $(\delta)^{*}$ and

\int_{0}^{t} f^{\prime}\left(X_{s}\right) 1_{[0, t]}(s) \delta^{*} X_{s}=f\left(X_{t}\right)-f\left(X_{0}\right)-\frac{1}{2} \int_{0}^{t} f^{\prime \prime}\left(X_{s}\right) d \gamma_{s}
$$

Proof (of Proposition 11.7): We proceed similarly to [8] and [32]. We first observe that

belongs to $\mathcal{L}^{2} \subset \mathcal{M}$, for every bounded function $g$. In particular this is true for $g=f^{\prime}$. Moreover

belongs to $L^{2}(\Omega)$, since $f$ has linear growth, $f^{\prime \prime}$ is bounded and $X$ is square integrable. In agreement with (10.10) for $u_{s}=f^{\prime}\left(X_{s}\right) 1_{[0, t]}(s)$ we have to prove that for any $F$ of the type $H_{n}\left(\int_{0}^{\infty} \phi d X\right), \phi \in C_{0}^{1}, n \geq 0$.

E\left(F Z_{f}\right) & =\int_{0}^{t} R(d s, \infty) E\left(D_{s} F f^{\prime}\left(X_{s}\right)\right) \\
& -\int_{\mathbb{R}_{+}^{2}} \mu\left(d s_{1}, d s_{2}\right) E\left(\left(f^{\prime}\left(X_{s_{1}}\right) 1_{[0, t]}\left(s_{1}\right)-f^{\prime}\left(X_{s_{2}}\right) 1_{[0, t]}\left(s_{2}\right)\right)\left(D_{s_{1}} F-D_{s_{2}} F\right)\right) \tag{11.1}
\end{align*}

Without restriction to generality we suppose $\|\phi\|_{\mathcal{H}}=1$. In this case by Proposition 8.12, we have

in the sense of measures. Let $\alpha \in C_{0}^{\infty}(\mathbb{R})$ be a test function. With help of classical Lebesgue-Stieltjes integration theory, we have

& \left.\left.=\int_{0}^{\infty} \alpha(t)\left(\int_{\mathbb{R}} d y f^{(n)}(y) \frac{\partial p}{\partial \sigma}\left(\gamma_{t}, y\right)\right)\right) d \gamma_{t}=\int_{0}^{\infty} \alpha(t)\left(\int_{\mathbb{R}} d y f^{(n)}(y) \frac{1}{2} \frac{\partial^{2}}{\partial y^{2}} p\left(\gamma_{t}, y\right)\right)\right) d \gamma_{t} \\
& \left.=\int_{0}^{\infty} \alpha(t)\left(\int_{\mathbb{R}} d y f^{(n+2)}(y) p\left(\gamma_{t}, y\right)\right)\right) \frac{d \gamma_{t}}{2}=\int_{0}^{\infty} \frac{d \gamma_{t}}{2} \alpha(t) E\left(f^{(n+2)}\left(\sqrt{\gamma_{t}} N\right)\right) \\

c) $E\left(H_{n}\left(\int_{0}^{\infty} \phi d X\right) f^{\prime \prime}\left(X_{s}\right)\right)=\frac{1}{n!} E\left(f^{(n+2)}\left(X_{s}\right)\right)\left\langle 1_{[0, s]}, \phi\right\rangle_{\mathcal{H}}^{n}$

Similarly to [8] , Lemma 4.3, we evaluate, as a measure,

\int_{0}^{\infty} g(s) \phi(s) R(d s, \infty)+\int_{0}^{\infty} g(s) d m_{\phi}(s)=\int_{0}^{\infty} g(s) d<1_{[0,]}, \phi>_{\mathcal{H}}(s)
$$

At this point (11.1) is established for every $F=H_{n}\left(\int_{0}^{\infty} \phi d X\right),\|\phi\|_{\mathcal{H}}=1$. If $\|\phi\|=0$ then (11.2) holds trivially. If $\|\phi\|_{\mathcal{H}}=\sigma>0$ then (11.1) with $\|\phi\|_{\mathcal{H}}=1$ can be extended to this case replacing $X$ with $\sigma X$.

## 12 Wiener and Skorohod integrals

If the integrand is deterministic, the Wiener integral equals Skorohod integral as Proposition 12.1 below shows. We list here some properties, whose proof is very close to the one of 25], where we supposed that $X$ has a covariance measure structure. We suppose Assumptions (A), (B), (C) by default.

Proposition 12.1. Let $h \in L_{R}$. Then $h \in \operatorname{Dom}(\delta)$ and

$$
\int_{0}^{\infty} h \delta X=\int_{0}^{\infty} h d X .
$$

Proof: It follows from Proposition 8.4 and the definition of Skorohod integral.
Proposition 12.2. Let $u \in \operatorname{Cyl}\left(L_{R}\right)$. Then $u \in \operatorname{Dom}(\delta)$ and $\int_{0}^{\infty} u \delta X \in L^{p}(\Omega), \forall p \geq 1$.
Proof: Let $u=G \psi, \psi \in L_{R}, G \in C y l$. Proposition 12.1 says that $\psi \in \operatorname{Dom}(\delta)$. Applying Proposition 10.2 with $F=G, u=\psi$, it follows that $\psi G \in \operatorname{Dom}(\delta)$ and

$$
\int_{0}^{\infty} u \delta X=G \int_{0}^{\infty} \psi \delta X-\langle\psi, D G\rangle_{\mathcal{H}}
$$

Making explicit previous equality when $G=g\left(Y_{1}, \ldots, Y_{n}\right)$, where $g \in C_{0}^{\infty}\left(\mathbb{R}^{n}\right), Y_{j}=$ $\int_{0}^{\infty} \varphi_{j} d X, 1 \leq j \leq n$, then

$$
\begin{equation*}
\int_{0}^{\infty} u \delta X=g\left(Y_{1}, \ldots, Y_{n}\right) \int_{0}^{\infty} \psi d X-\sum_{j=1}^{n}\left\langle\varphi_{j}, \psi\right\rangle_{\mathcal{H}} \partial_{j} g\left(Y_{1}, \ldots, Y_{n}\right) . \tag{12.1}
\end{equation*}
$$

The right-hand side belongs obviously to each $L^{p}$ since $Y_{j}$ is a Gaussian random variable and $g, \partial_{j} g$ are bounded. The final result for $u \in \operatorname{Cyl}\left(L_{R}\right)$ follows by linearity.

Remark 12.3. (12.1) provides an explicit expression of $\int_{0}^{\infty} u \delta X$, if $u \in C y l\left(L_{R}\right)$.
Next result concerns the commutation property of the derivative and Skorohod integral. First we observe that $\left(D_{t} F\right) \in \operatorname{Dom}(\delta)$ if $F \in \operatorname{Cyl}$. Moreover, if $u \in \operatorname{Cyl}\left(L_{R}\right)$, $\left(D_{s} u_{t}\right)$ belongs to $\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$. Closely to Proposition 7.3 of 25] and to [33, Chapter 1, (1.46) we can prove the following result.

Proposition 12.4. Let $u \in \operatorname{Cyl}\left(L_{R}\right)$. Then

\int_{0}^{\infty} u \delta X \in\left|\mathbb{D}^{1,2}\right|
$$

and for every $t$

D_{t}\left(\int_{0}^{\infty} u \delta X\right)=u_{t}+\int_{0}^{\infty}\left(D_{t} u_{s}\right) \delta X .
$$

We can now evaluate the $L^{2}(\Omega)$-norm of the Skorohod integral.

Proposition 12.5. Let $u \in\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$. Then $u \in \operatorname{Dom}(\delta), \int_{0}^{\infty} u \delta X \in L^{2}(\Omega)$ and

& E\left(\int_{0}^{\infty} u \delta X\right)^{2}=E\left(\|u\|_{\mathcal{H}}^{2}\right) \\
& \quad-\frac{1}{2} E\left(\int_{\mathbb{R}_{+}} d \mu\left(t_{1}, t_{2}\right)\left\langle D \cdot\left(u_{t_{1}}-u_{t_{2}}\right),\left(D_{t_{1}}-D_{t_{2}}\right) u .\right\rangle_{\mathcal{H}}\right)  \tag{12.2}\\
& \quad+E\left(\int_{0}^{\infty} R(d t, \infty)\left\|D_{t} u \cdot\right\|_{\mathcal{H}}^{2}\right)
\end{align*}
$$

Moreover

$$
\begin{align*}
& E\left(\int_{0}^{\infty} u \delta X\right)^{2} \\
& \leq E\left(\|u\|_{R}^{2}+\int_{\mathbb{R}_{+}} d|R|(d t, \infty)\left\|D_{t} u^{2}\right\|_{R}+\frac{1}{2} \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(s_{1}, s_{2}\right)\left\|D \cdot u_{s_{1}}-D \cdot u_{s_{2}}\right\|_{R}^{2}\right) \tag{12.3}
\end{align*}
$$

Remark 12.6. We denote $\left(D^{1} u\right)(s, t)=D_{t} u_{s},(D u)(s, t)=D_{s} u_{t}, s, t \geq 0$.
i) The right-hand side of (12.7) can be written as

E\left(\|u\|_{\mathcal{H}}^{2}+\left\langle D u, D^{1} u\right\rangle_{\mathcal{H} \otimes \mathcal{H}}\right)
$$

ii) The right-hand side of (12.3) can be written as

E\left(\|u\|_{R}^{2}+\|D u\|_{2, R}^{2}\right) .
$$

Proof (of Proposition 12.5): Let $u \in \operatorname{Cyl}\left(L_{R}\right)$. By Proposition 12.4, $\int_{0}^{\infty} u \delta X \in$ $\left|\mathbb{D}^{1,2}\right|$ and we get

& -\frac{1}{2} E\left(\int_{\mathbb{R}_{+}^{2}}\left(u_{s_{1}}-u_{s_{2}}\right)\left(D_{s_{1}}-D_{s_{2}}\right)\left(\int_{0}^{\infty} u \delta X\right) \mu\left(d s_{1}, d s_{2}\right)\right) \\
& =E_{1}-\frac{1}{2} E_{2}
\end{aligned}
$$

where

\begin{aligned}
& E_{1}=E\left(R(d t, \infty) u_{t}^{2}+\int_{0}^{\infty} u_{t}\left(\int_{0}^{\infty}\left(D_{t} u_{r}\right) \delta X_{r}\right) R(d t, \infty)\right) \\
& E_{2}=E\left(\int_{\mathbb{R}_{+}^{2}} \mu\left(d t_{1}, d t_{2}\right)\left(u_{t_{1}}-u_{t_{2}}\right)^{2}+\int_{\mathbb{R}_{+}^{2}} \mu\left(d t_{1}, d t_{2}\right)\left(u_{t_{1}}-u_{t_{2}}\right) \int_{0}^{\infty}\left(D_{t_{1}}-D_{t_{2}}\right) u_{r} \delta X_{r}\right)
\end{aligned}
$$

Consequently

& E_{1}-\frac{1}{2} E_{2}=E\left(\|u\|_{\mathcal{H}}^{2}\right)+\int_{0}^{\infty} R(d t, \infty) E\left(u_{t} \int_{0}^{\infty} D_{t} u_{r} \delta X_{r}\right) \\
& -\frac{1}{2} \int_{\mathbb{R}_{+}^{2}} \mu\left(d t_{1}, d t_{2}\right) E\left(\left(u_{t_{1}}-u_{t_{2}}\right) \int_{0}^{\infty}\left(D_{t_{1}}-D_{t_{2}}\right) u_{r} \delta X_{r}\right)
\end{aligned}
$$

Using again the duality relation of Skorohod integral, we obtain

& \left.\quad-\frac{1}{2} \int_{\mathbb{R}_{+}^{2}} d \mu\left(t_{1}, t_{2}\right)\left\langle D \cdot\left(u_{t_{1}}-u_{t_{2}}\right),\left(D_{t_{1}}-D_{t_{2}}\right) u \cdot\right\rangle_{\mathcal{H}}\right) .
\end{aligned}
$$

This proves (12.2) and the result for $u \in C y l\left(L_{R}\right)$. (12.3) is then a consequence of CauchySchwarz with respect to the inner product $\langle\cdot, \cdot\rangle_{\mathcal{H}}$ and the fact that the norm $\|\cdot\|_{R}$ (resp. $\|\cdot\|_{2, R}$ ) dominates $\|\cdot\|_{\mathcal{H}}\left(\right.$ resp. $\left.\|\cdot\|_{\mathcal{H} \otimes \mathcal{H}}\right)$. The general result for $u \in\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$ follows because $\operatorname{Cyl}\left(L_{R}\right)$ is dense in $\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$.

## 13 Link between symmetric and Skorohod integral

We wish now to establish a relation between the symmetric integral via regularization and Skorohod integral. We recall that, in most of our examples, forward integrals do not exist. If $X=B$ is a fractional Brownian motion with Hurst parameter $H<\frac{1}{2}$, then $X$ is not of finite quadratic variation, therefore $\int_{0}^{0} X d^{-} X$ does not exist, see Introduction.

We suppose here again the validity of Assumptions (A), (B), (C) and $X_{t}=X_{T}$, $t \geq T$. We first need a technical lemma.

Lemma 13.1. Let $Y \in\left|\mathbb{D}^{1,2}\left(L_{R}\right)\right|$ cadlag. For $\varepsilon>0$, we set

$$
Y_{t}^{\varepsilon}=\frac{1}{2 \varepsilon} \int_{(t-\varepsilon)^{+}}^{(t+\varepsilon) \wedge T} Y_{s} d s
$$

We suppose next the validity of next hypothesis.
Hypothesis $\boldsymbol{T} \boldsymbol{R}$ We set $\nu(d t)=|R|(d t, \infty)$

1. For every $t \geq 0, Y_{t} \in \mathbb{D}^{1,2}$.
2. $t \longmapsto Y_{t}$ is continuous and bounded in $\mathbb{D}^{1,2}$. In particular $t \longmapsto Y_{t}$ is continuous and bounded in $L^{2}, t \longmapsto D Y_{t}$ is continuous, bounded in $L^{2}\left(\Omega ; L_{R}\right)$.
3. For $r \in \mathbb{R}$ sufficiently small, $t \longrightarrow Y_{t+r}$ belongs to $\mathbb{D}^{1,2}\left(L_{R}\right)$ and $r \longmapsto Y_{+r}$ is continuous in $\mathbb{D}^{1,2}\left(L_{R}\right)$ at $r=0$. In particular $r \longmapsto Y_{+r}$ is continuous in $L^{2}\left(\Omega ; L_{R}\right)$ and $r \longmapsto D . Y_{+r}$ is continuous in $L^{2}\left(\Omega ; L_{2, R}\right)$ at $r=0$.

Then $Y^{\varepsilon}$ converges to $Y$ in $\mathbb{D}^{1,2}\left(L_{R}\right)$.
Proof: We set $a(s, t)=1_{\left[(t-\varepsilon)^{+},(t+\varepsilon) \wedge T\right]}(s), \rho_{t}=(t+\varepsilon) \wedge T$. By Hypothesis TR and Corollary 6.19, $a(s, \cdot) \in L_{R}$ for every $s \geq 0$. Hence Assumptions i), ii) of Proposition 9.14 are verified. By Hypothesis TR 2., Assumption iii) of the same Proposition 9.14 is also valid. Consequently $Y_{t}^{\varepsilon}=\frac{1}{2 \varepsilon} \int_{0}^{\infty} a(s, t) Y_{s} d \rho_{s}$ defines a process in $\mathbb{D}^{1,2}\left(L_{R}\right)$. Moreover

$$
\begin{equation*}
D_{r} Y_{t}^{\varepsilon}=\frac{1}{2 \varepsilon} \int_{(t-\varepsilon)^{+}}^{(t+\varepsilon) \wedge T} d s D_{r} Y_{s} . \tag{13.1}
\end{equation*}
$$

We need to prove the following

$$
\begin{align*}
E\left(\left\|Y-Y^{\varepsilon}\right\|_{R}^{2}\right) & \xrightarrow[\varepsilon \rightarrow 0]{\longrightarrow} 0,  \tag{13.2}\\
E\left(\left\|D\left(Y-Y^{\varepsilon}\right)\right\|_{2, R}^{2}\right) & \xrightarrow[\varepsilon \rightarrow 0]{\longrightarrow} 0 . \tag{13.3}
\end{align*}
$$

1) The left hand-side of (13.2), using Bochner integration properties and Jensen's inequality, is bounded by

\frac{1}{2 \varepsilon} \int_{(-\varepsilon)^{+}}^{\varepsilon} d r E\left(\left\|Y_{s+r}-Y_{s}\right\|_{R}^{2}\right) . \tag{13.4}
\end{equation*}

By Hypothesis TR 3. $\lim _{r \rightarrow 0} E\left(\left\|Y_{+r}-Y \cdot\right\|_{R}\right)^{2}=0$ and (13.4) converges to zero.
Again by Bochner integration properties and Jensen's inequality the left-hand side of (13.3) is bounded by

\frac{1}{2 \varepsilon} \int_{(-\varepsilon)^{+}}^{\varepsilon} d r E\left(\left\|D \cdot Y_{\cdot+r}-D Y\right\|_{2, R}^{2}\right)
$$

Again this converges to zero since $r \longmapsto D . Y_{+r}$ is continuous in $L_{2, R}$.
Hypothesis TR is quite technical. We provide a very important example, which is constituted by $Y=g(X)$, for suitable real functions $g$. Before treating this we need a preliminary lemma which looks similar, but is significantly different from Corollary 9.10.

Lemma 13.2. Let $g \in C_{b}^{2}(\mathbb{R})$. Then $Y_{t}=g\left(X_{t}\right)$ belongs to $\mathbb{D}^{1,2}$ and

$$
\begin{equation*}
D_{r} Y_{t}=g^{\prime}\left(X_{t}\right) 1_{[0, t]}(r), \quad t \geq 0 \tag{13.5}
\end{equation*}
$$

Moreover the assumptions of Lemma 9.13 are verified with $\rho(t)=t$.
Proof: i) By Assumption (D) $1_{[0, t]} \in L_{R}$ because of Corollary 6.19. Hence the first part and (13.5) follow by Proposition 8.12.
ii) We continue verifying the assumption of Lemma 9.13. $Y$ is continuous in $L^{2}$ because $Y$ is pathwise continuous and $\left(Y_{t}\right)_{t \leq T}$ is uniformly integrable. Indeed $g$ has linear growth and $X$ is Gaussian, so there is constant const. with

$$
\sup _{t \leq T} E\left(g\left(X_{t}\right)\right)^{4} \leq \text { const. }\left(1+\left(\sup _{t \geq 0} \operatorname{Var} X_{t}\right)^{2}\right)
$$

$Y$ is bounded in $L^{2}$ since $X$ by similar arguments as above $\left(g^{\prime}\left(X_{t}\right)\right)$ is continuous in $L^{2}$. Let now $t_{2}>t_{1}>0$. It follows that

\left\|D \cdot Y_{t_{2}}-D \cdot Y_{t_{1}}\right\|_{R}^{2} & \leq\left(g^{\prime}\left(X_{t_{2}}\right)^{2}\right)\left\|1_{] t_{1}, t_{2}\right]}\right\|_{R}^{2}+\left(g^{\prime}\left(X_{t_{2}}\right)-g^{\prime}\left(X_{t_{1}}\right)\right)^{2}\left\|1_{\left[0, t_{1}\right]}\right\|_{R}^{2} \\
& =2 g^{\prime}\left(X_{t_{2}}\right)^{2} \operatorname{Var}\left(X_{t_{2}}-X_{t_{1}}\right)+2\left(g^{\prime}\left(X_{t_{2}}\right)-g^{\prime}\left(X_{t_{1}}\right)\right)^{2} \operatorname{Var}\left(X_{t_{1}}\right)
\end{aligned}
$$

Since $X$ and $g^{\prime}(X)$ are continuous in $L^{2}$ and $g^{\prime}$ has linear growth, we obtain that $t \longmapsto D . Y_{t}$ is continuous in $L^{2}$. By similar arguments $t \longmapsto\left\|D Y_{t}\right\|_{R}^{2}$ is also bounded. This concludes the proof of the Lemma 13.2 .

We go on with another step in the investigation between symmetric and Skorohod integral.

Proposition 13.3. Together with the assumptions mentioned at the beginning of Section 13, we suppose

\int_{\mathbb{R}_{+}^{2}} \sup _{r \in\left[-\varepsilon_{0}, \varepsilon_{0}\right]} \operatorname{Var}\left(X_{s_{1}+r}-X_{s_{2}+r}\right) d|\mu|\left(s_{1}, s_{2}\right)<\infty \tag{13.6}
\end{equation*}
$$

for some $\varepsilon_{0}>0$. Let $g \in C_{b}^{2}(\mathbb{R})$. Then $Y=g(X)$ verifies Hypothesis $T R$.

## Proof :

1) Hypothesis TR 1. was the objective of Lemma 13.2 .
2) We have

E\left(g\left(X_{t_{1}}\right)-g\left(X_{t_{2}}\right)\right)^{2} \leq\left\|g^{\prime}\right\|_{\infty} \operatorname{Var}\left(X_{t_{2}}-X_{t_{1}}\right)
$$

Since $X$ is continuous in $L^{2}$, then $g(X)$ is continuous in $L^{2}$. On the other hand (13.5) holds and $t \longmapsto 1_{[0, t]}$ is continuous from $\mathbb{R}_{+}$to $L_{R}$ because

\left\|1_{[0, t]}-1_{[0, s]}\right\|_{R}^{2}=\operatorname{Var}\left(X_{t}-X_{s}\right)
$$

taking into account Corollary 6.19. This implies that $t \longmapsto D Y_{t+r}$ is continuous (and bounded) from $\mathbb{R}_{+}$to $\mathbb{D}^{1,2}$ for $r$ small enough. Consequently Hypothesis TR 2. is valid.
3) i) By Proposition 9.7 and Remark 9.8 we know that $X_{+r} \in \mathbb{D}^{1,2}\left(L_{R}\right)$ for $s$ small enough. Proposition 9.9 implies, that $Y=g\left(X_{+r}\right)$ belongs to $\mathbb{D}^{1,2}\left(L_{R}\right)$ and $D_{s} Y_{t}=$ $g^{\prime}\left(X_{t+r}\right) 1_{[0, t+r]}(s)$.
ii) To conclude the validity of Hypothesis TR 3. we need to show that
a) $r \longmapsto g\left(X_{+r}\right)$ is continuous in $L^{2}\left(\Omega ; L_{R}\right)$ in a neighbourhood of 0 .
b) $r \longmapsto(s, t) \longmapsto g^{\prime}\left(X_{t+r}\right) 1_{[0, t+r]}(s)$ is continuous in a neighbourhood of zero in $L^{2}\left(\Omega ; L_{2, R}\right)$. Concerning a), by definition of $\|\cdot\|_{R}$,

\left\|g\left(X_{\cdot+r}\right)-g(X .)\right\|_{R}^{2} \leq\left\|g^{\prime}\right\|_{\infty}\left\|X_{\cdot+r}-X .\right\|_{R}^{2}
$$

Taking the expectation and since

\begin{aligned}
E\left(\left\|X_{+r}-X .\right\|_{R}^{2}\right) & =\int_{0}^{\infty} R(d s, \infty) E\left(X_{s+r}-X_{s}\right)^{2} \\
& +\frac{1}{2} \int_{\mathbb{R}_{+}^{2}} d|\mu|\left(s_{1}, s_{2}\right) E\left(X_{s_{1}+r}-X_{s_{1}}-X_{s_{2}+r}+X_{s_{2}}\right)^{2}
\end{aligned}
$$

Since $X$ is bounded and continuous in $L^{2}$, 13.6) and Lebesgue's dominated convergence theorem imply that

\begin{equation*}
\lim _{r \rightarrow 0} E\left(\left\|X_{+r}-X .\right\|_{R}^{2}\right)=0 \tag{13.7}
\end{equation*}
$$

Concerning b) we have to estimate,

$$
E\left(\left\|D Y_{\cdot+r}-D Y\right\|_{2, R}^{2}\right)
$$

where $D_{s} Y_{t+r}=g^{\prime}\left(X_{t+r}\right) 1_{[0, t+r]}(s)$. Previous expectation is bounded by

$$
2\left(I_{1}(r)+I_{2}(r)\right)
$$

where

$$
\begin{aligned}
& I_{1}(r)=E\left(g\left(X_{t+r}\right)\right)^{2}\left\|1_{[0, t+r]}-1_{[0, t]}\right\|_{R}^{2} \\
& I_{2}(r)=E\left(\left\|g\left(X_{\cdot+r}\right)-g(X .)\right\|_{R}^{2}\right)\left\|1_{[0, t]}\right\|_{R}^{2}
\end{aligned}
$$

We clearly have

I_{1}(r) \leq\left(g(0)+\left\|g^{\prime}\right\|_{\infty} E\left(X_{t+r}^{2}\right)\right)\left\|\operatorname{Var}\left(X_{++r}\right)-\operatorname{Var}\left(X^{2}\right)\right\|_{R}^{2}
$$

Since $X$ is continuous and bounded in $L^{2}(\Omega)$ and taking into account the definition of $\|\cdot\|_{R}$, 13.6) and Lebesgue's dominated convergence theorem imply $\lim _{r \rightarrow 0} I_{1}(r)=0$. On the other hand

\left\|1_{[0, t]}\right\|_{R}^{2}=\int_{0}^{\infty} \operatorname{Var}\left(X_{t}\right) R(d t, \infty)+\frac{1}{2} \int_{\mathbb{R}_{+}^{2}} \operatorname{Var}\left(X_{t_{2}}-X_{t_{1}}\right) d|\mu|\left(t_{1}, t_{2}\right) .
$$

Since

E\left(\left\|g\left(X_{++r}\right)-g\left(X_{.}\right)\right\|_{R}^{2}\right) \leq\left\|g^{\prime}\right\|_{\infty}\left\|X_{++r}-X_{.}\right\|_{R}^{2},
$$

(13.7) and (13.6) imply $\lim _{r \rightarrow 0} I_{2}(r)=0$. This concludes the proof of Proposition 13.3.

Remark 13.4. If $X_{t}=\tilde{X}_{t \wedge T}$ and $\tilde{X}$ has stationary increments, then (13.6) and (6.35) are equivalent to

\int_{0+} Q(r)\left|Q^{\prime \prime}\right|(d r)<\infty,
$$

whenever $Q(t)=\operatorname{Var} \tilde{X}_{t}$.
We are able now to state a theorem linking Skorohod integral and regularization integrals. We will introduce first a definition.

Definition 13.1. Let $Y \in \mathbb{D}^{1,2}\left(L_{R}\right)$. We say that $D Y$ admits a symmetric trace if

$$
\lim _{\varepsilon \rightarrow 0} \int_{0}^{\tau}\left\langle D Y_{t}, 1_{[t-\varepsilon, t+\varepsilon]}\right\rangle_{\mathcal{H}} \frac{d t}{\varepsilon}
$$

for every $\tau>0$ in probability. We denote by $\left(T r^{0} D Y\right)(\tau)$ the mentioned quantity.
Theorem 13.5. Let $Y$ be a process with the following assumptions

1. Assumption (D).
2. $Y \in \mathbb{D}^{1,2}\left(L_{R}\right)$.
3. Hypothesis TR holds.
4. $Y$ admits a symmetric trace.

Then

$$
\begin{equation*}
\int_{0}^{t} Y d^{0} X=\int_{0}^{t} Y \delta X+\left(T r^{0} D Y\right)(t) \tag{13.8}
\end{equation*}
$$

Proof: As in Lemma 13.1, we denote

$$
Y_{t}^{\varepsilon}=\frac{1}{2 \varepsilon} \int_{(t-\varepsilon)^{+}}^{(t+\varepsilon) \wedge T} d s Y_{s}
$$

The $\varepsilon$ - approximation of the left-hand symmetric integral in (13.8) gives

$$
\frac{1}{2 \varepsilon} \int_{0}^{t} Y_{s}\left(X_{s+\varepsilon}-X_{(s-\varepsilon)^{+}}\right) d s
$$

Using Proposition 12.1 and Proposition 10.2 previous expression equals

$$
\begin{align*}
& \frac{1}{2 \varepsilon} \int_{0}^{t} d s Y_{s} \int_{0}^{\infty} \delta X_{u} 1_{[s-\varepsilon, s+\varepsilon]}(u)= \\
& =\int_{0}^{t} d s \int_{0}^{\infty} Y_{s} 1_{[s-\varepsilon, s+\varepsilon]}(u)-\frac{1}{2 \varepsilon} \int_{0}^{t} d s\left\langle D Y_{s}, 1_{[s-\varepsilon, s+\varepsilon]}\right\rangle_{\mathcal{H}} \tag{13.9}
\end{align*}
$$

Using Fubini's theorem Proposition 10.3 , the last expression equals

$$
\left(I_{1}+I_{2}\right)(\varepsilon)
$$

where

$$
\begin{aligned}
& I_{1}(\varepsilon)=\frac{1}{2 \varepsilon} \int_{0}^{\infty} \delta X_{u} Y_{u}^{\varepsilon} \\
& I_{2}(\varepsilon)=\int_{0}^{t} \frac{d s}{2 \varepsilon}\left\langle D Y_{s}, 1_{[s-\varepsilon, s+\varepsilon]}\right\rangle_{\mathcal{H}}
\end{aligned}
$$

with

$$
Y_{u}^{\varepsilon}=\frac{1}{2 \varepsilon} \int_{(u-\varepsilon)^{+}}^{(u+\varepsilon) \wedge t} Y_{r} d r
$$

Lemma 13.1 implies that $I_{1}(\varepsilon) \longrightarrow \int_{0}^{t} Y_{u} \delta X_{u}$. The definition of symmetric trace implies that $\lim _{\varepsilon \rightarrow 0} I_{2}(\varepsilon)=\left(T r^{0} D Y\right)(t)$.

Next application will be an application to the case $Y=g(X), g \in C_{b}^{2}(\mathbb{R})$.
Corollary 13.6. We suppose the following

1. Assumption (D), 13.6) are fulfilled.
2. $\forall T>0$

$$
\begin{equation*}
\sup _{\varepsilon>0} \int_{\varepsilon}^{T}\left|\operatorname{Var}\left(X_{s+\varepsilon}-X_{s}\right)-\operatorname{Var}\left(X_{s}-X_{s-\varepsilon}\right)\right| d s<\infty \tag{13.10}
\end{equation*}
$$

3. $\gamma(t)=\operatorname{Var}\left(X_{t}\right)$ has bounded variation.

Then, for $g \in C_{b}^{3}(\mathbb{R})$ we have

$$
\int_{0}^{t} g(X) d^{0} X=\int_{0}^{t} g(X) \delta X+\frac{1}{2} \int_{0}^{t} g^{\prime}\left(X_{s}\right) d \gamma_{s}, \forall t \in[0, T]
$$

Finally we are able to state an It formula related to the symmetric (Stratonovich) integral via regularization.

Corollary 13.7. Under the assumptions 1), 2), 3) of Corollary 13.6, if $f \in C_{b}^{\infty}(\mathbb{R})$, then

$$
\begin{equation*}
f\left(X_{t}\right)=f\left(X_{0}\right)+\int_{0}^{t} f^{\prime}\left(X_{s}\right) d^{0} X_{s} \tag{13.11}
\end{equation*}
$$

Remark 13.8. 1. The mentioned Ito's formula has to be considered as a side effect of Theorem 13.5. We do not aim in providing minimal assumptions. A refinement of this formula could concern the case when the paths of $X$ do not belong to $L_{R}$ and $X$ belongs only to $(D o m \delta)^{*}$. Various techniques developed by [16, 3才, 8] for the specific case of fractional (or bifractional) Brownian motion will probably help.
2. If $X$ has stationary increments, then 13.10) holds.

Proof (of Corollary 13.6): The result follows as consequence of Theorem 13.5. Indeed $Y=g(X)$ belongs to $\mathbb{D}^{1,2}\left(L_{R}\right)$ because of Corollary 9.10. Hypothesis TR holds because of Proposition 13.3. So Hypotheses 1., 2., 3. of Theorem 13.5 are verified. It remains to check that $Y$ admits a symmetric trace and

$$
\begin{equation*}
\operatorname{Tr}^{0} D g(X)_{\tau}=\int_{0}^{\tau} g^{\prime}\left(X_{s}\right) d \gamma_{s}, \forall \tau>0 \tag{13.12}
\end{equation*}
$$

As we said, Corollary 9.10 implies that

$$
D_{r} Y_{t}=g^{\prime}\left(X_{t}\right) 1_{[0, t]}(r)
$$

Hence for $\tau>0$ the left-hand side of (13.12) is the limit when $\varepsilon \rightarrow 0$ of

$$
\begin{equation*}
\int_{0}^{\tau} \frac{1}{2 \varepsilon}\left\langle D Y_{t}, 1_{[t-\varepsilon, t+\varepsilon]}\right\rangle_{\mathcal{H}} d t=\frac{1}{2} \int_{0}^{\tau} g^{\prime}\left(X_{t}\right)\left\langle 1_{[0, t]}, 1_{[t-\varepsilon, t+\varepsilon]}\right\rangle_{\mathcal{H}} d t . \tag{13.13}
\end{equation*}
$$

We consider the bounded variation function

$$
F_{\varepsilon}(\tau)=\int_{0}^{\tau}\left\langle 1_{[0, t]}, 1_{[t-\varepsilon, t+\varepsilon]}\right\rangle_{\mathcal{H}} \frac{d t}{2 \varepsilon}
$$

Let $T>0$. If we prove that

$$
\begin{equation*}
d F_{\varepsilon}(\tau) \Rightarrow \frac{d \gamma(\tau)}{2}, \quad \tau \in[0, T] \tag{13.14}
\end{equation*}
$$

then (13.14) converges to $\frac{1}{2} \int_{0}^{\tau} g^{\prime}\left(X_{t}\right) d \gamma_{t}$ a.s. for every $\tau \geq 0$ and the theorem would be established. To prove (13.14) we need to establish the following.
i) The total variation $d\left|F_{\varepsilon}\right|(T)$ a.e. is bounded in $\varepsilon>0$.
ii) $F_{\varepsilon}(\tau) \longrightarrow \frac{\gamma(\tau)}{2}, \forall \tau>0$.

Indeed we have

$$
\begin{aligned}
F_{\varepsilon}(\tau) & =\int_{0}^{\tau} \frac{d t}{2 \varepsilon}\left(\operatorname{Cov}\left(X_{t+\varepsilon}, X_{t}\right)-\operatorname{Cov}\left(X_{t-\varepsilon}, X_{t}\right)\right) \\
& =\frac{1}{2 \varepsilon} \int_{0}^{\tau} d t\left((\gamma(t+\varepsilon)-\gamma(t))-\operatorname{Var}\left(X_{t+\varepsilon}-X_{t}\right)\right) \\
& -\frac{1}{2 \varepsilon} \int_{0}^{\tau} d t\left(\gamma(t)-\gamma(t-\varepsilon)-\operatorname{Var}\left(X_{t}-X_{t-\varepsilon}\right)\right)
\end{aligned}
$$

So

$$
F_{\varepsilon}(\tau)=I_{1, \varepsilon}(\tau)+I_{2, \varepsilon}(\tau)
$$

where

$$
\begin{align*}
& I_{1, \varepsilon}(\tau)=\frac{1}{2 \varepsilon} \int_{\tau-\varepsilon}^{\tau} d t \gamma(t) \\
& I_{2, \varepsilon}(\tau)=\frac{1}{2 \varepsilon} \int_{\tau-\varepsilon}^{\tau} d t\left(\operatorname{Var}\left(X_{t+\varepsilon}-X_{t}\right)-\operatorname{Var}\left(X_{t}-X_{t-\varepsilon}\right)\right) \tag{13.15}
\end{align*}
$$

i) The total variations of $I_{1, \varepsilon}$ on $[0, T]$ are bounded by the total variation of $\gamma$. The total variation of $I_{2, \varepsilon}$ are bounded because of (13.10).
ii) Obviously

$$
\begin{align*}
& \lim _{\varepsilon \rightarrow 0} I_{1, \varepsilon}(\tau)=\frac{\gamma(t)}{2} \\
& \lim _{\varepsilon \rightarrow 0} I_{2, \varepsilon}(\tau)=0 \tag{13.16}
\end{align*}
$$

Finally i) and ii) are proved.
